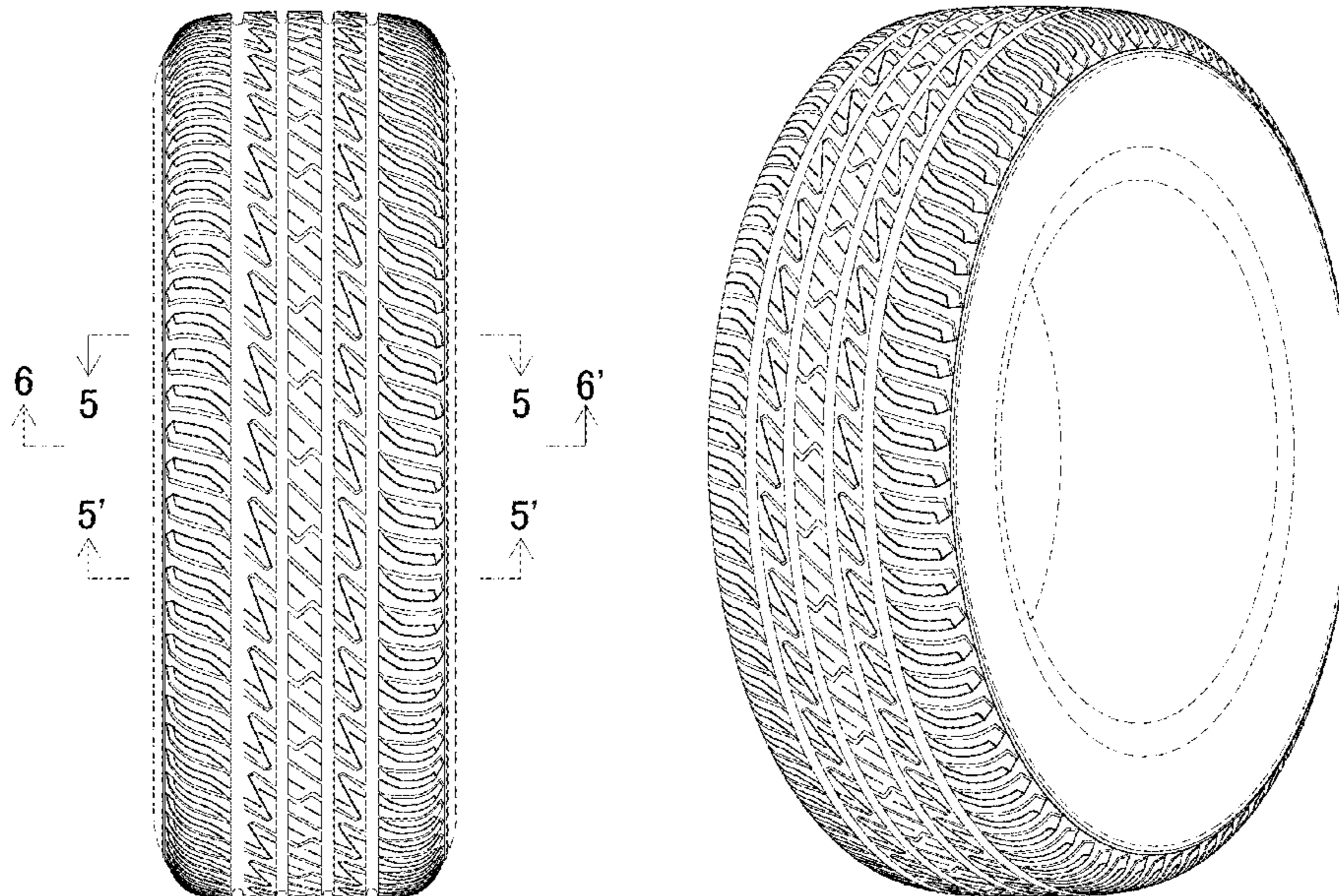
(57) **CLAIM**

The ornamental design for an automobile tire, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of an automobile tire, for which the rear view is the same;  
 FIG. 2 is a top plan view thereof, for which the bottom plan view is the same;  
 FIG. 3 is a right side view thereof, for which the left-side view is the same;  
 FIG. 4 is a perspective view thereof;  
 FIG. 5 is an enlarged sectional view taken along line 5-5 and line 5'-5' in FIG. 1; and,  
 FIG. 6 is an enlarged cross-sectional view taken along line 6-6 in FIG. 1, in the area designated by "6" in FIG. 3 thereof.  
 In the drawings, the broken lines defining the sidewall, inner bead and the peripheral boundary between the claimed tire tread and the unclaimed sidewall depict environmental subject matter that forms no part of the claimed design.

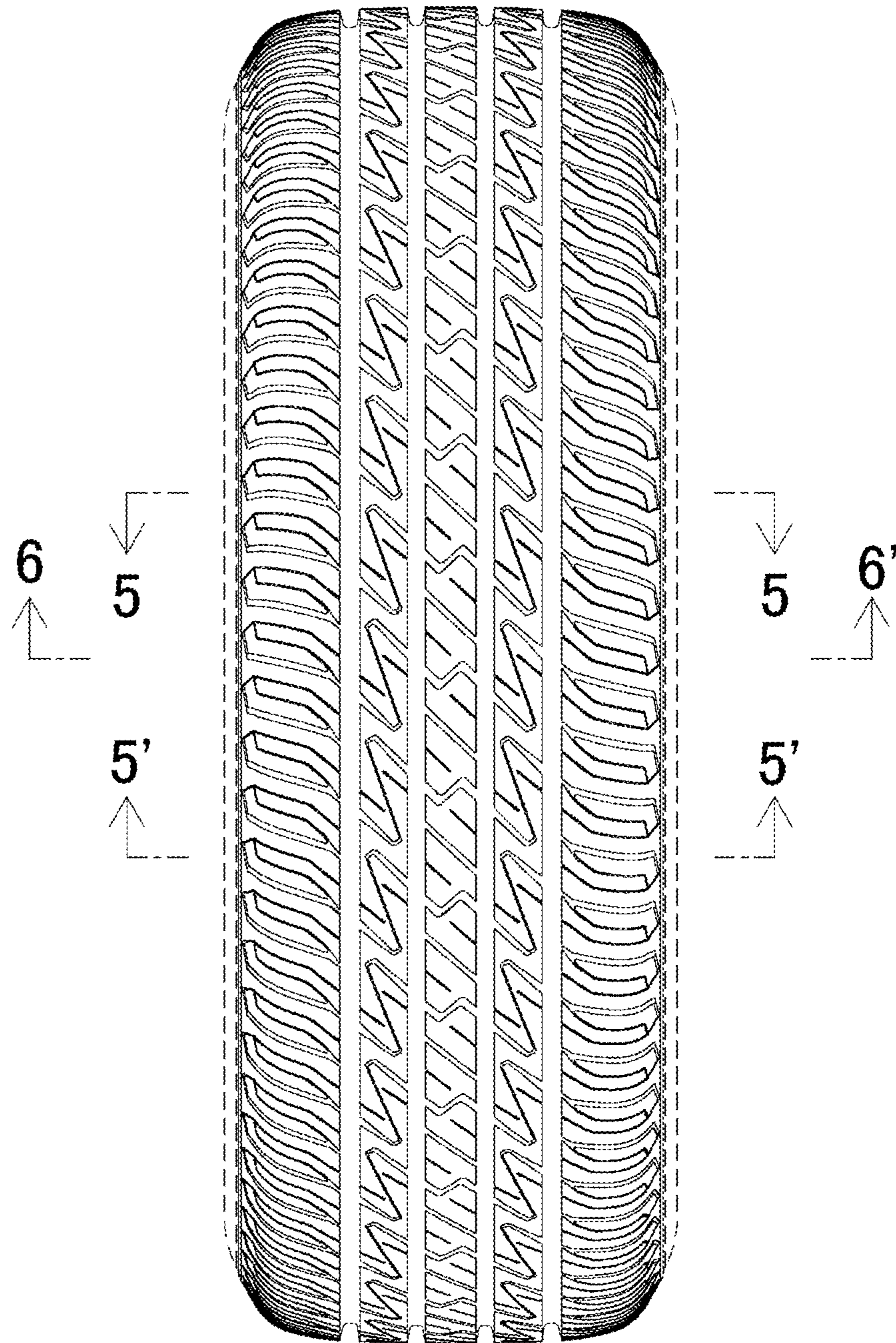

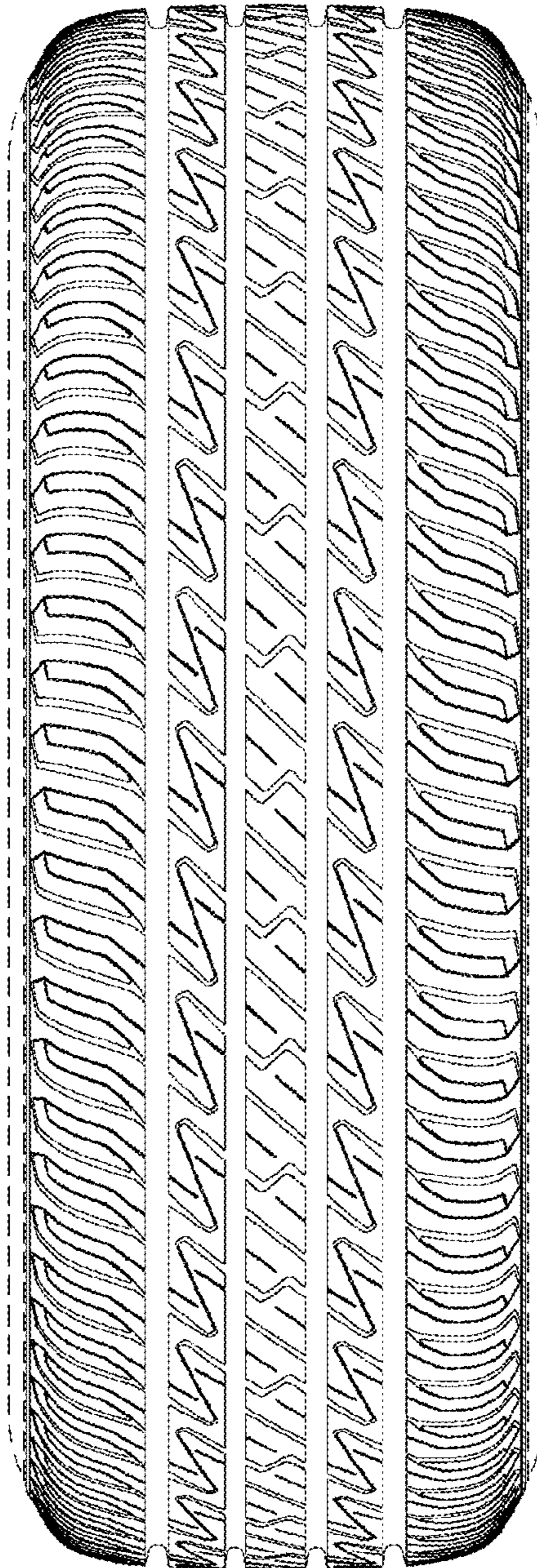
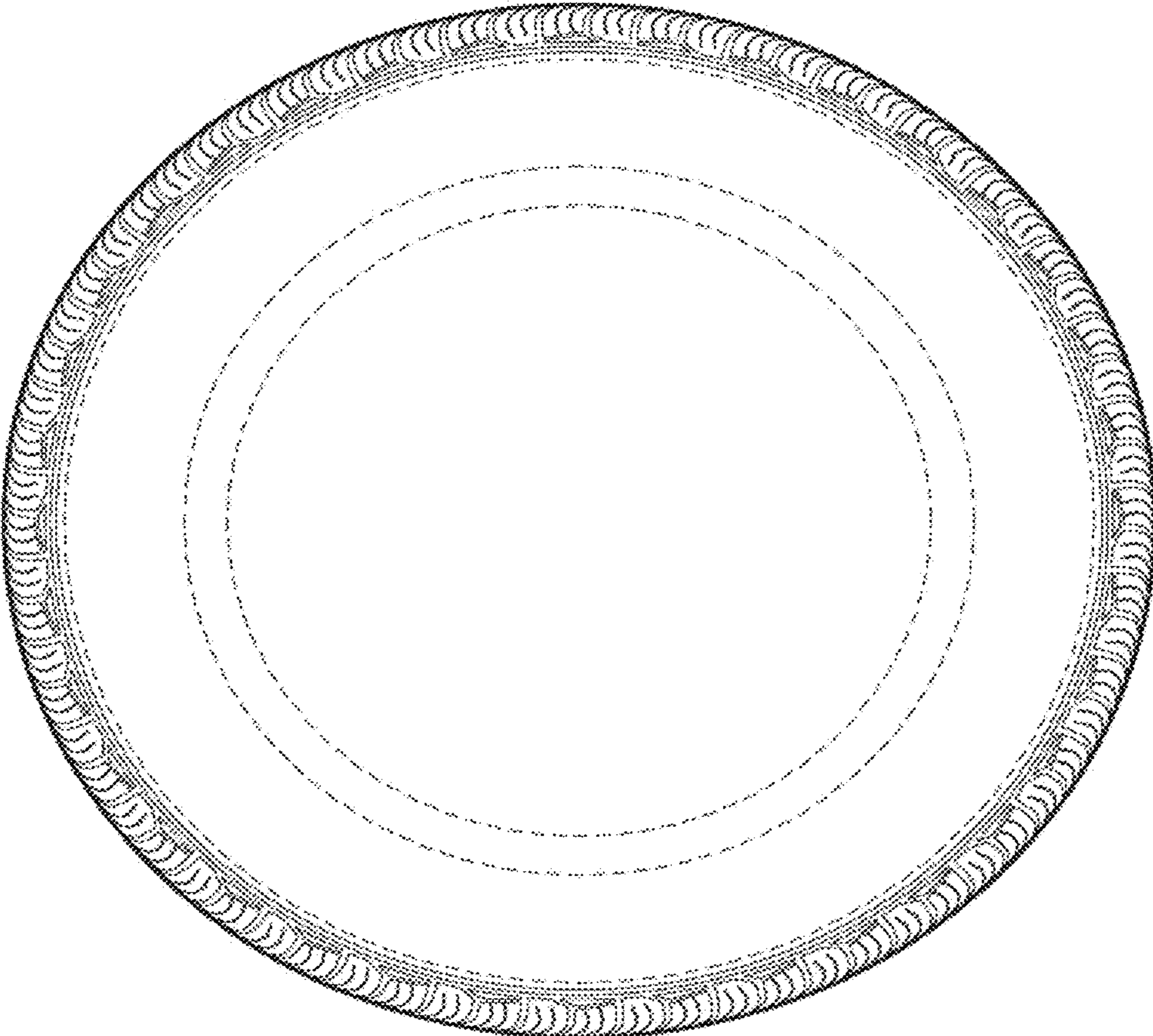

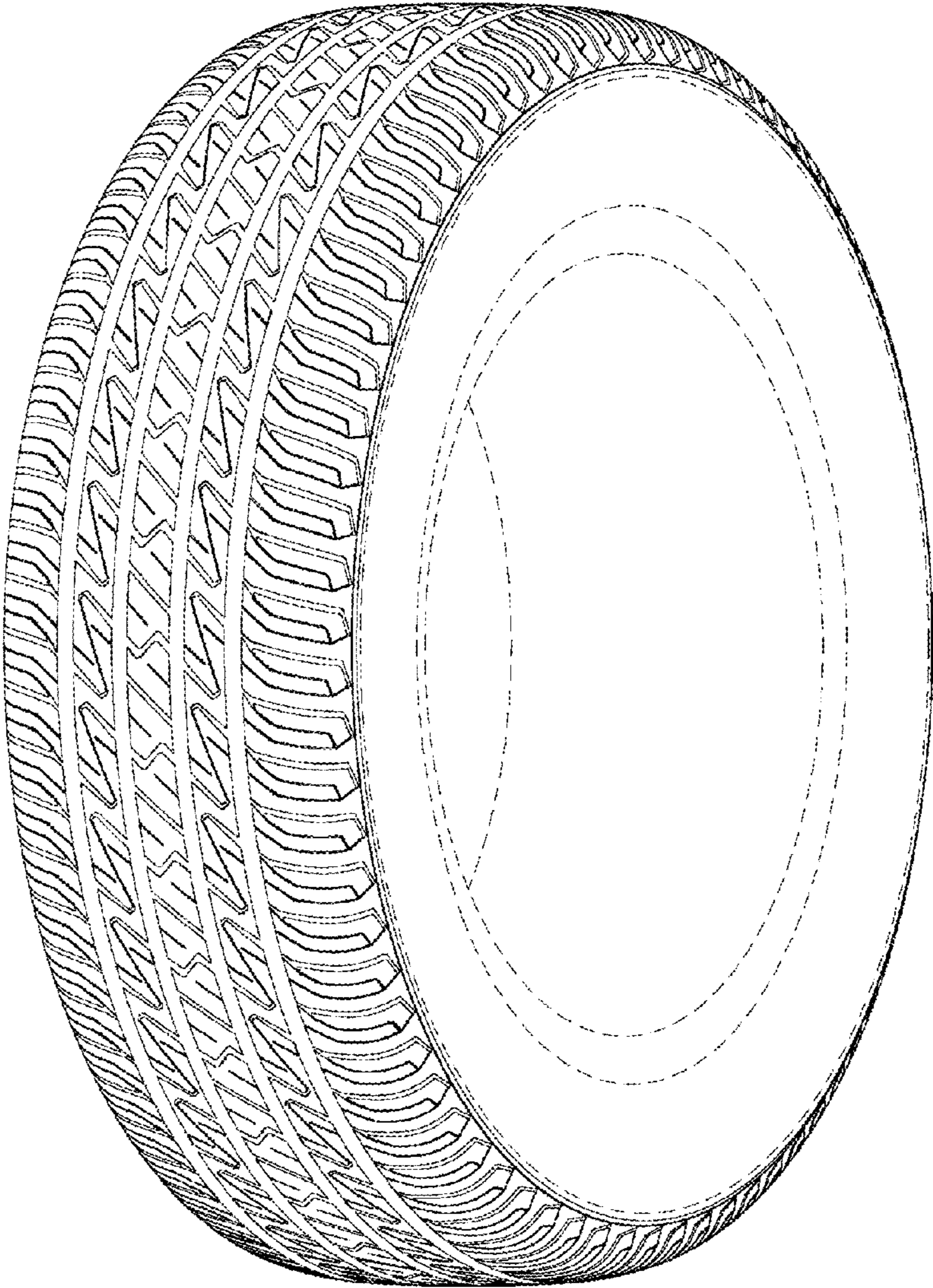

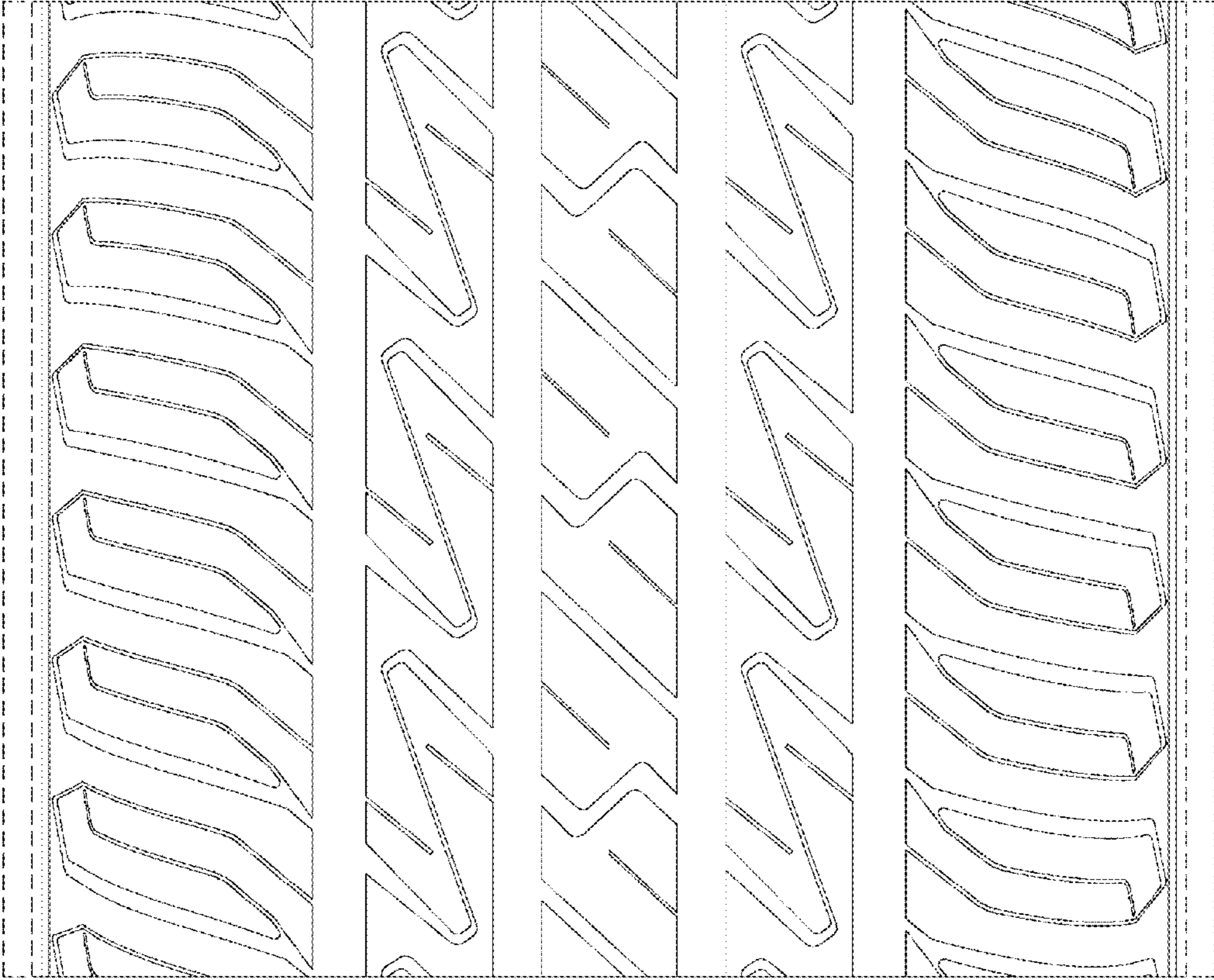

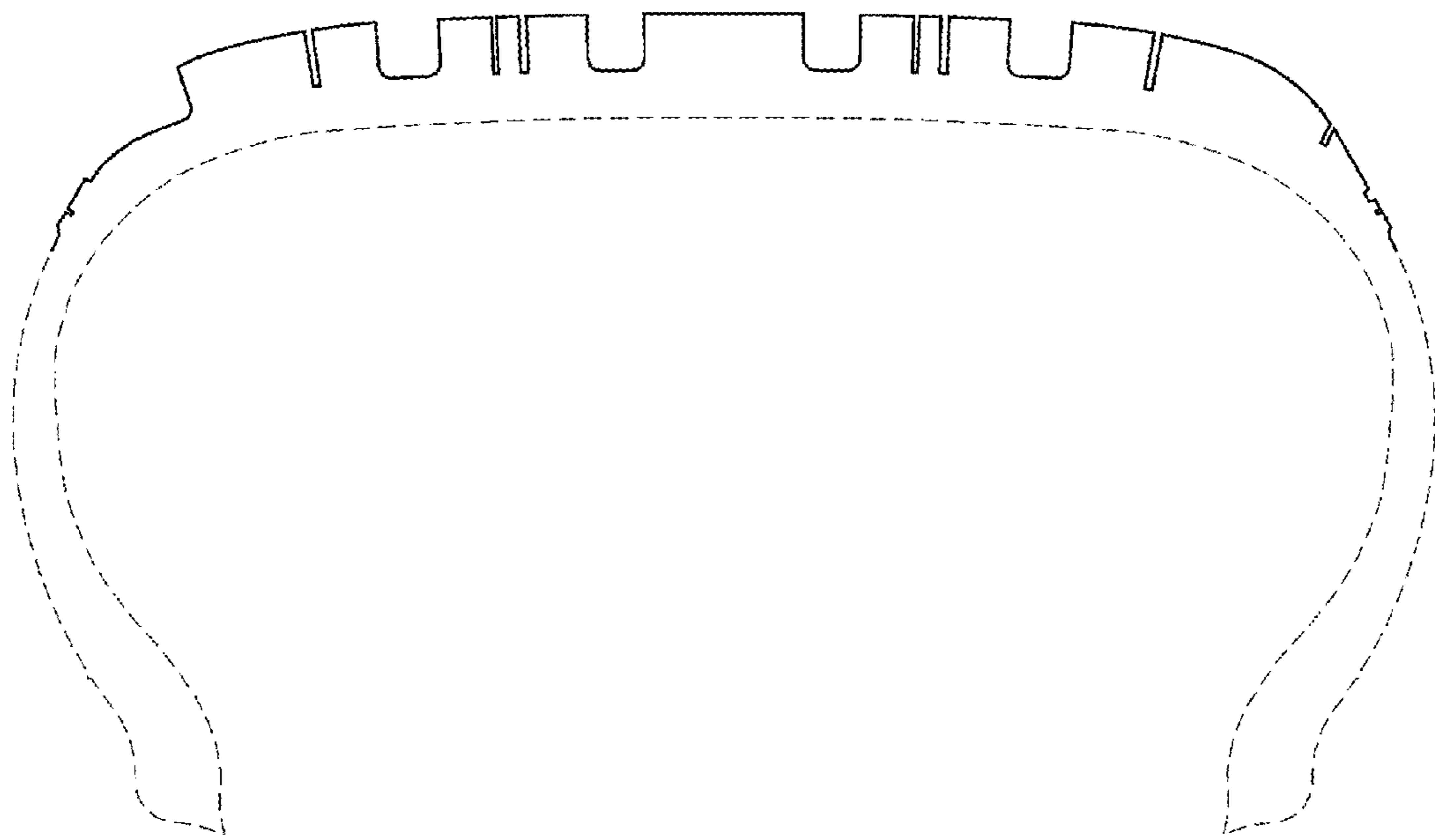
