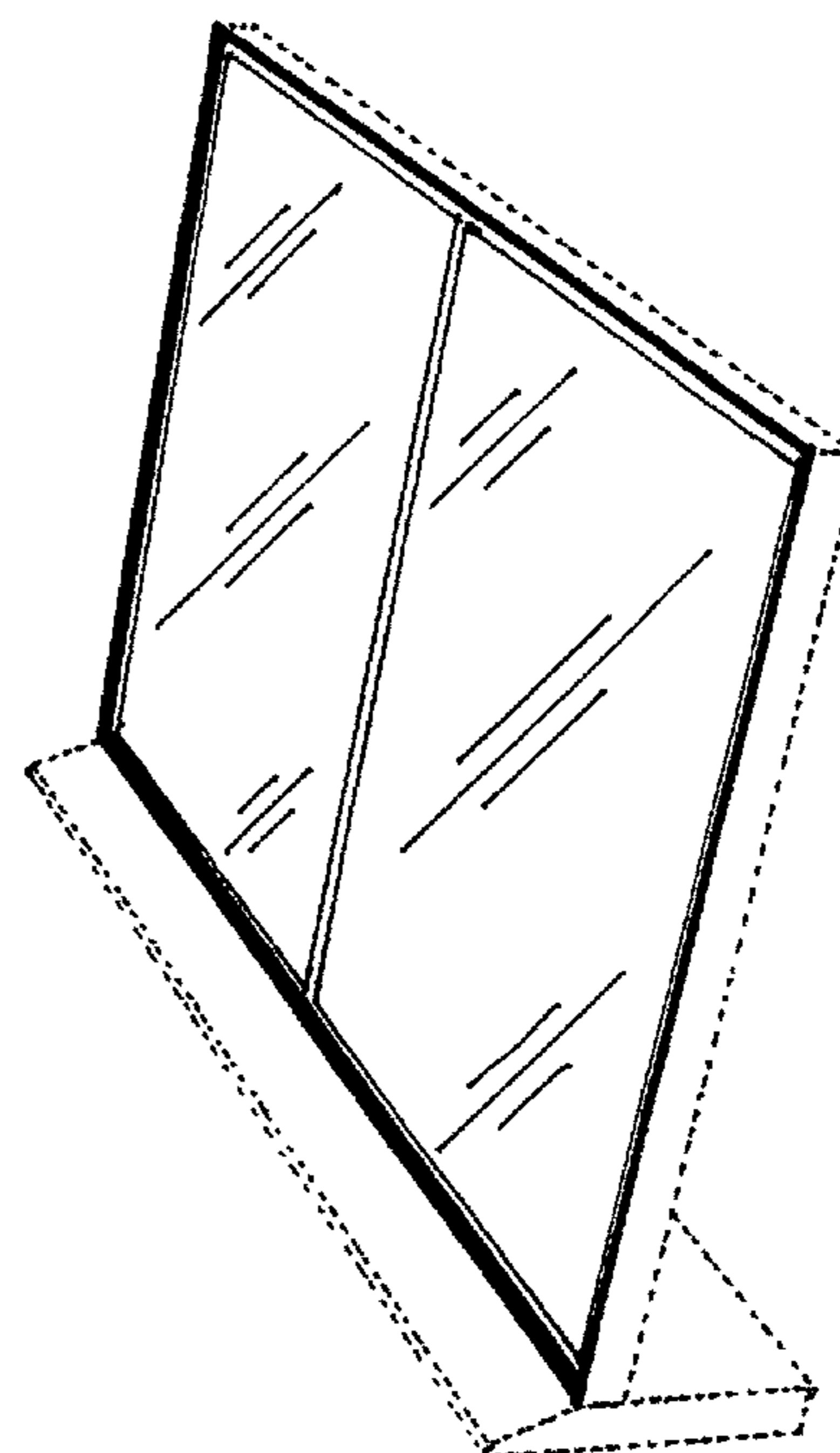
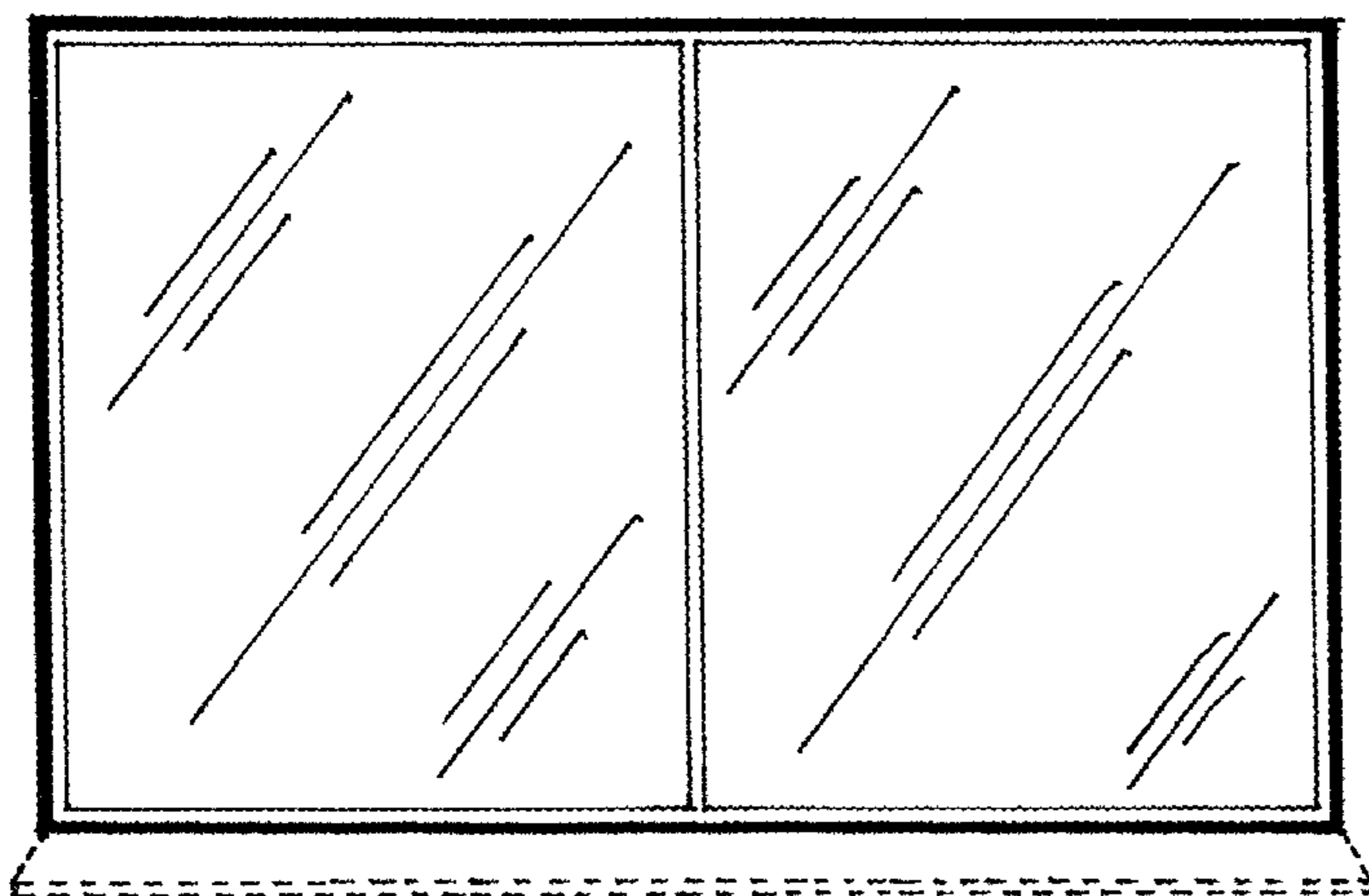
(57) **CLAIM**
The ornamental design for a dual-portrait-screen monitor, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a dual-portrait-screen monitor showing my new design;
FIG. 2 is a front perspective view thereof;
FIG. 3 is a top plane view thereof;
FIG. 4 is a right side elevational view thereof;
FIG. 5 is a left side elevational view thereof;
FIG. 6 is a rear elevational view thereof; and,
FIG. 7 is a bottom plane view thereof.

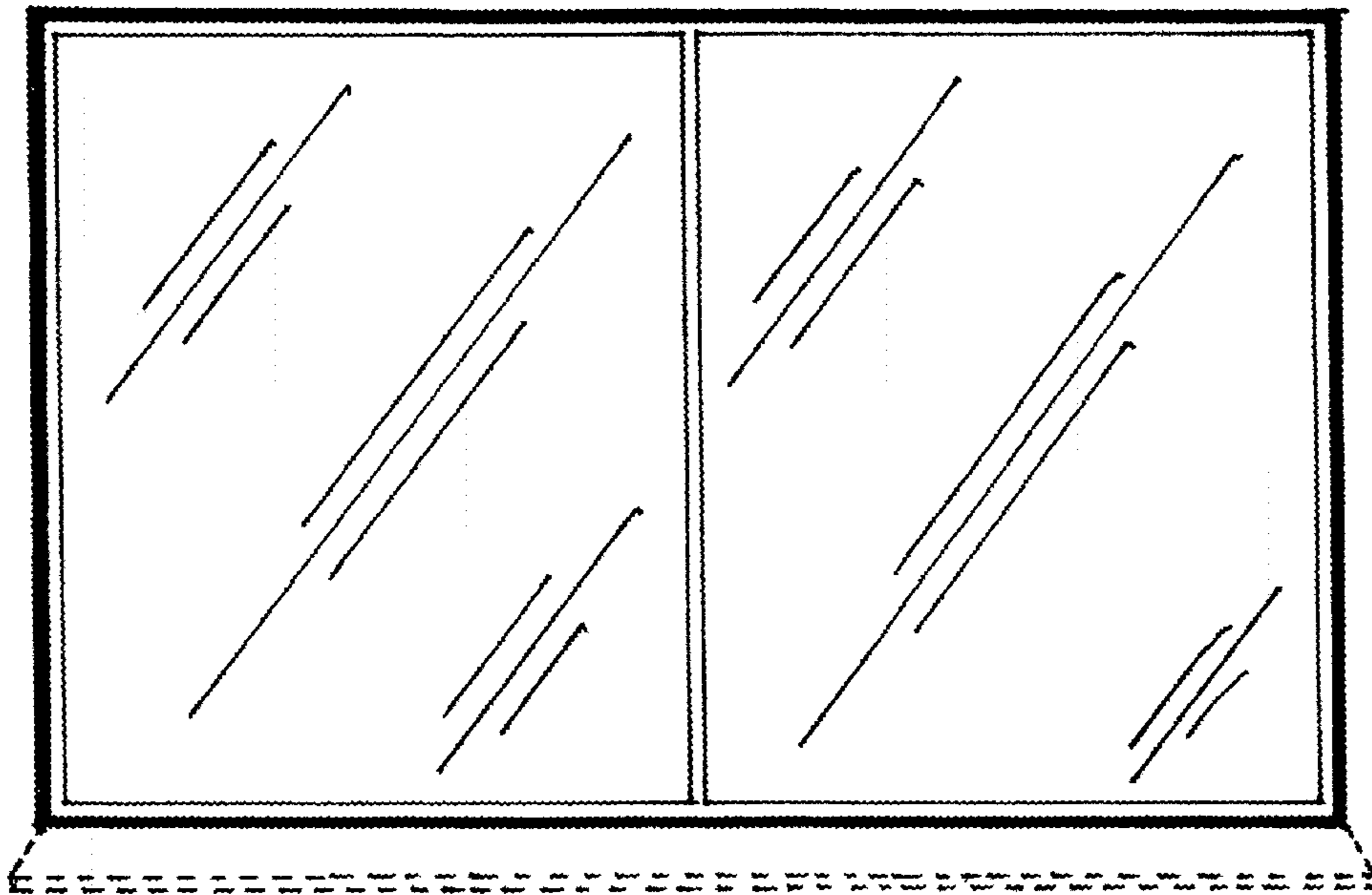

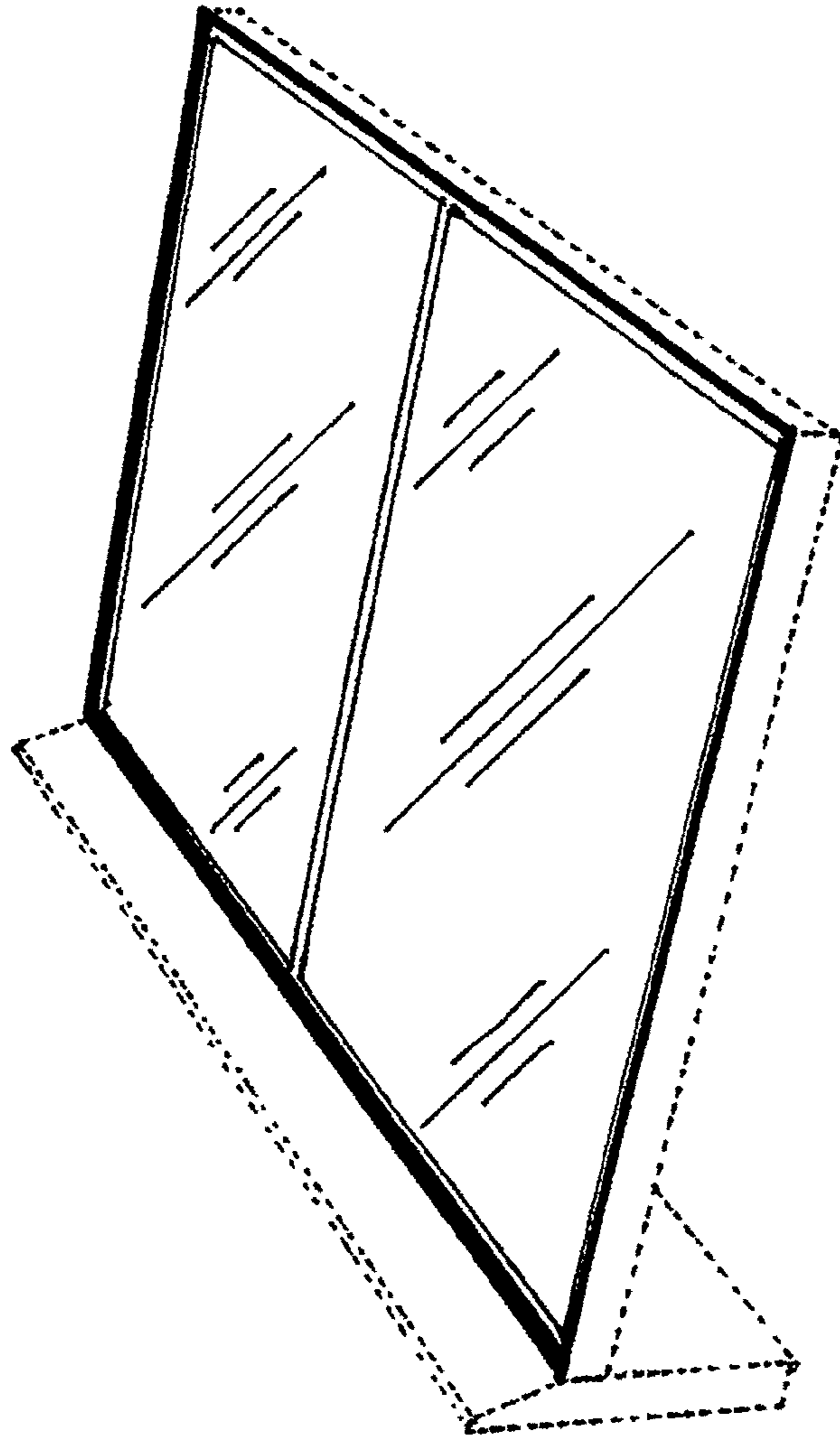

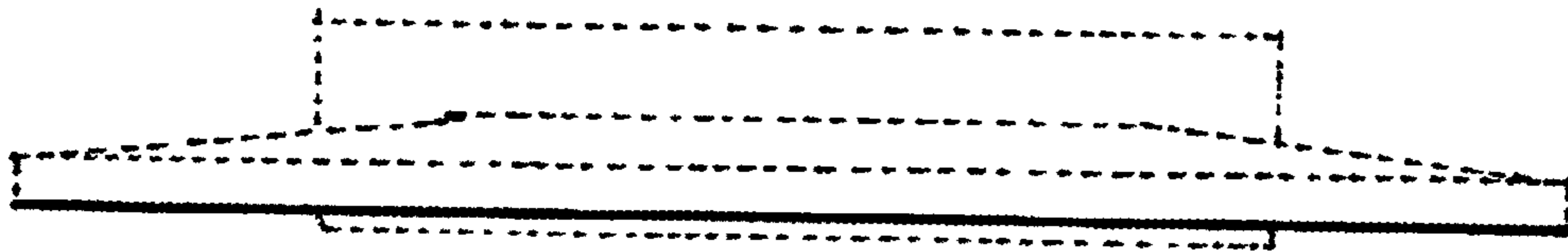

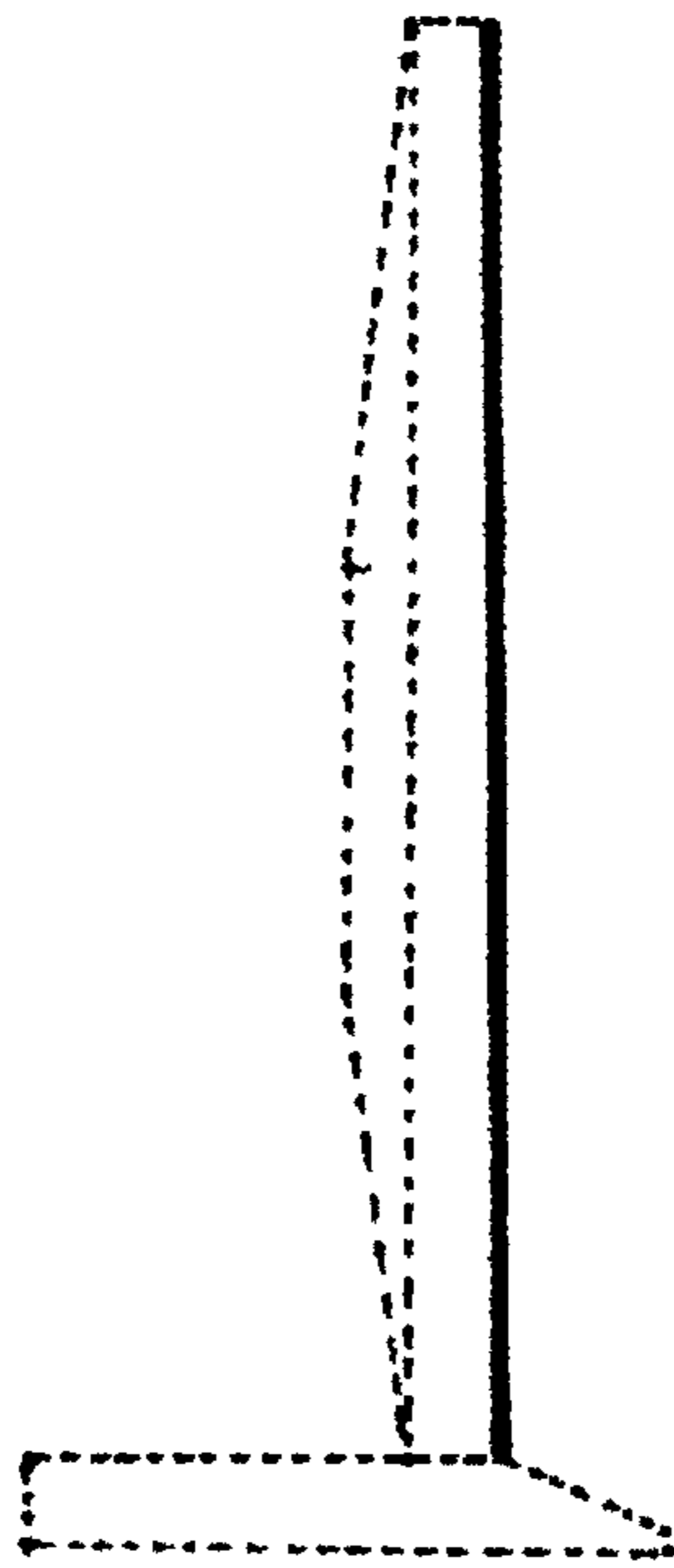

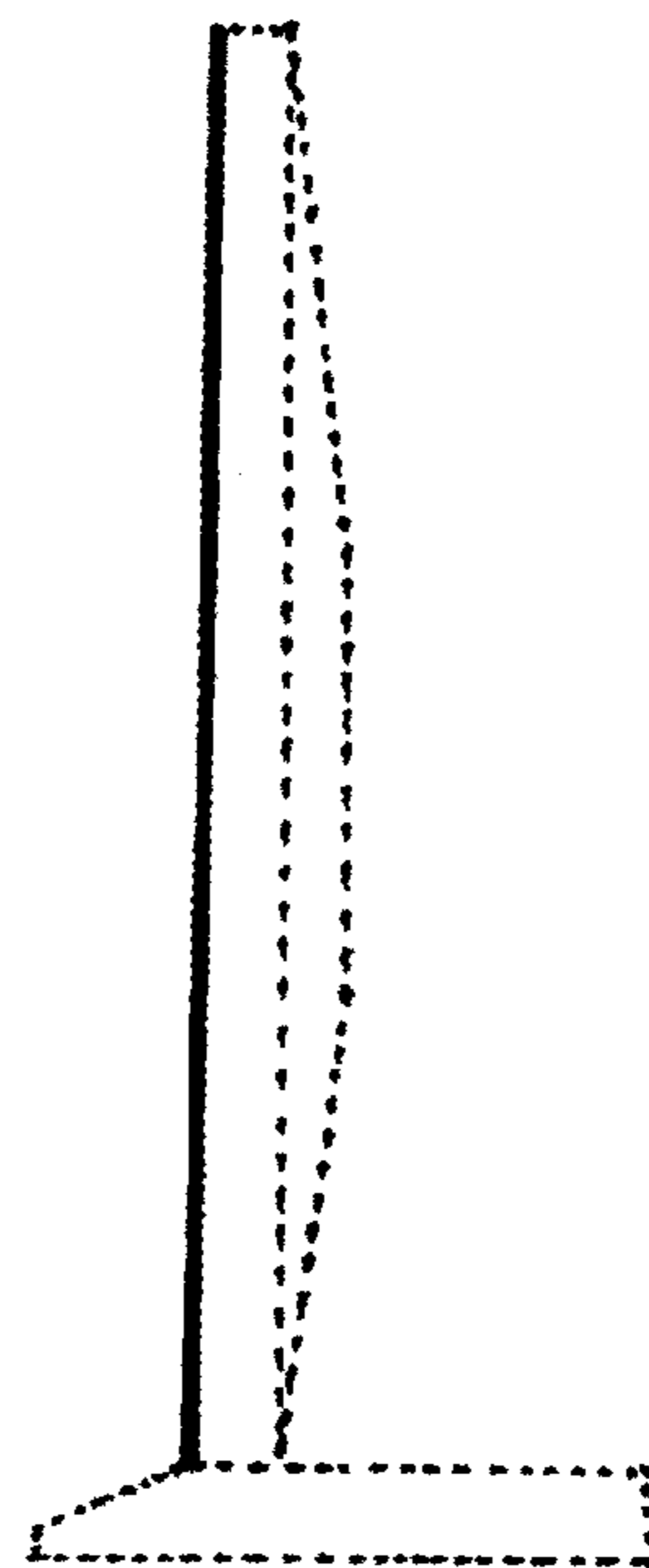

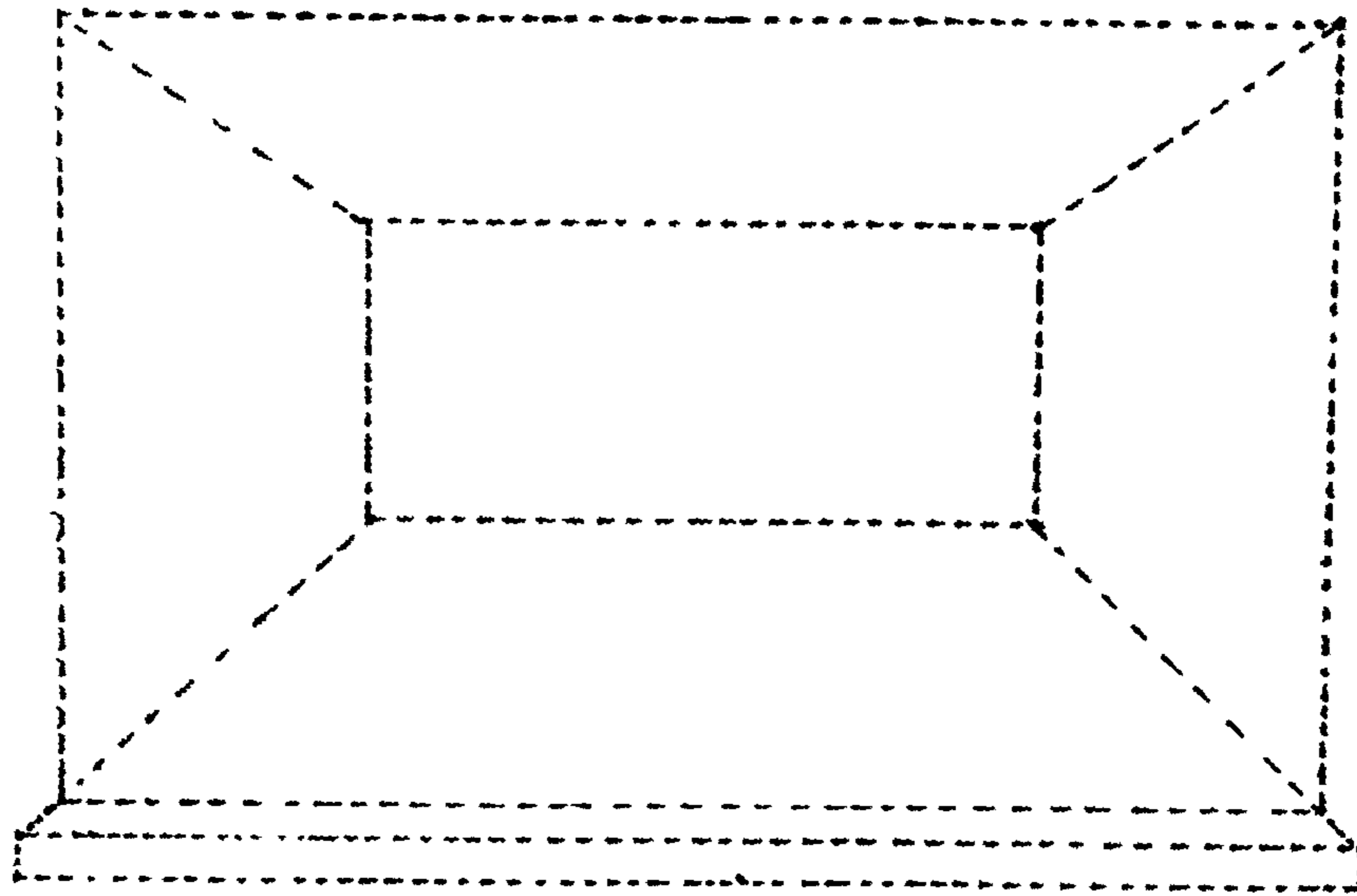
