(57) **CLAIM**

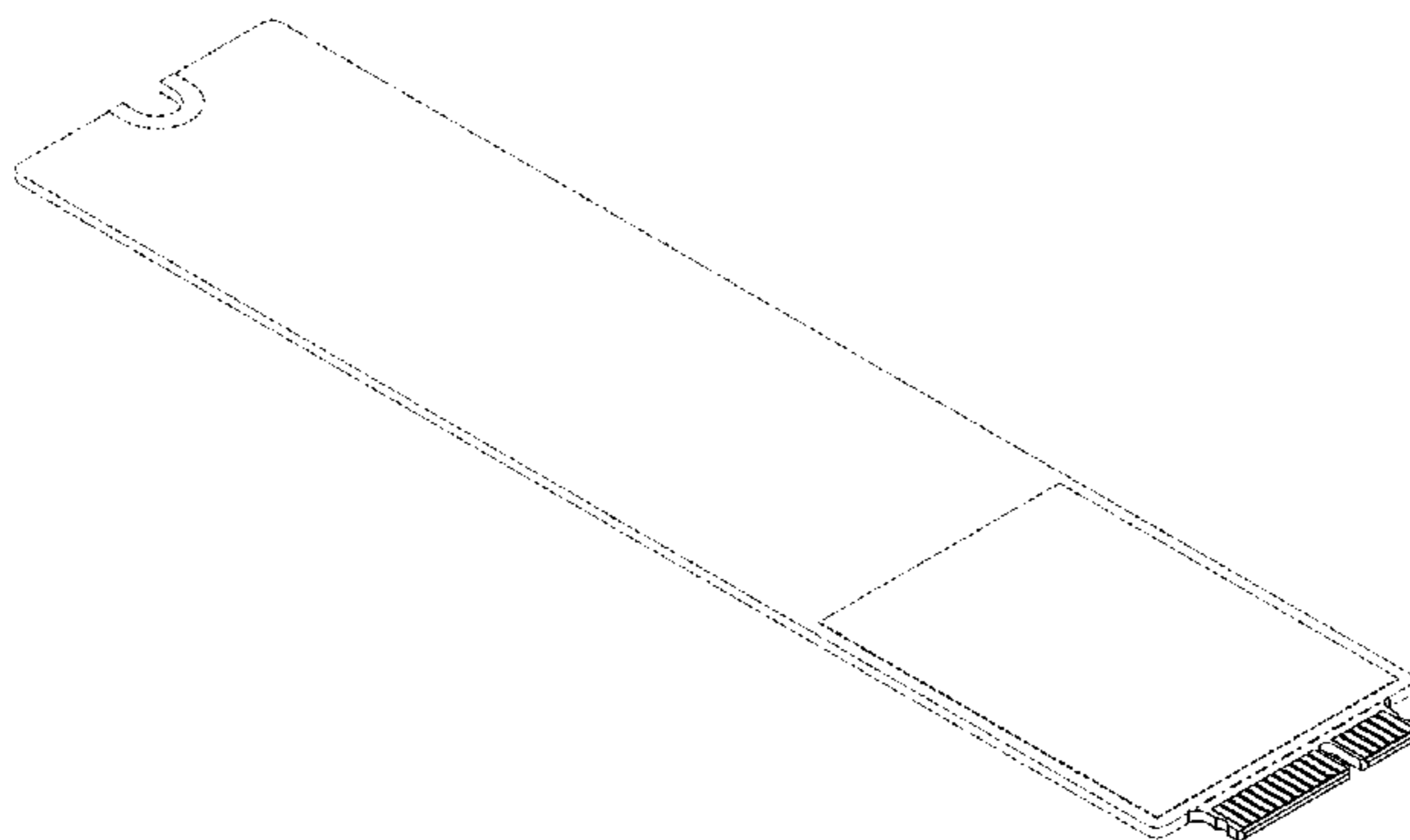
The ornamental design for an electronic device, as shown and described.

**DESCRIPTION**

FIG. 1 is a top, front, left perspective view of an electronic device showing our new design;

FIG. 5 is a left side view thereof;  
FIG. 6 is a front view thereof; and,

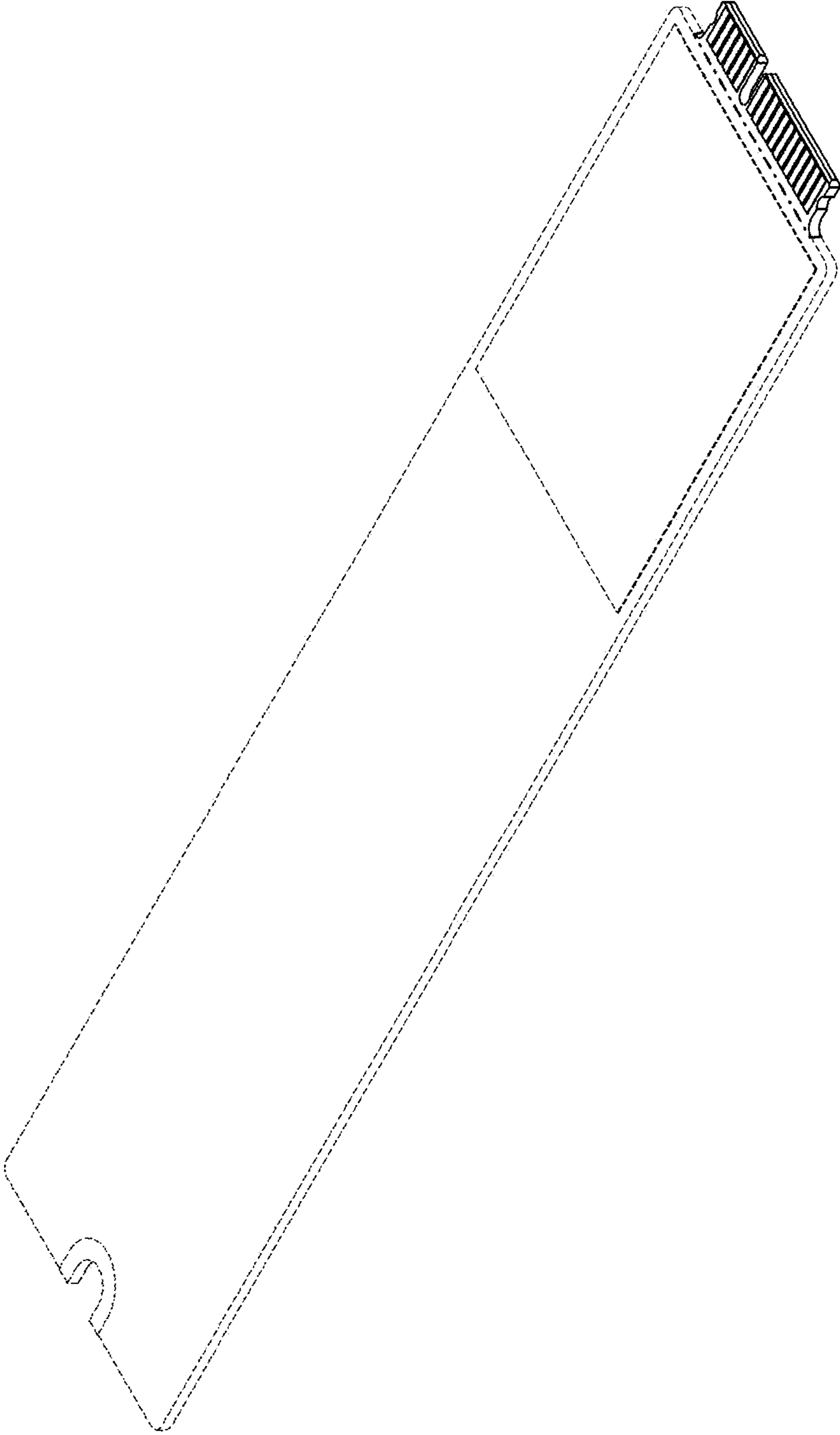
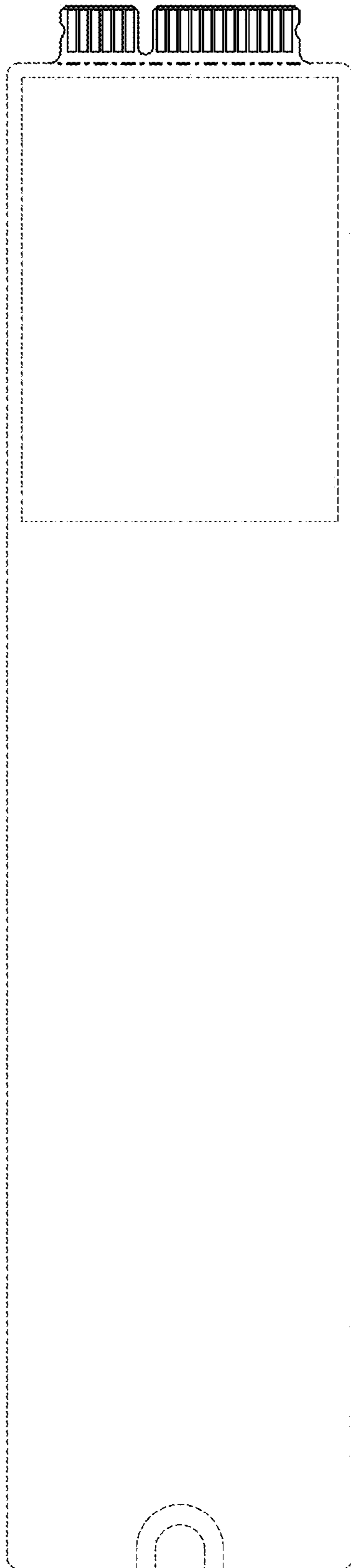
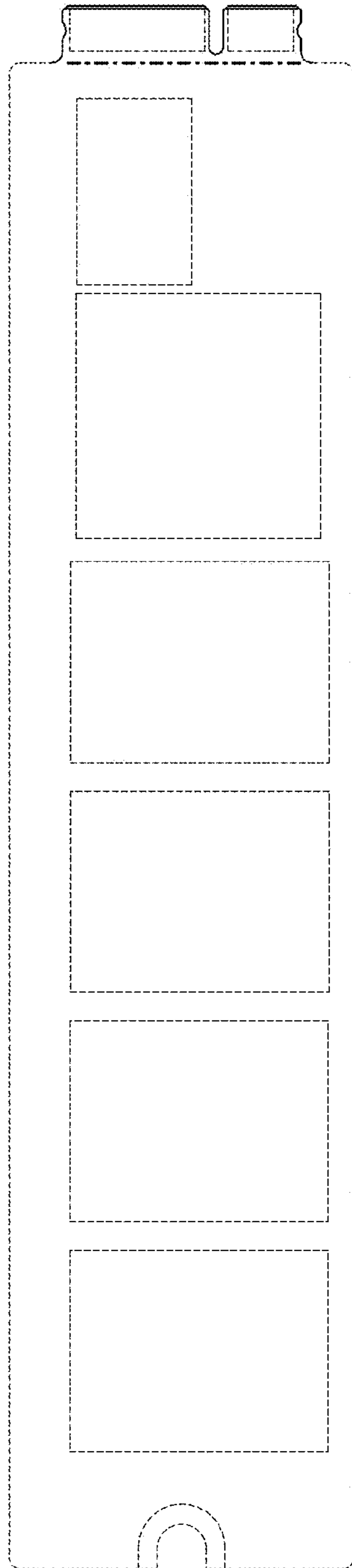


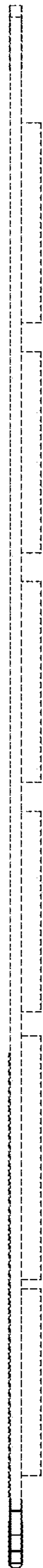

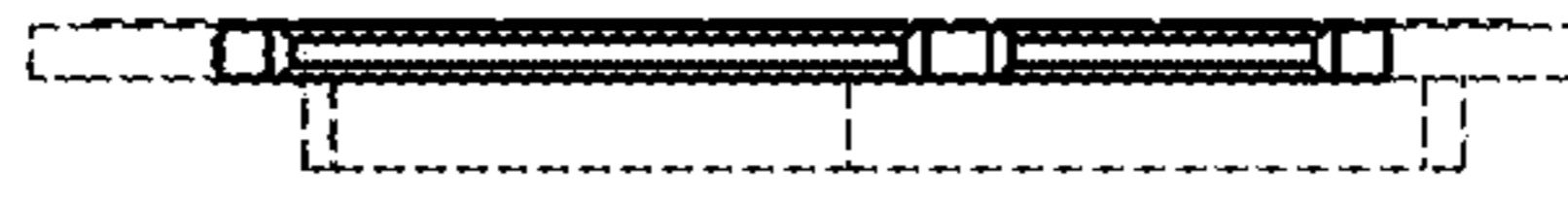

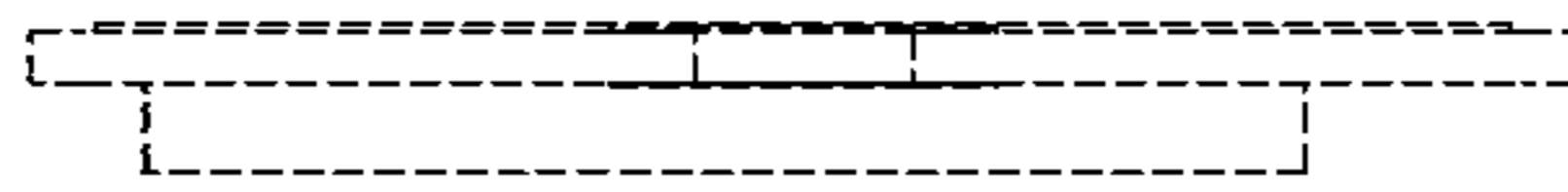
