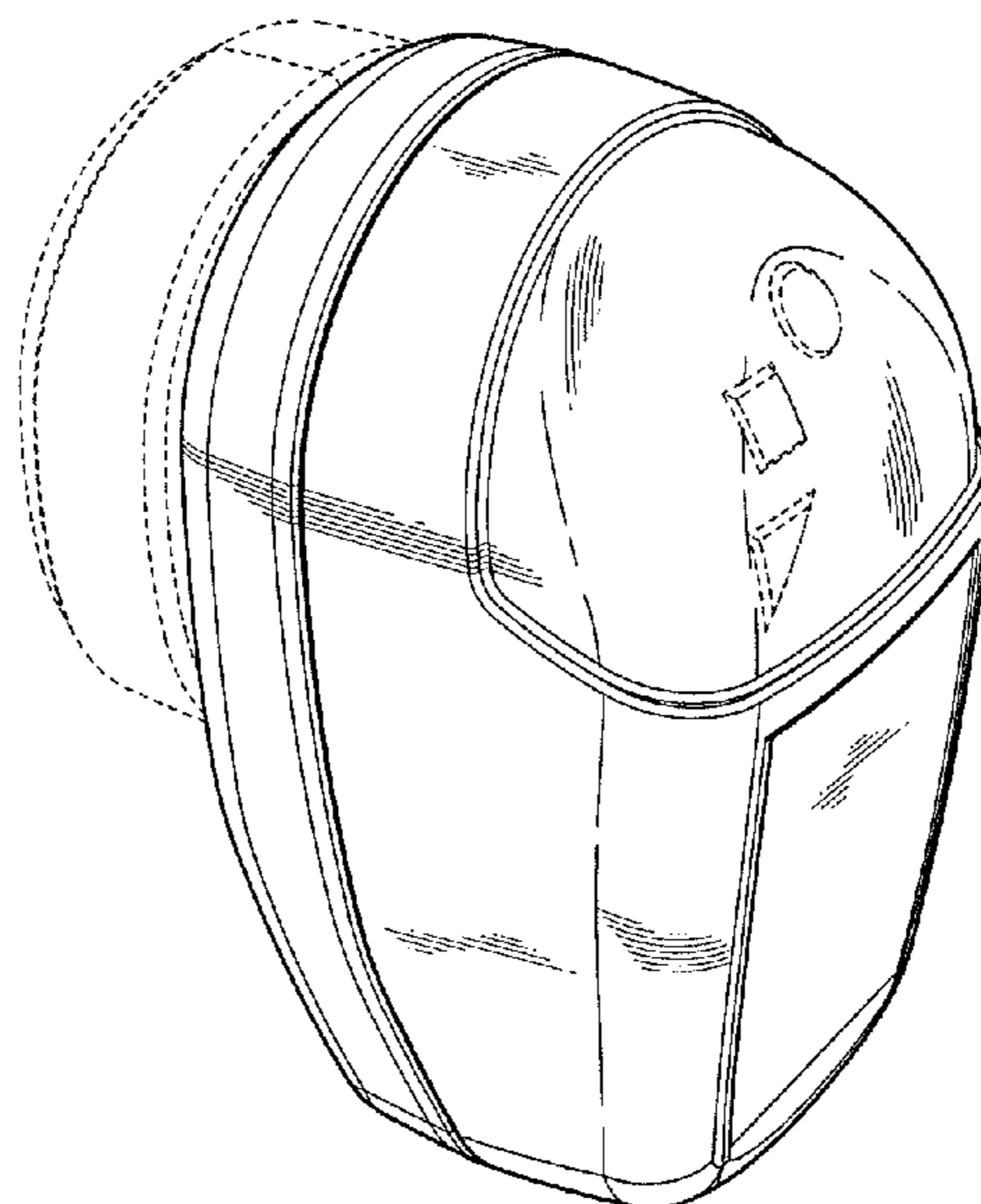

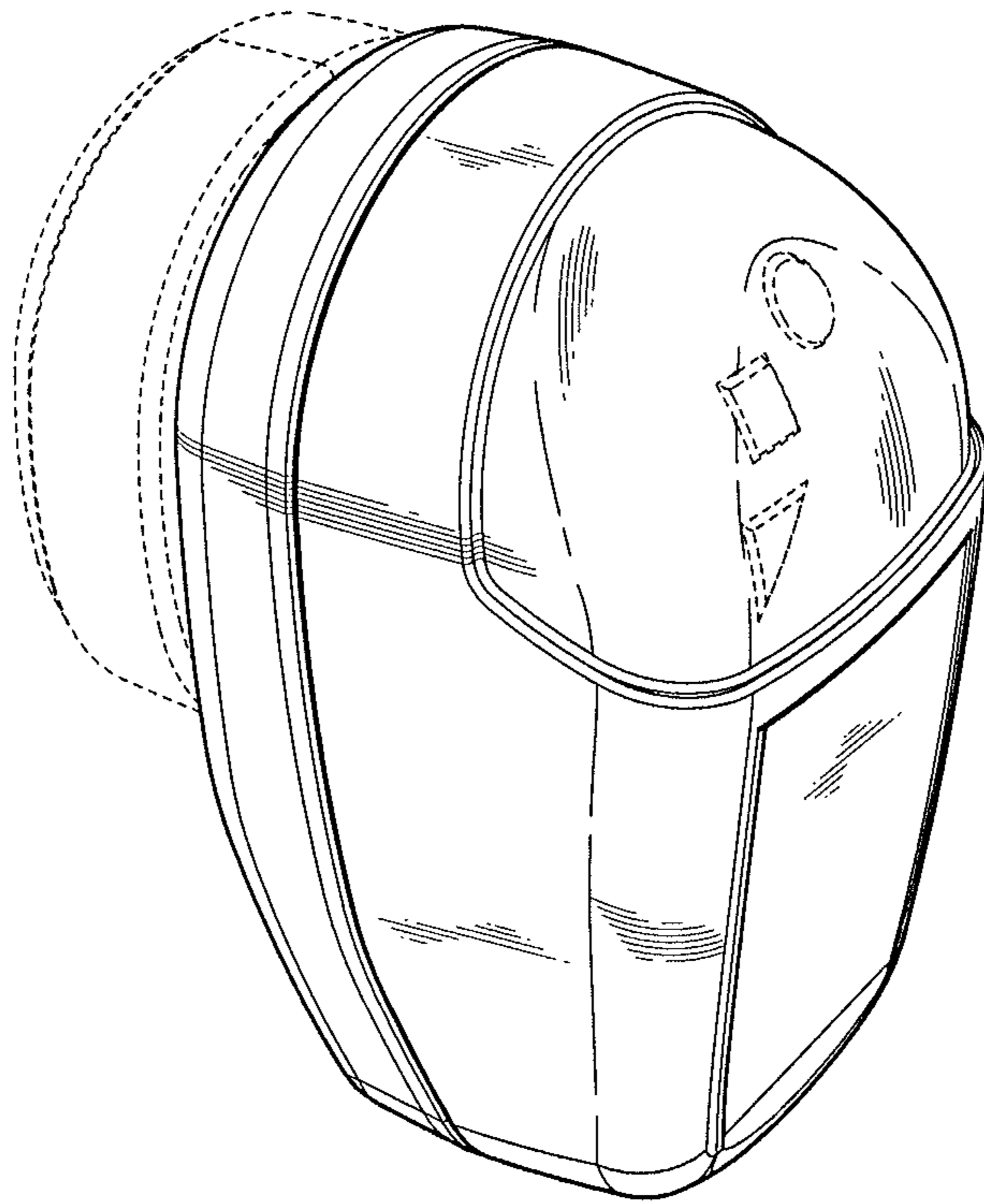
The ornamental design for a fluid control valve actuator, as shown and described.

**DESCRIPTION**

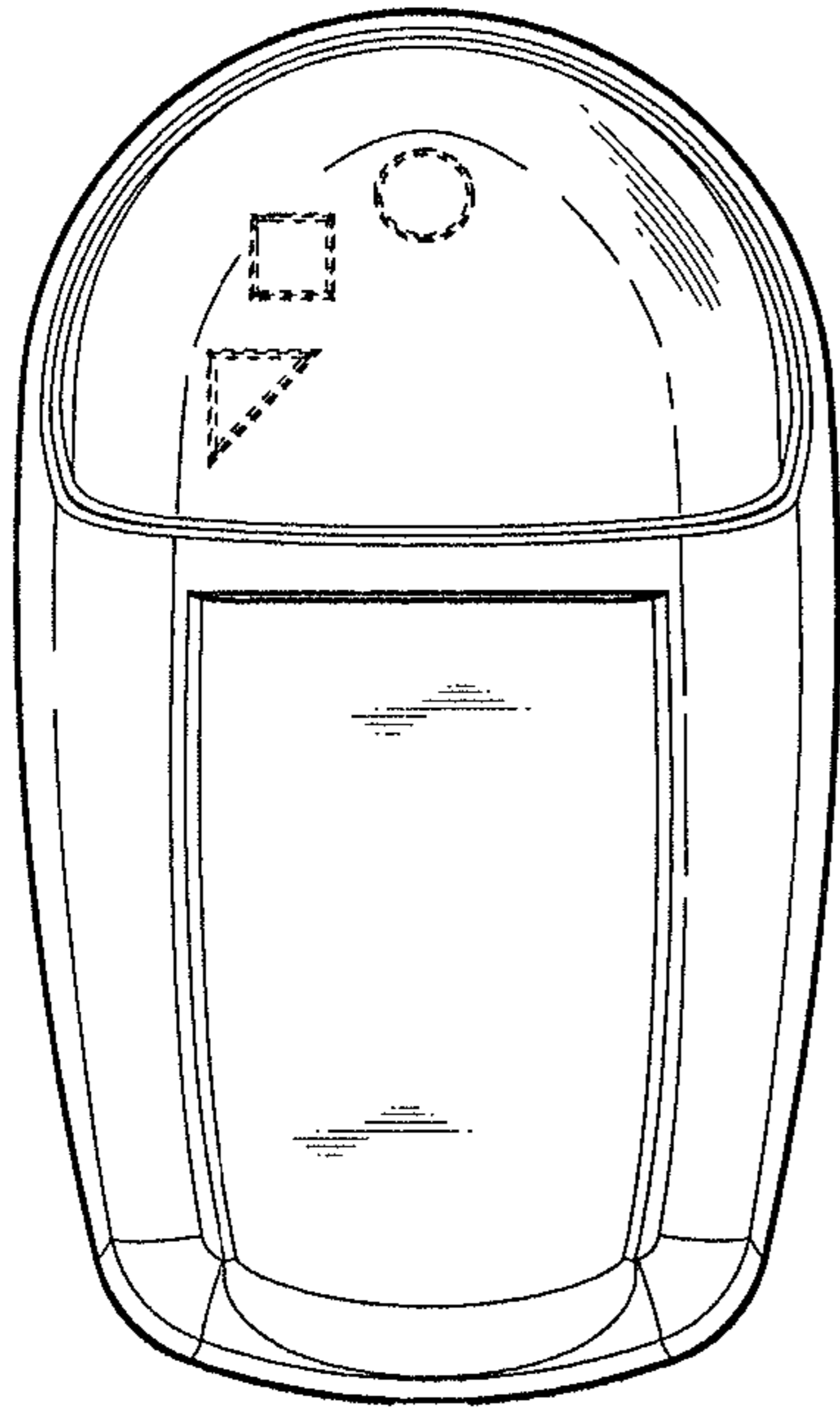
FIG. 1 is a perspective view of a fluid control valve actuator showing our new design;

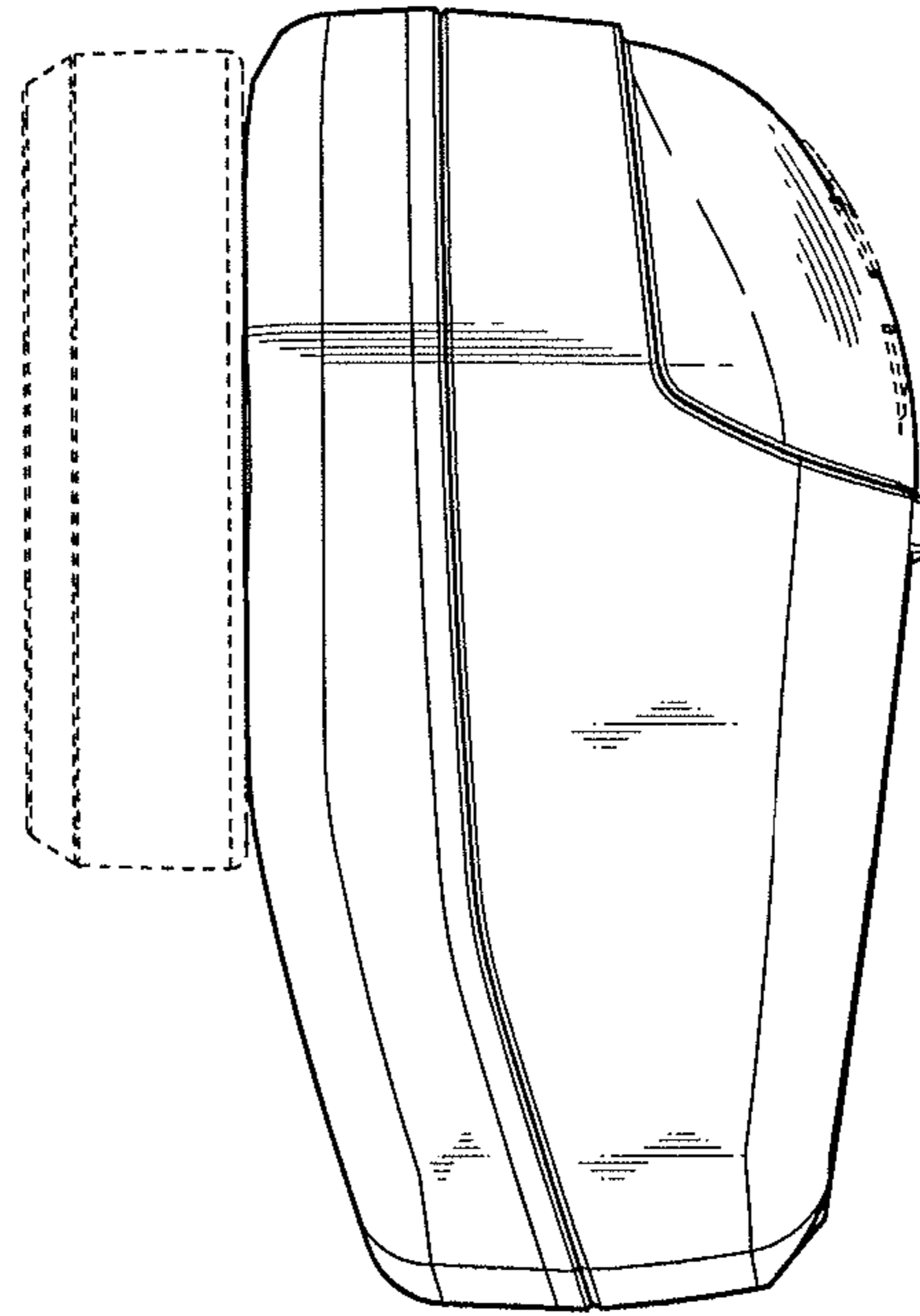




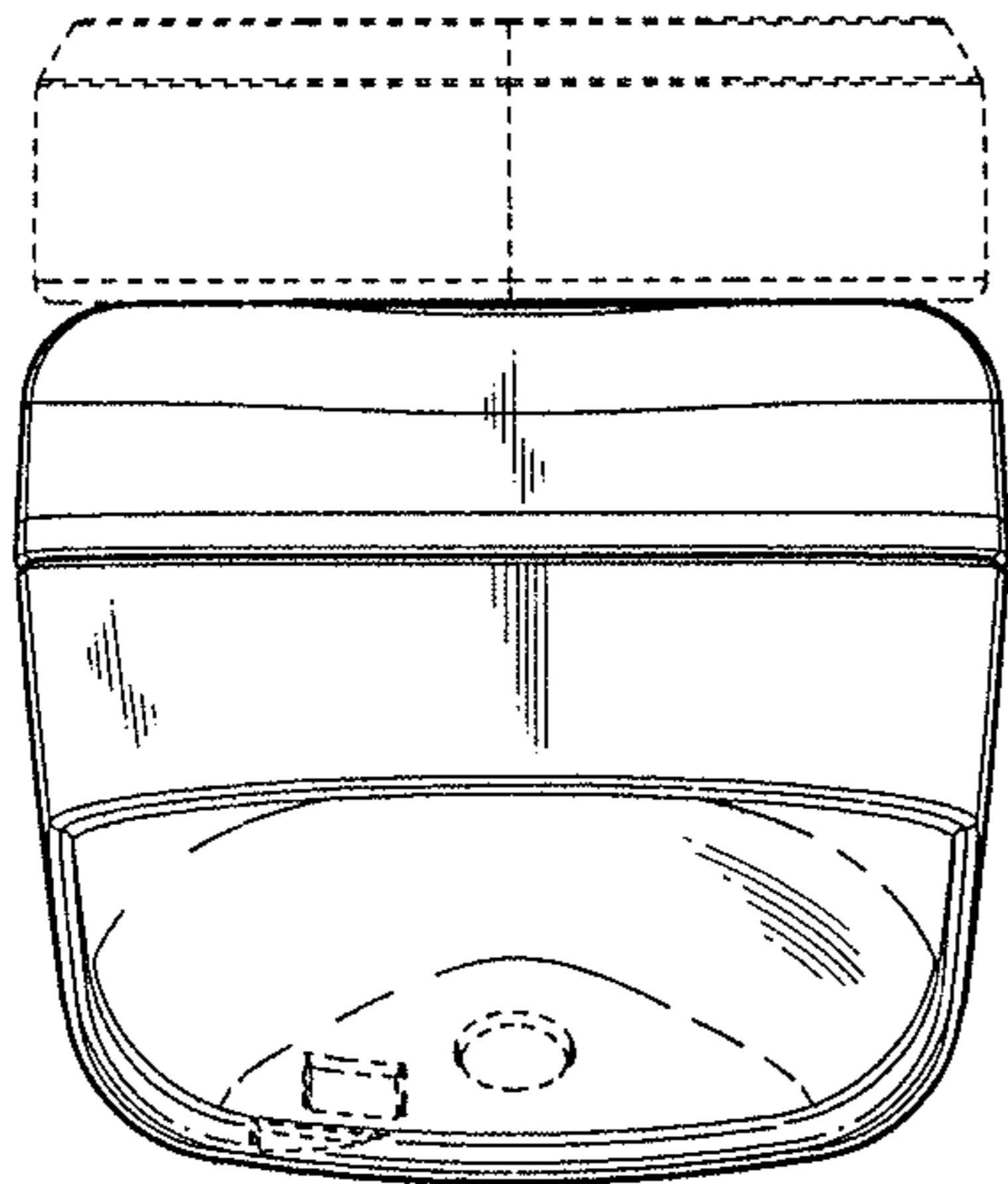

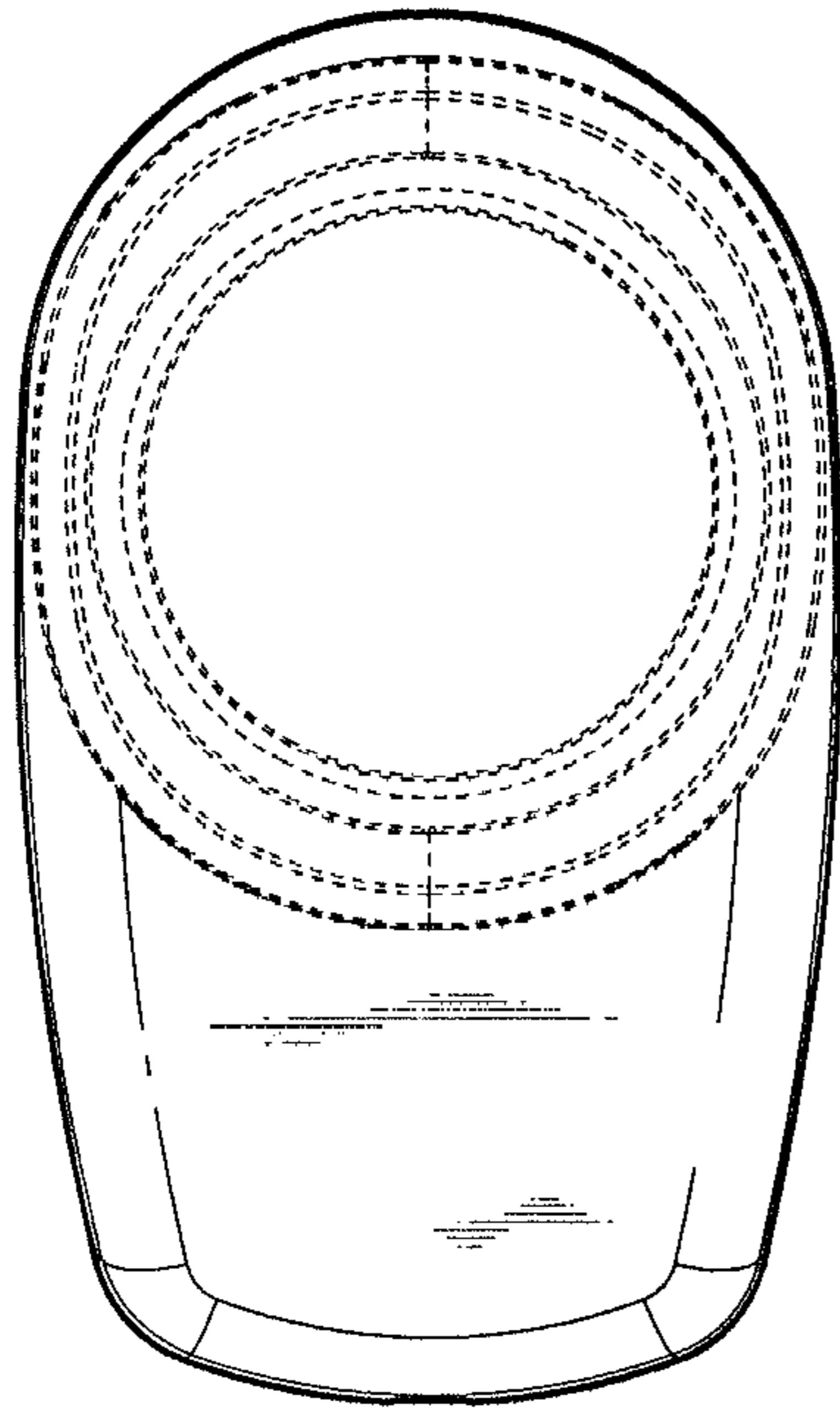

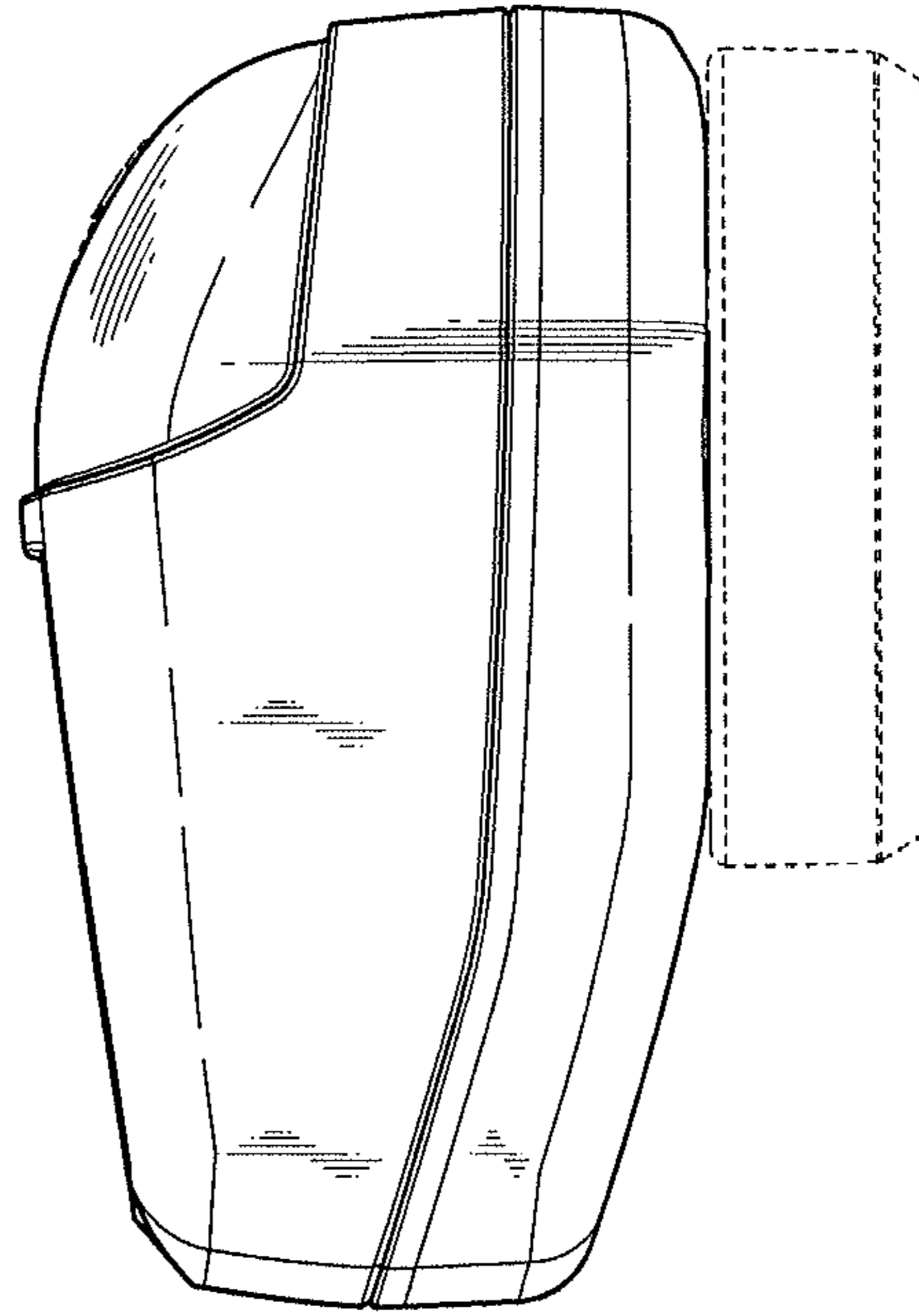

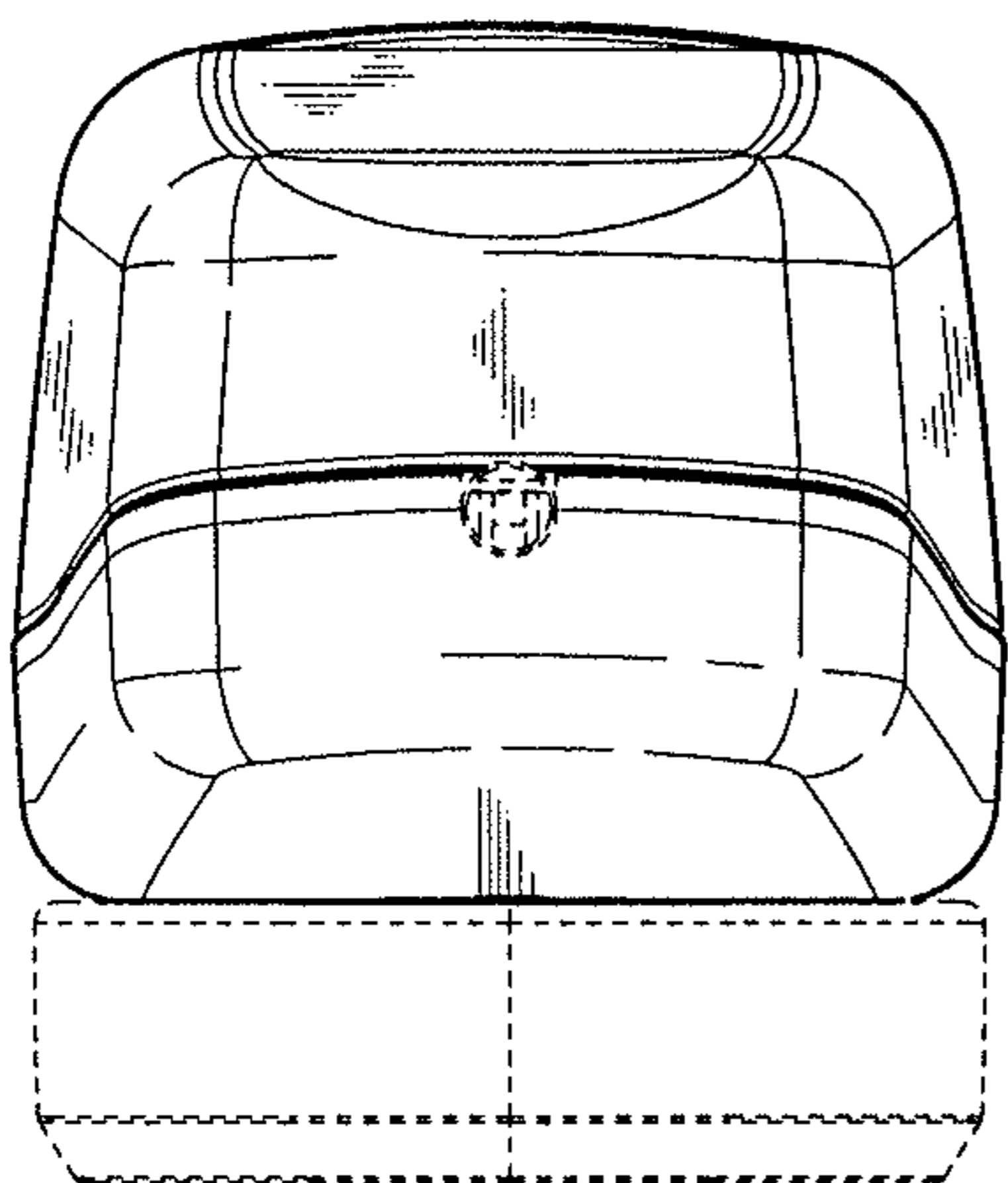
