The ornamental design for an electronic wristband, as shown and described.

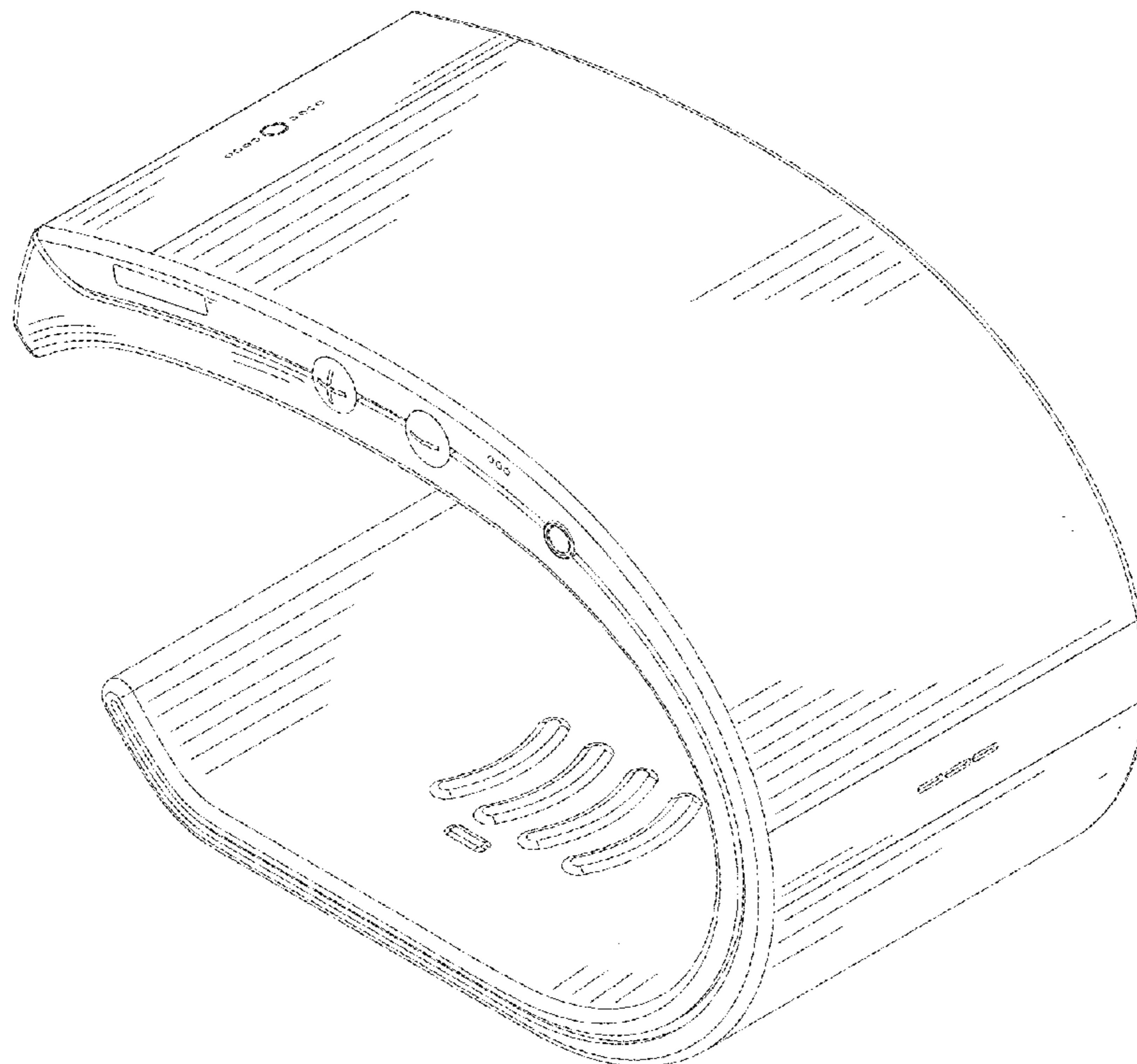
DESCRIPTION

FIG. 1 is a perspective view of the electronic wristband; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a rear perspective view thereof; FIG. 4 is a front plane view thereof; FIG. 5 is a rear plane view thereof; FIG. 6 is a left plane view thereof; FIG. 7 is a right plane view thereof; FIG. 8 is a top plane view thereof; FIG. 9 is a bottom plane view thereof; and, FIG. 10 shows how the electronic wristband is worn around the wrist.

The broken line showing an arm in FIG. 10 is included for the purpose of illustrating environmental structure and forms no part of the claimed design.

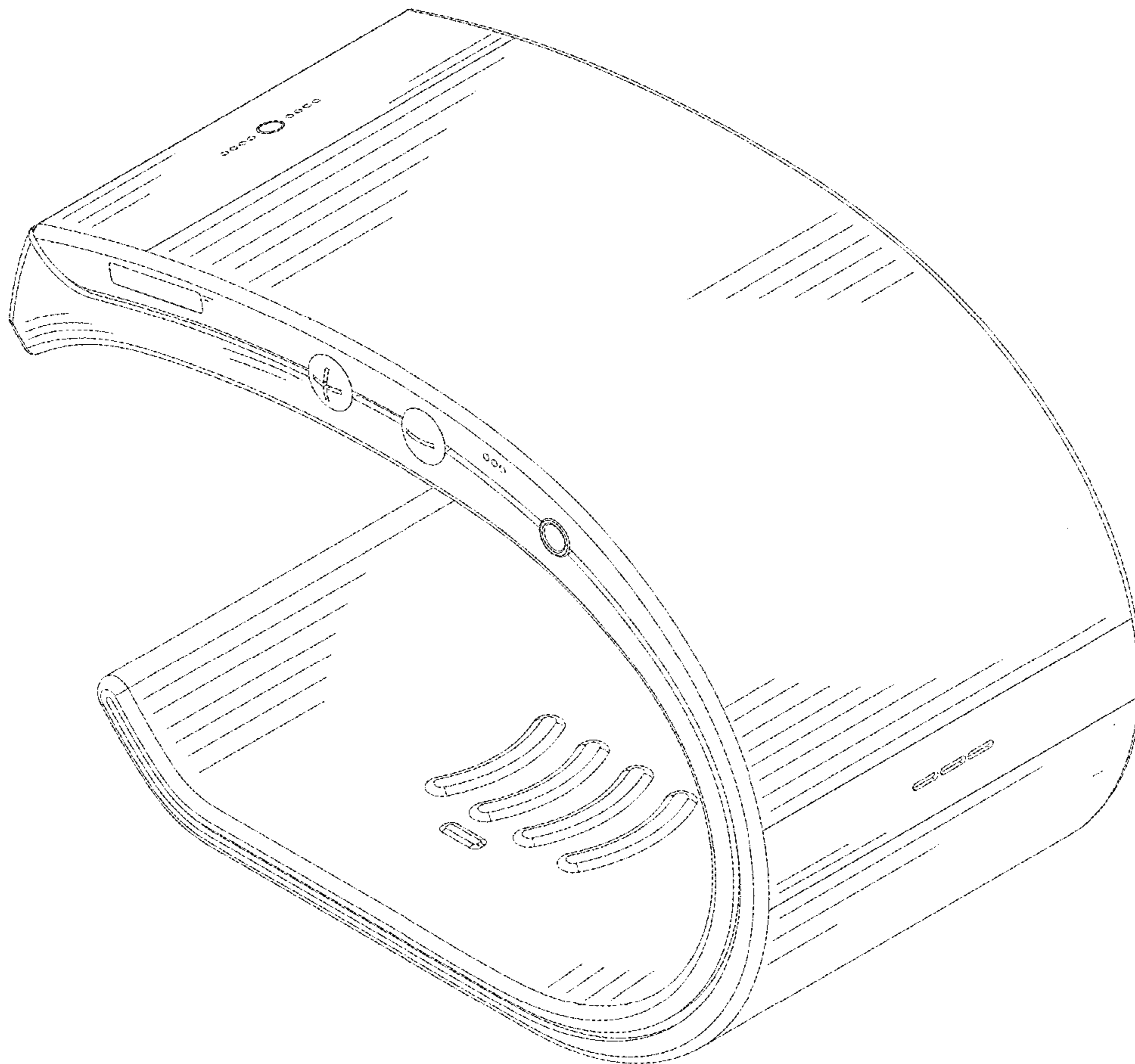

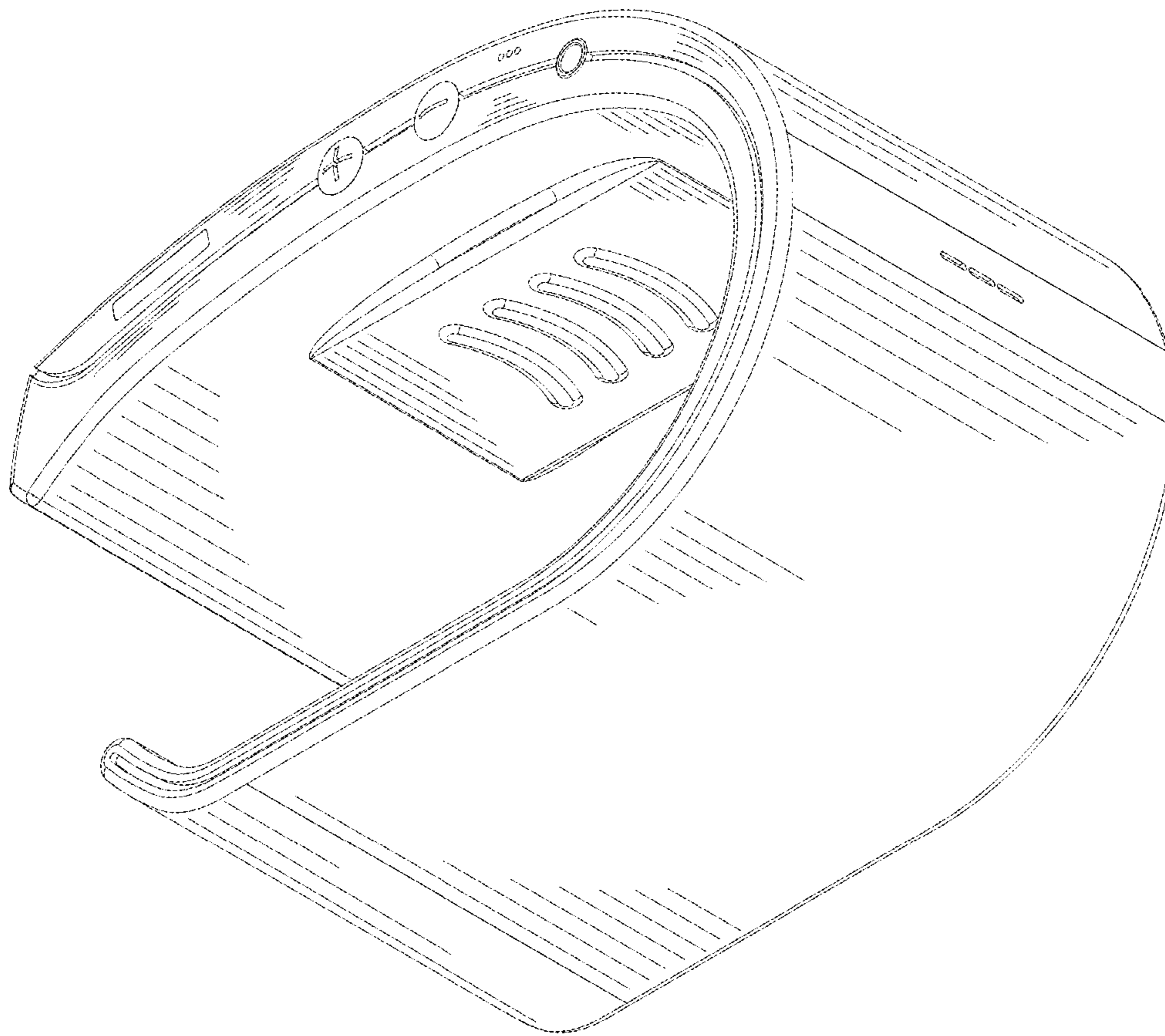

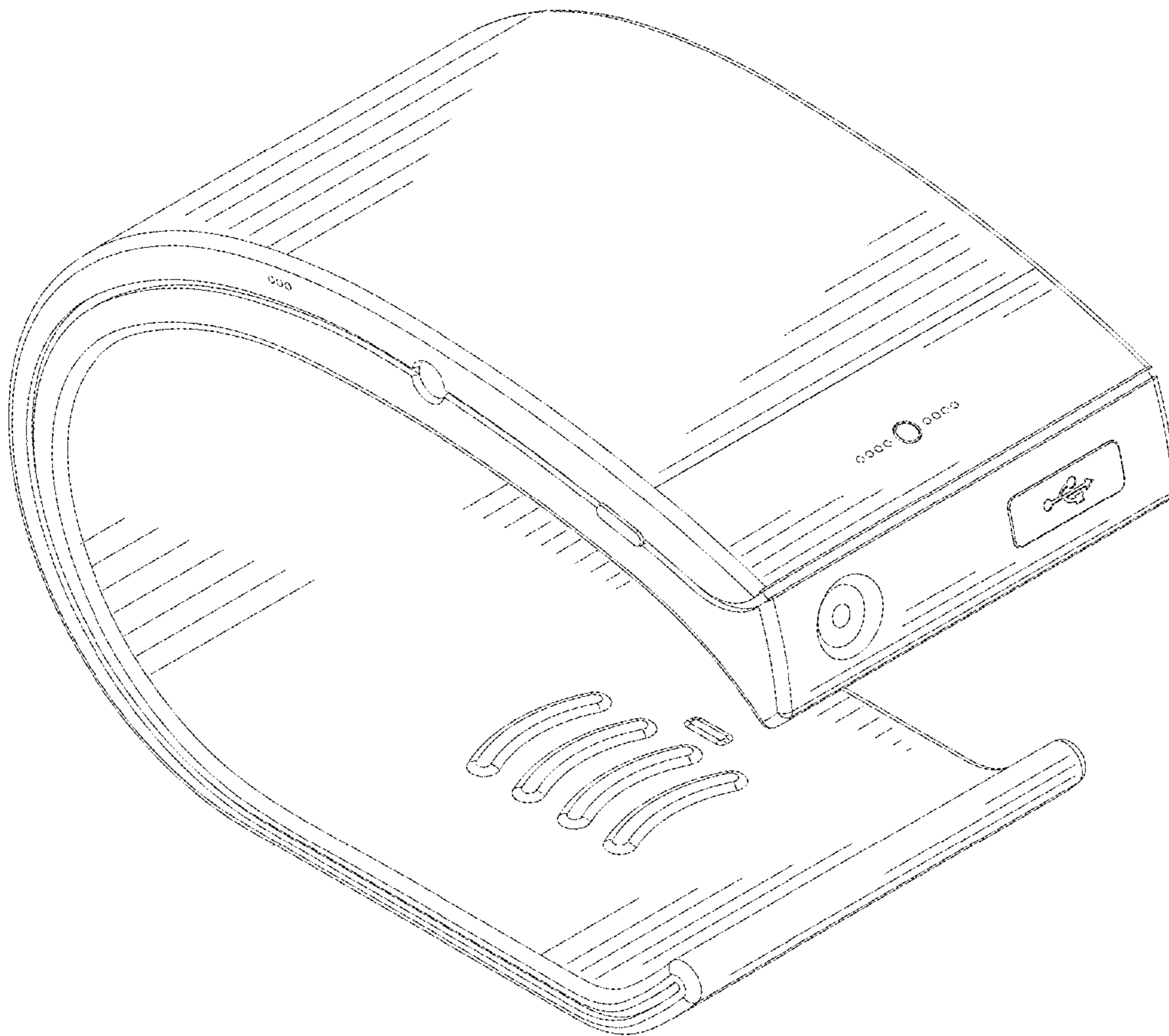

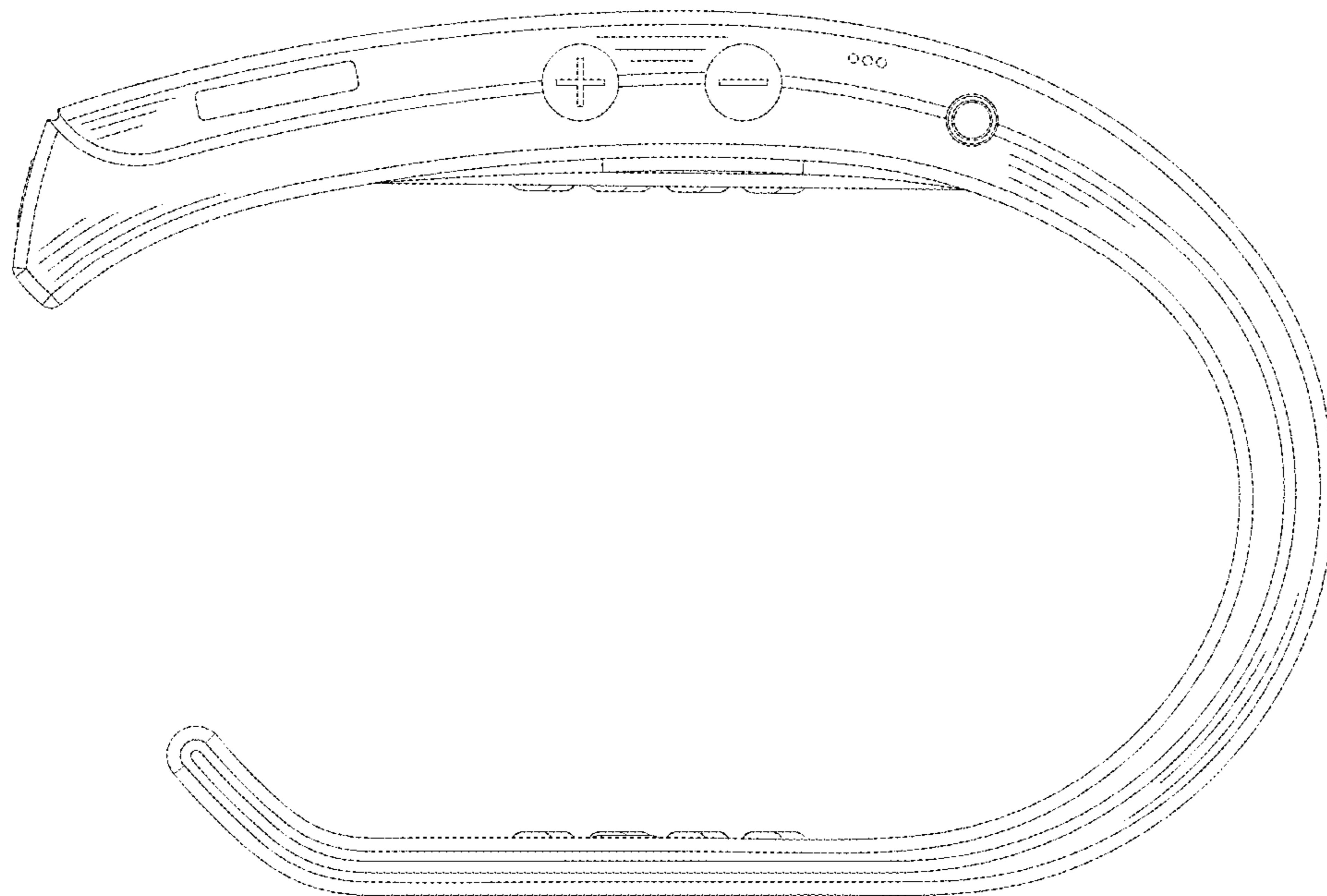

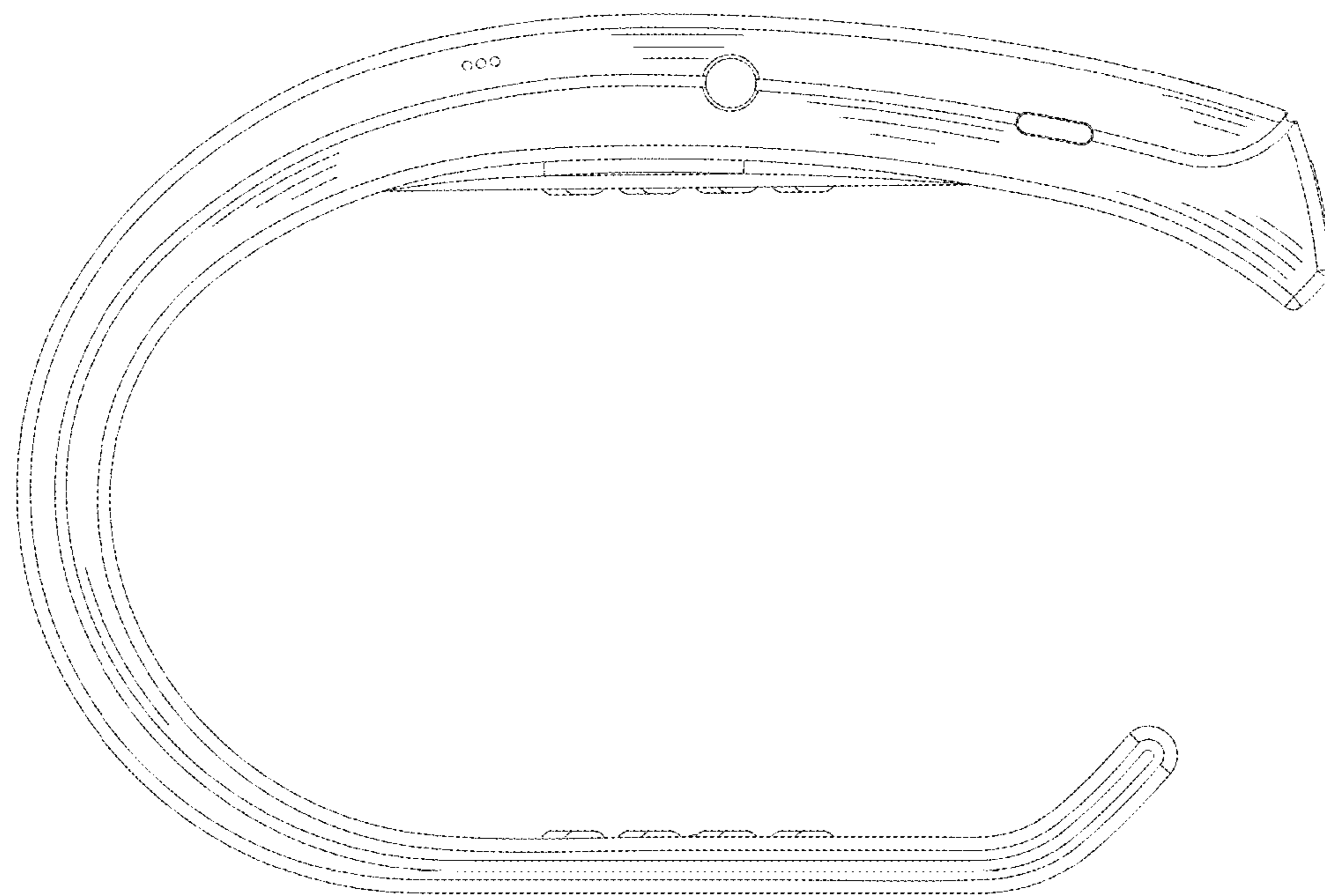

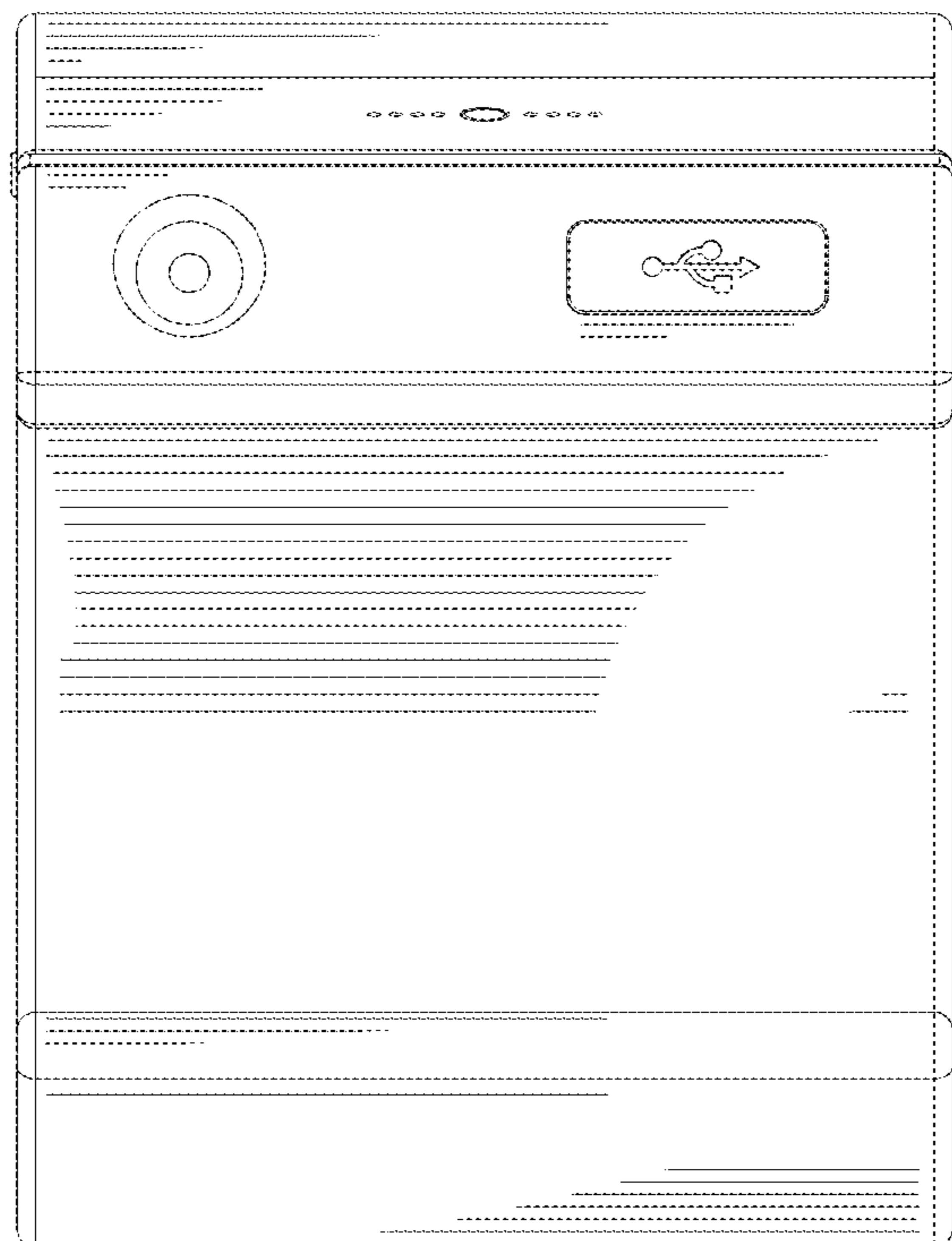

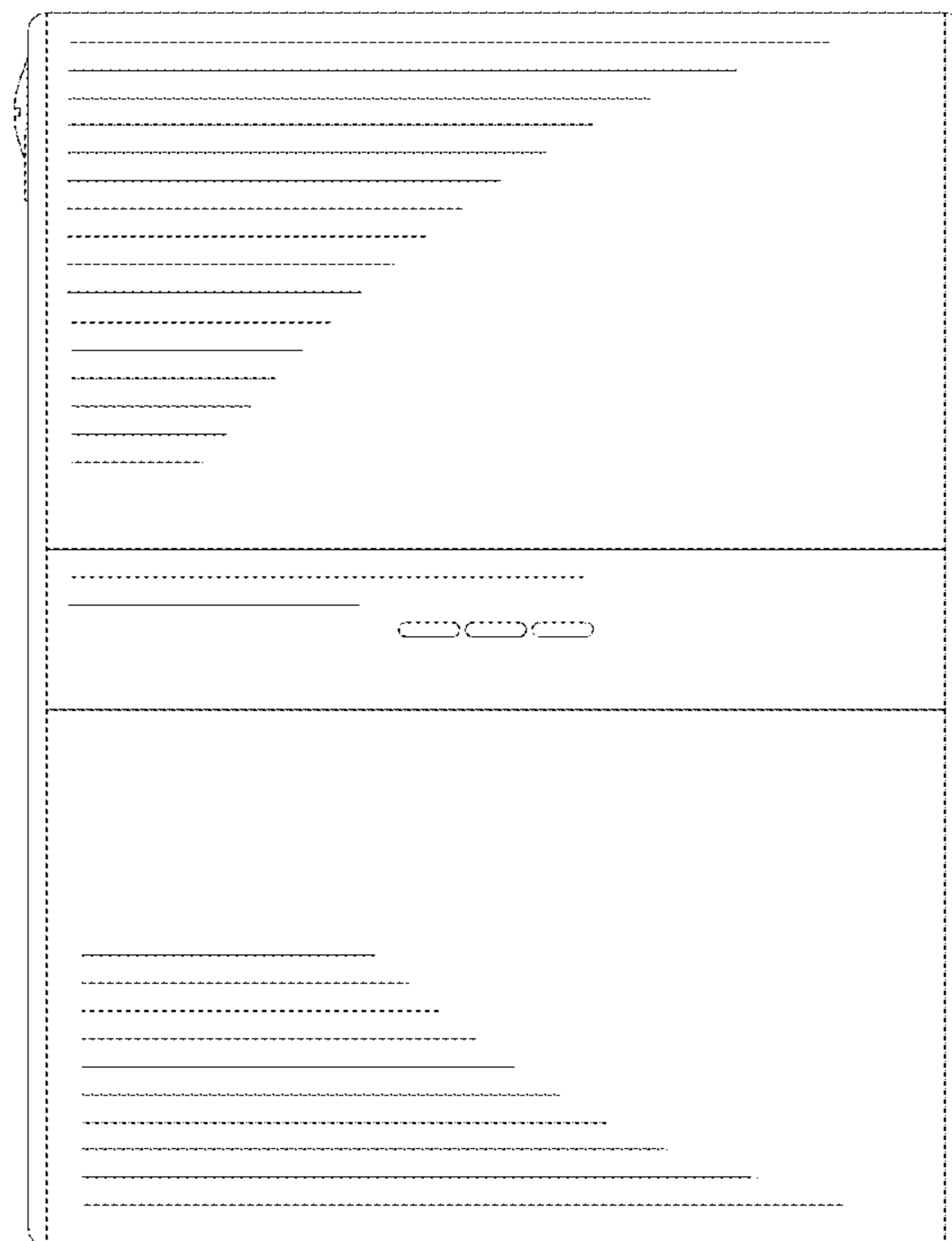

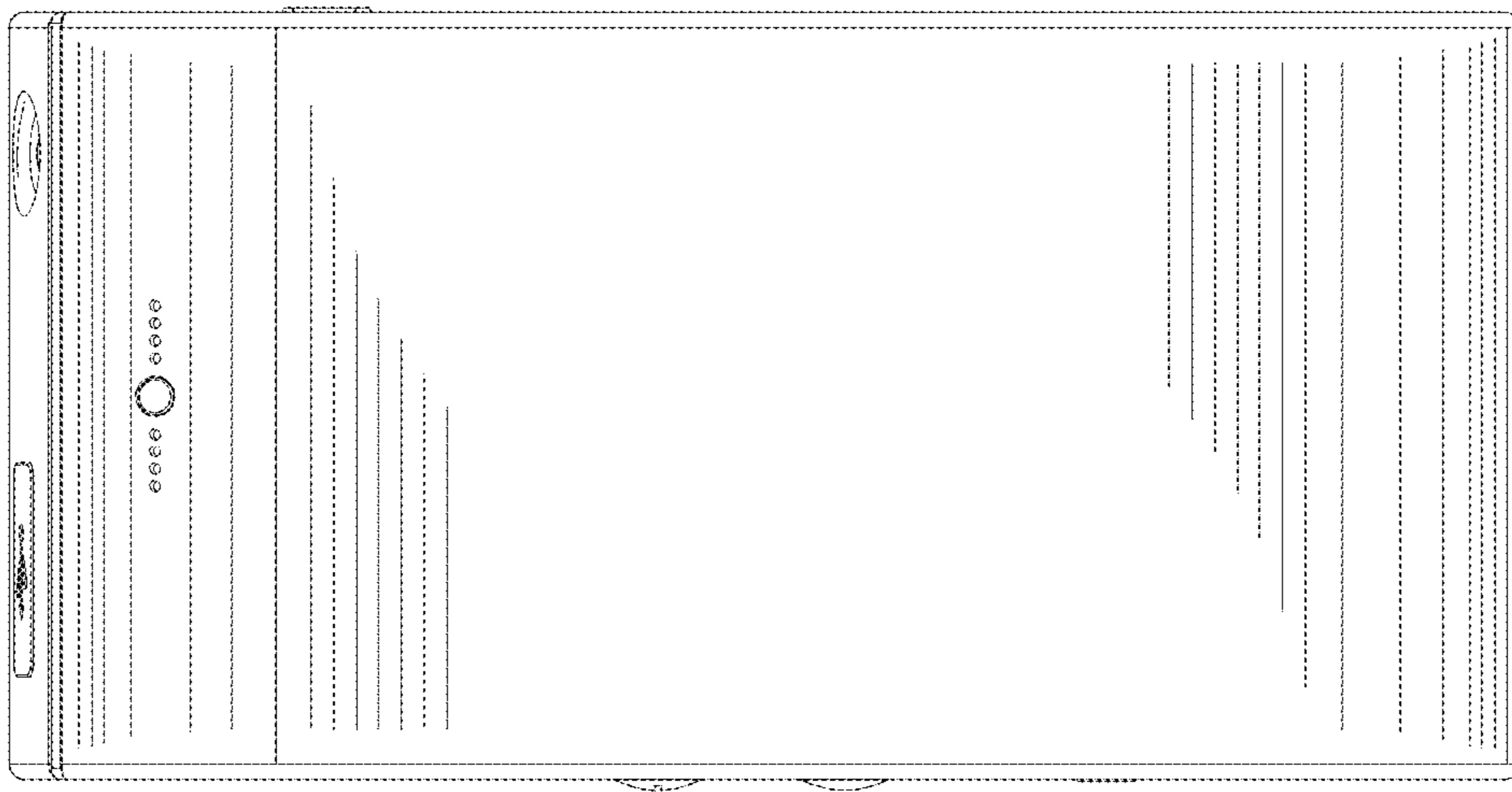

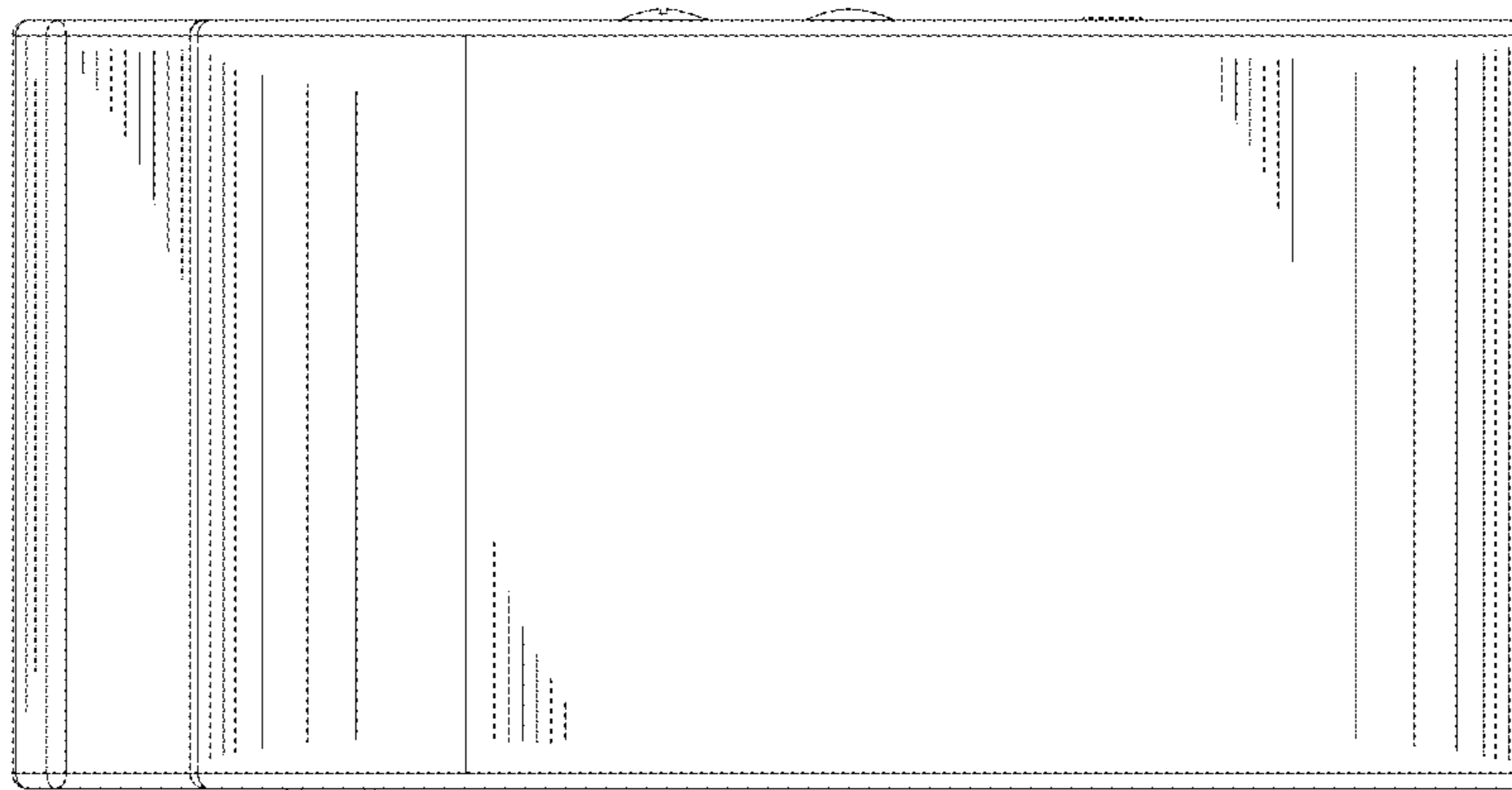

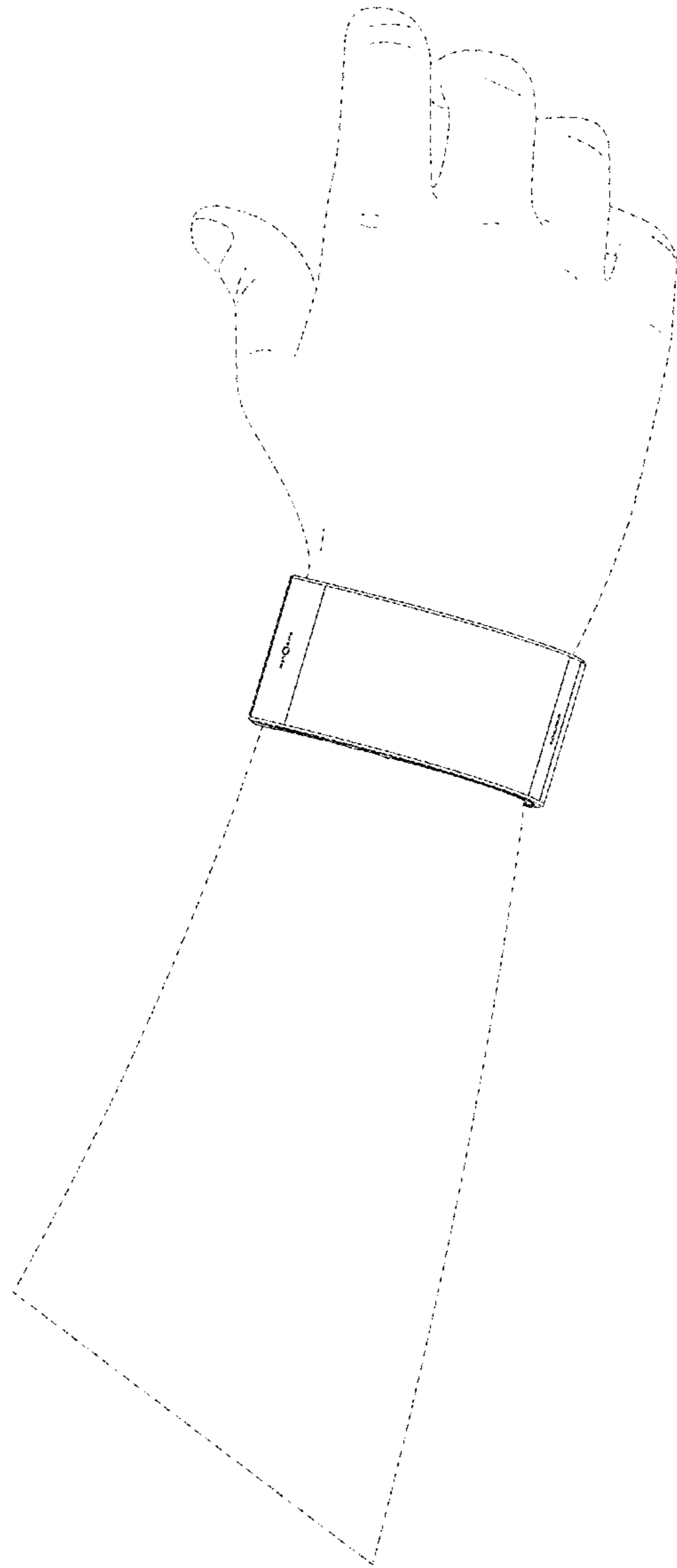
