DESCRIPTION

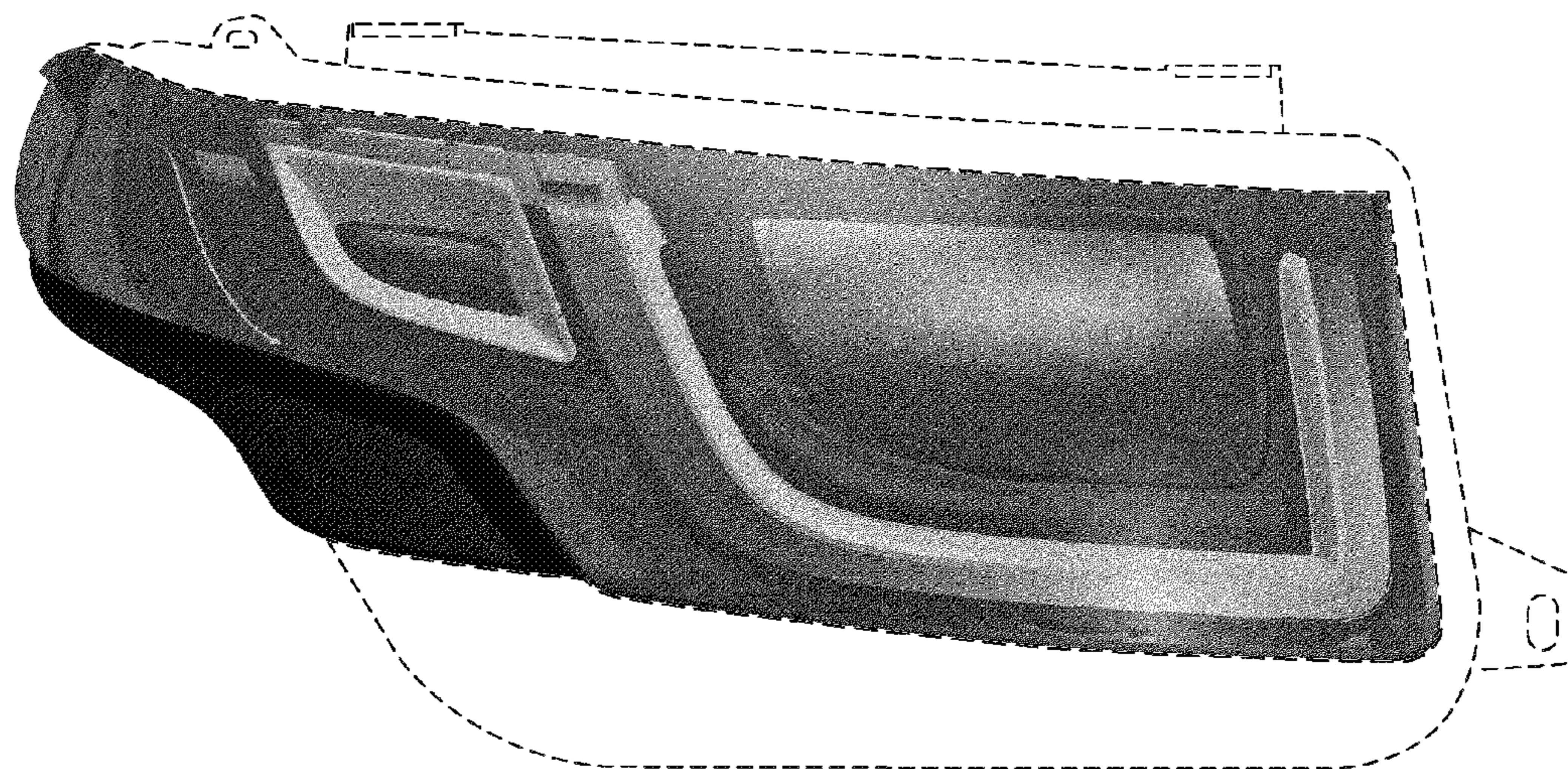
FIG. 1 is a front view of the head lamp of the present invention.

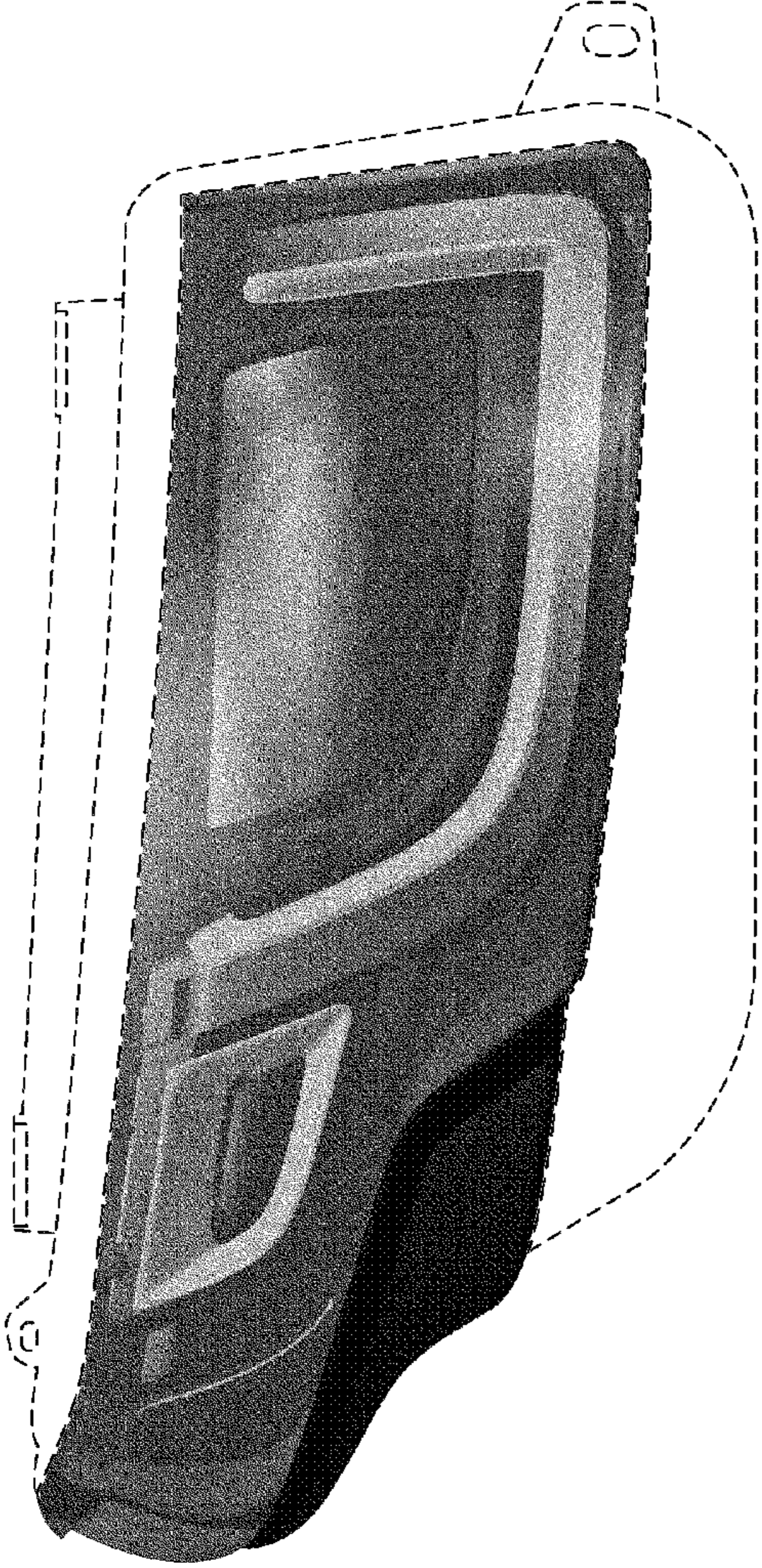

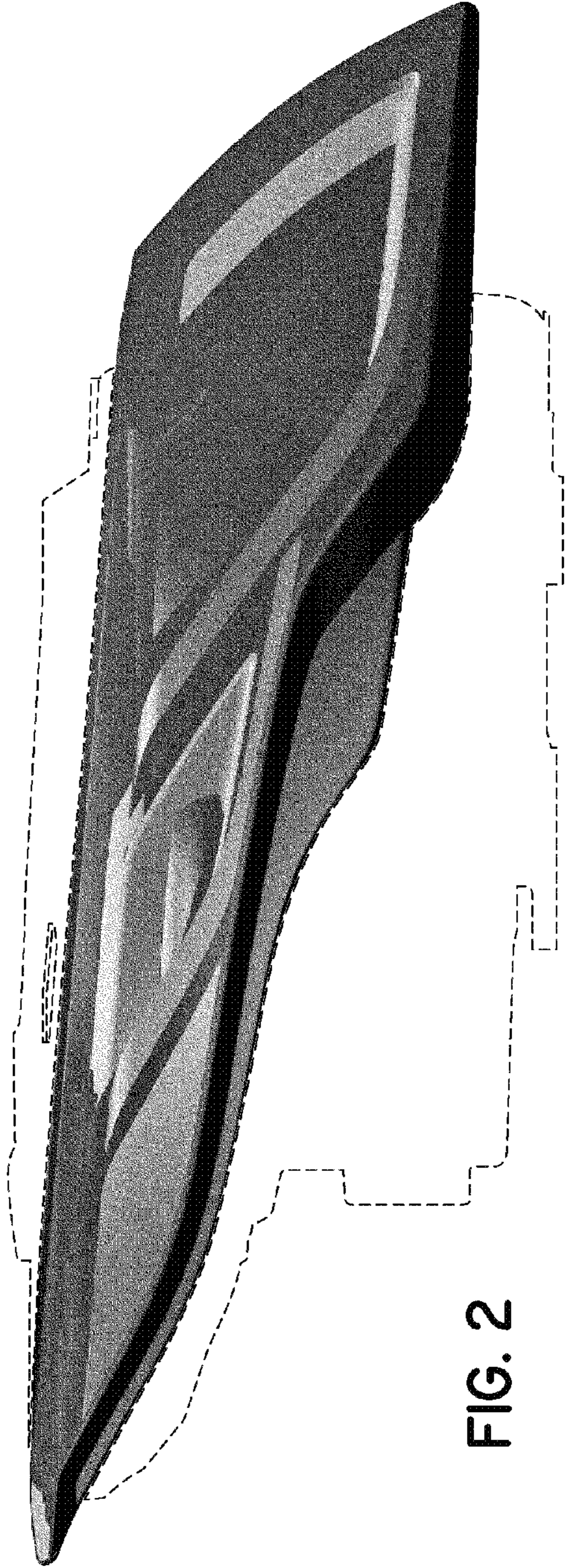

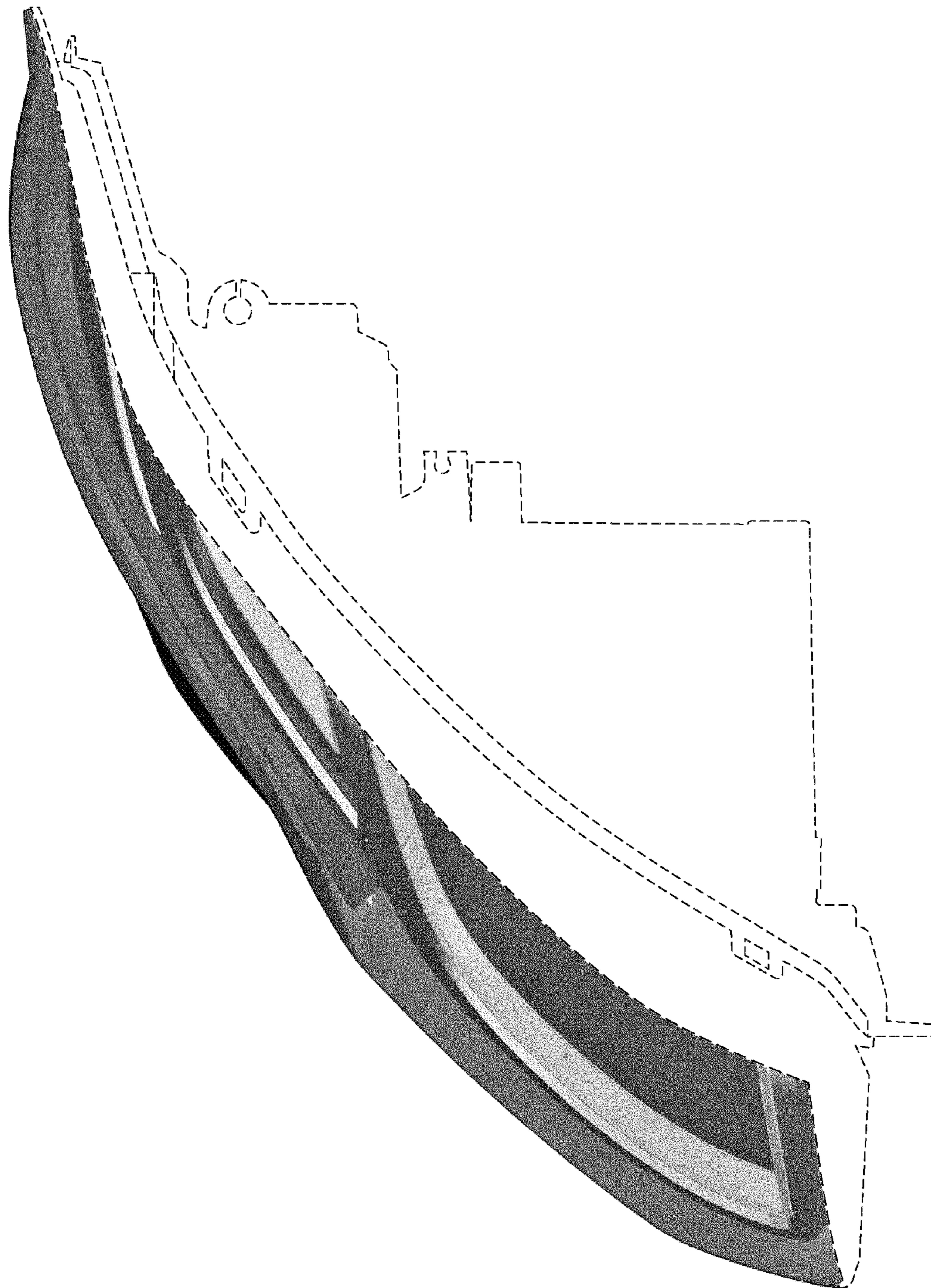
