FIG. 4 is a top side elevation view thereof;

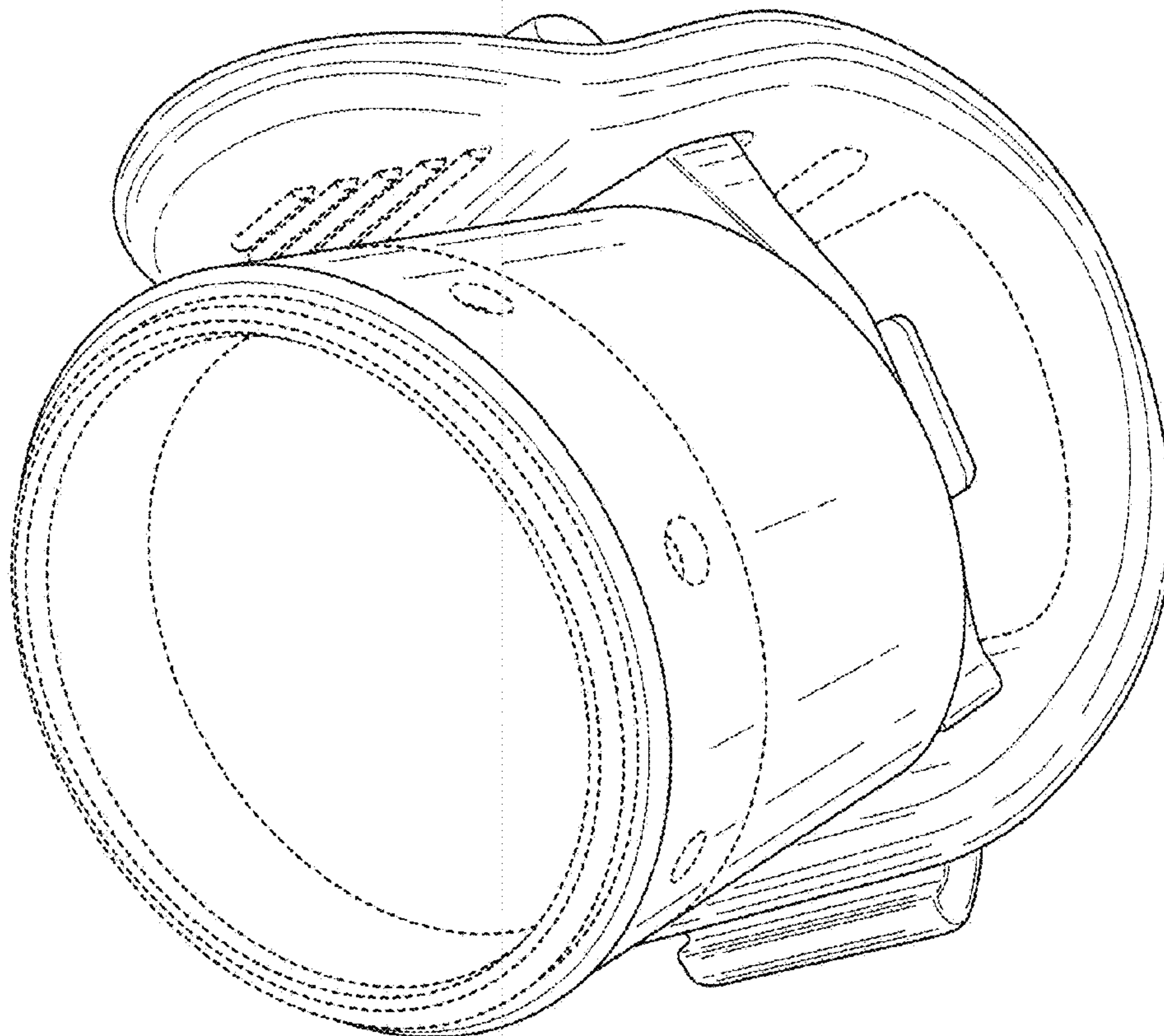
FIG. 5 is a bottom plan elevation view thereof;

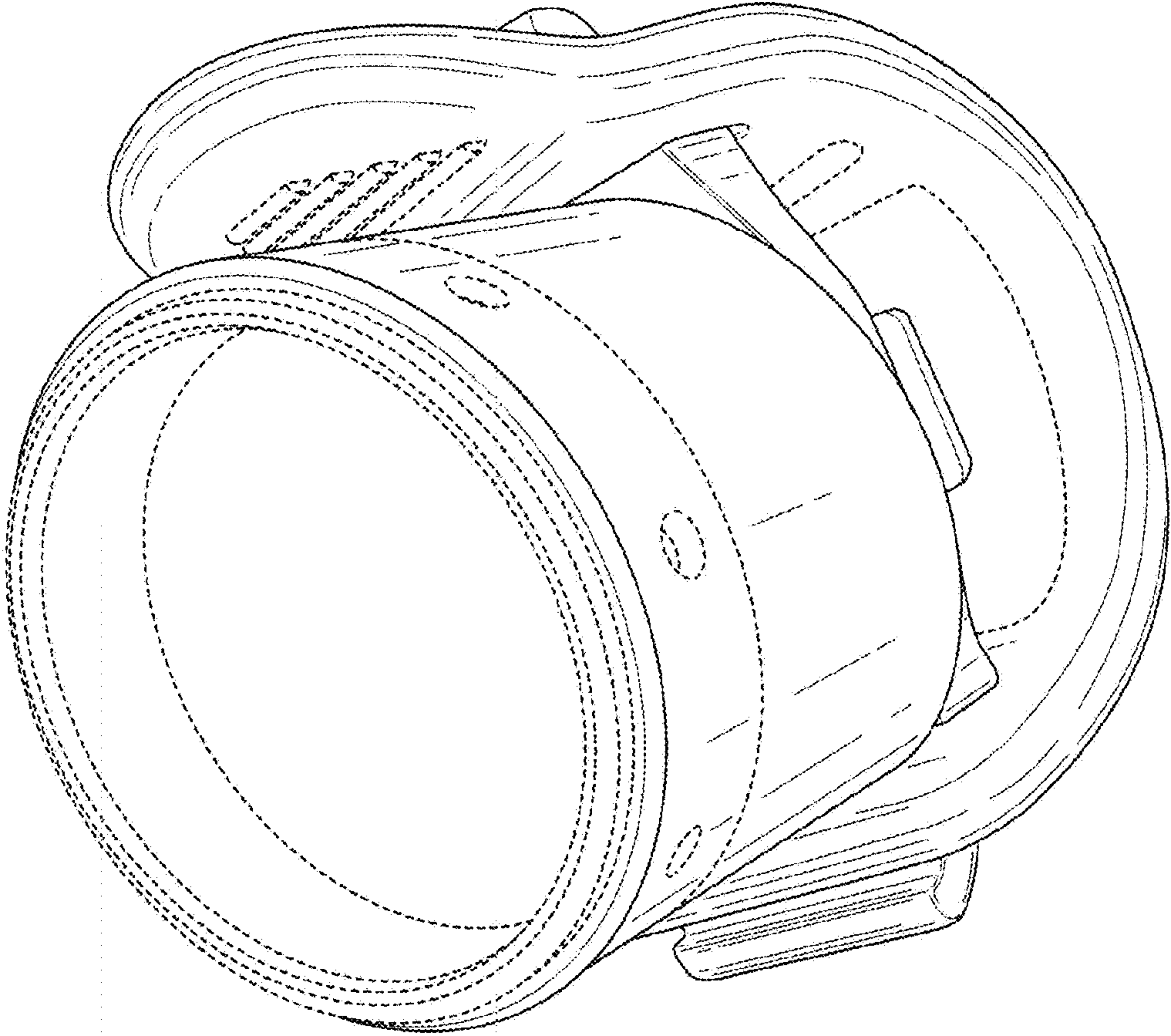

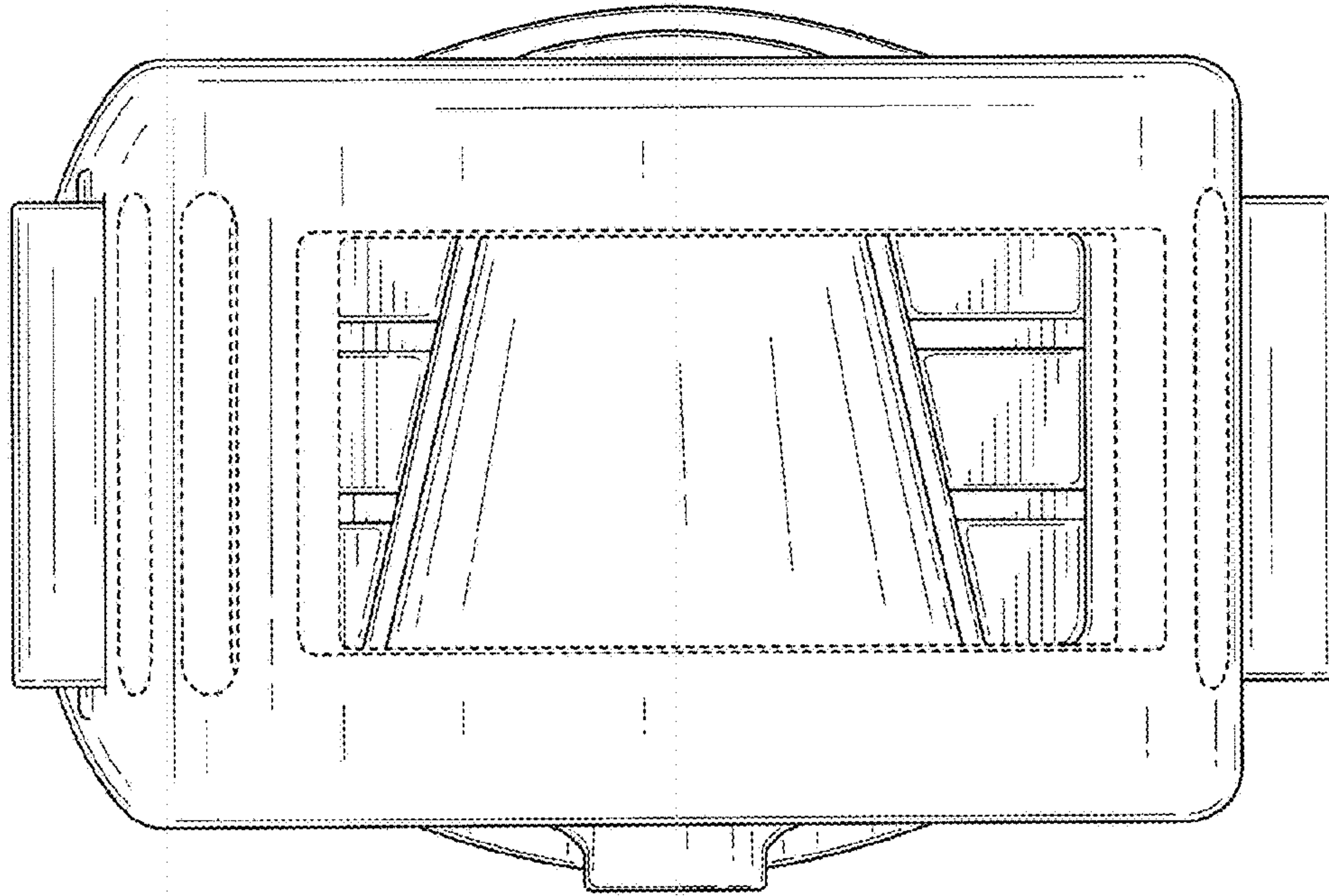

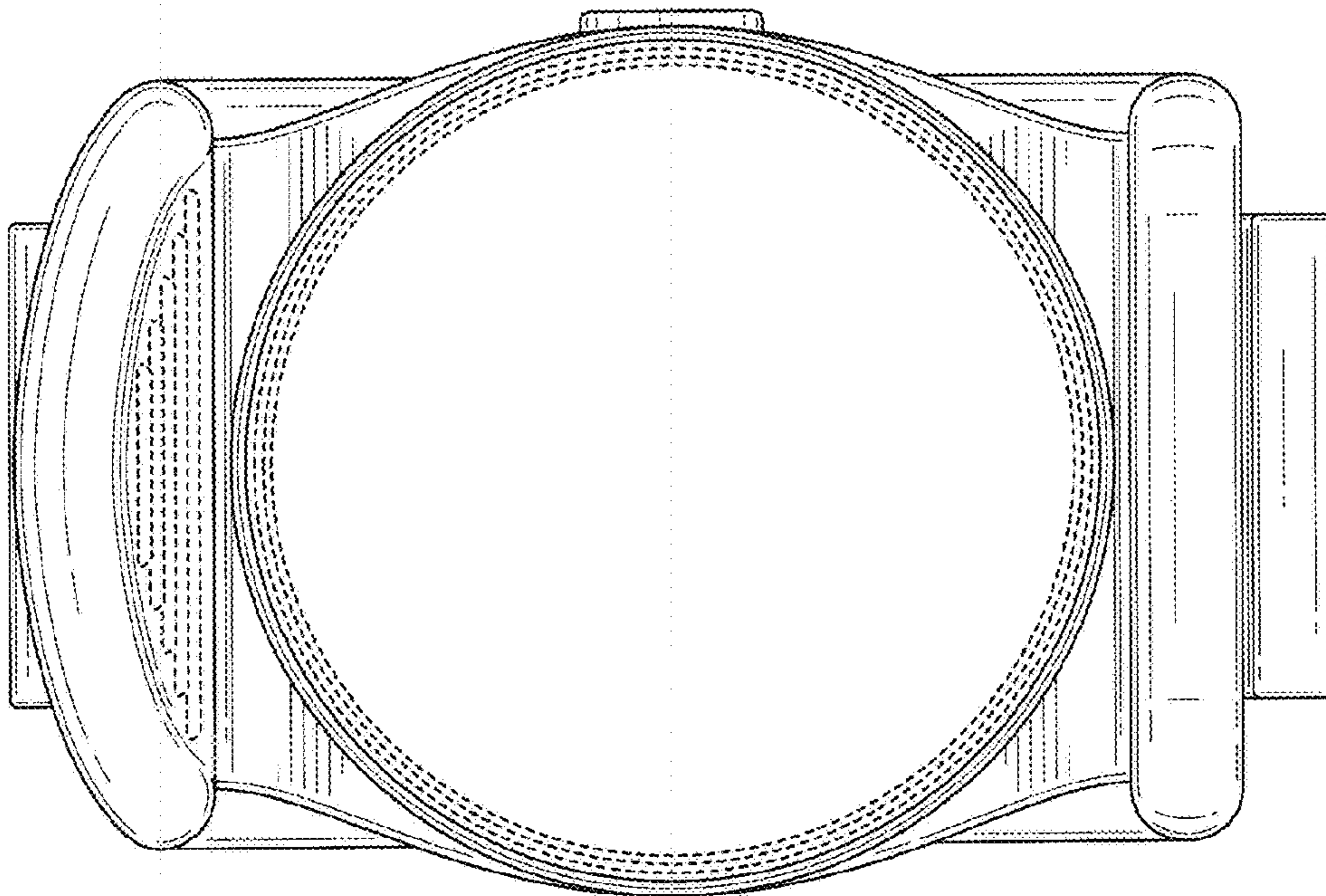

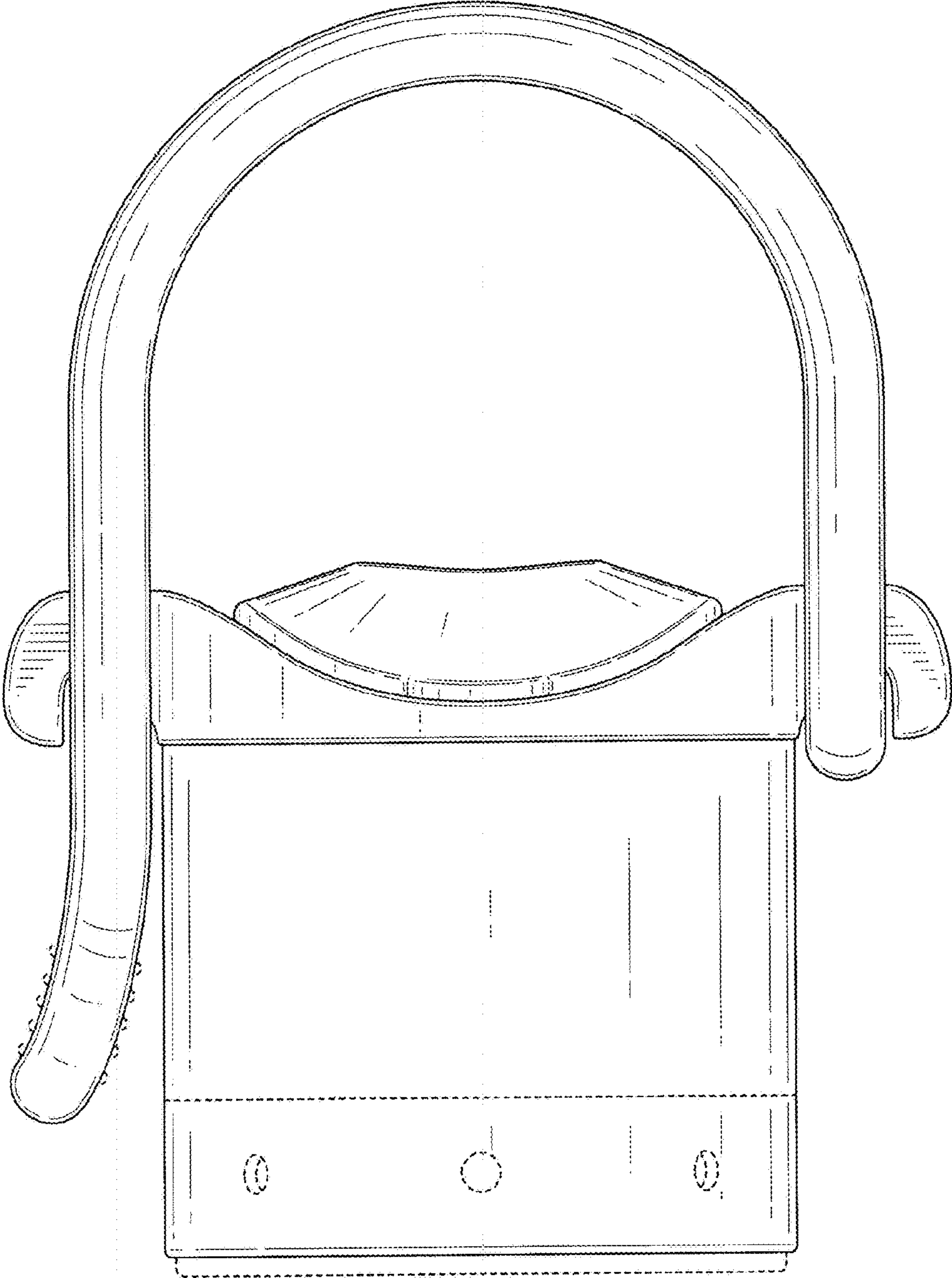

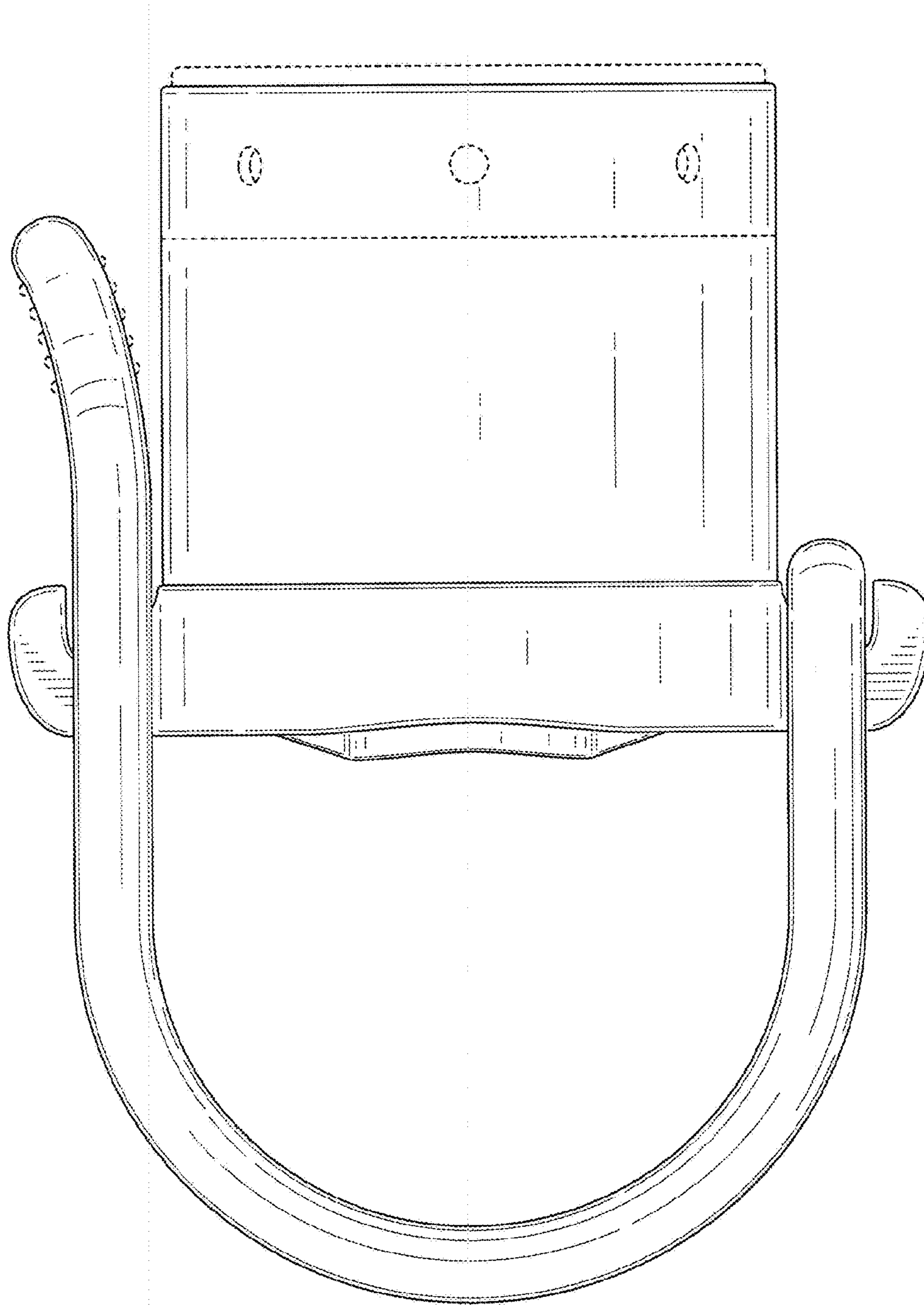

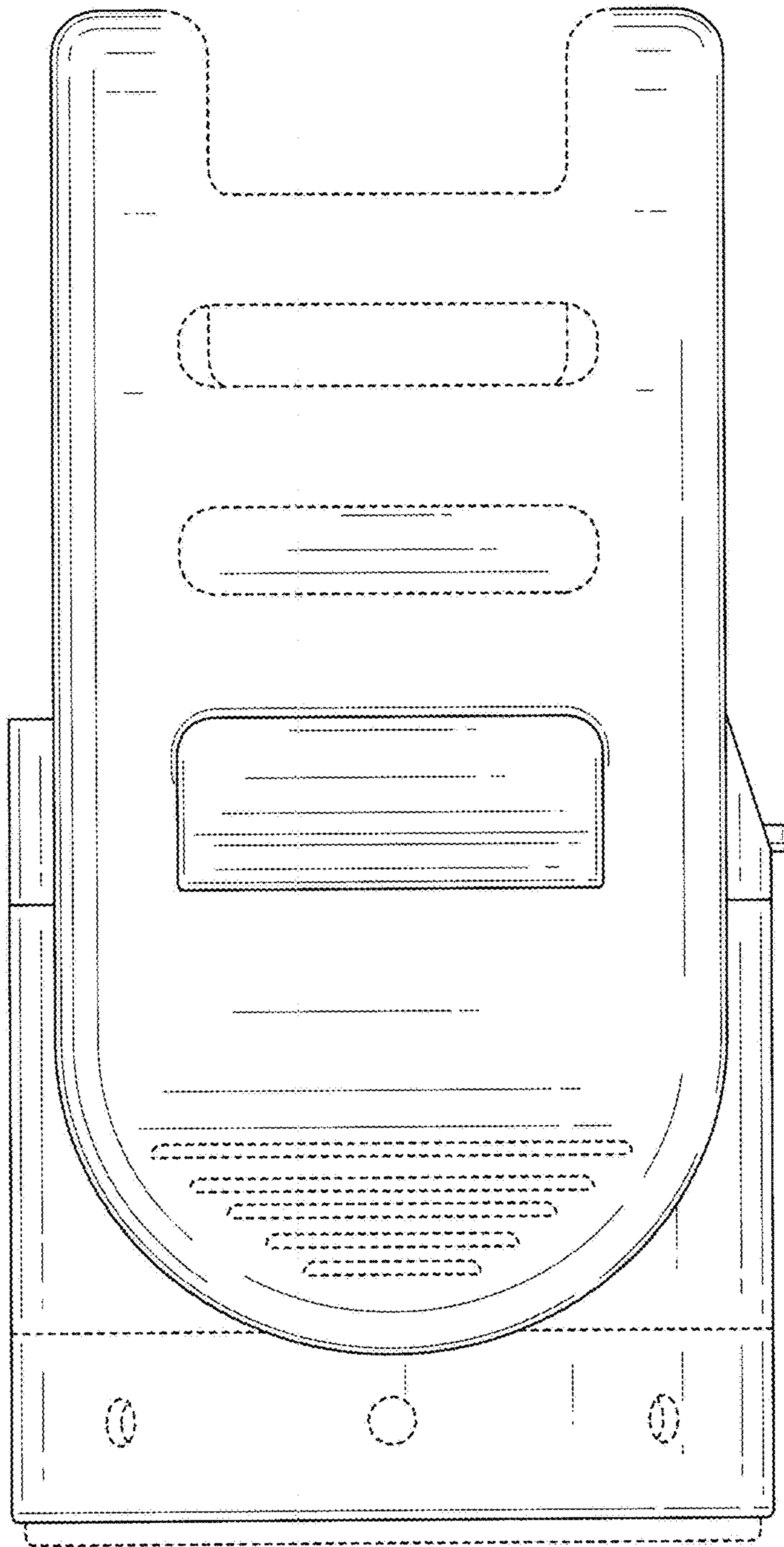

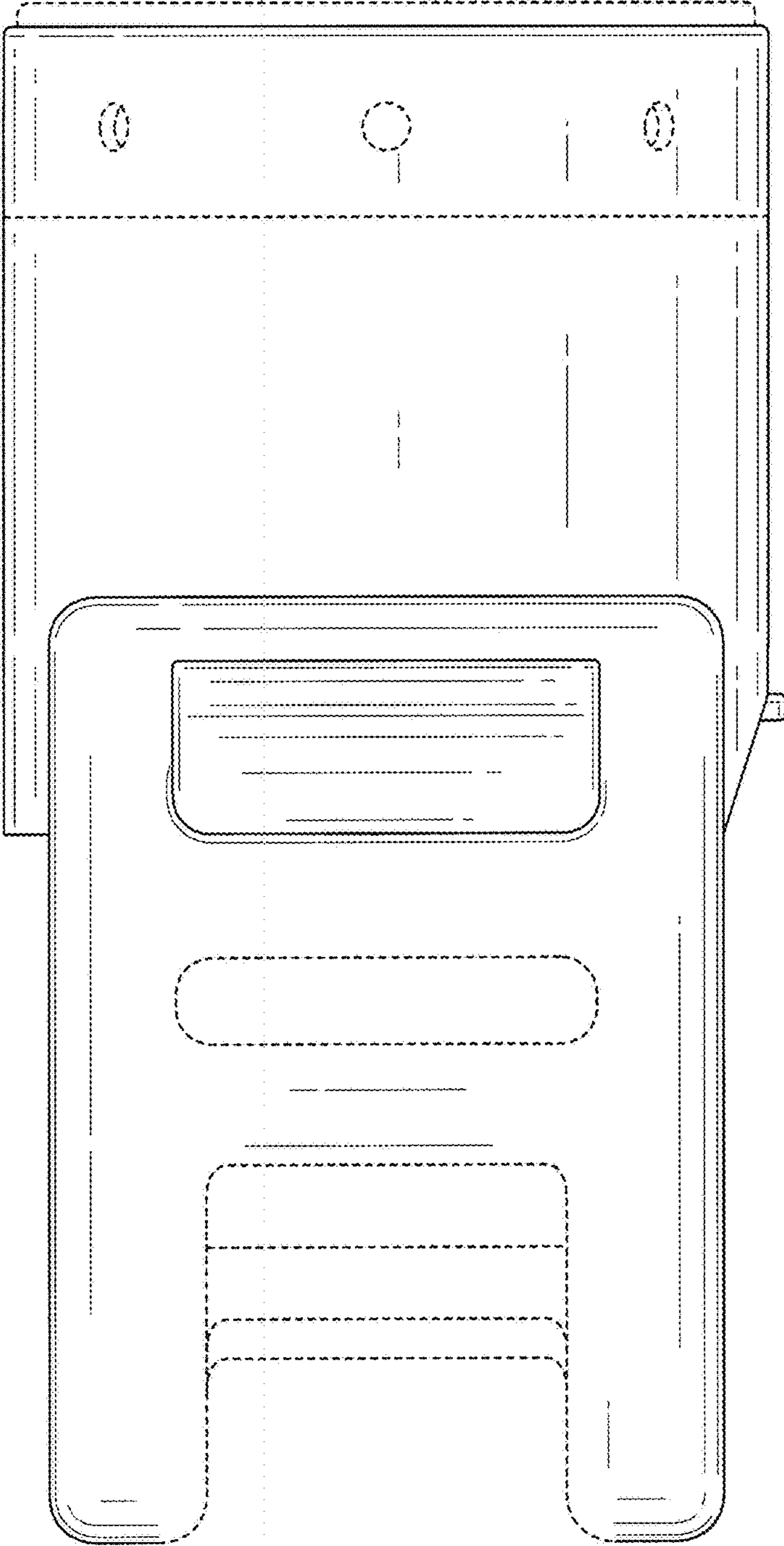
