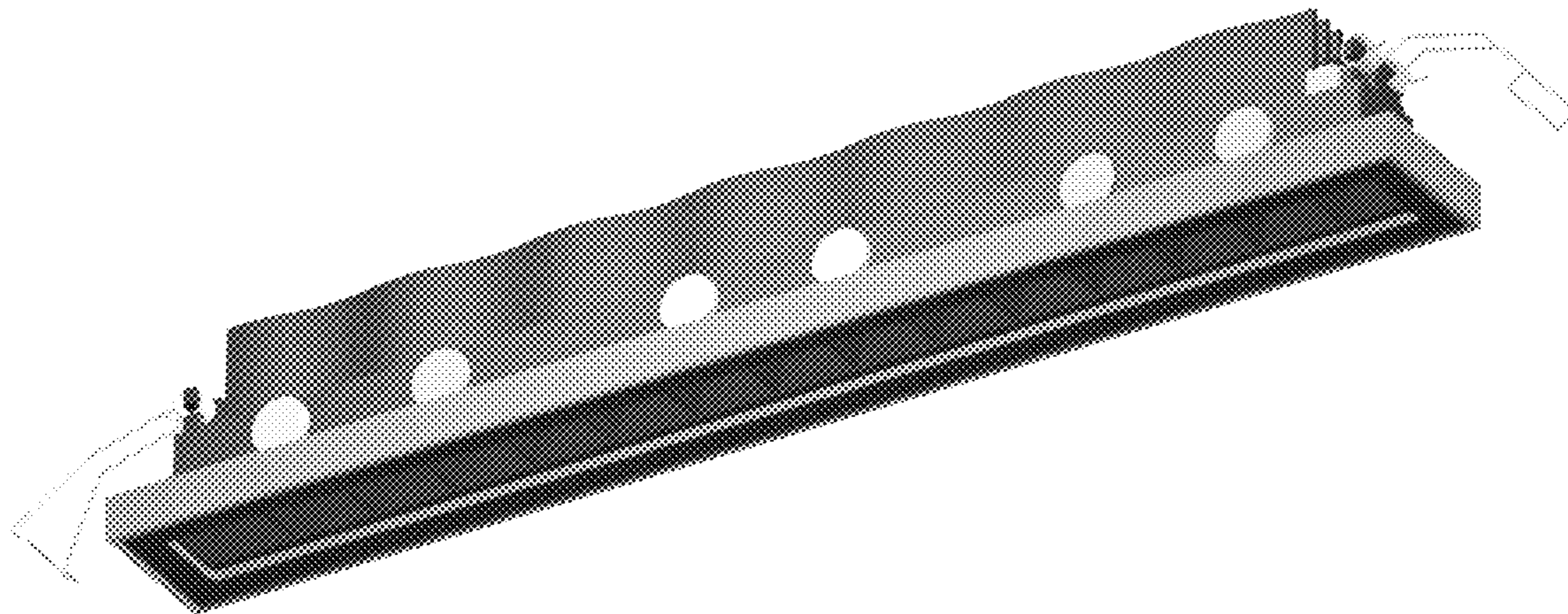
FIG. 1 is a front perspective view of the luminaire of the present invention showing my new design;

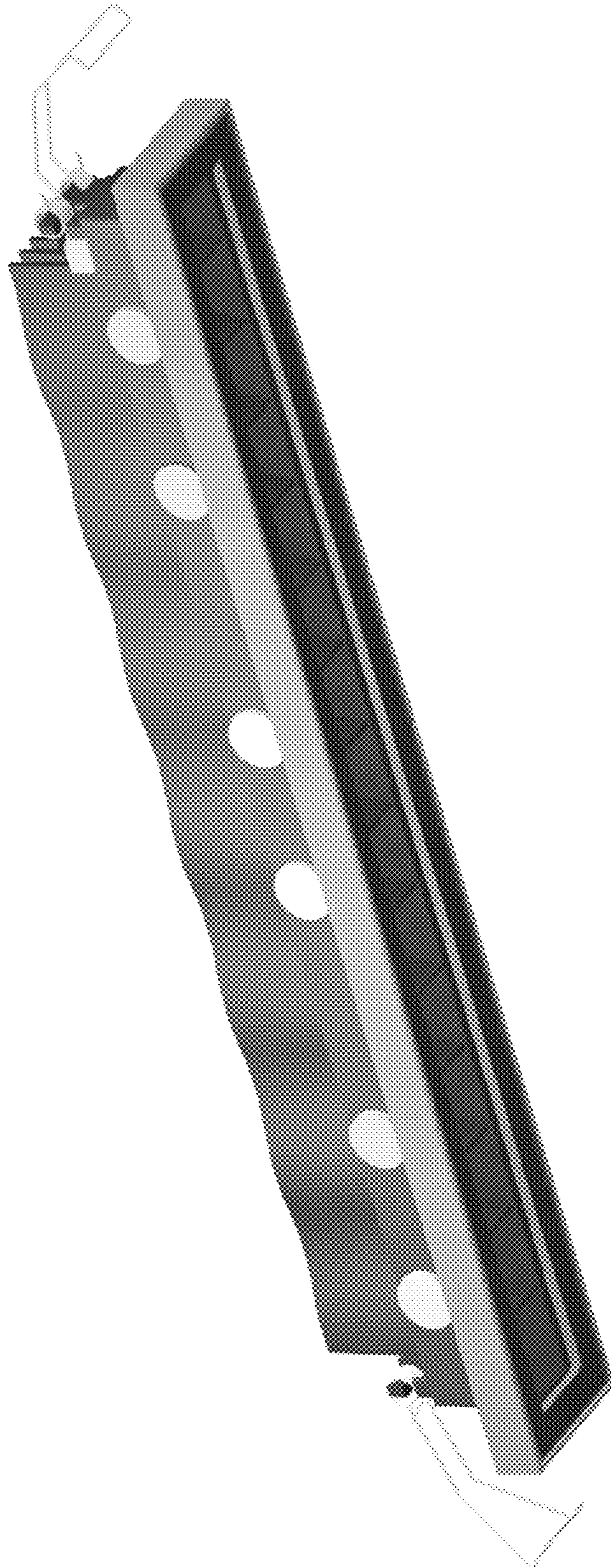

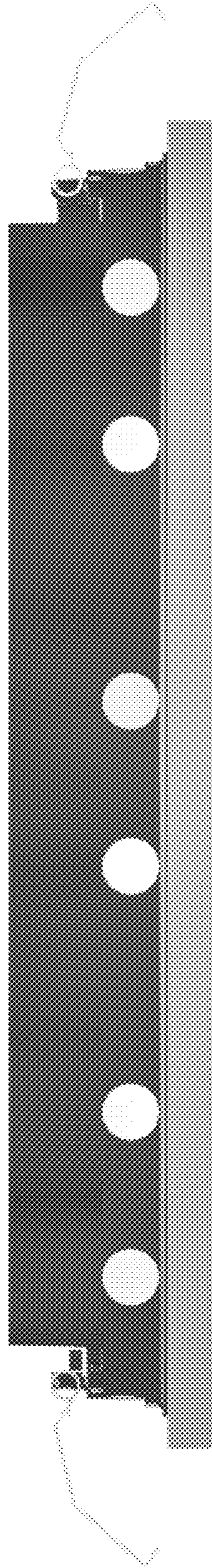

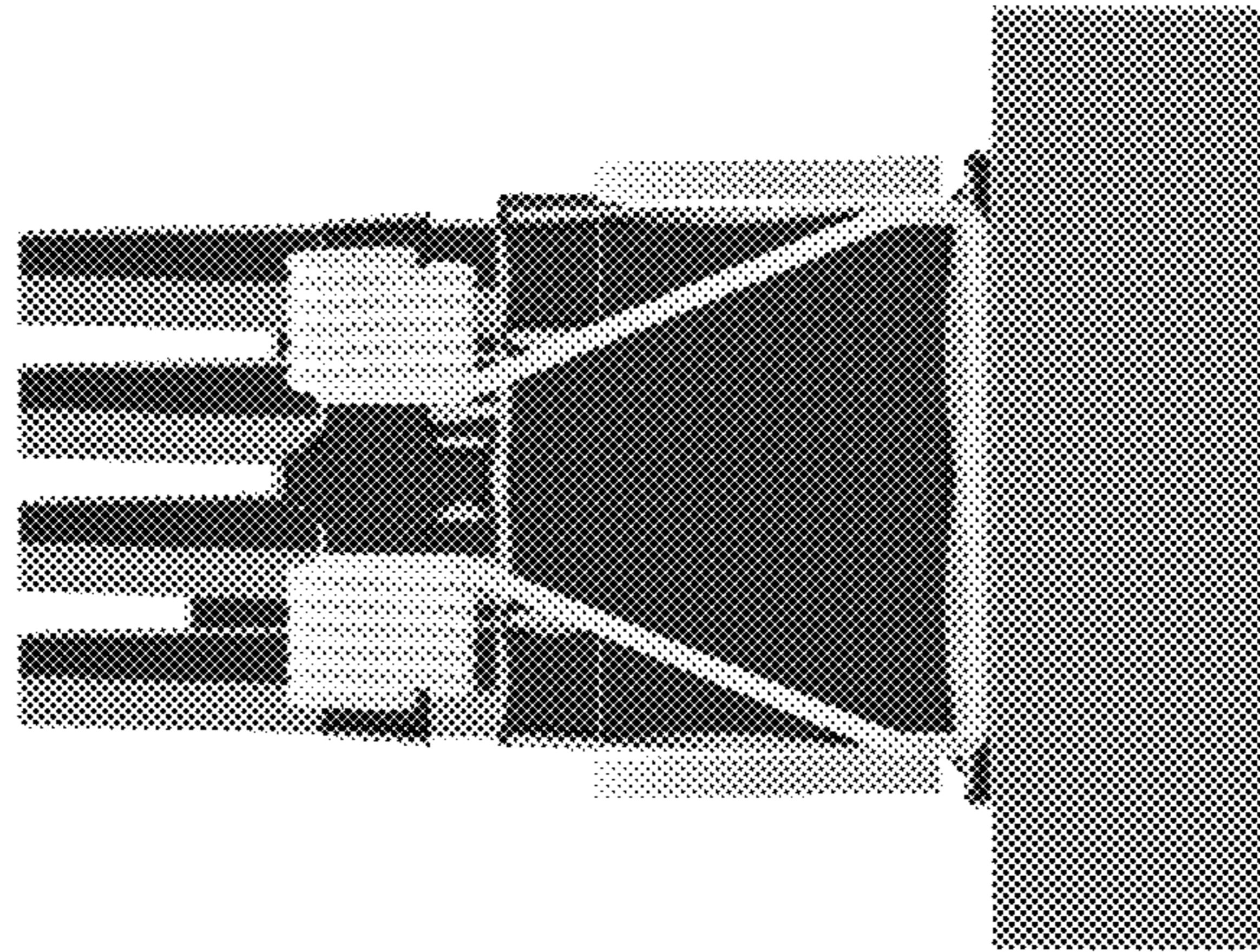

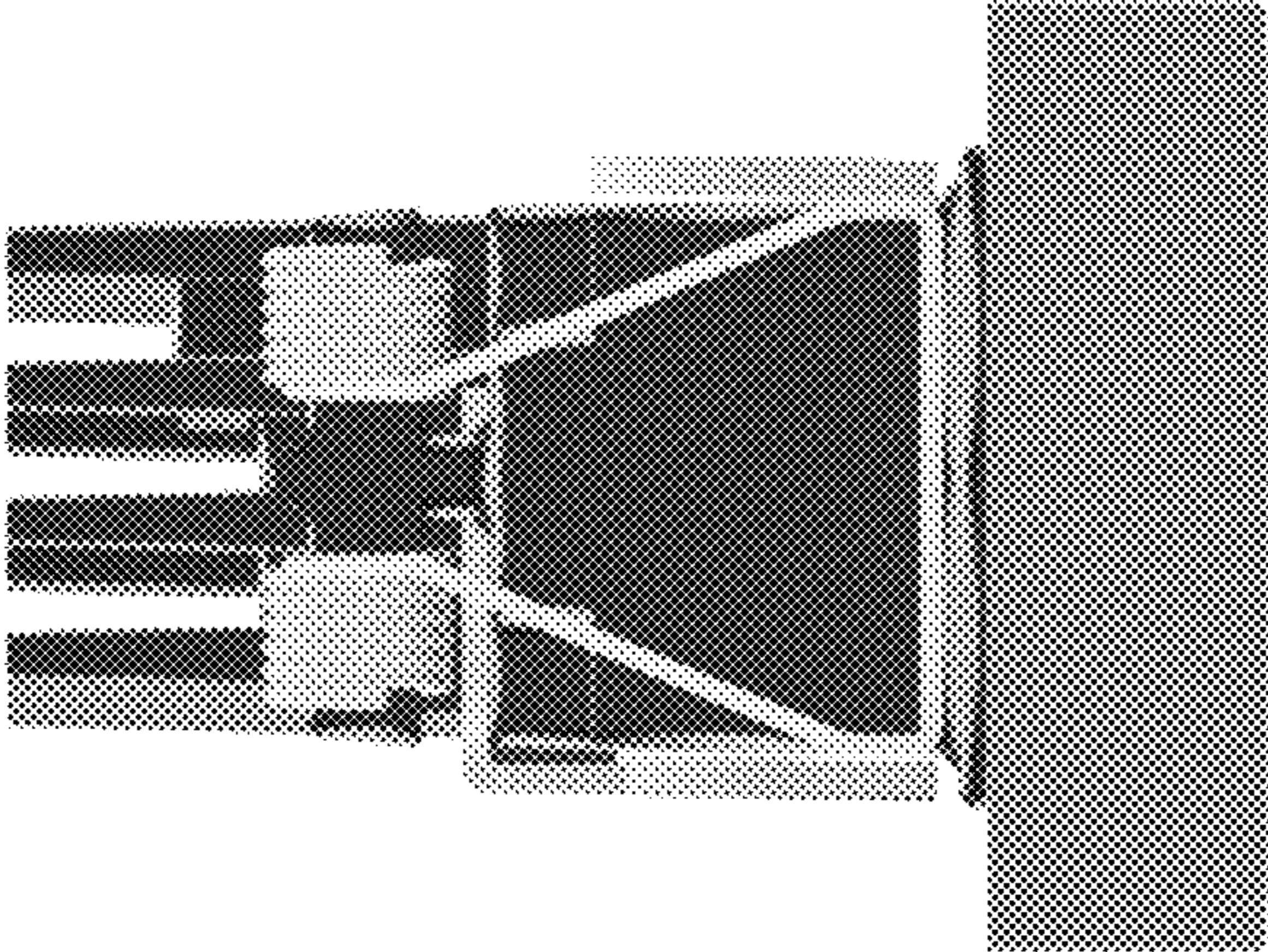

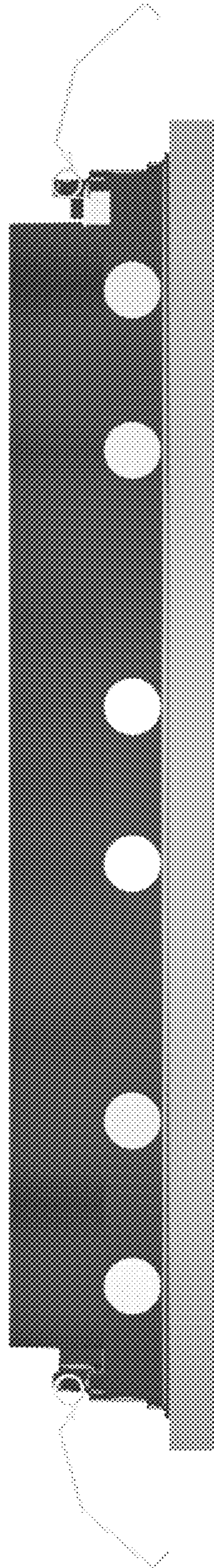

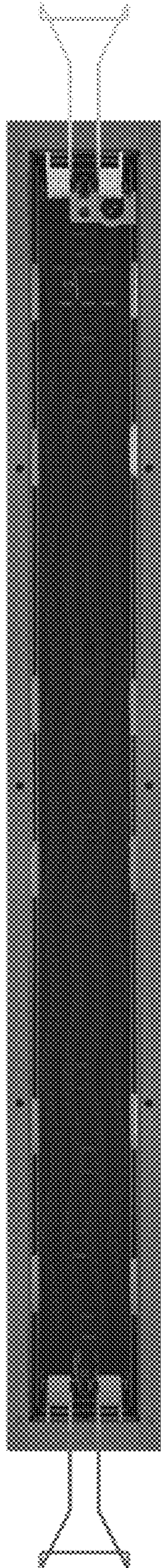

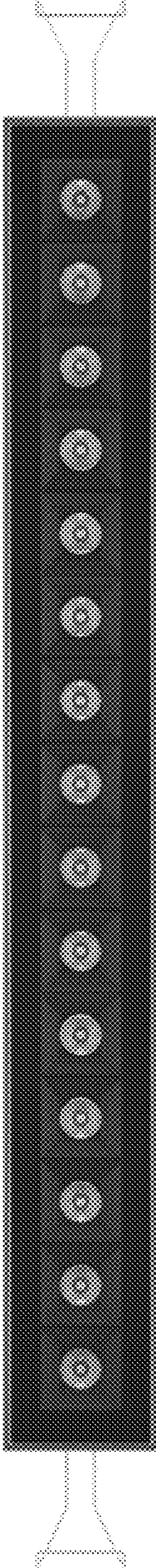
