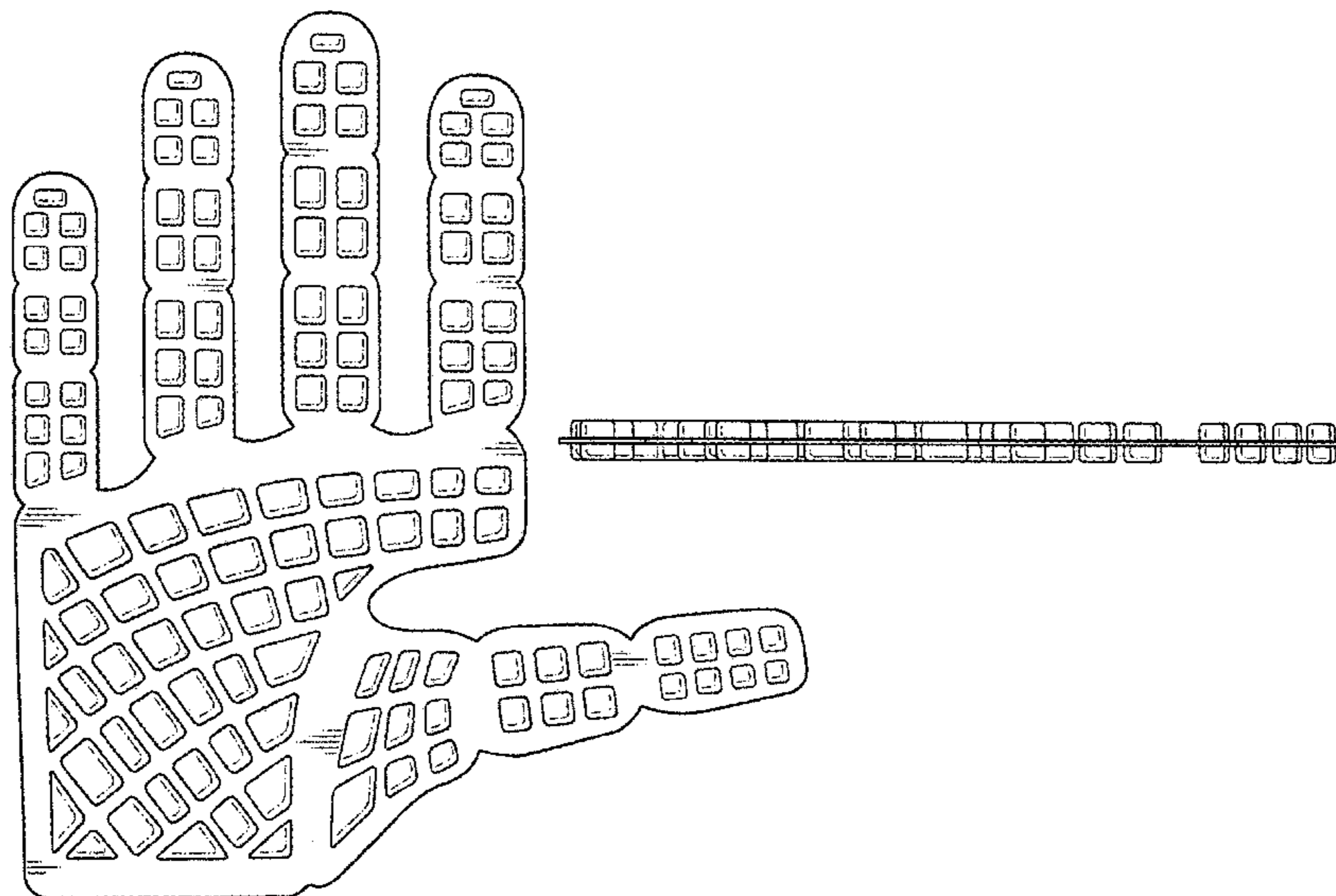
(57) **CLAIM**

The ornamental design for a vibration damping device for glove, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the vibration damping device for glove, the rear being a mirror image;
FIG. 2 is a top elevation view of the vibration damping device for glove;
FIG. 3 is a bottom elevation view of the vibration damping device for glove;
FIG. 4 is a side elevation view of the vibration damping device for glove as seen from the left of FIG. 1; and,
FIG. 5 is a side elevation view of the vibration damping device for glove as seen from the right of FIG. 1.

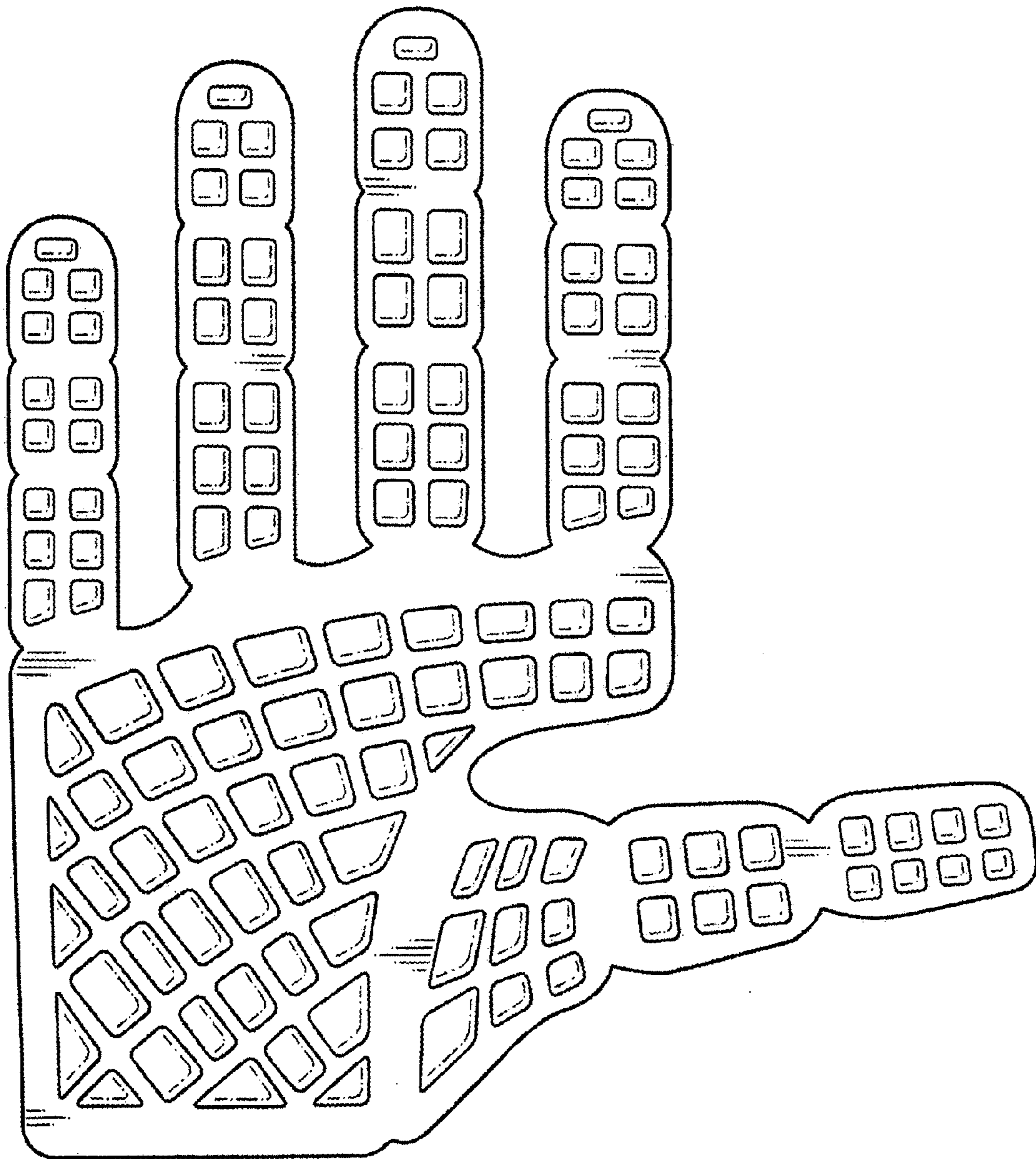

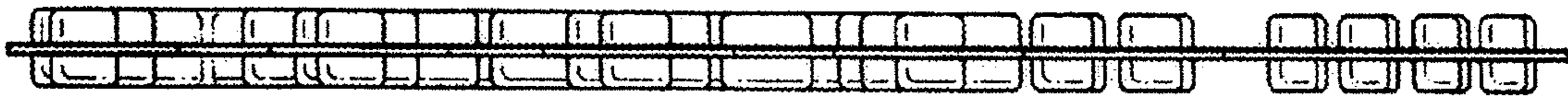

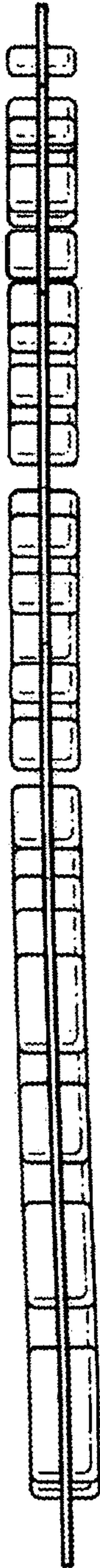

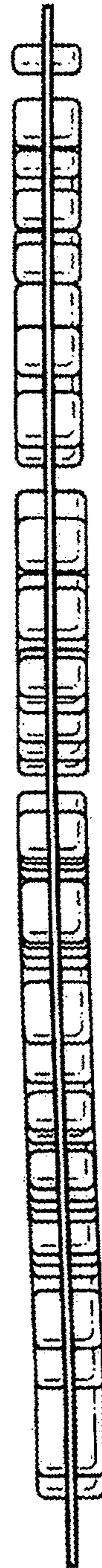
