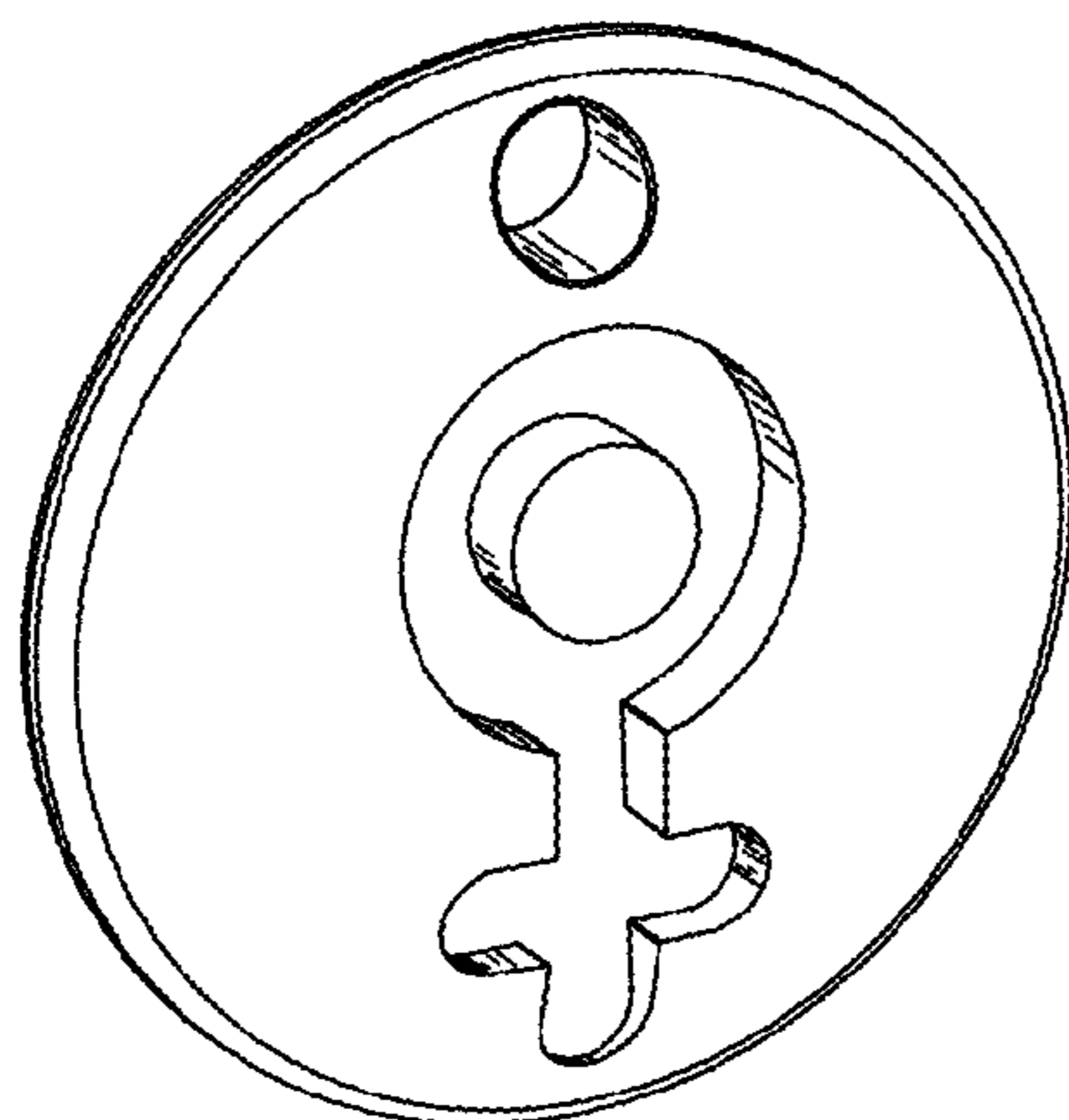
(57) **CLAIM**

The ornamental design for a pet tag, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pet tag of our new design;
 FIG. 2 is a front view of the invention;
 FIG. 3 is a rear view of the invention;
 FIG. 4 is a left side view of the design of FIG. 1 thereof, with the right side view being substantially similar;
 FIG. 5 is a top view thereof;
 FIG. 6 is a bottom view thereof;
 FIG. 7 is front perspective view of another embodiment of the pet tag;
 FIG. 8 is a front view thereof;
 FIG. 9 is a rear view thereof;
 FIG. 10 is a left view of the design of FIG. 7 thereof, with the right side view being substantially similar;
 FIG. 11 is a top view thereof; and,
 FIG. 12 is a bottom view thereof.
 Characteristic features of the design reside in the configuration of a pet collar tag to suggest the male or female symbols in the front and the written expression "The Bog Tag" in the back.

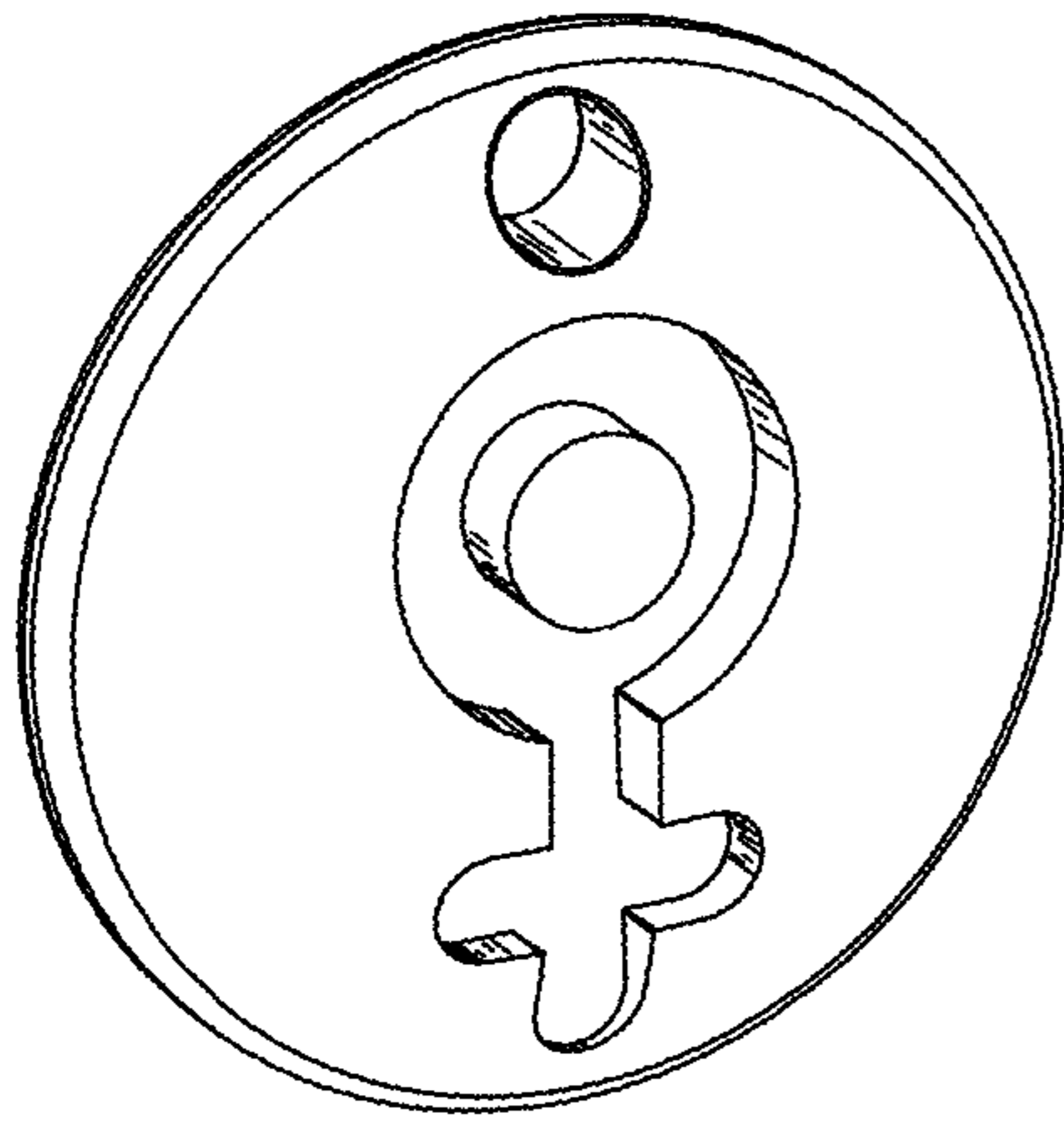

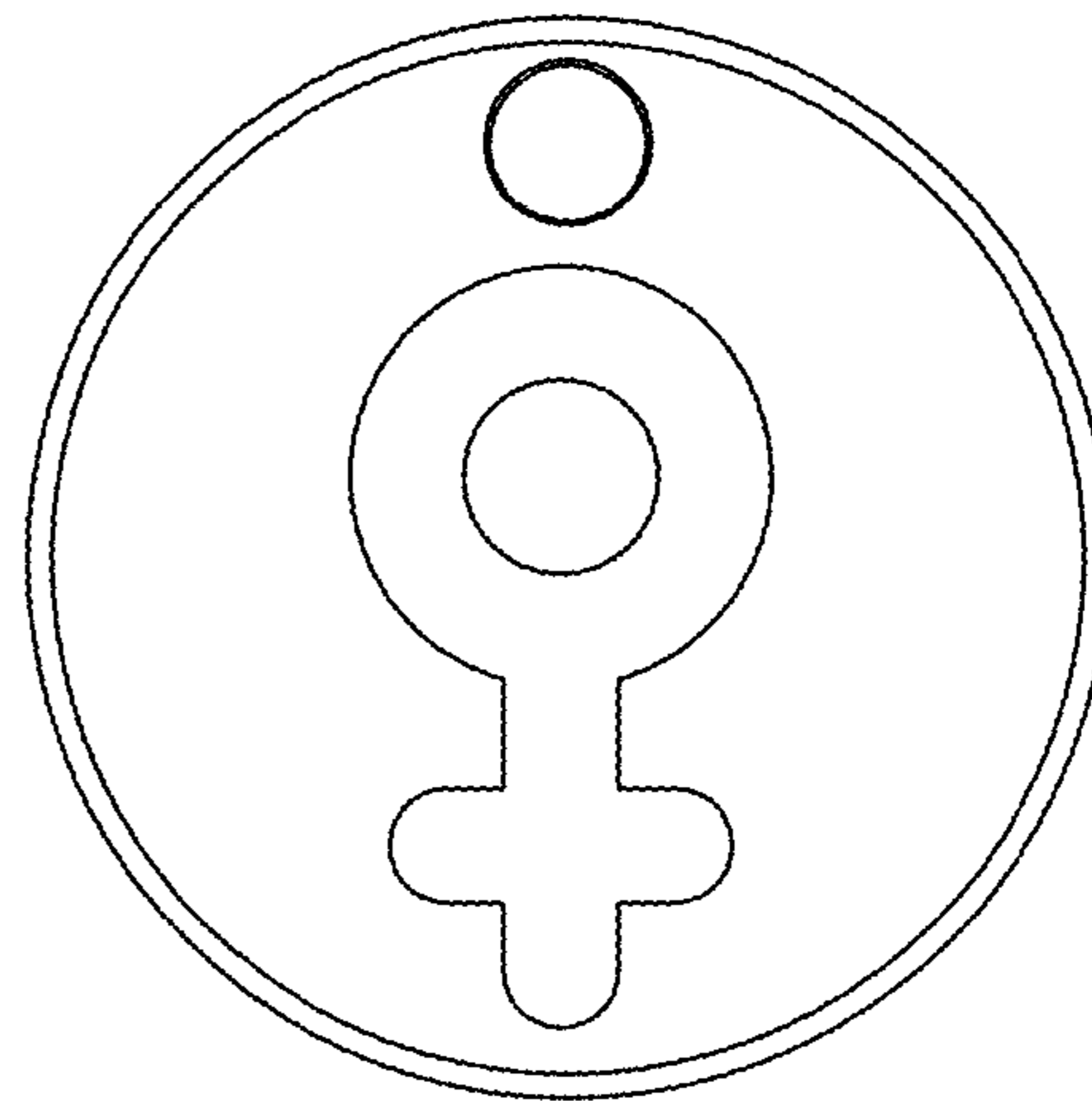

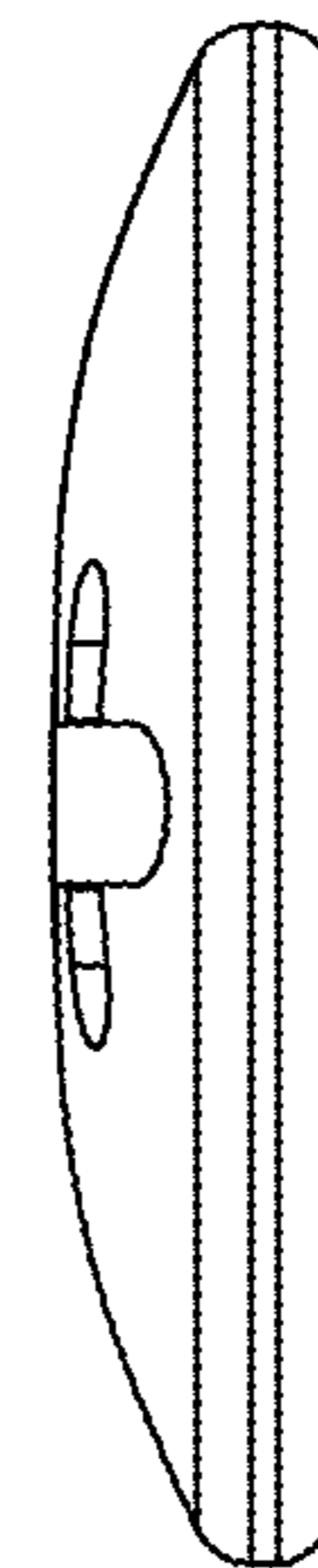

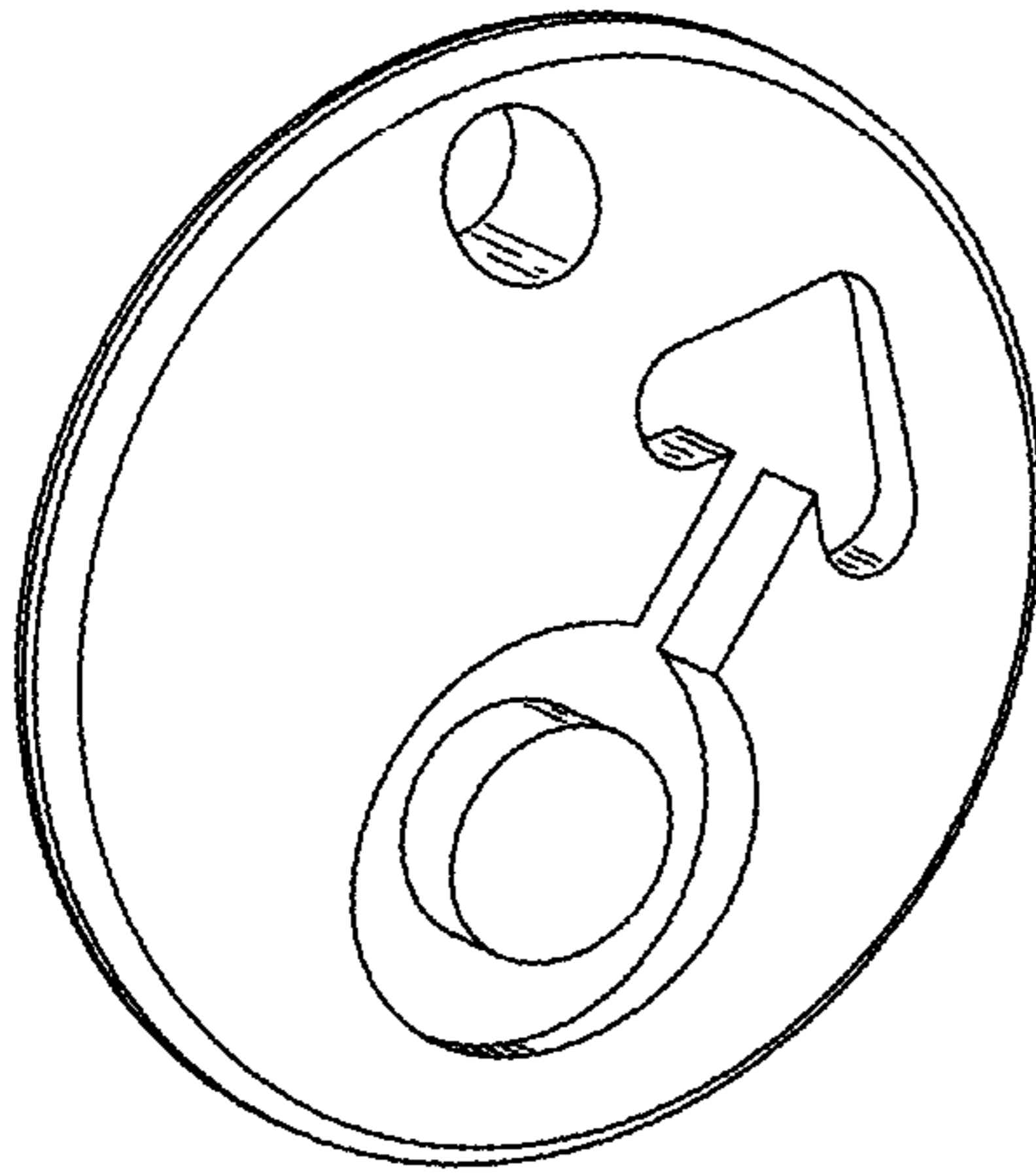

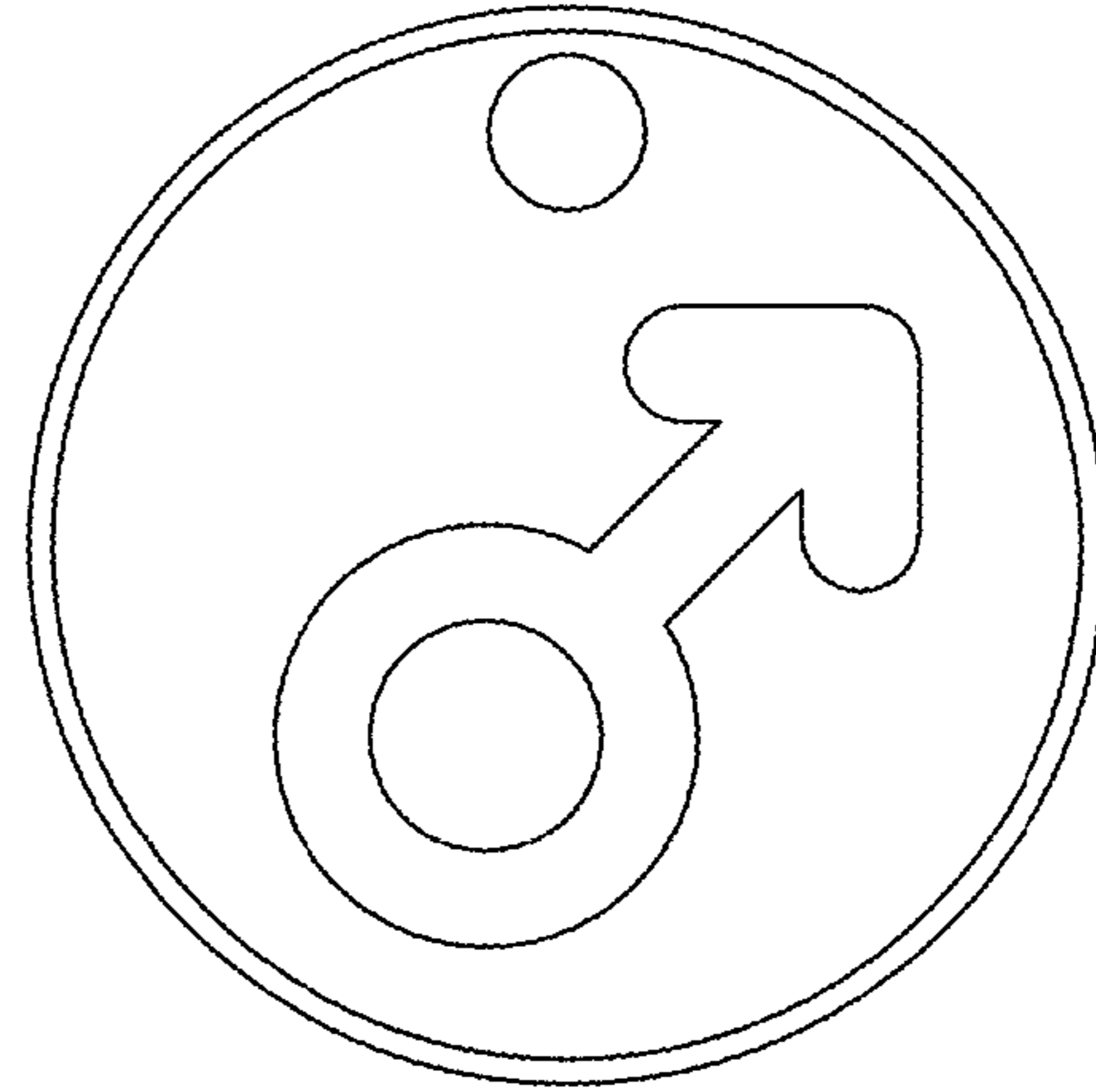

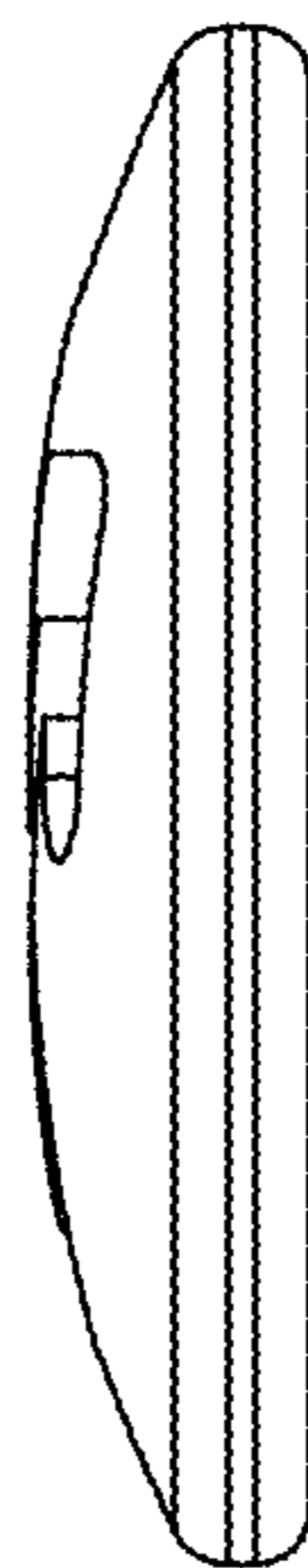

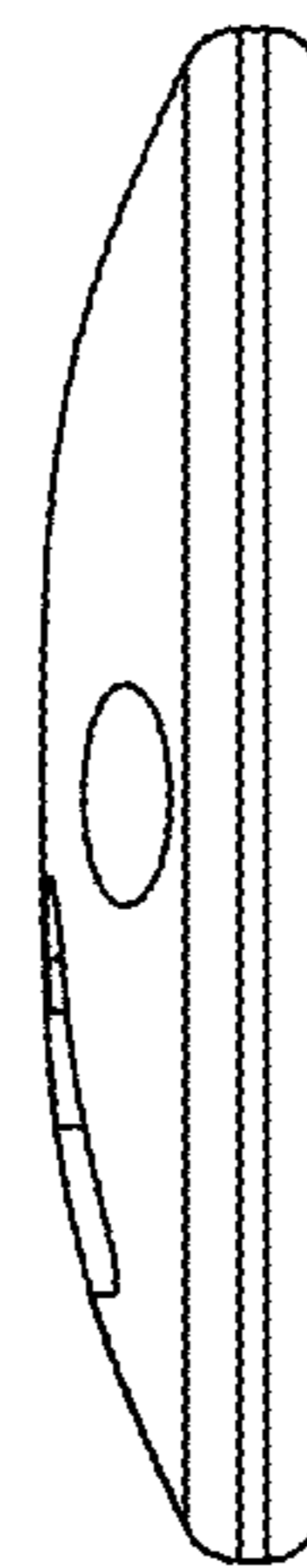

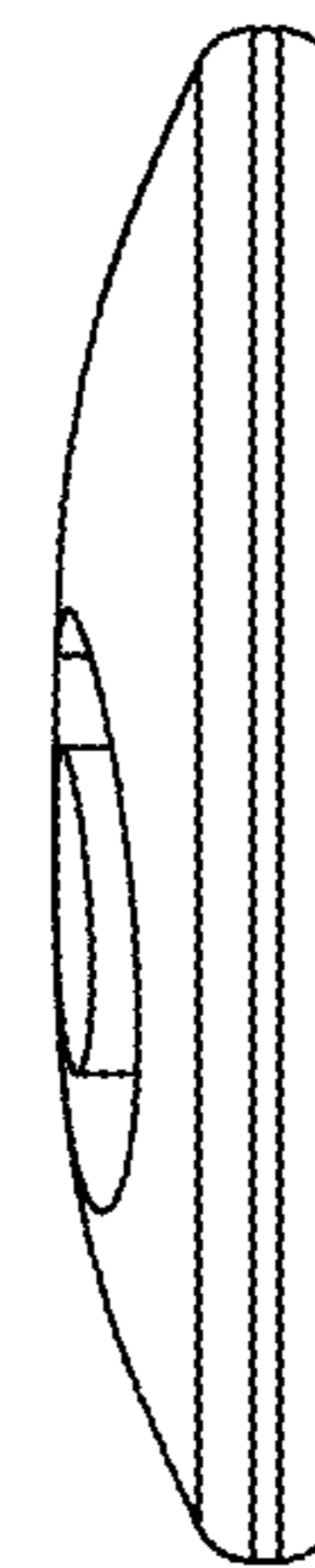
