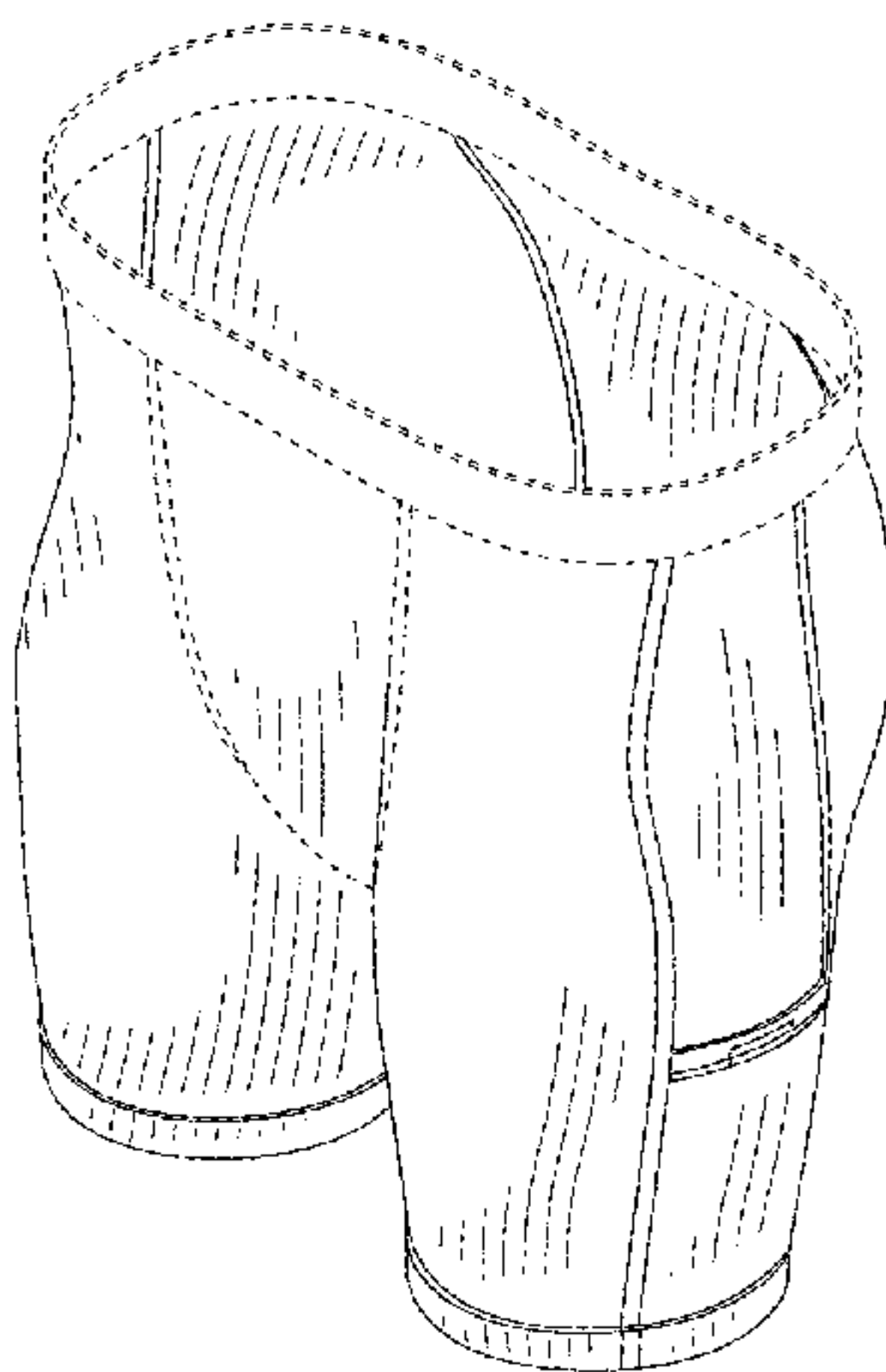
(57) **CLAIM**
The ornamental design for athletic compression shorts, as shown and described.

DESCRIPTION

FIG. 1 is a perspective front view of an athletic compression shorts;
FIG. 2 is a front elevation view of the athletic compression shorts;
FIG. 3 is a rear elevation view of the athletic compression shorts;
FIG. 4 is a left side elevation view of the athletic compression shorts;
FIG. 5 is a right side view of the athletic compression shorts;
FIG. 6 is a top elevation view of the athletic compression shorts; and,
FIG. 7 is a bottom elevation view of the athletic compression shorts.
The broken lines illustrating portions of the athletic compression shorts form no part of the claimed design.

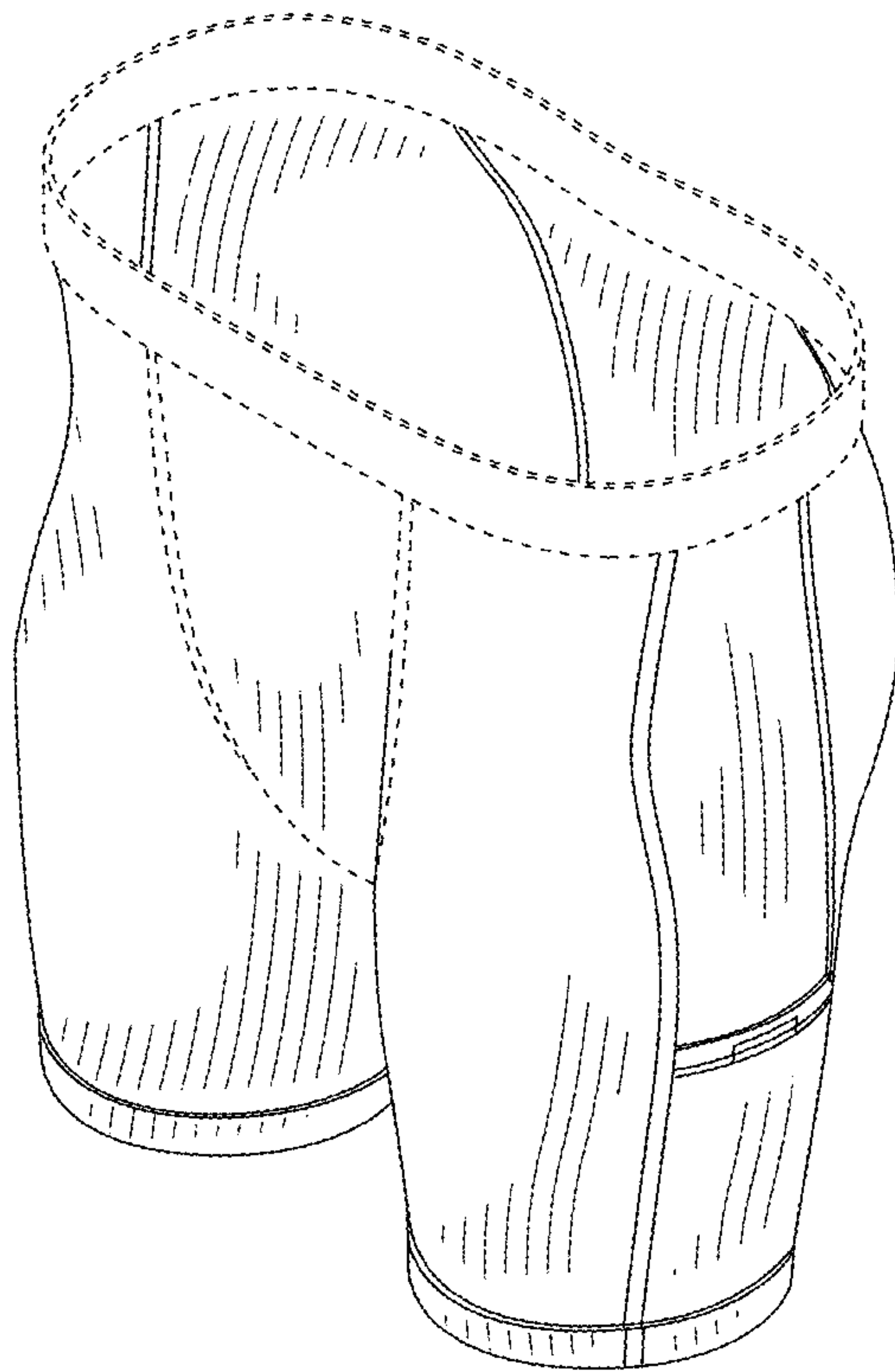

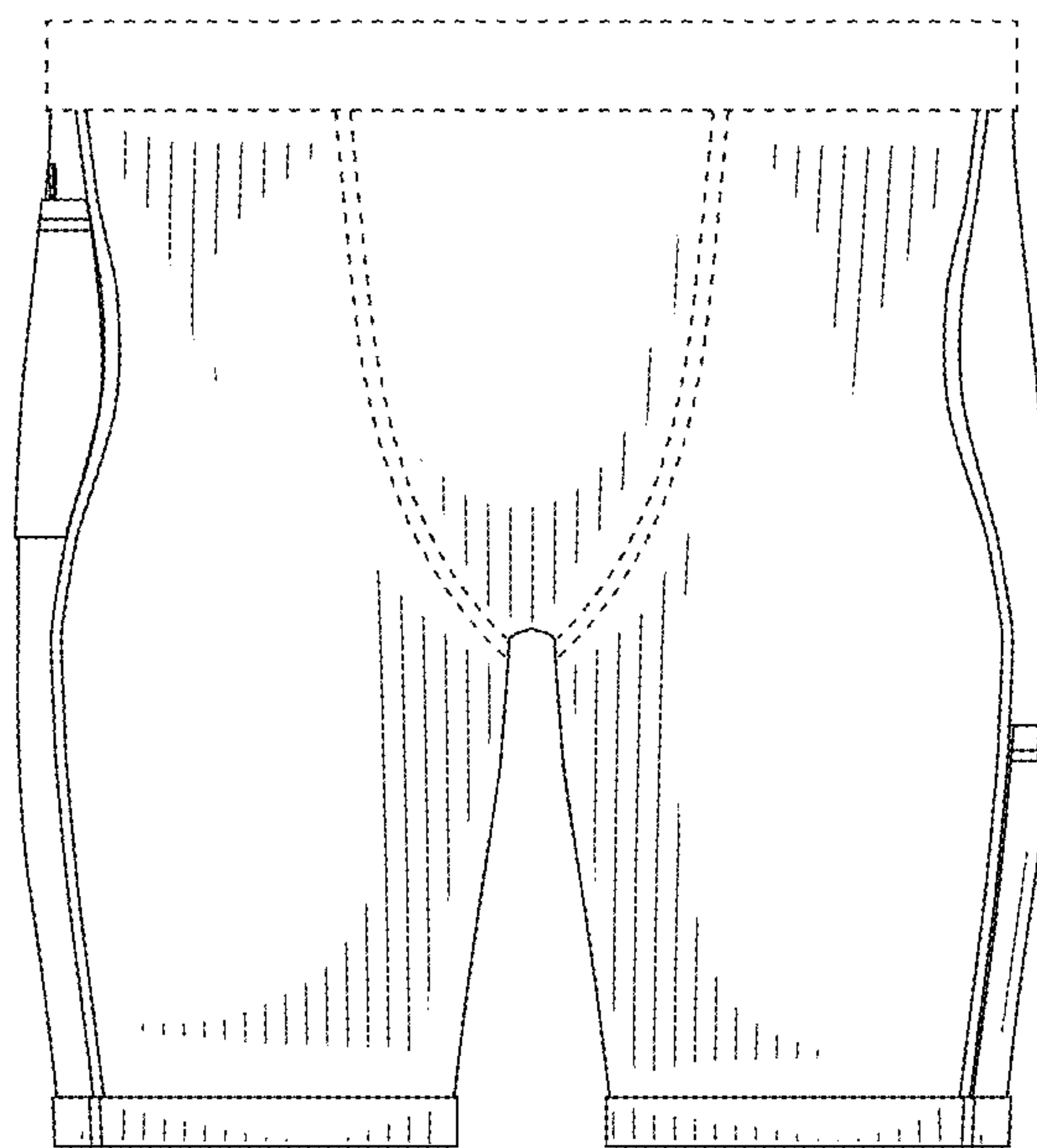

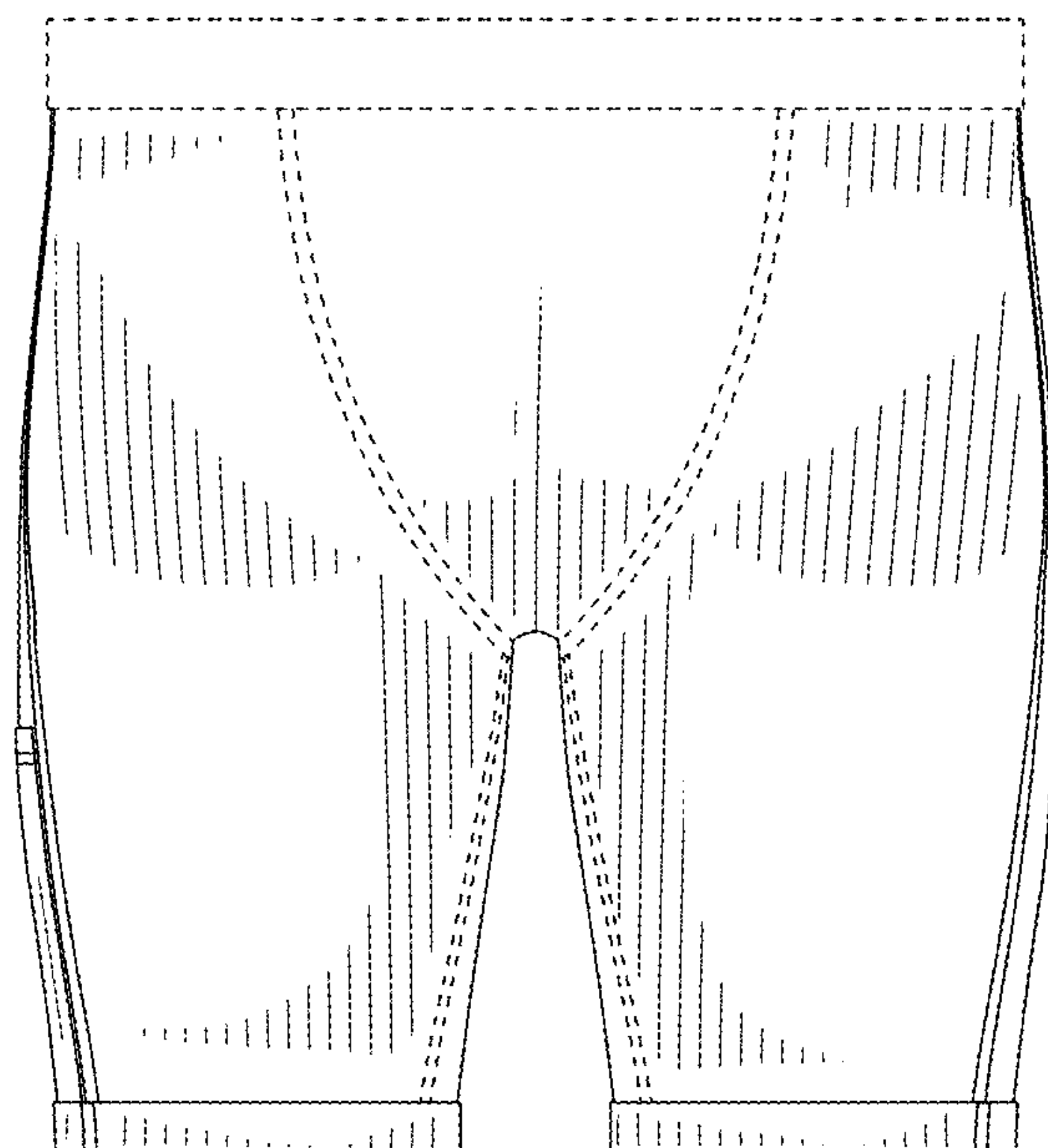

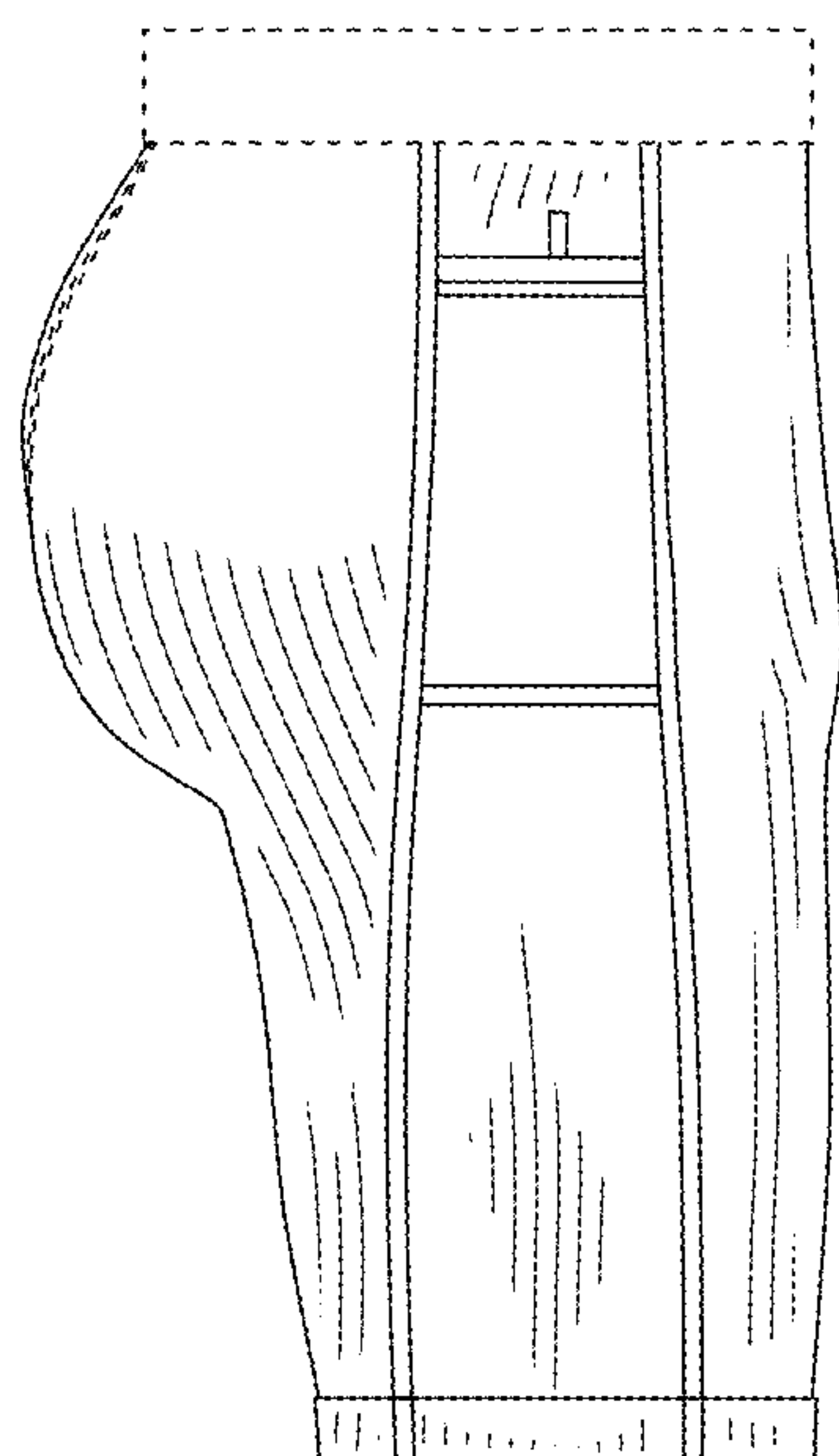

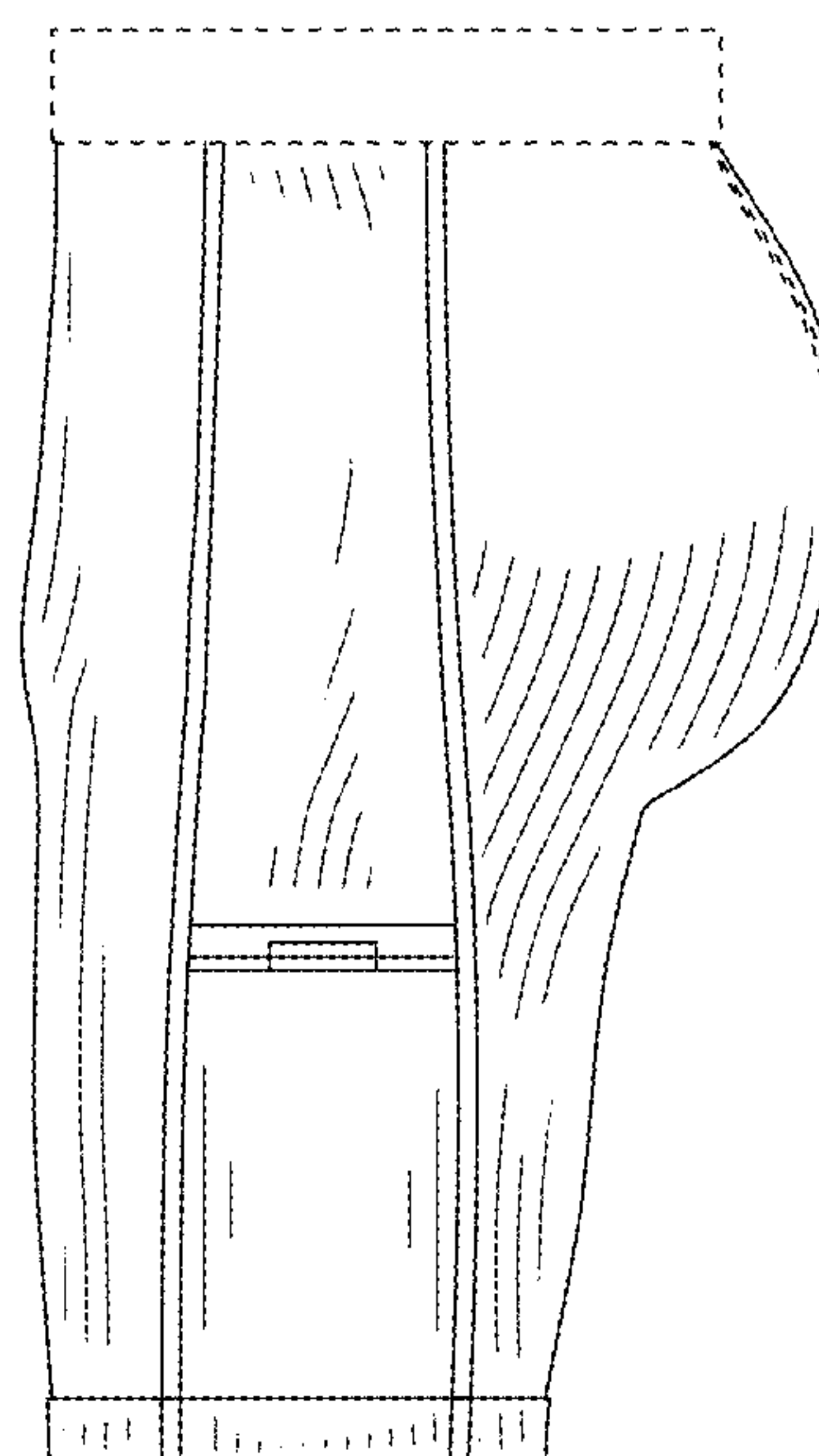

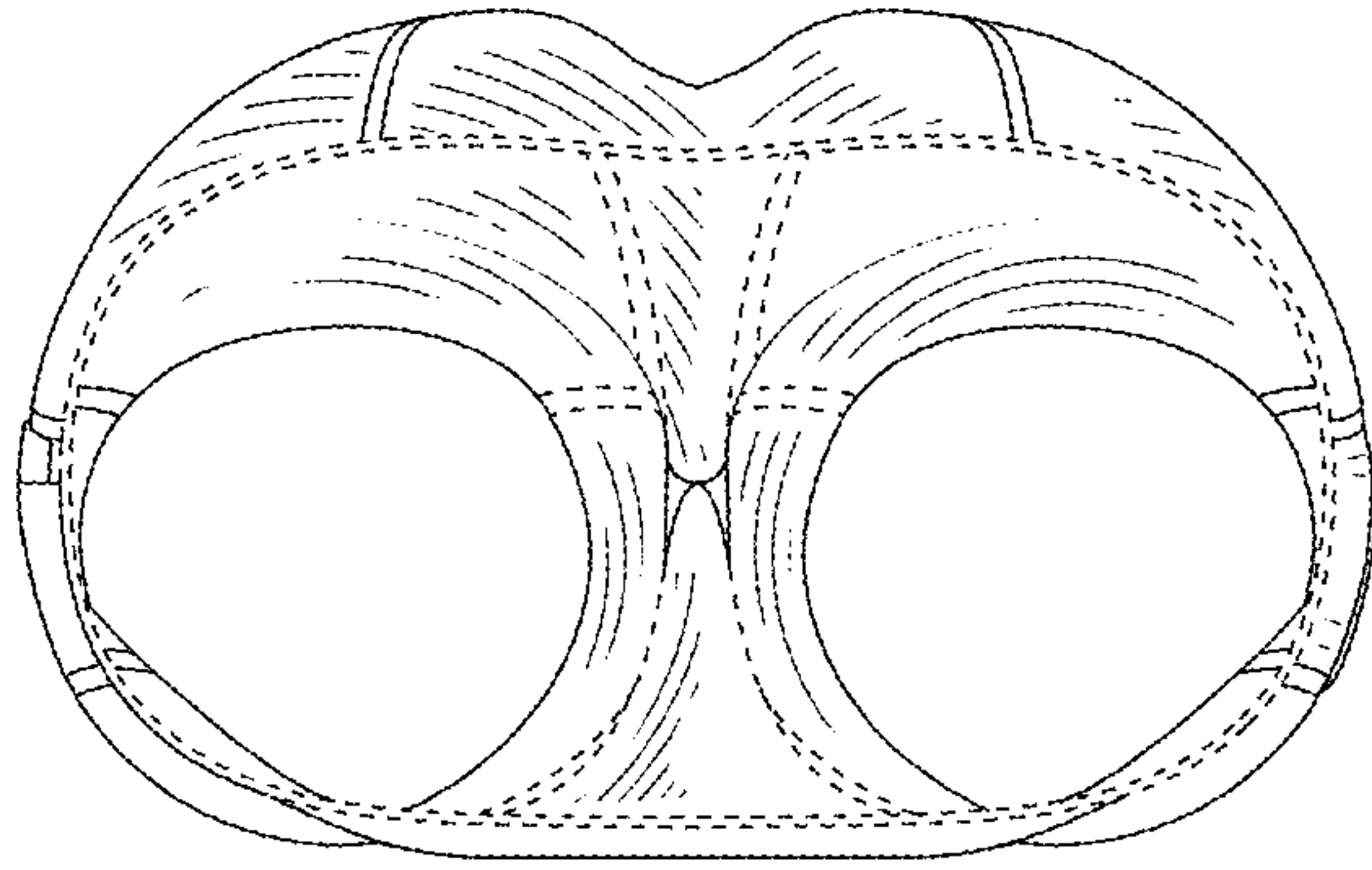

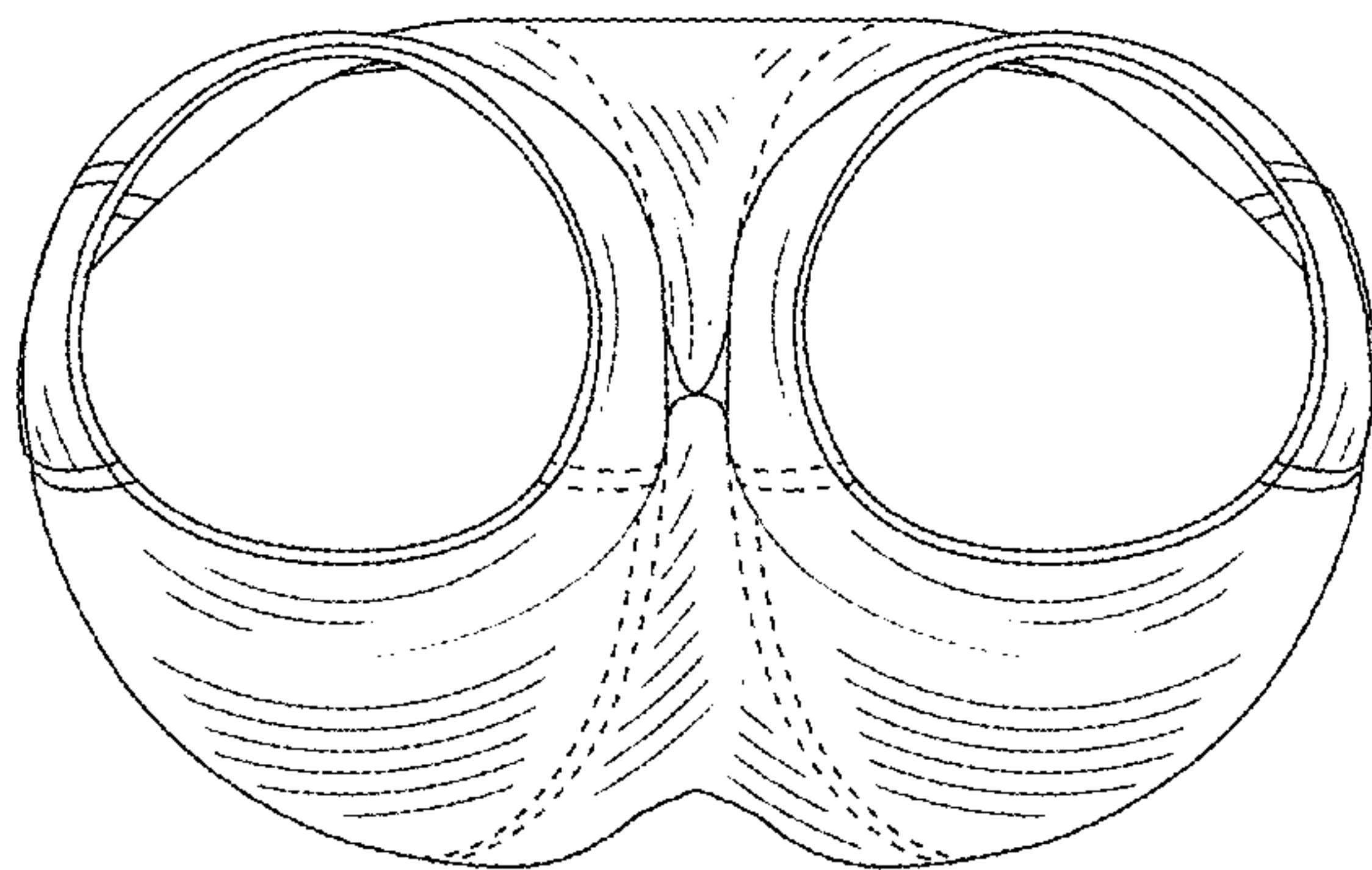
