The ornamental design for a paper product with surface pattern, as shown and described.

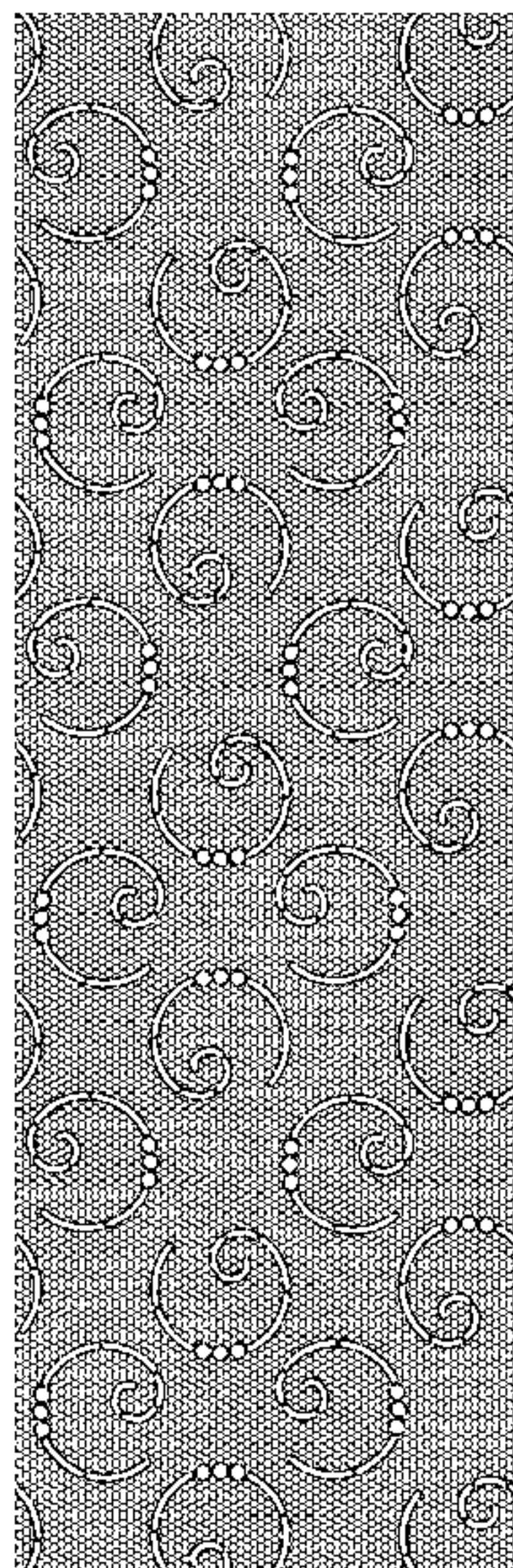
DESCRIPTION

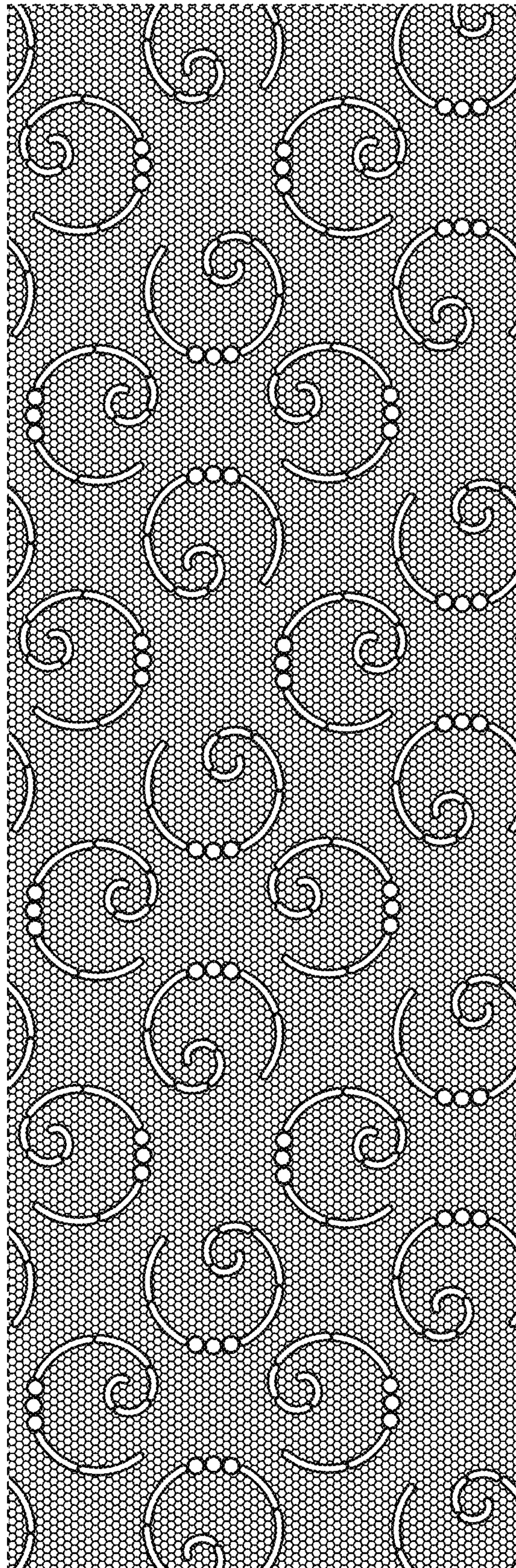

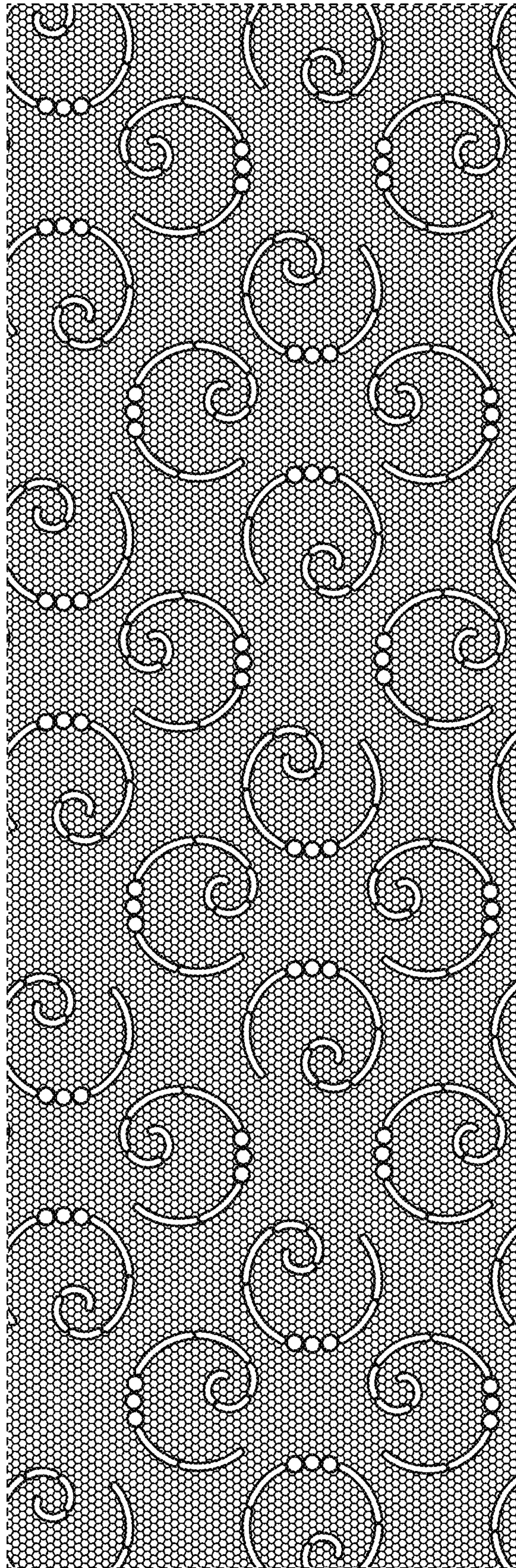
