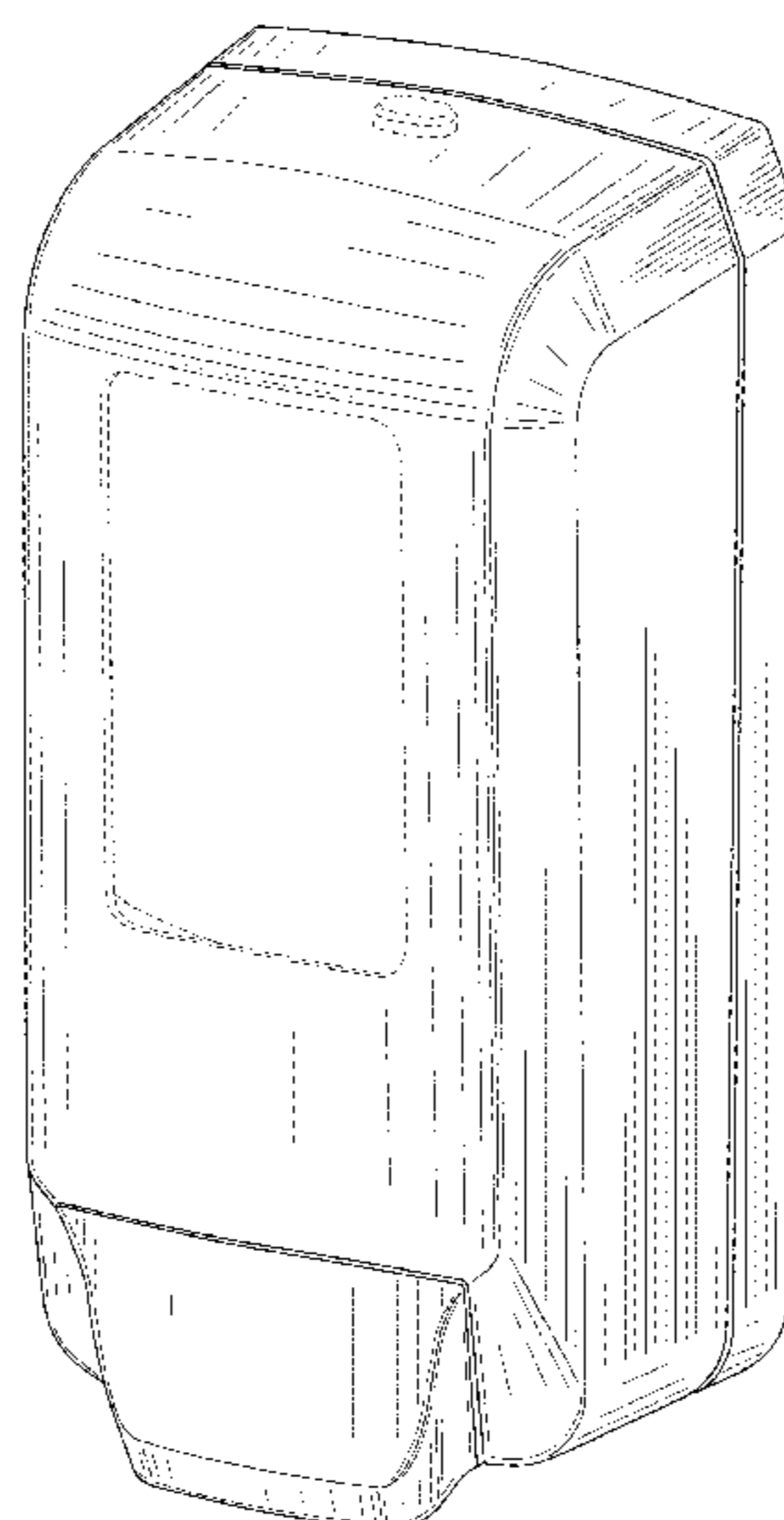
(57) **CLAIM**

We claim the ornamental design for a dispenser, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a dispenser showing our new design;

FIG. 4 is a left side elevation view thereof;

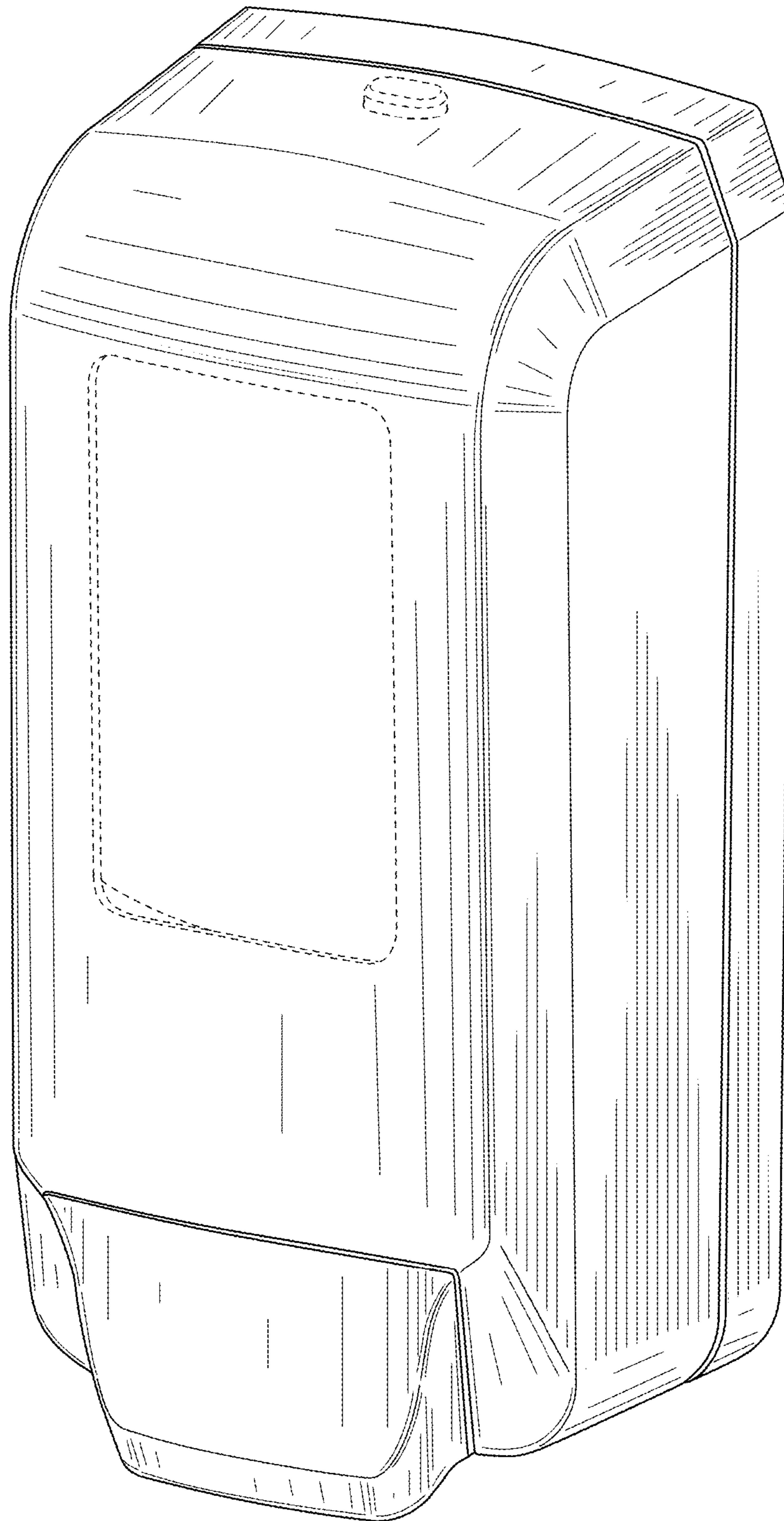

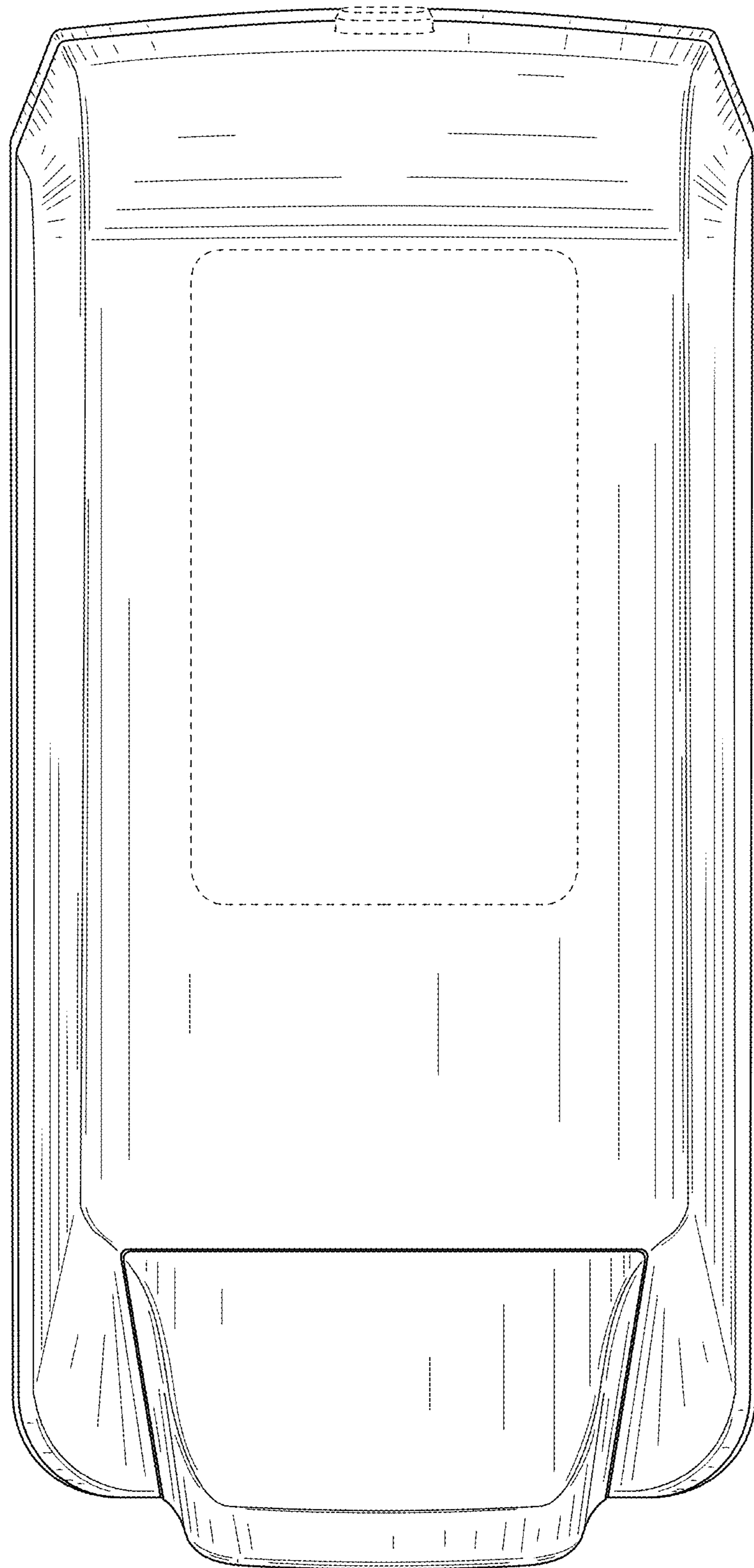
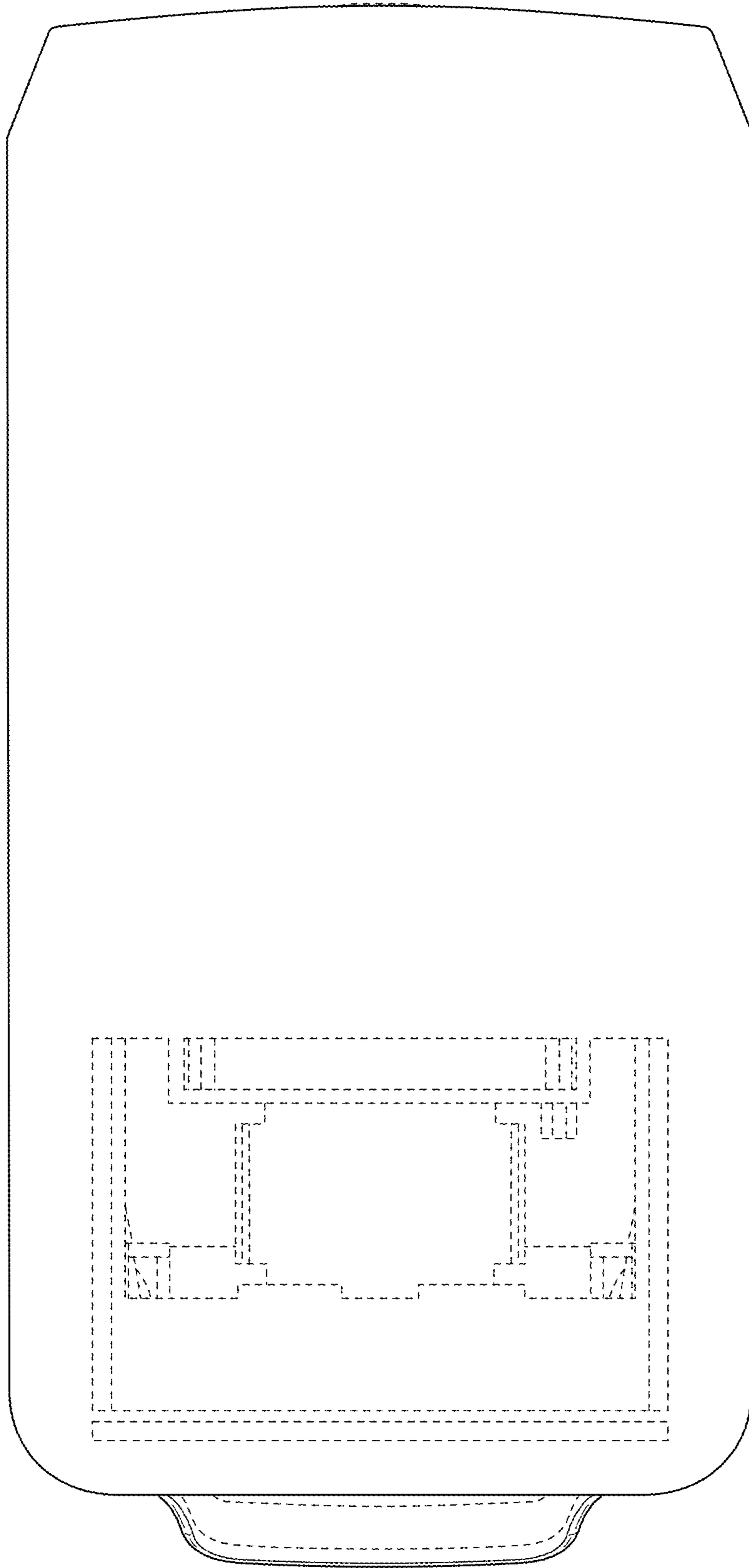

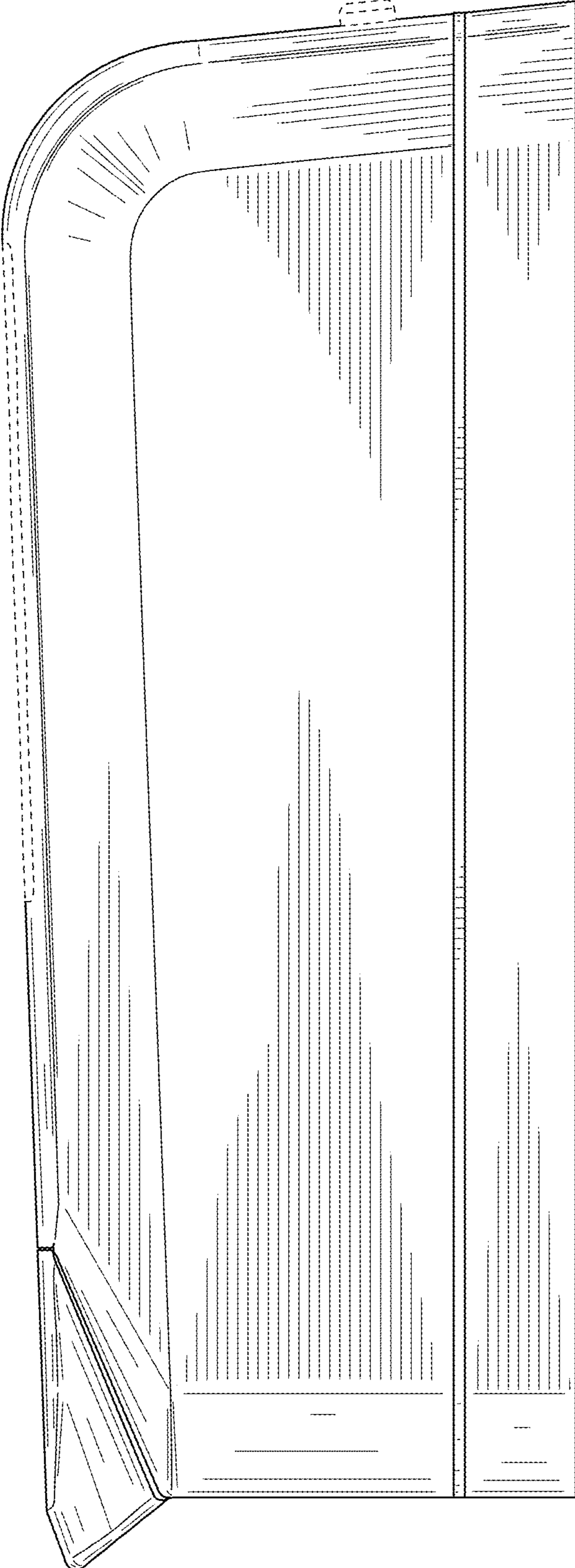

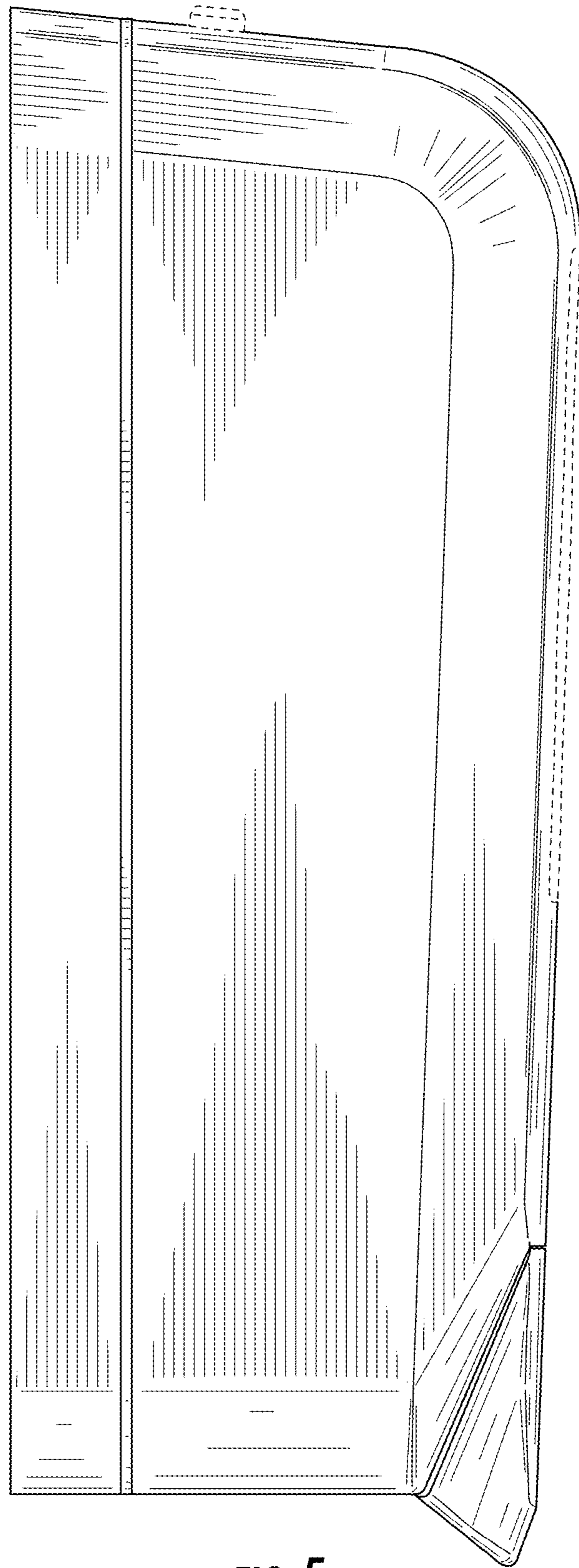
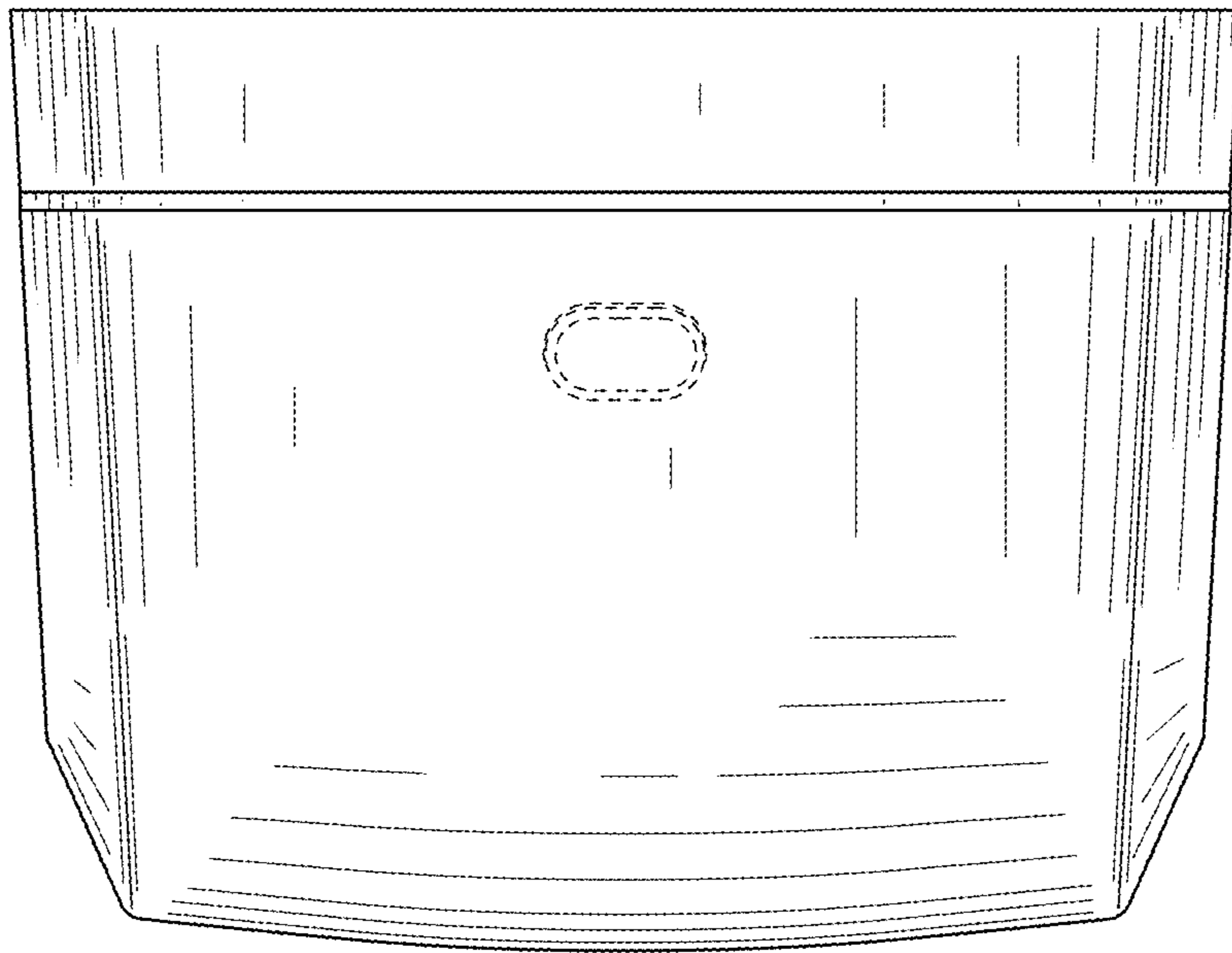
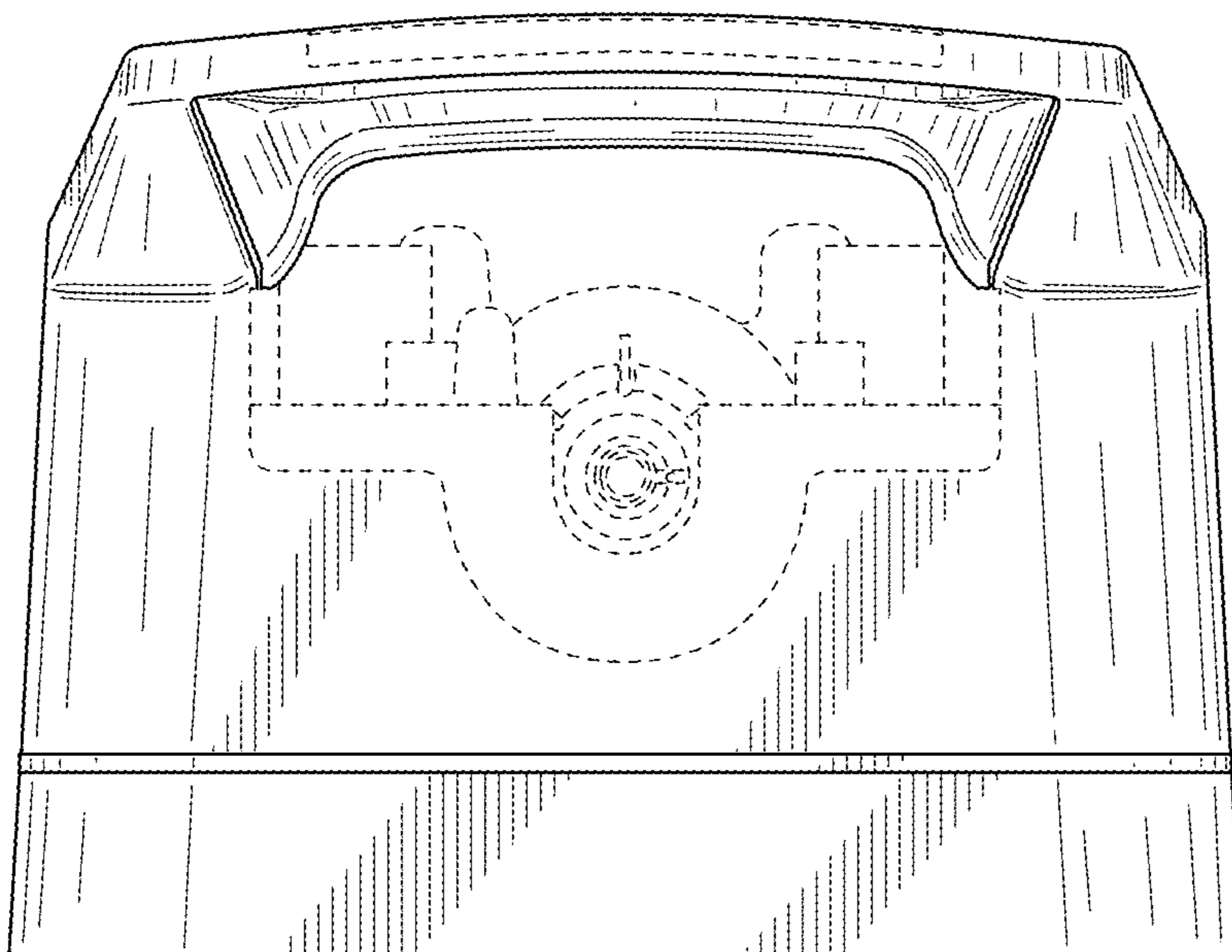
