I claim, the ornamental design for a body pillow, as shown and described.

DESCRIPTION

FIG. 1 is a top and front perspective view of a body pillow, showing my new design;

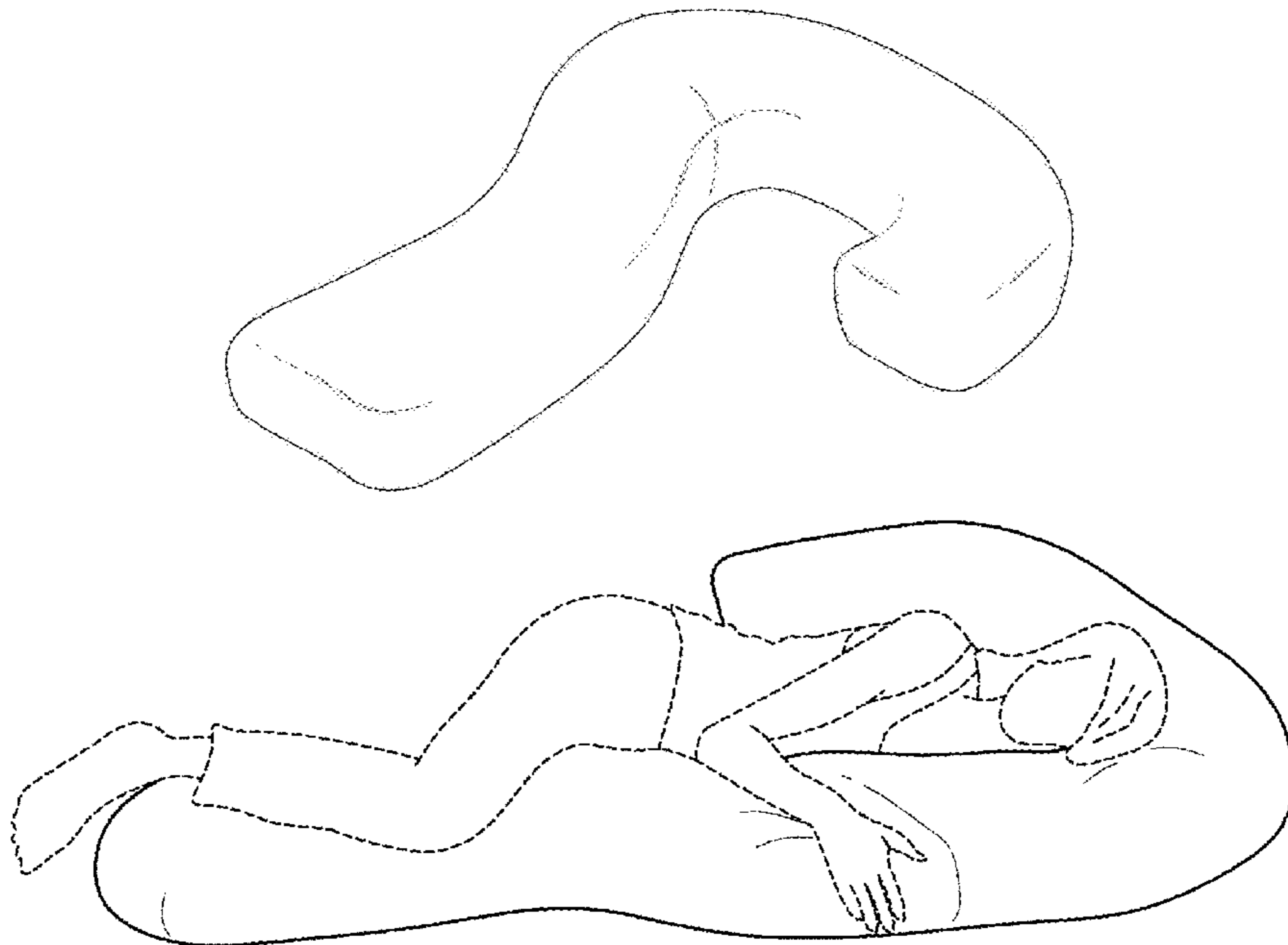

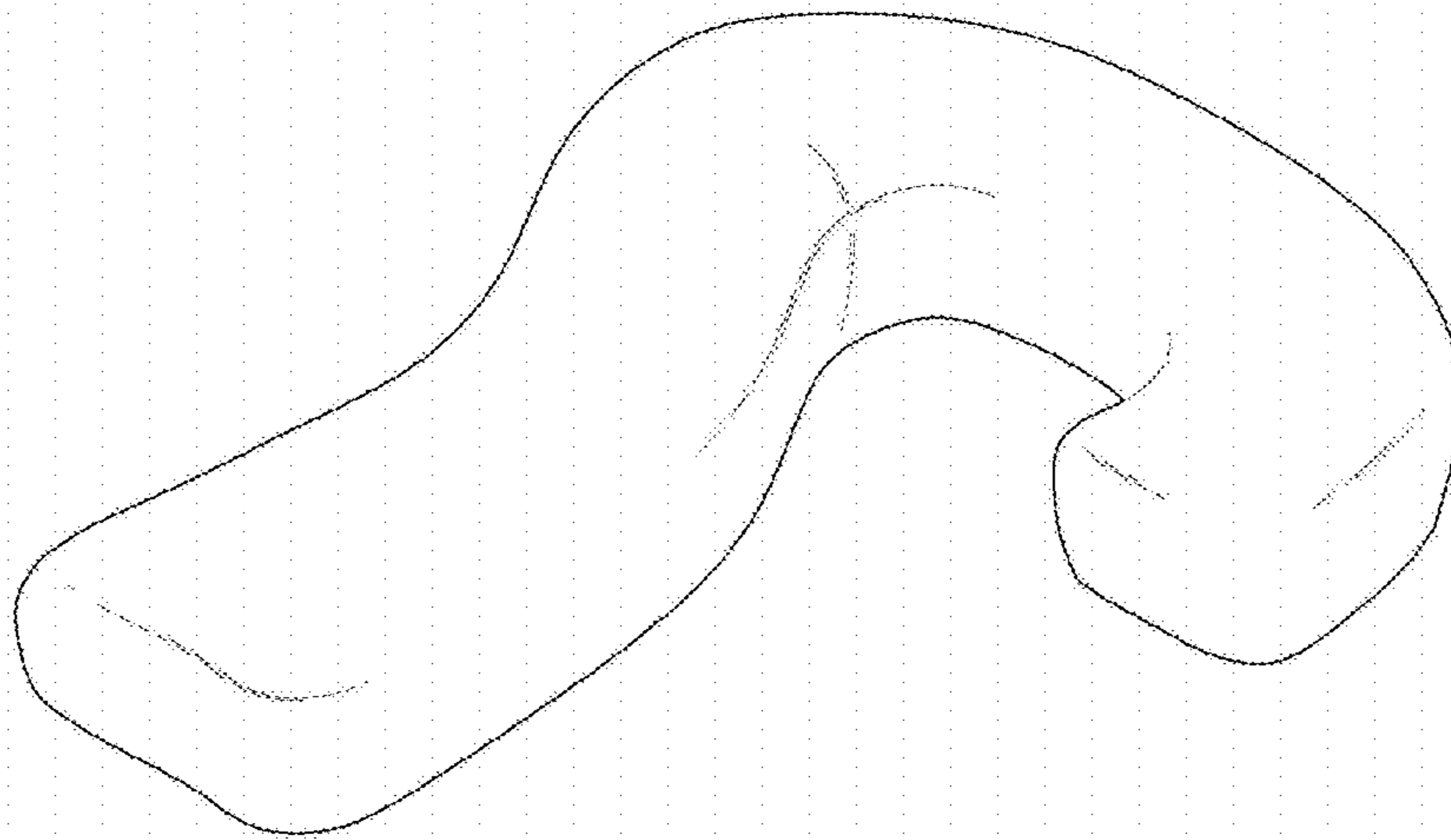

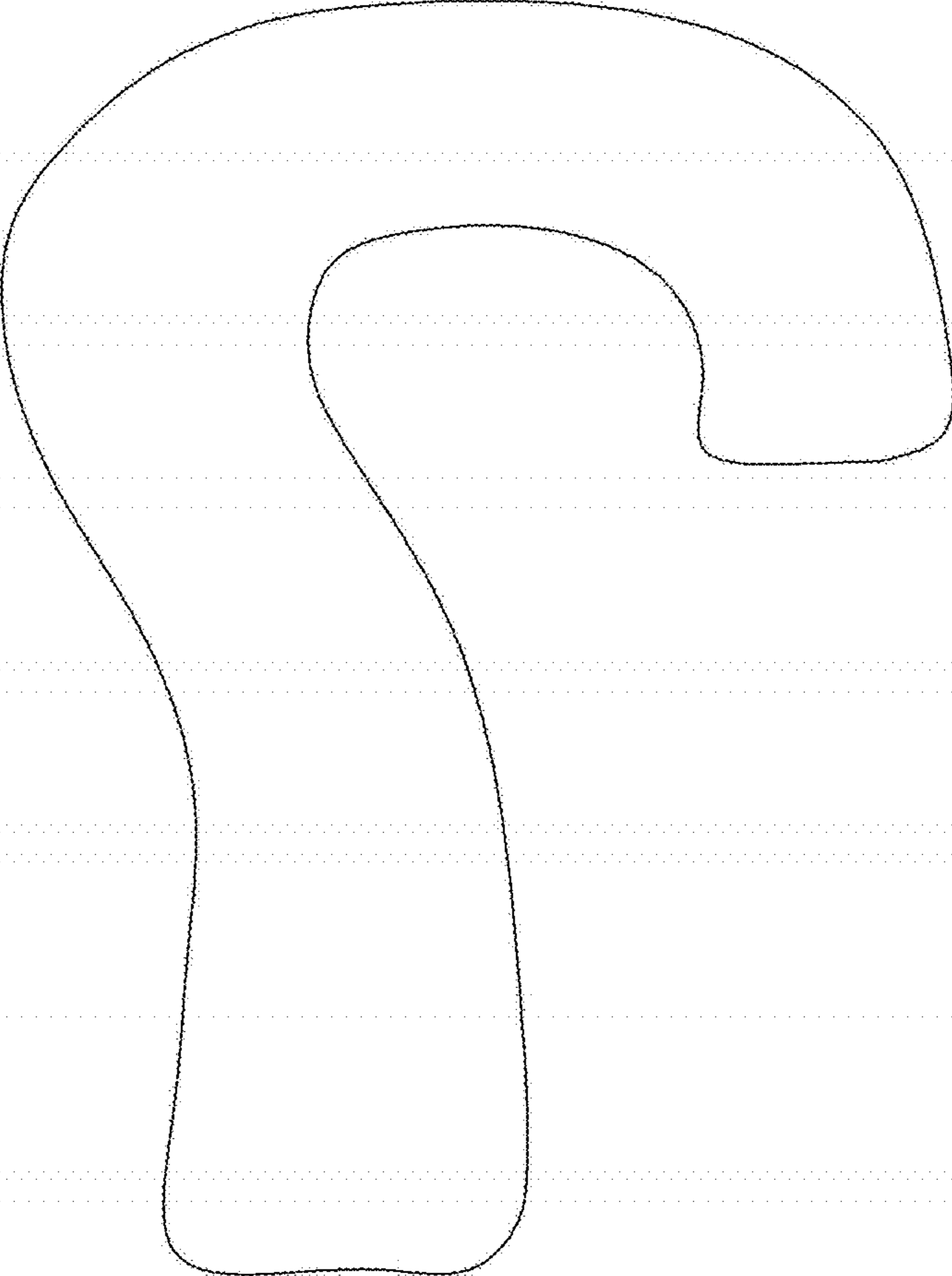

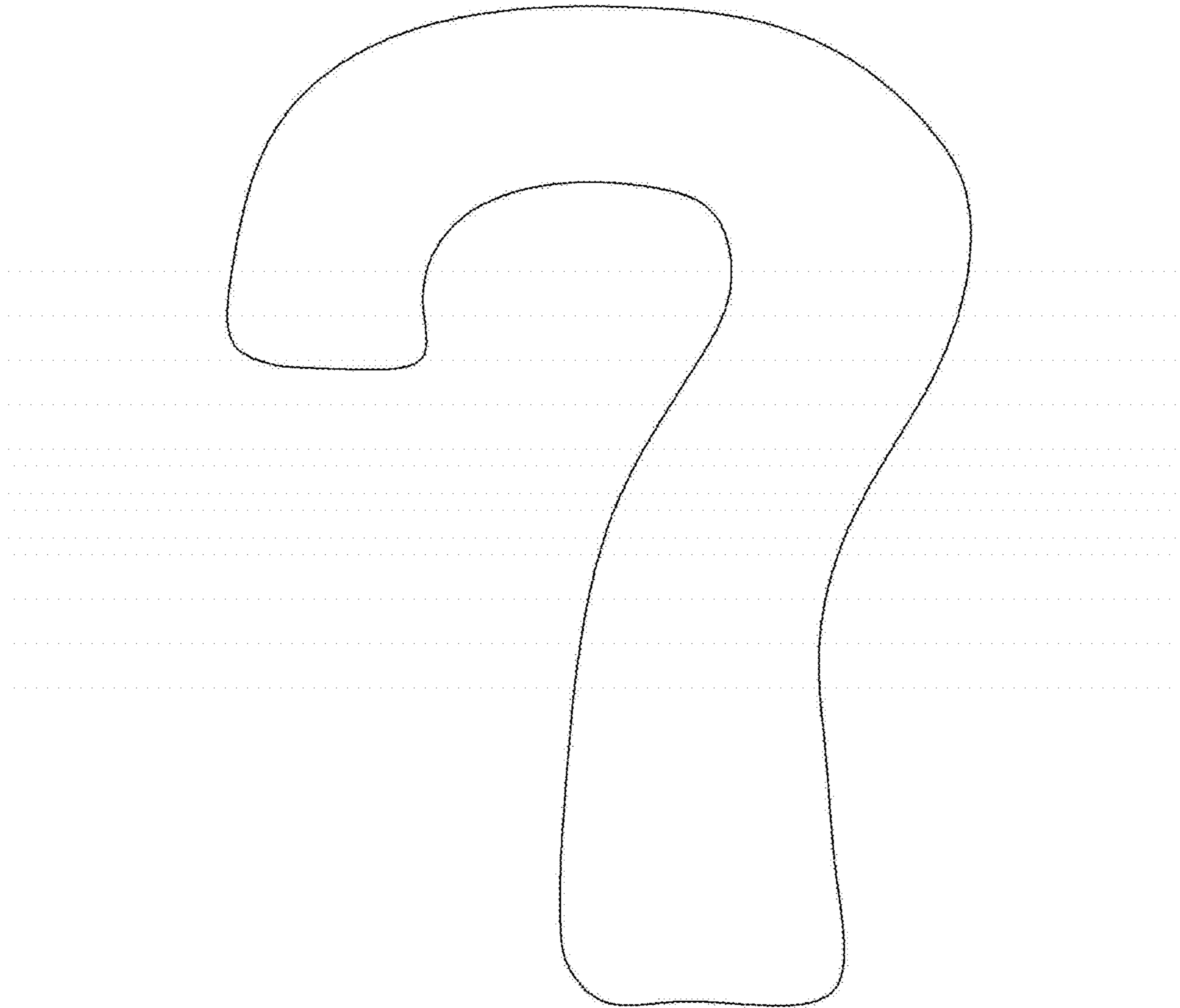

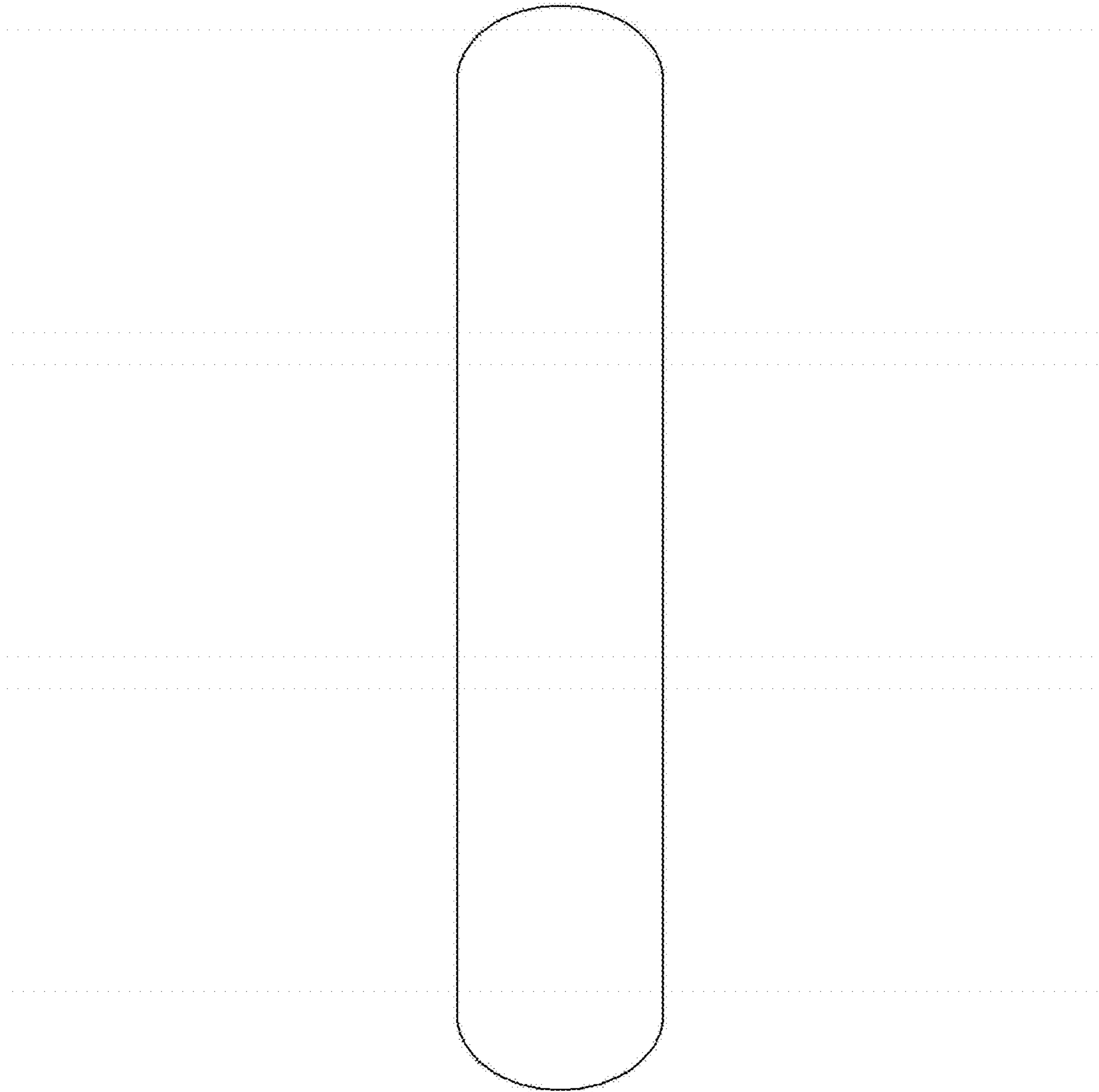

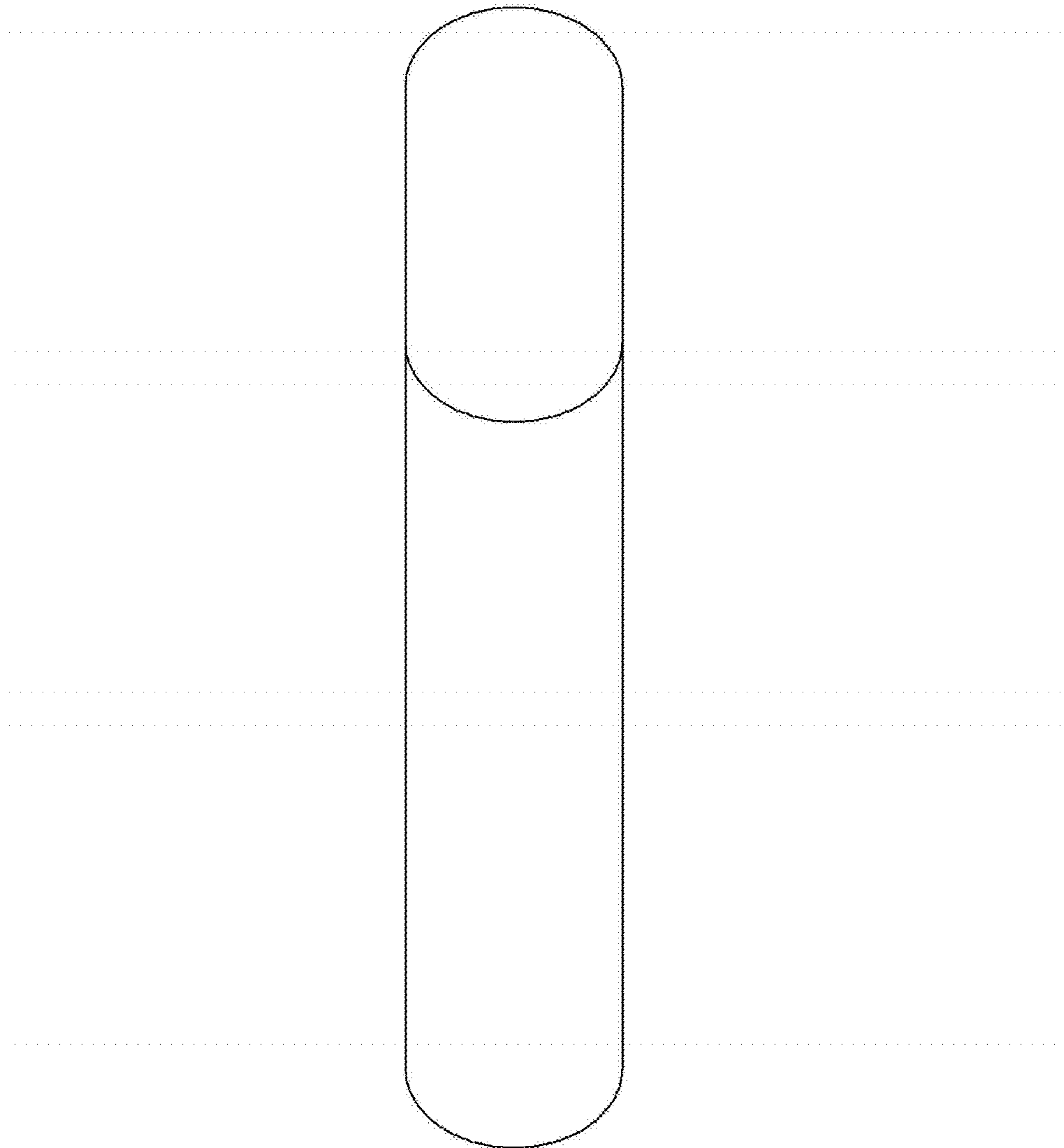

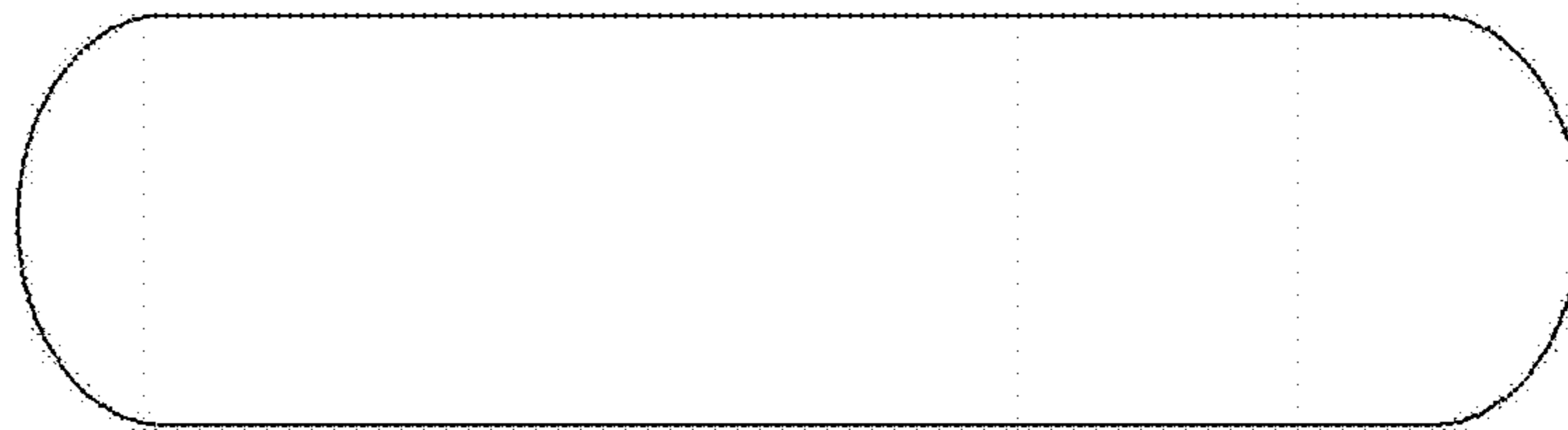

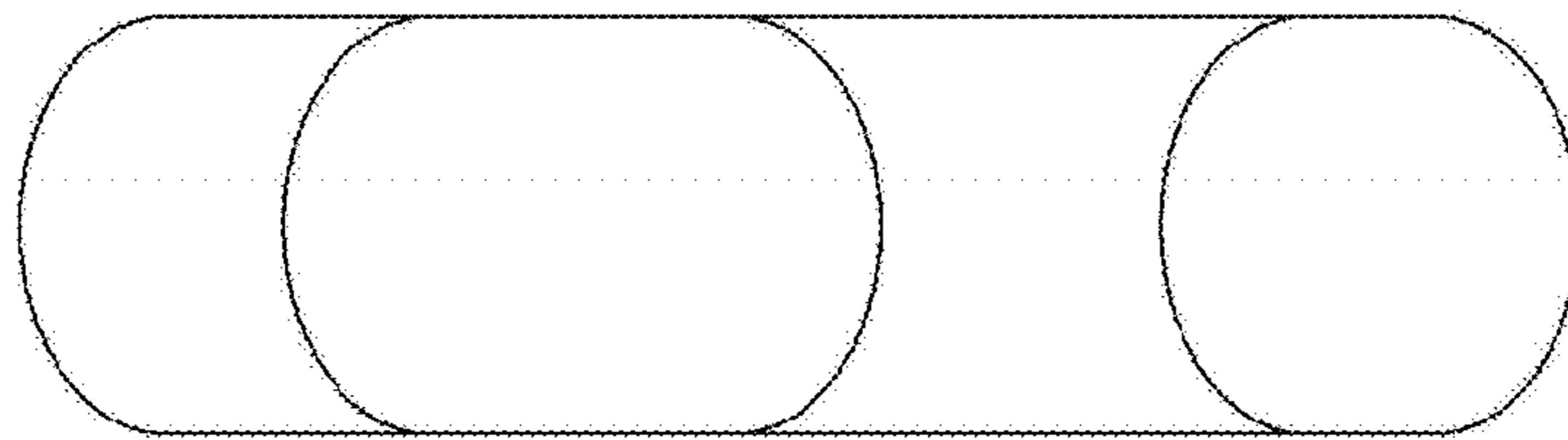
