DESCRIPTION

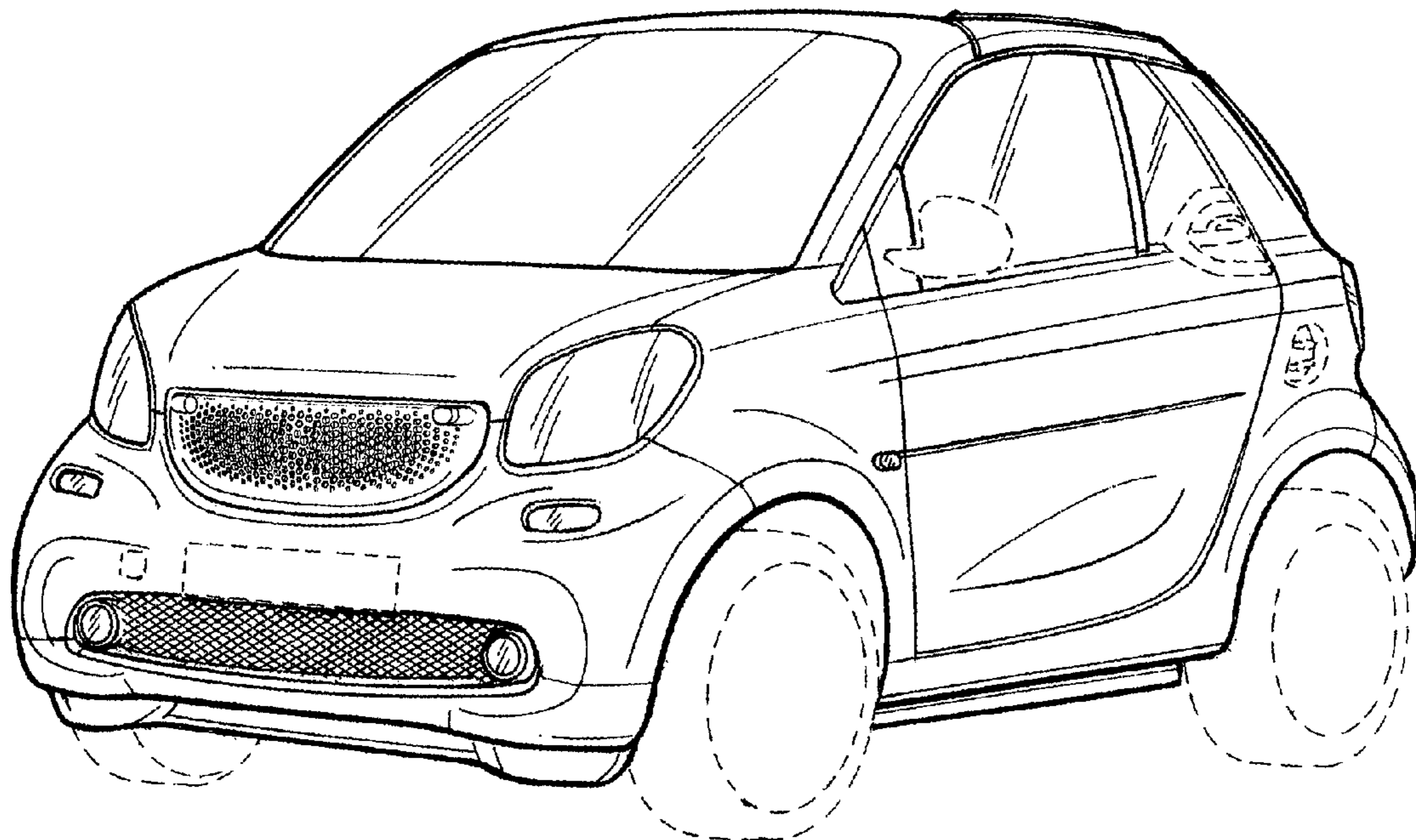
This application contains subject matter related to the following U.S. design patent application:

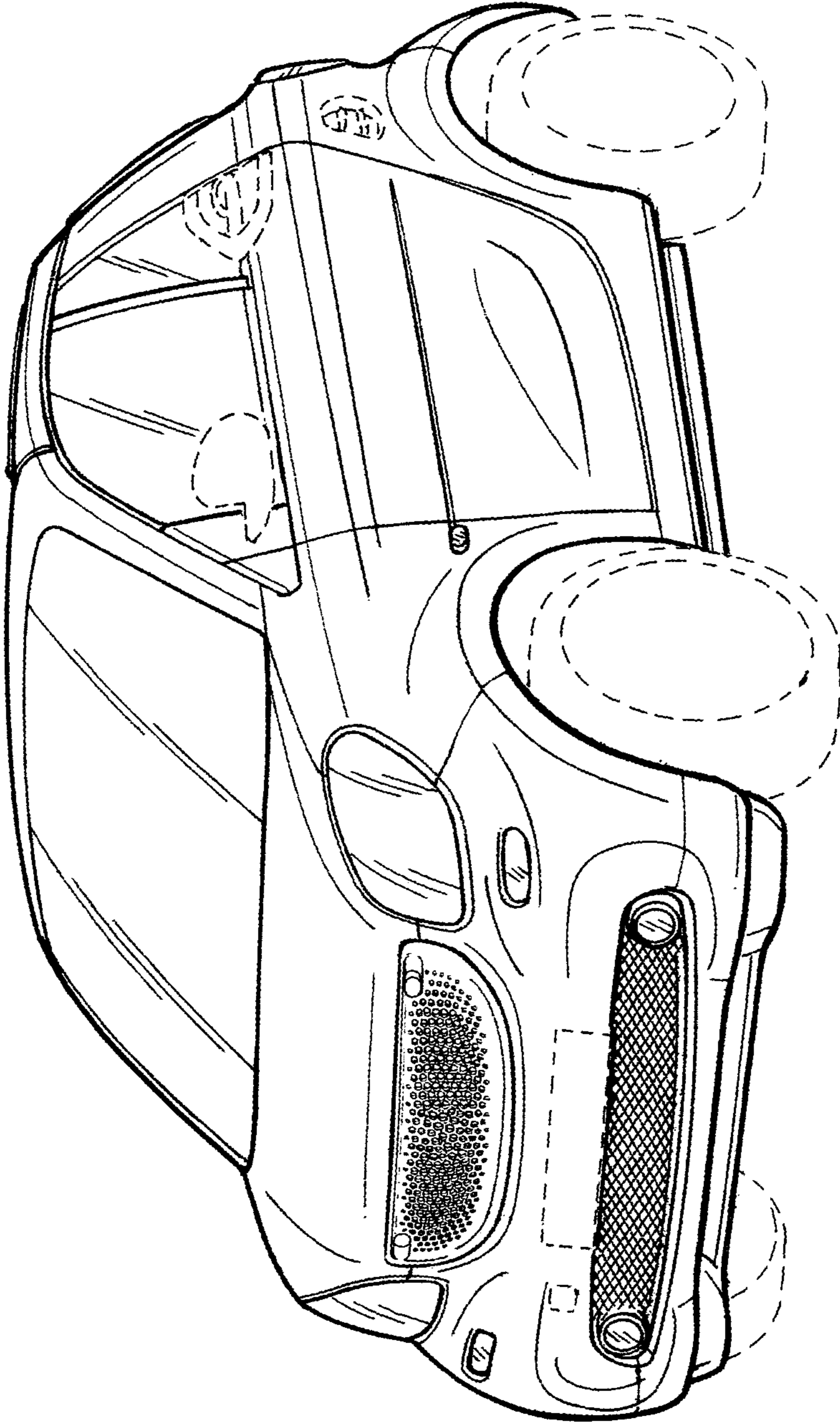

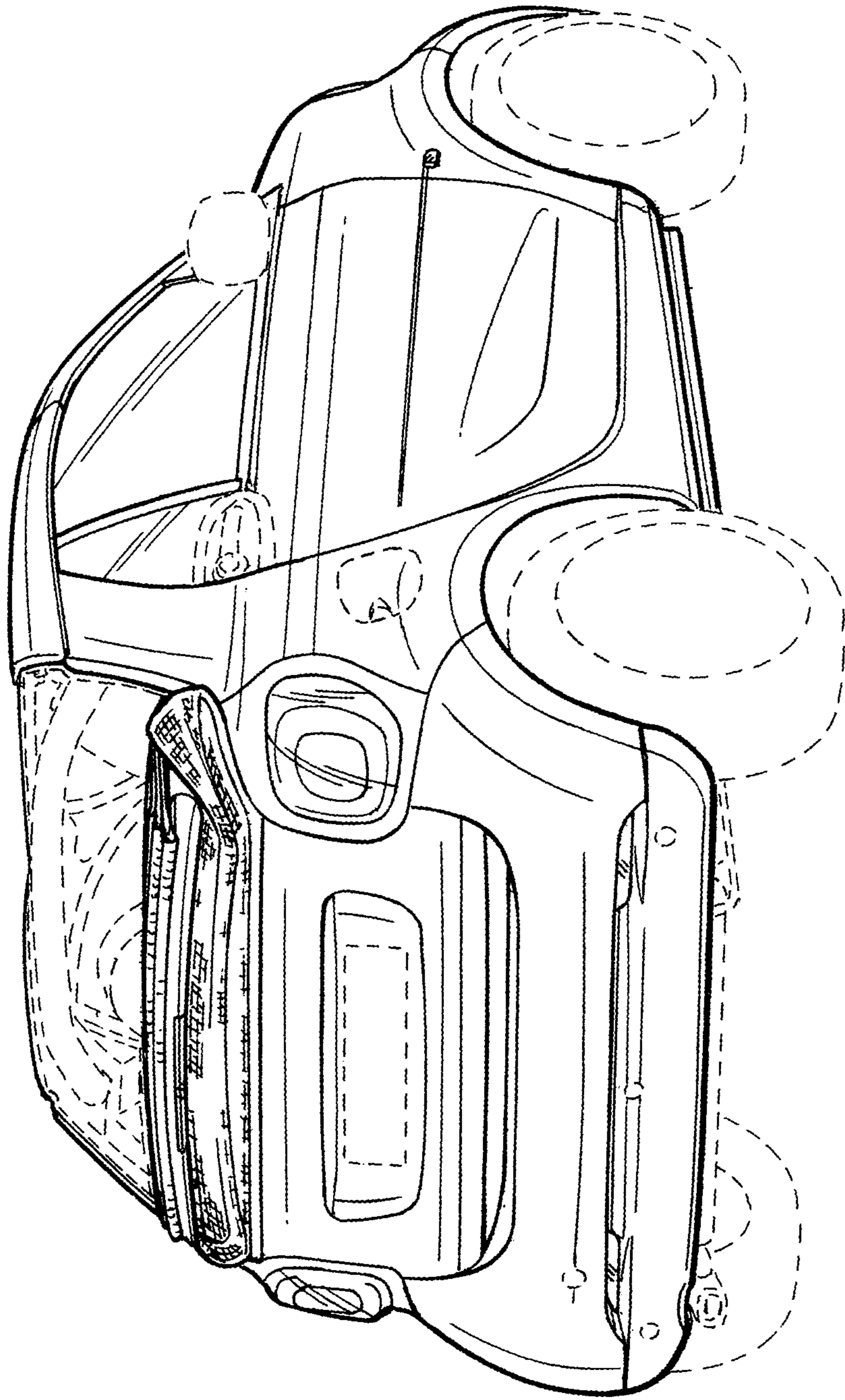

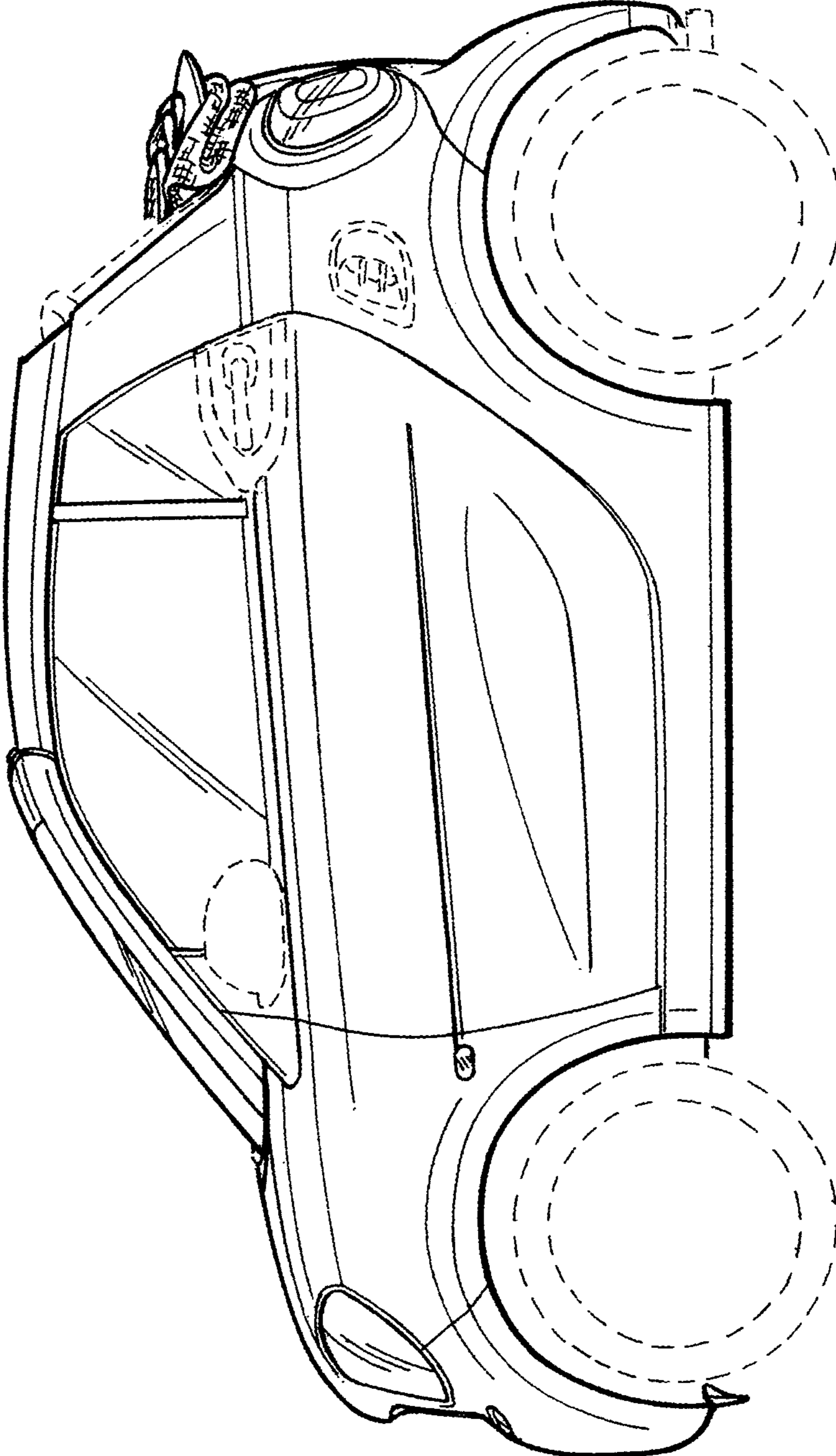

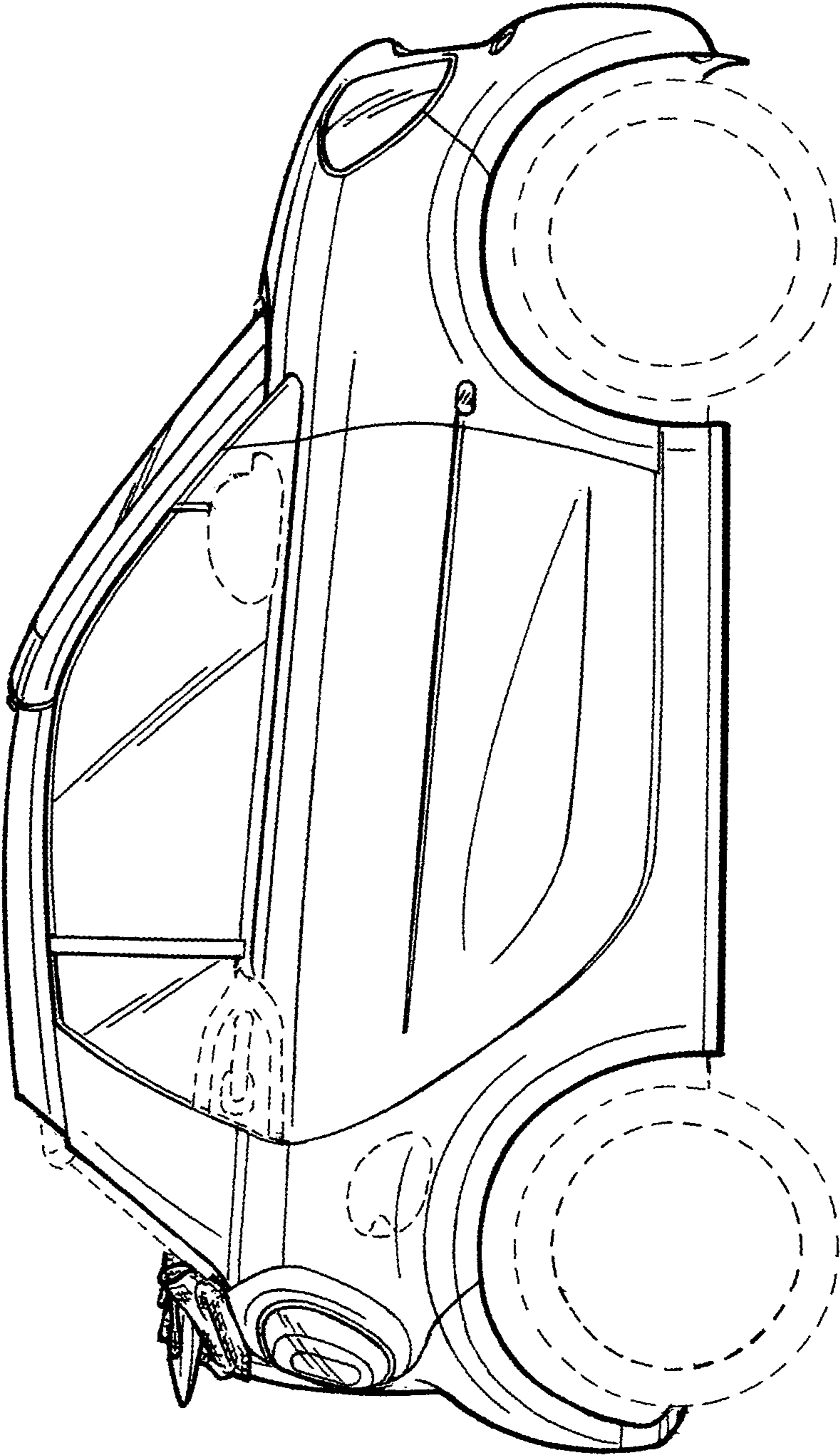

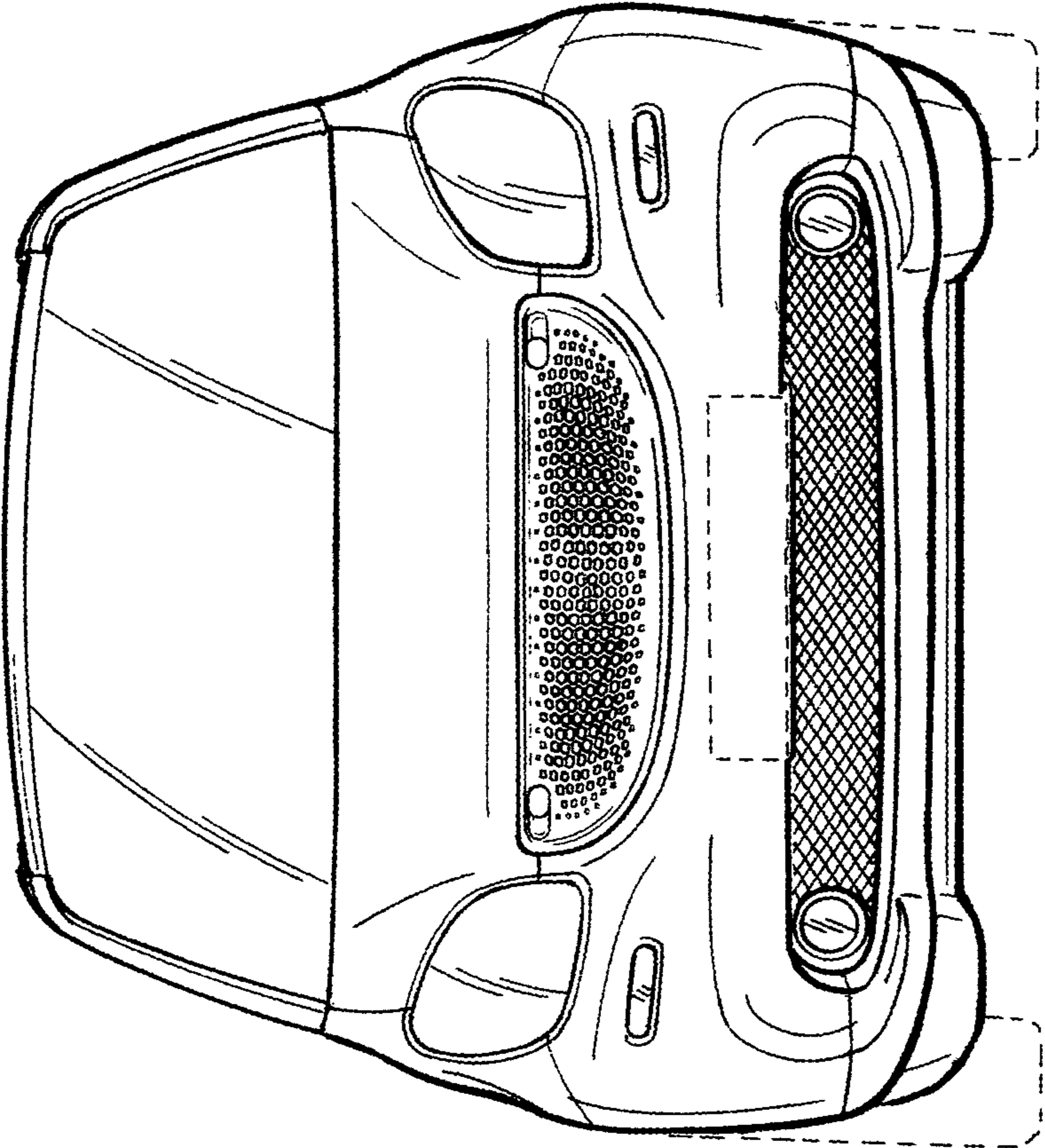

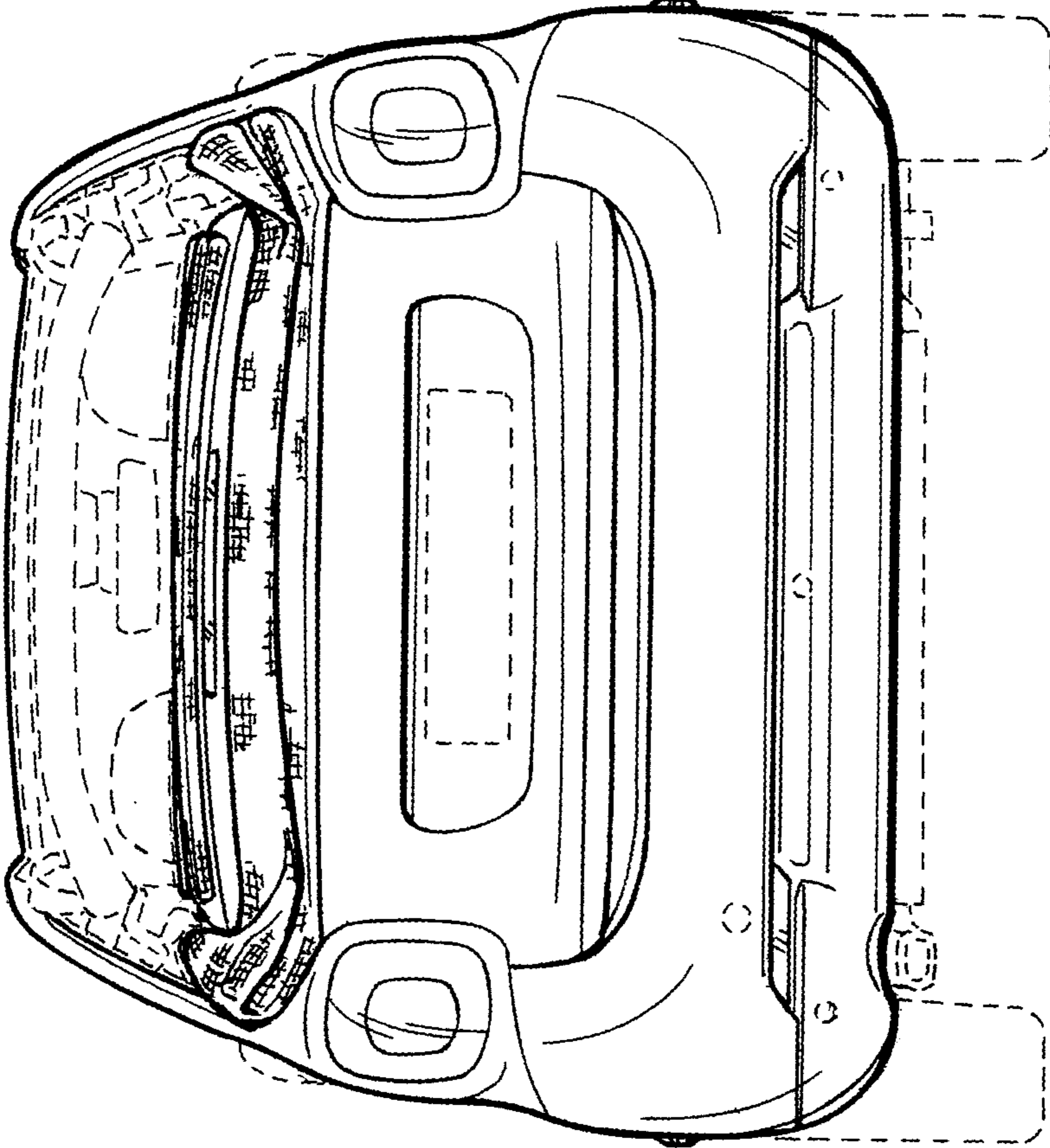
