DESCRIPTION

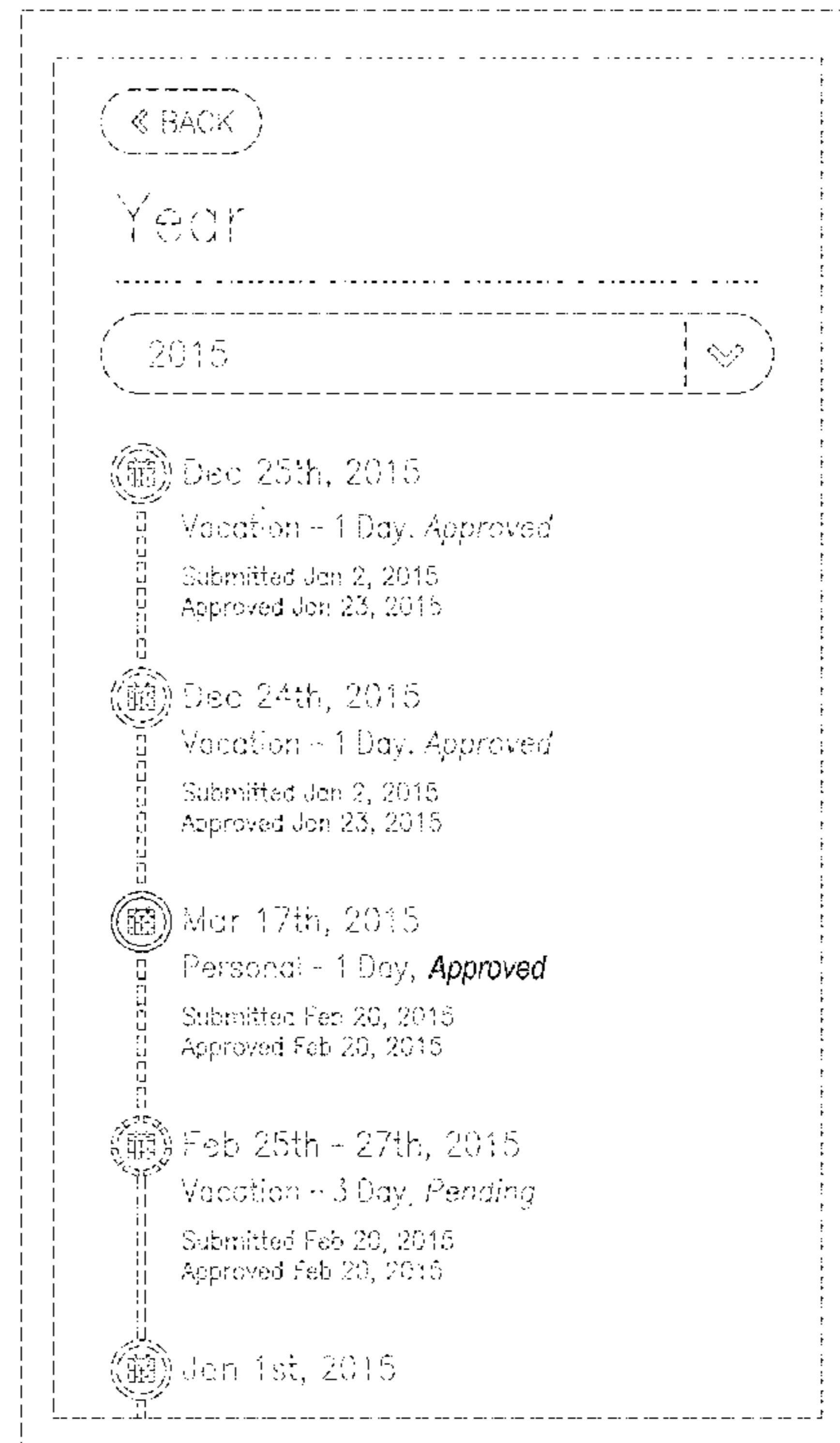
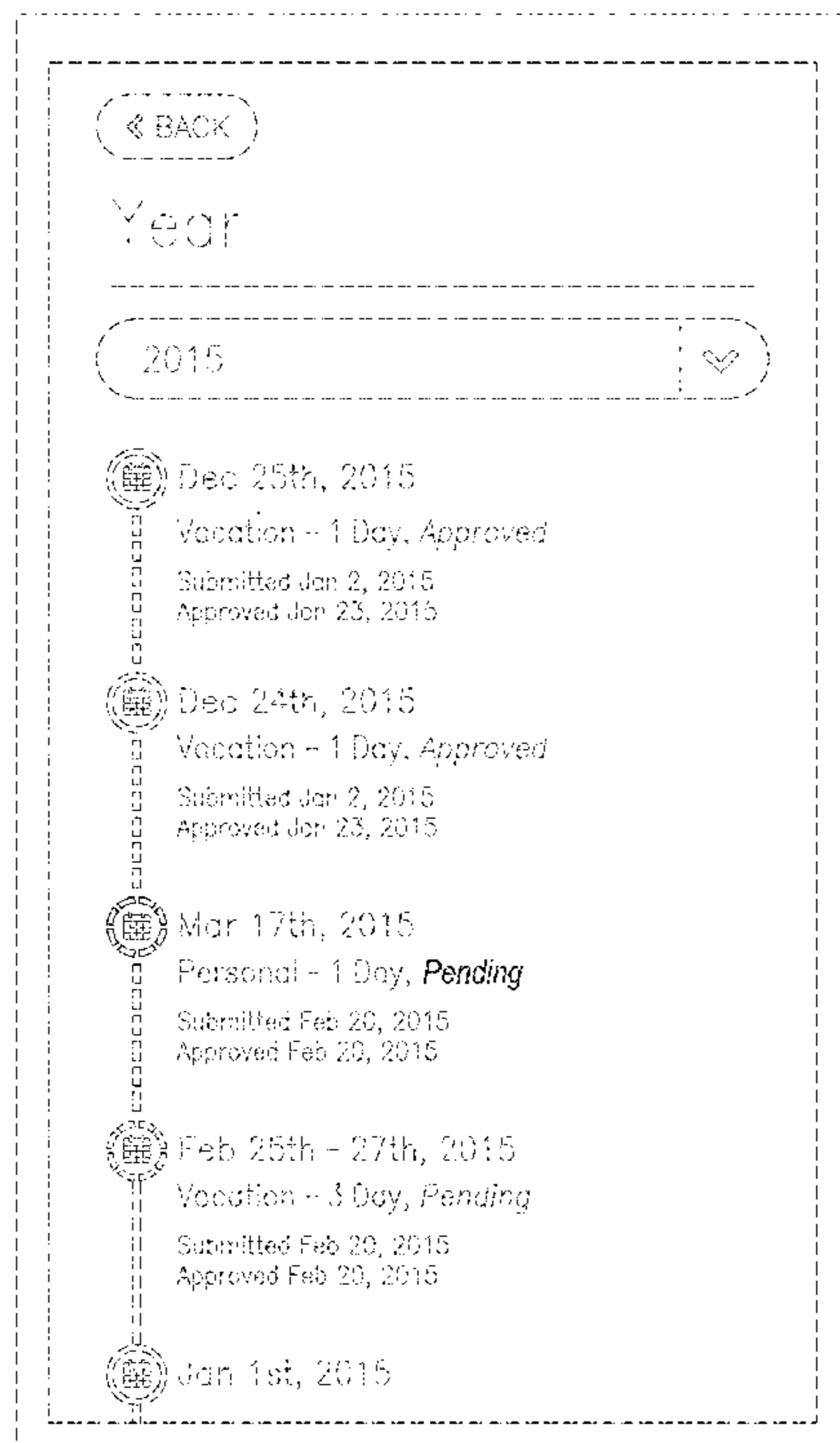
FIG. 1 is a front view of the first image of the display screen with an animated graphical user interface.

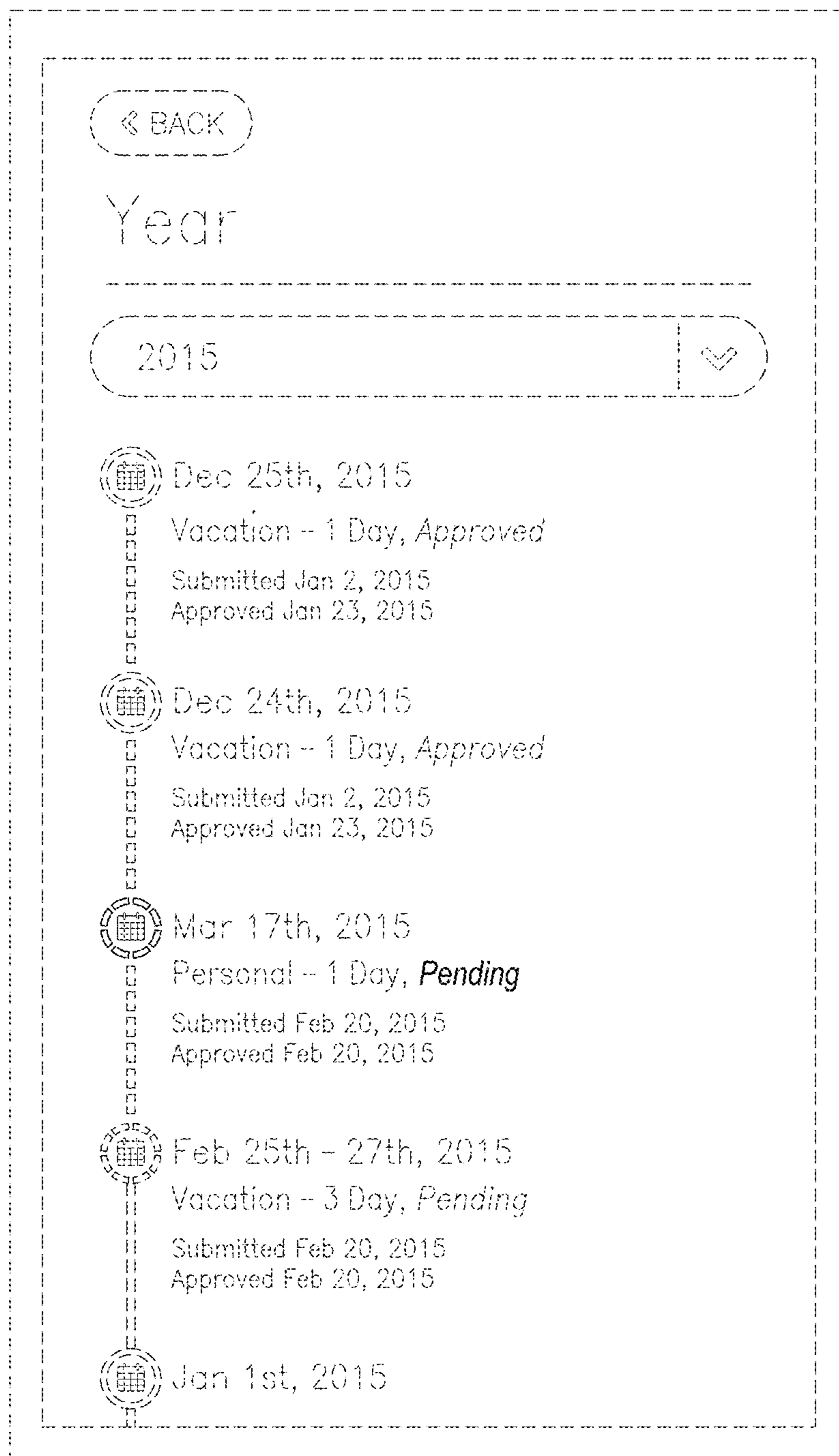

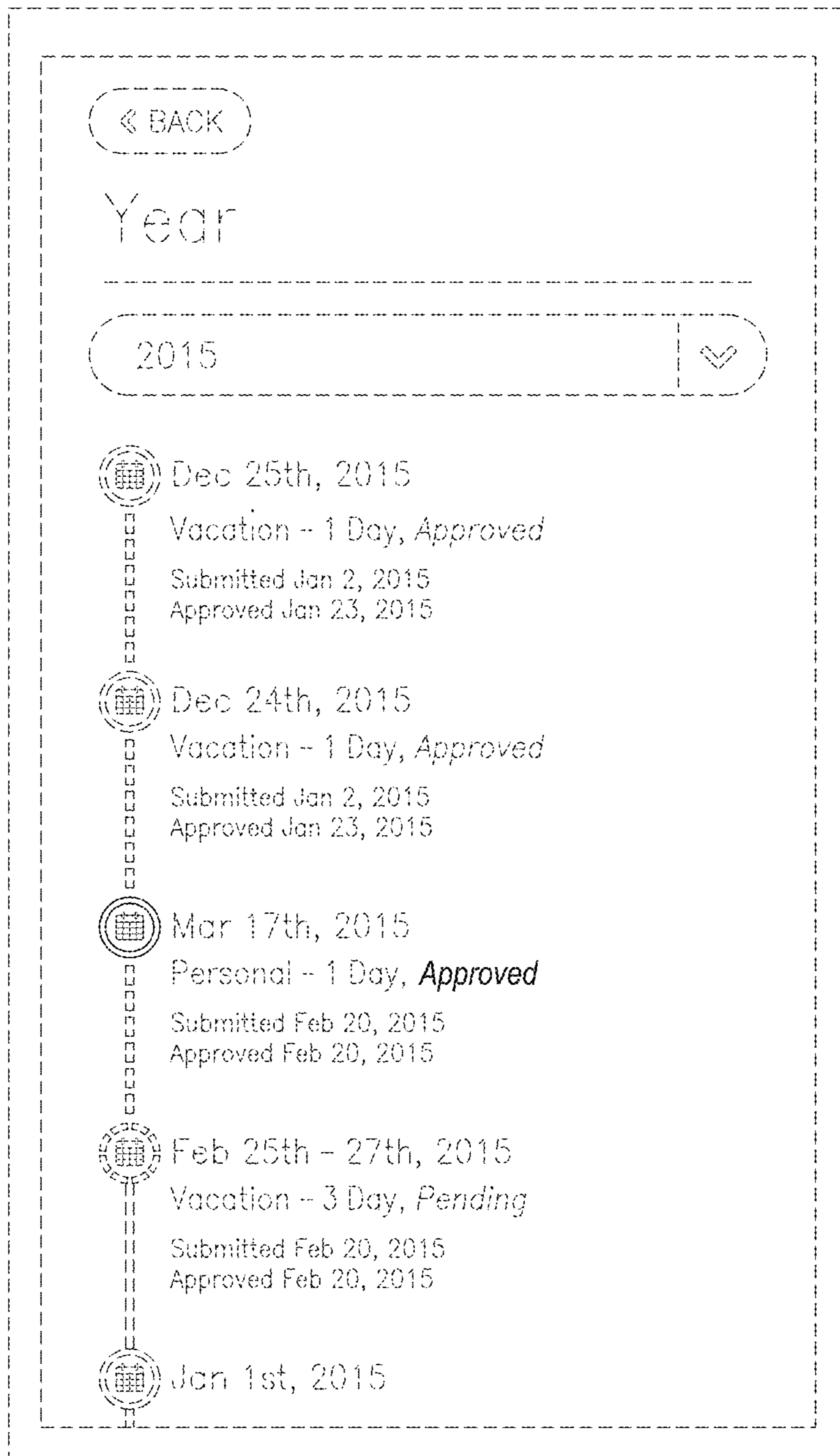

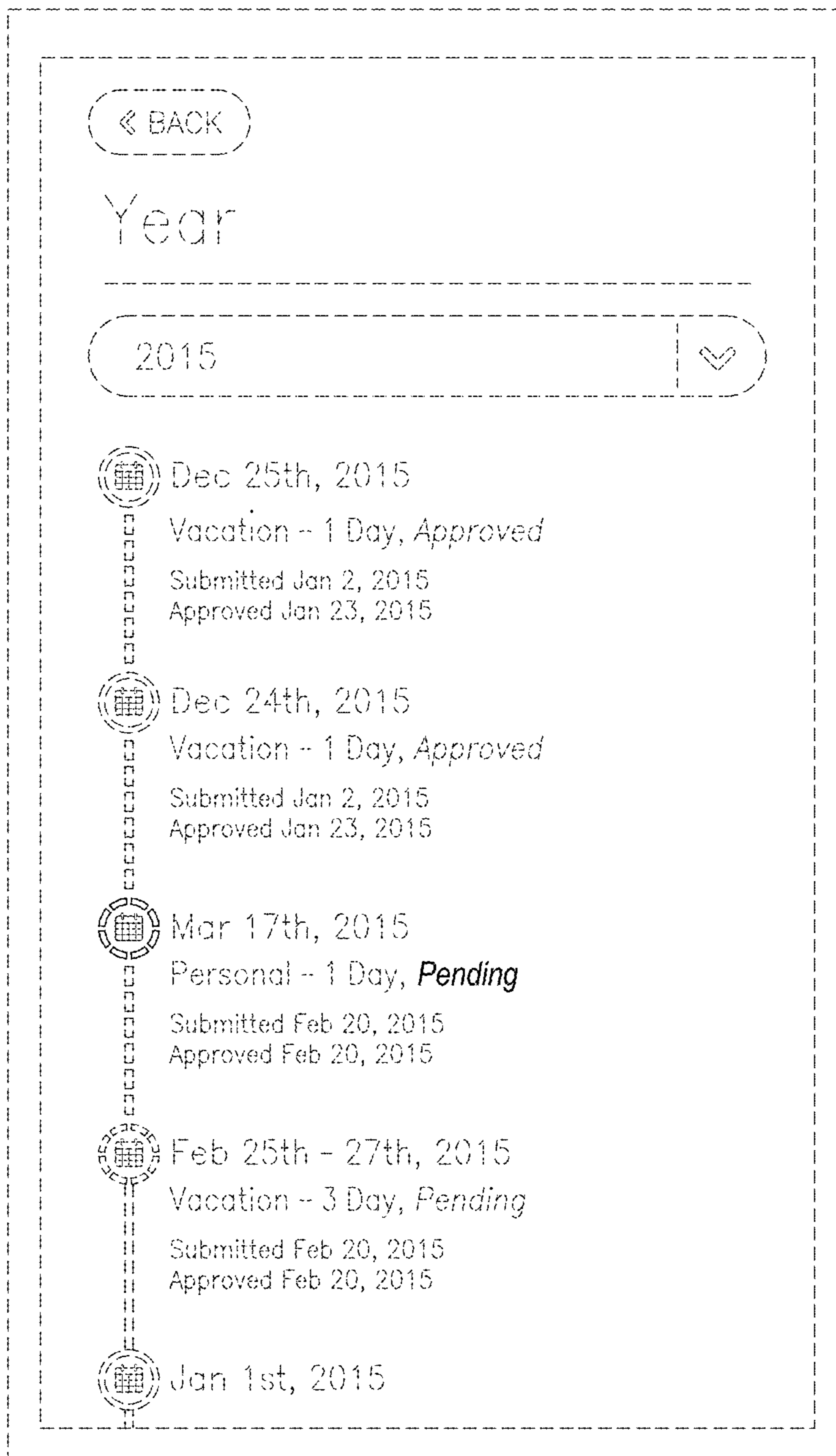

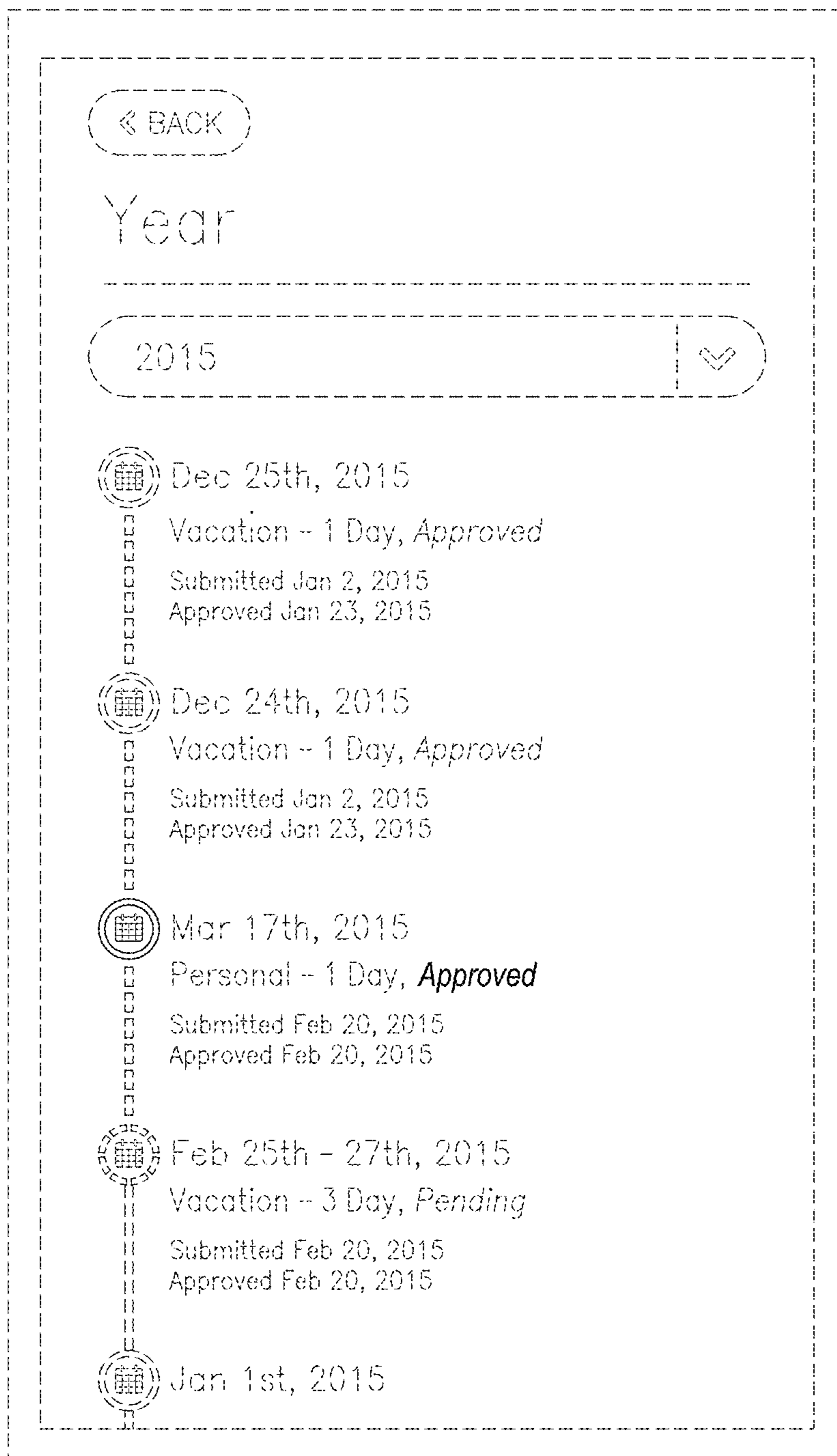
