FIG. 5 is the fifth image thereof.

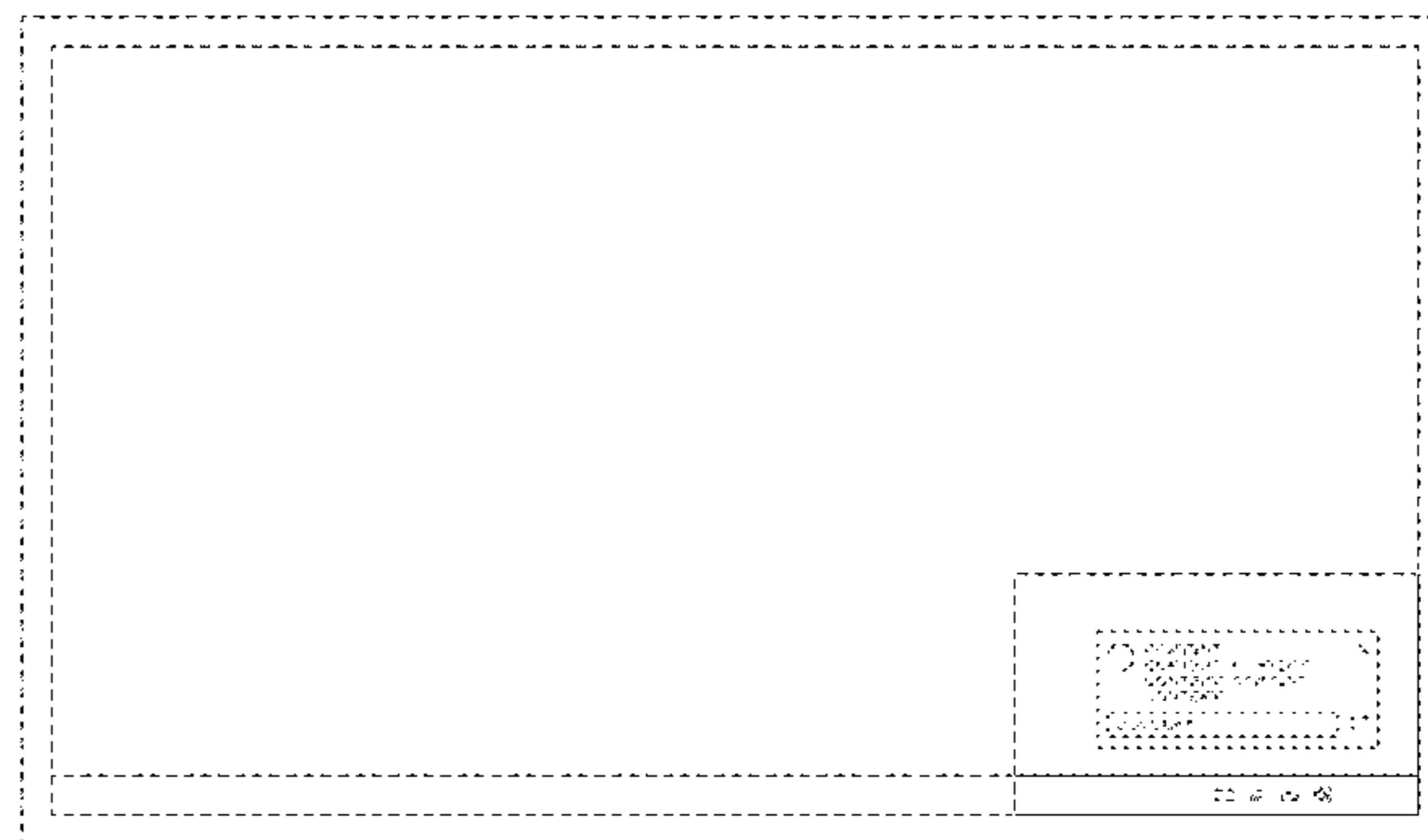
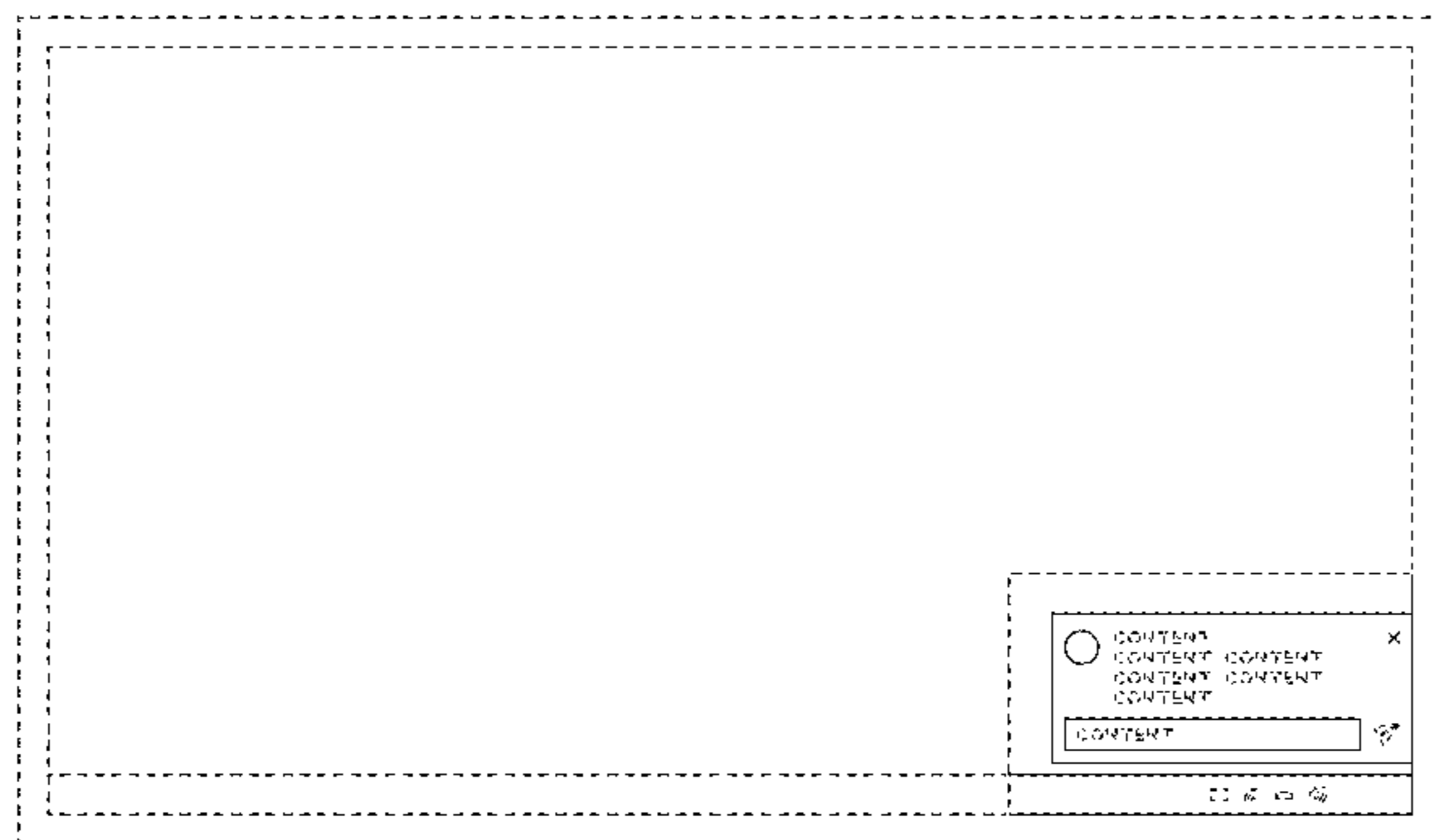
The difference in shade indicates a contrast of appearance and does not depict any particular color, texture, or material.

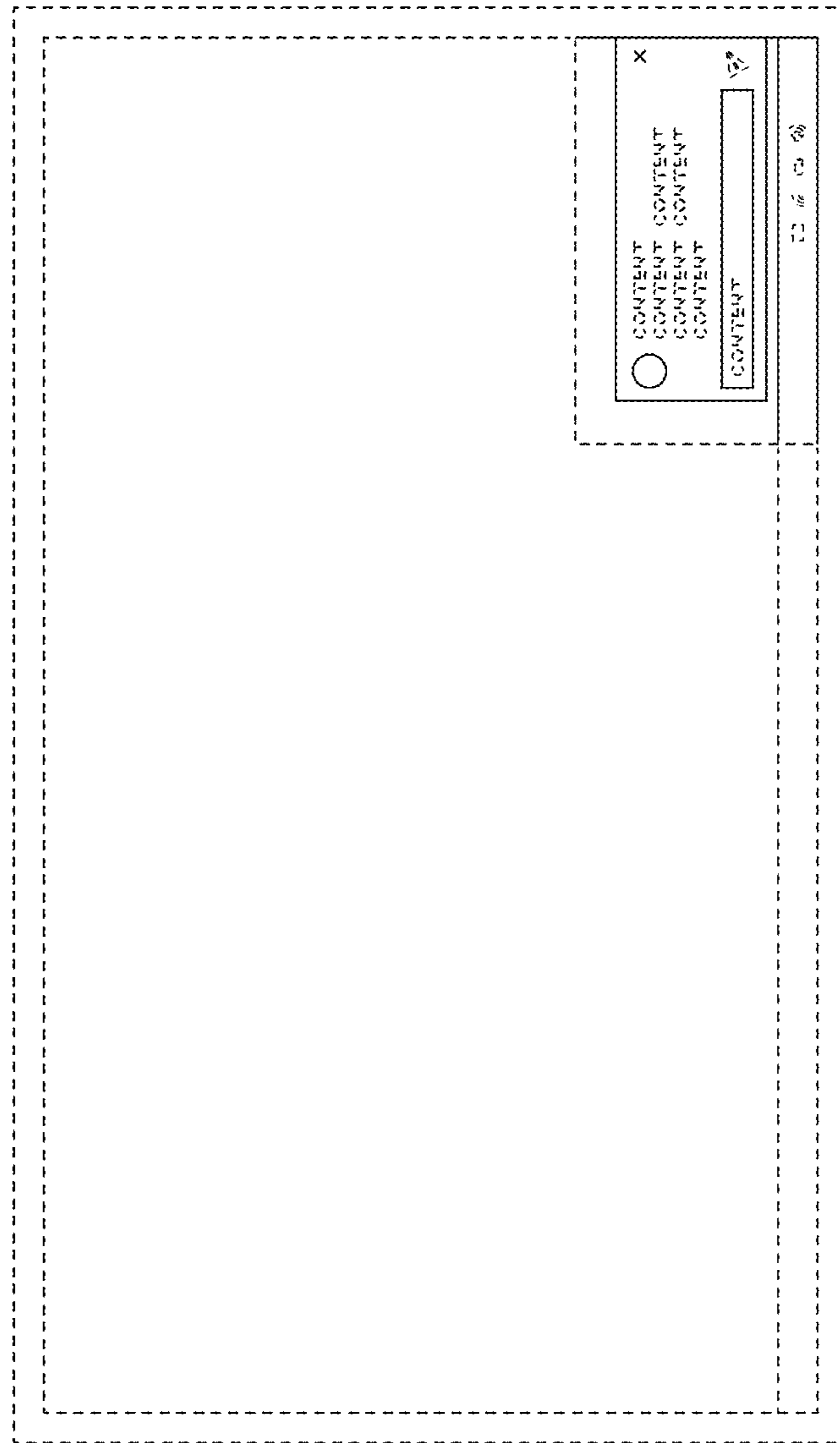

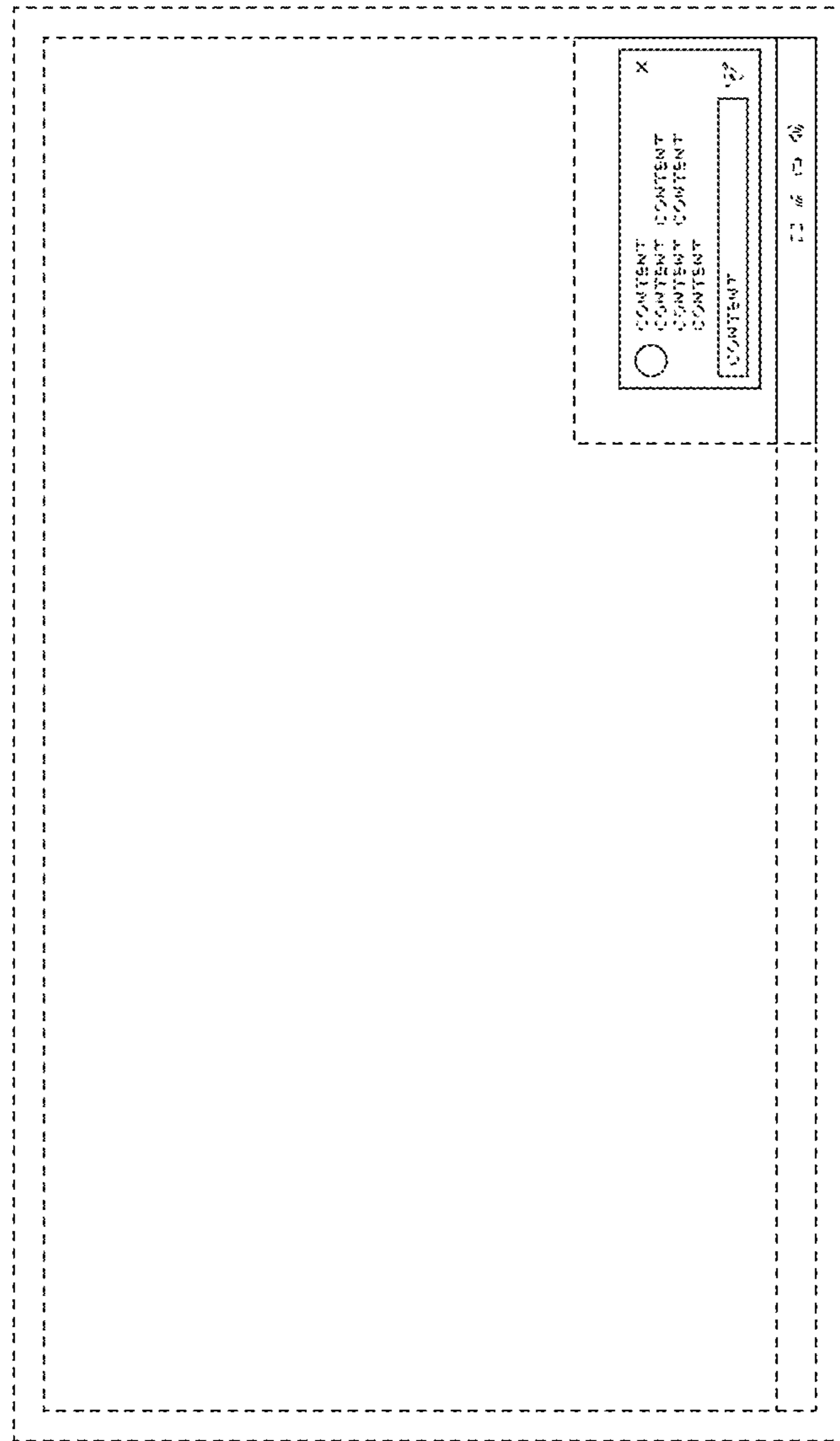

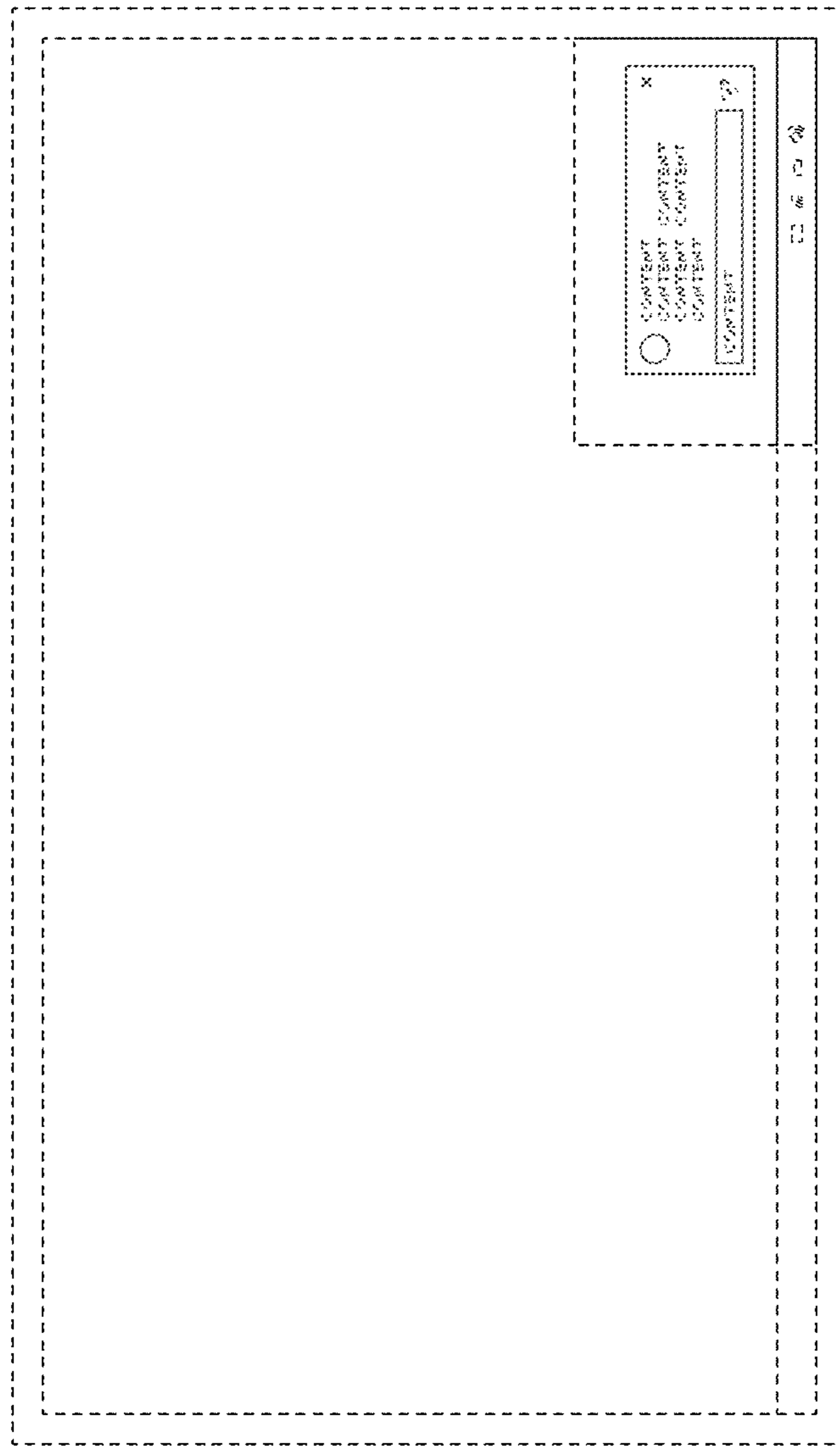

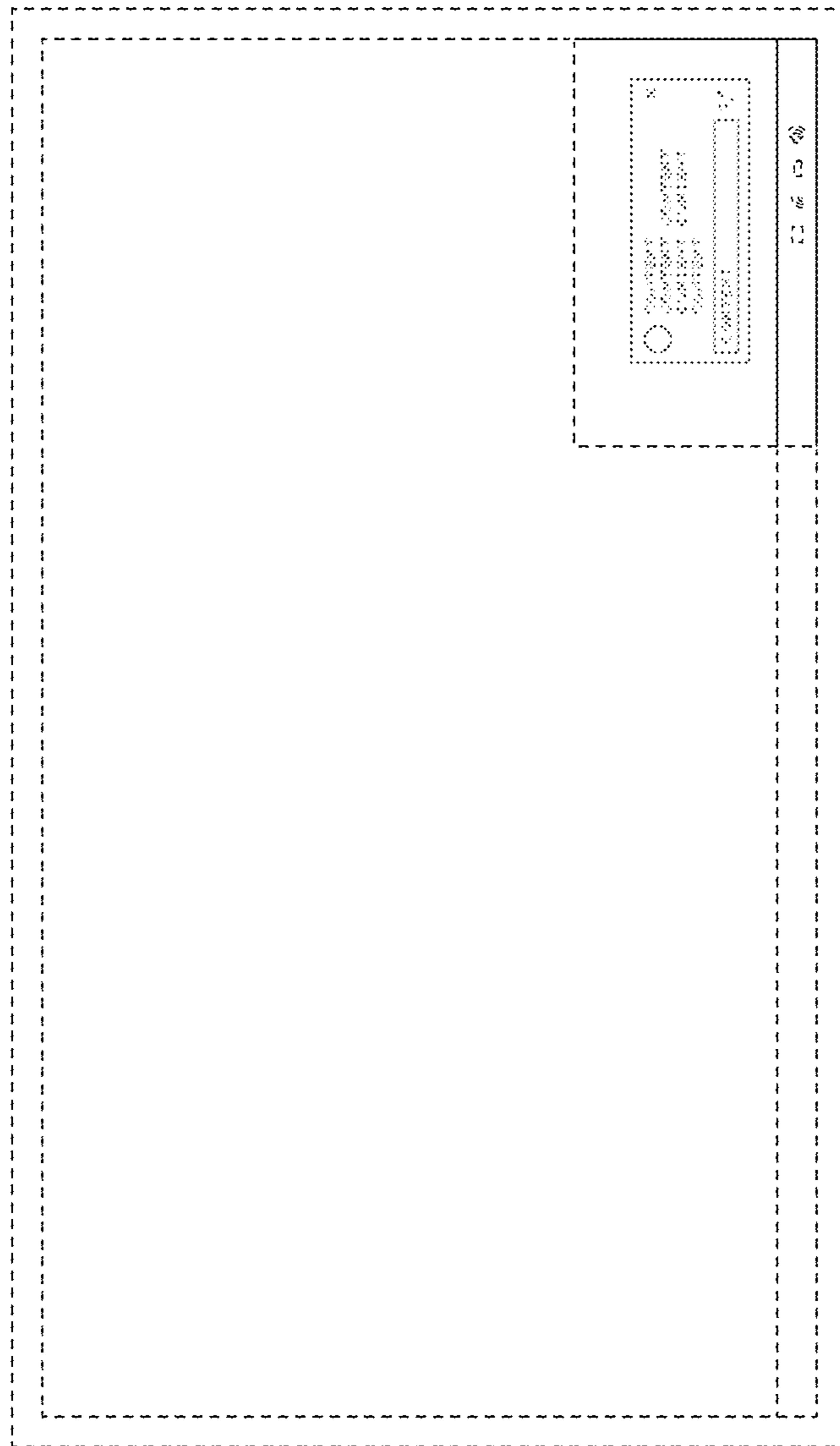

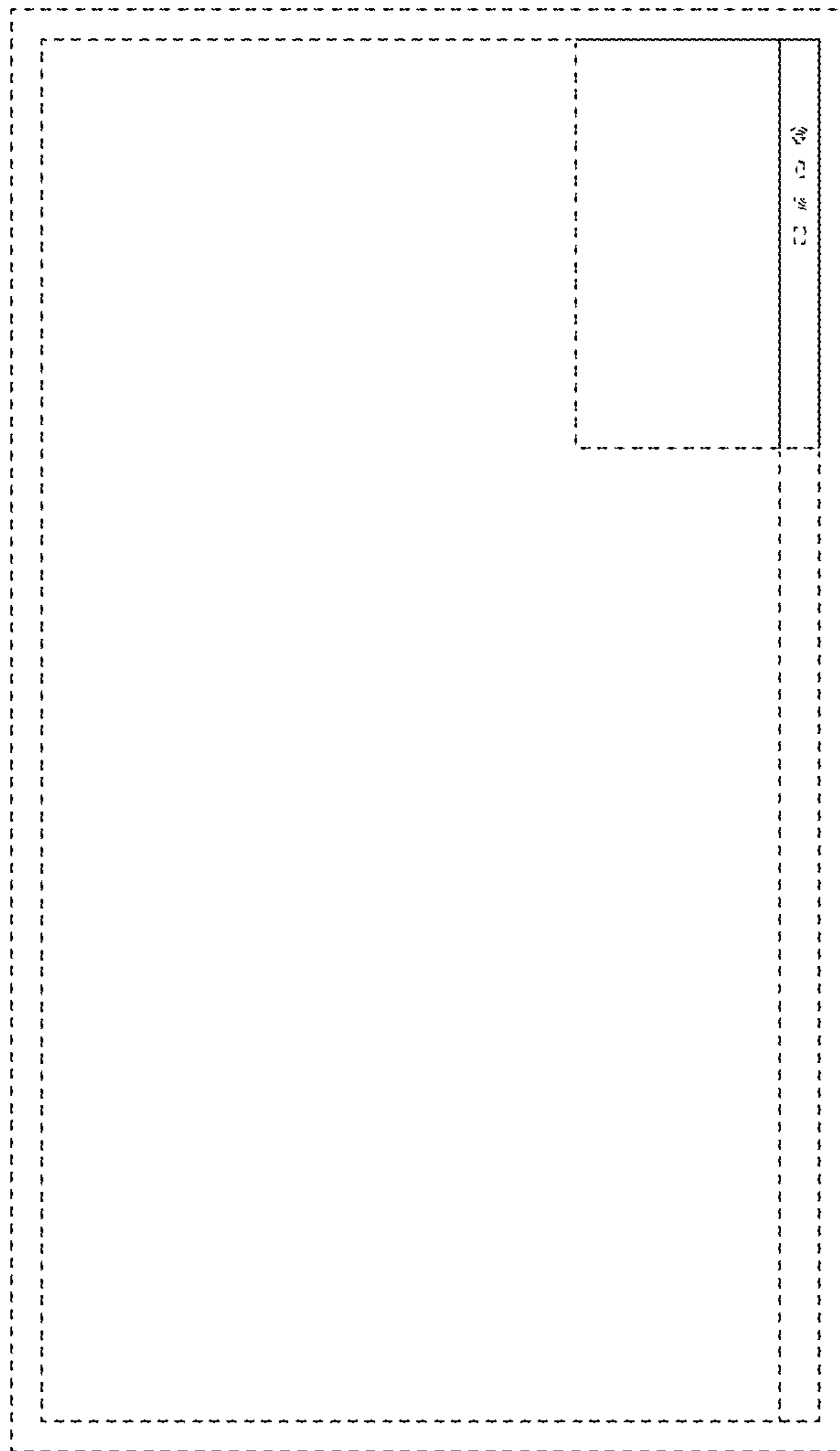
