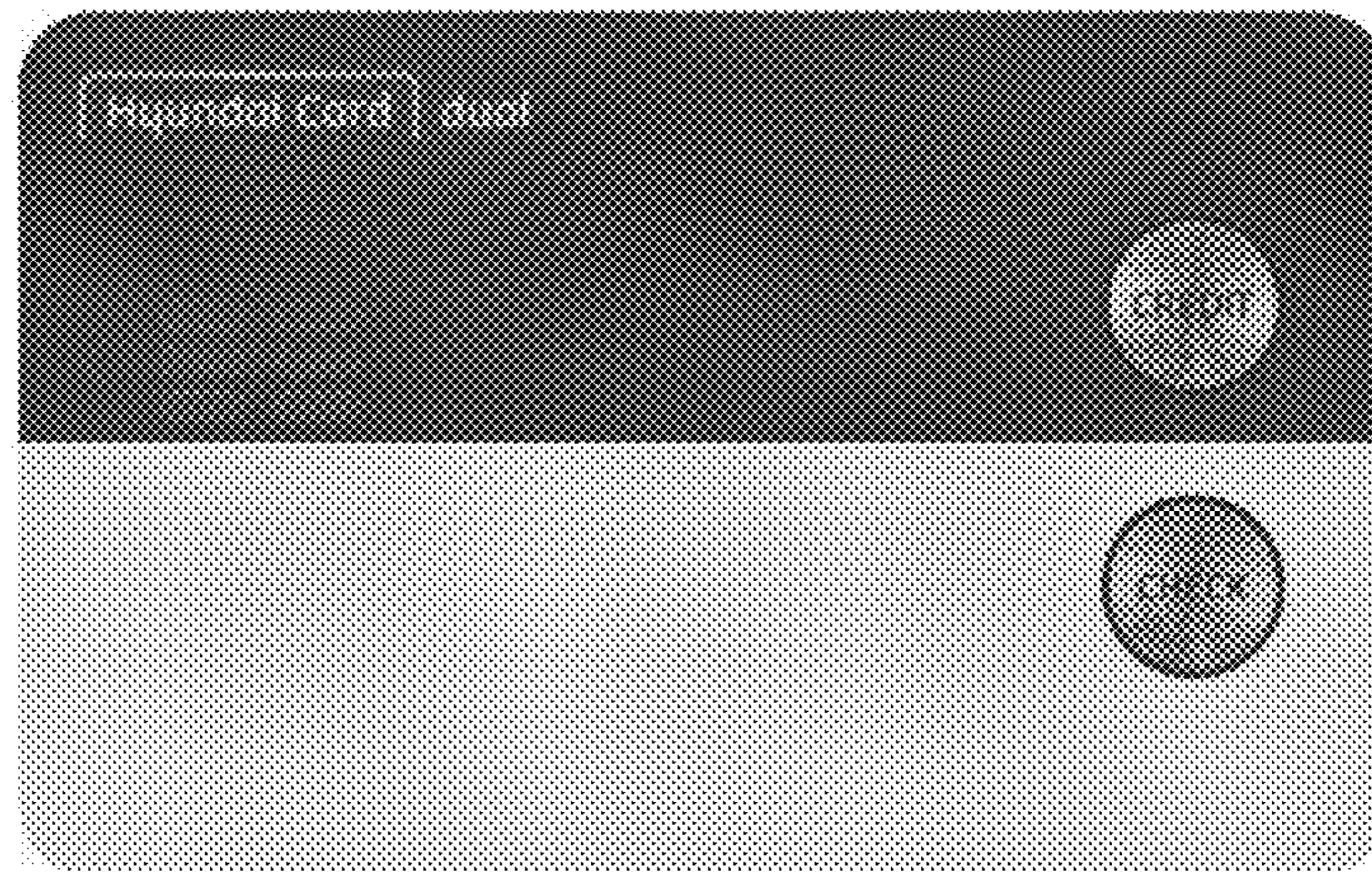
FIG. 1 is a front view of a credit card of the present invention; and,

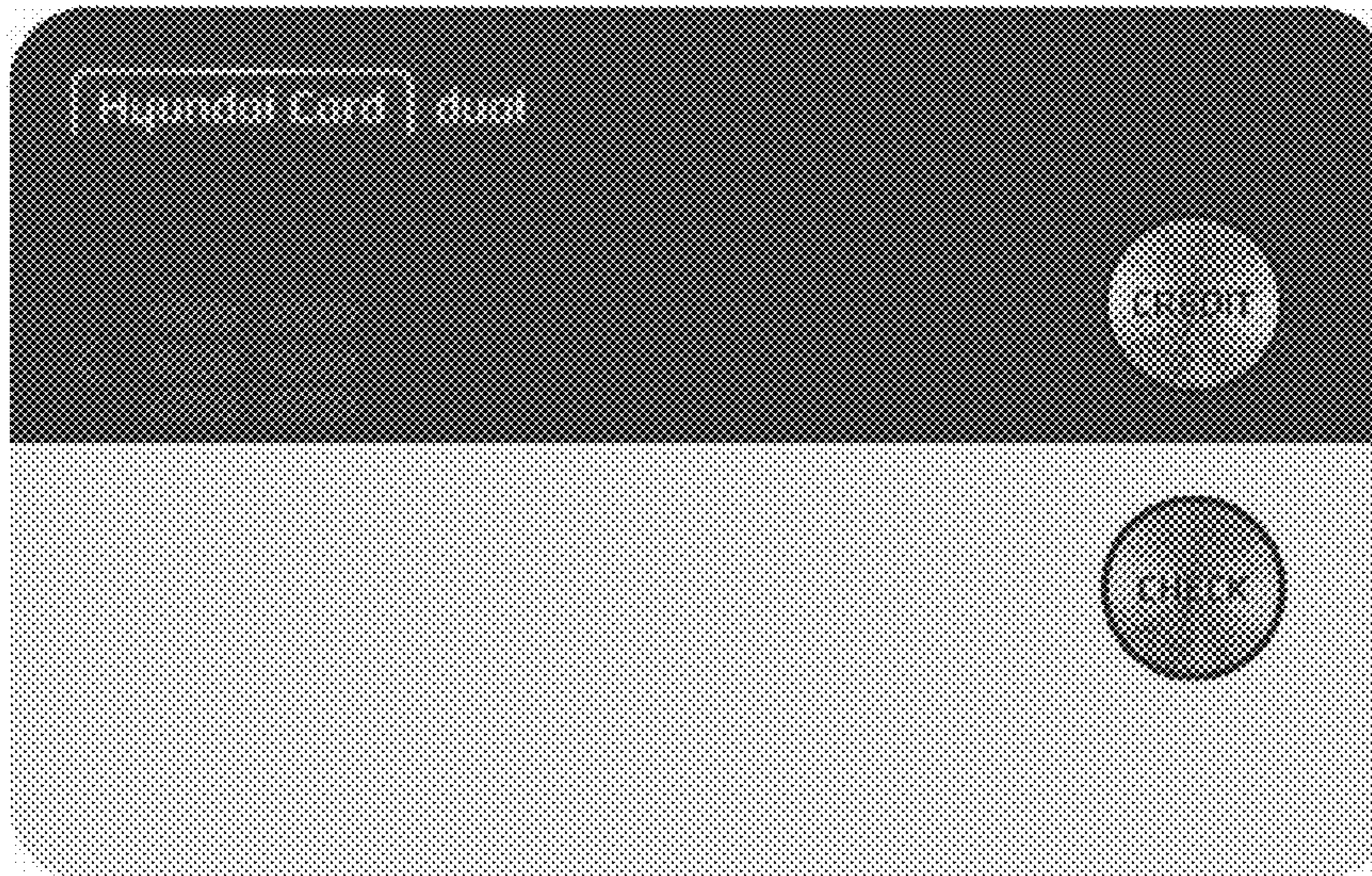

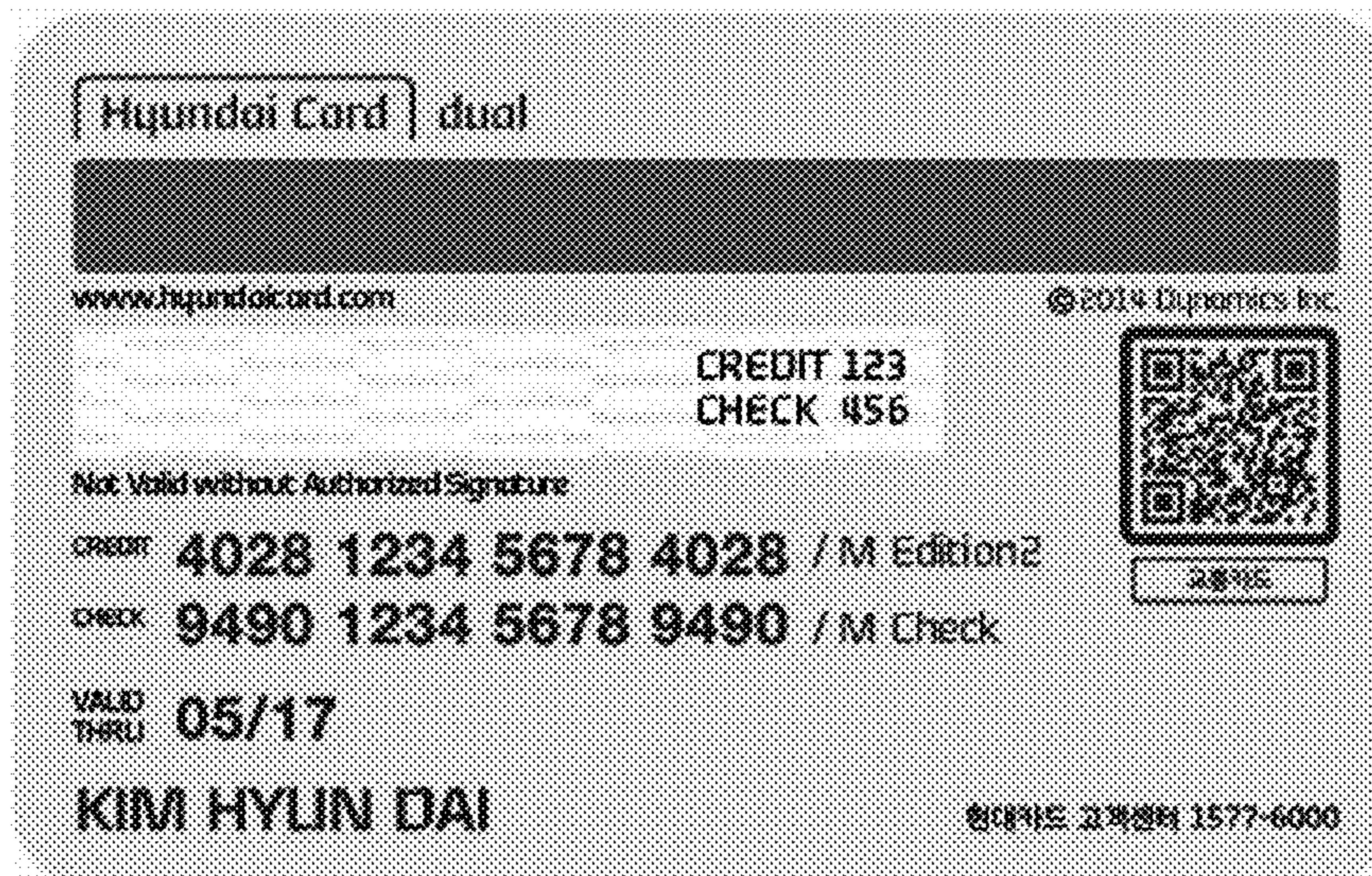
