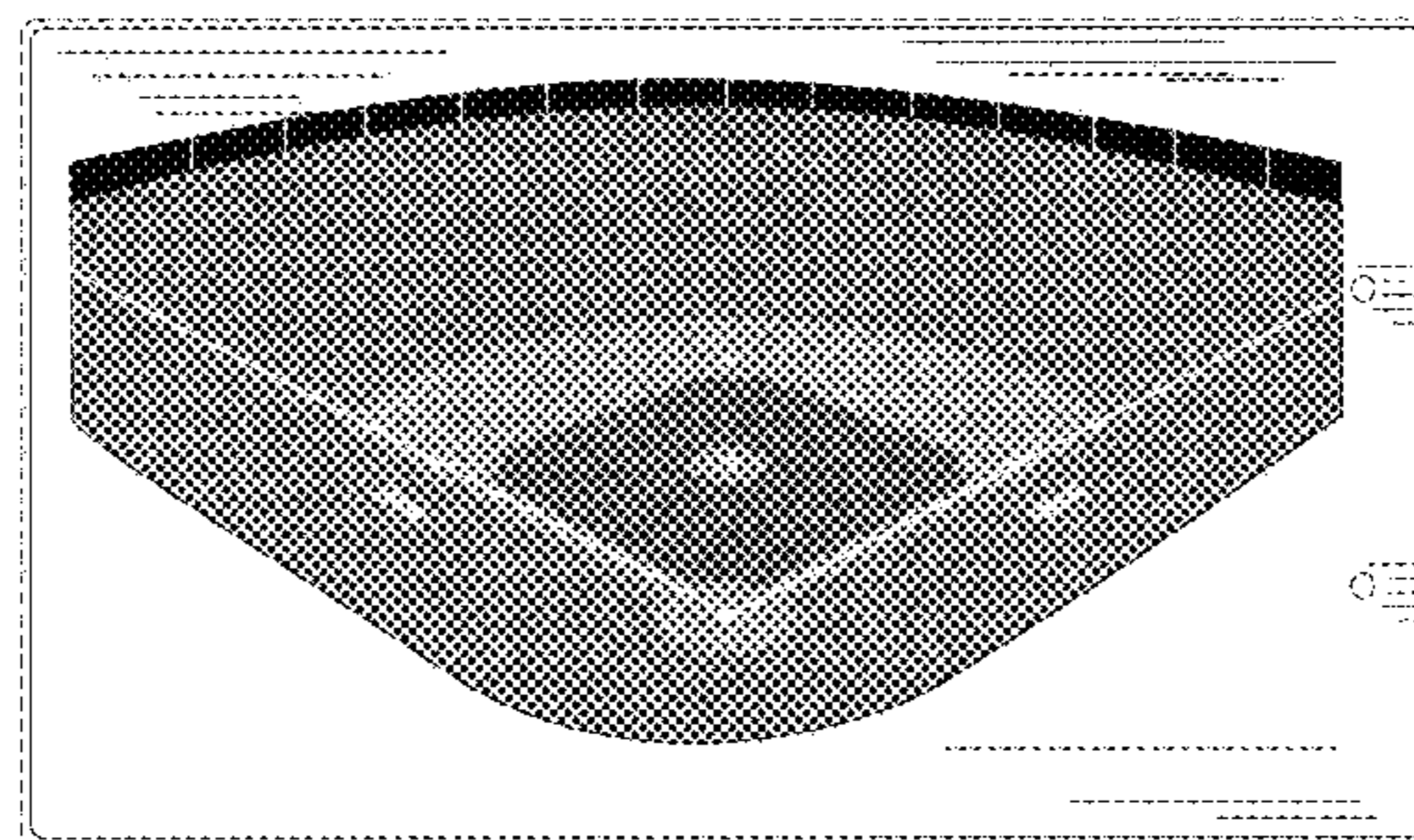
(57) **CLAIM**

The ornamental design for a baseball diamond clipboard, as shown and described.

DESCRIPTION

FIG. 1 is a plan view of a baseball diamond clipboard; and, FIG. 2 is a side plan view of the clipboard. The broken lines in FIGS. 1 and 2 are included for the purpose of showing portions of the baseball diamond clipboard that form no part of the claimed design.

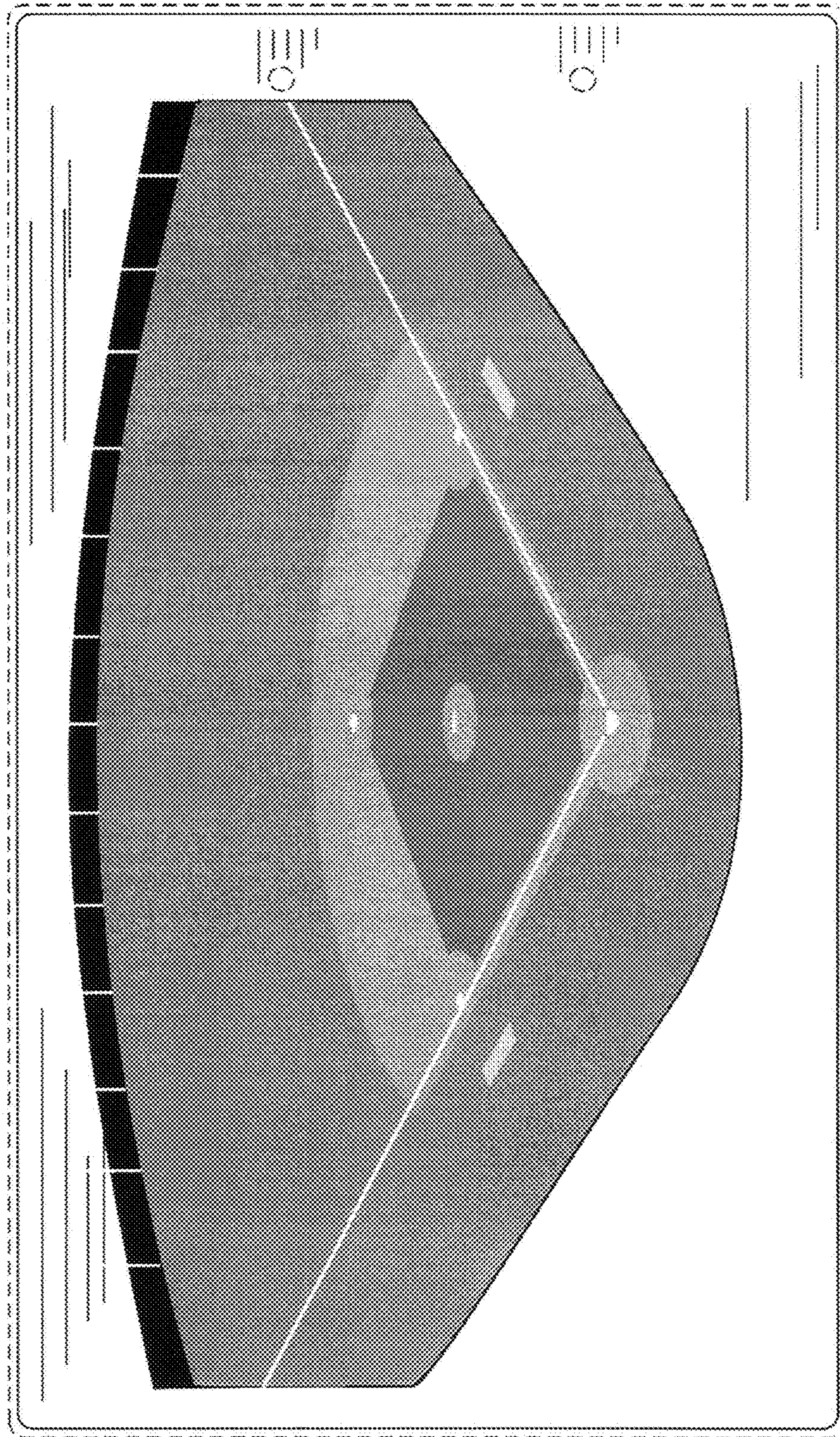

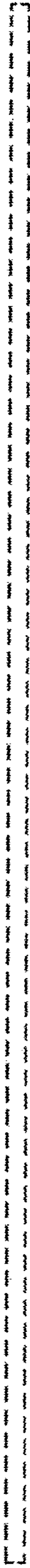
