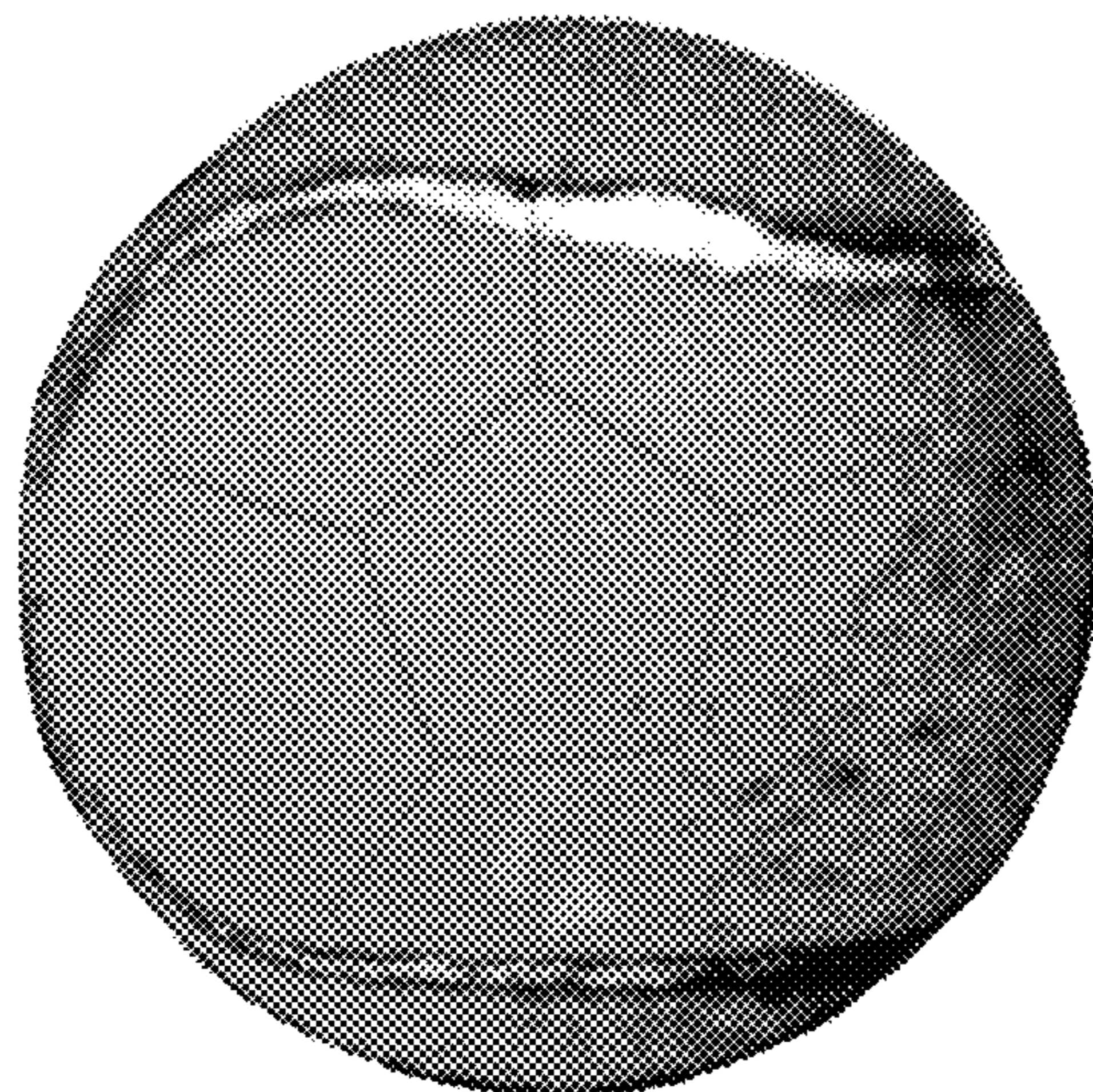
The ornamental design for a soccer ball, as shown and described.

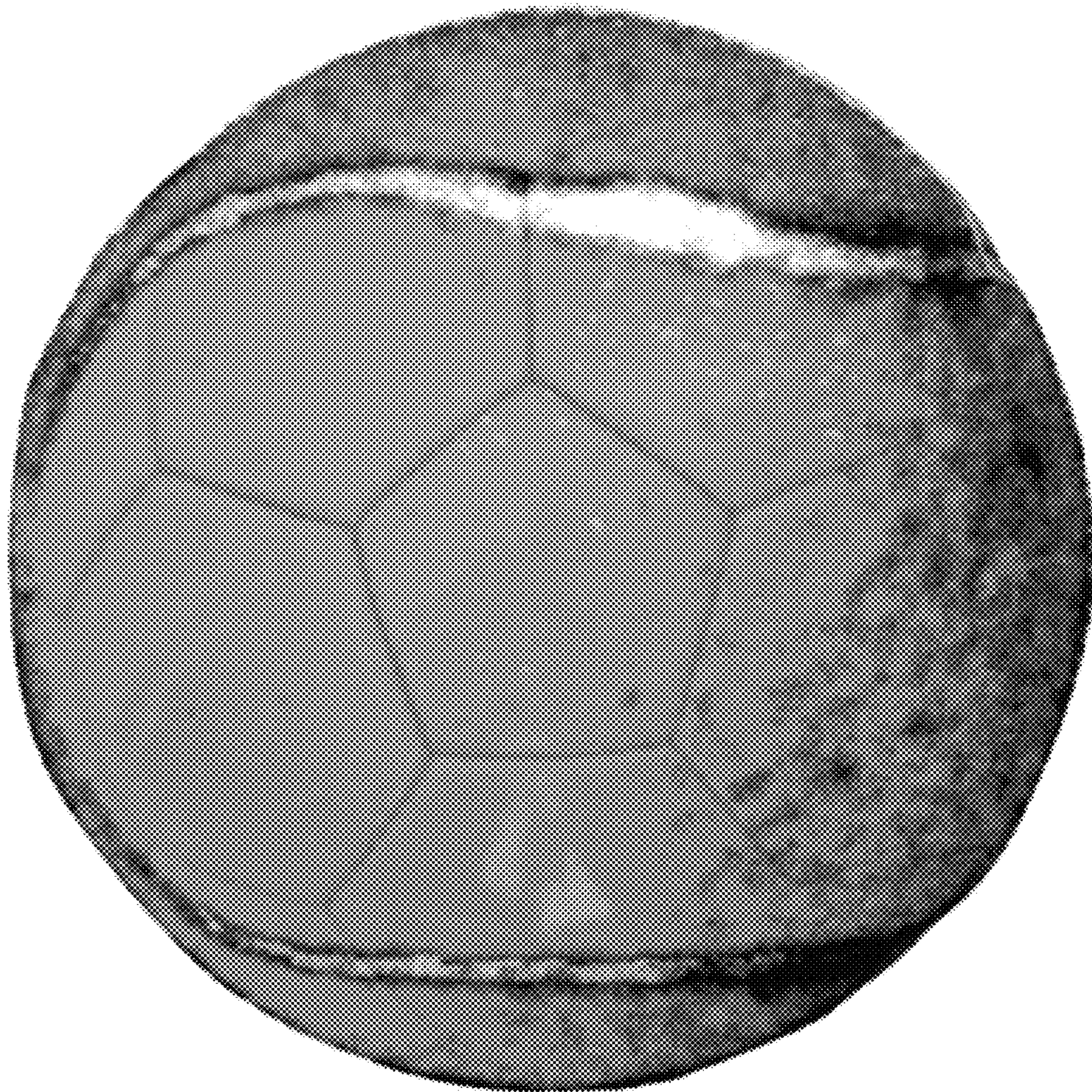
