DESCRIPTION

FIG. 1 is a top plan view of a helmet with hydration facility showing my new design;

FIG. 3 is a bottom view thereof;

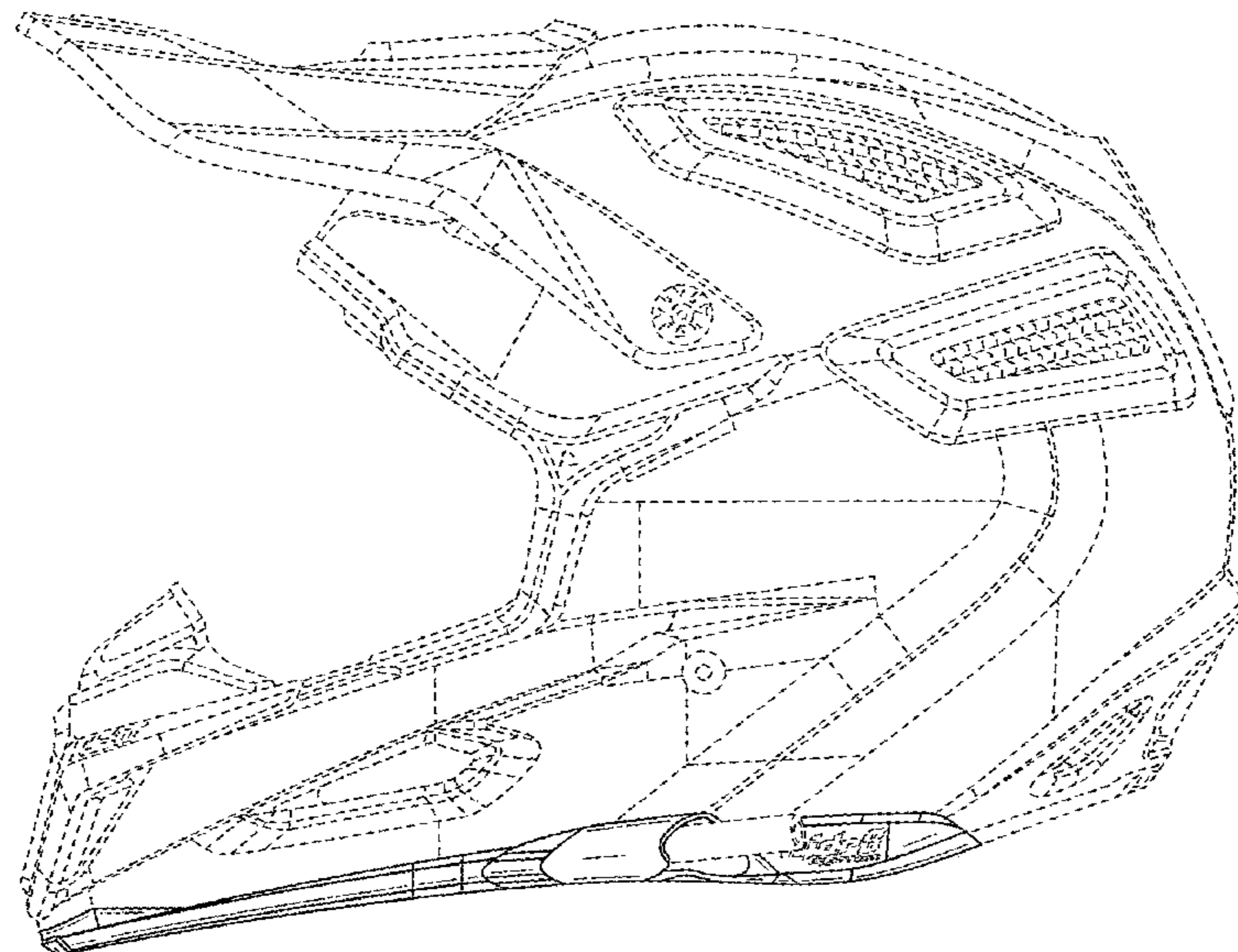
FIG. 4 is a front elevation view thereof; and,

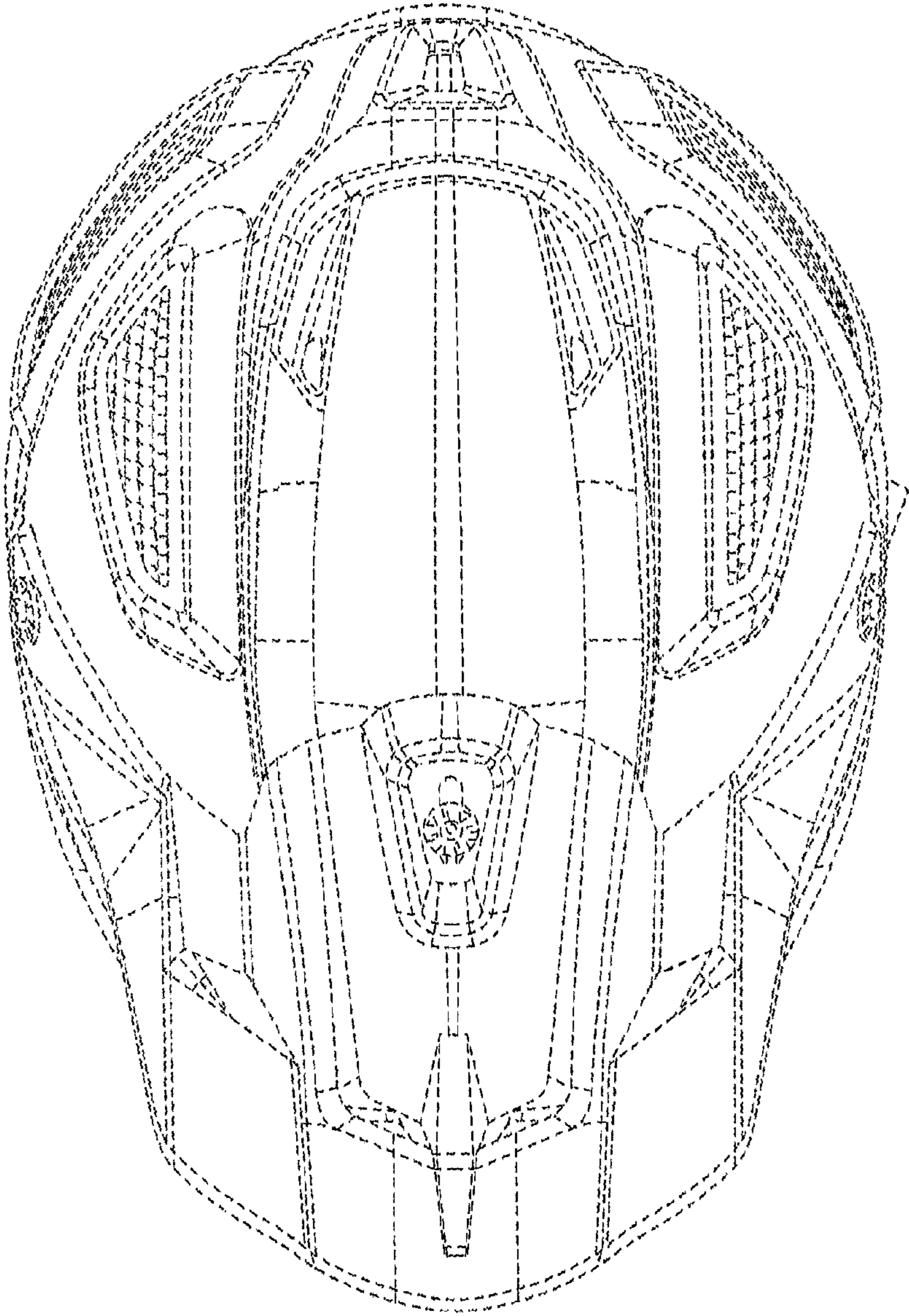

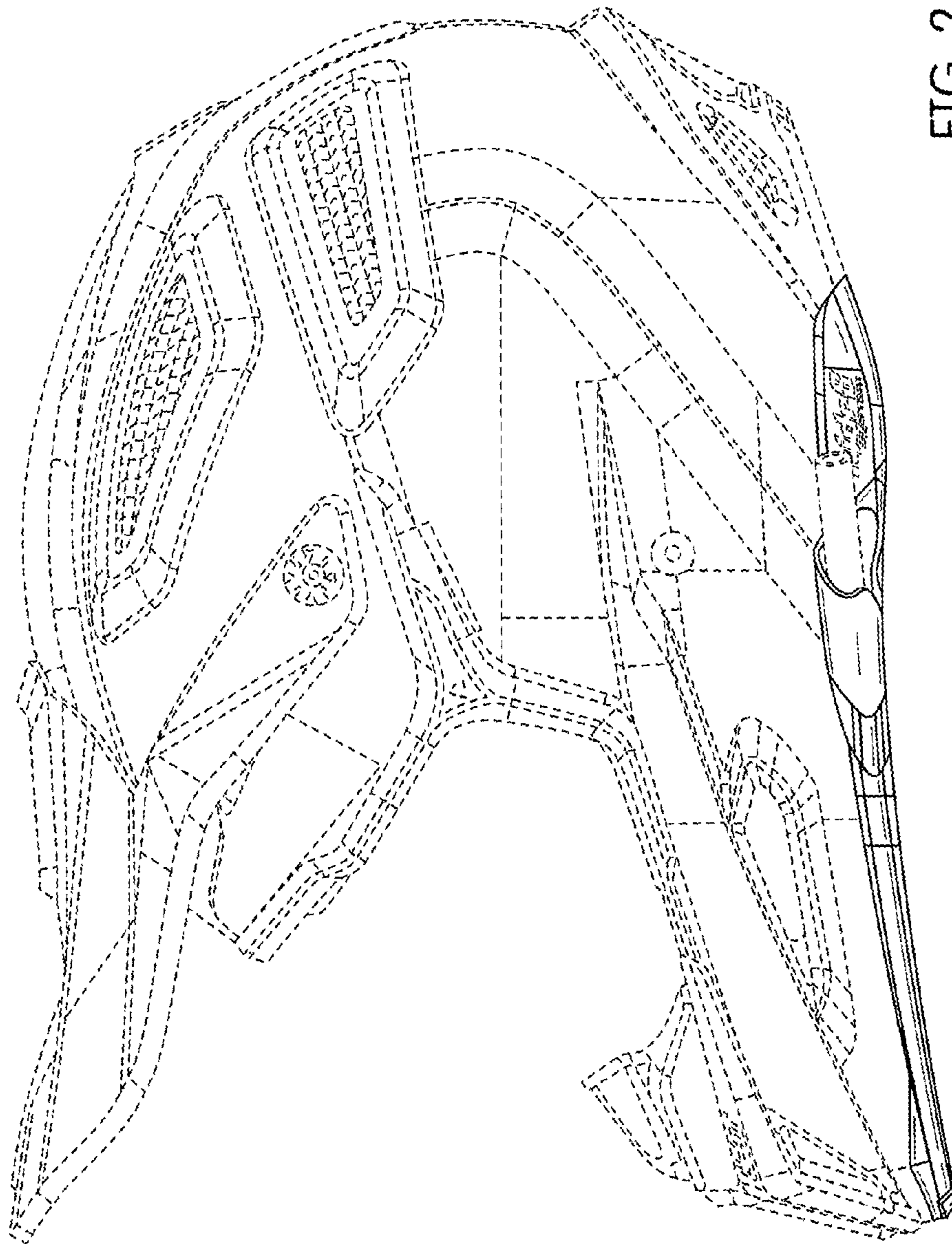

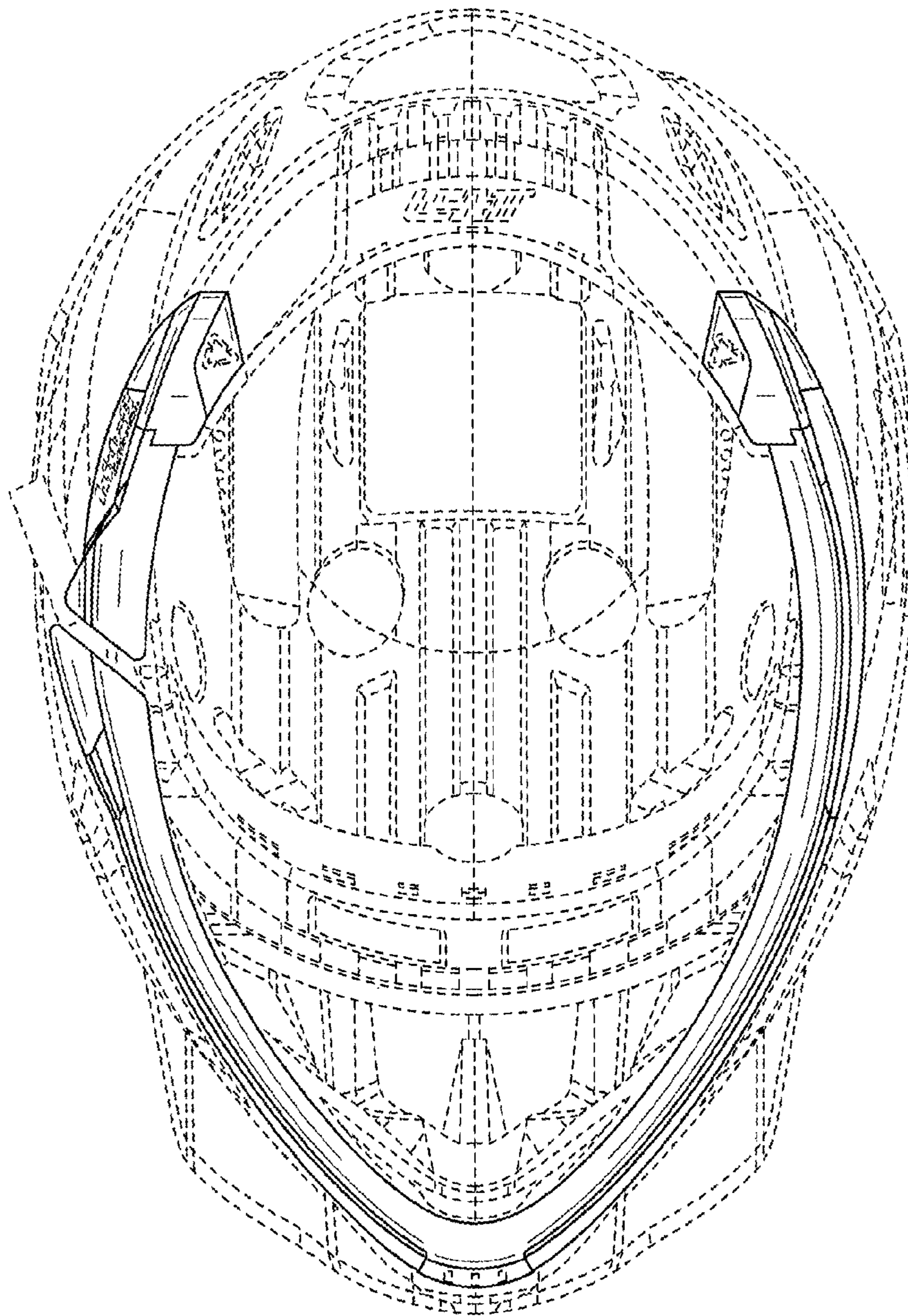

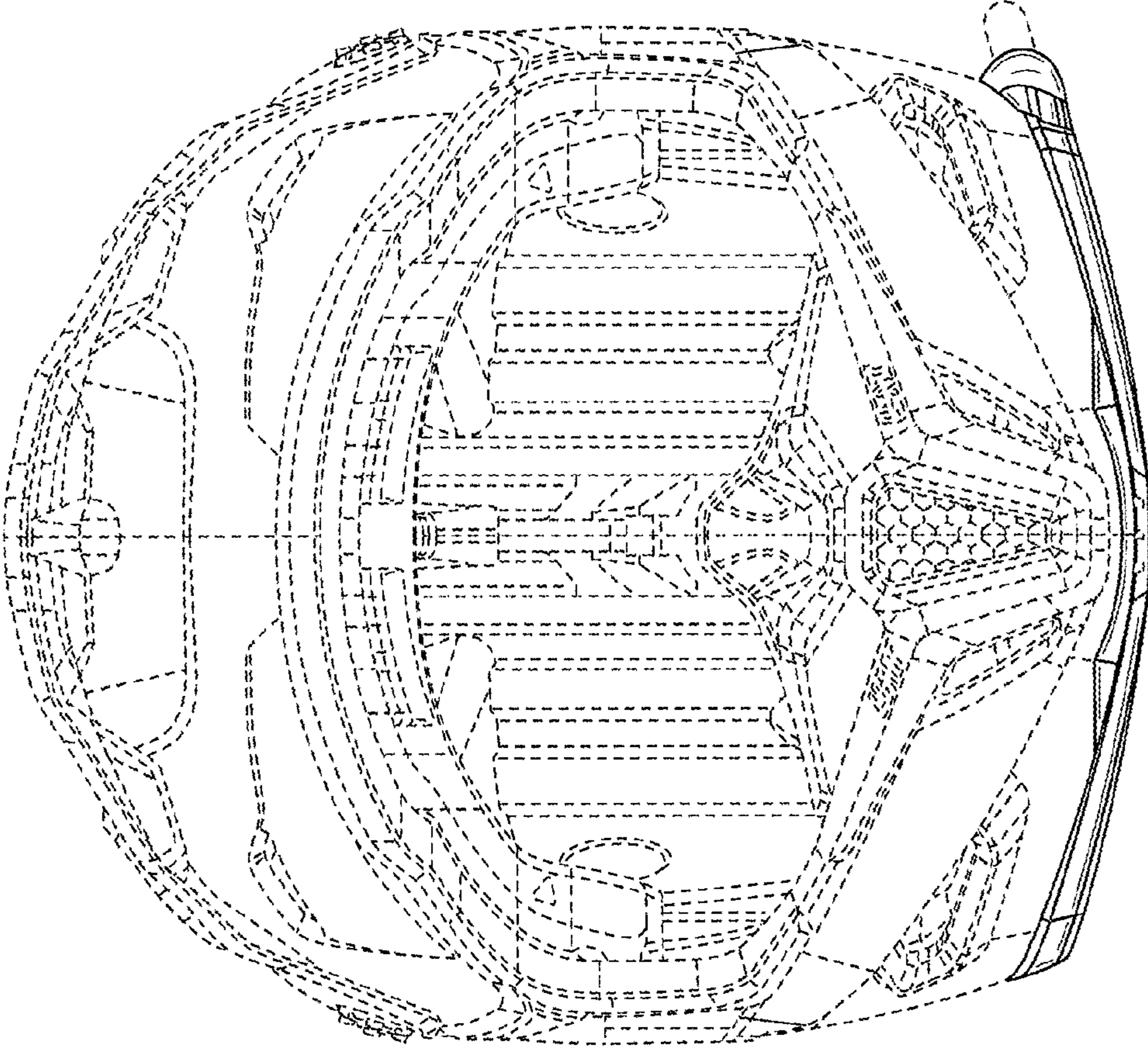

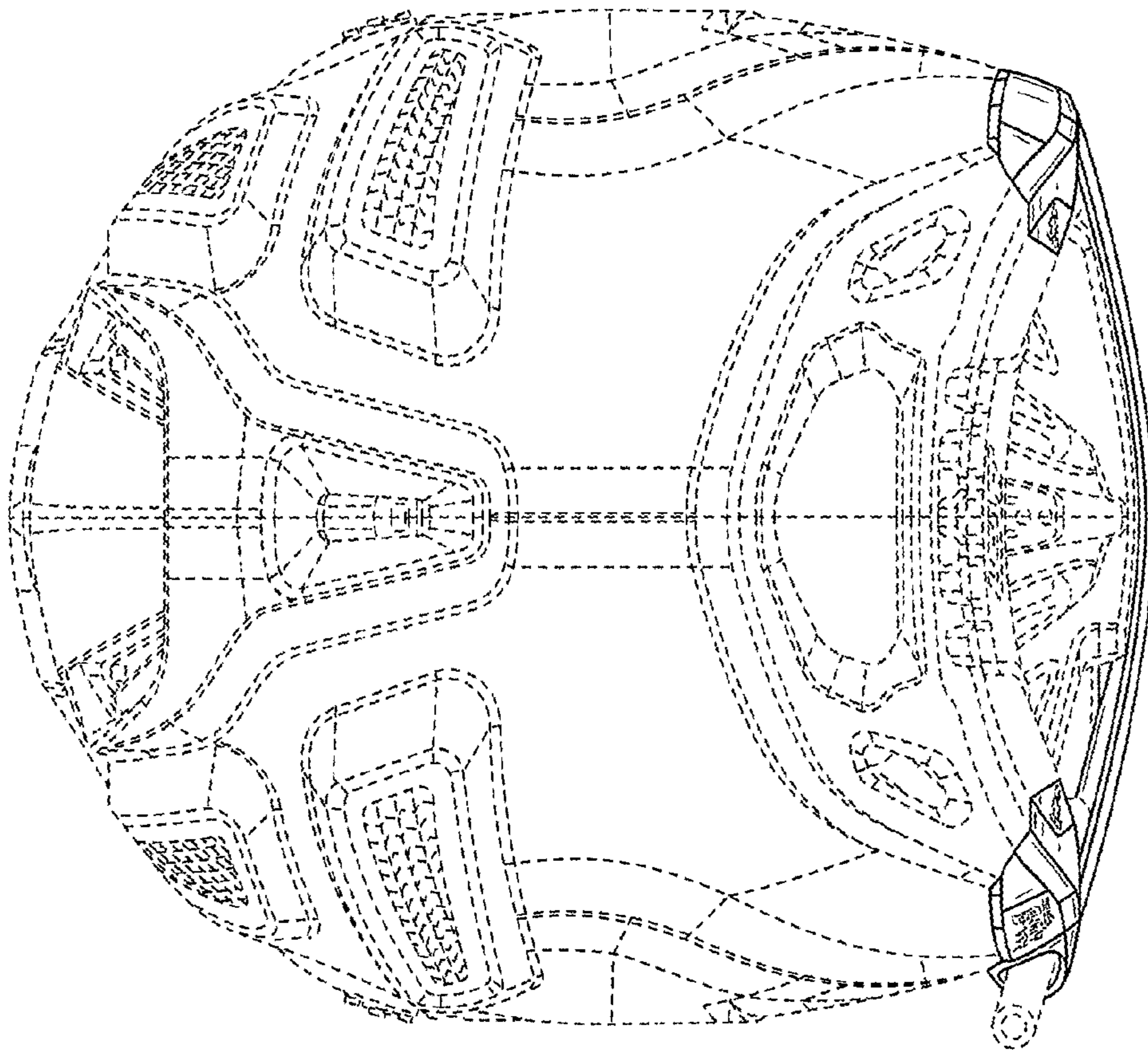
