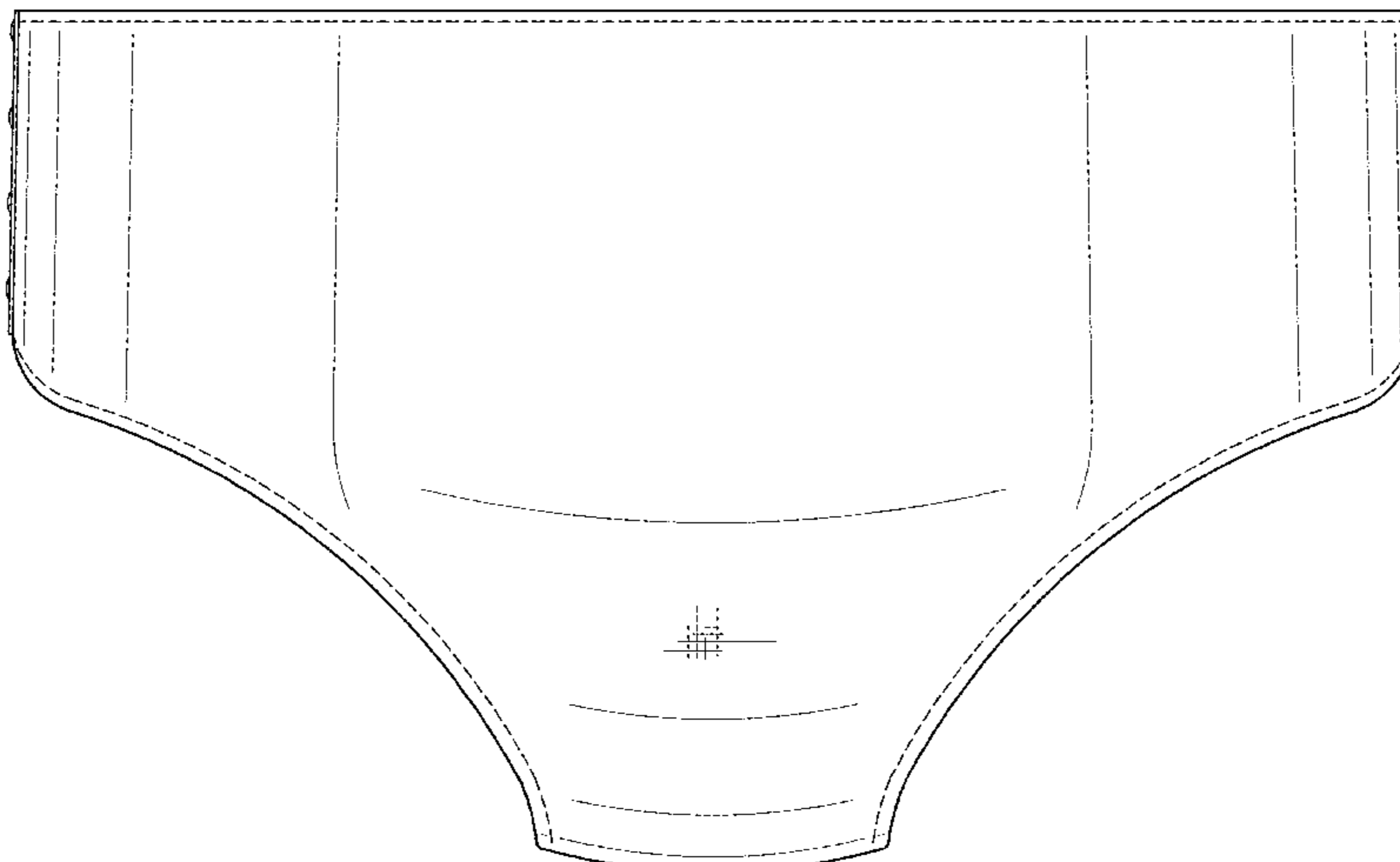
(57) **CLAIM**

The ornamental design for a side opening female underpant, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a side opening female underpant showing my new design;
FIG. 2 is a rear view thereof;
FIG. 3 is a left side view thereof, a right side view being a mirror image thereto;
FIG. 4 is a top view thereof; and,
FIG. 5 is a bottom view thereof.
In the drawings, the broken lines represent stitching.

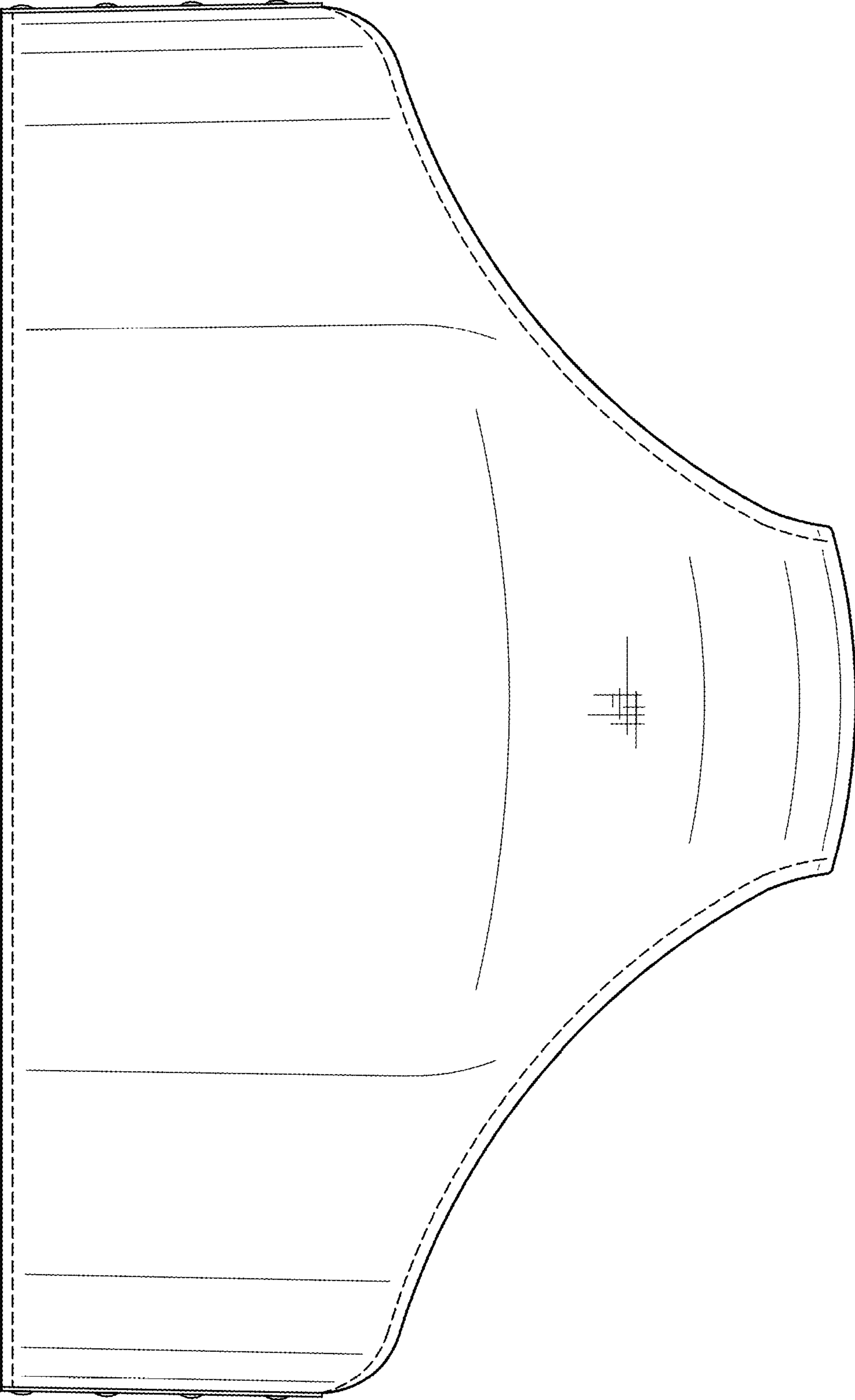

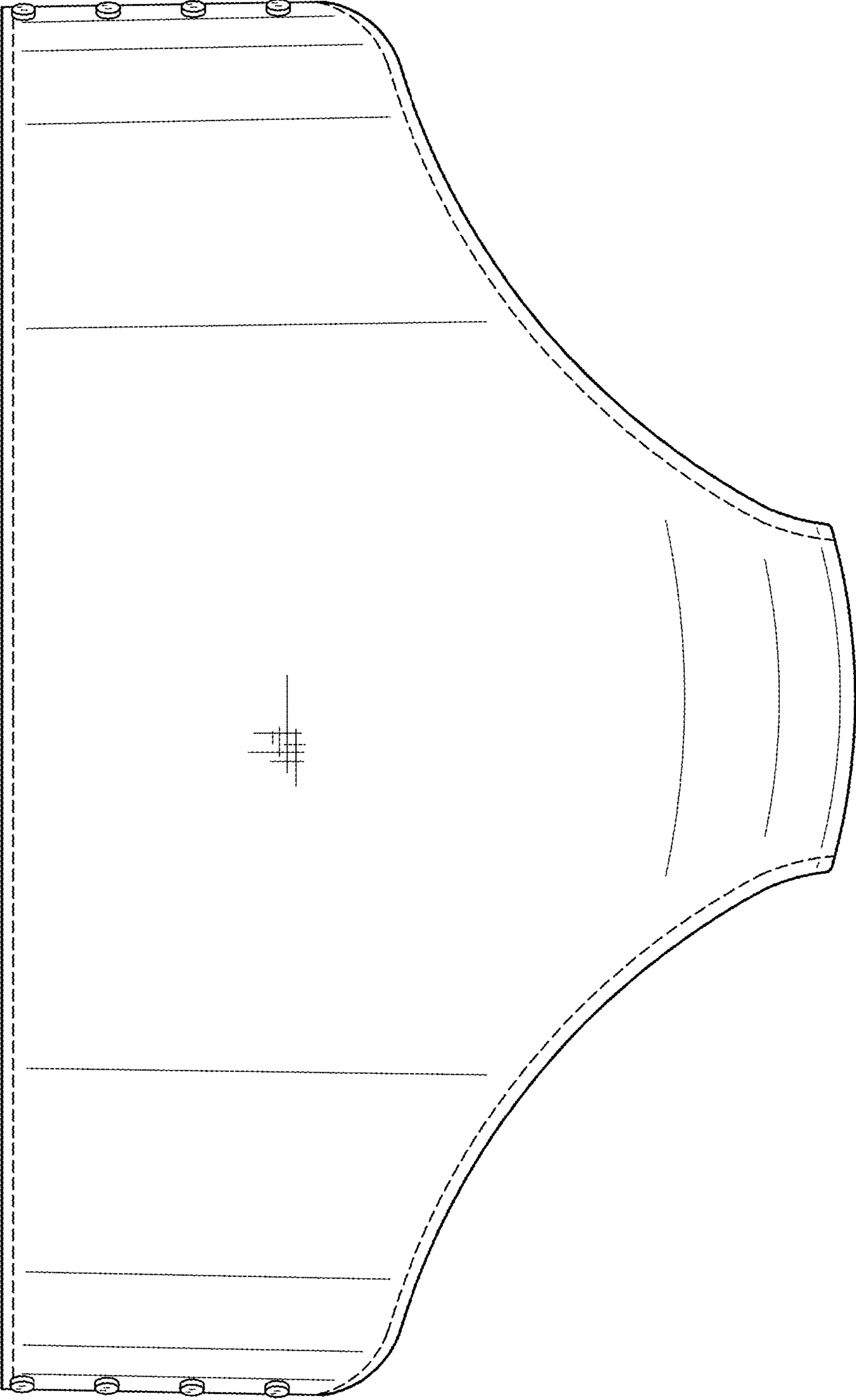

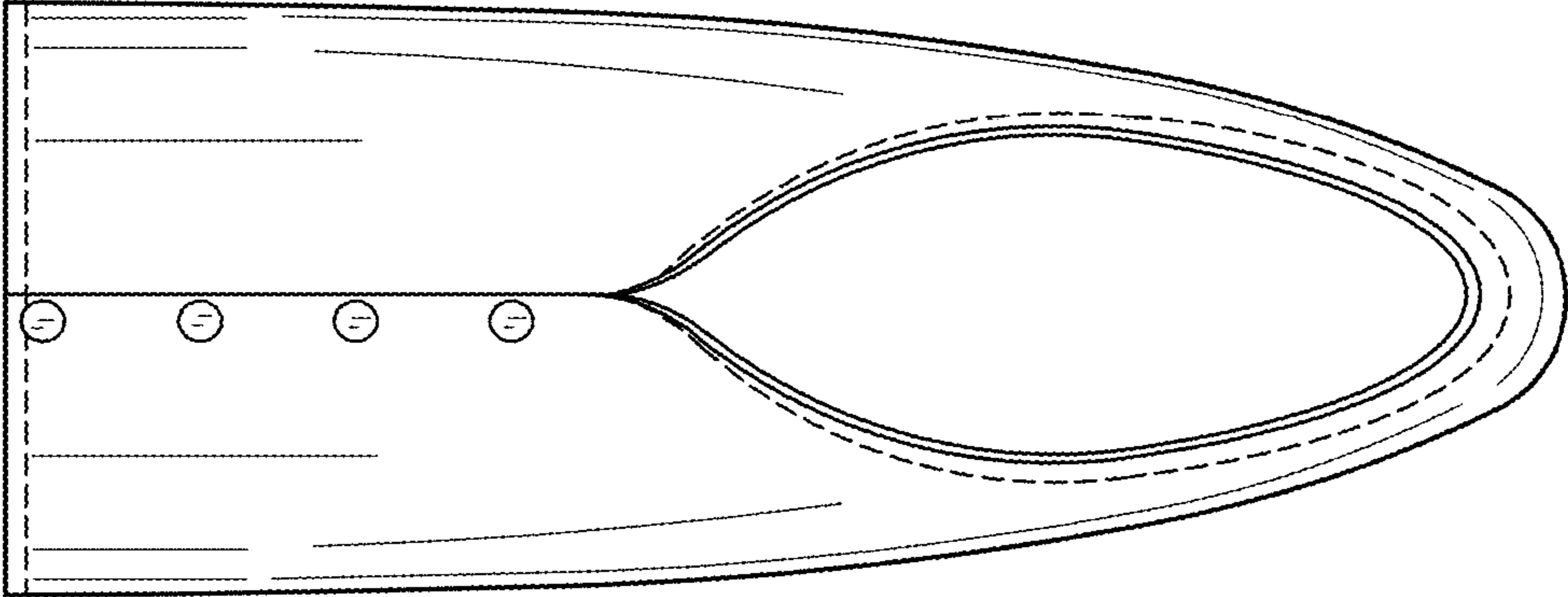

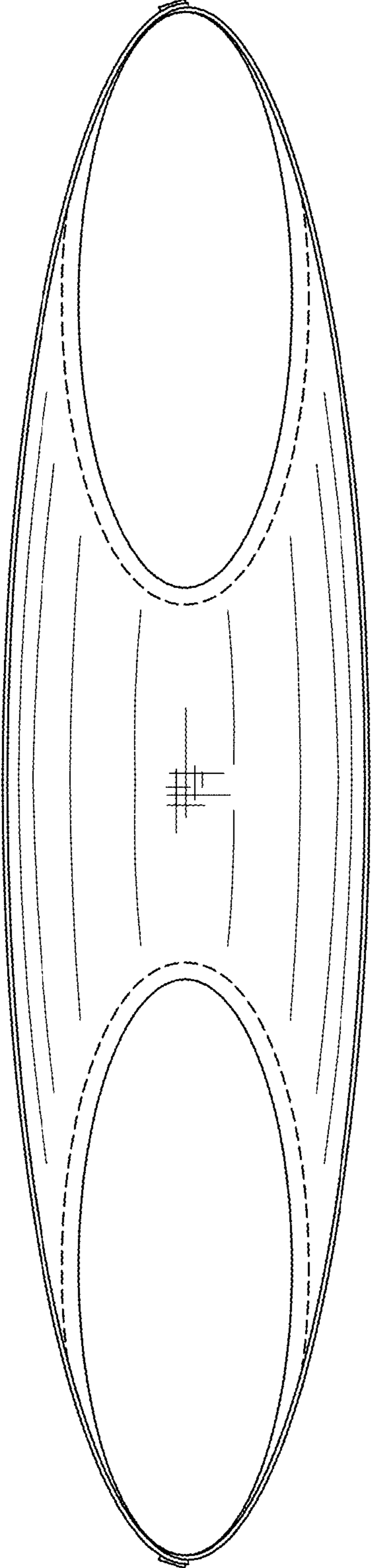

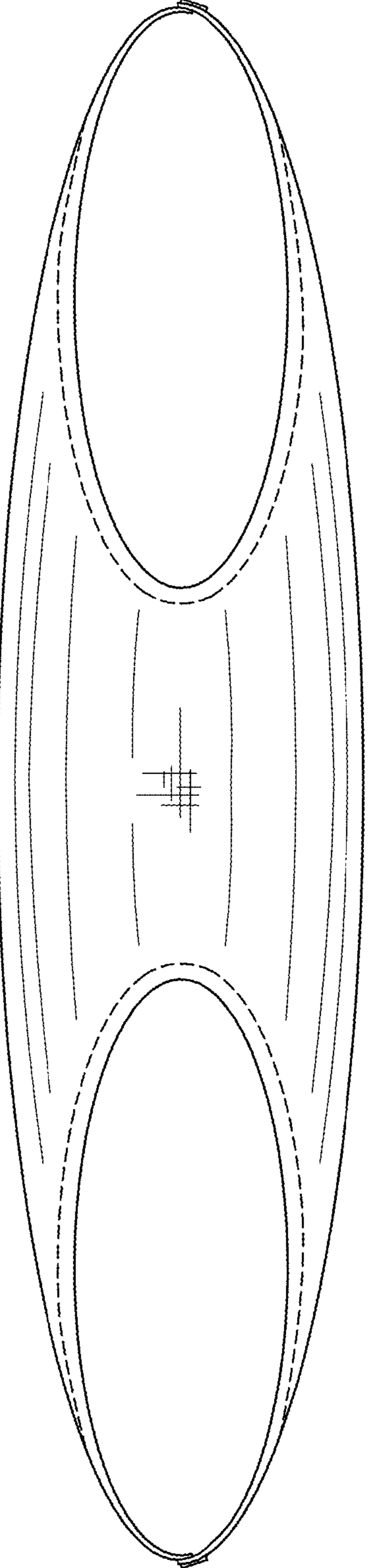
