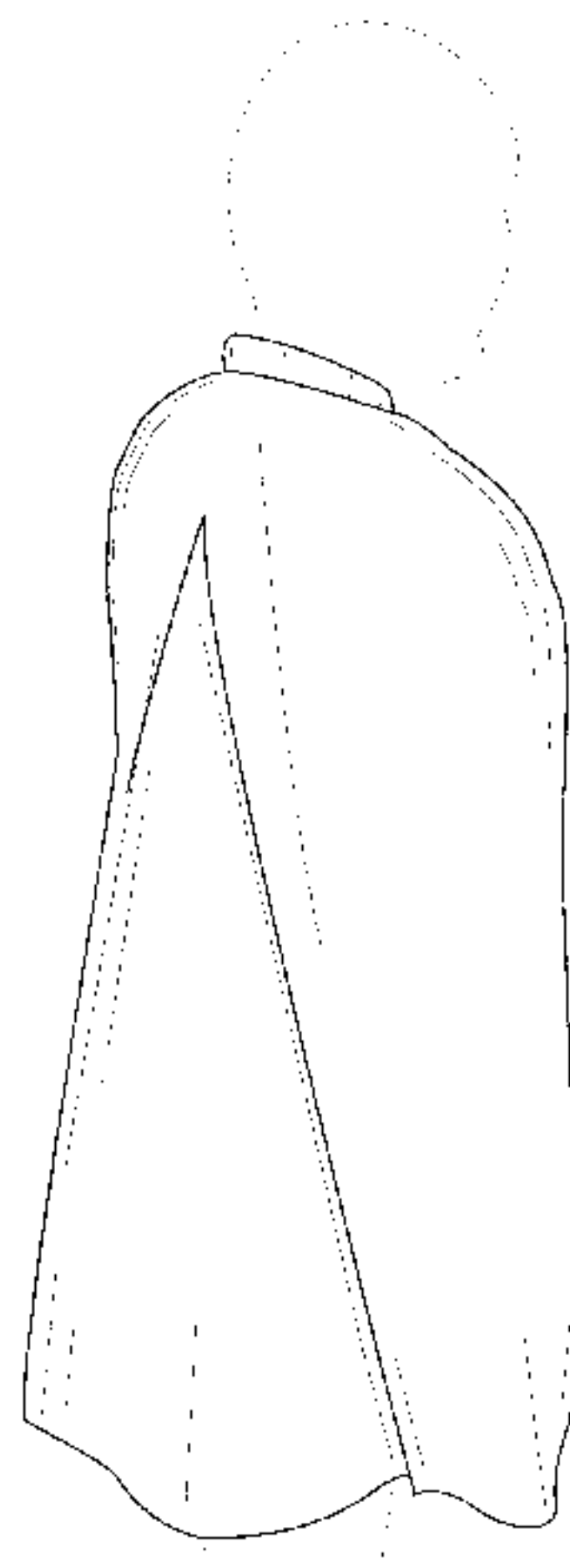

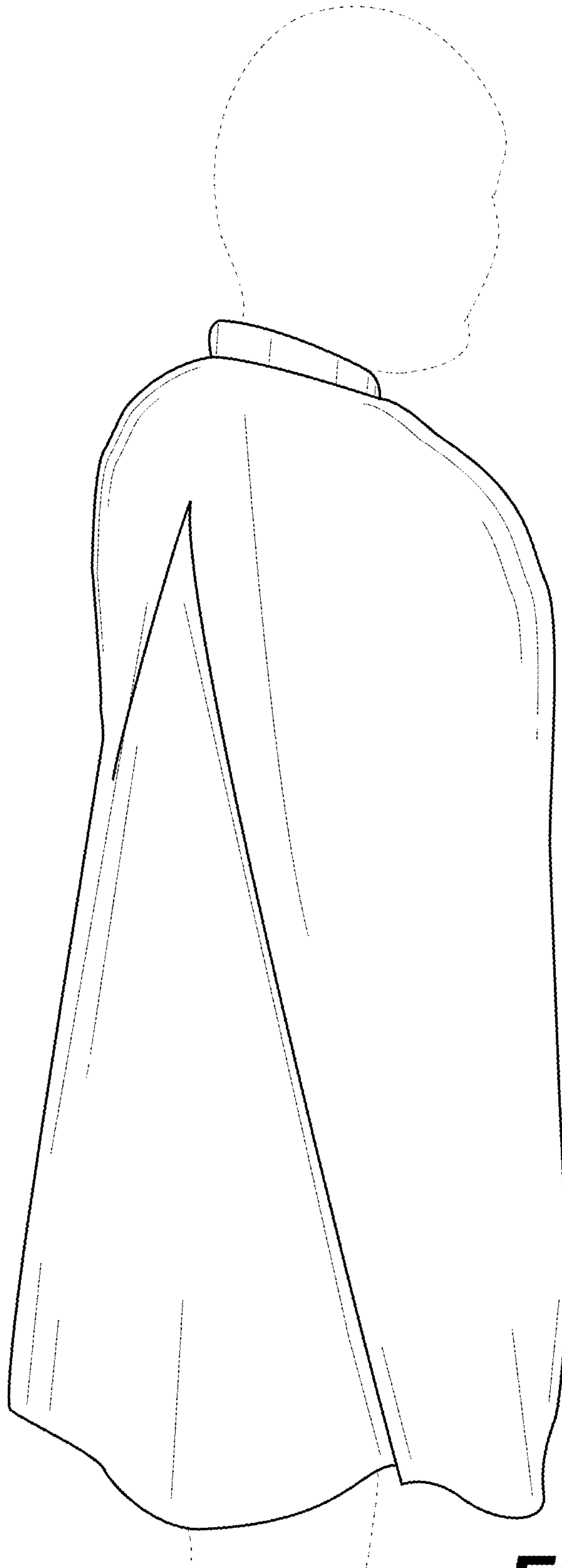
The ornamental design for a play cape with low collar, as shown and described.

**DESCRIPTION**

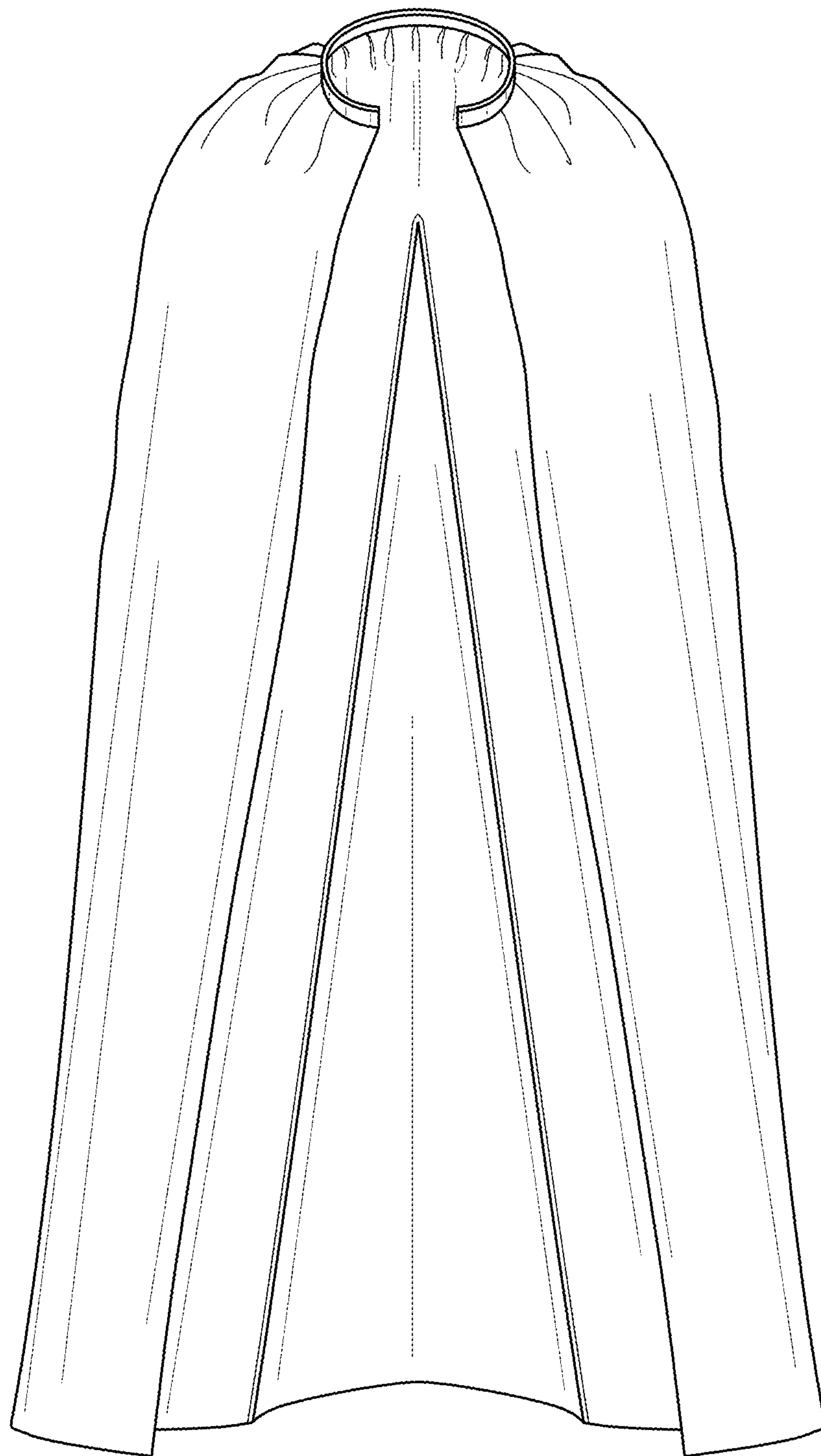
FIG. 1 is a perspective view of a play cape with low collar showing my new design in a worn state;

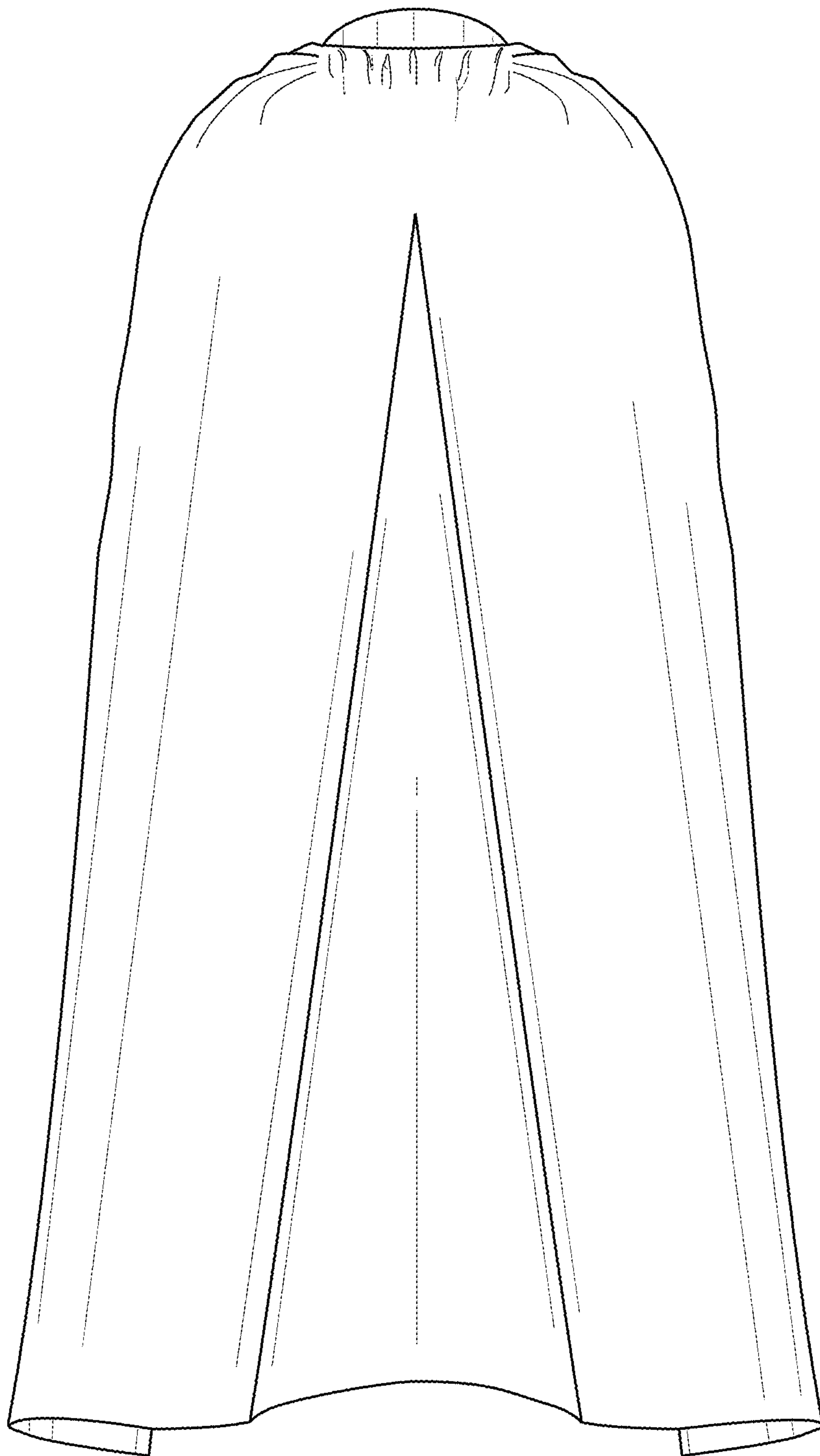




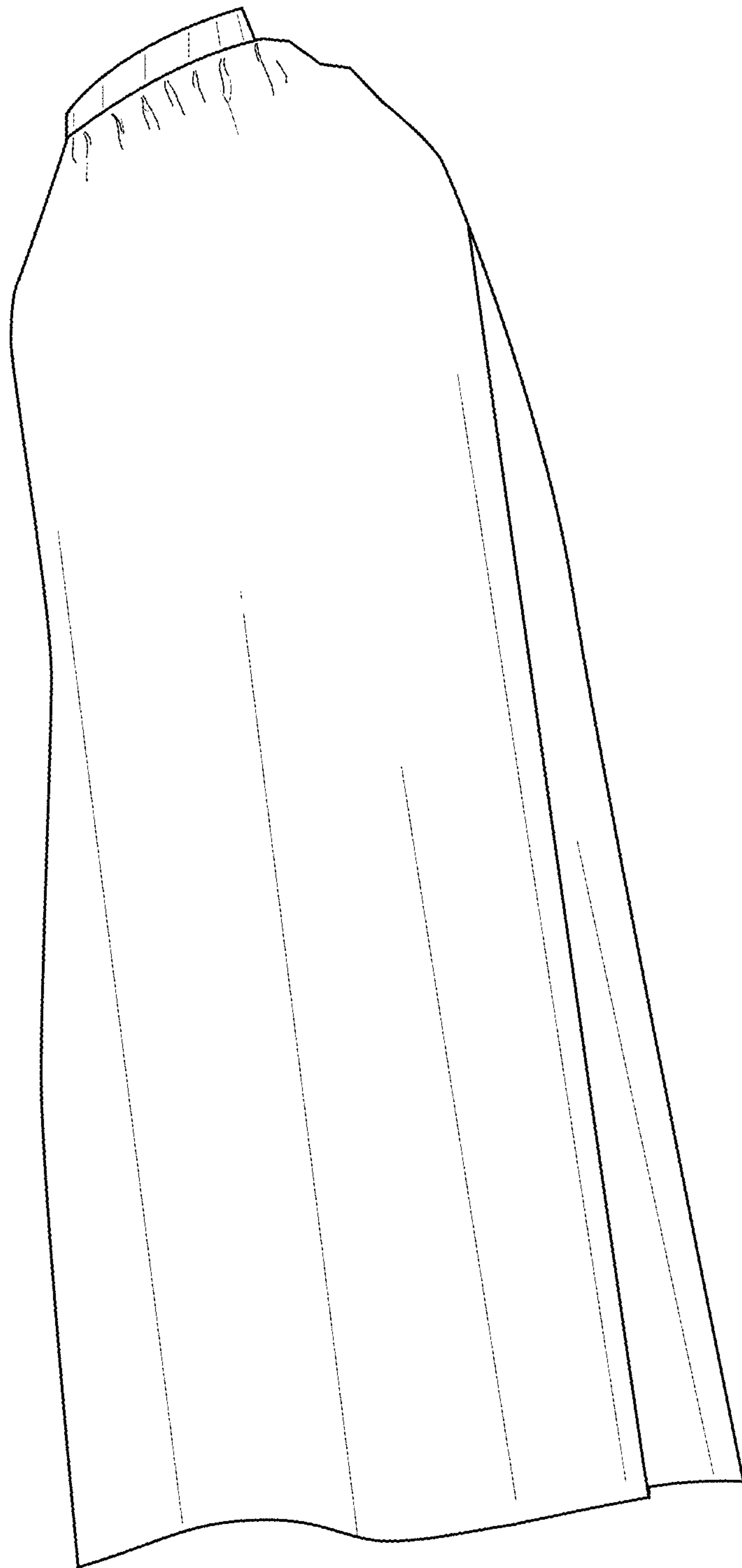

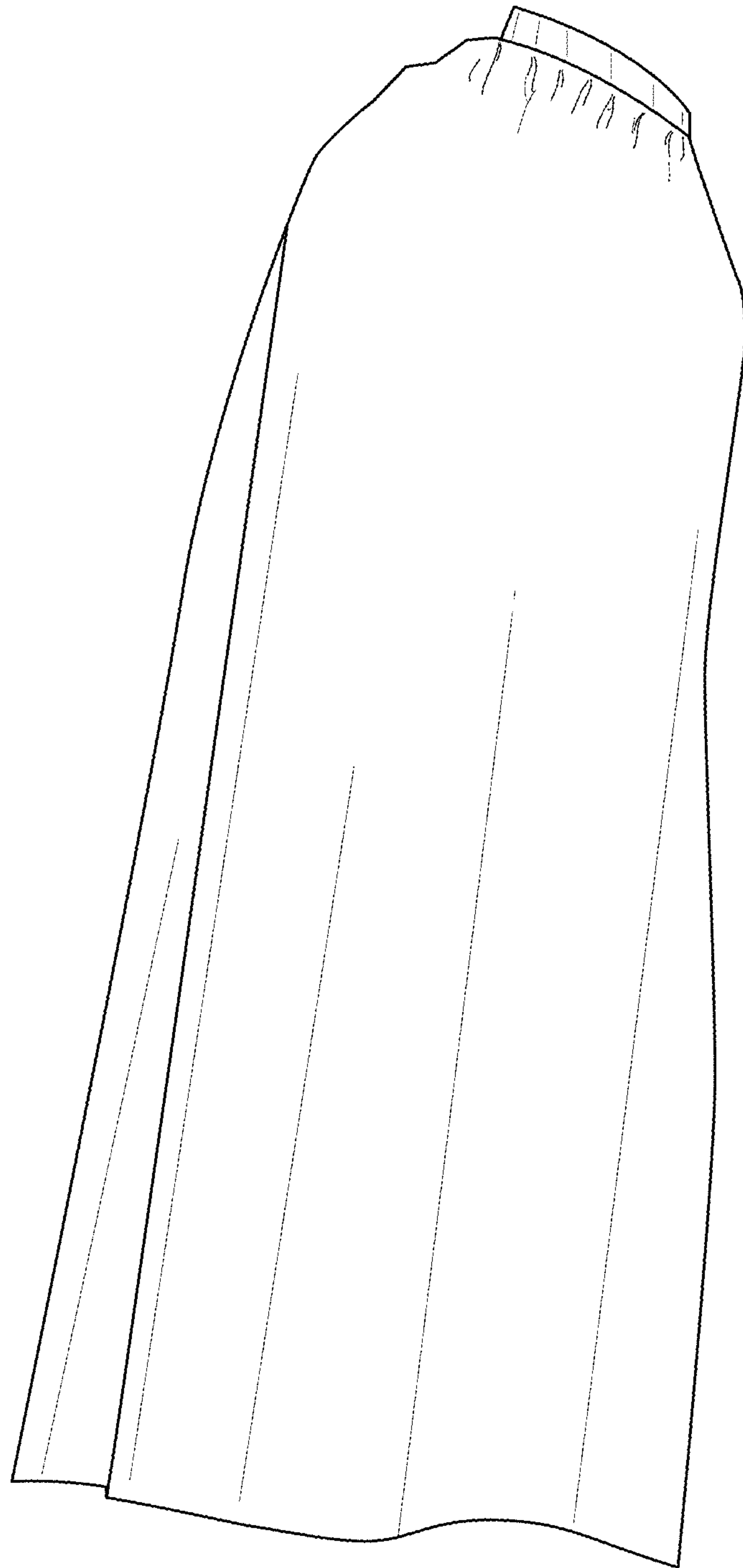

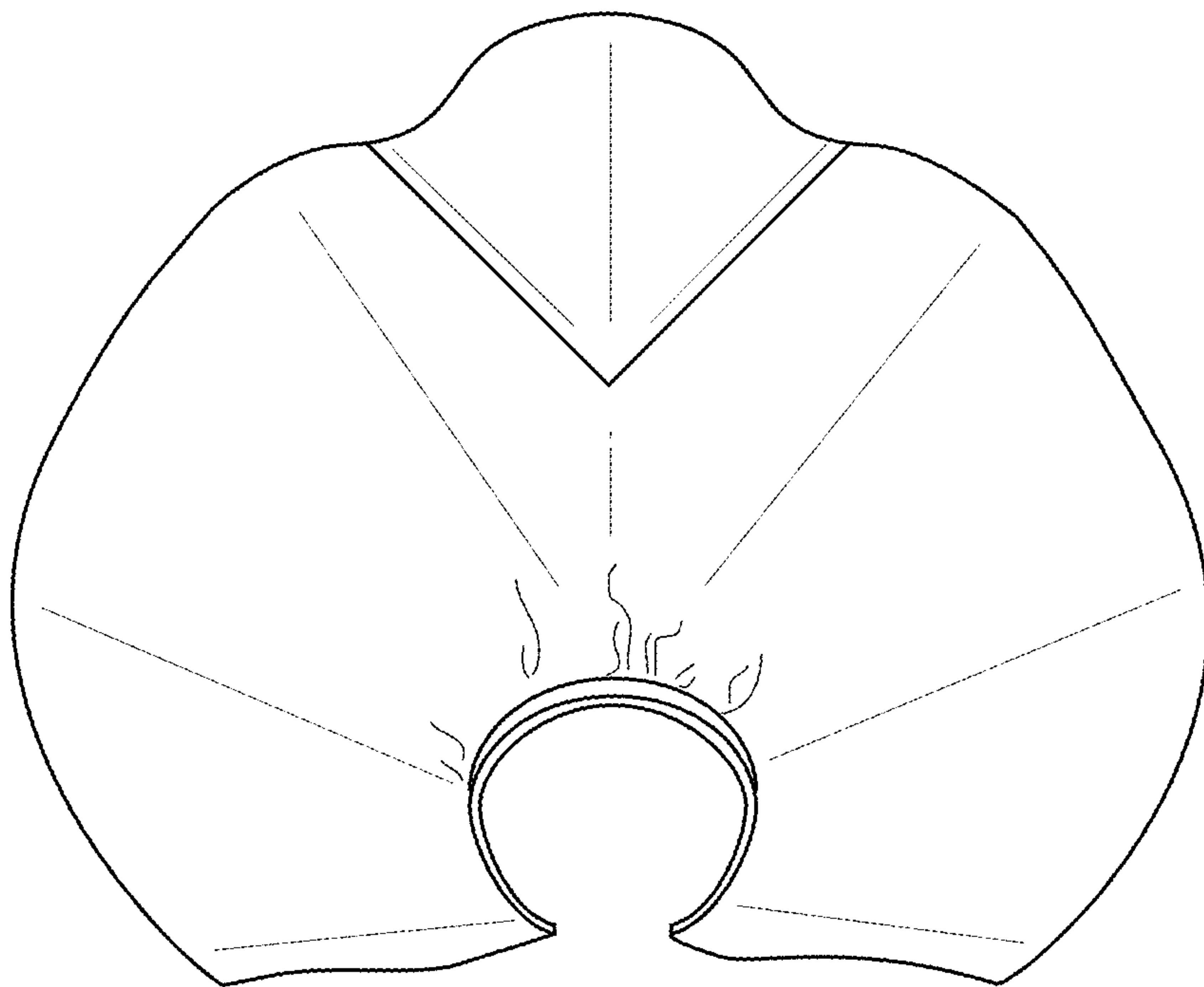

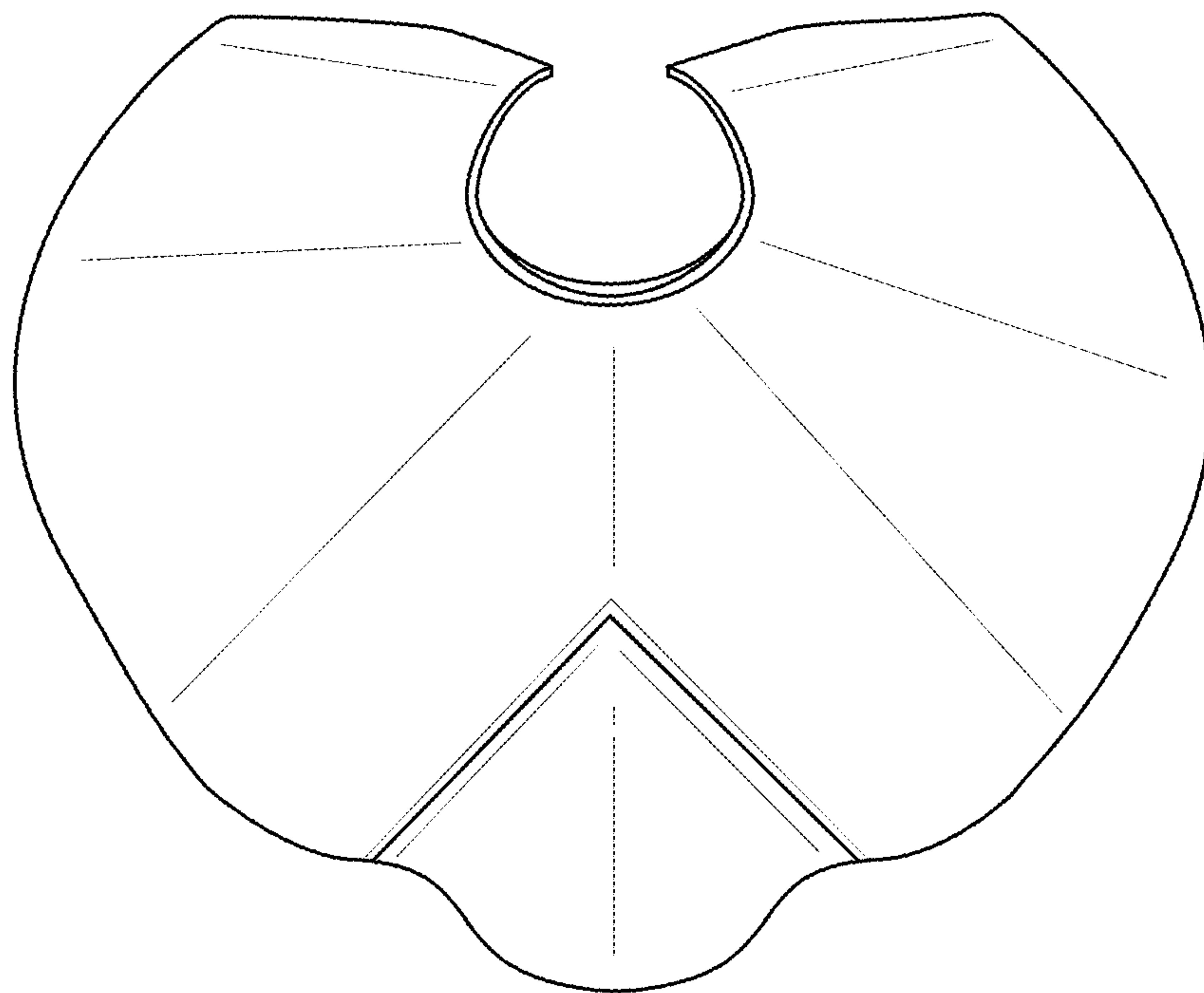
