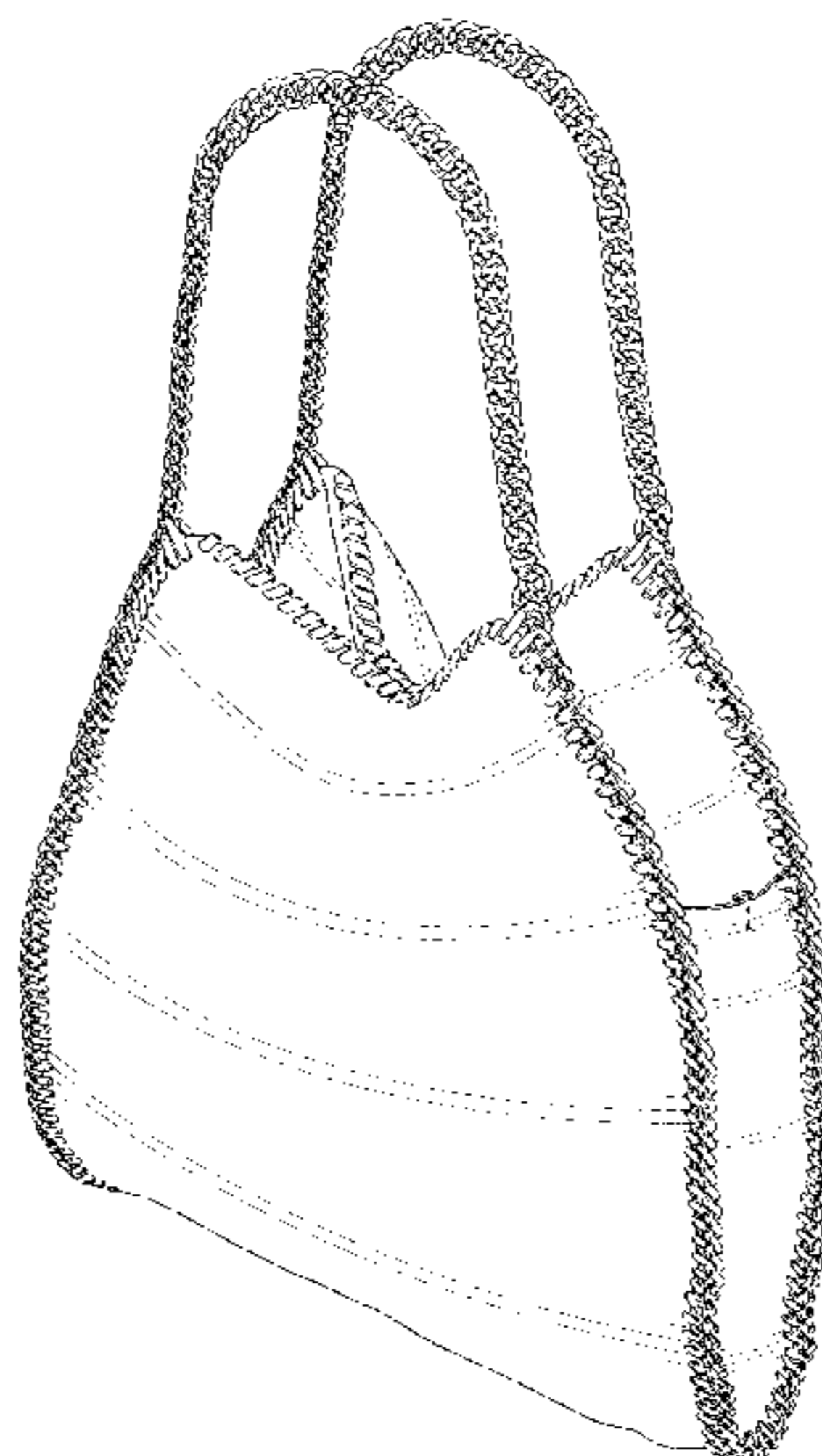
FIG. 5 is a left side view of the chain trim detail for handbags shown in FIG. 1;

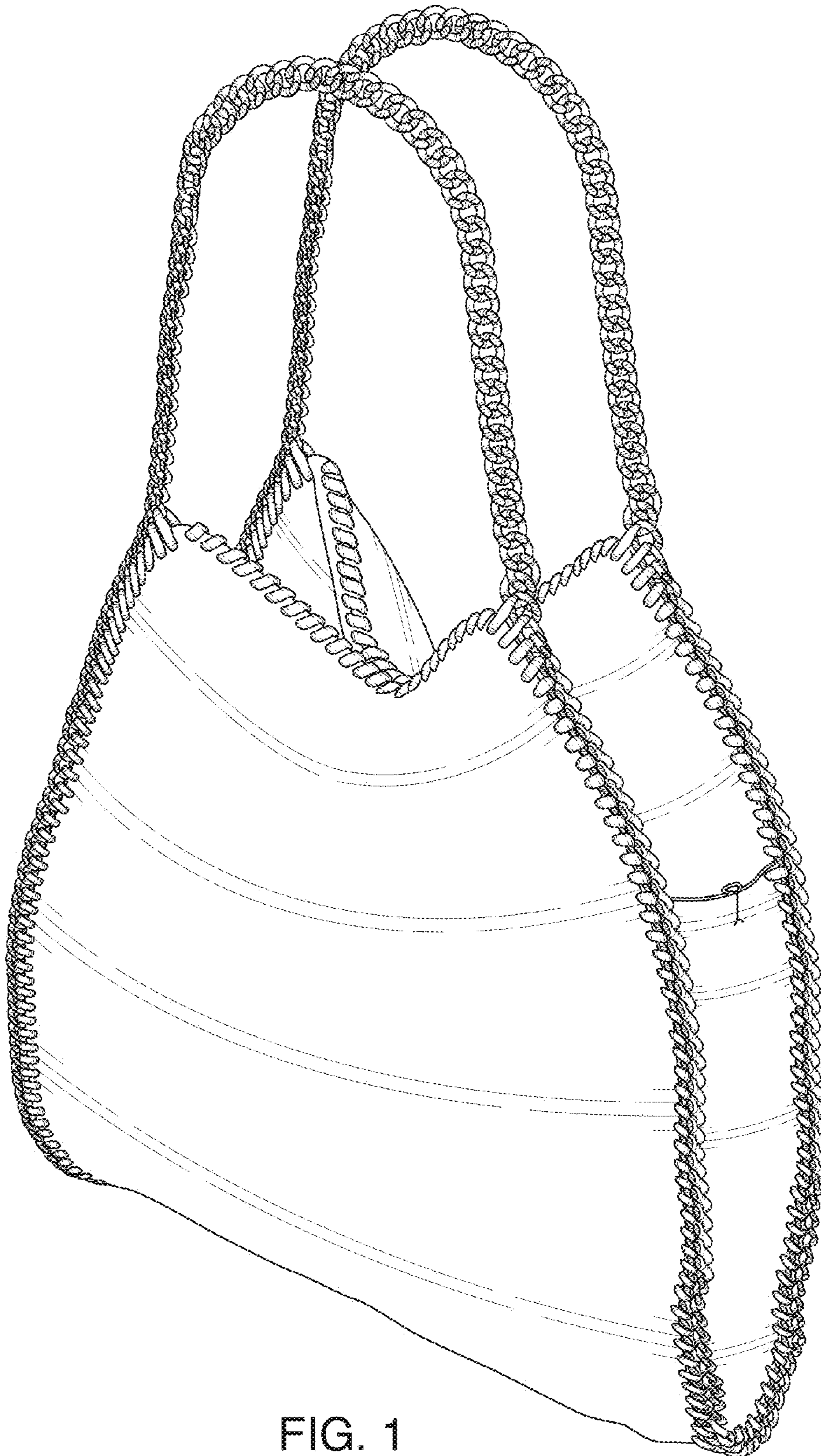

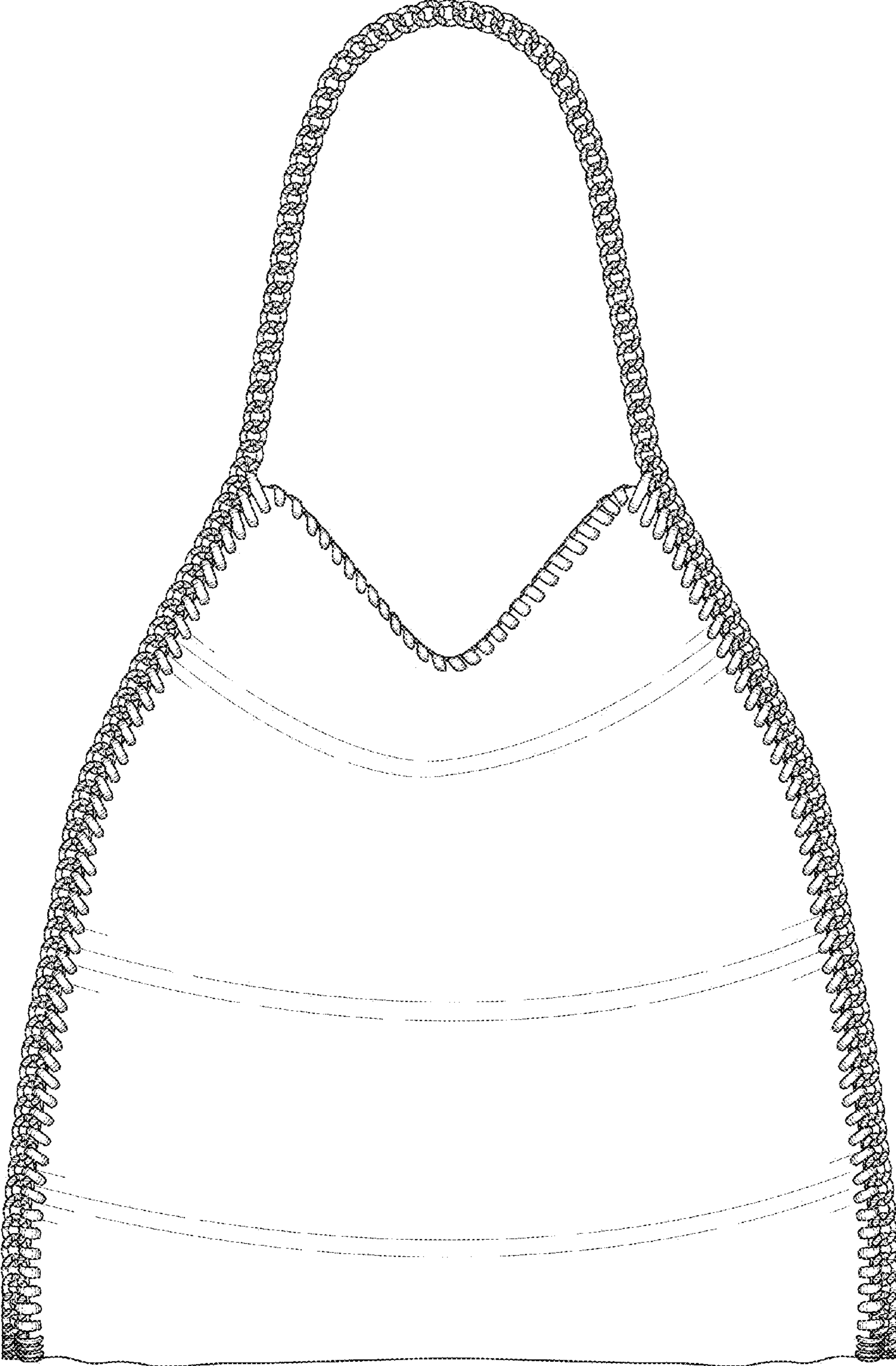

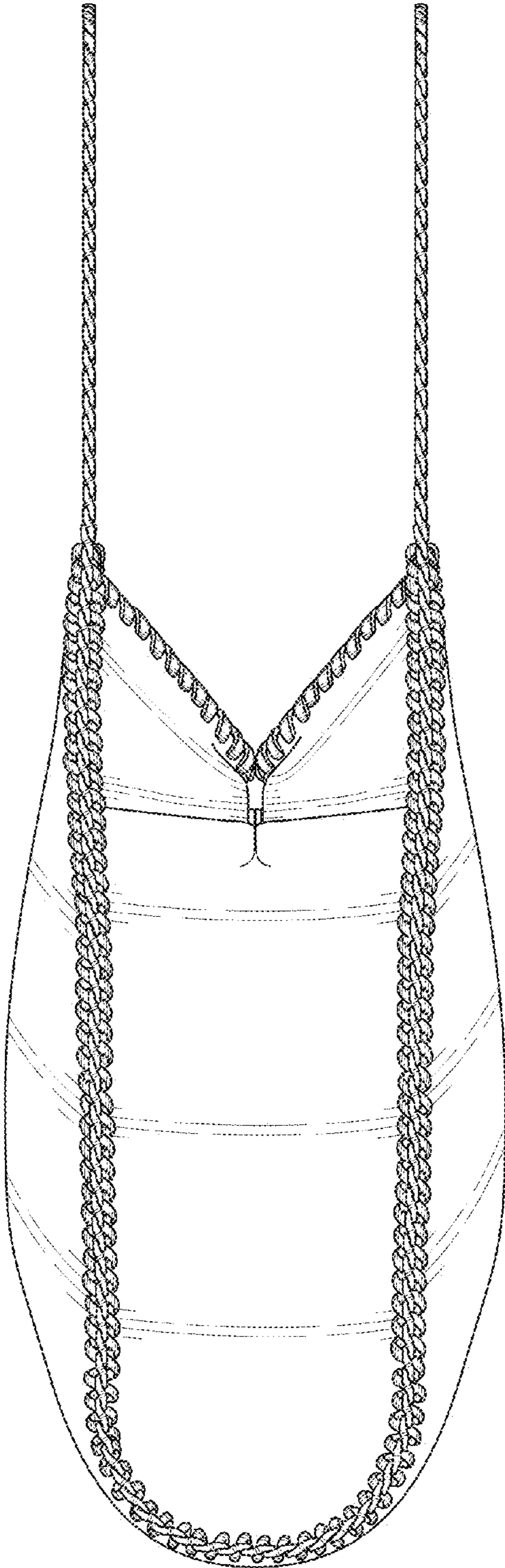

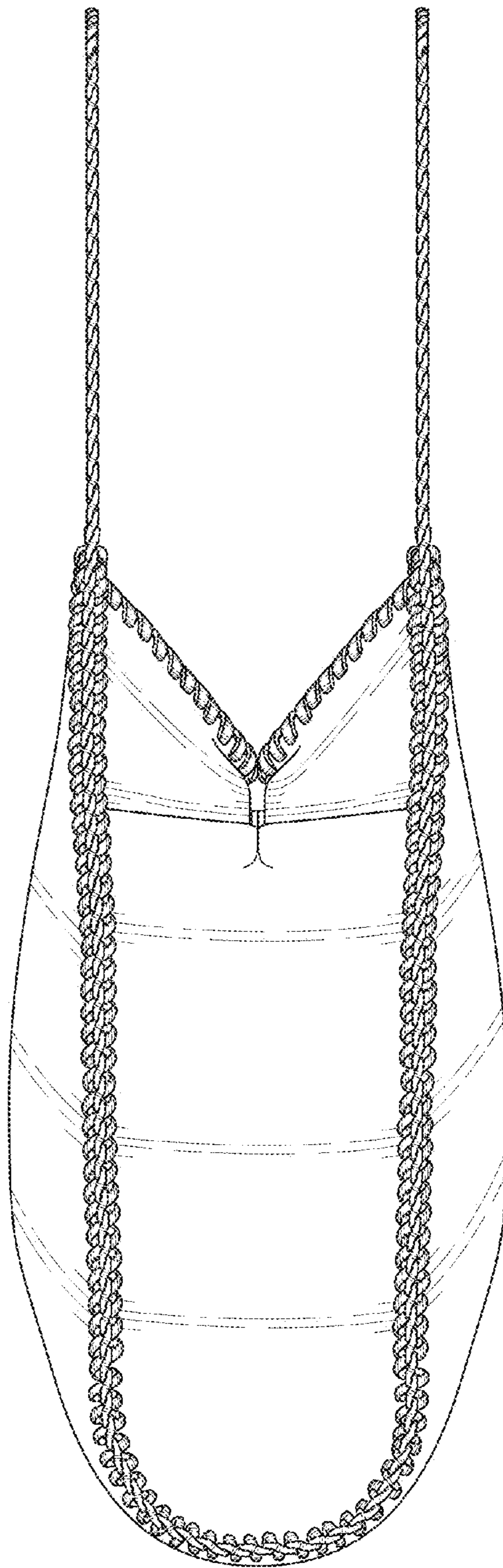

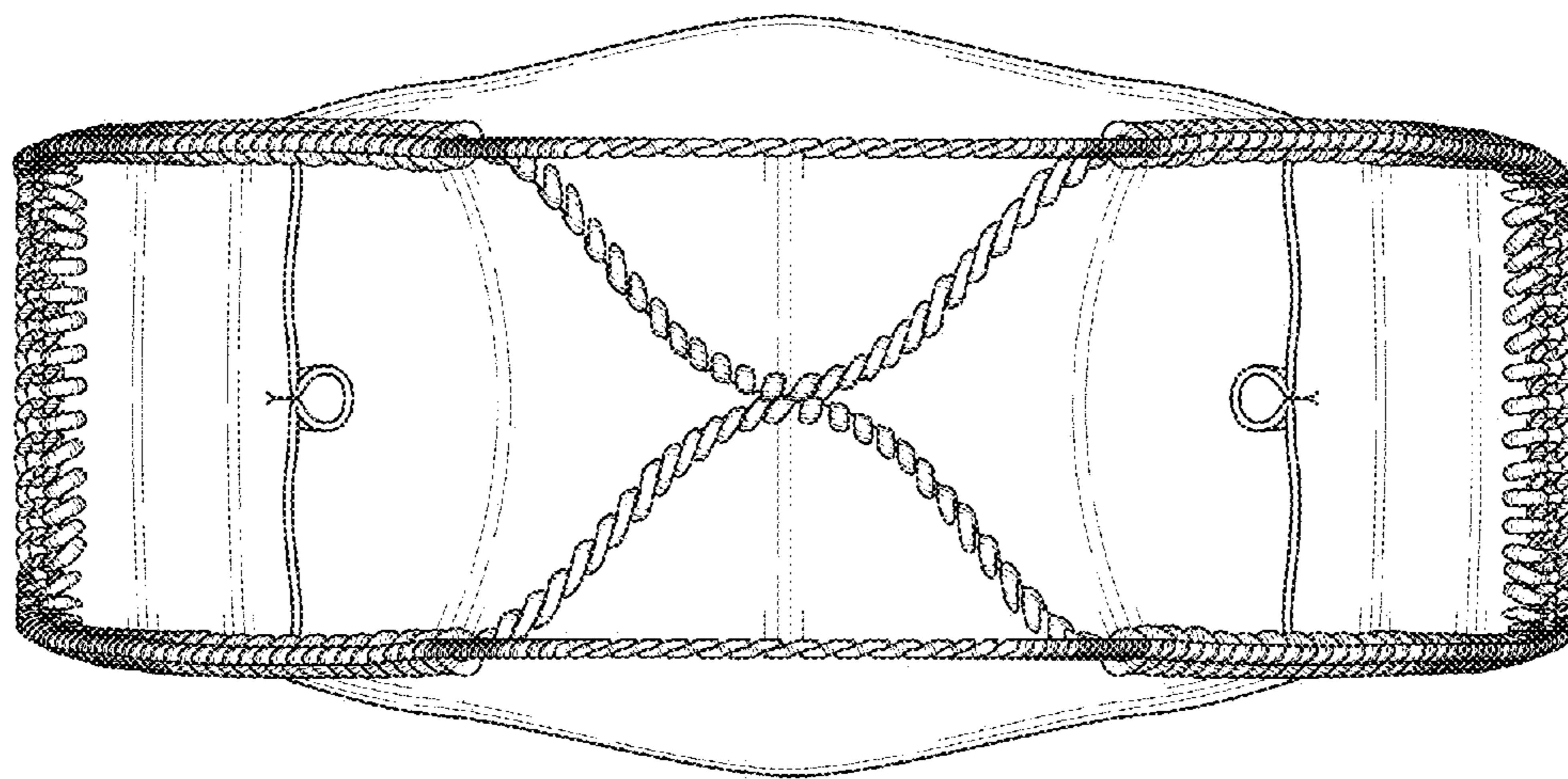

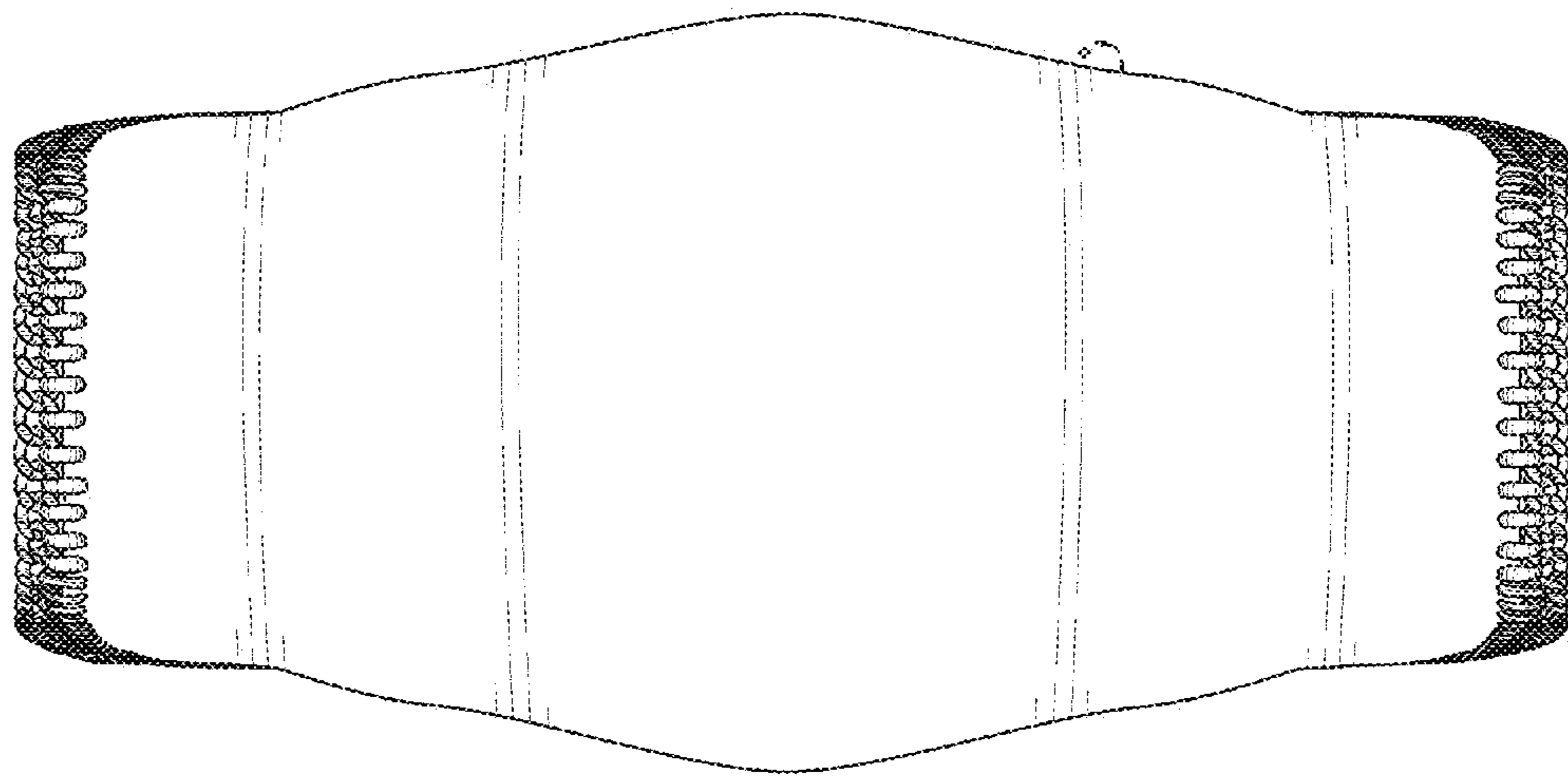
