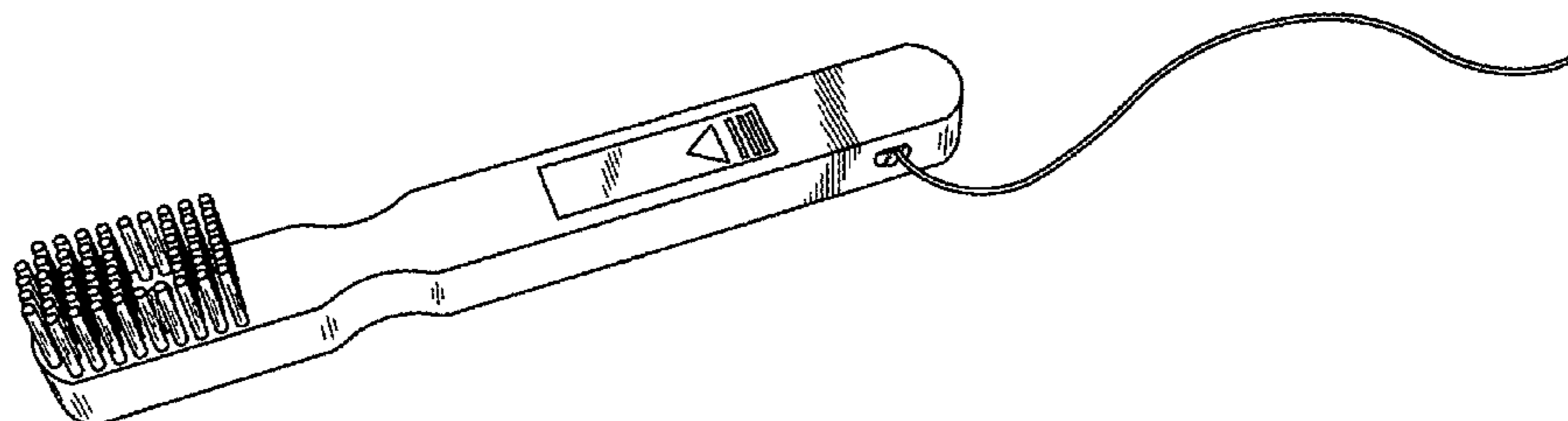
(57) **CLAIM**

The ornamental design for an all in one toothbrush, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an all in one toothbrush of our new design, shown with dental floss extended from the toothbrush;
 FIG. 2 is a front elevation view, shown without the dental floss extended;
 FIG. 3 is a rear elevation view thereof;
 FIG. 4 is a top plan view thereof;
 FIG. 5 is a bottom plan view thereof;
 FIG. 6 is a left elevation view thereof; and,
 FIG. 7 is a right elevation view thereof.

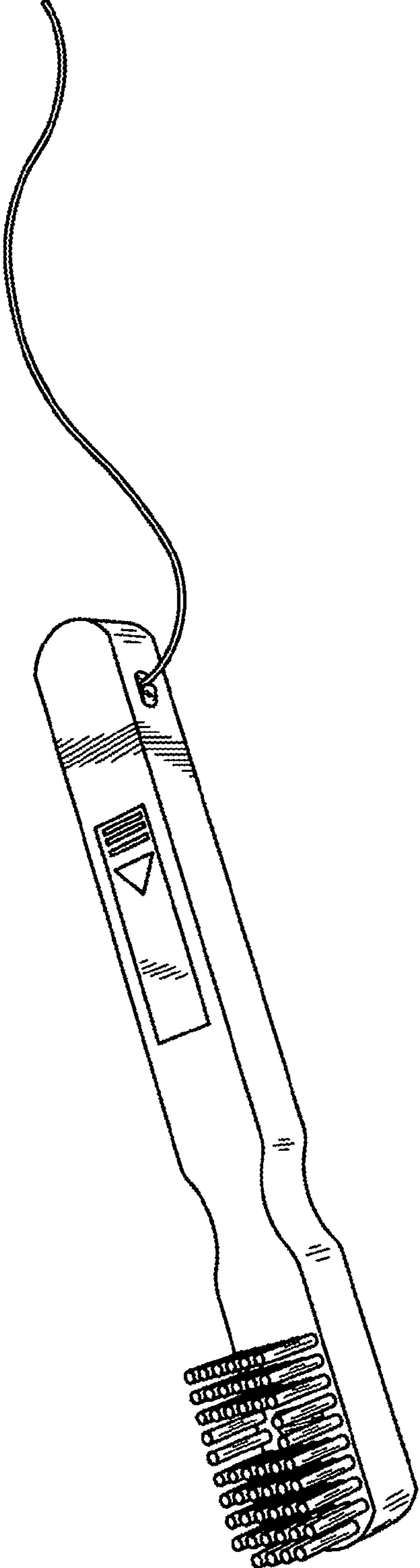

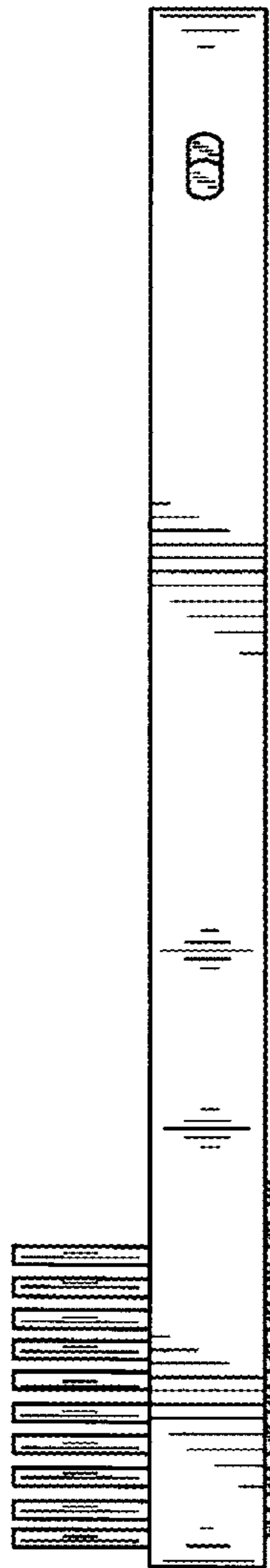

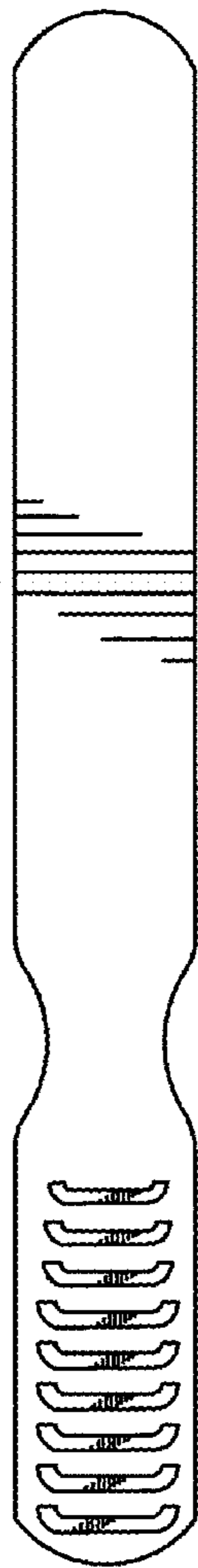

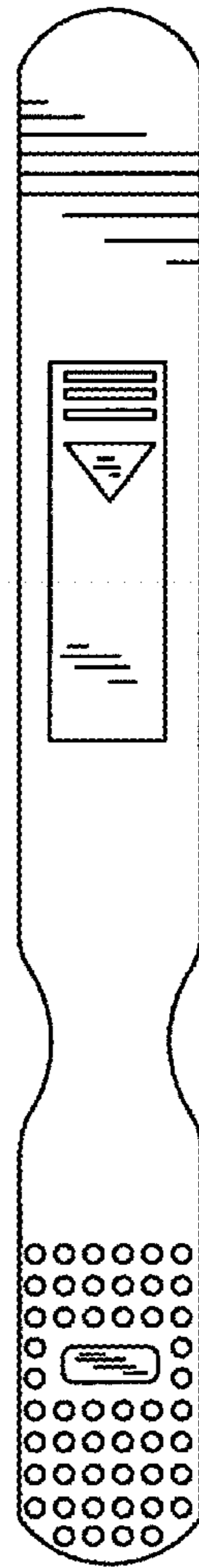

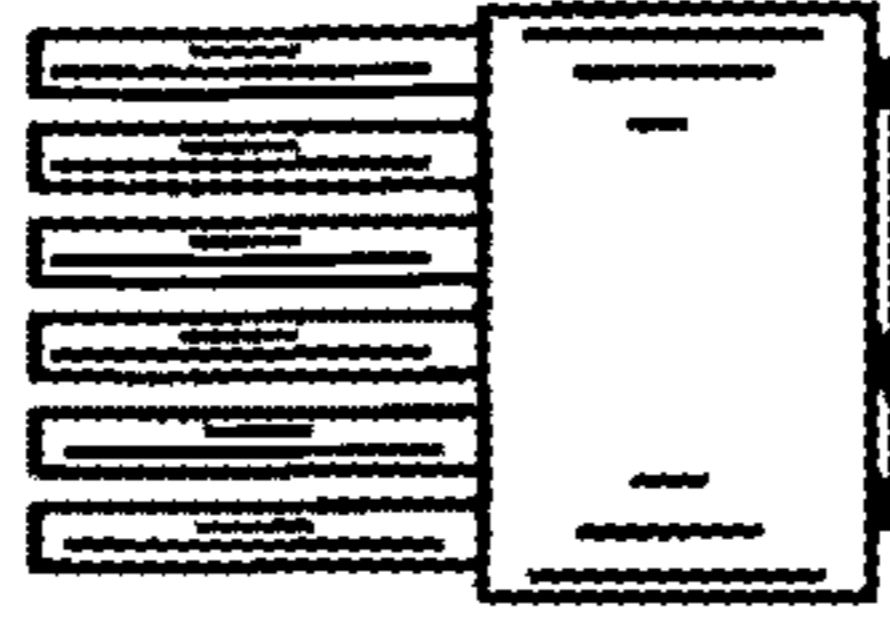

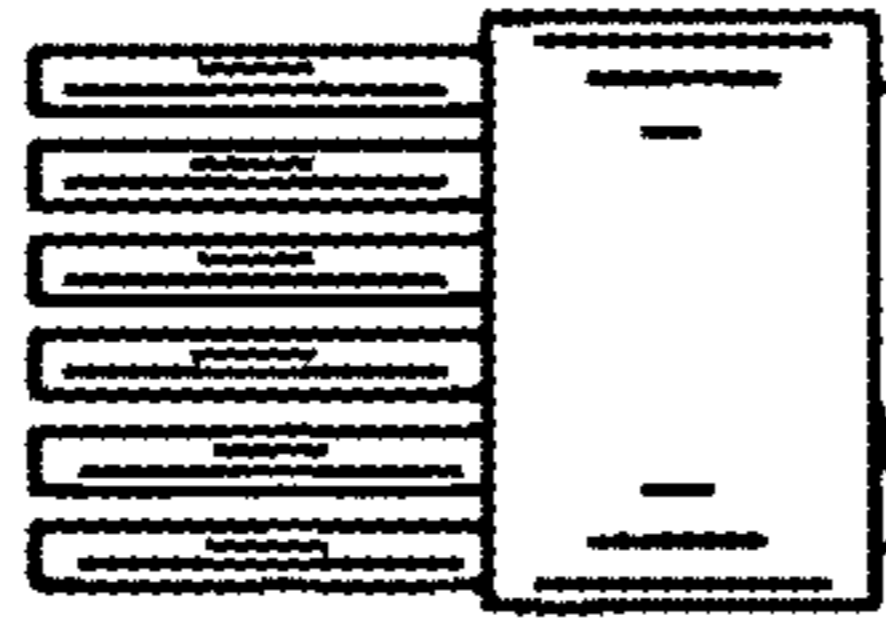
