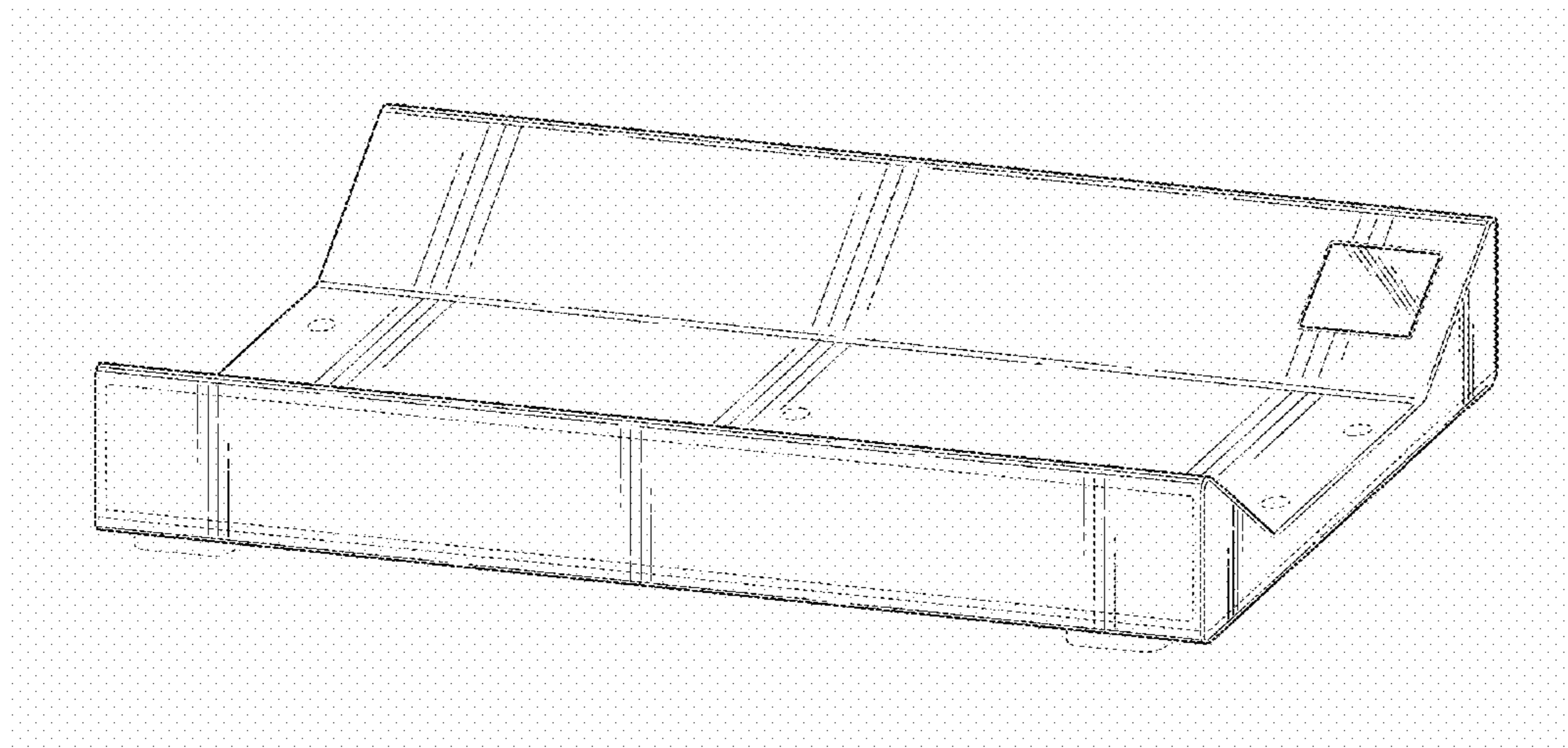
(57) **CLAIM**

The ornamental design for a changing pad, as shown and described.

DESCRIPTION

FIG. 1 is an angled top perspective view of a changing pad; FIG. 2 is a top view of the changing pad shown in FIG. 1; FIG. 3 is a bottom view of the changing pad shown in FIG. 1; FIG. 4 is a front view of the changing pad shown in FIG. 1; FIG. 5 is a rear view of the changing pad shown in FIG. 1; FIG. 6 is a left side view of the changing pad shown in FIG. 1; and, FIG. 7 is a right side view of the changing pad shown in FIG. 1. The elements shown in broken lines form no part of the claimed design.

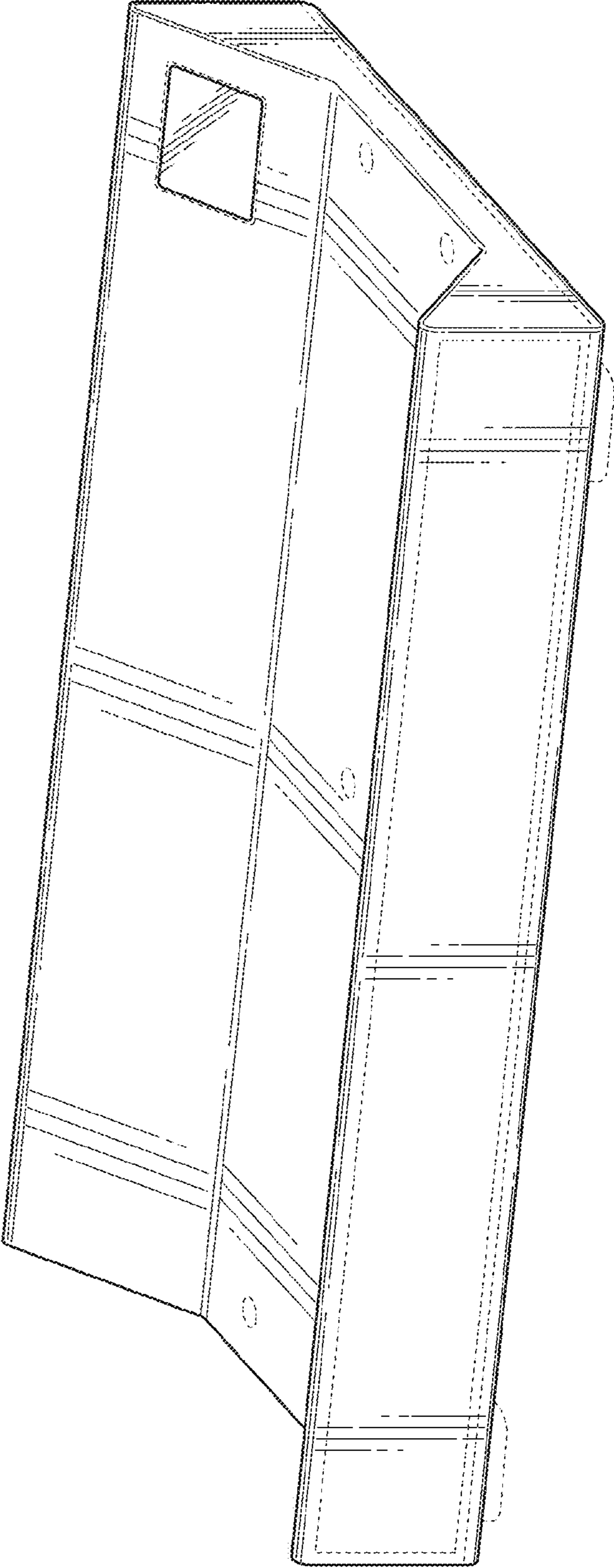

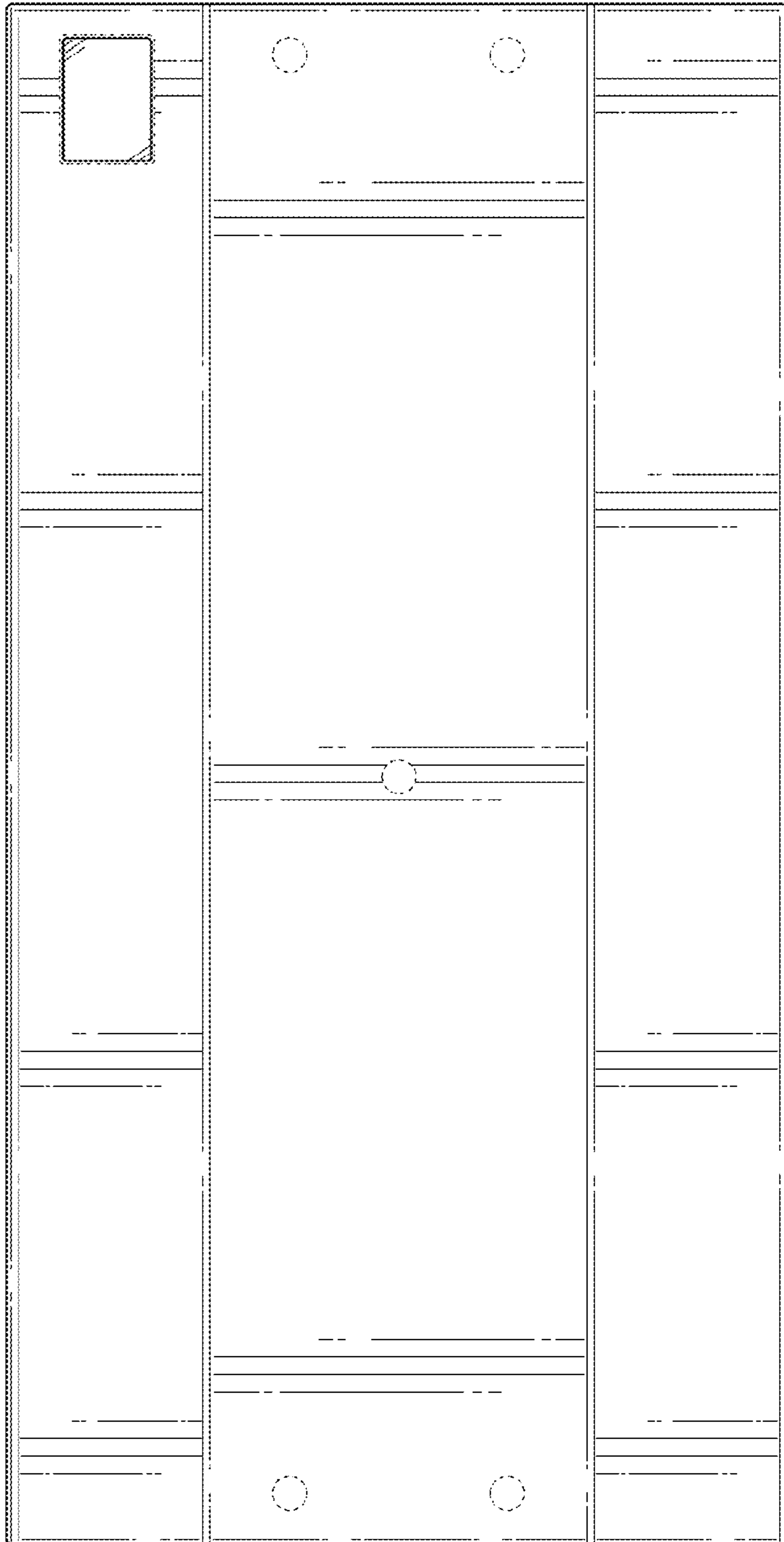

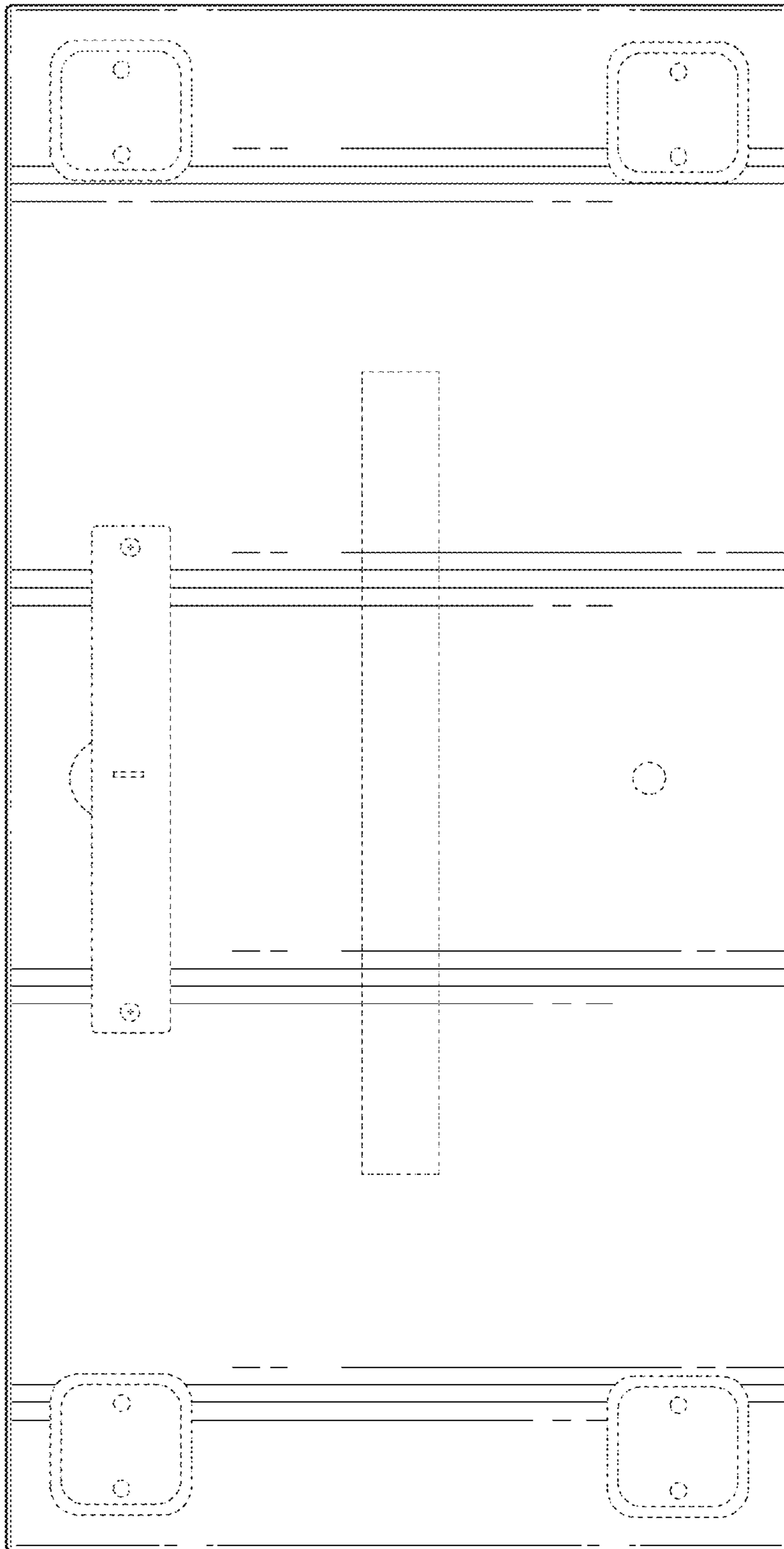

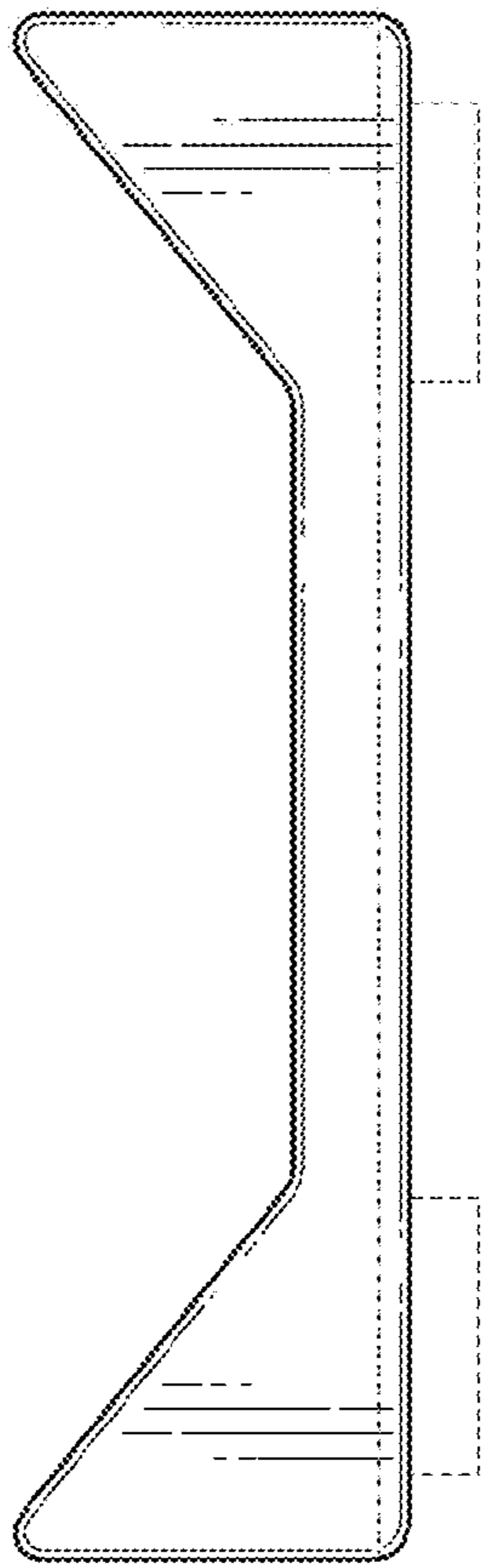

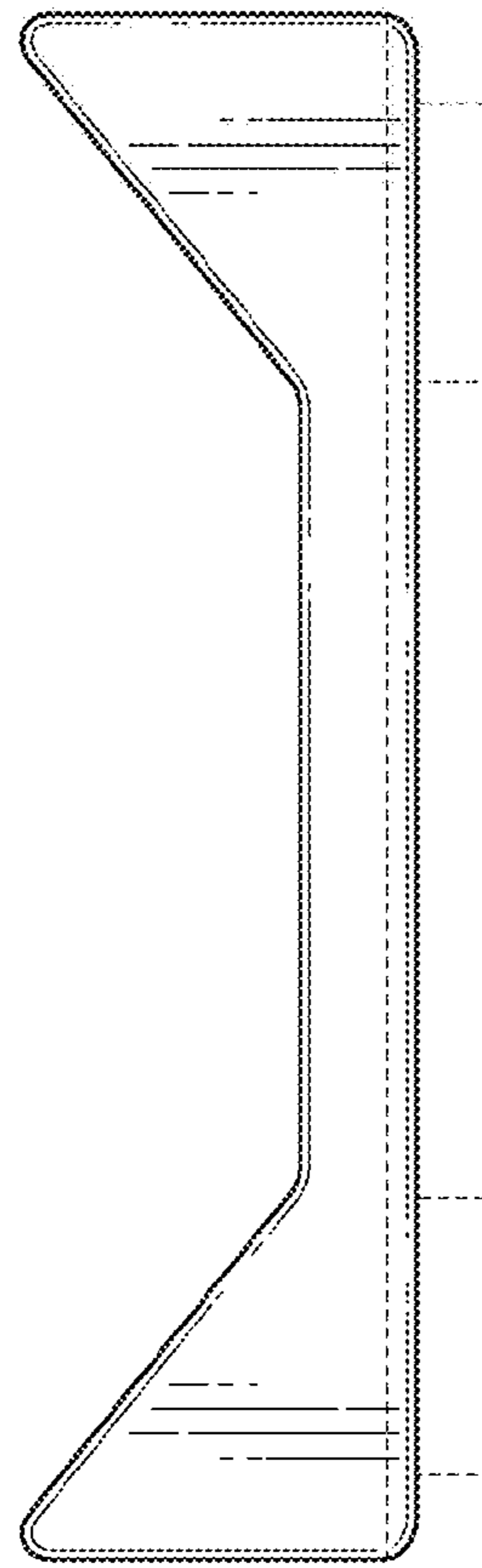

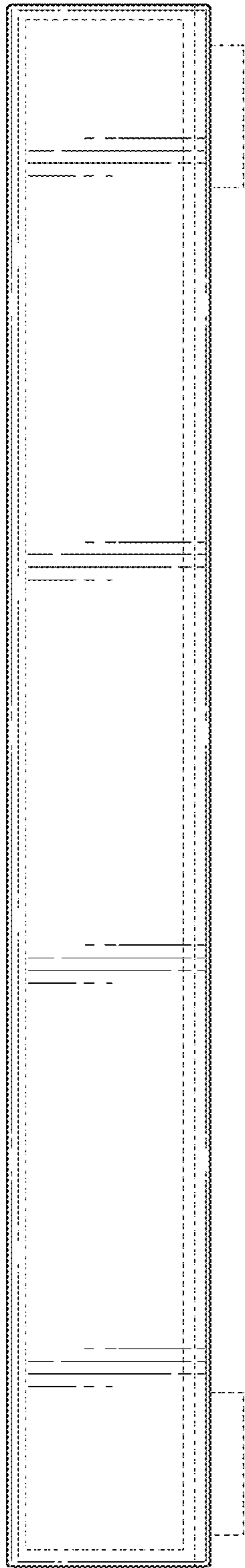

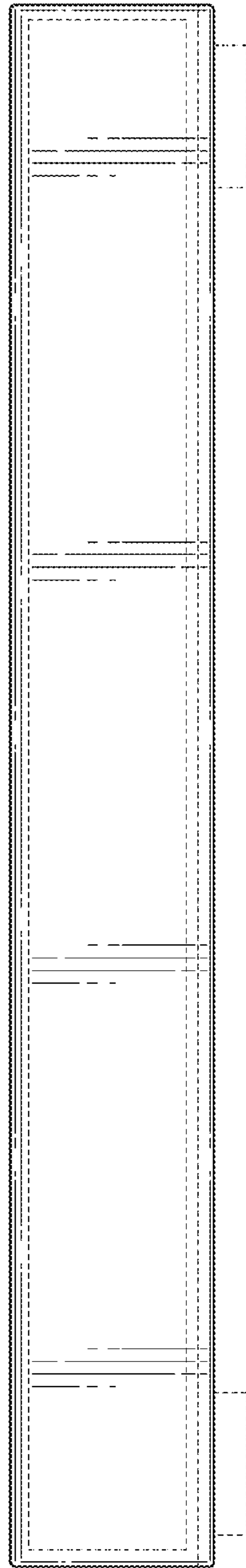
