FIG. 7 is an elevated right side view of the chair shown in FIG. 1.

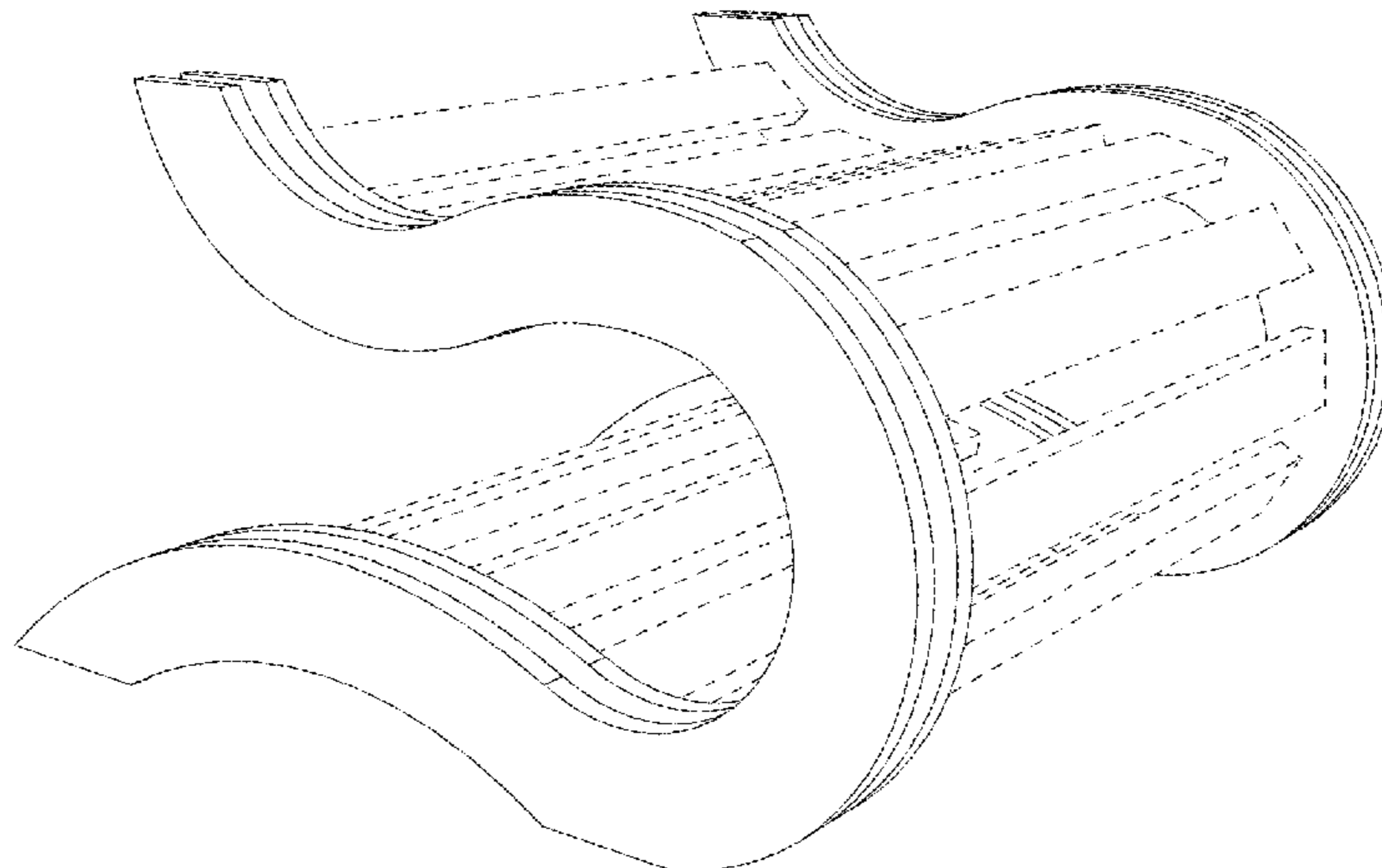

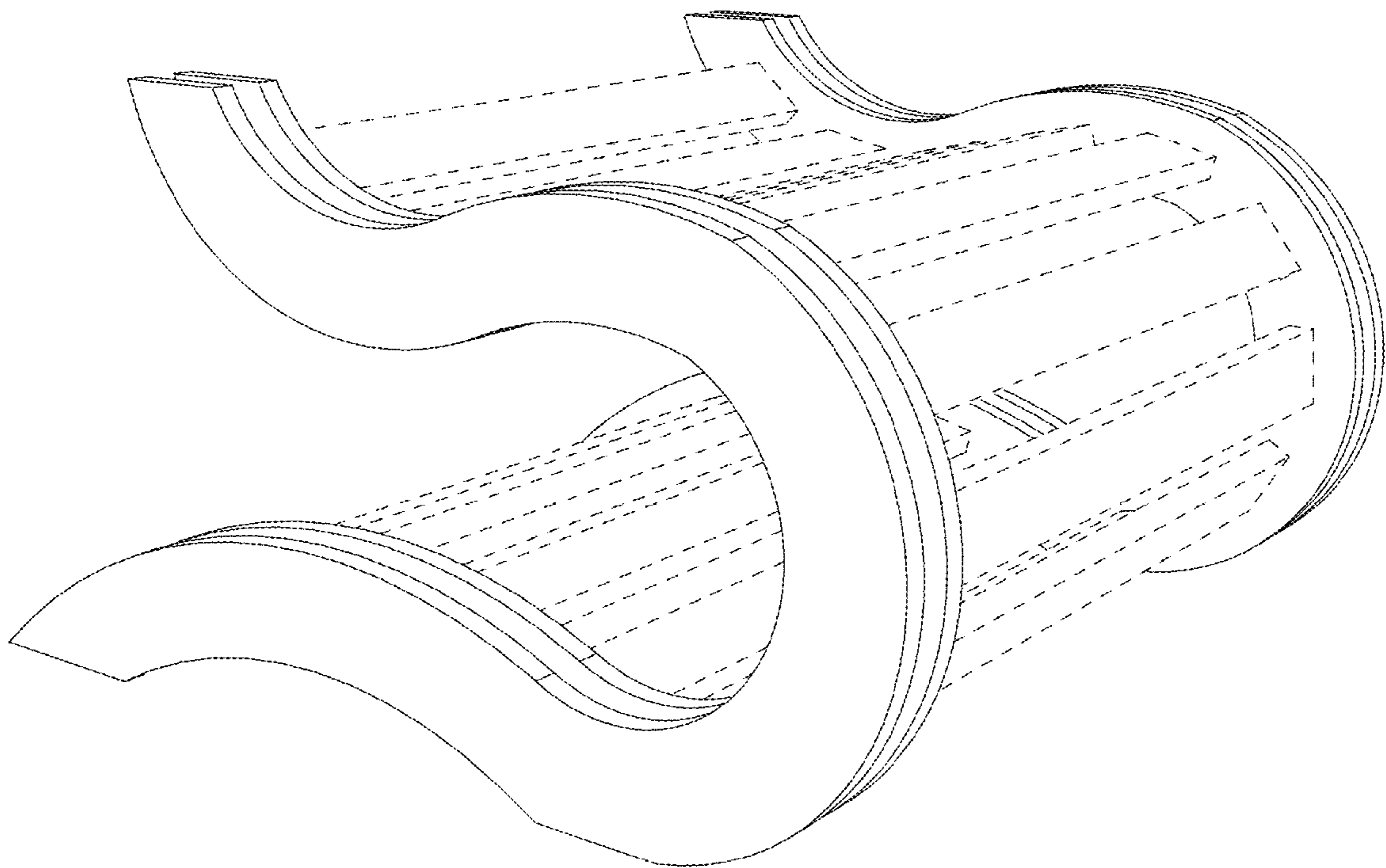

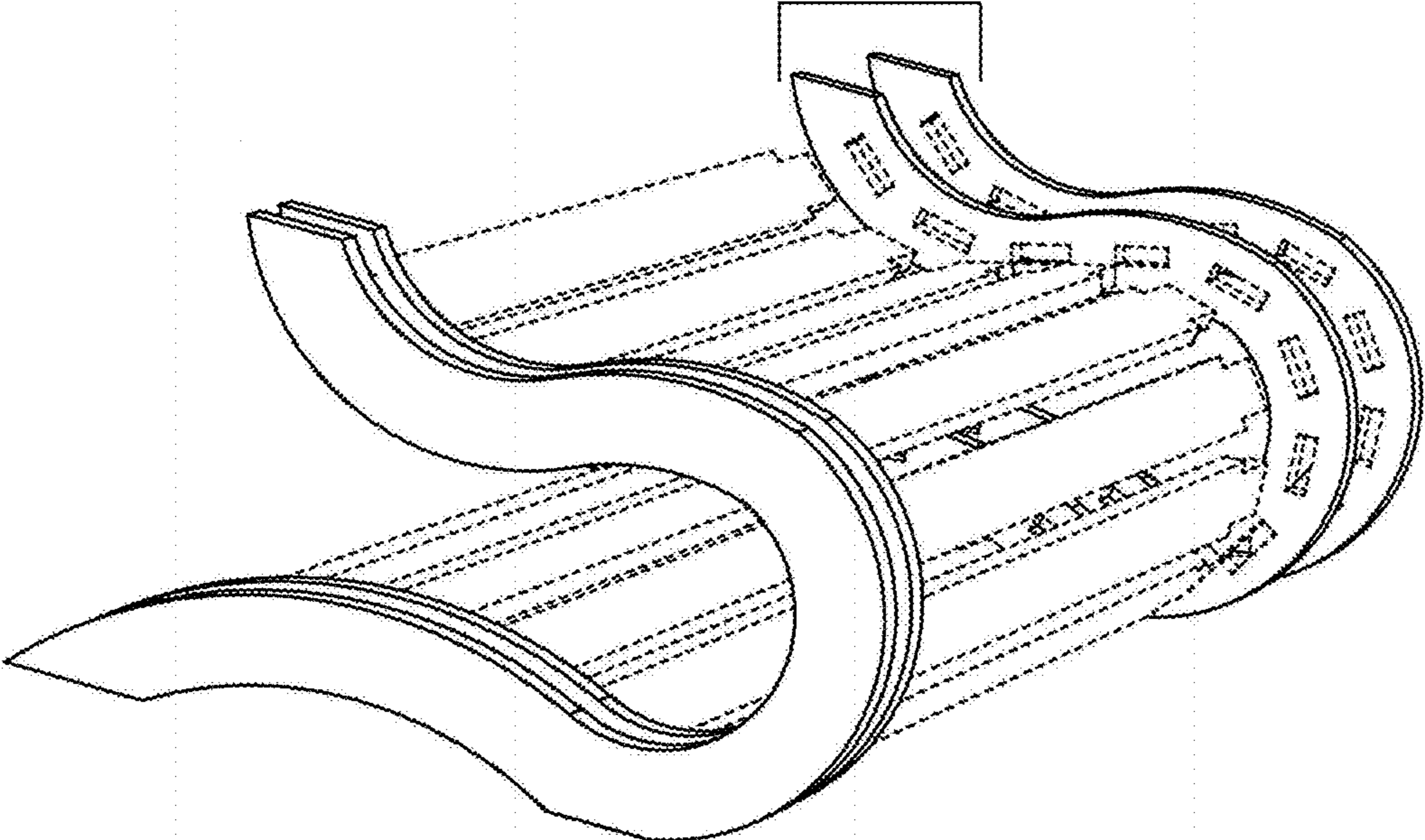

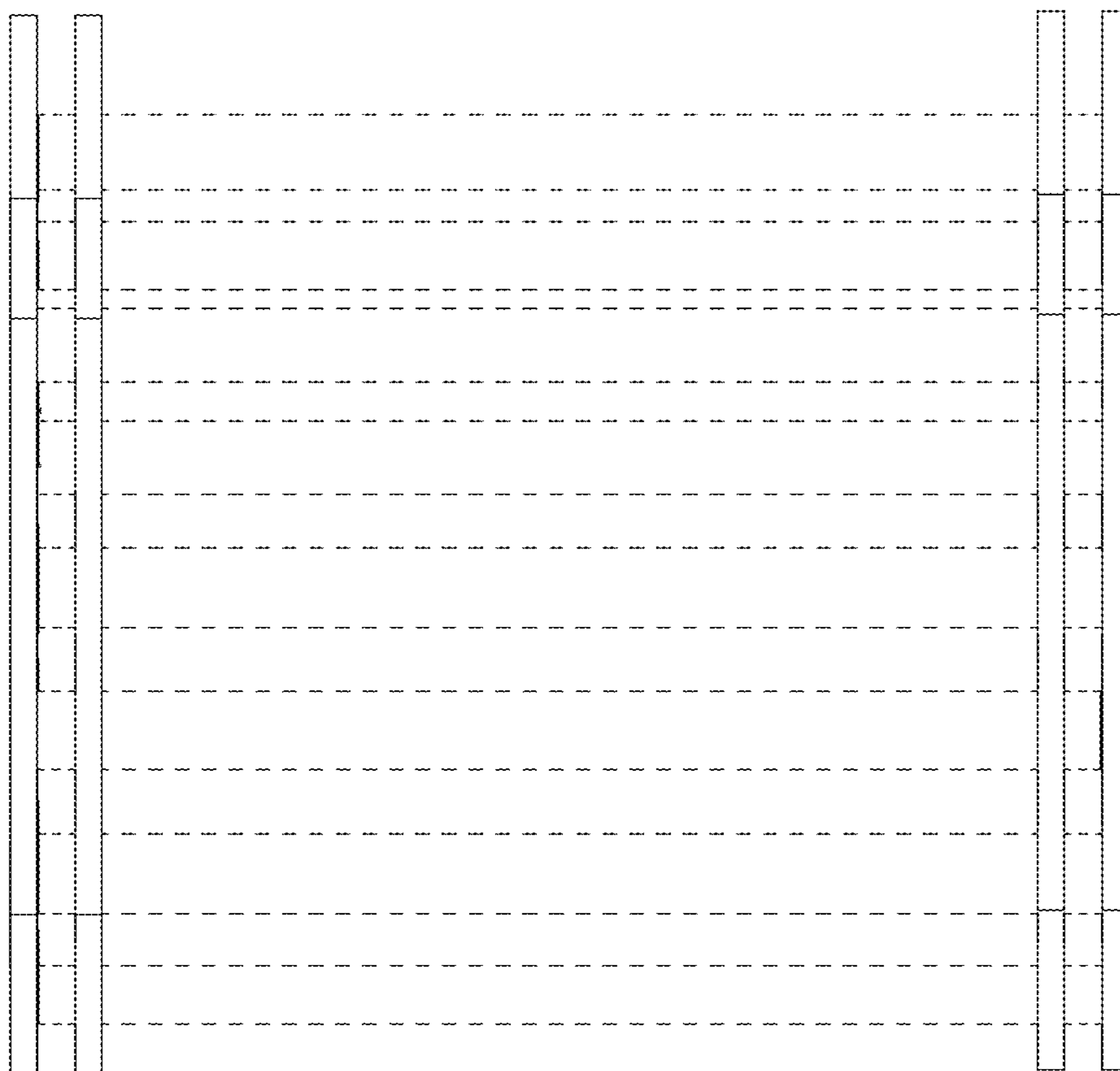

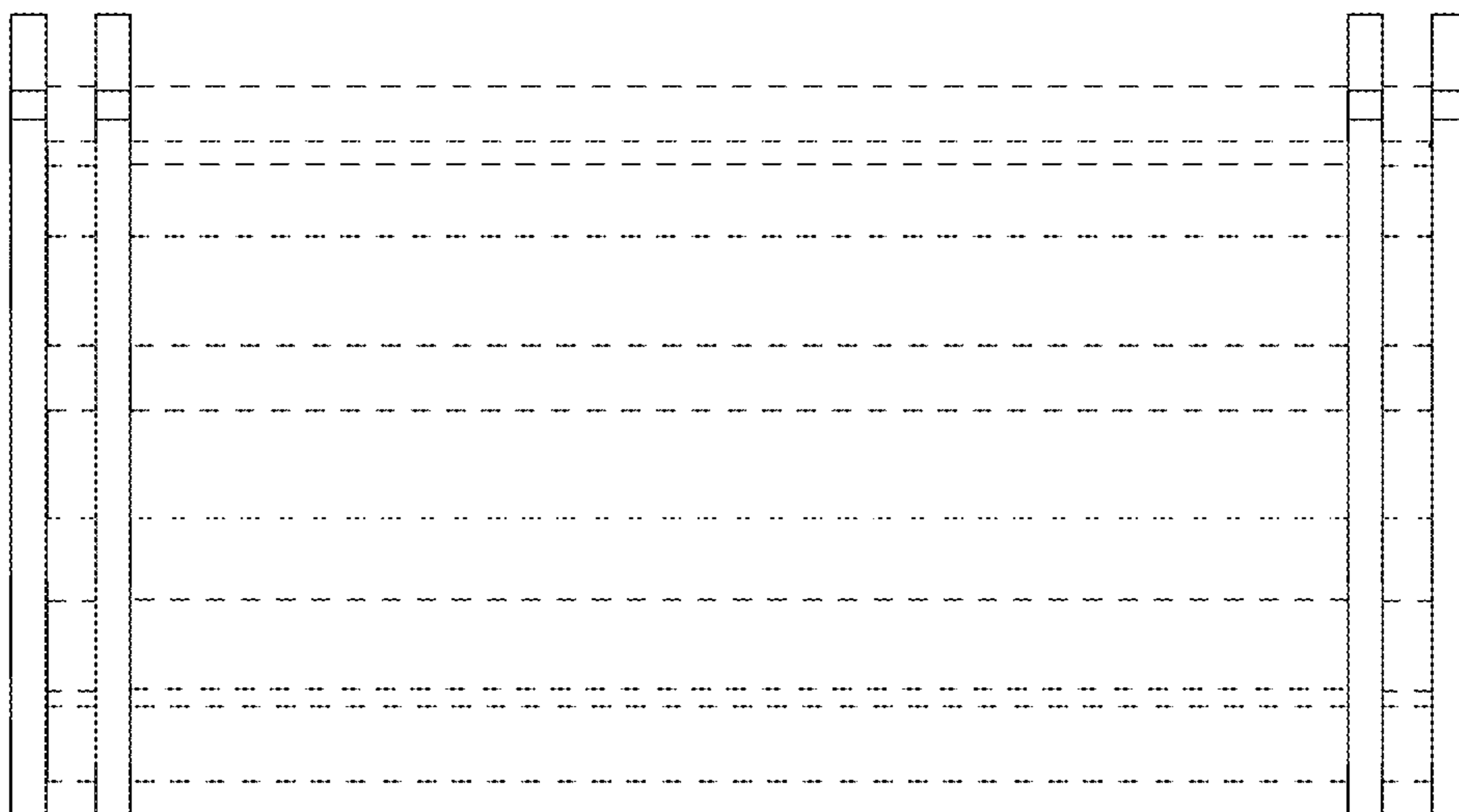

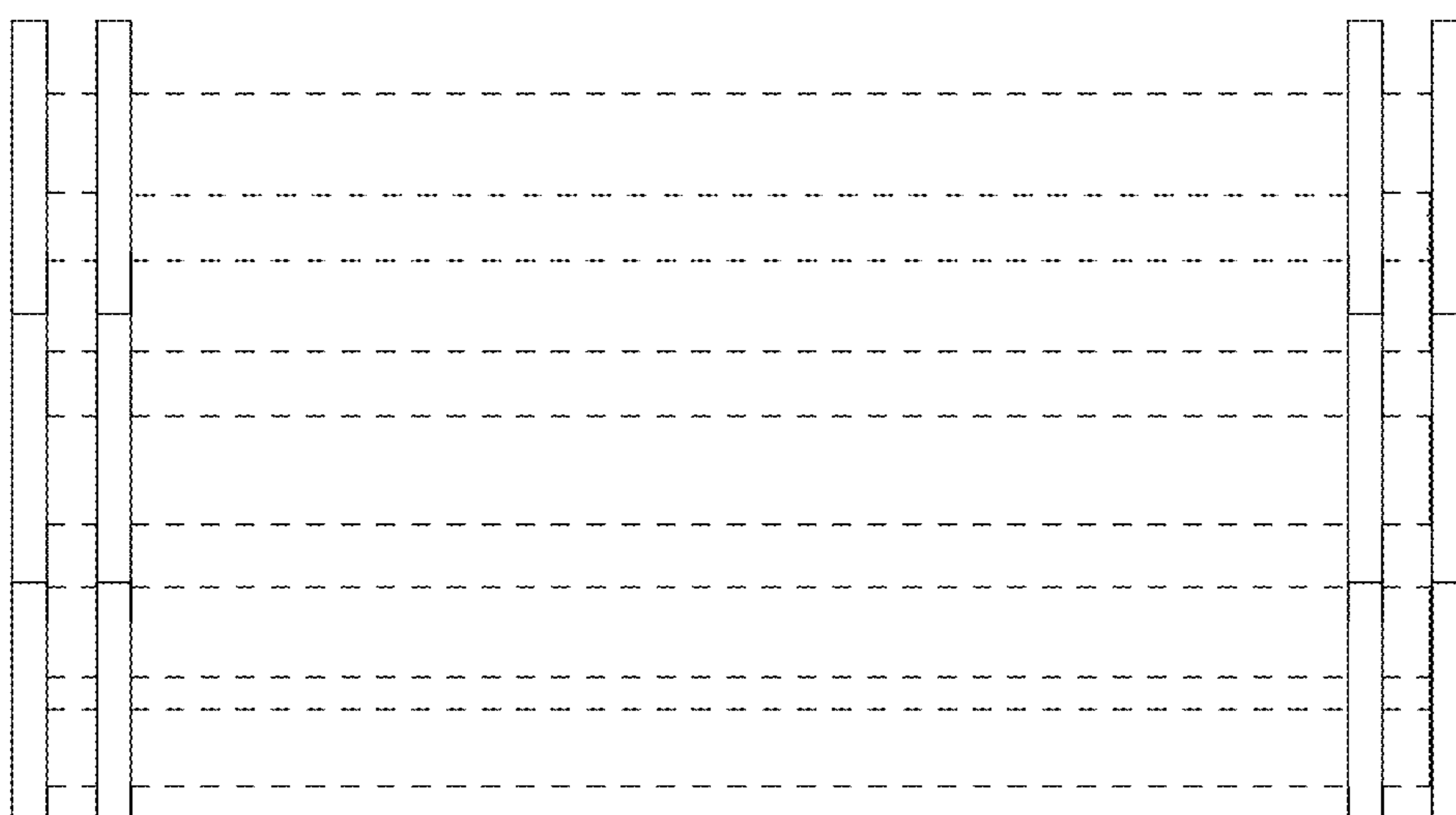

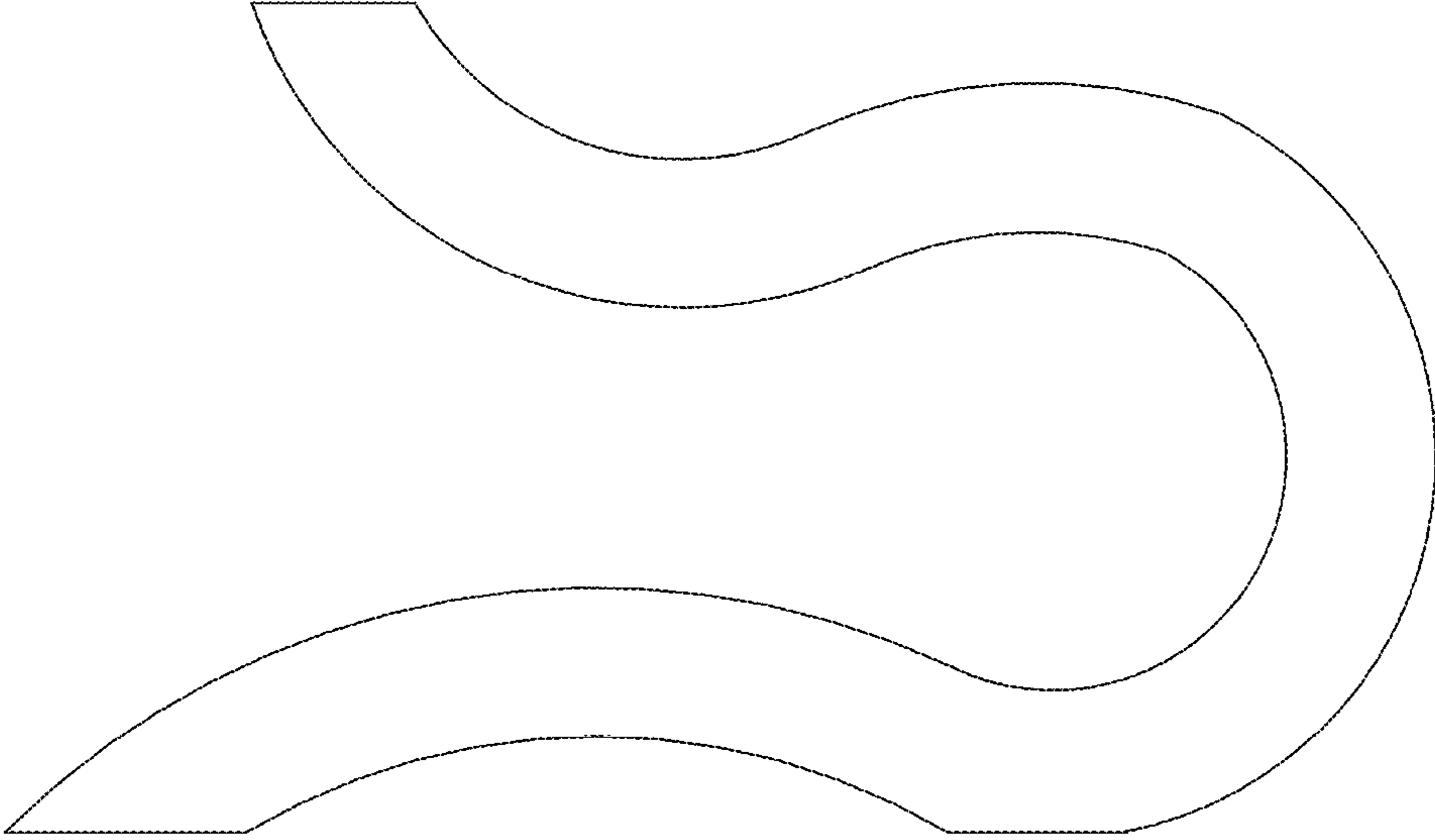

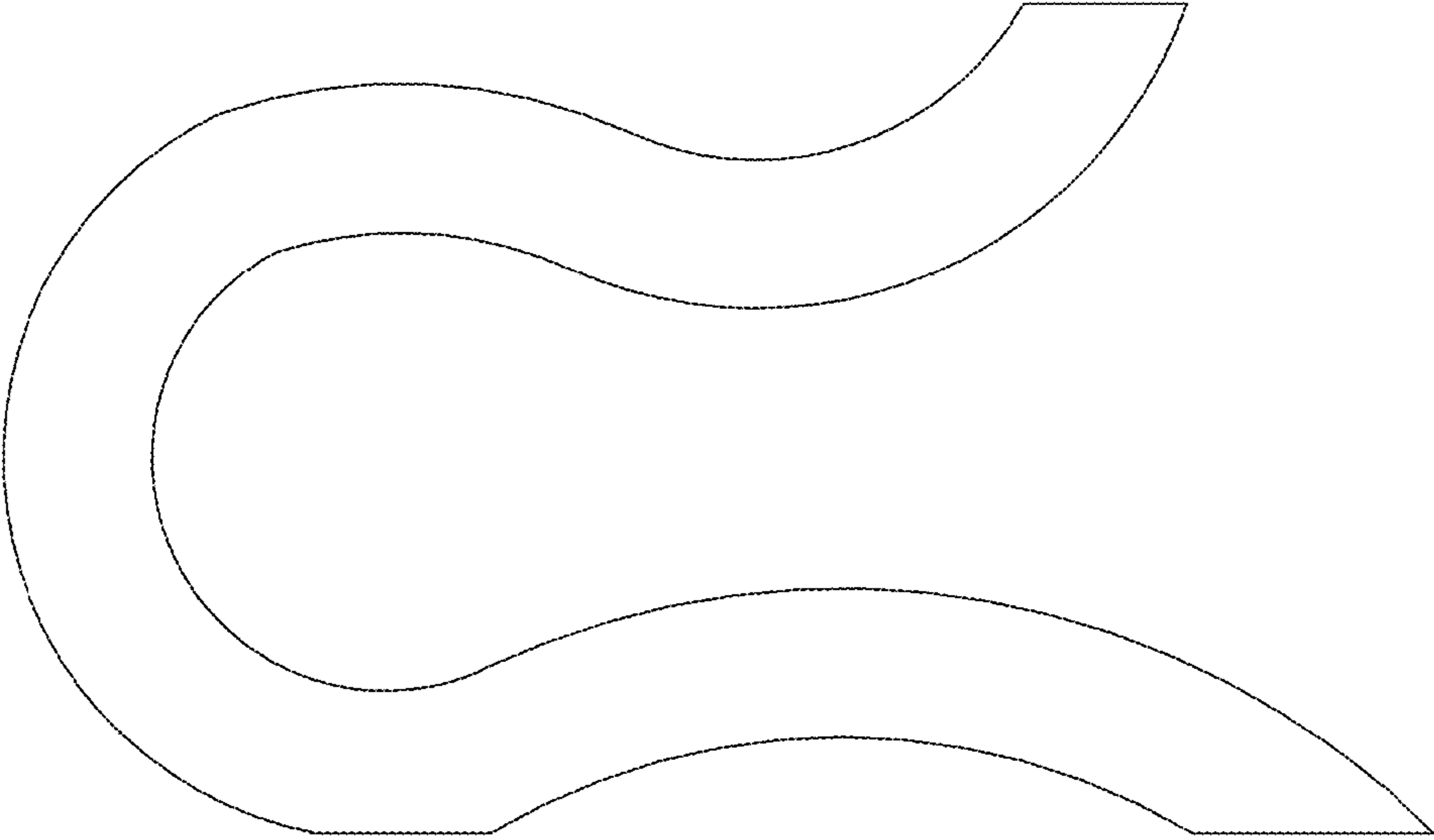
