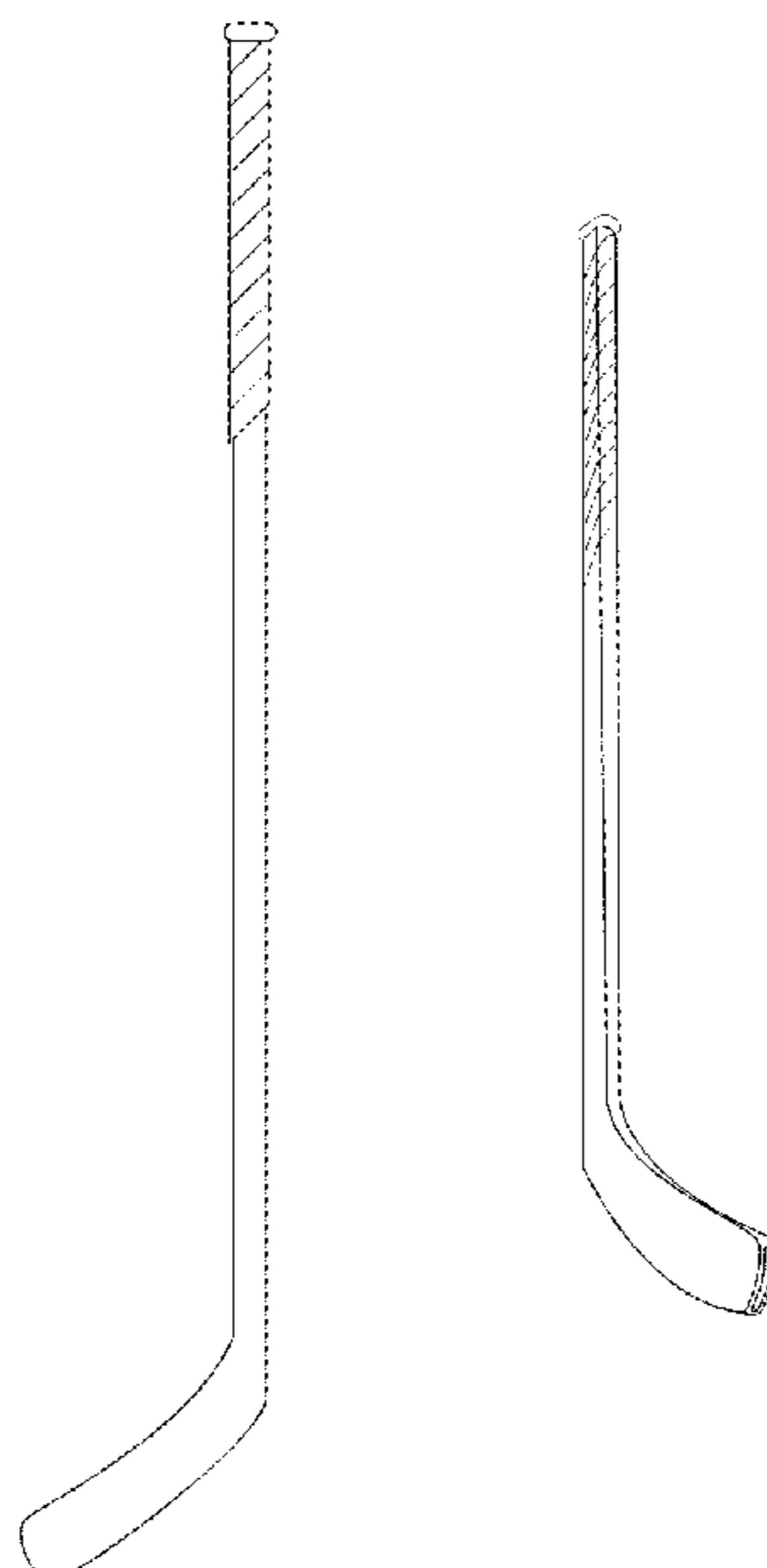
(57) **CLAIM**

We claim the ornamental design for a beverage consumption straw, as shown and described.

**DESCRIPTION**

FIG. 1 is a right side view of a beverage consumption straw showing our new design;  
FIG. 2 is a top view thereof;  
FIG. 3 is a front view thereof;  
FIG. 4 is a bottom left perspective view thereof; and,  
FIG. 5 is a right side cross sectional view thereof, taken in the direction of line 5-5' of FIG. 2.

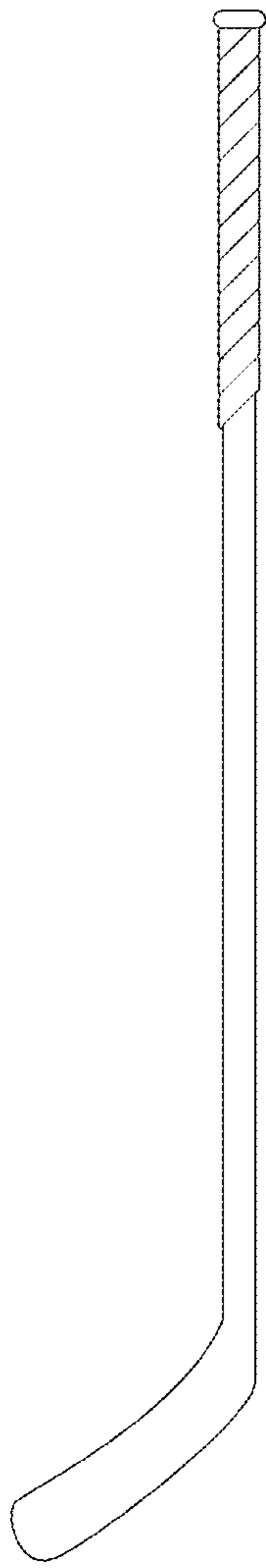

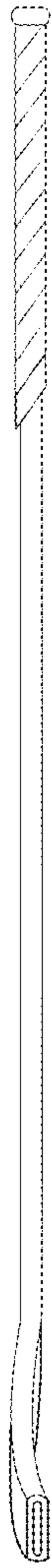

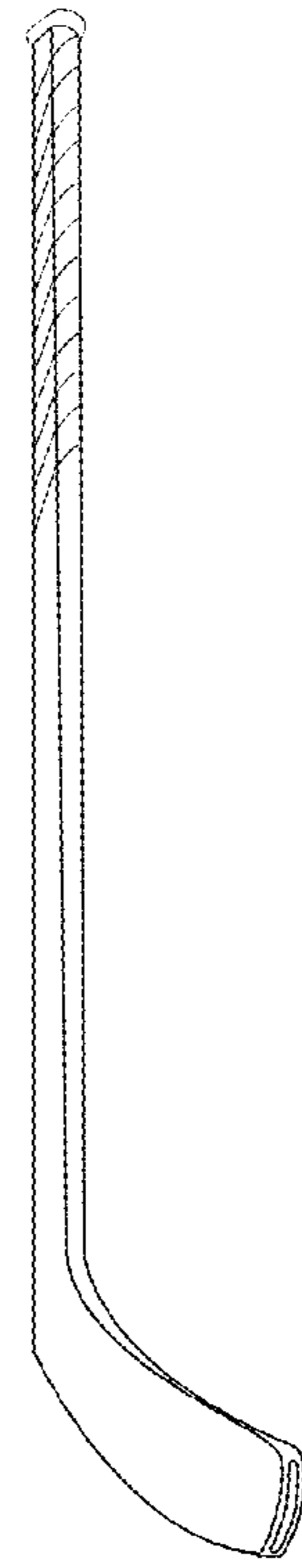

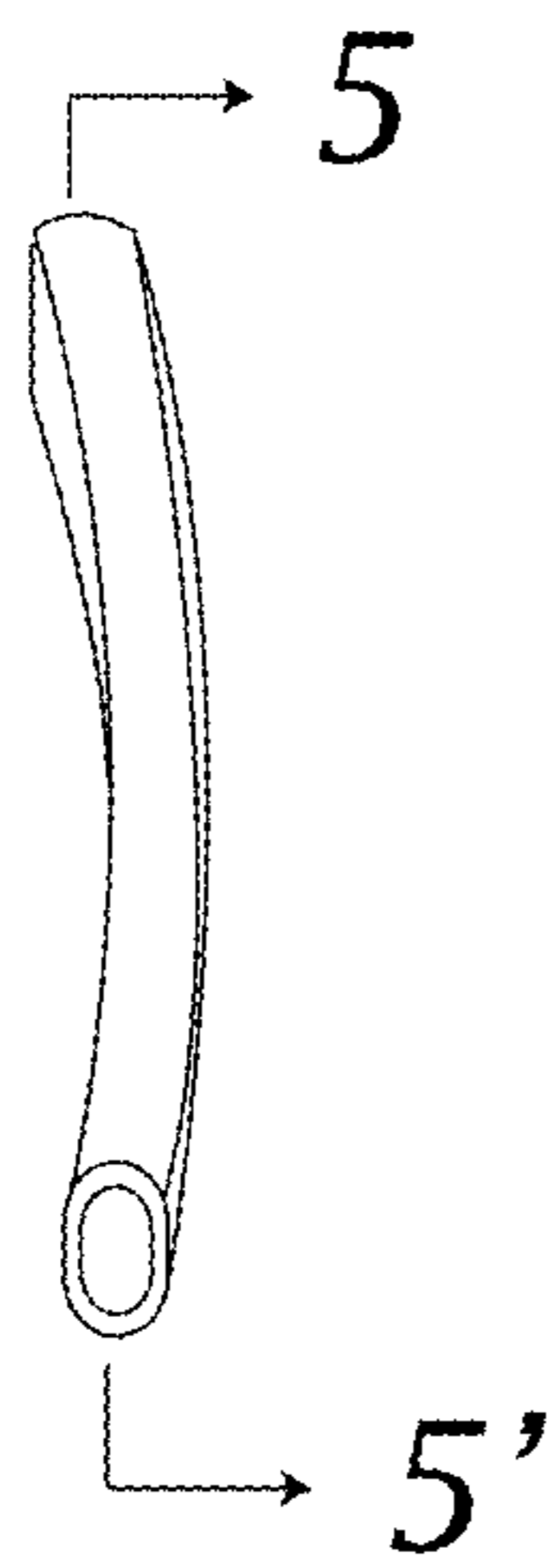
