The ornamental design for a serving bowl, as shown and described.

DESCRIPTION

FIG. 1 is a top front left side perspective view of a serving bowl showing my design;

FIG. 2 is a bottom rear right side perspective view thereof;

FIG. 3 is a top plan view thereof;

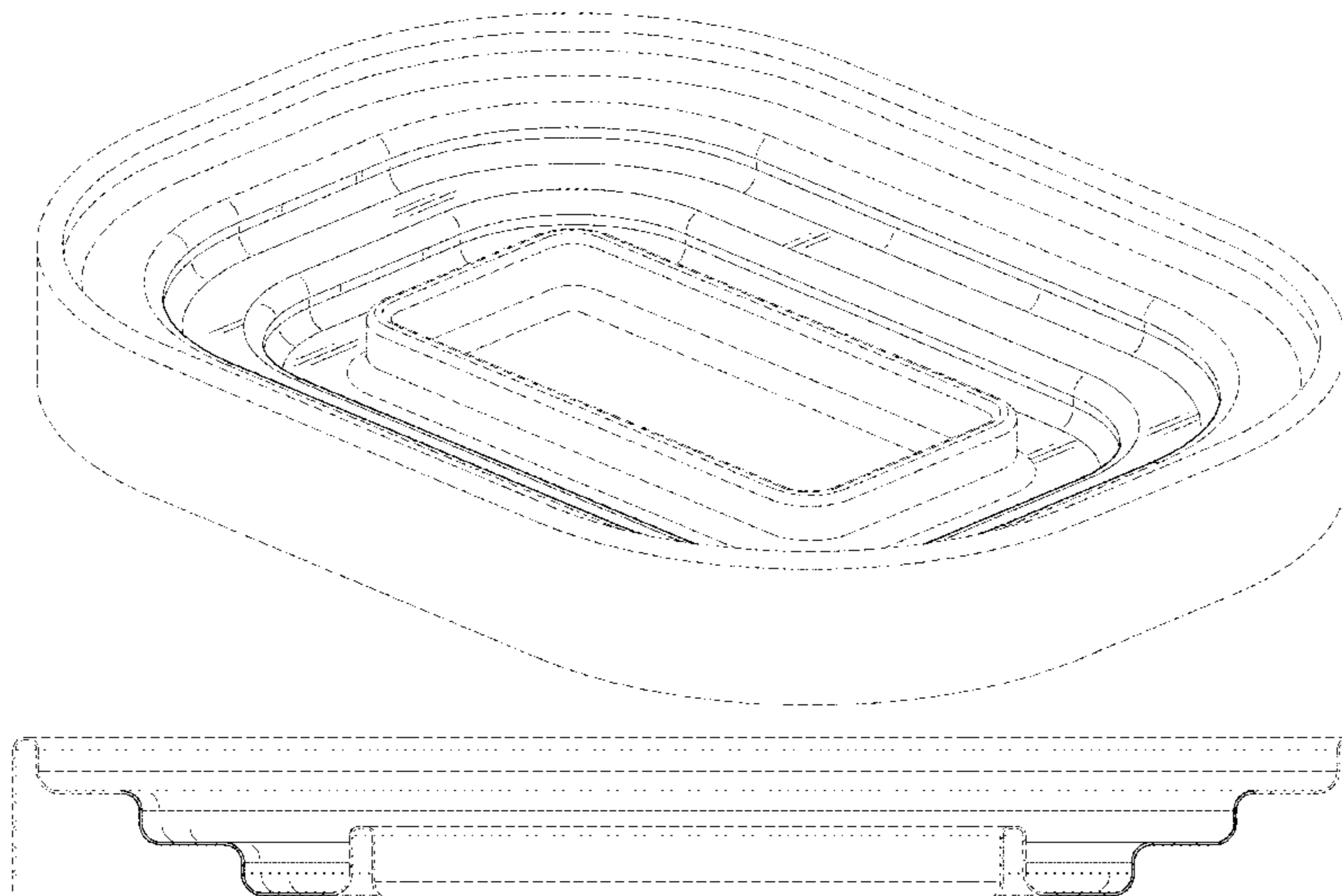
FIG. 4 is a left side elevation view thereof;

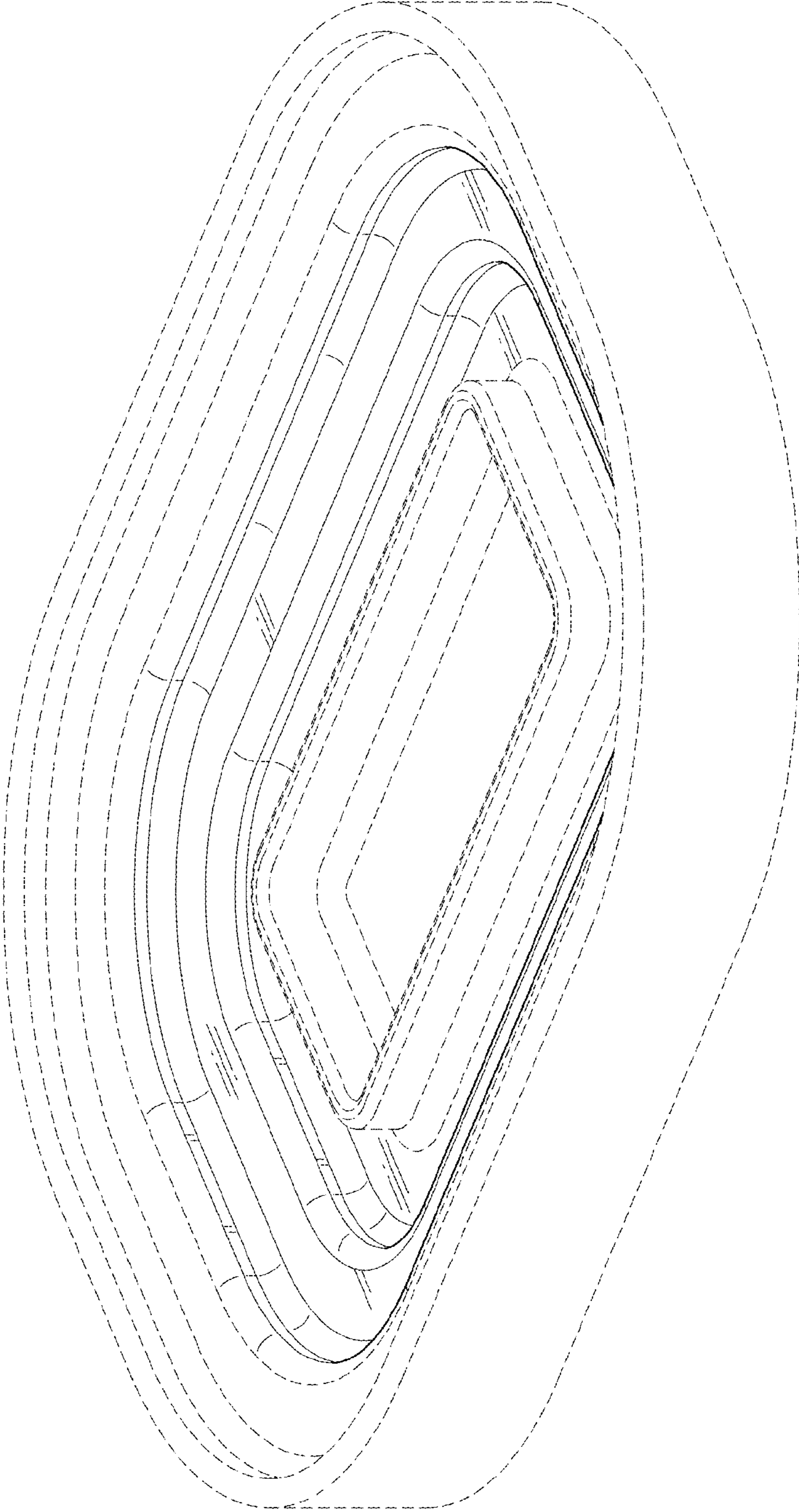

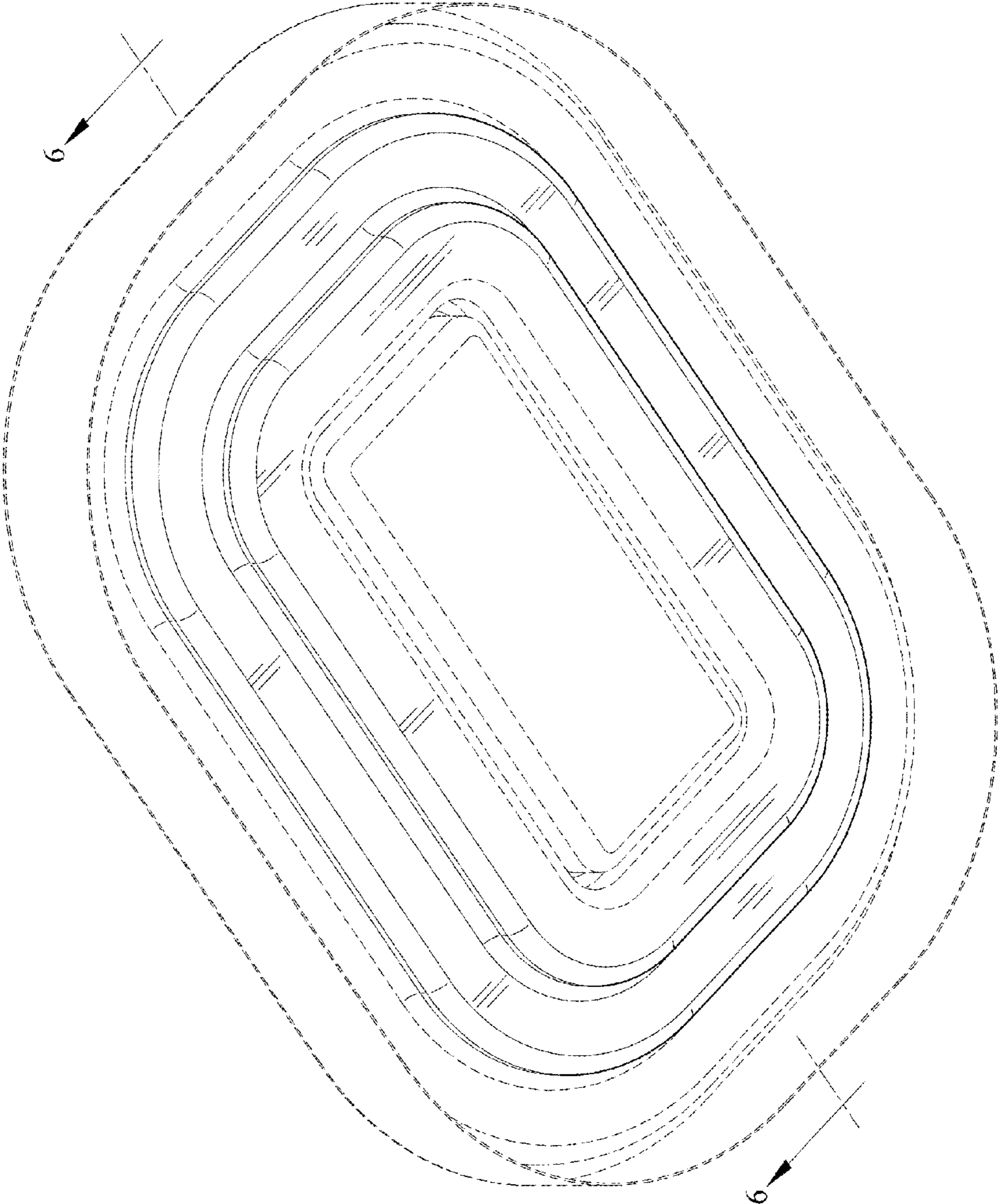

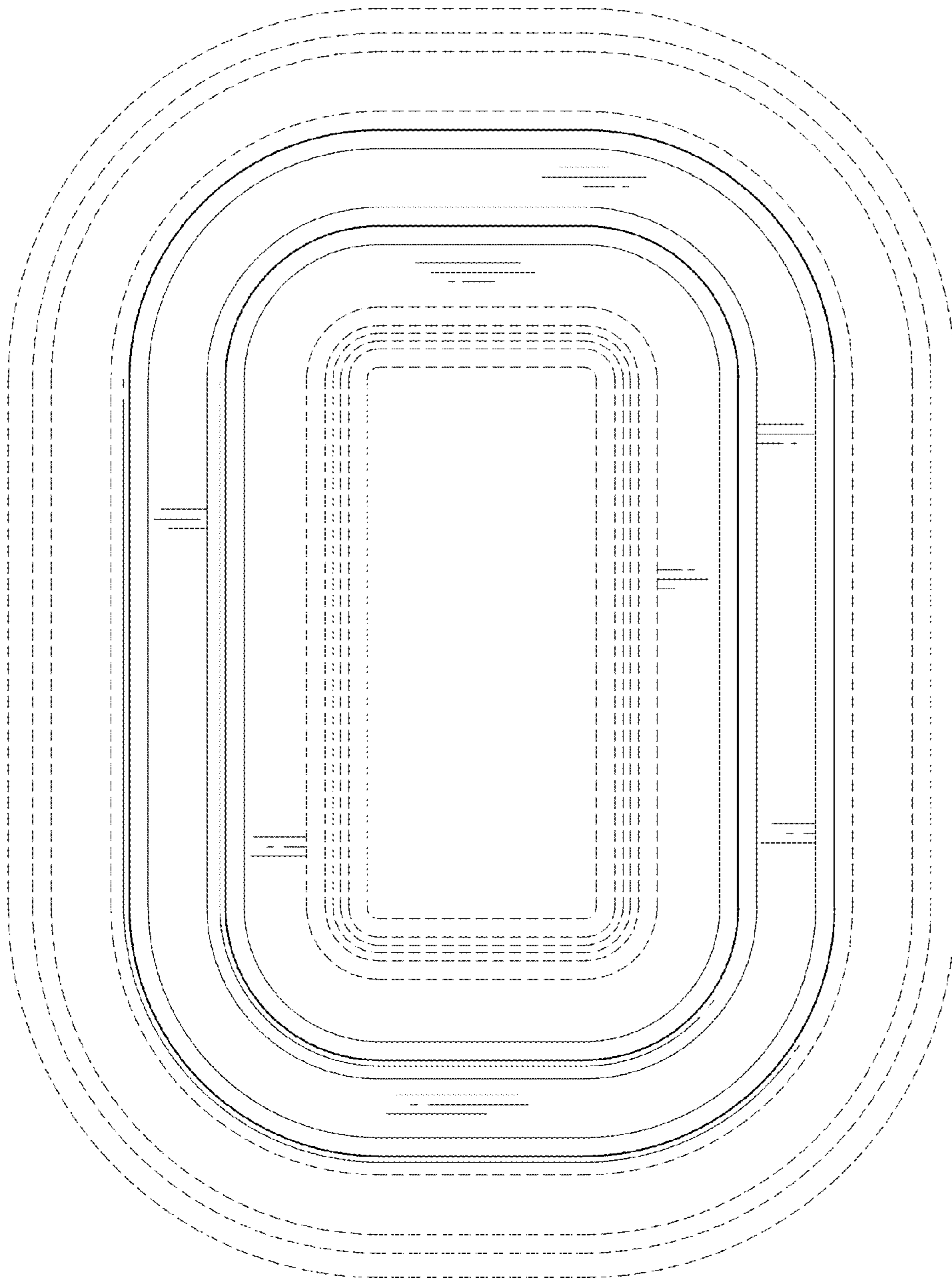

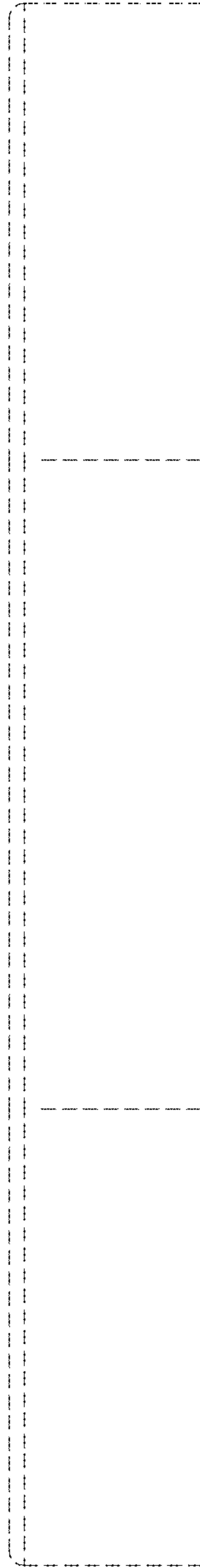

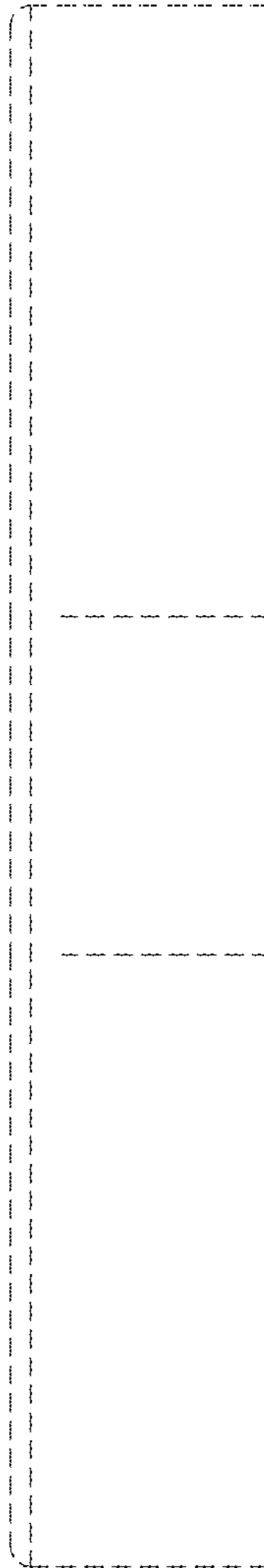

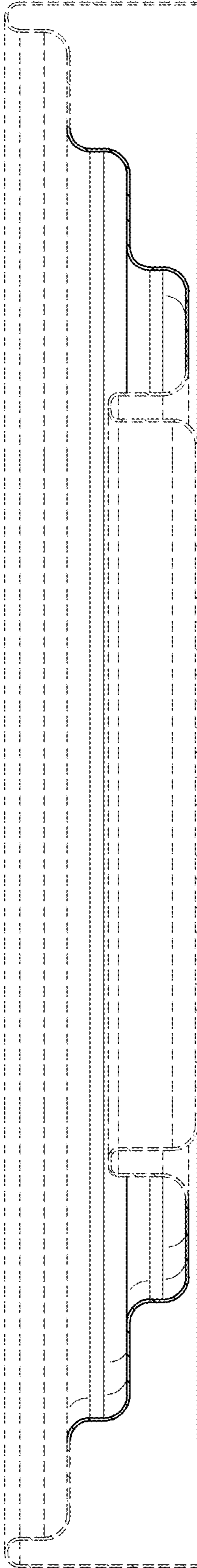
