We claim the ornamental design for a box for package, as shown and described.

**DESCRIPTION**

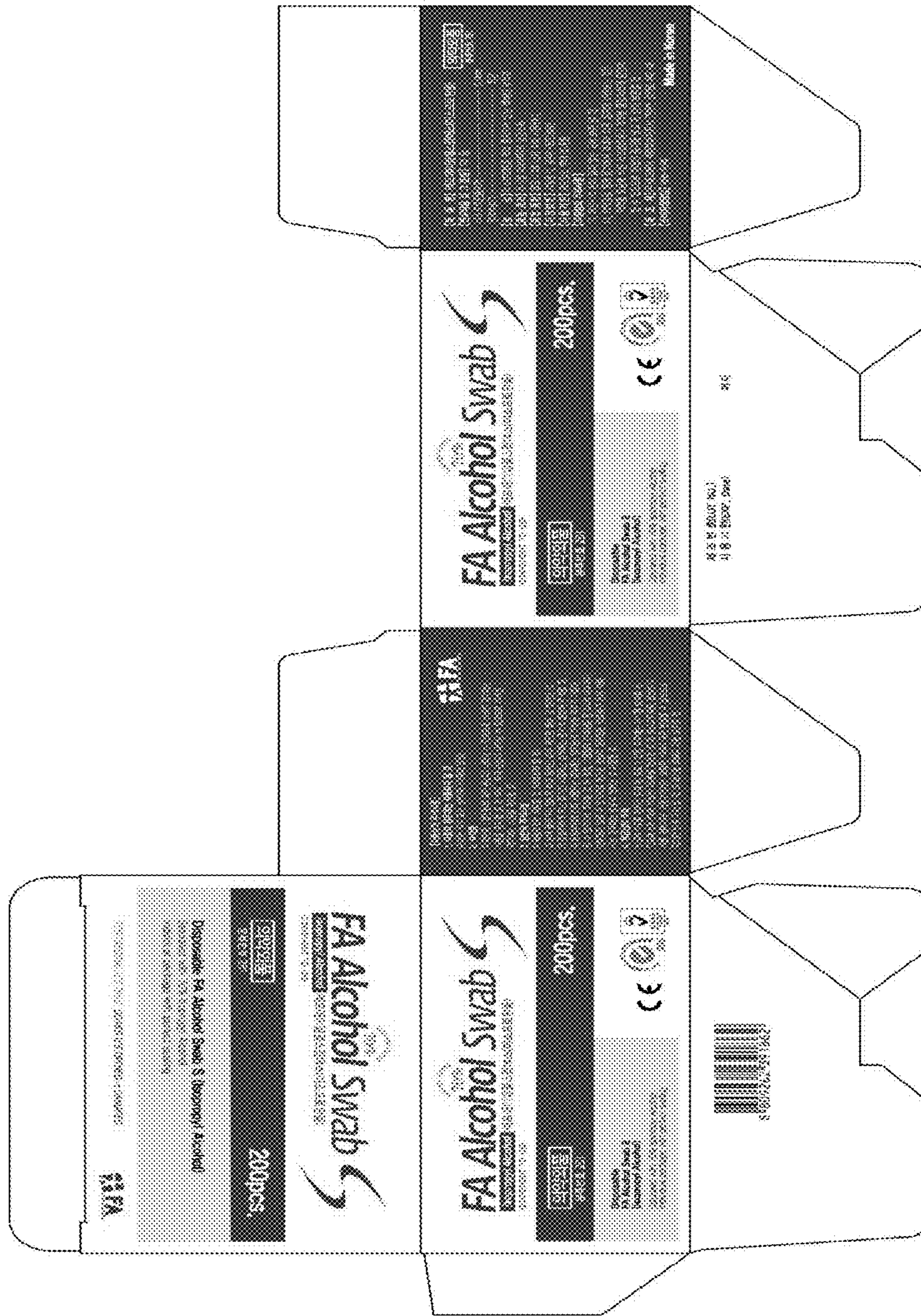
