FIG. 3 is a left side elevation view thereof, the right side being substantially a mirror image;

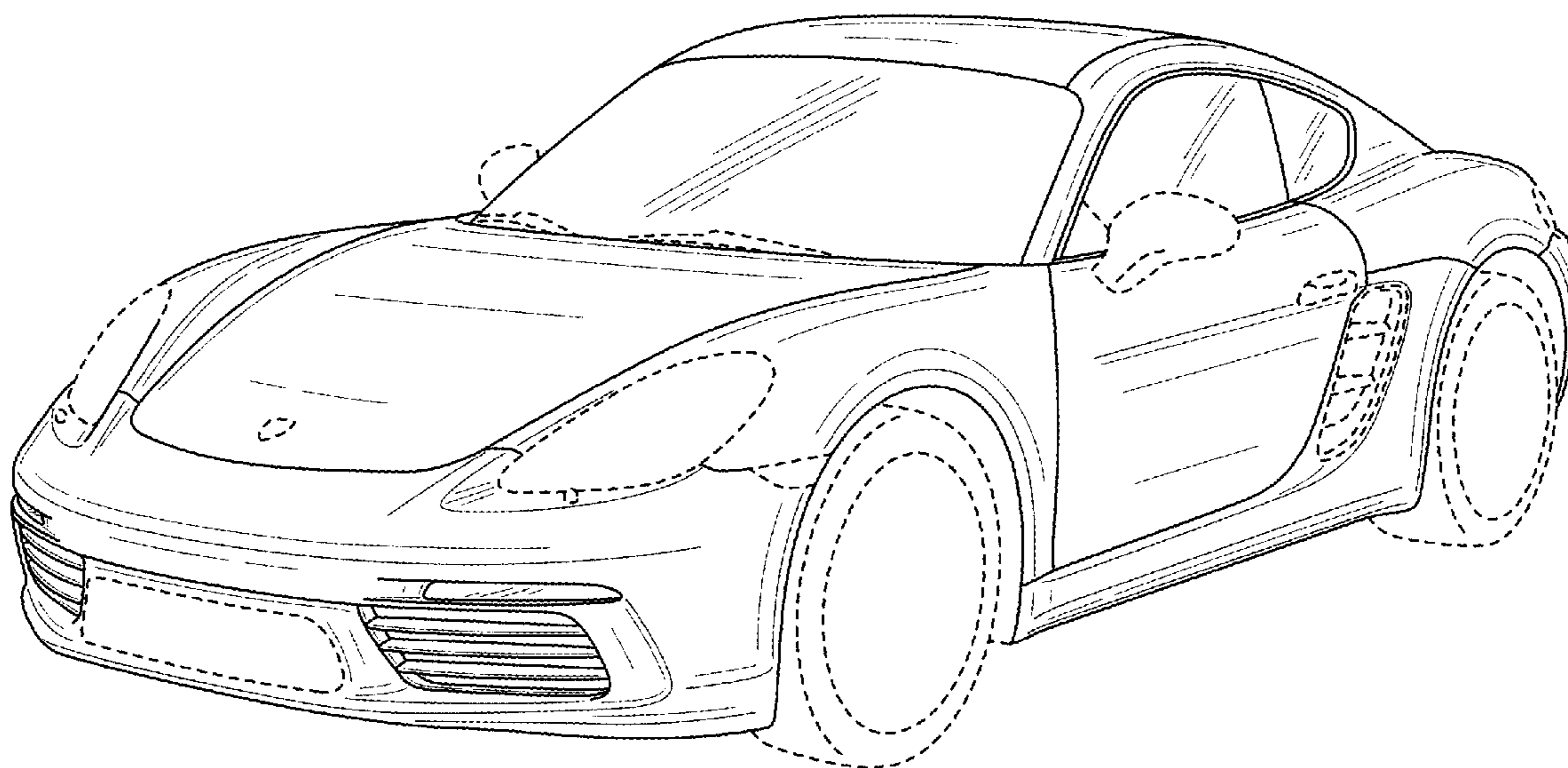
FIG. 4 is a front elevation view thereof;

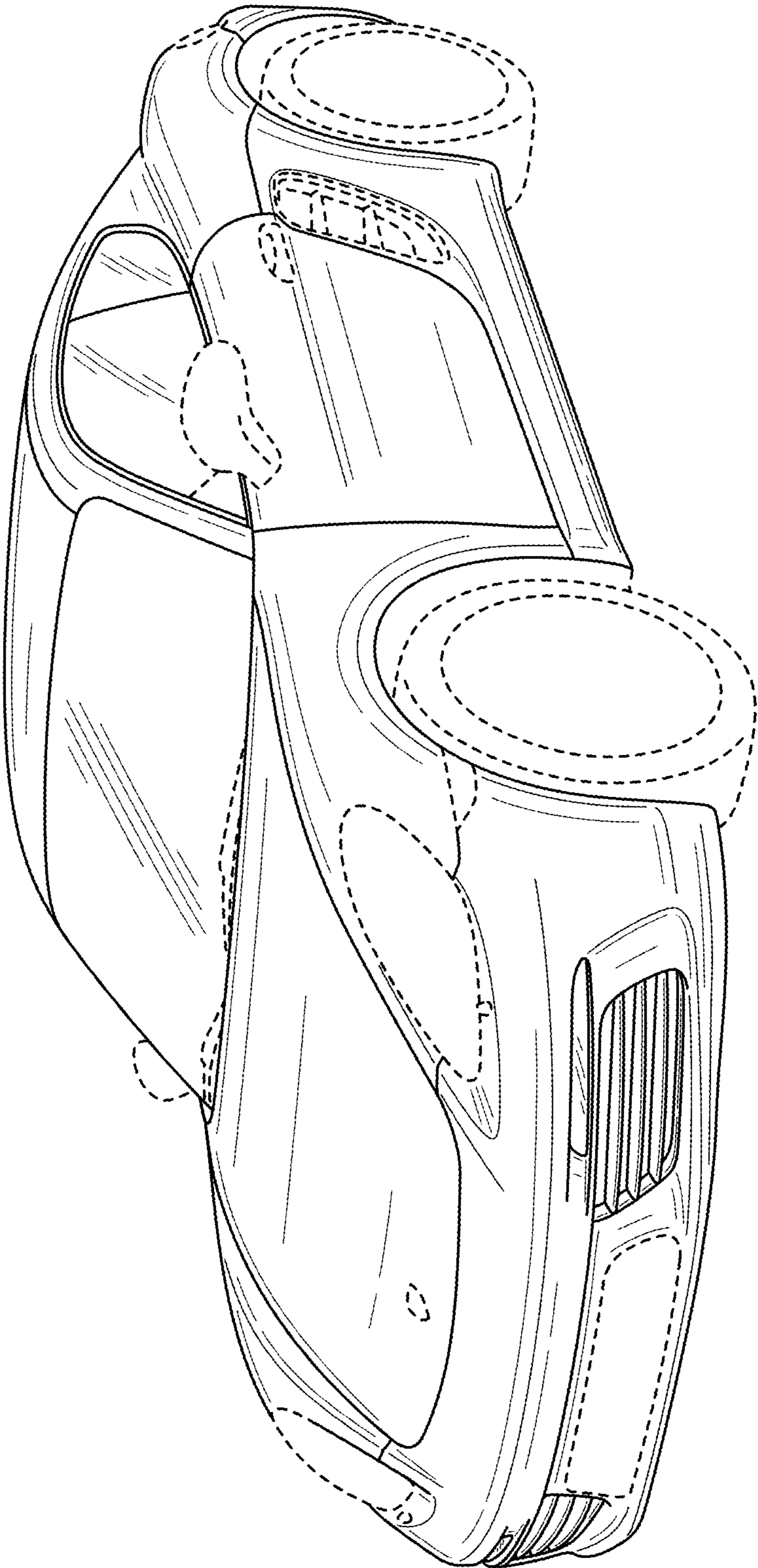

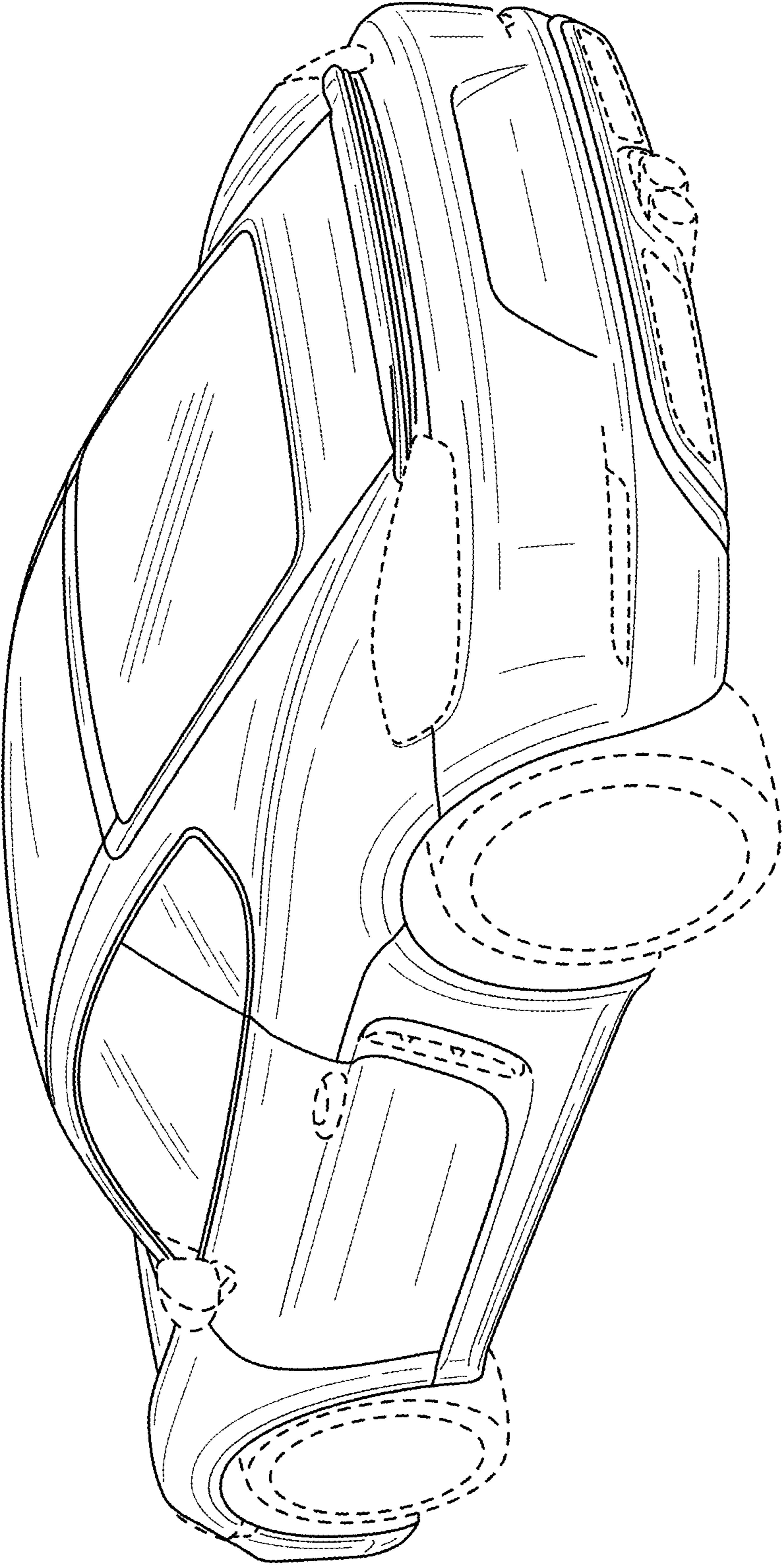

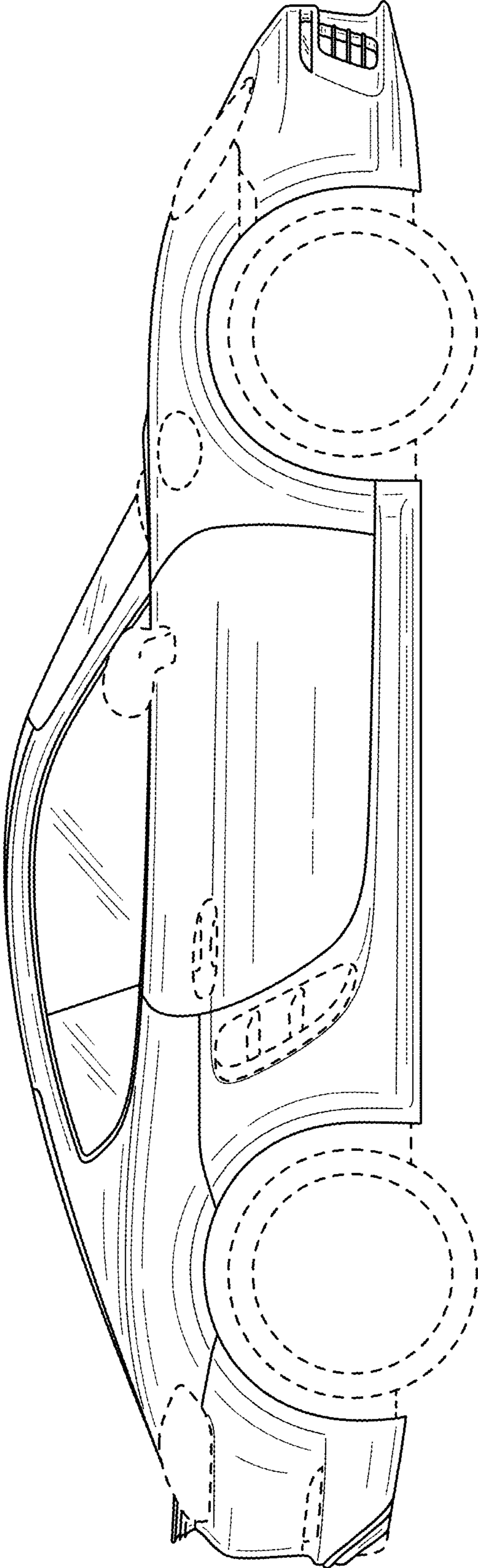

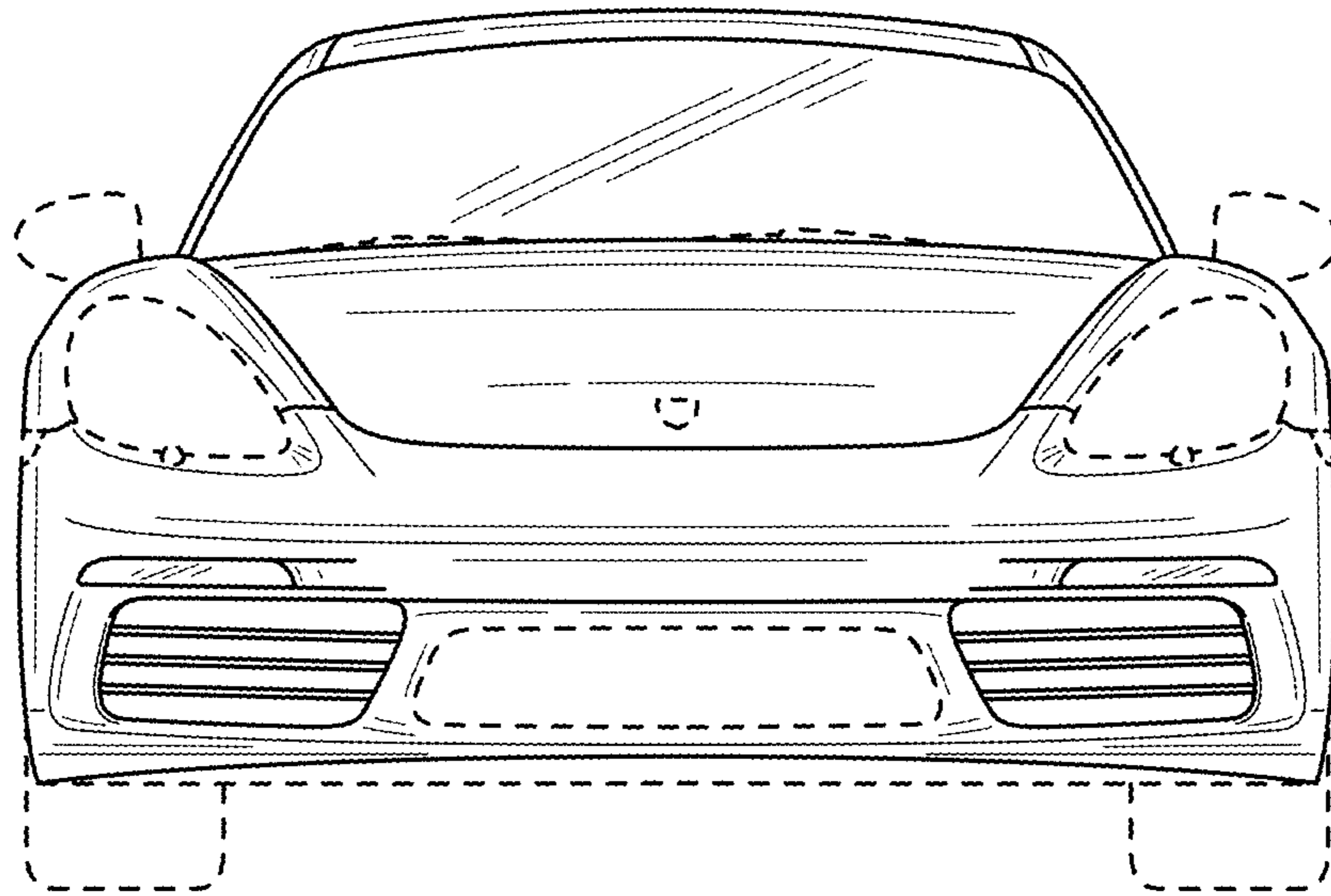

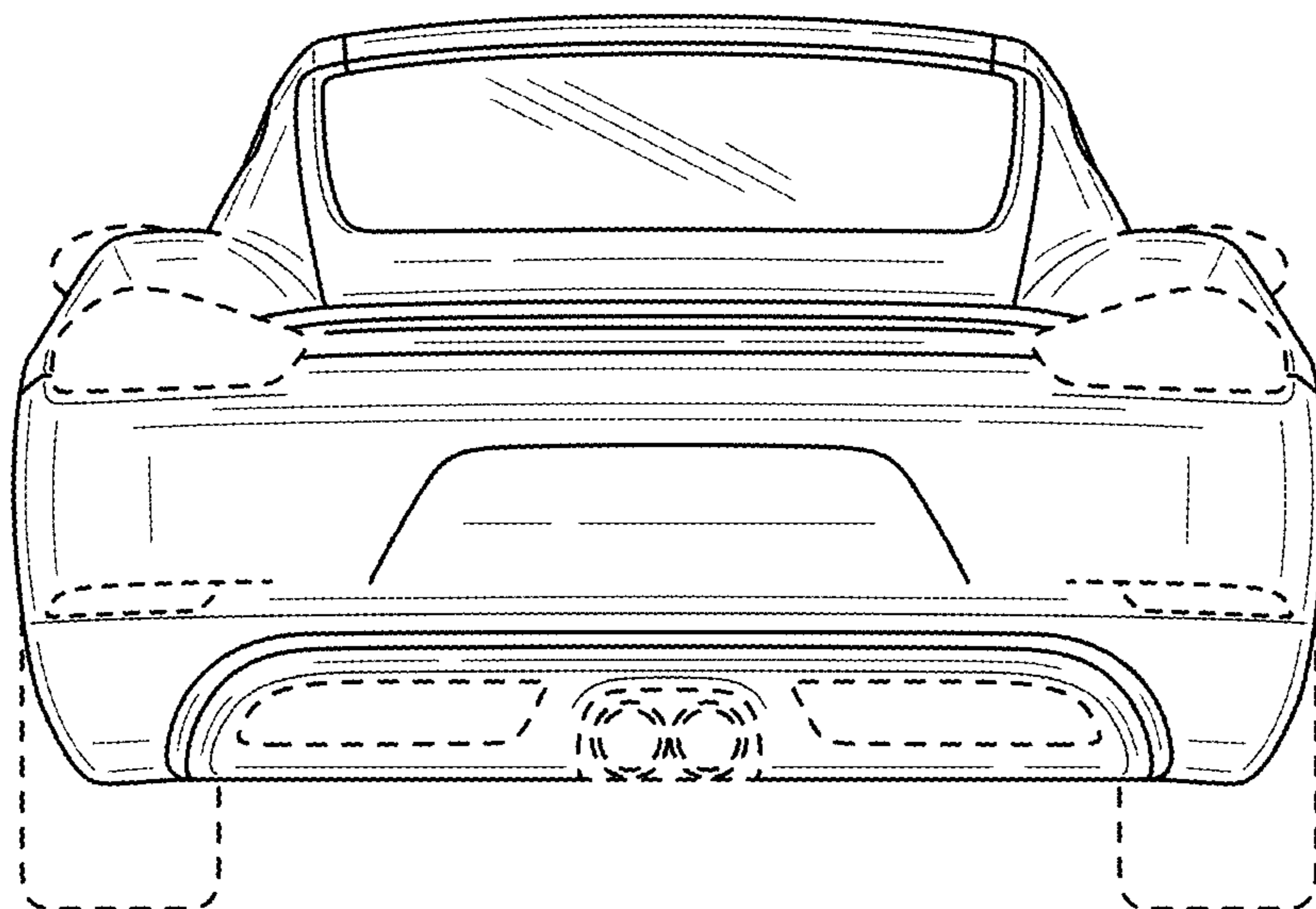

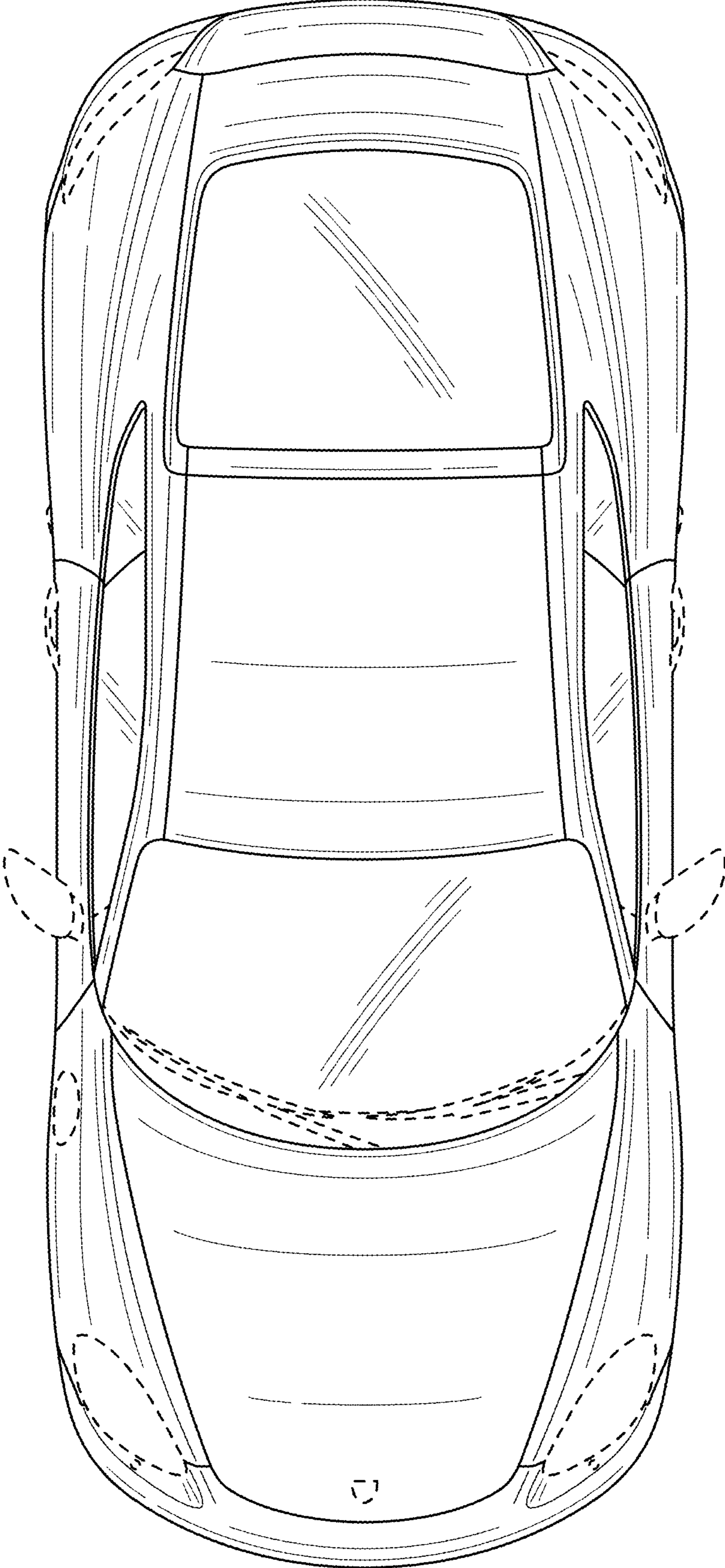
