FIG. 8 is a rear-outside perspective view thereof.
The inside surfaces of the front fender, shown in broken
lines in FIGS. 2 to 7, form no part of the claimed design
since the inside surfaces are hidden when the front fender is
mounted to the automobile. The broken lines shown in
FIGS. 2 to 7 are for the purpose of illustrating unclaimed
portions of the front fender for automobile, and form no part
of the claimed design.

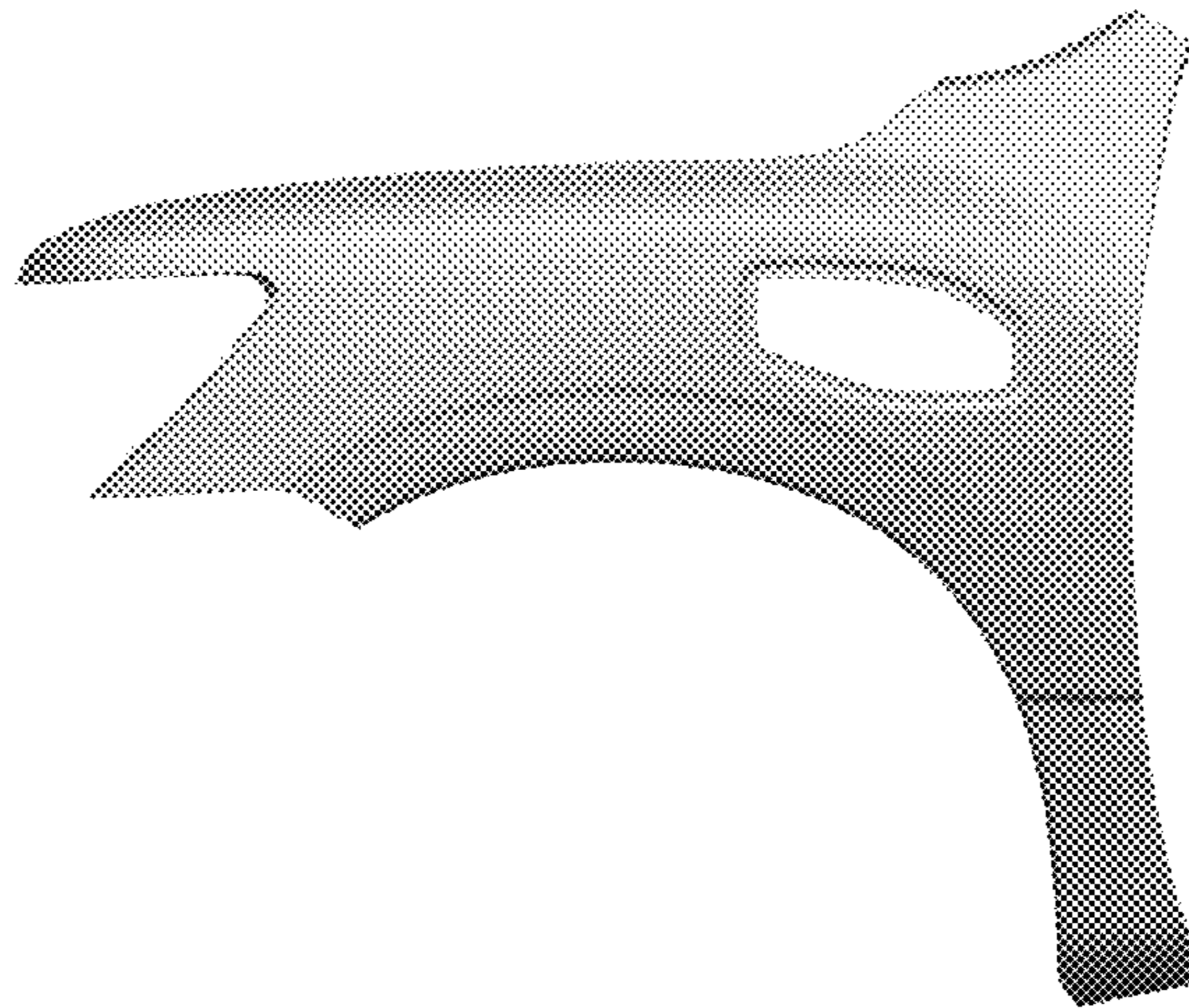

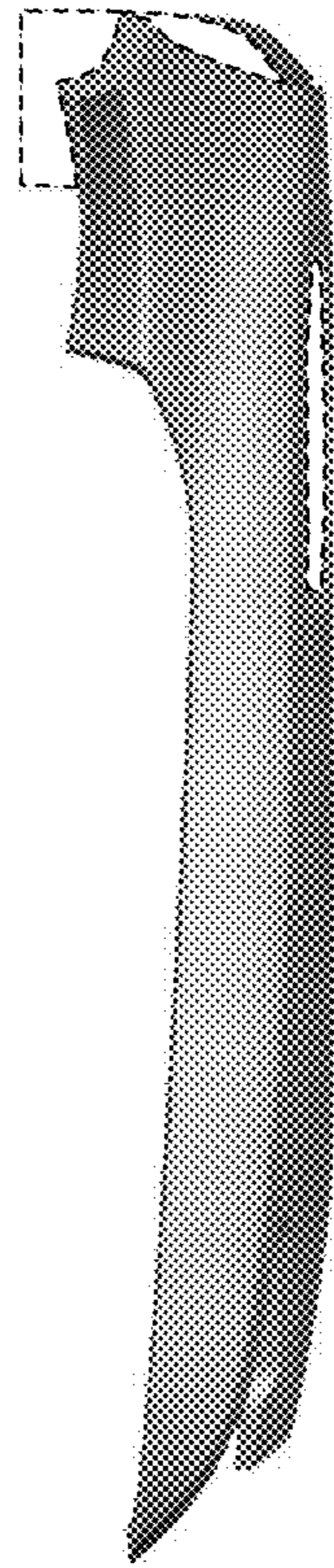

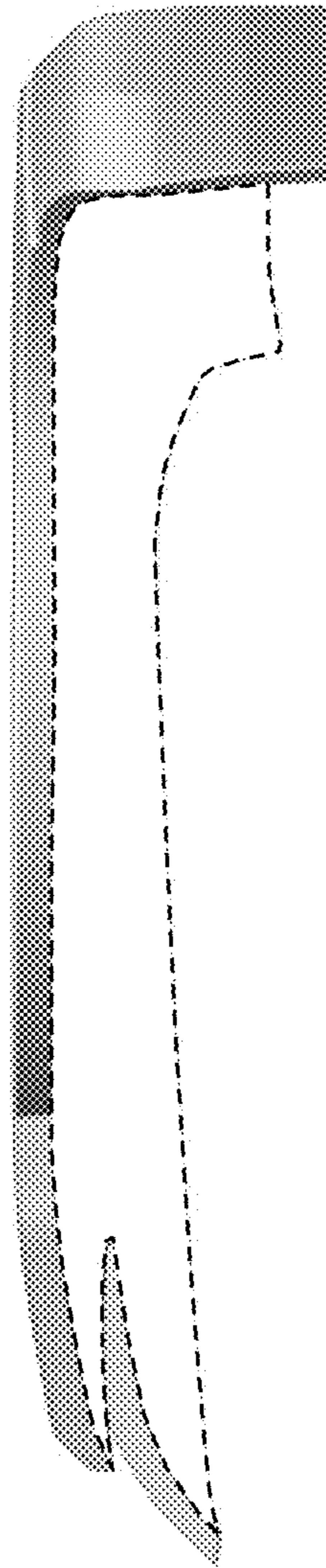

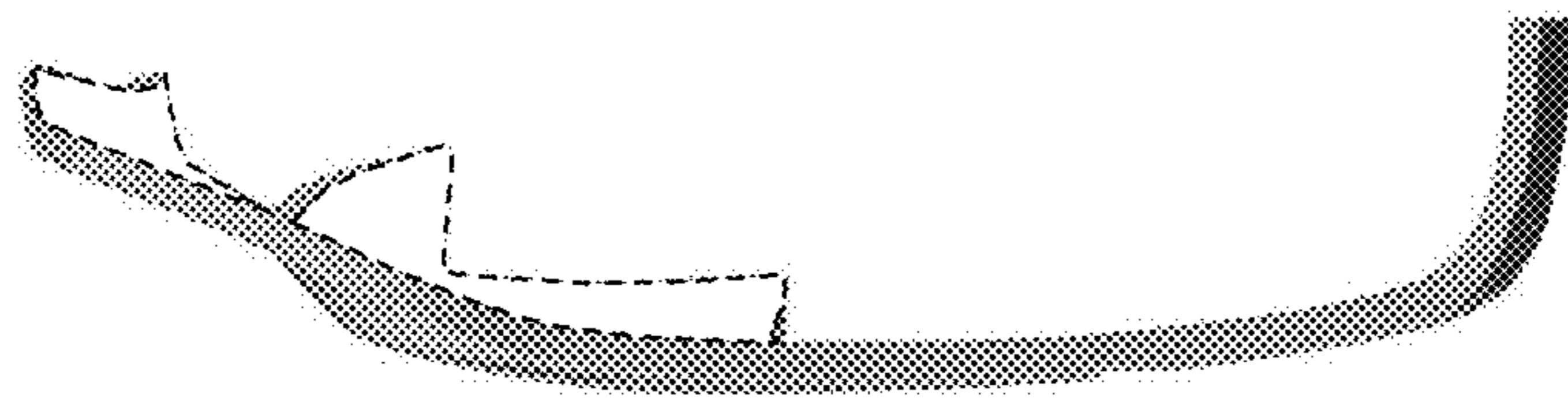

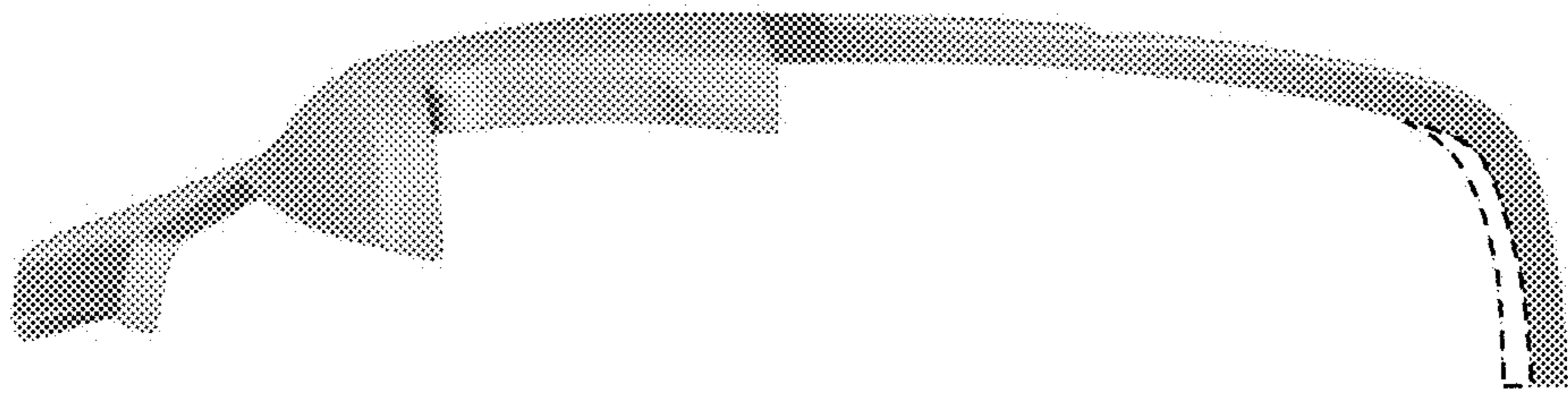

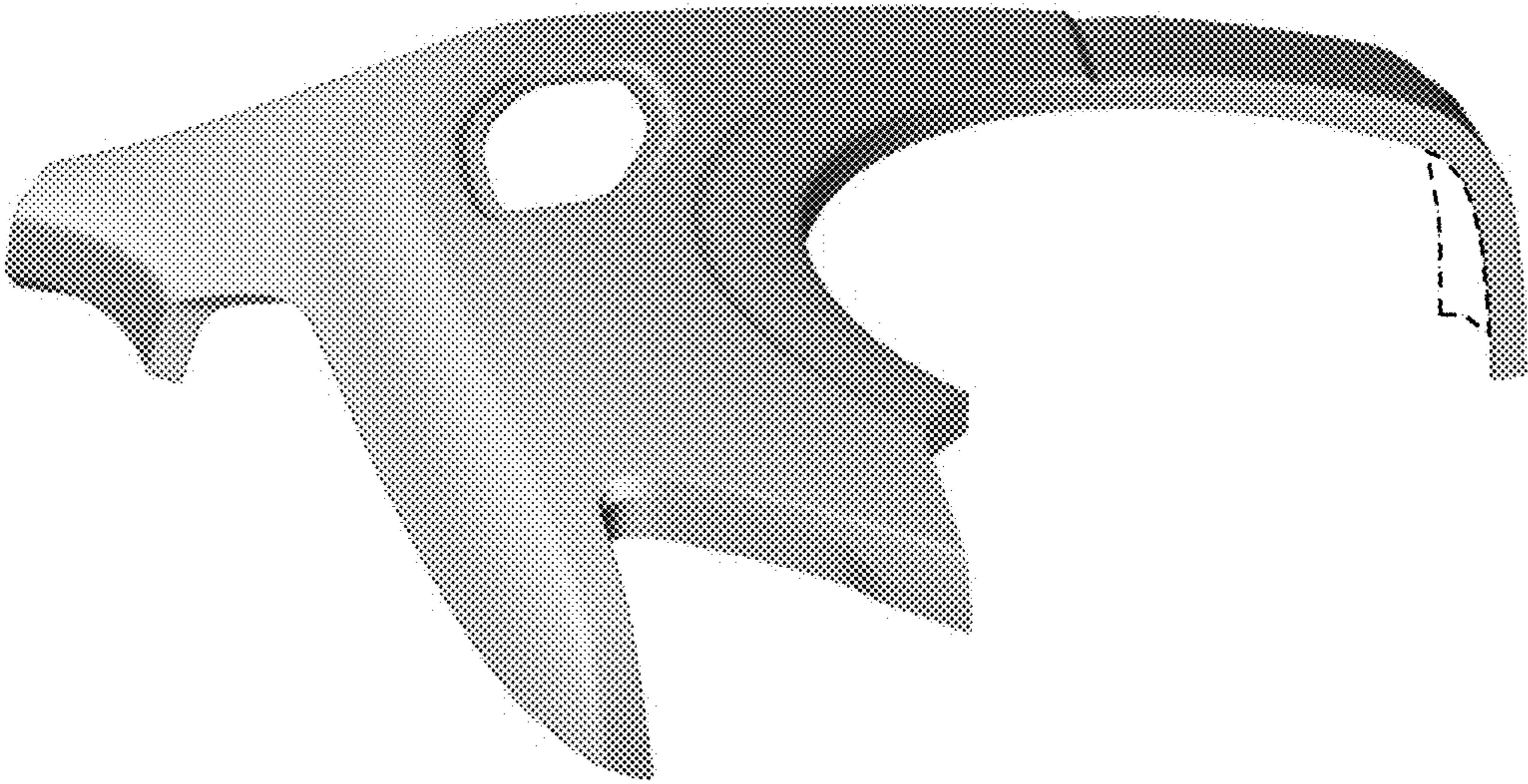

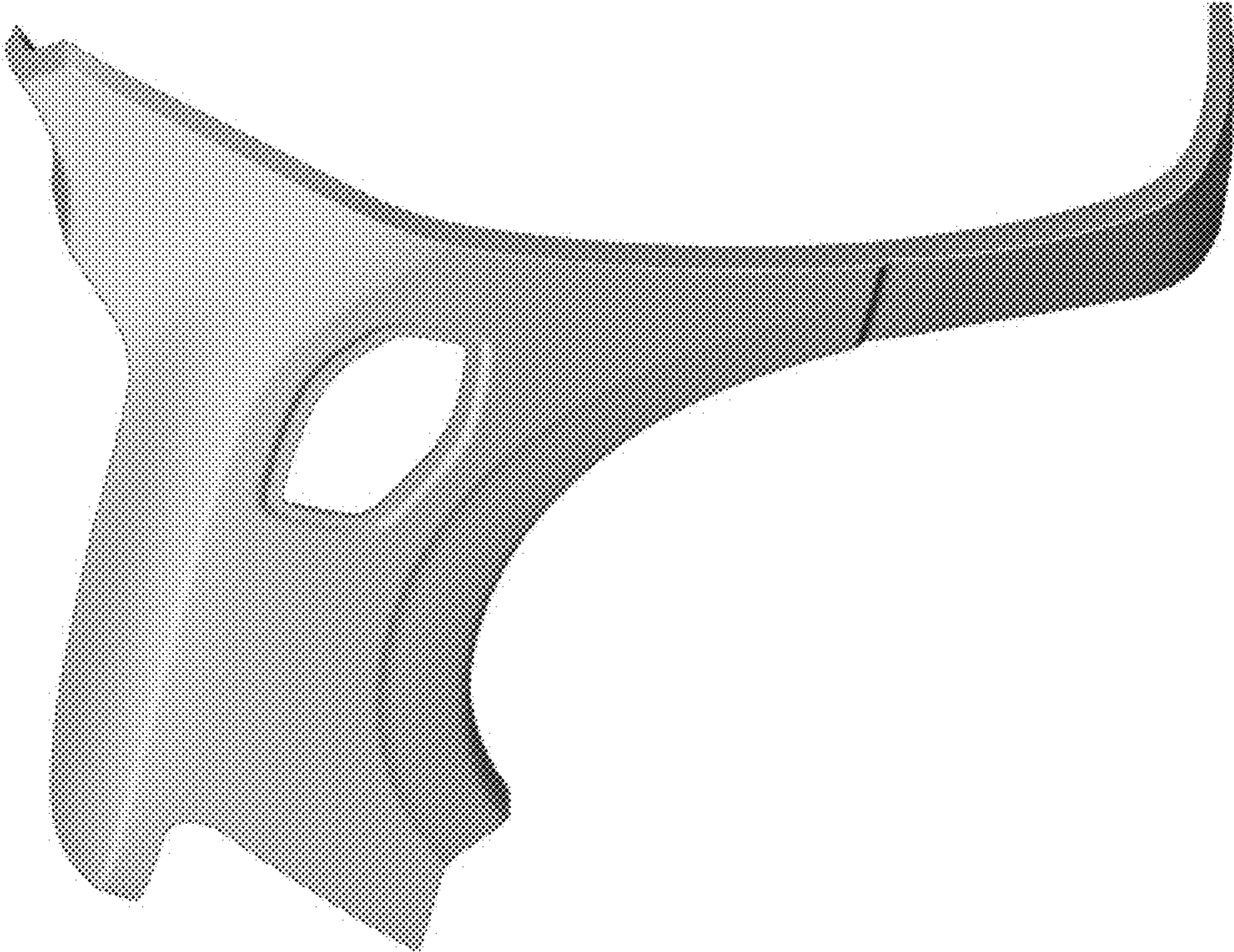
