FIG. 4 is a top view of the kayak.

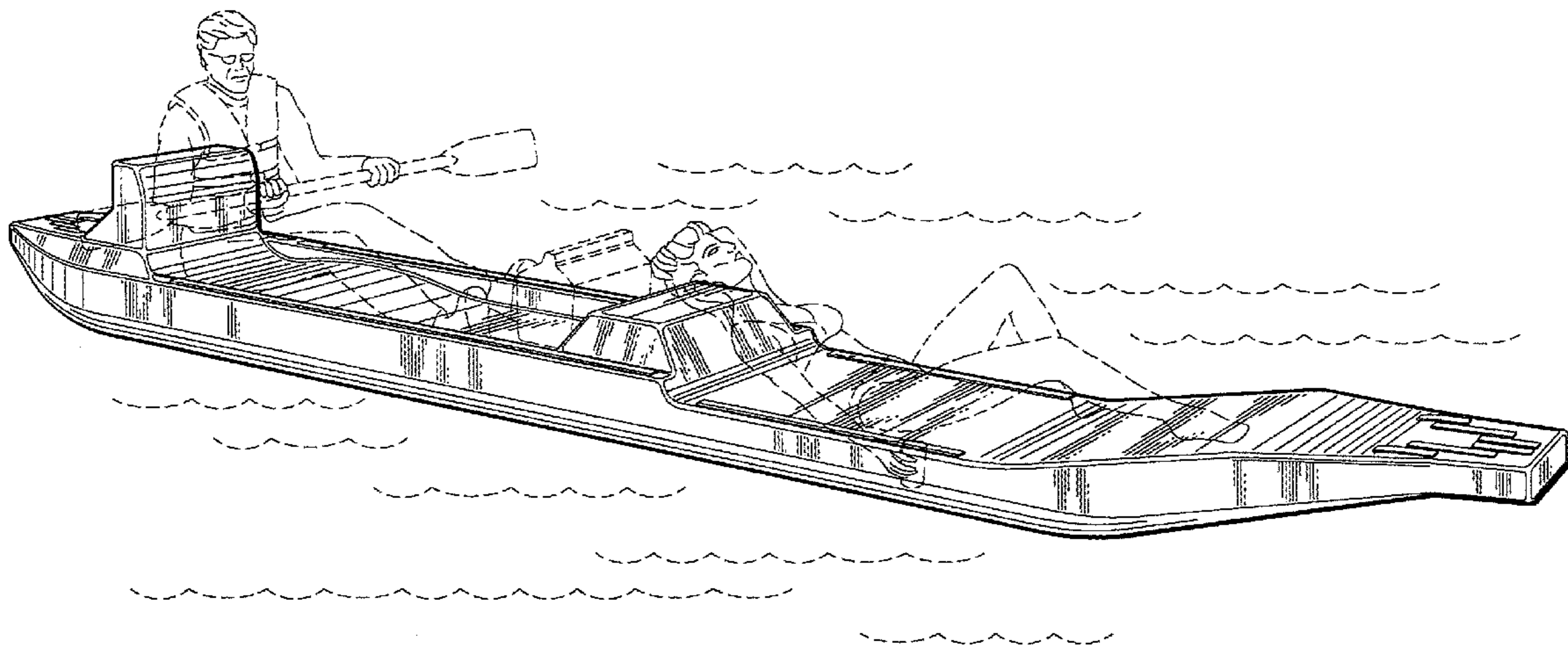
FIG. 5 is a bottom view of the kayak.

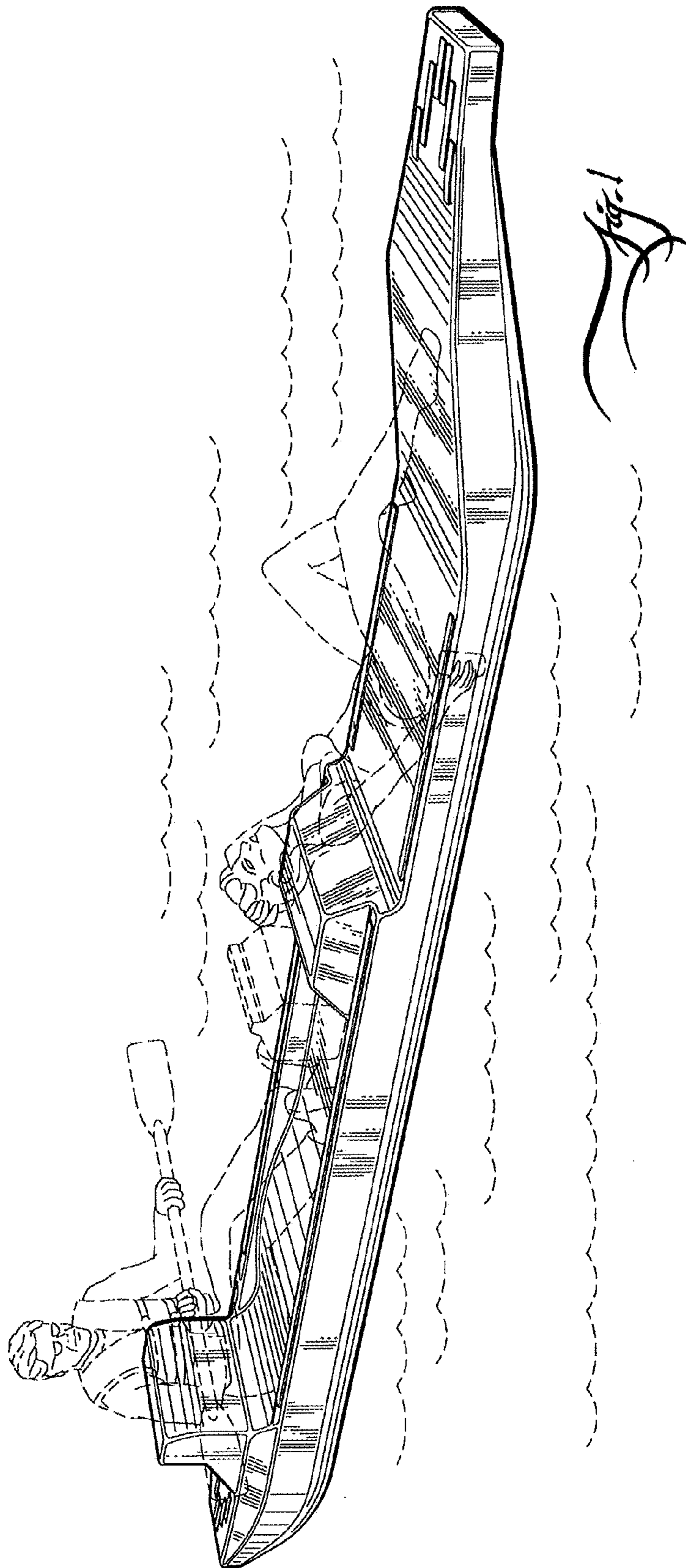
FIG. 6 is a front view of the kayak; and,

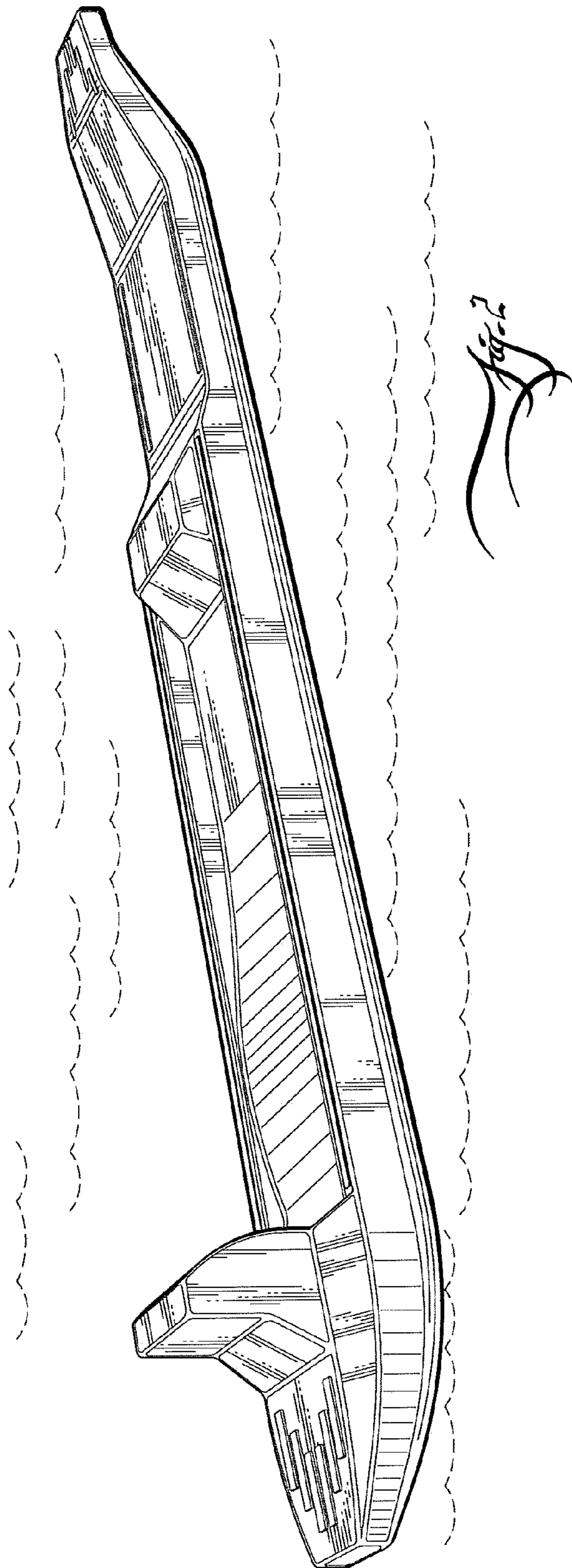
FIG. 7 is a rear view of the kayak.

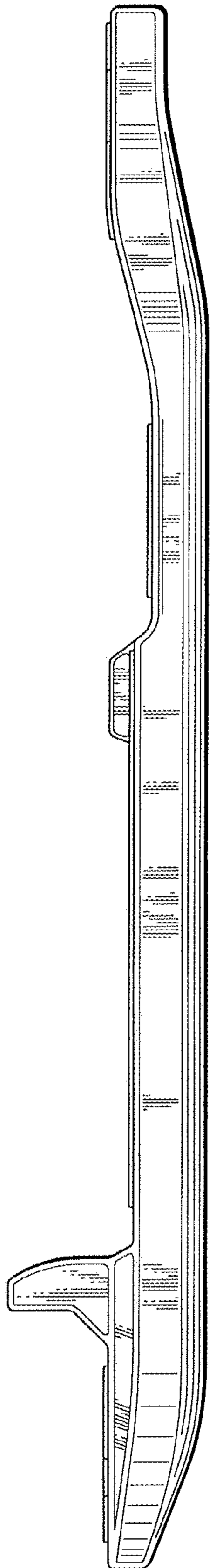

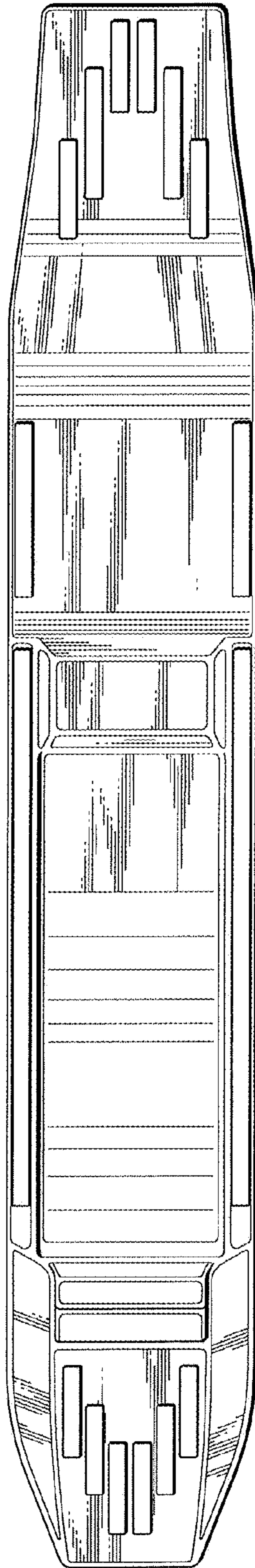




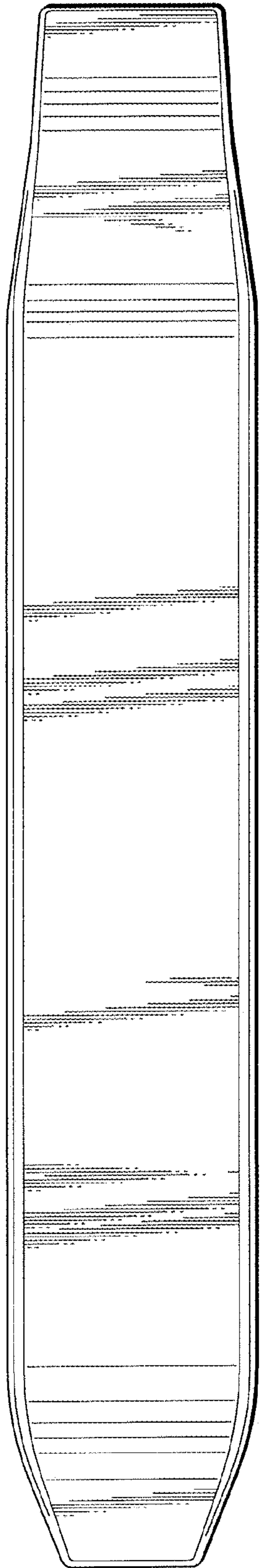




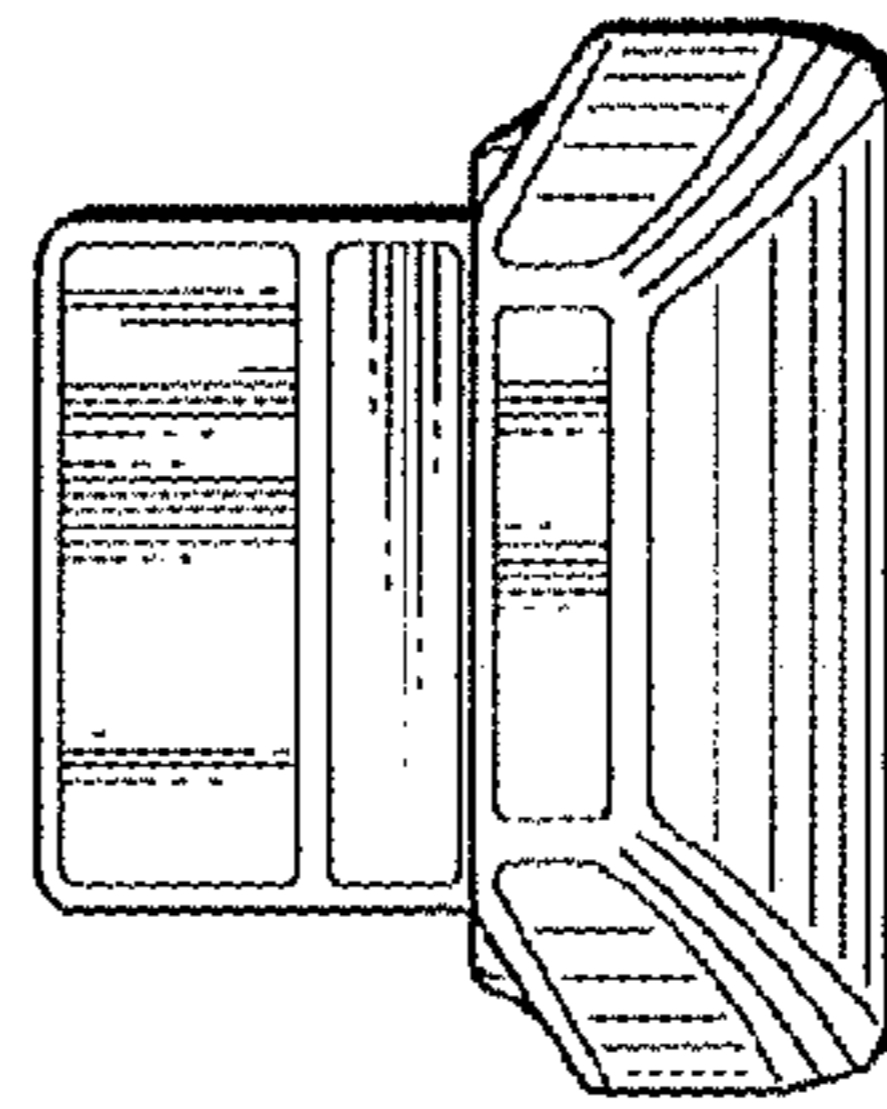

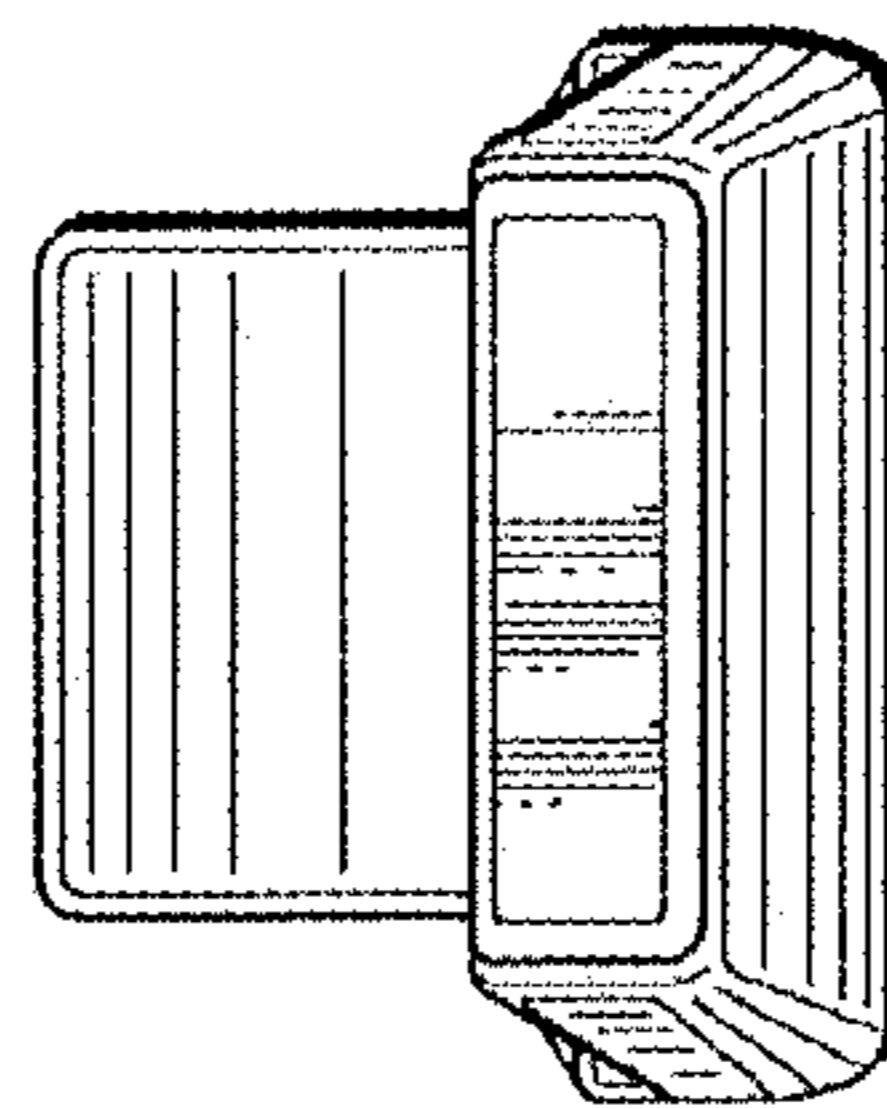
