DESCRIPTION

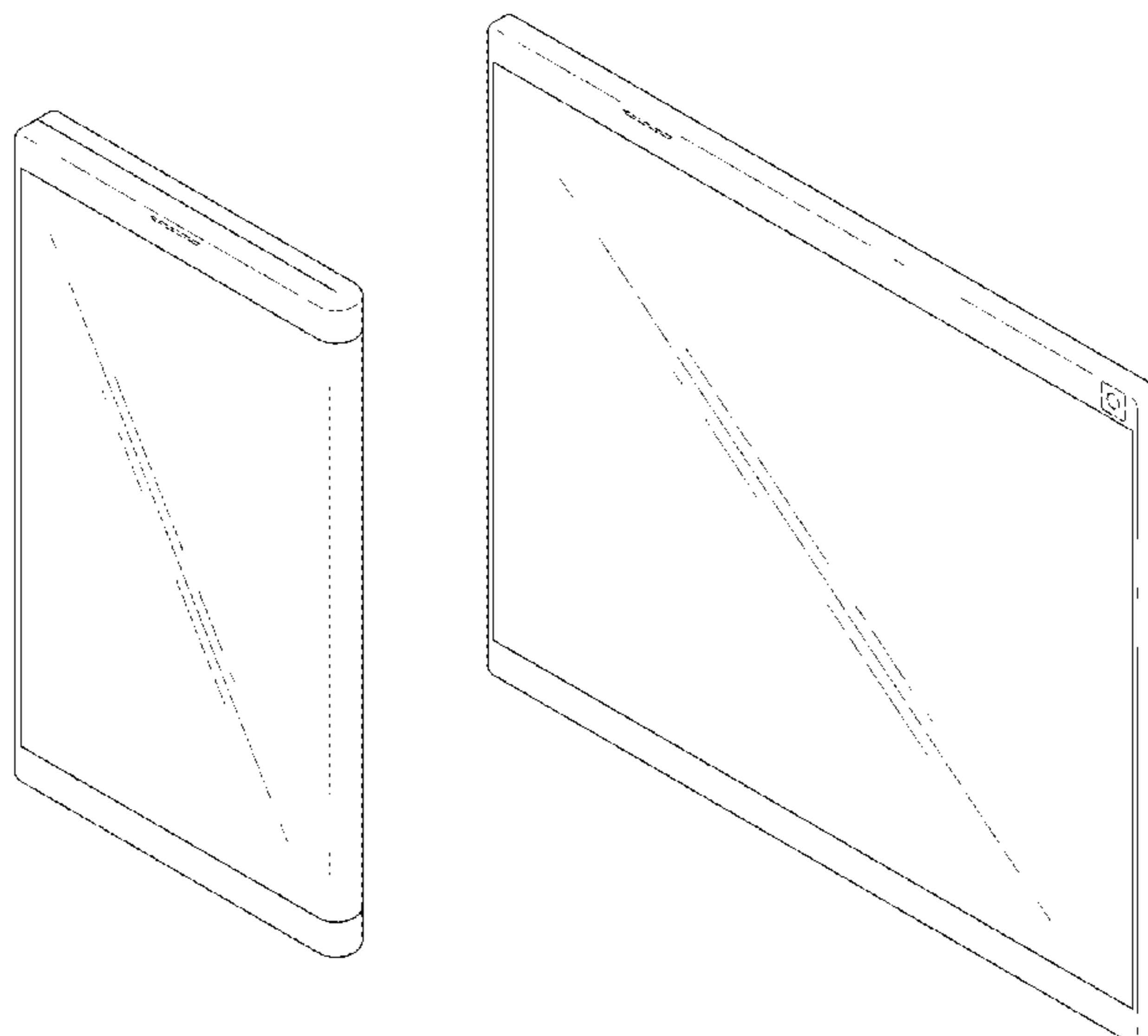
FIG. 1 is a front, right side, perspective view of a cellular phone showing our new design;

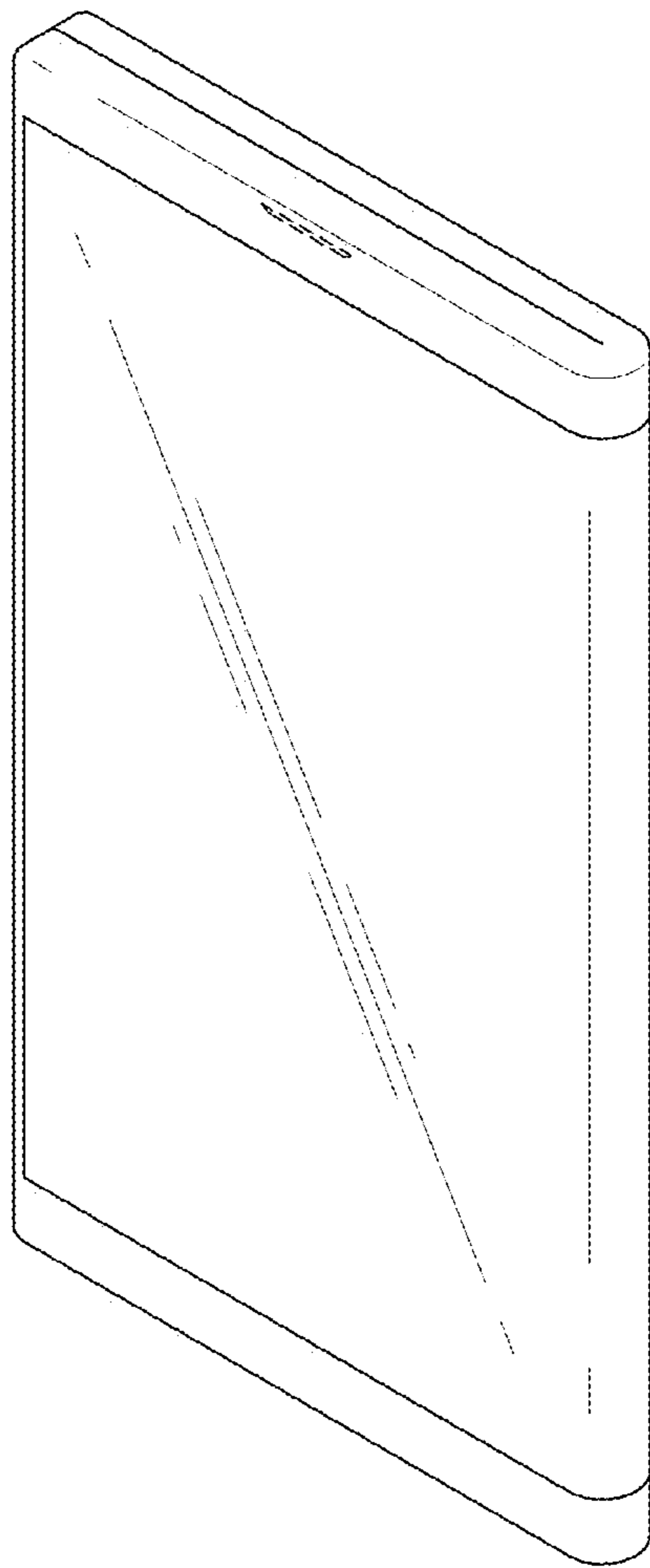

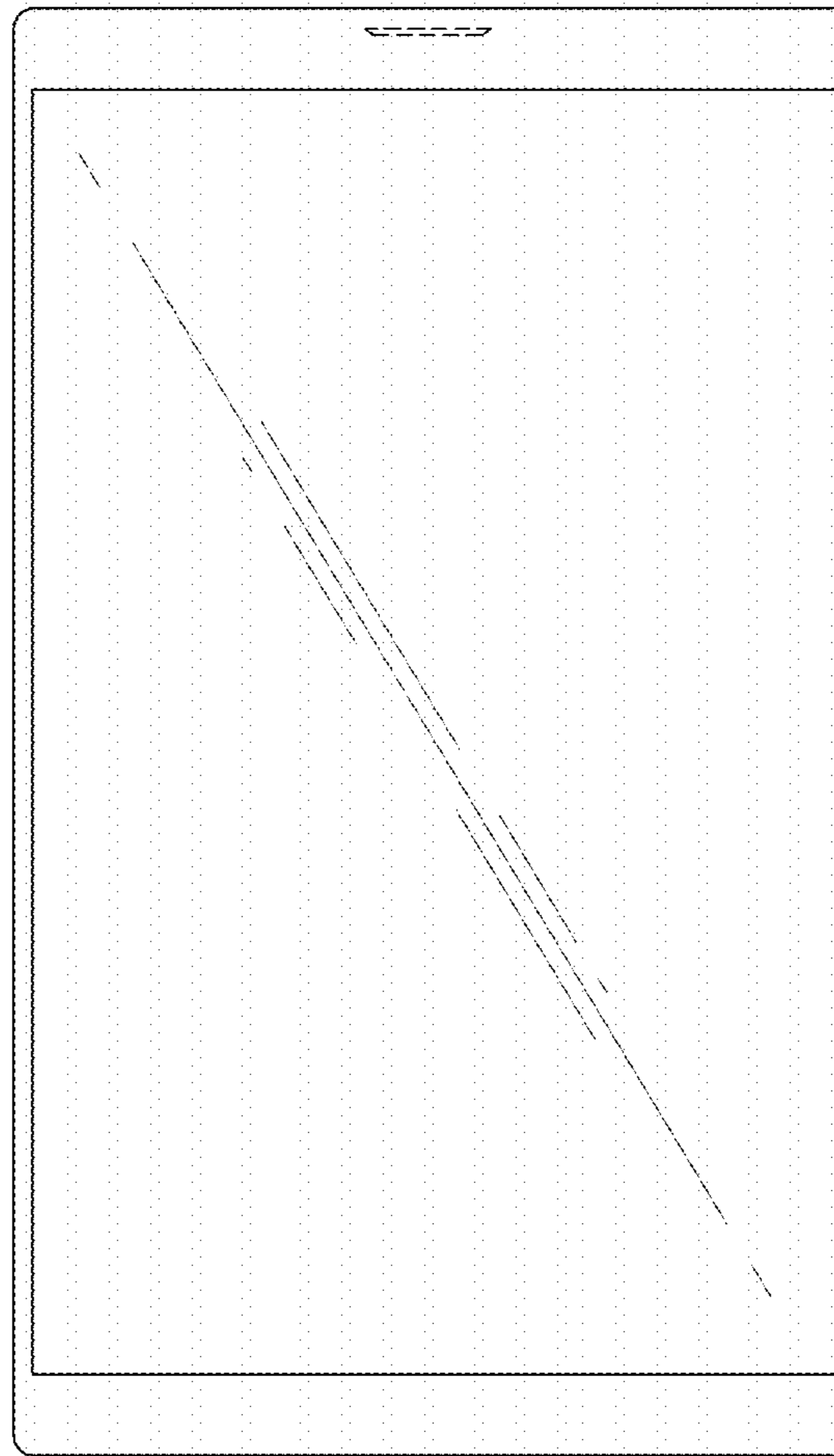

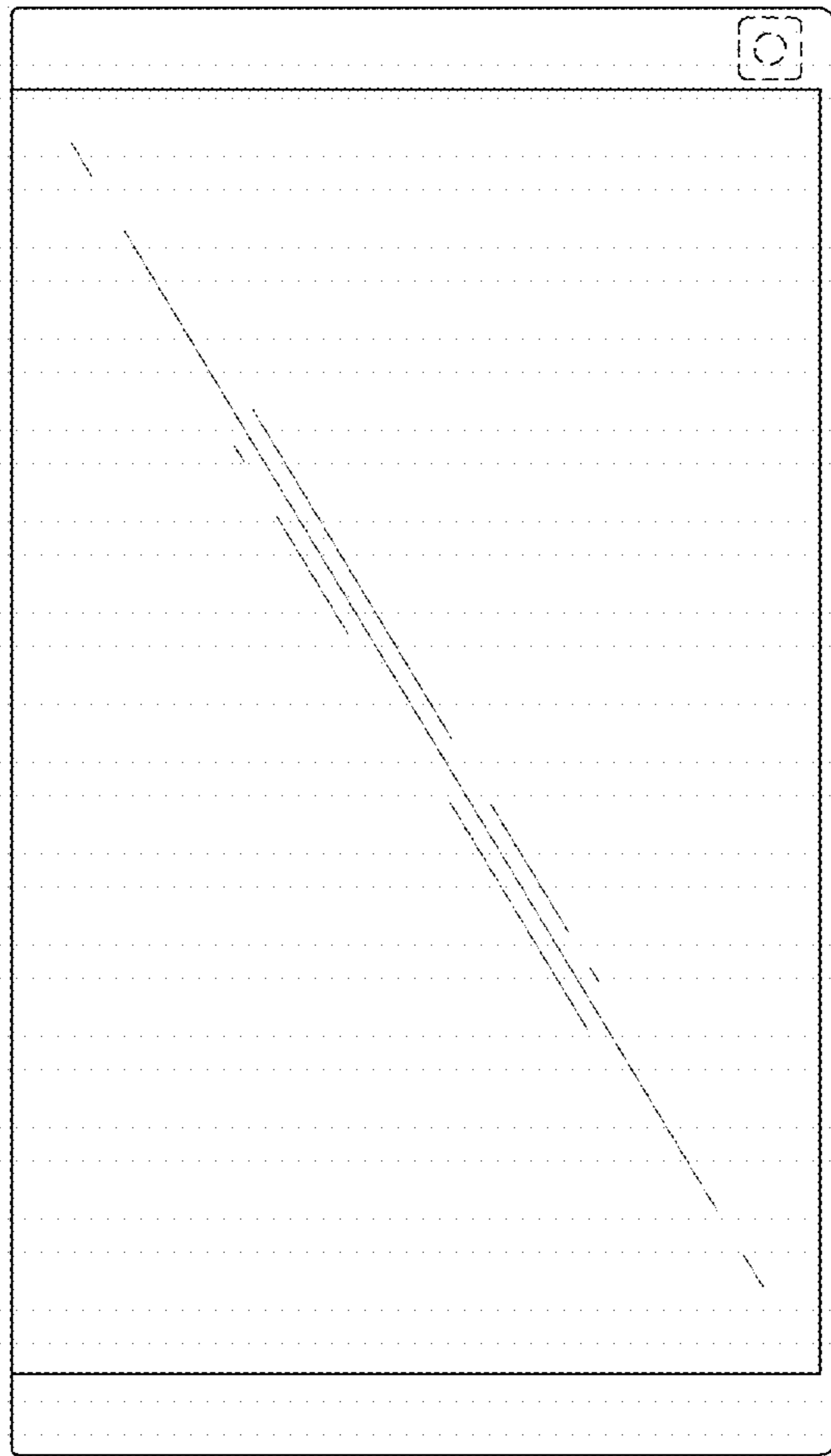

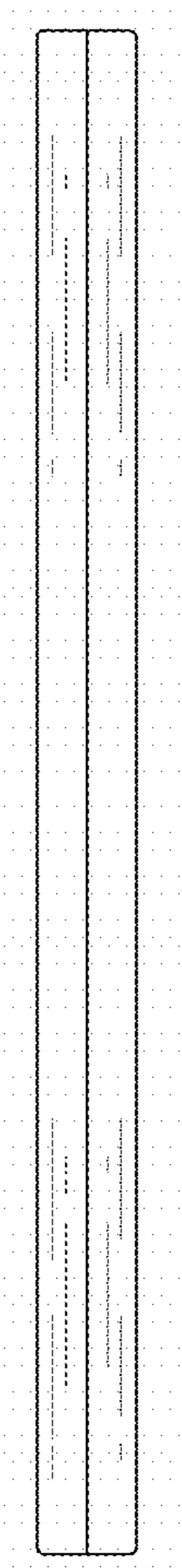

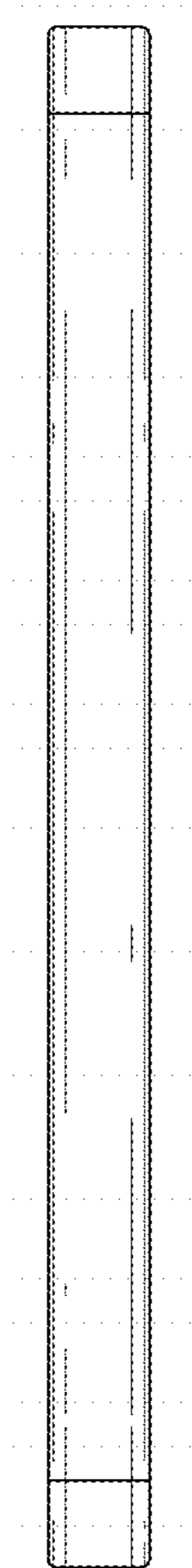

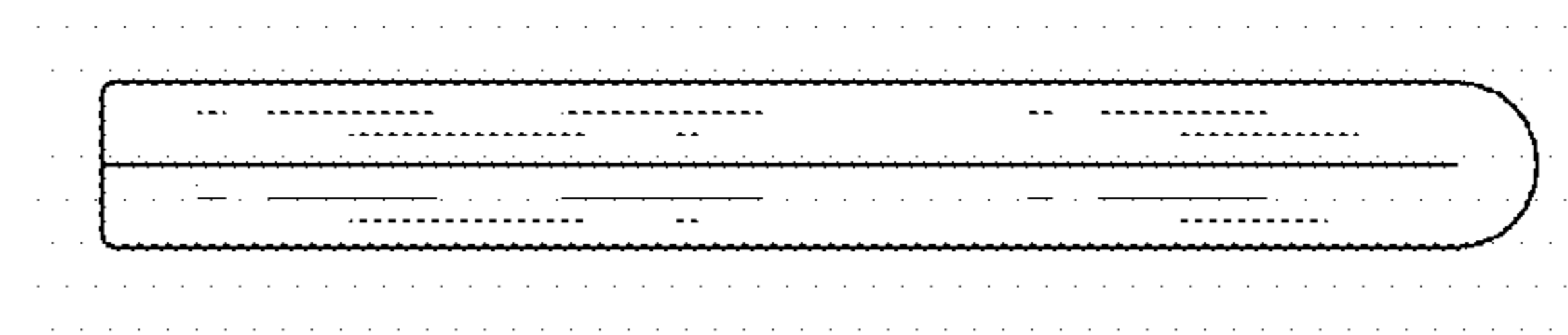

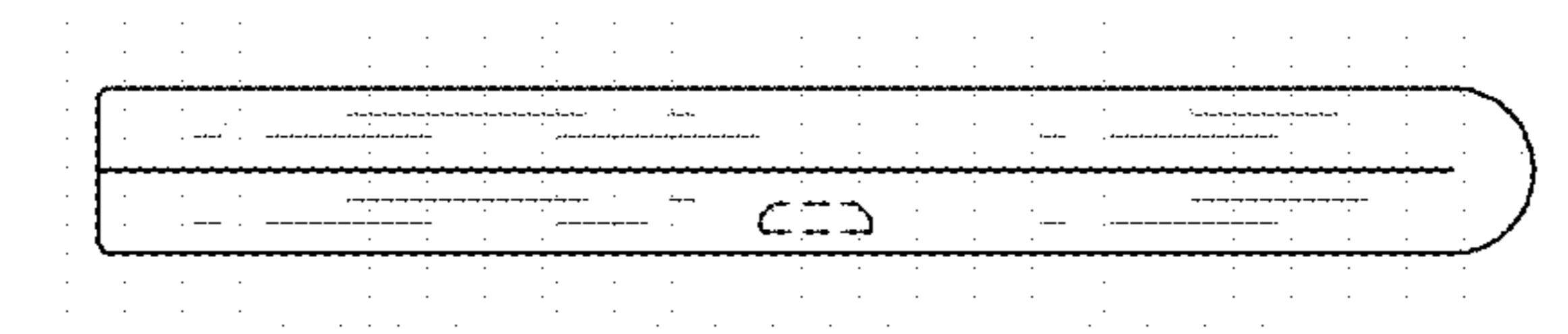

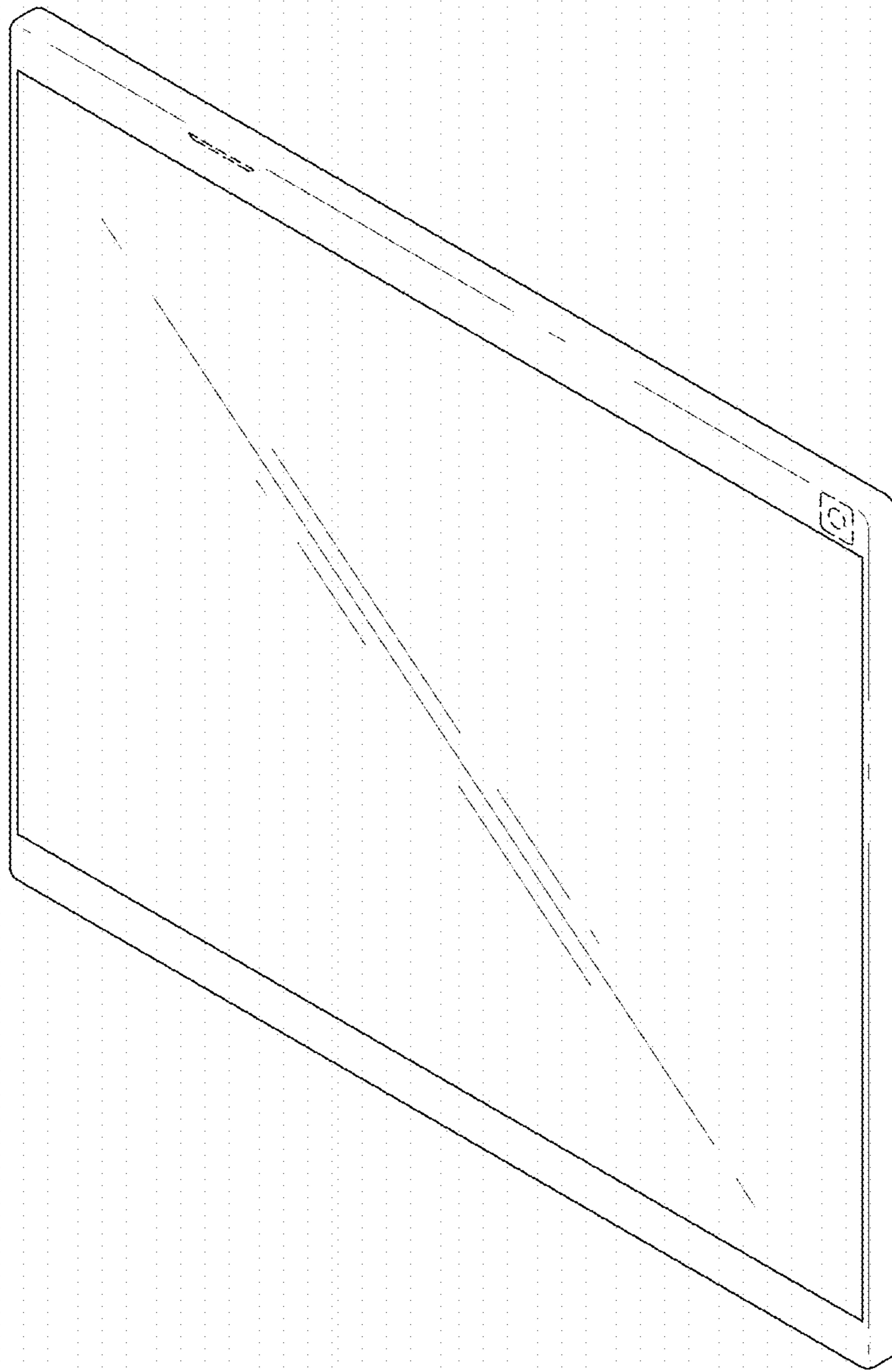

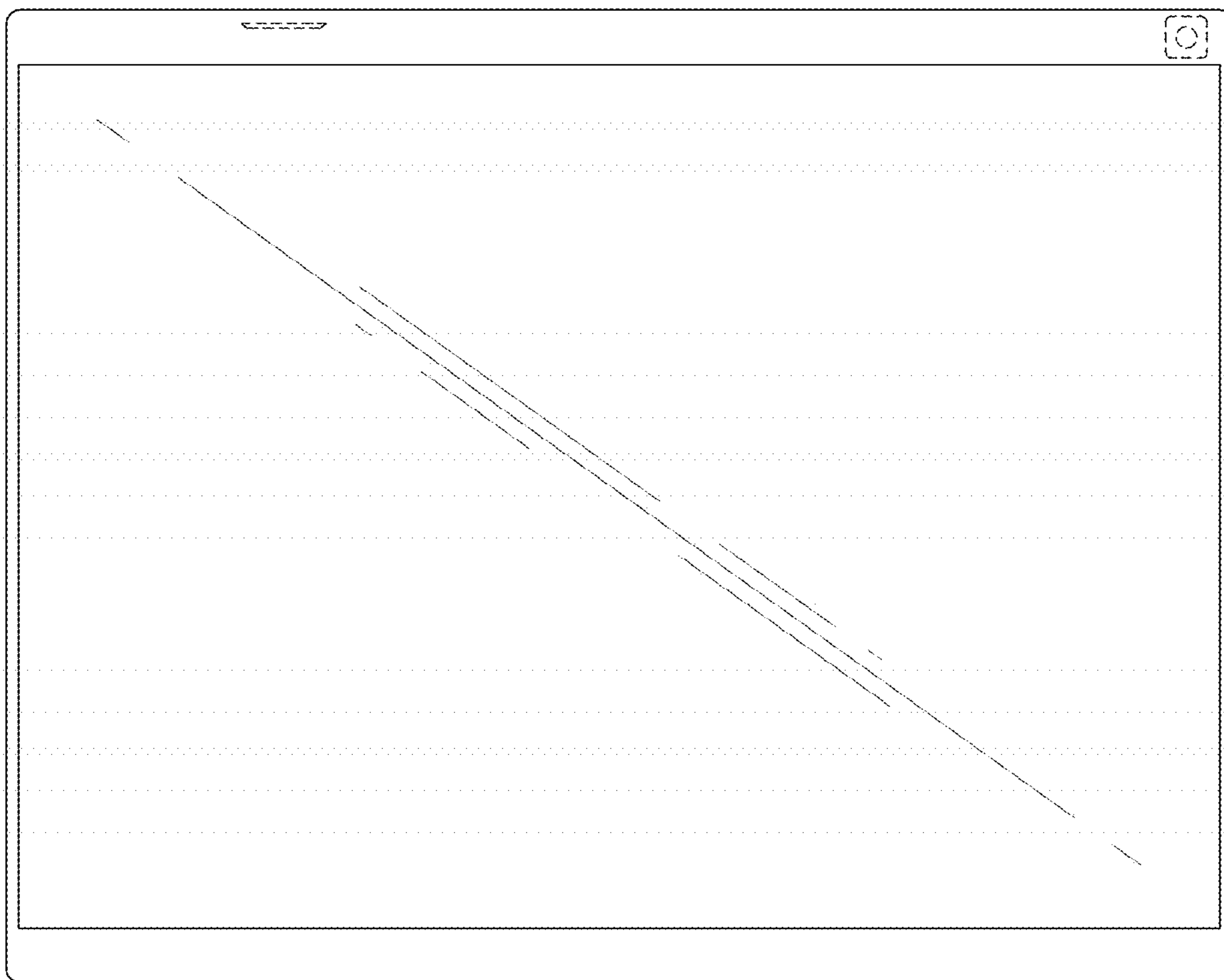

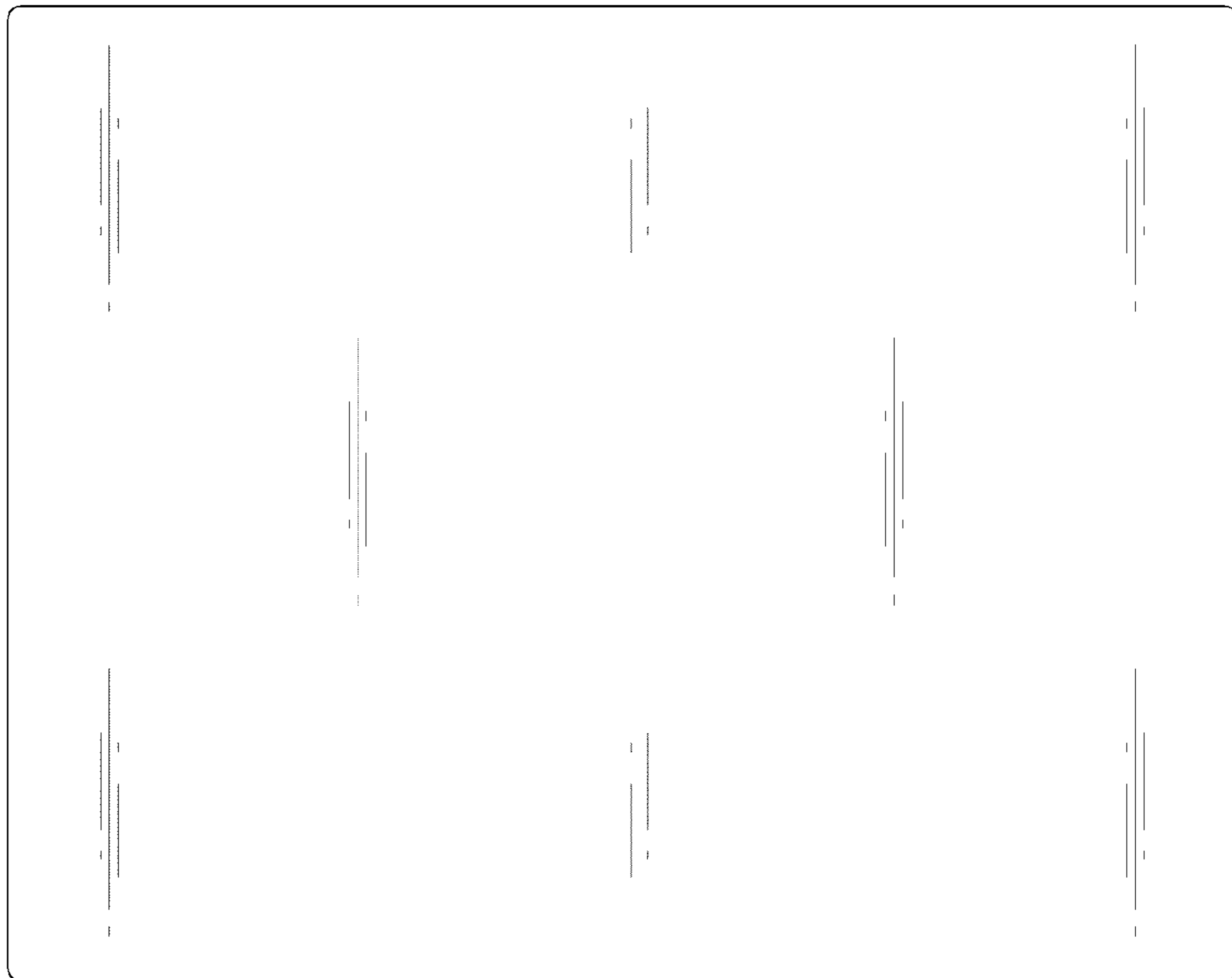

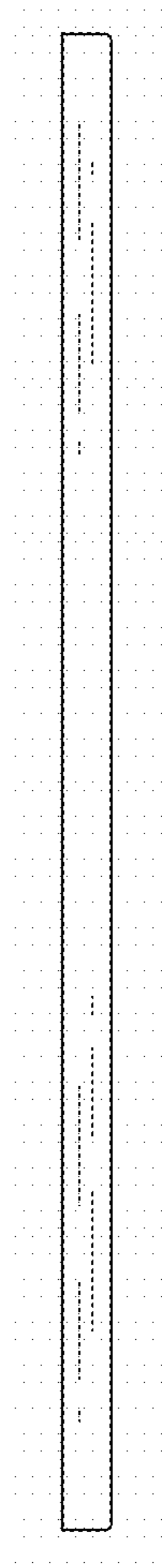

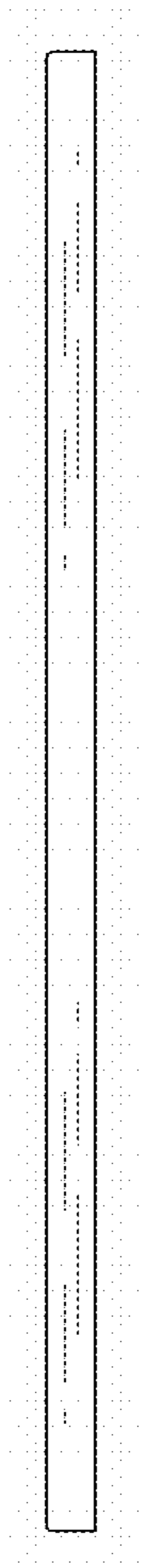

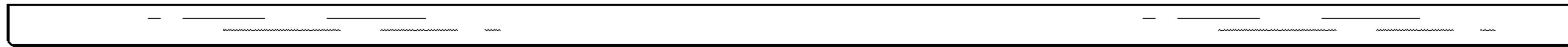
