FIG. 29 is a front view of a twenty ninth image thereof;

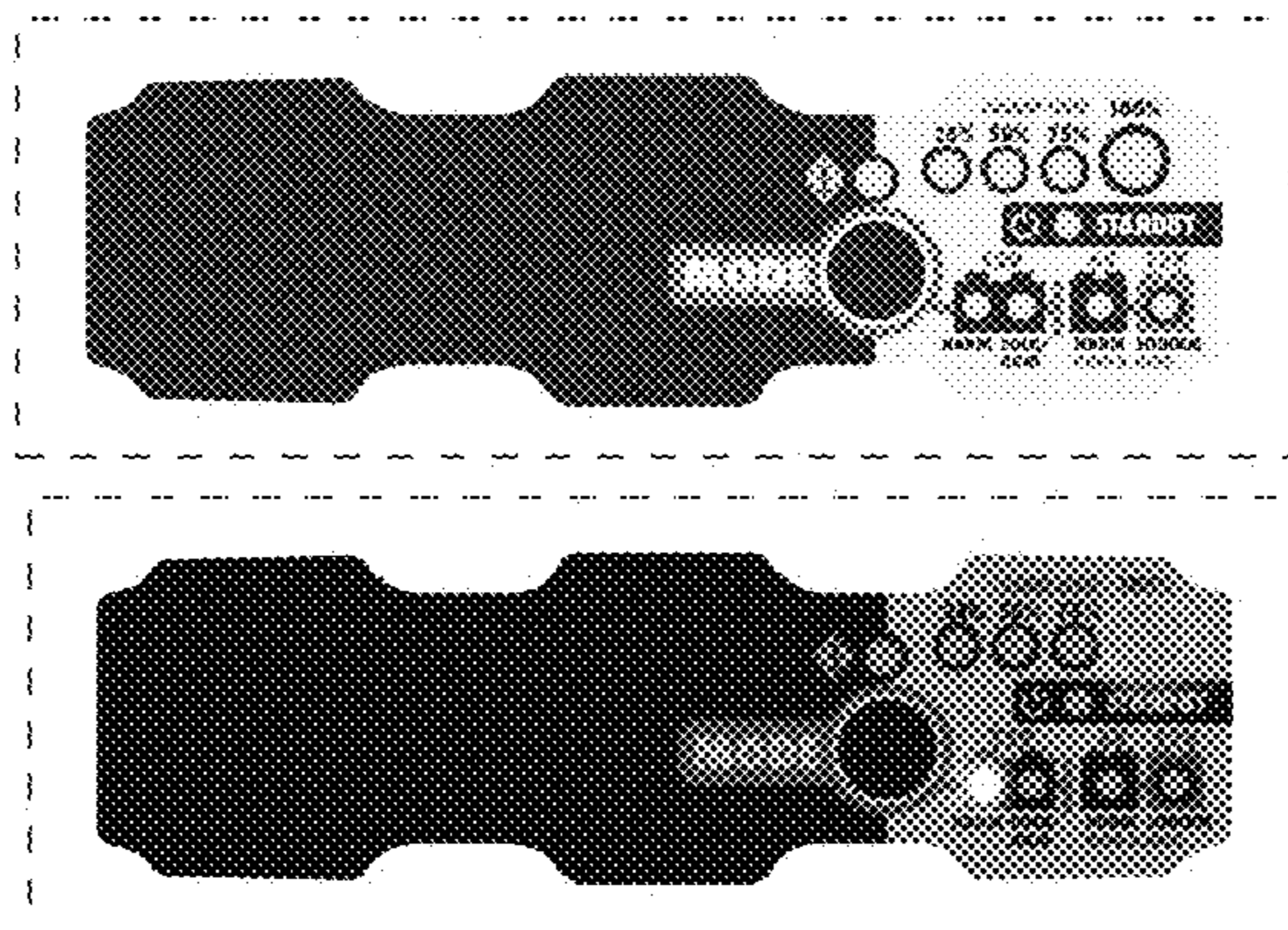
FIG. 30 is a front view of a thirtieth image thereof;

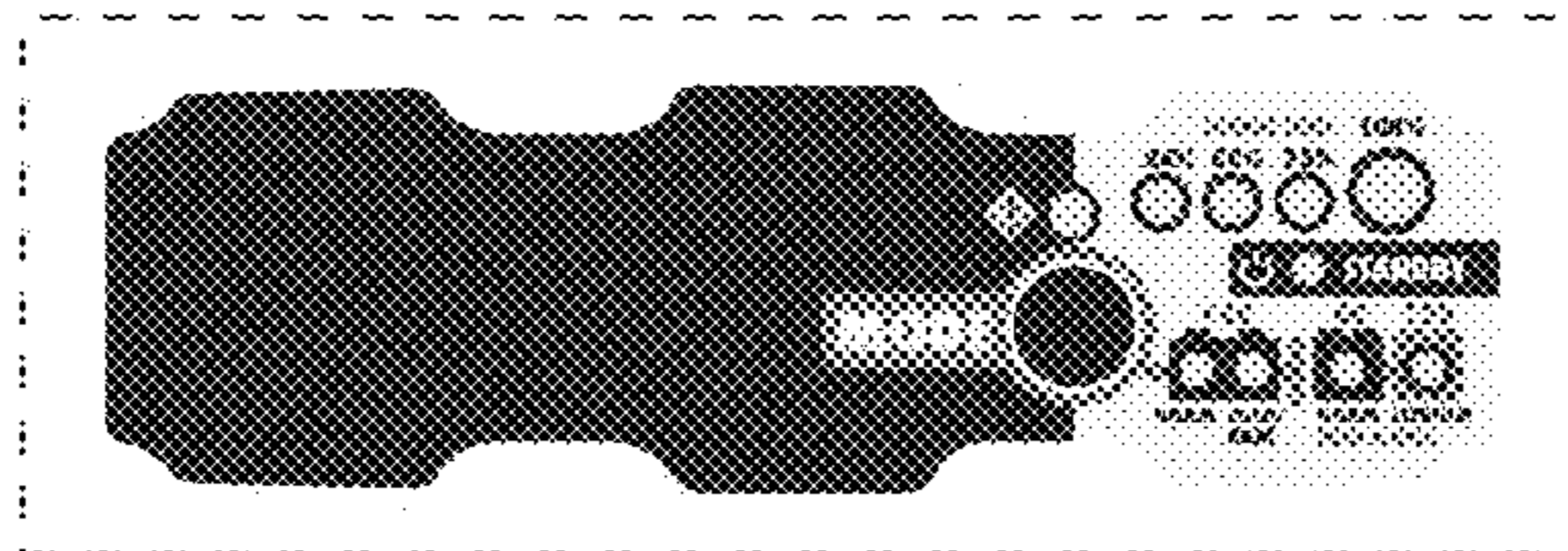

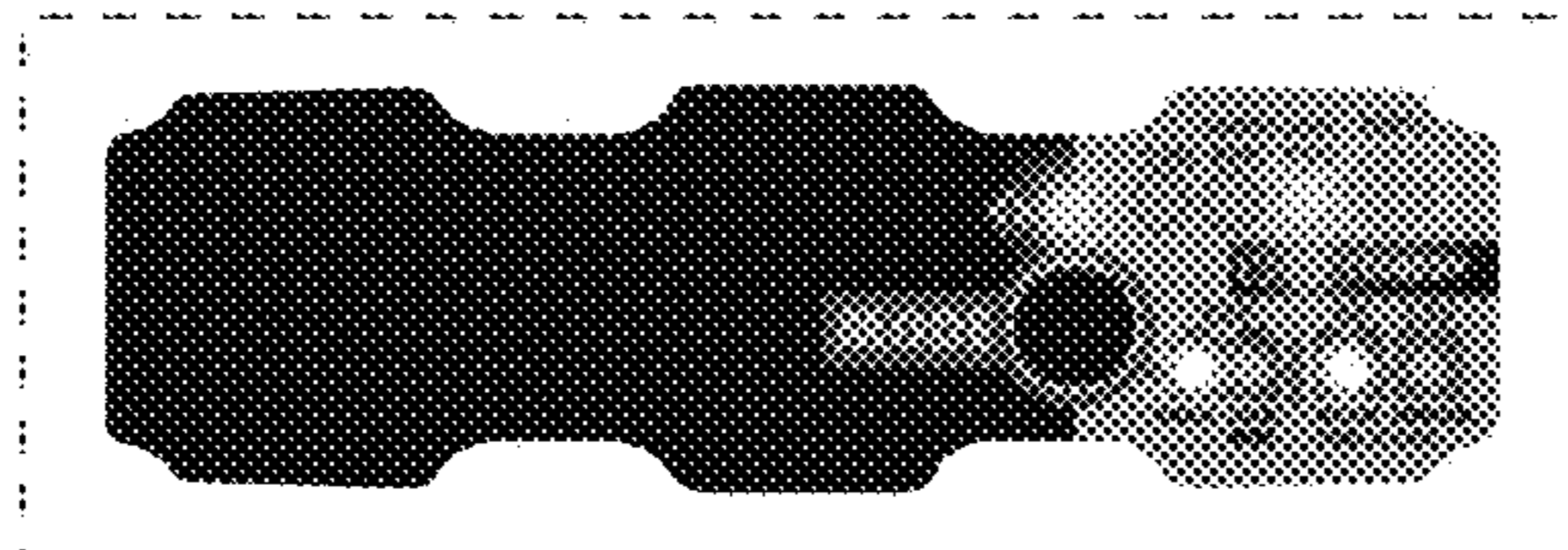

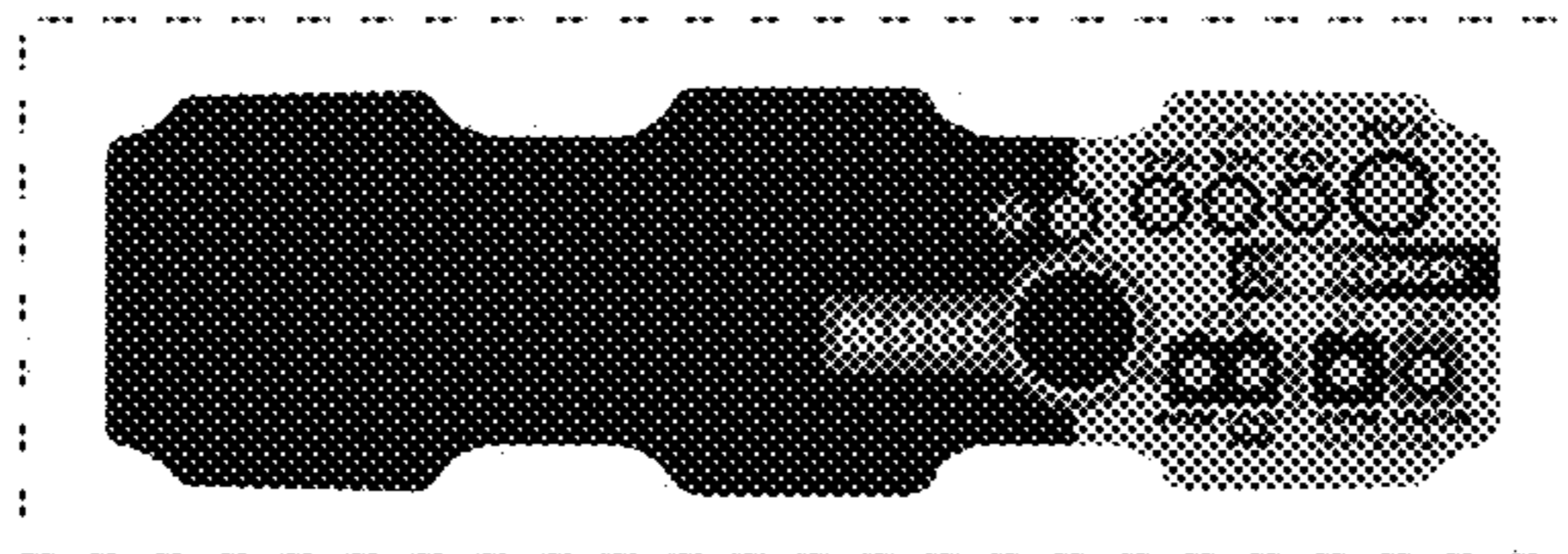

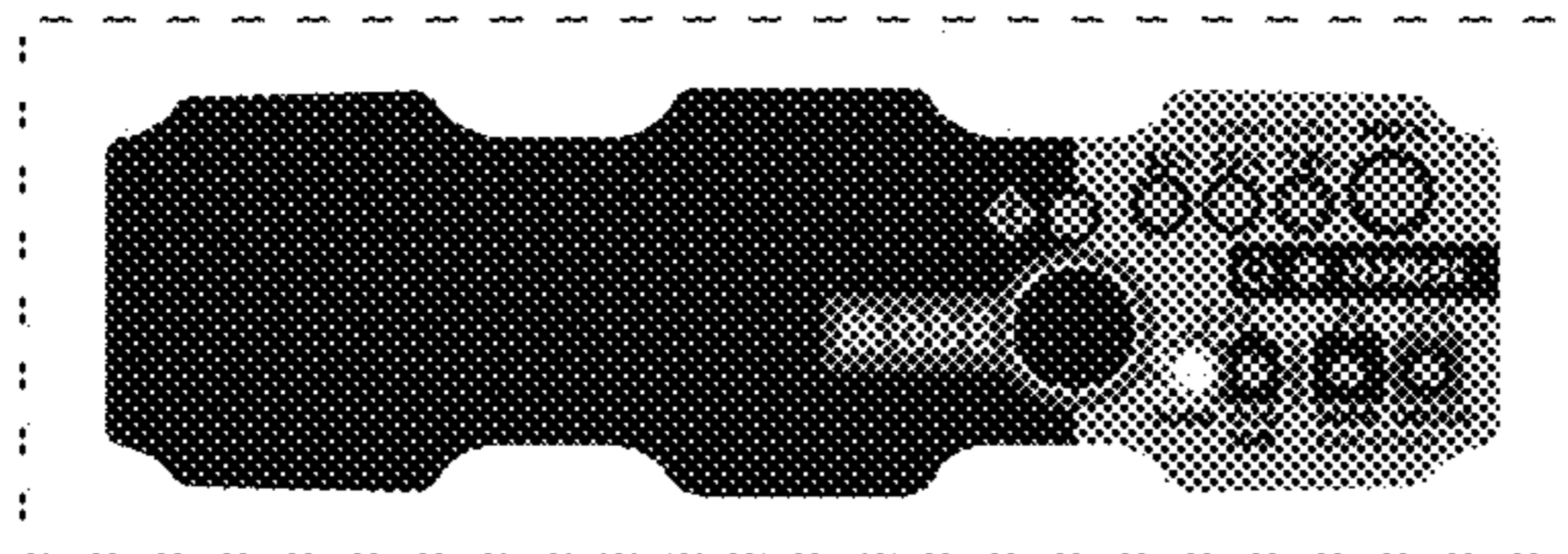

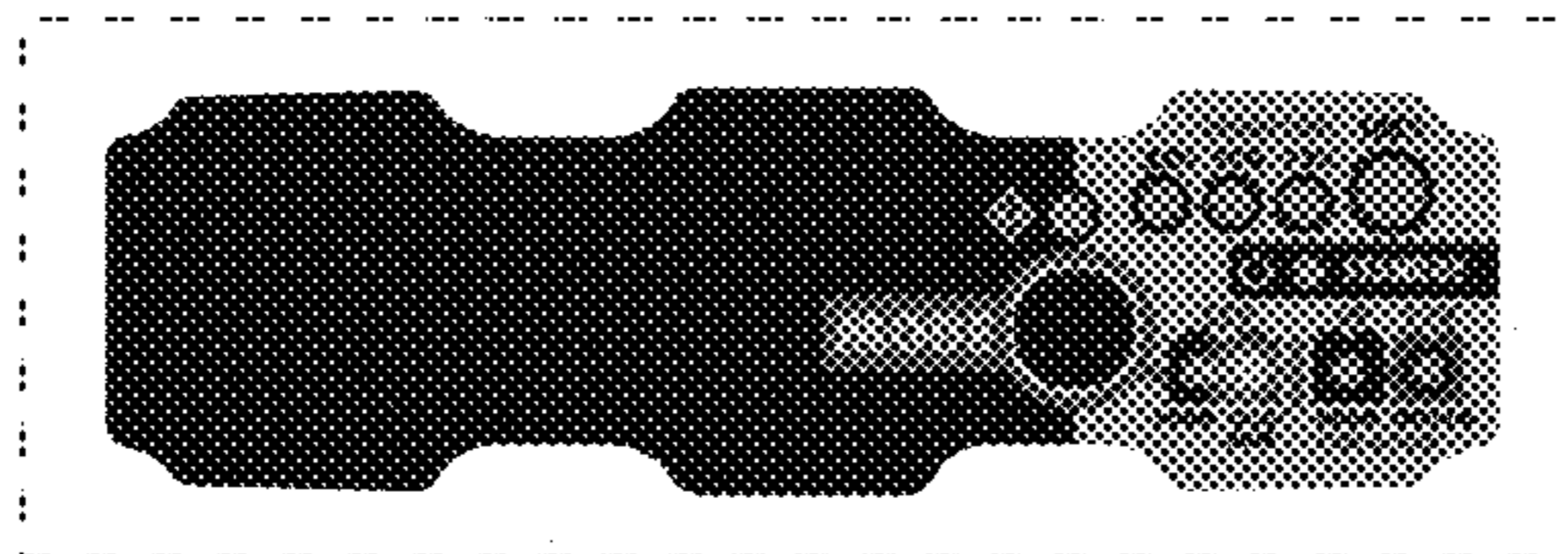

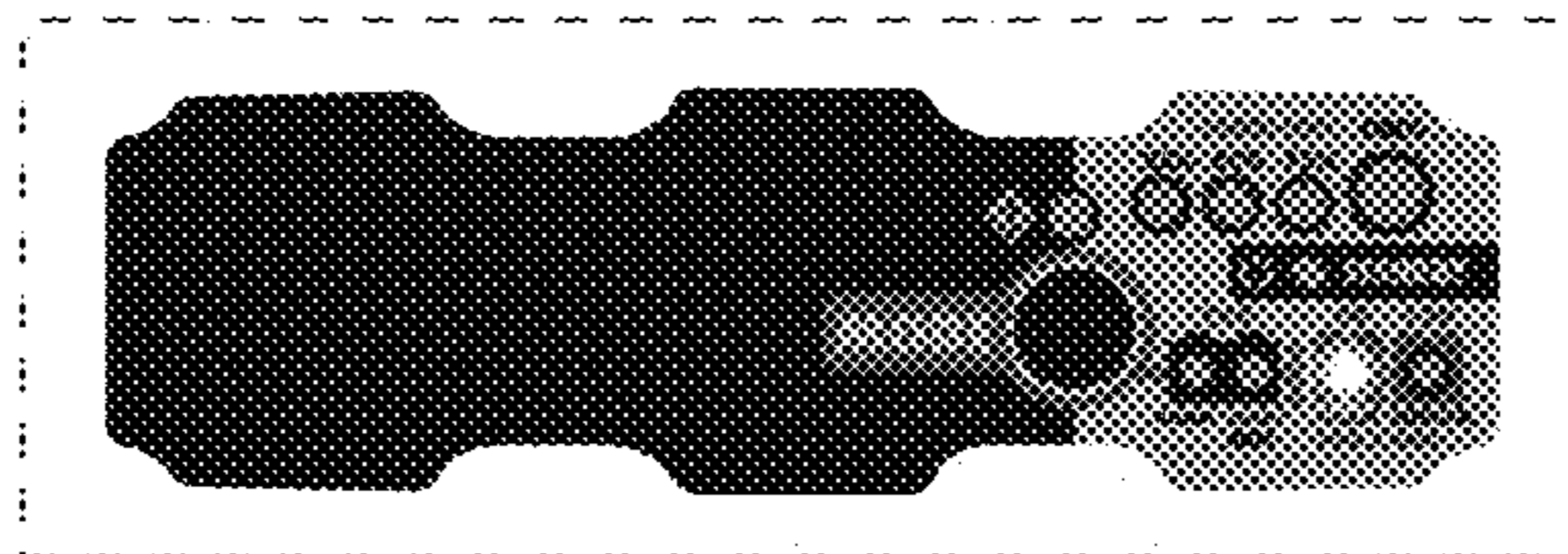

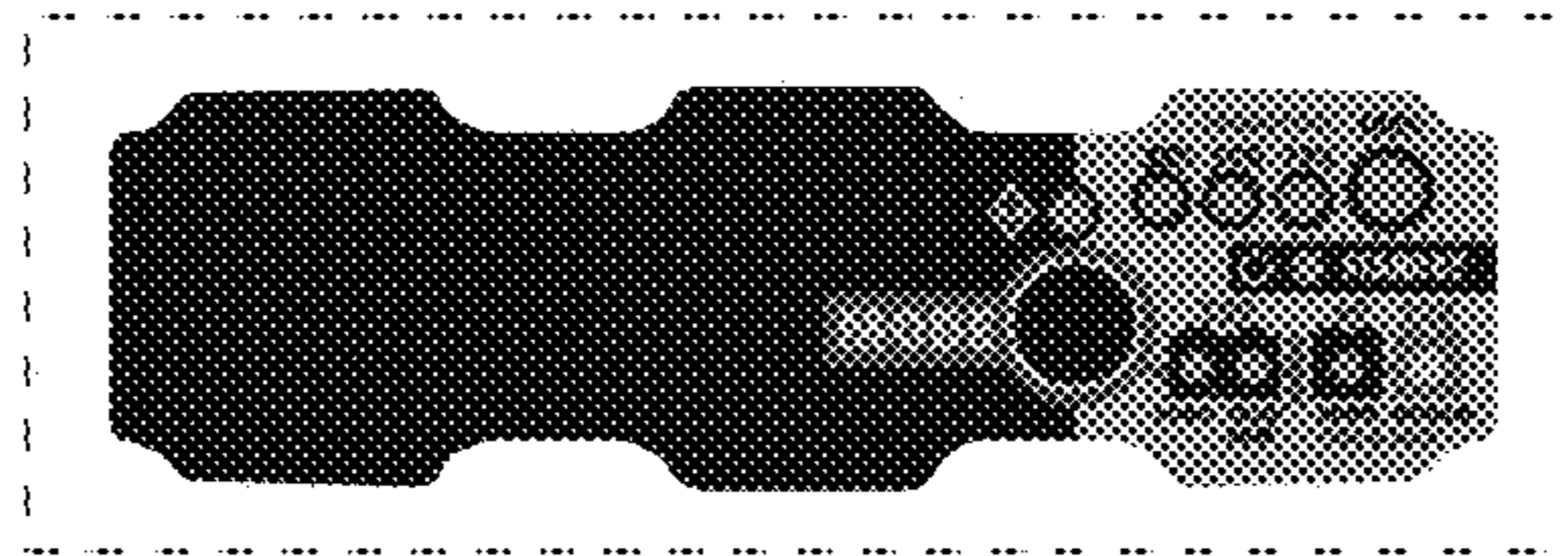

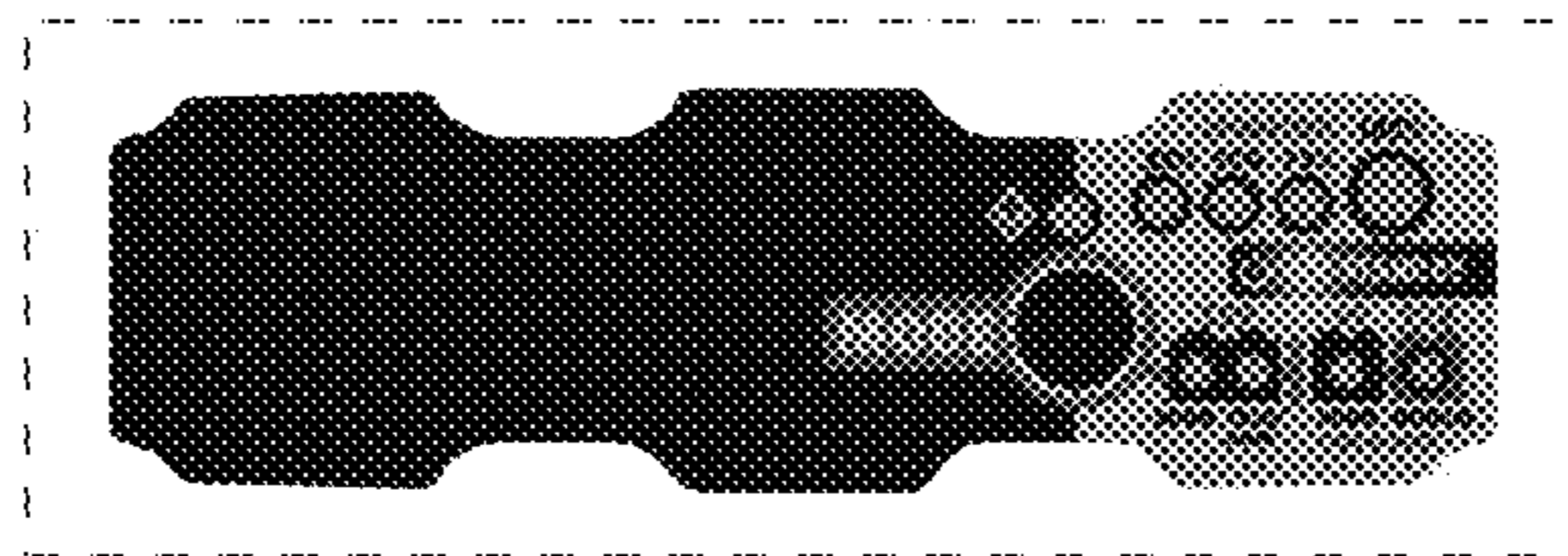

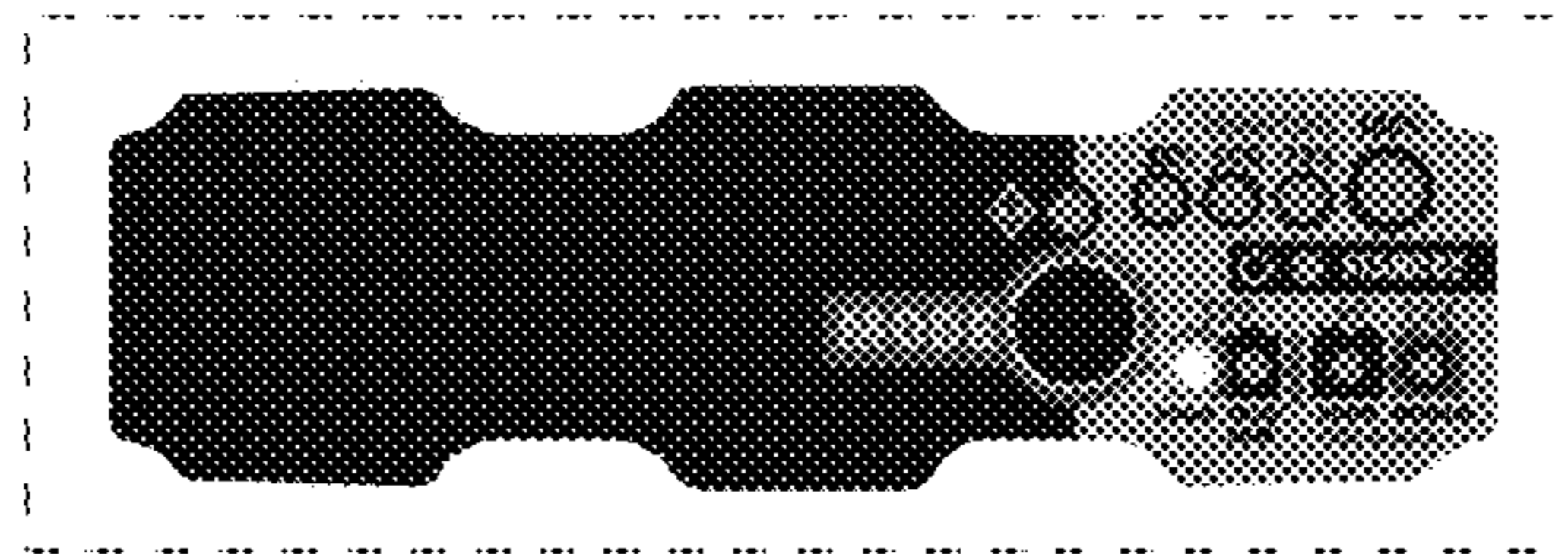

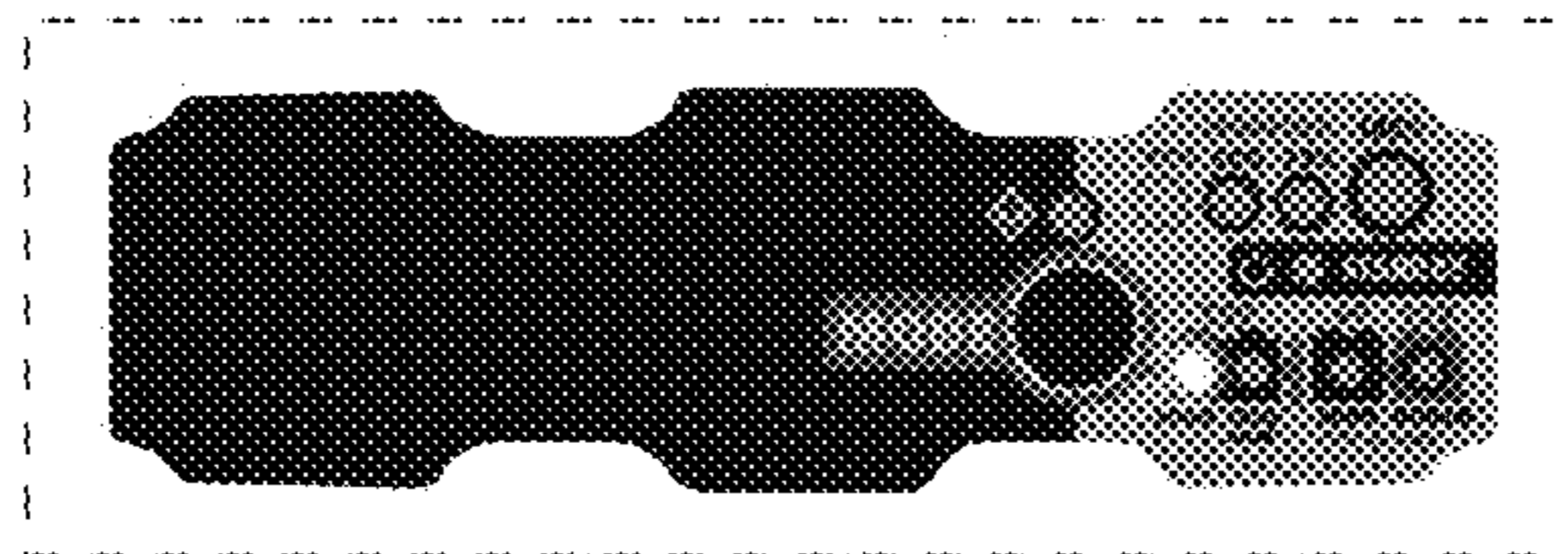

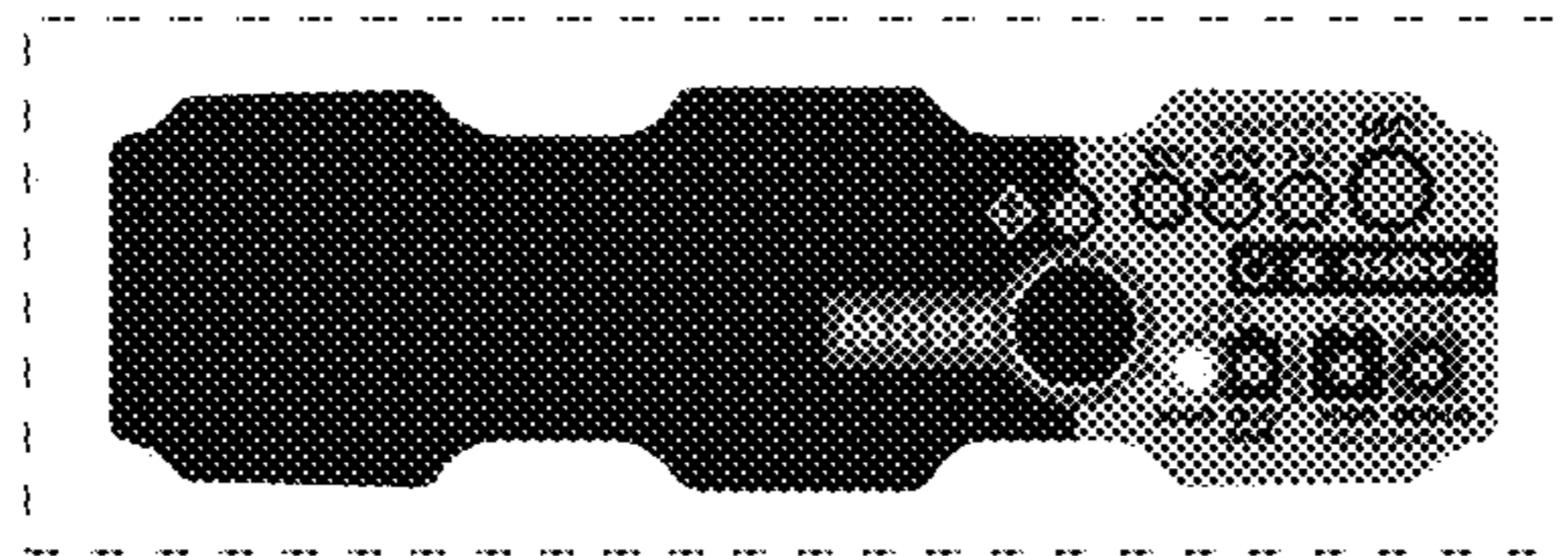

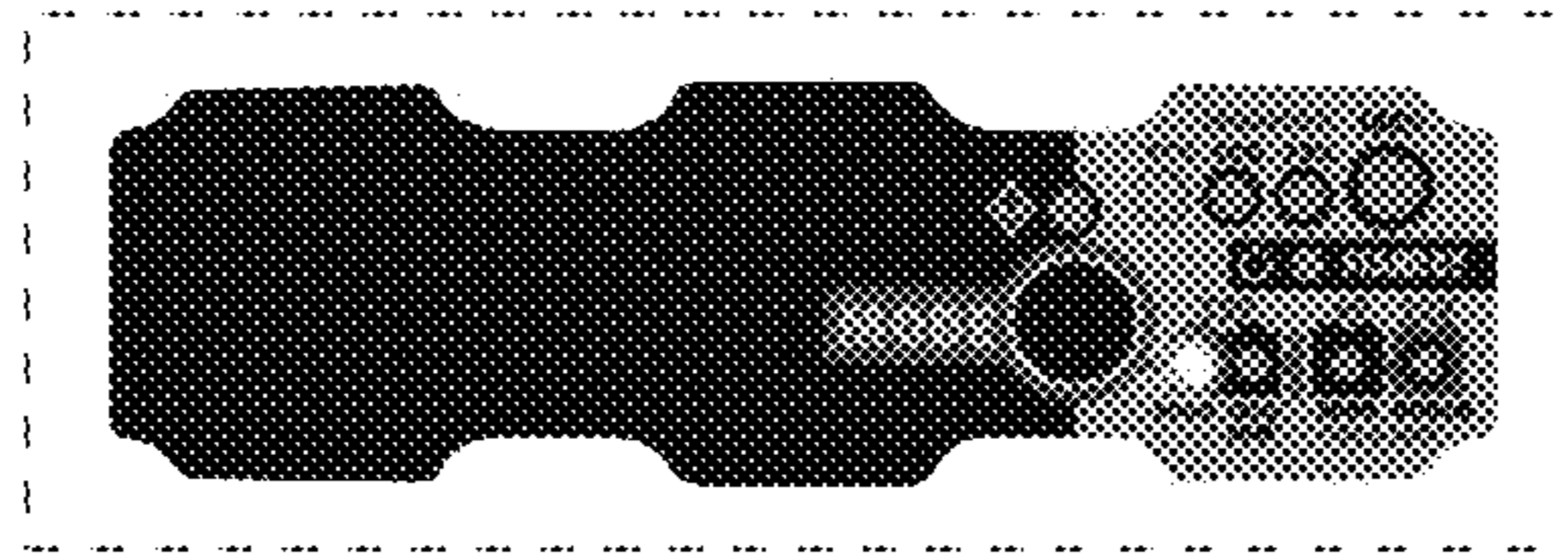

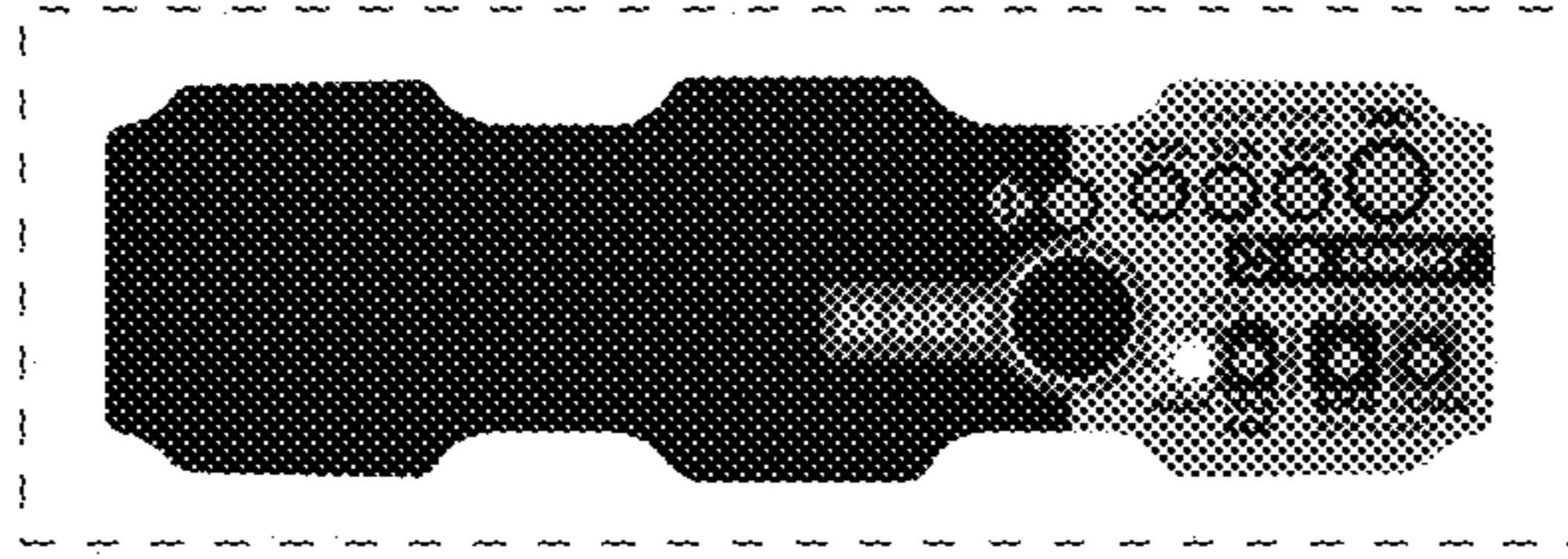

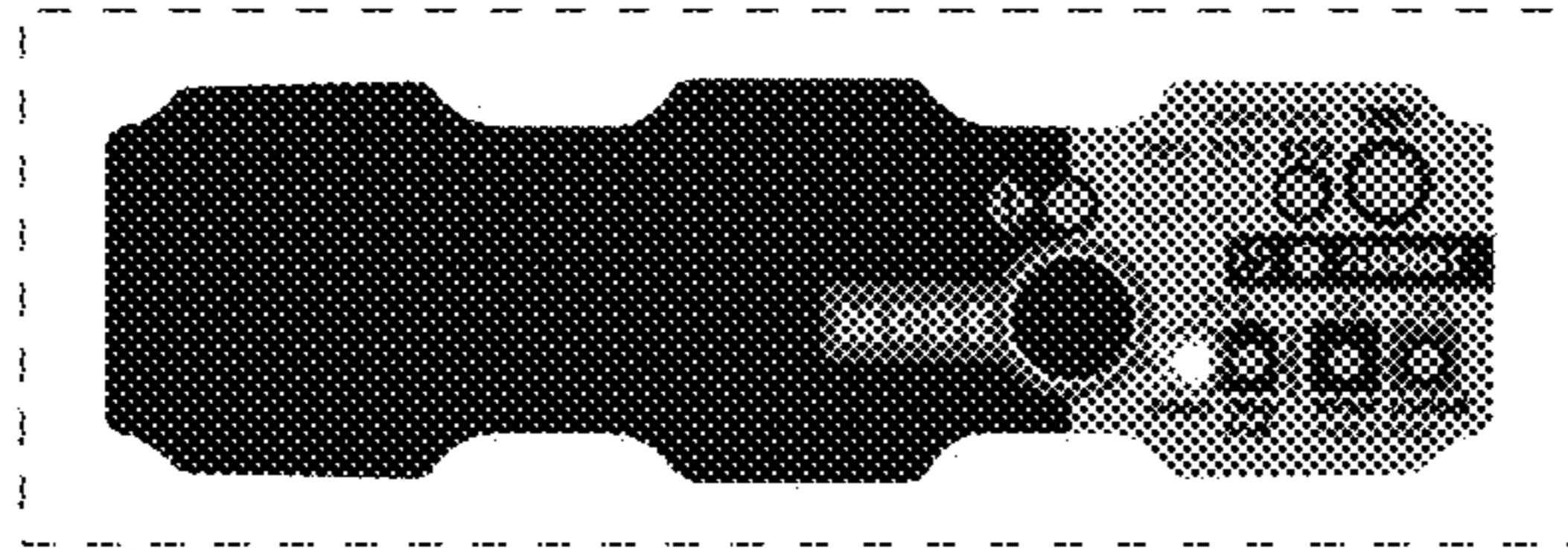

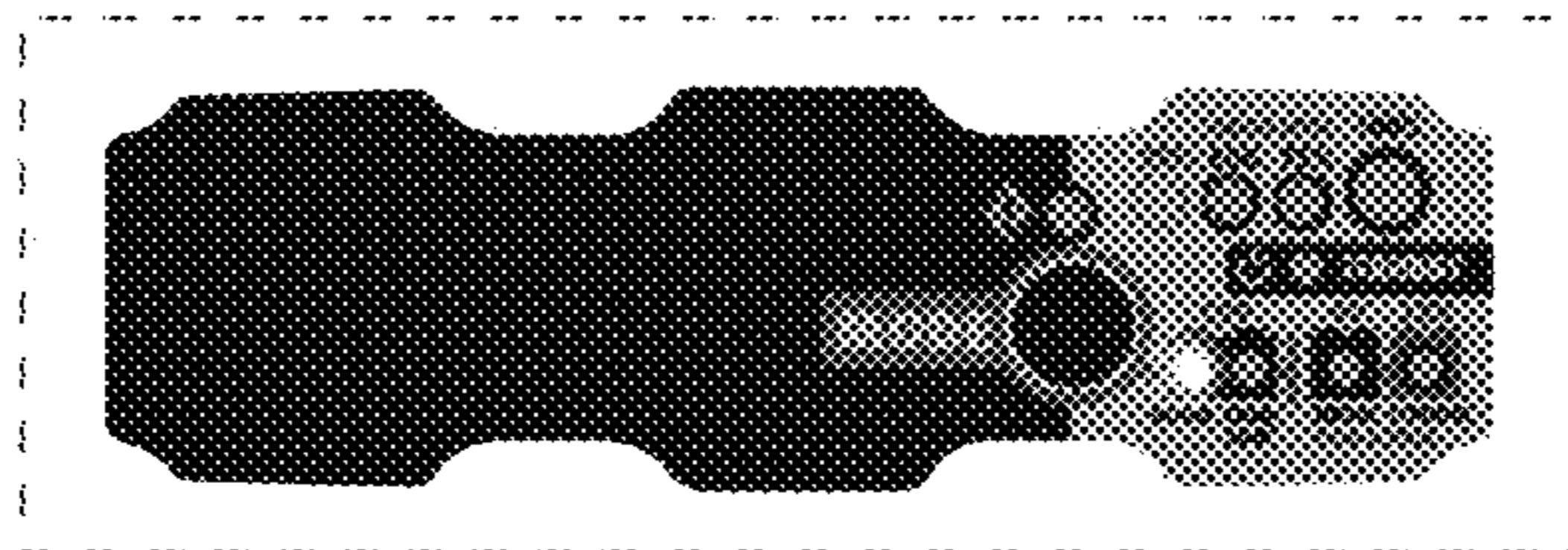

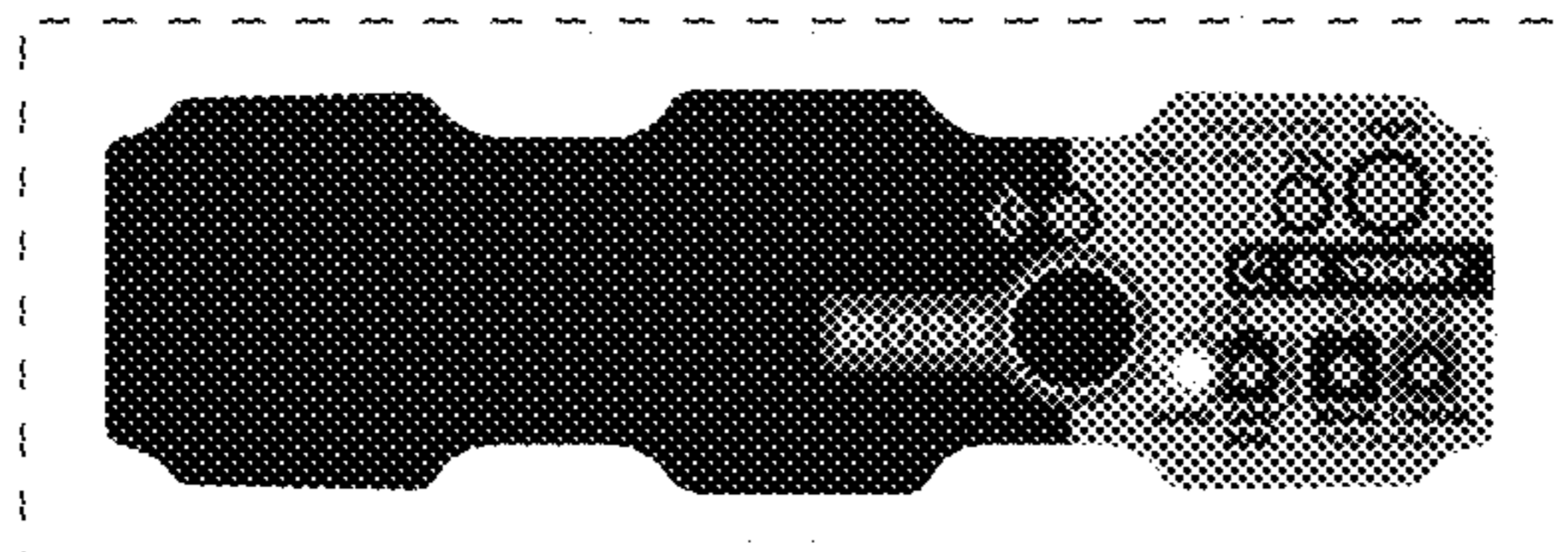

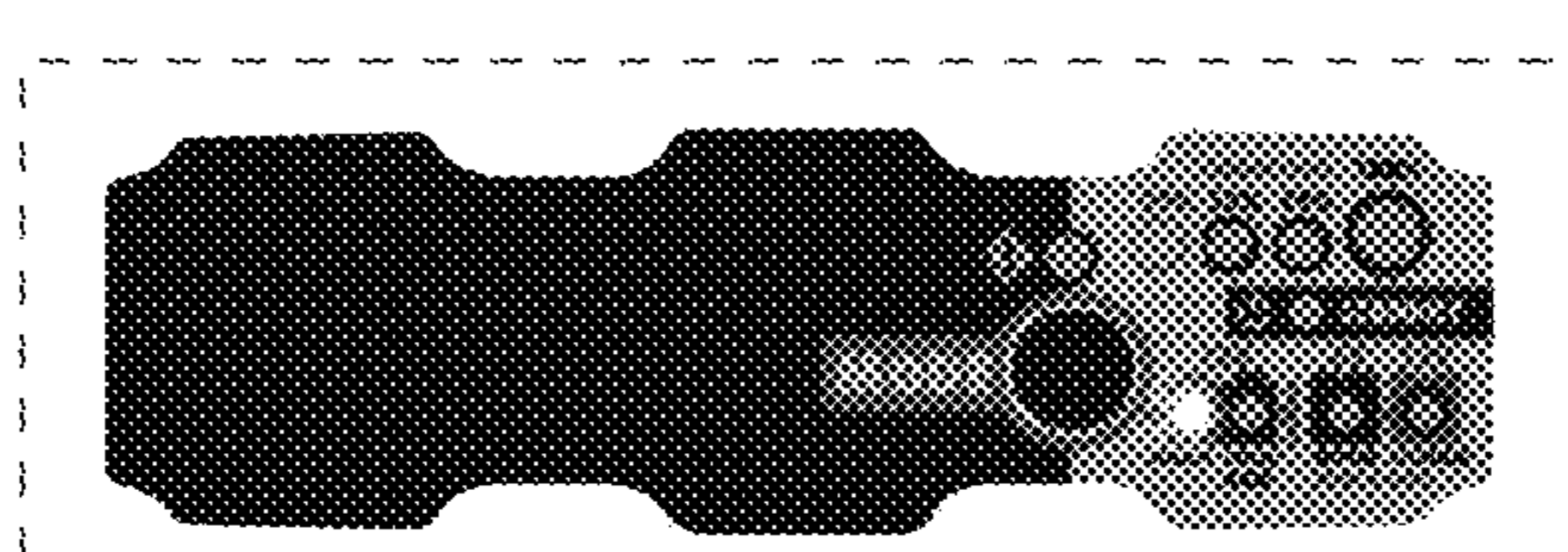

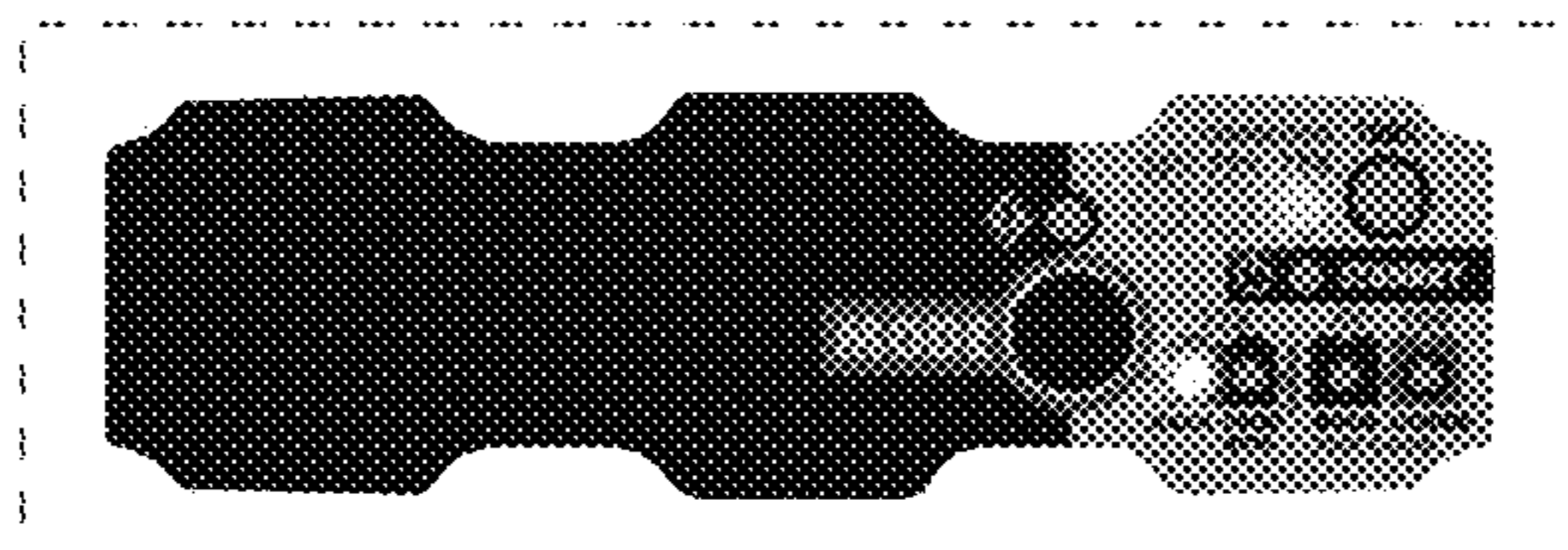

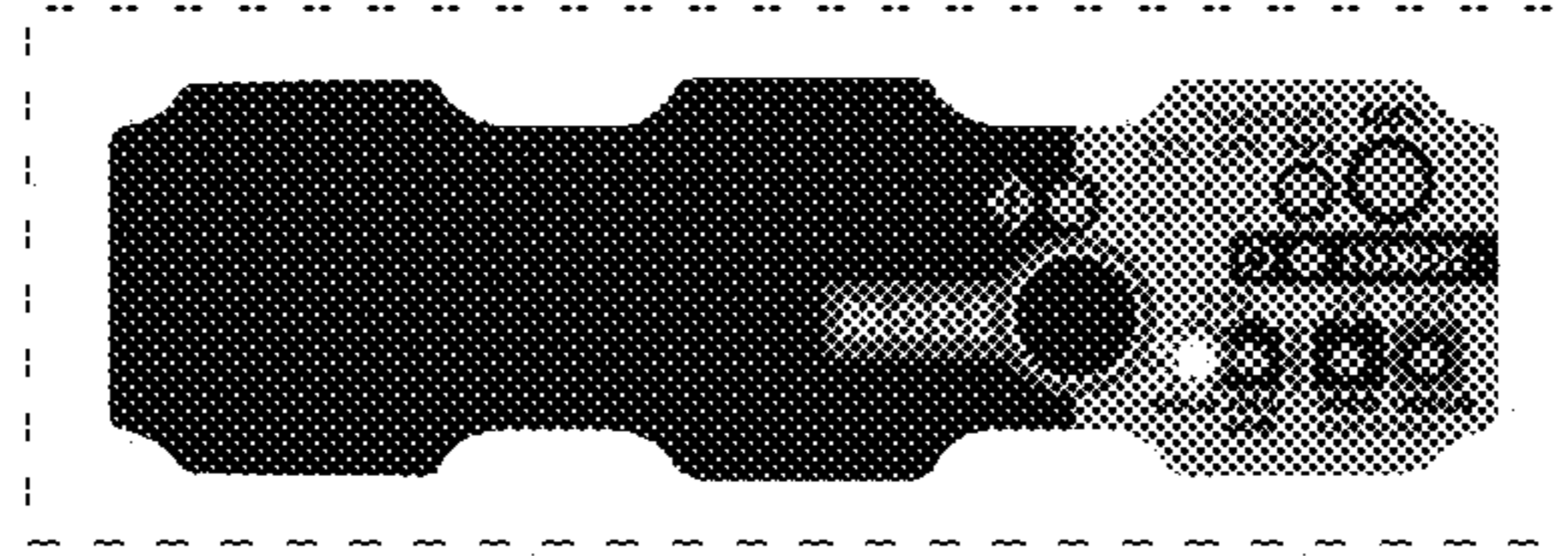

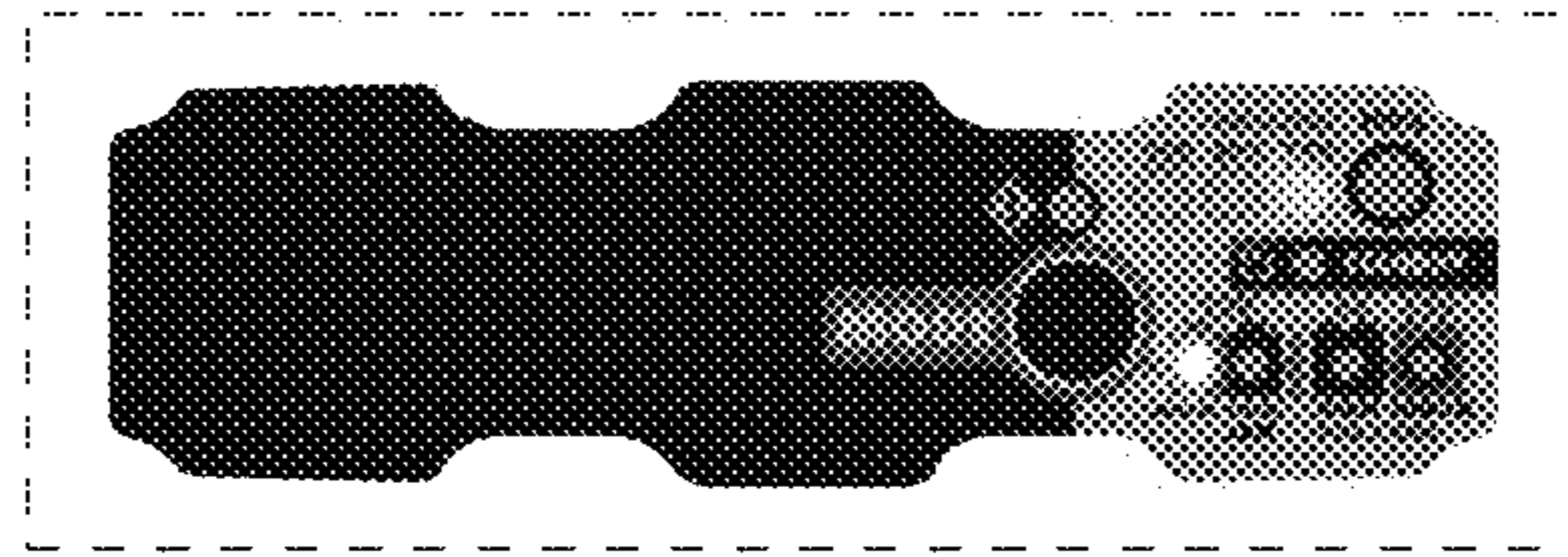

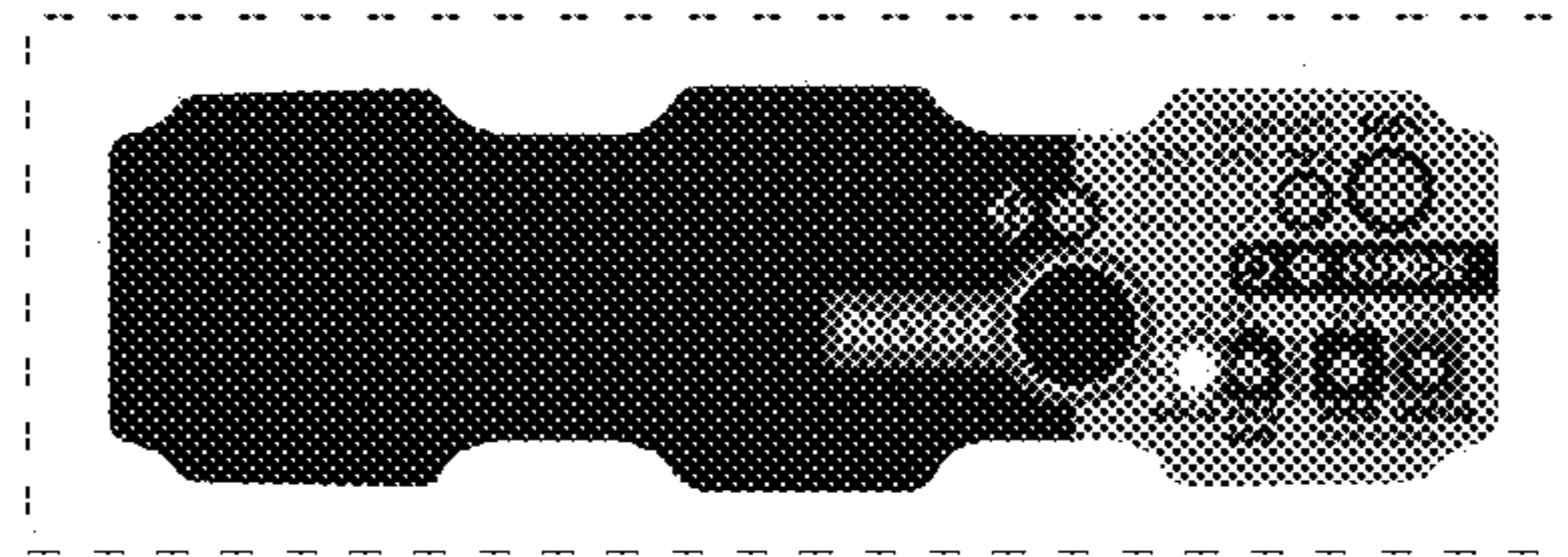

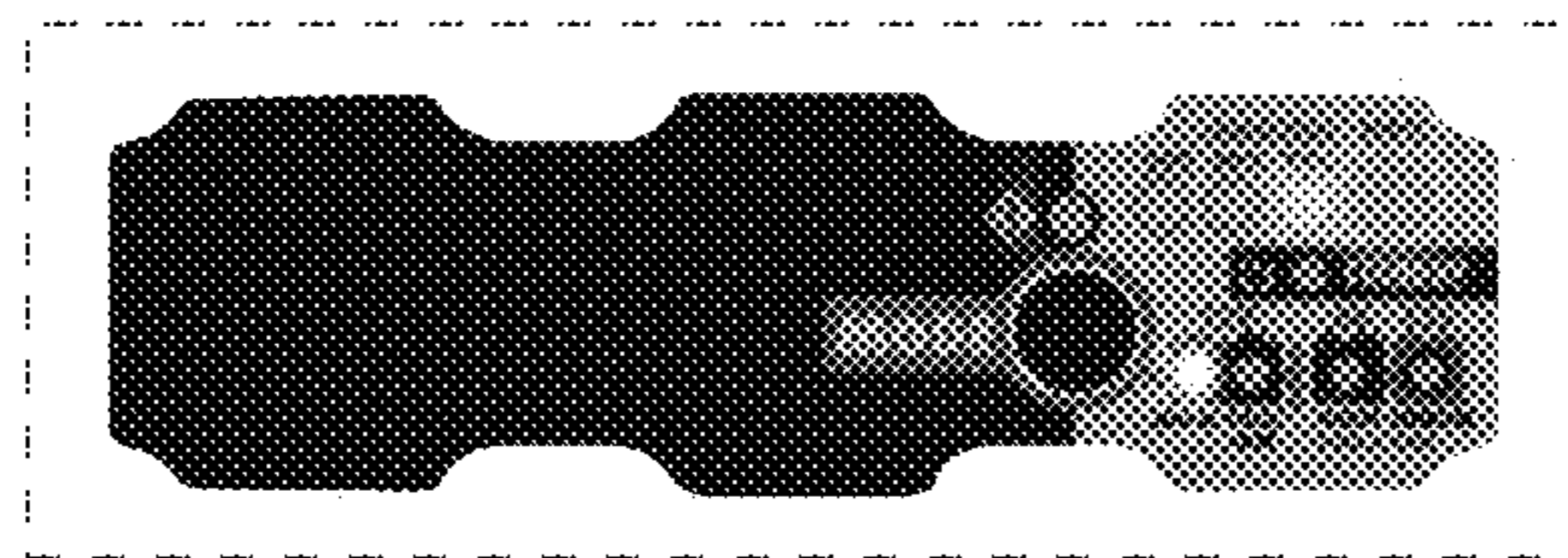

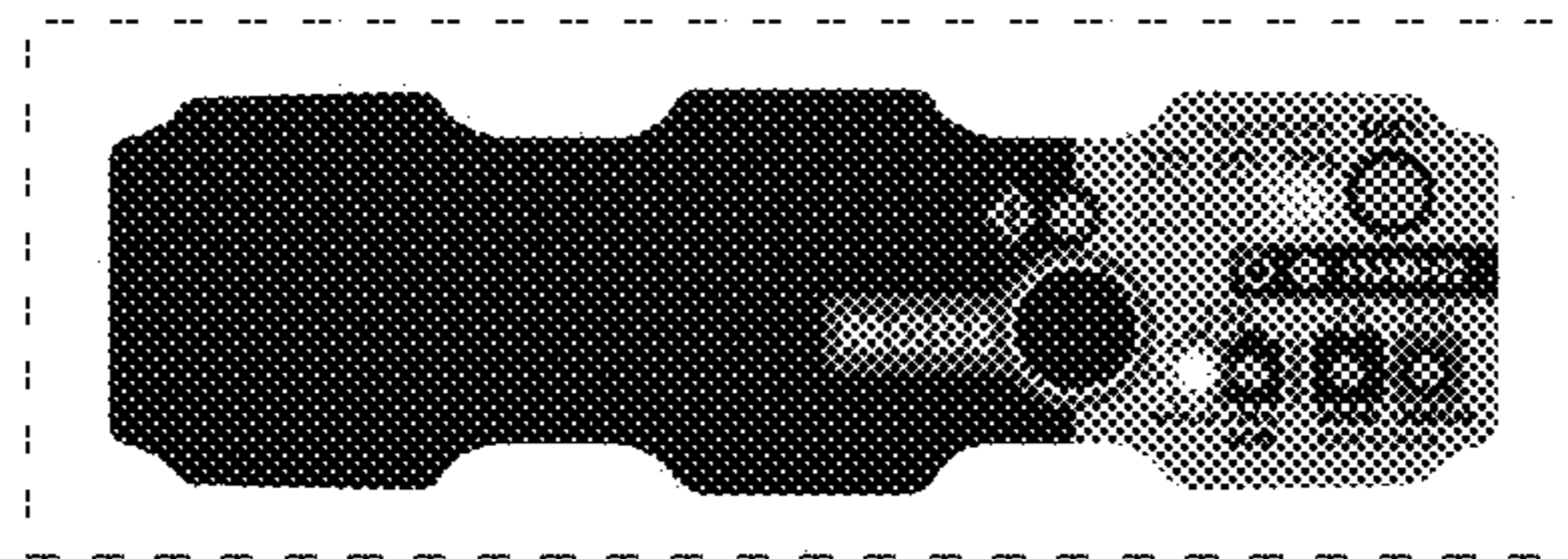

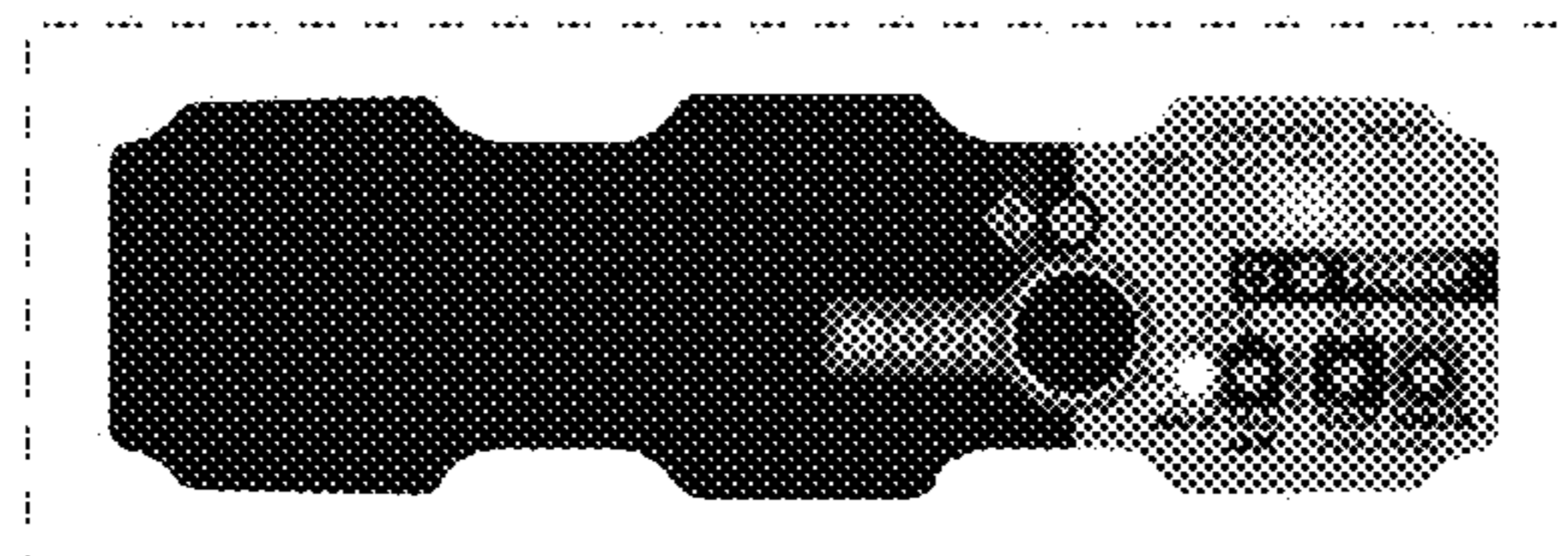

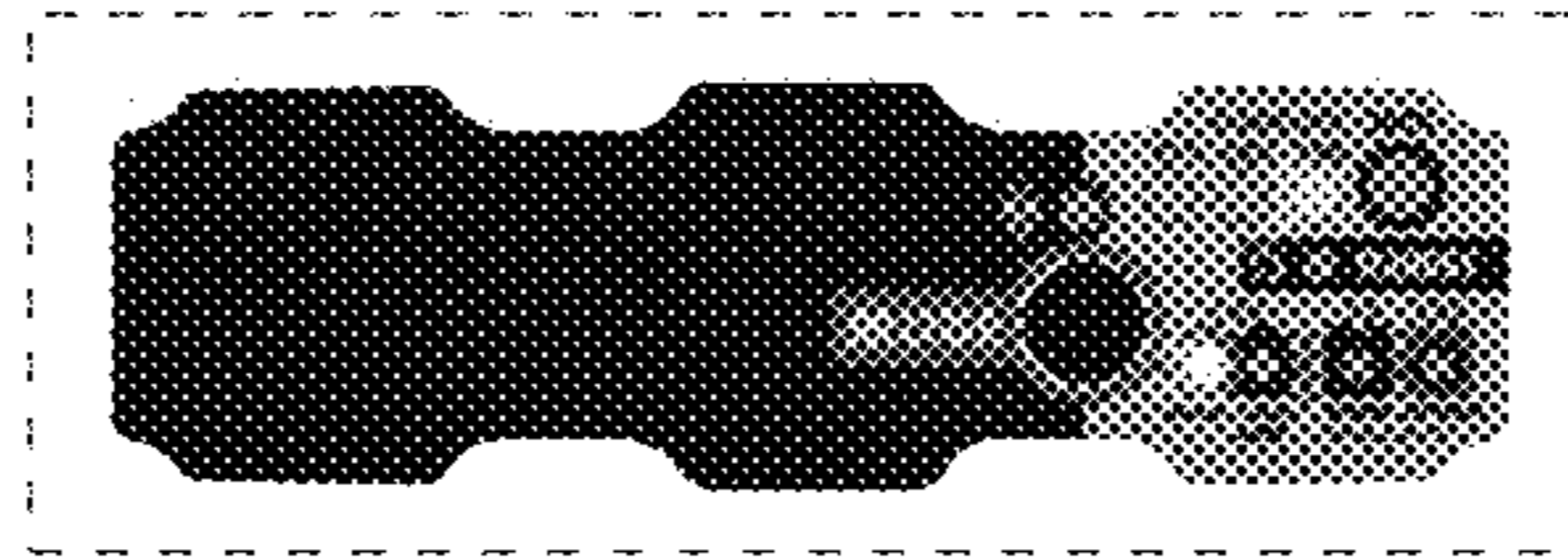

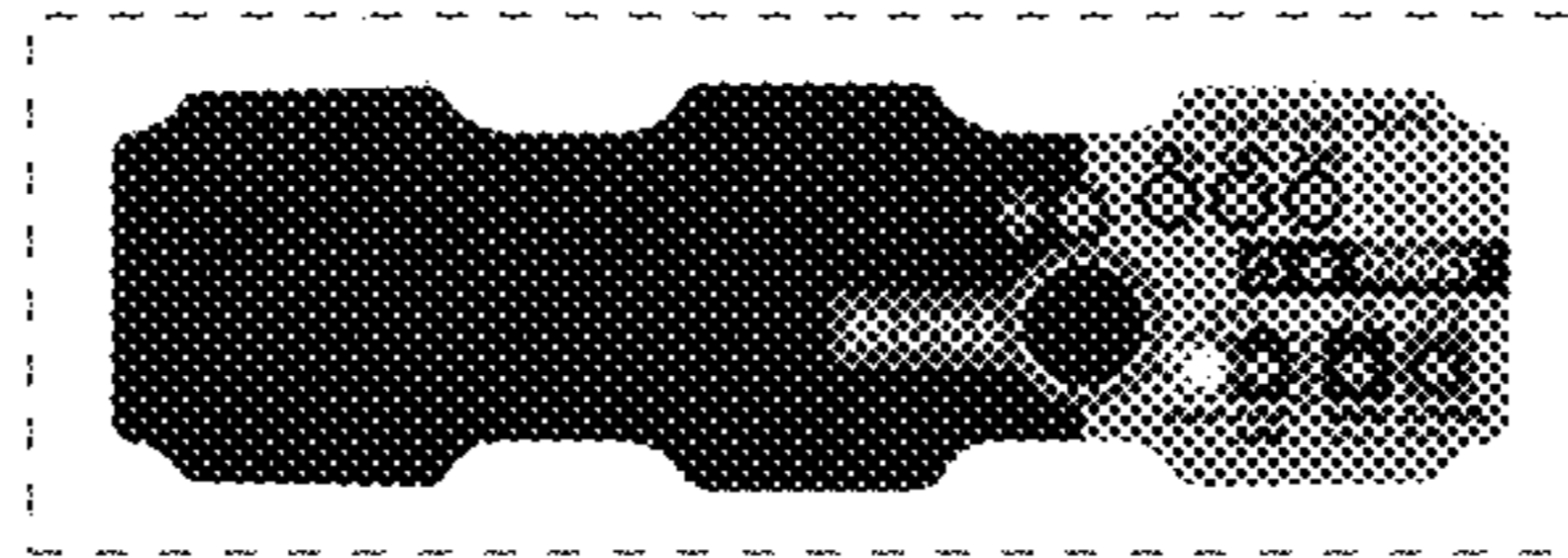

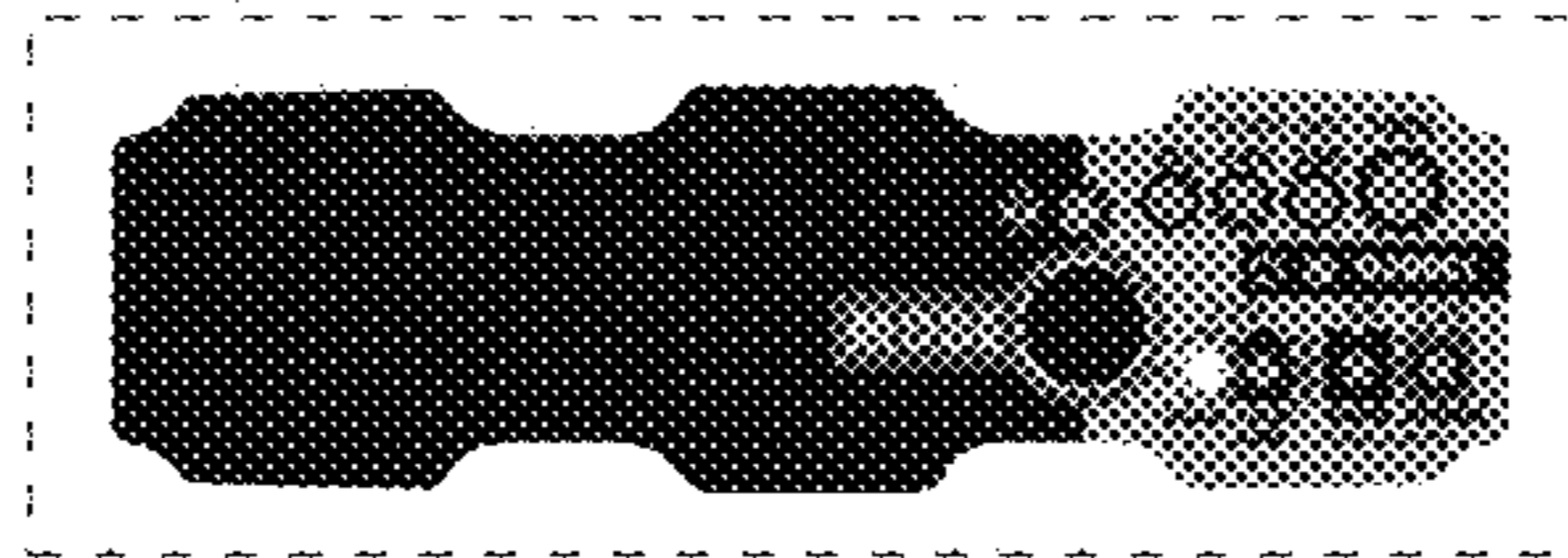

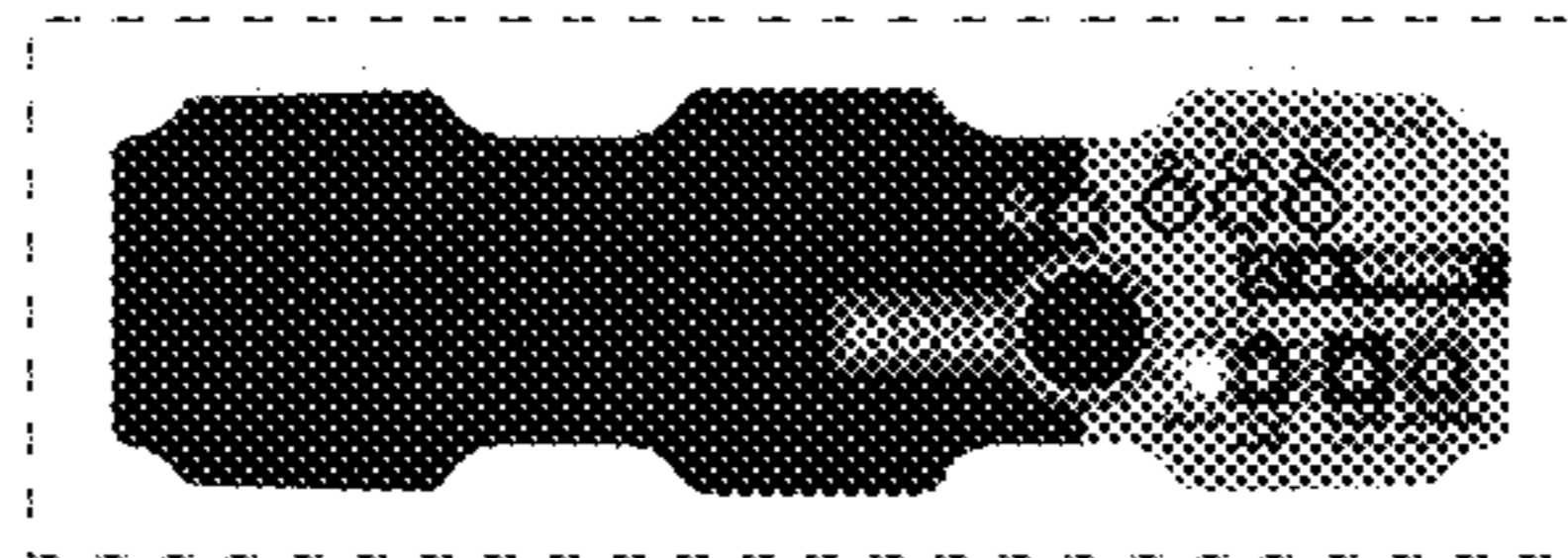

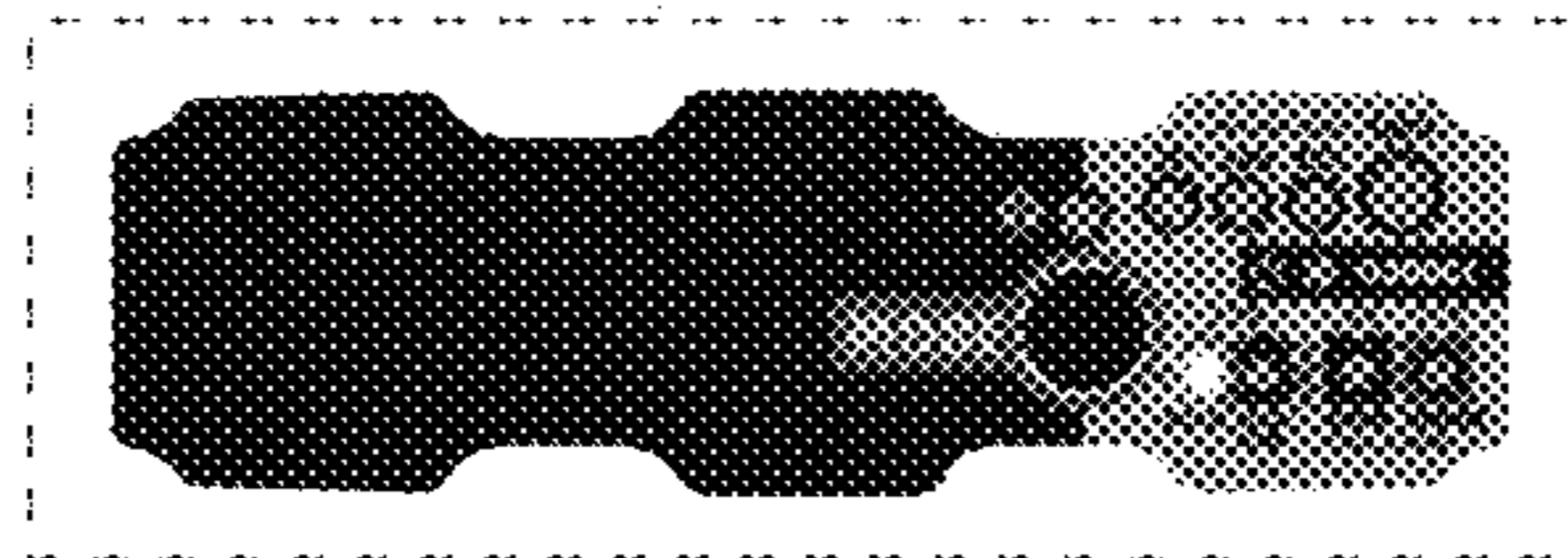

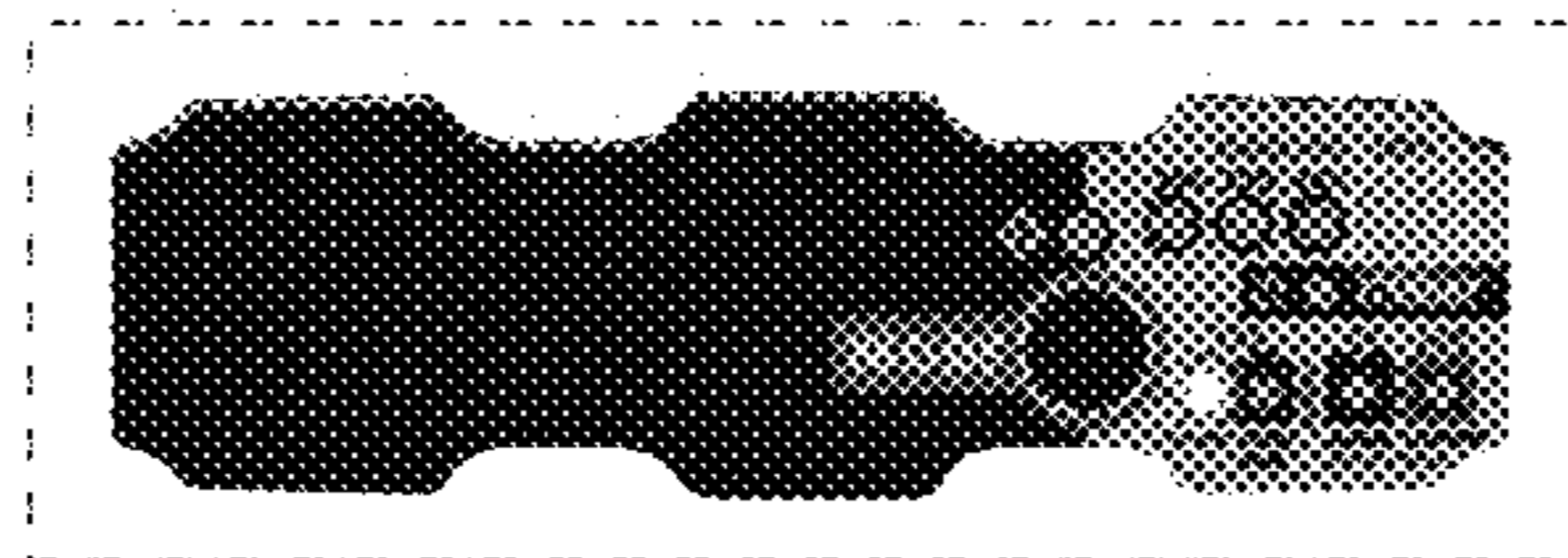

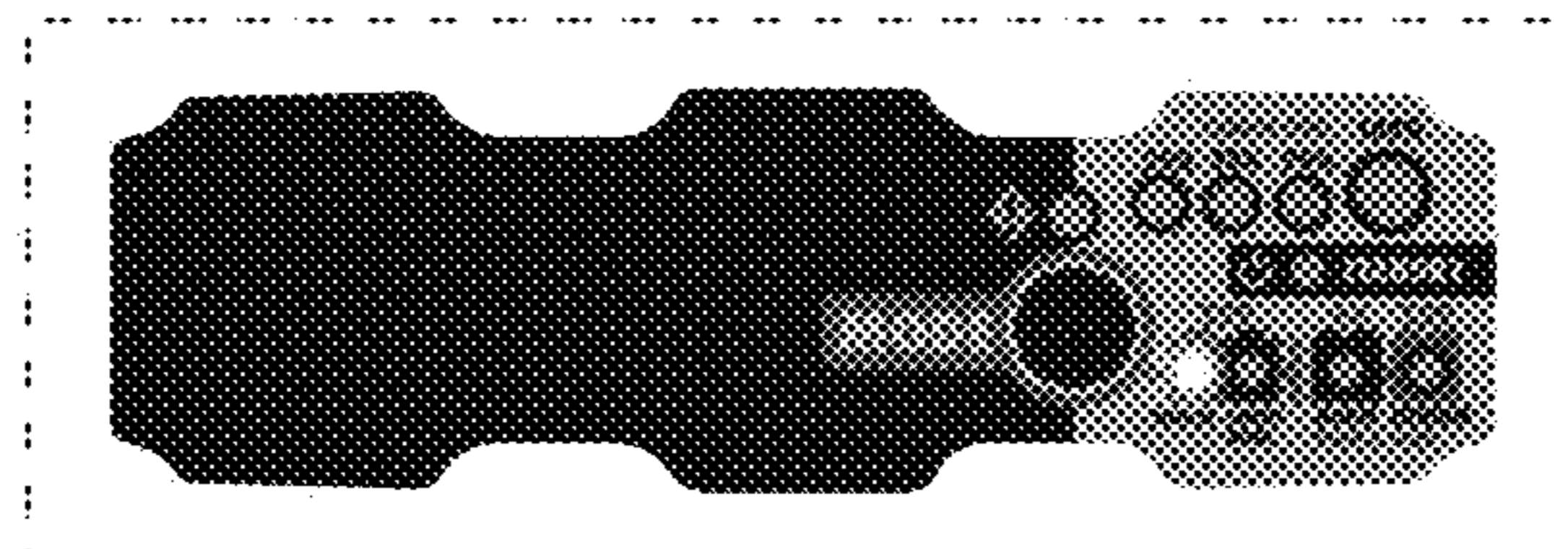

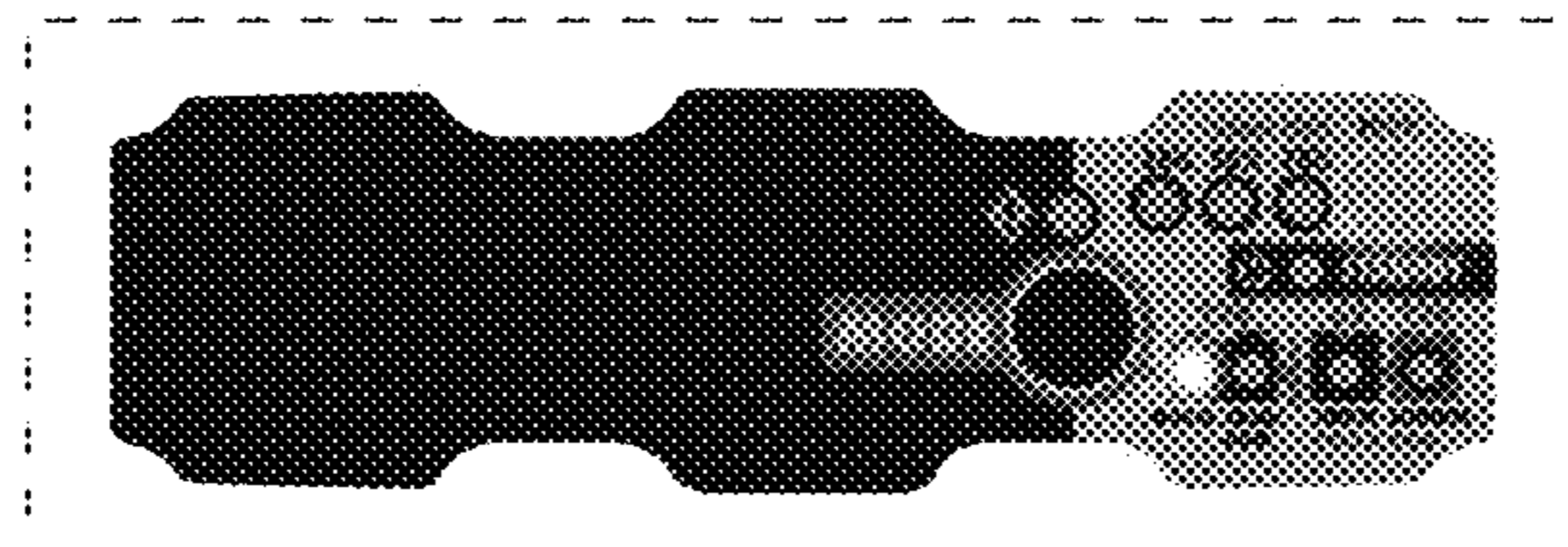
