(57) **CLAIM**

The ornamental design for a computer screen with practice health monitor and radar graphical user interface, as shown and described.

DESCRIPTION

The FIGURE is a front view of a computer screen with practice health monitor and radar graphical user interface showing the claimed design.
The outermost broken line rectangle illustrates a computer screen. The remainder of the broken lines illustrate portions of the graphical user interface. The broken lines form no part of the claimed design.
