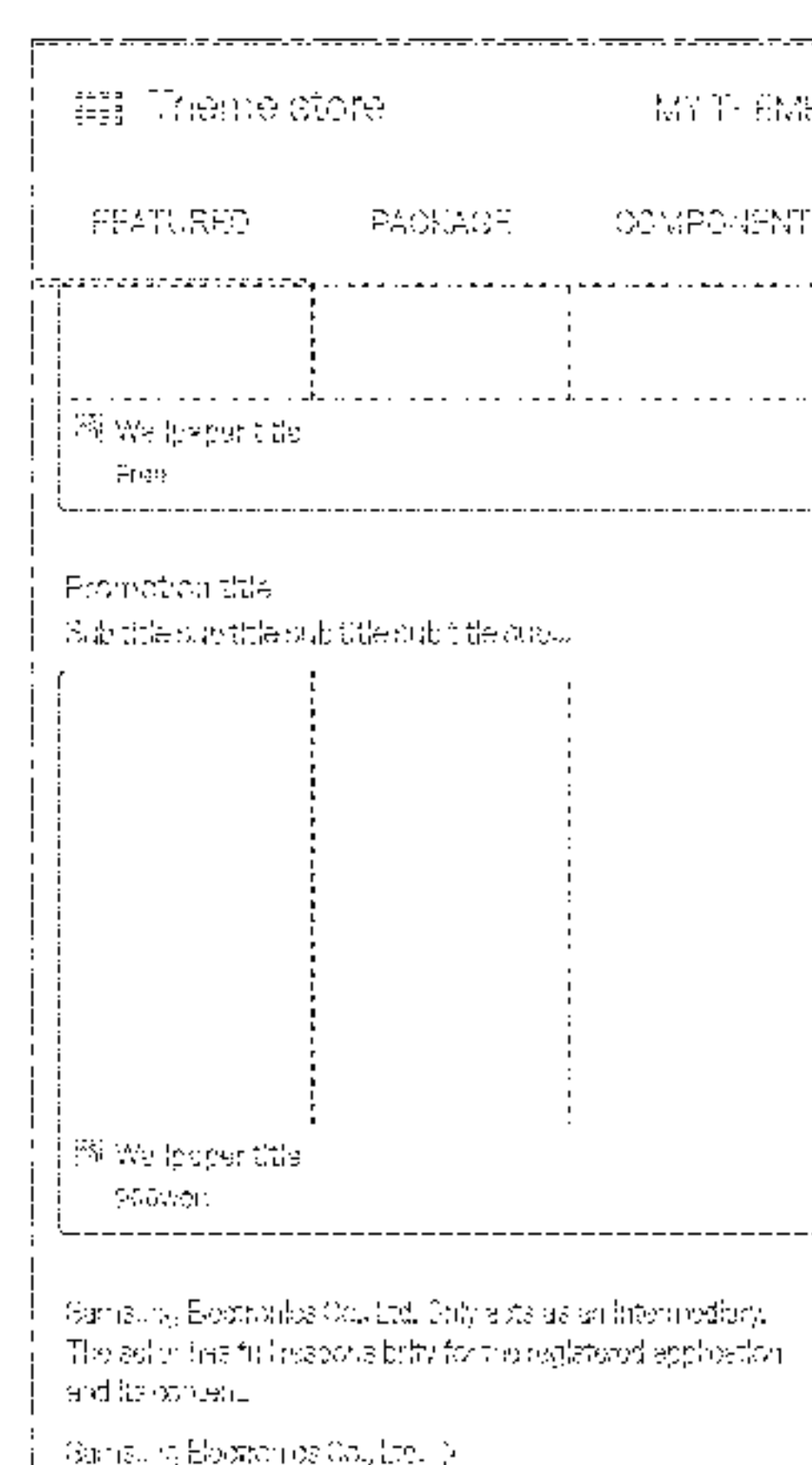
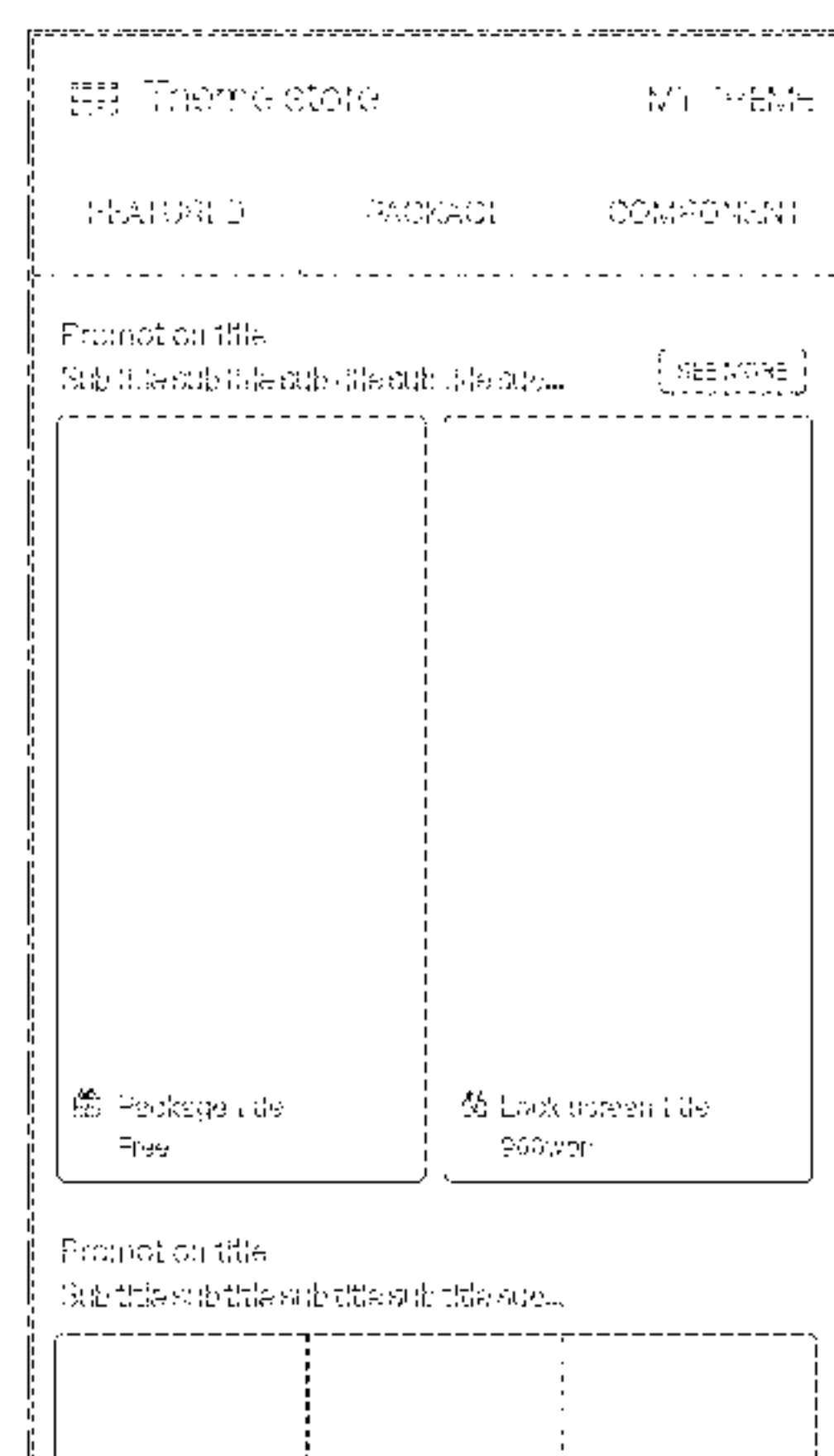
(57) **CLAIM**

We claim, the ornamental design for a display screen or portion thereof with animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 is the first image in a sequence for a display screen or portion thereof with animated graphical user interface, showing our new design;

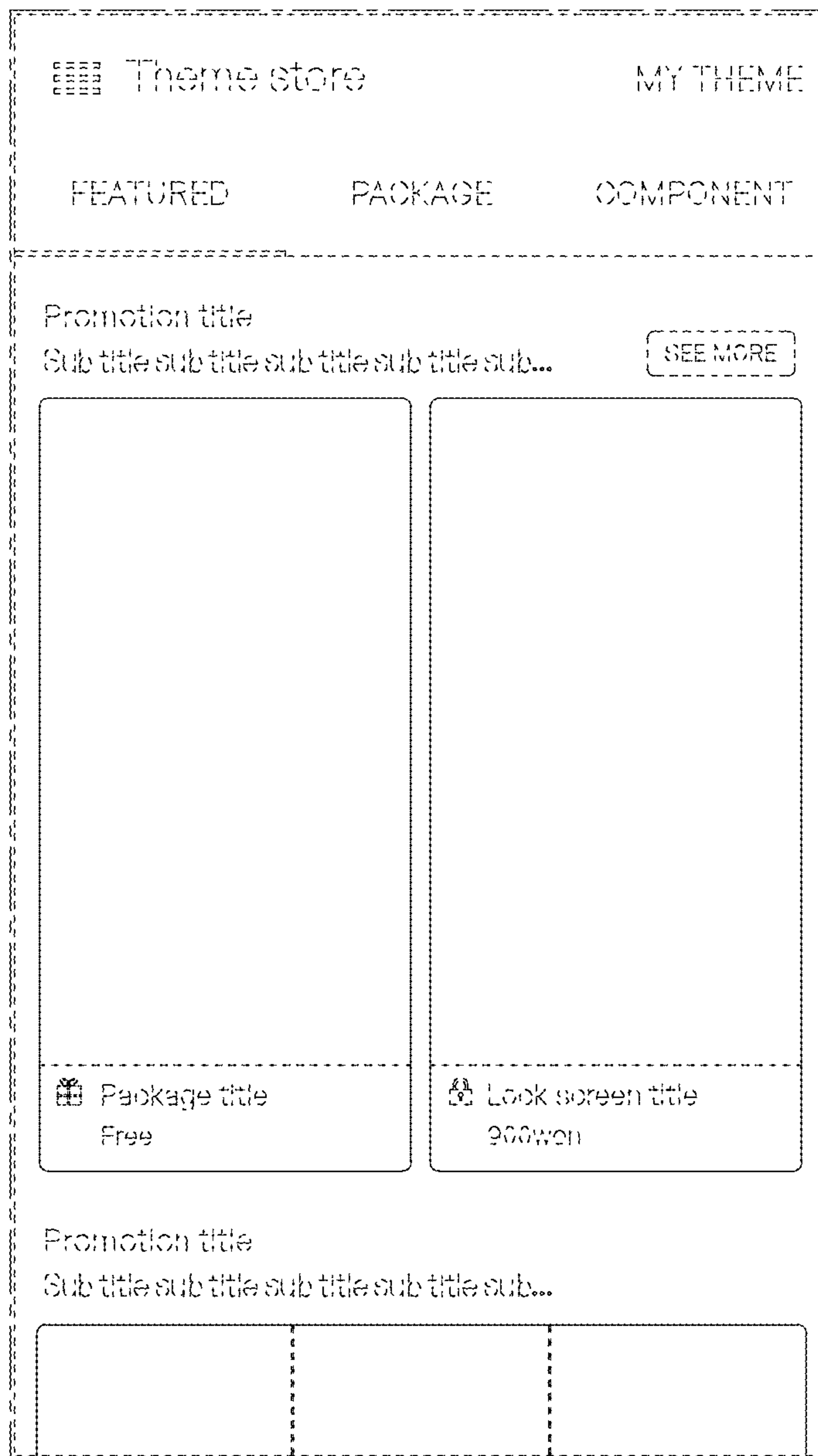

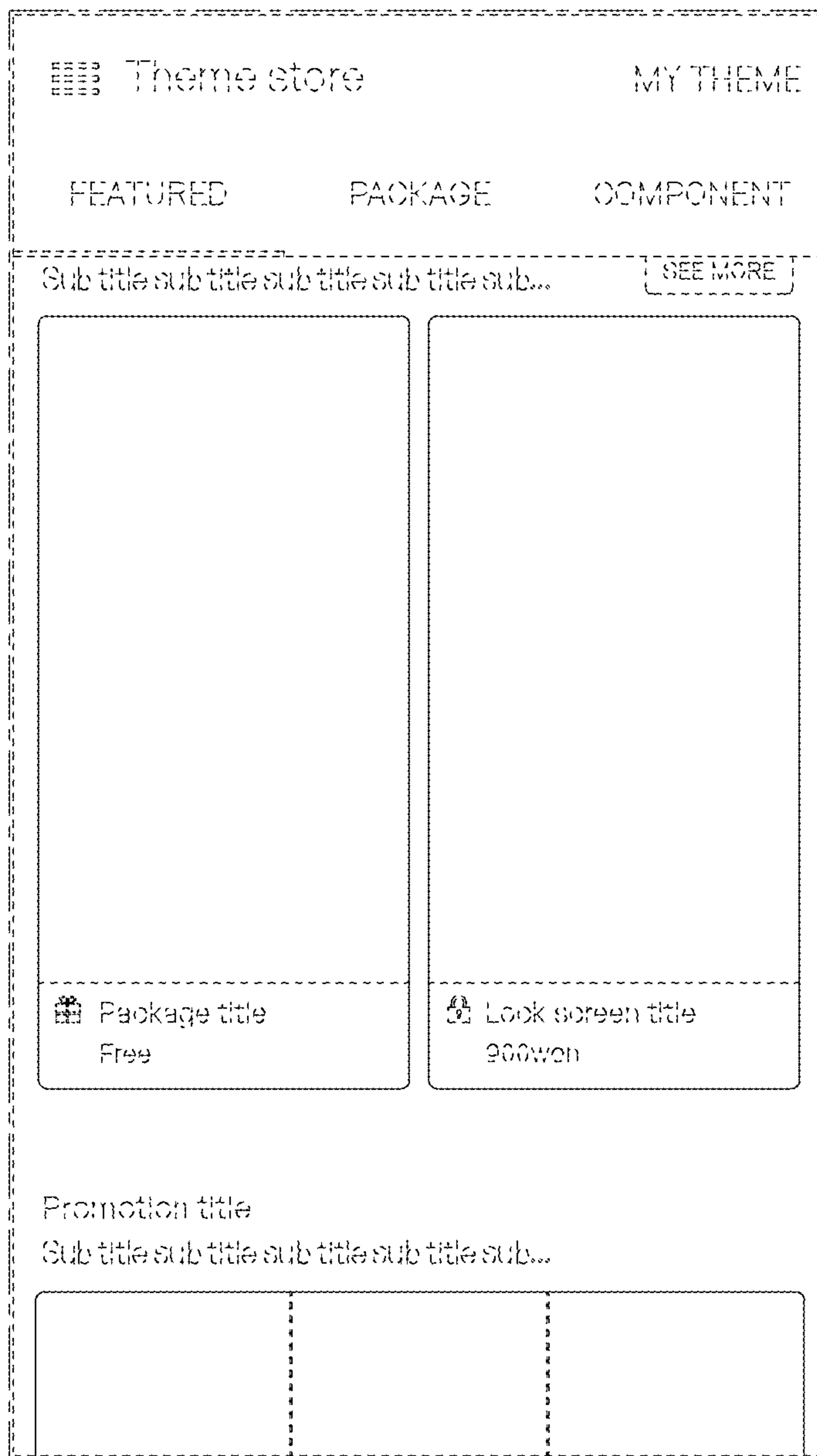

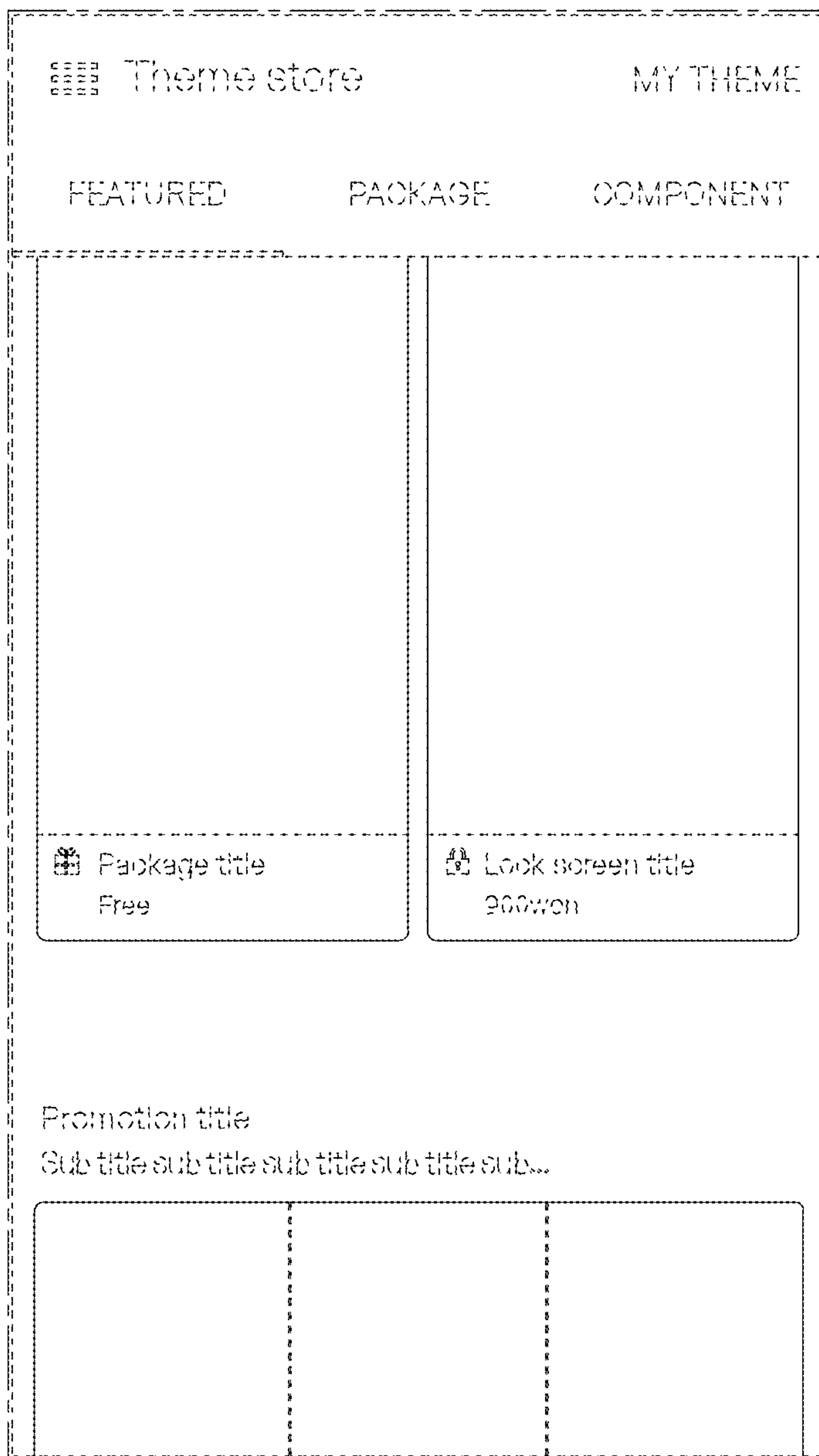

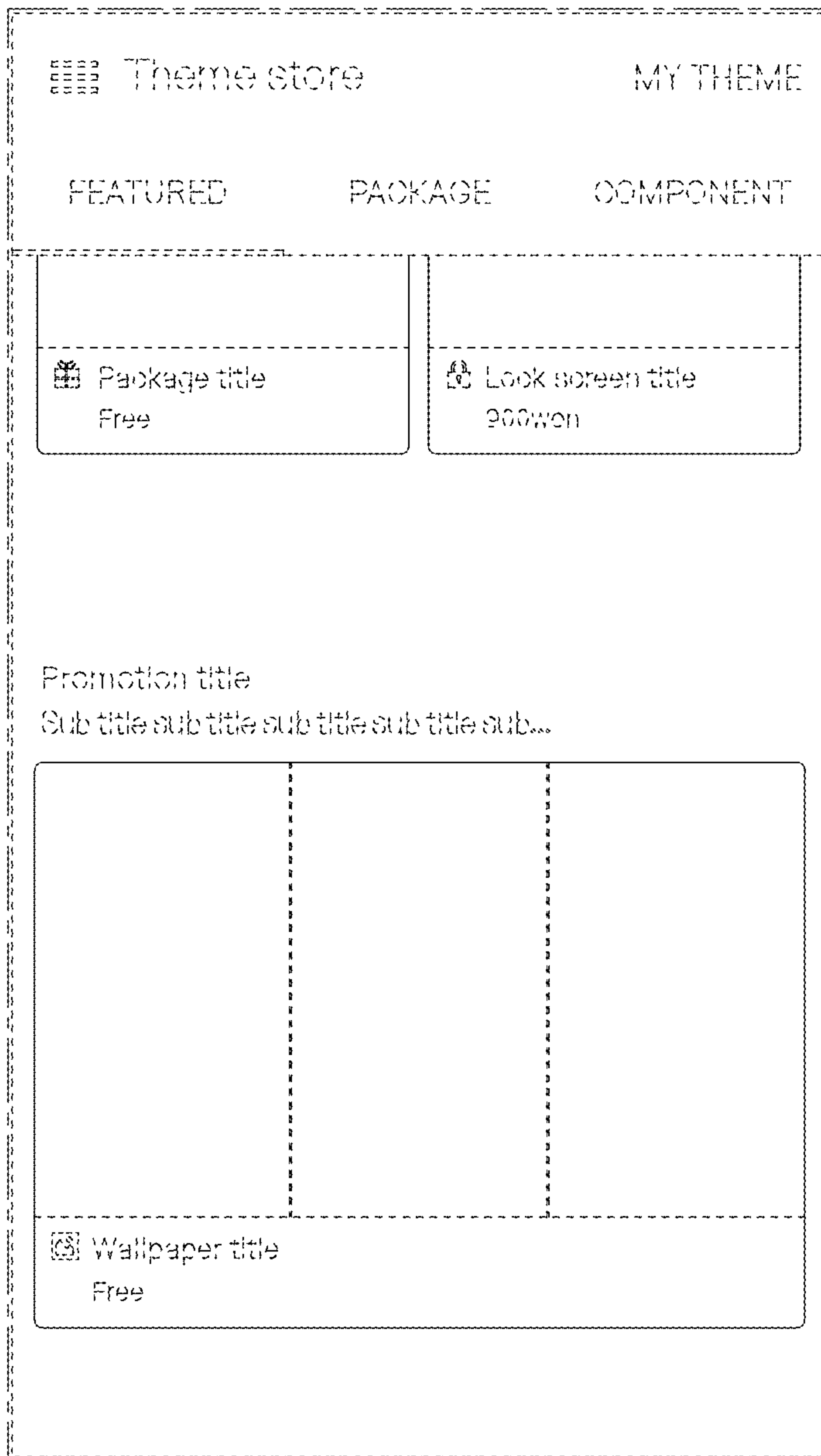

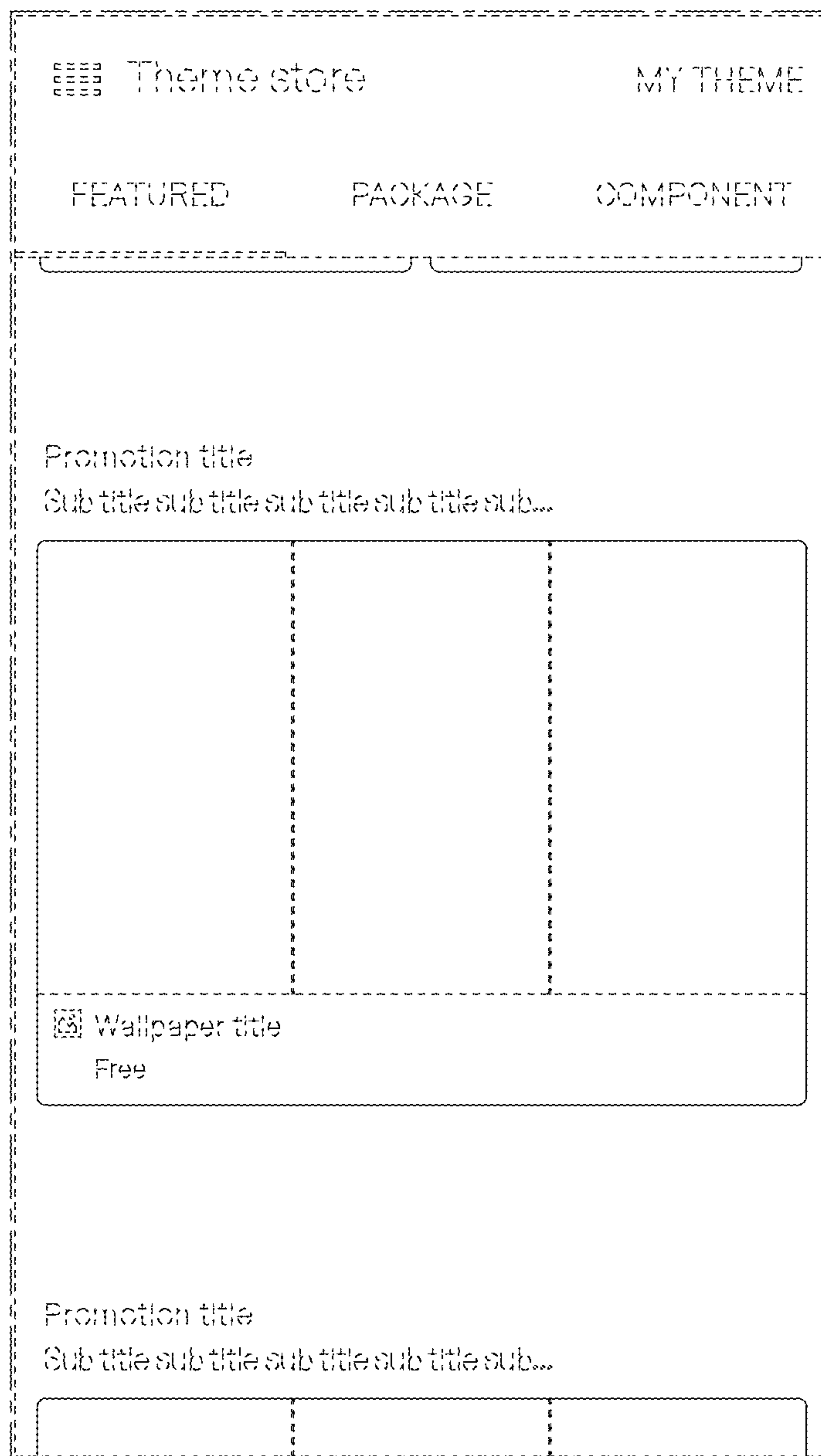

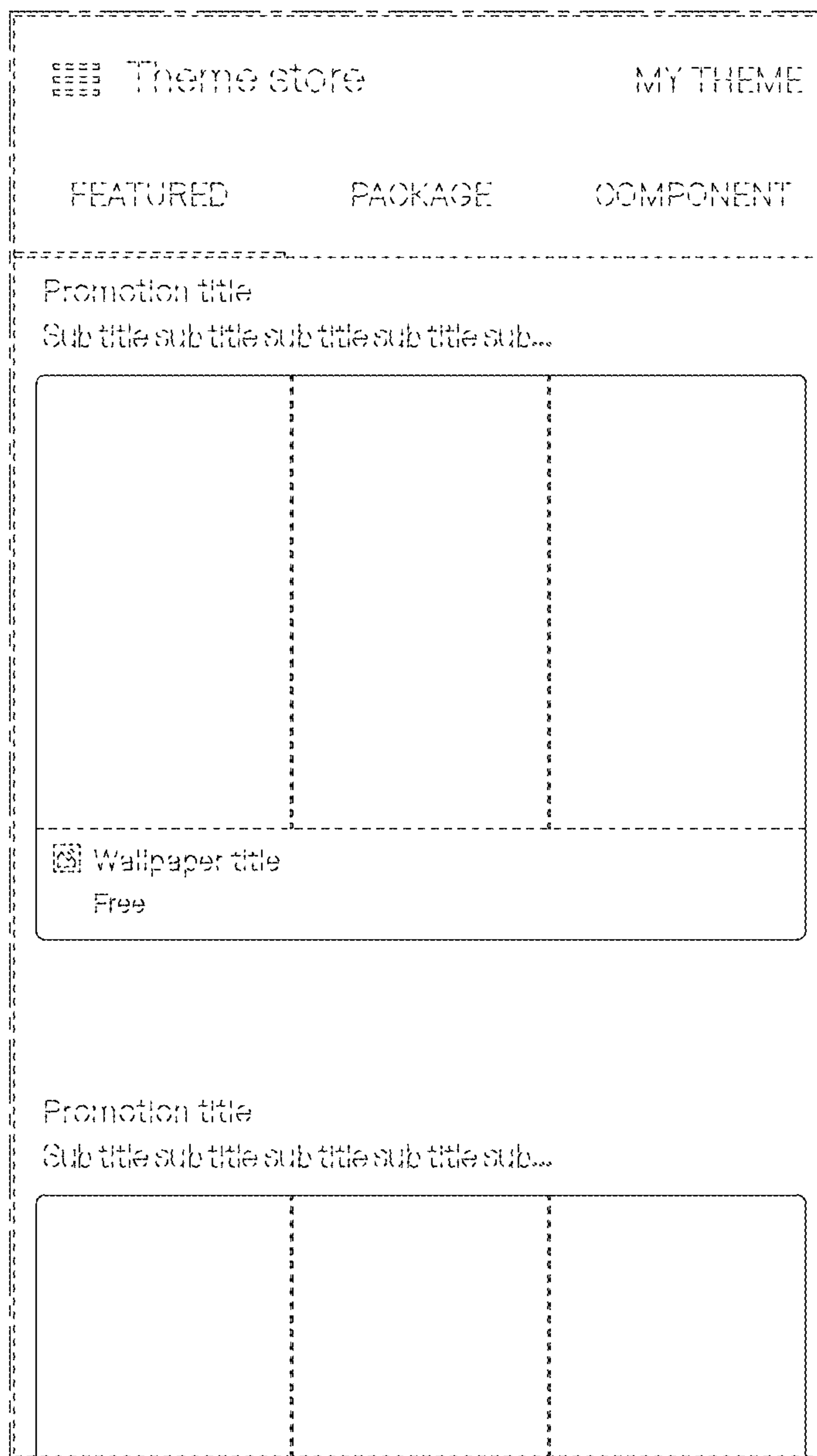

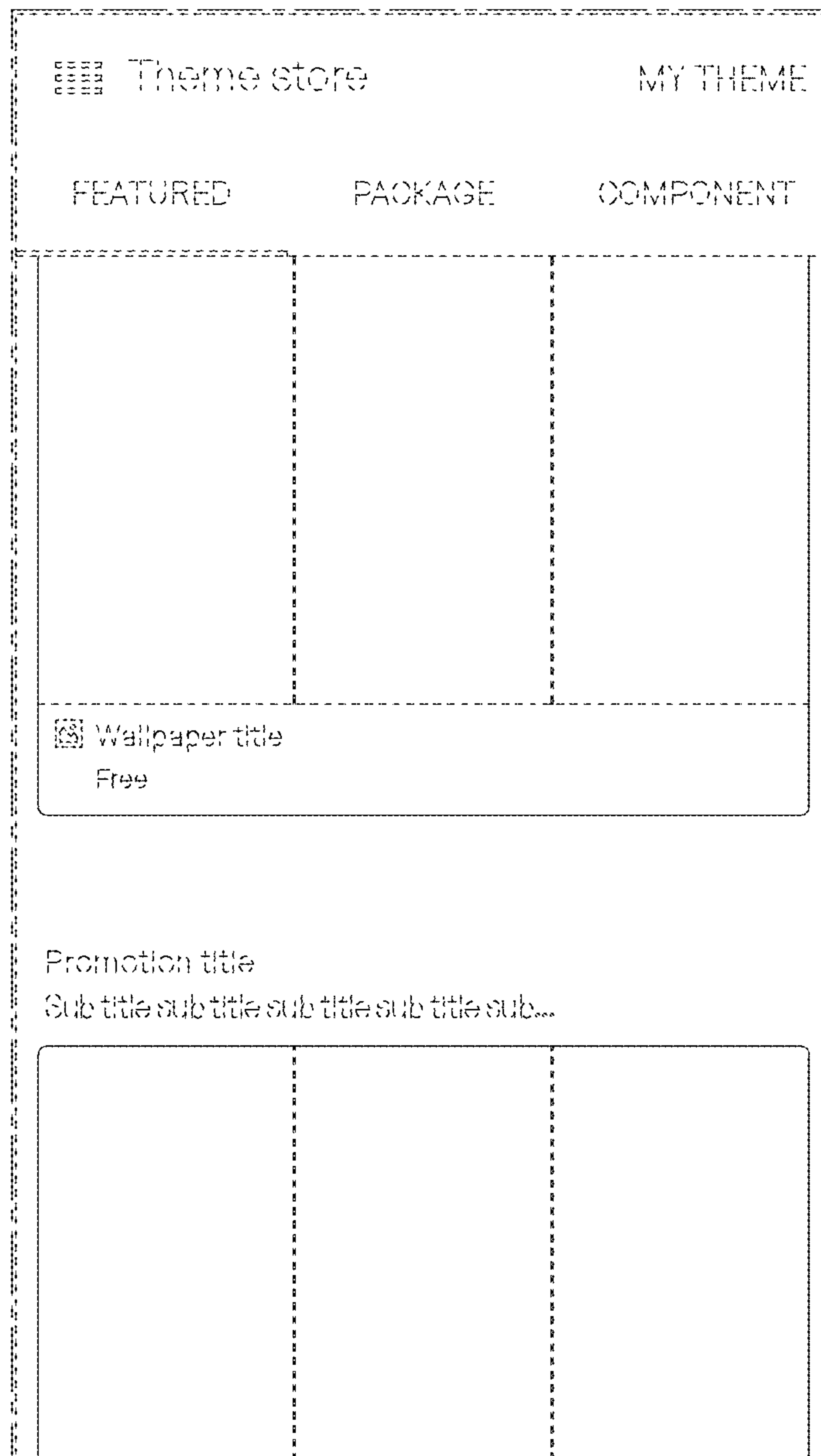

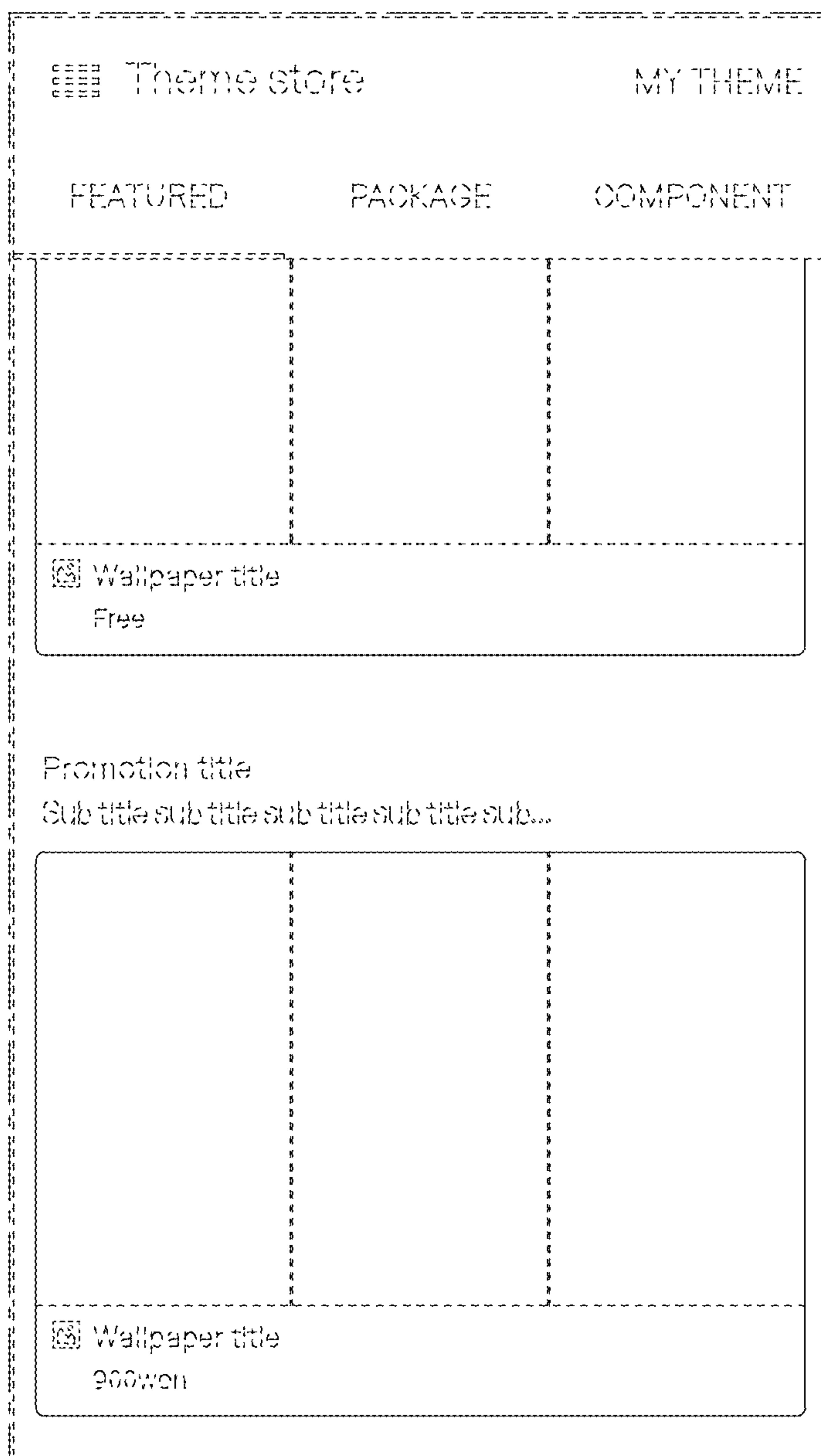

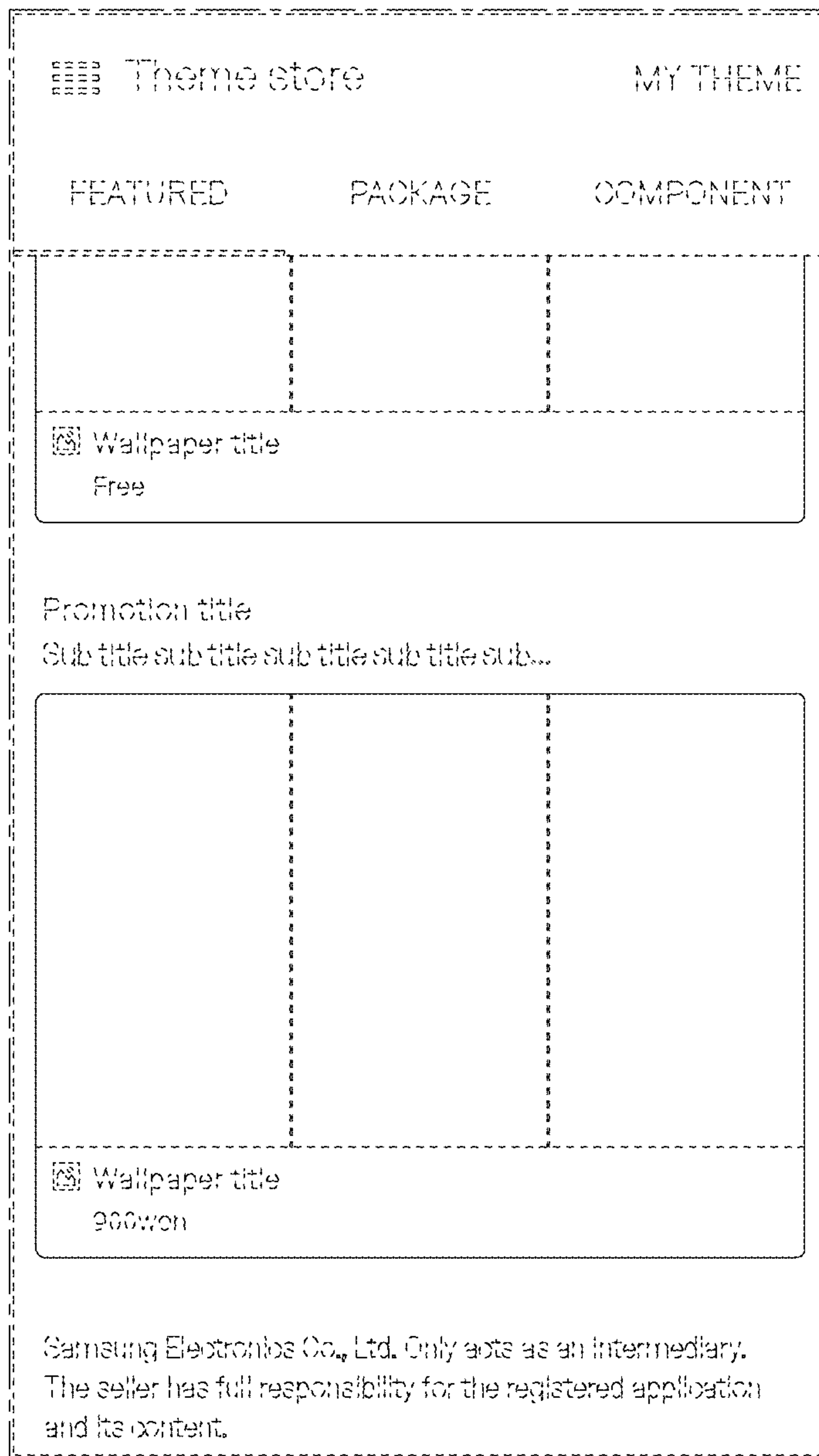

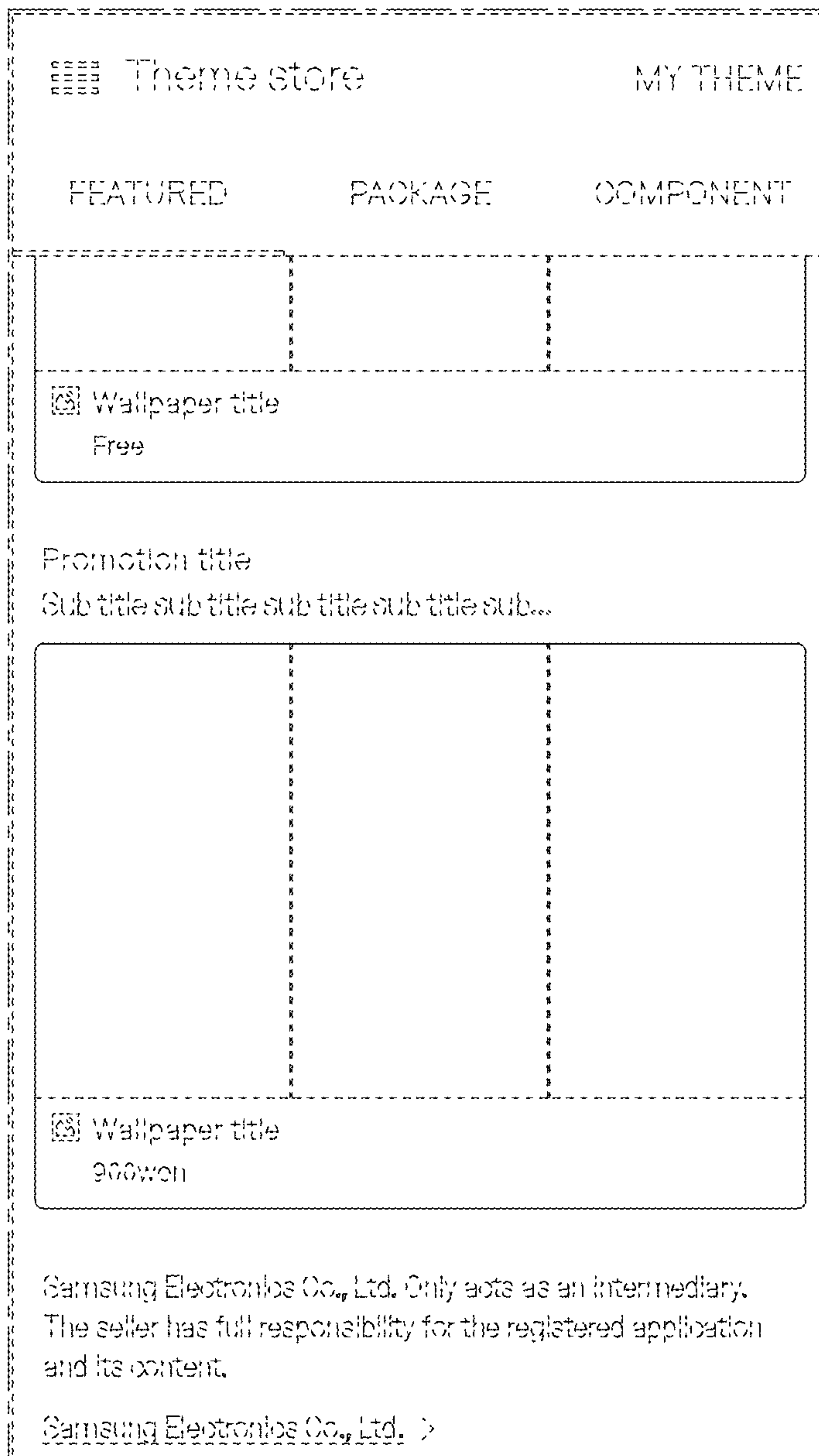
