(57) **CLAIM**

The ornamental design for a display screen with icons, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with icons showing our new design; and, FIG. 2 is a front view of a second embodiment thereof. The changes in greyscale in the drawings correspond to relative changes in color gradation. The outermost broken line showing of the display screen with icons is included for the purpose of illustrating the article and forms no part of the claimed design. The broken lines within the display screen represent elements of the graphical user interface, text, and symbols that form no part of the claimed design.

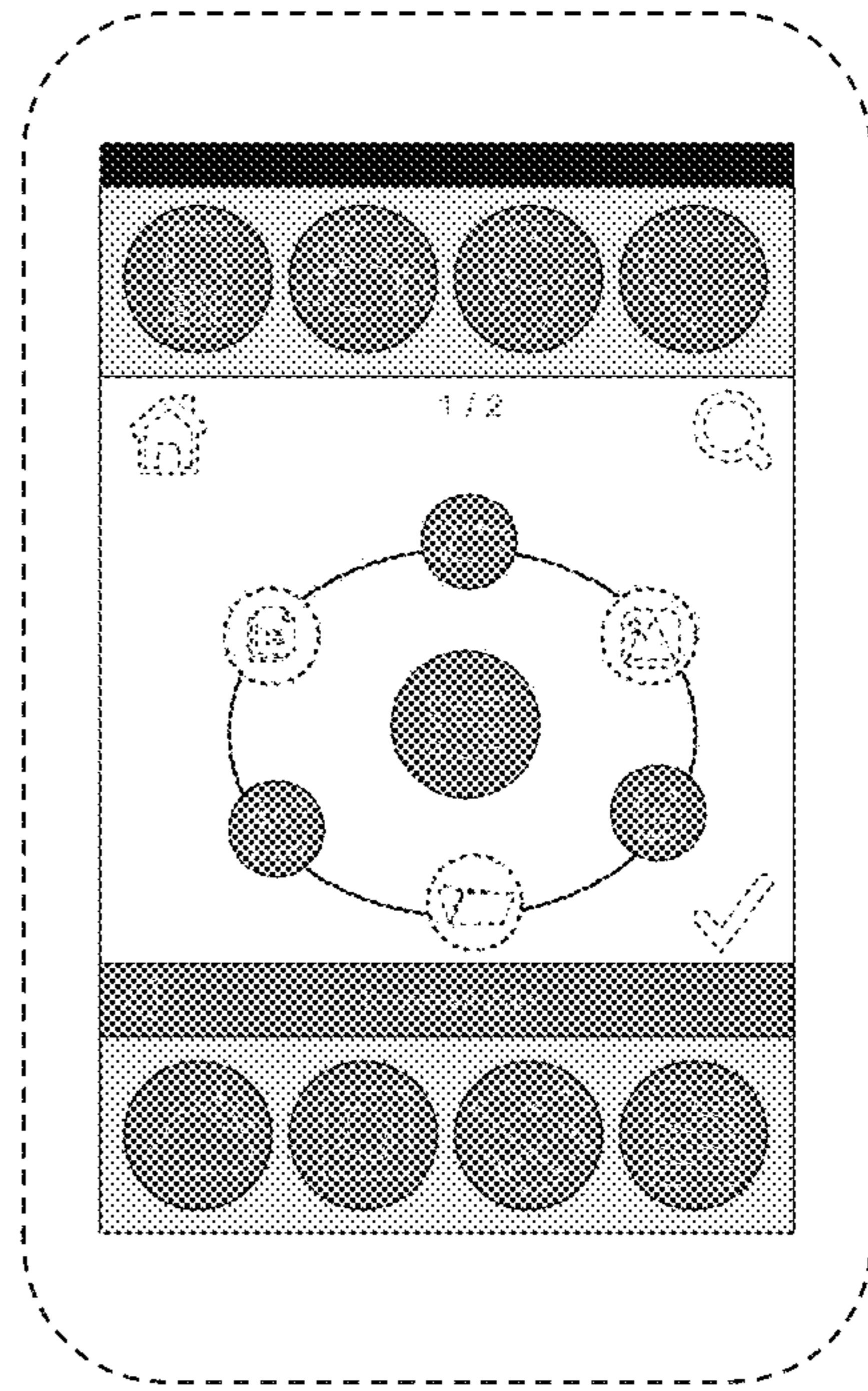
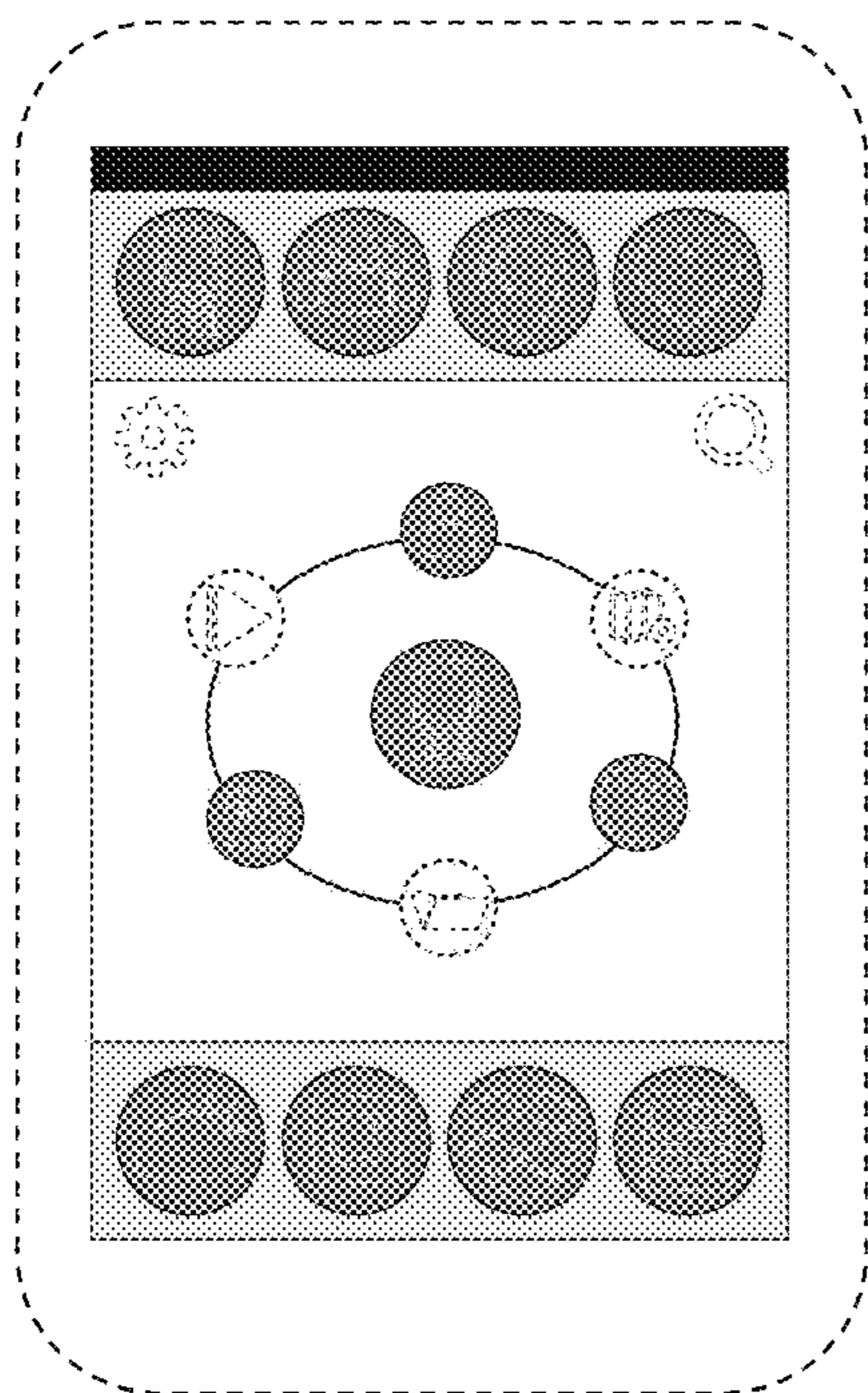

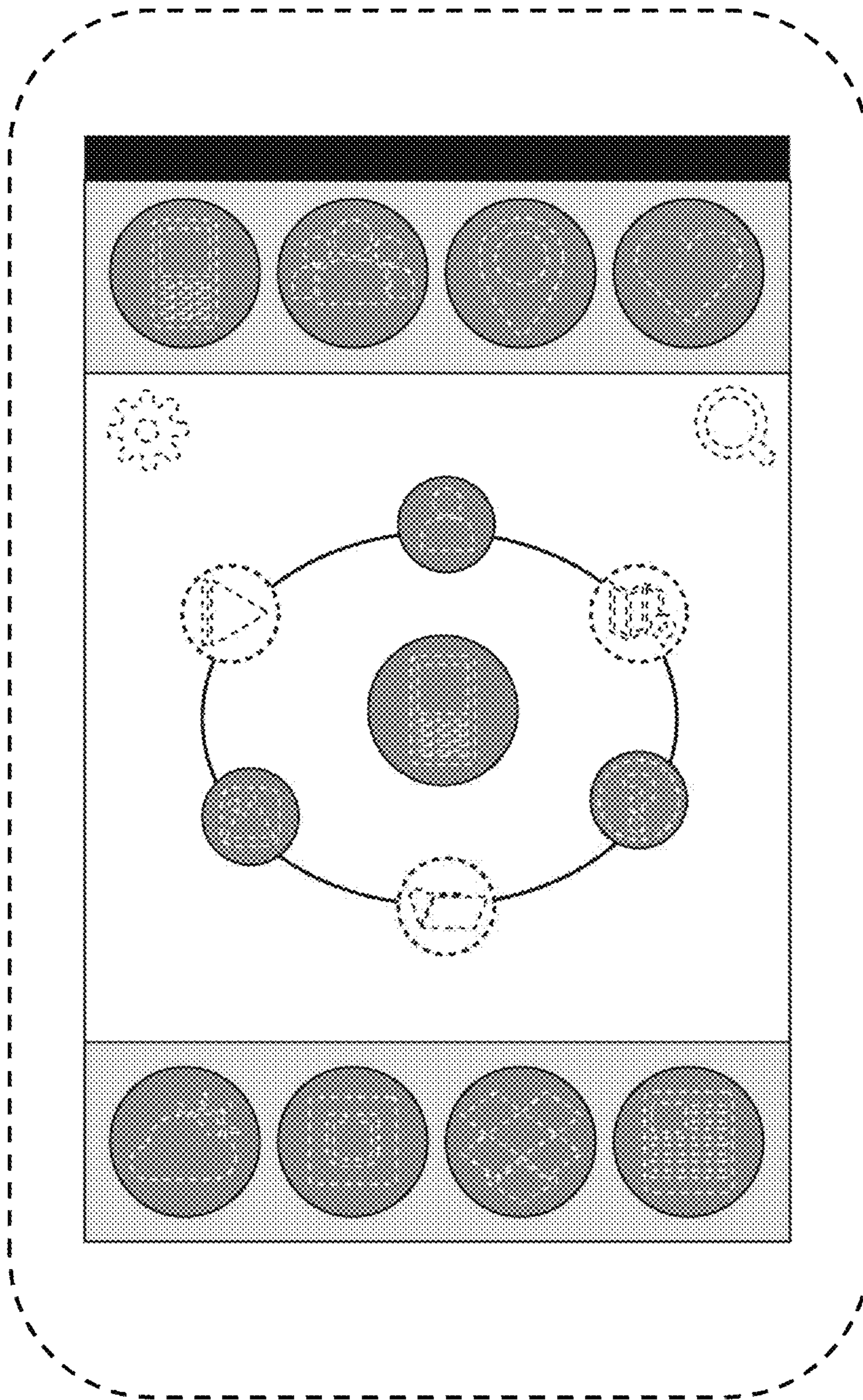
