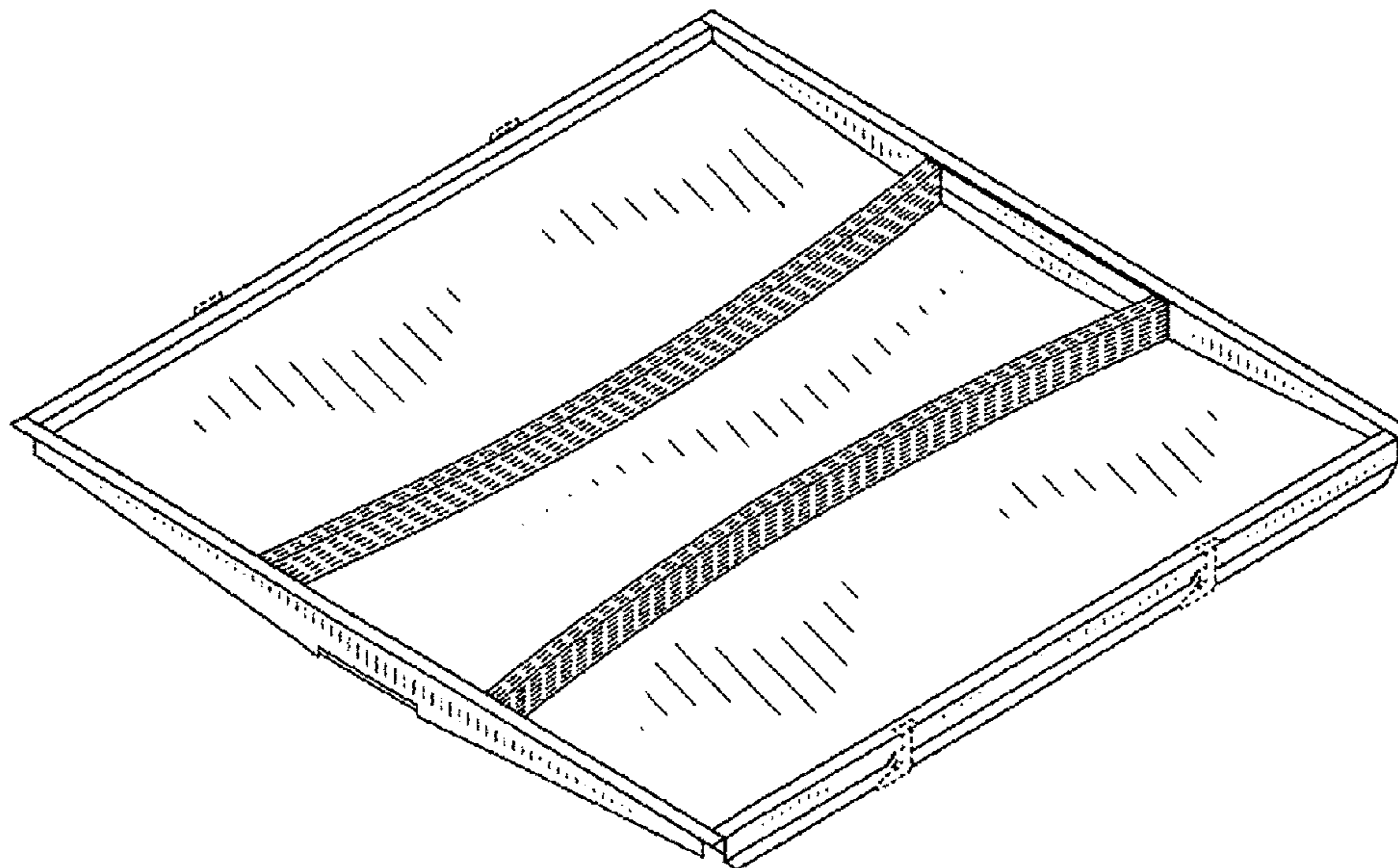
FIG. 8 is a view of the recessed light fixture cover suspended from a ceiling.

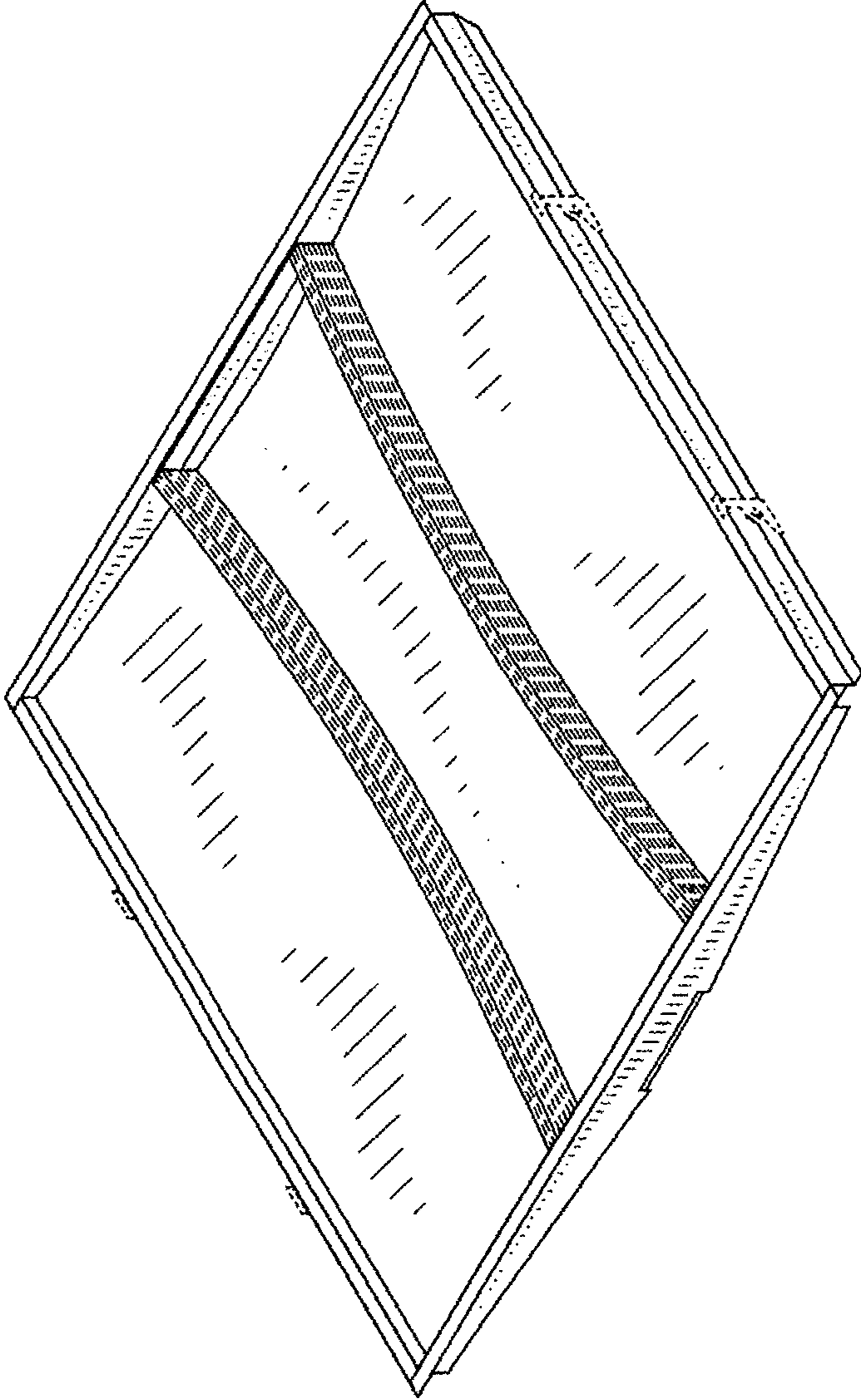

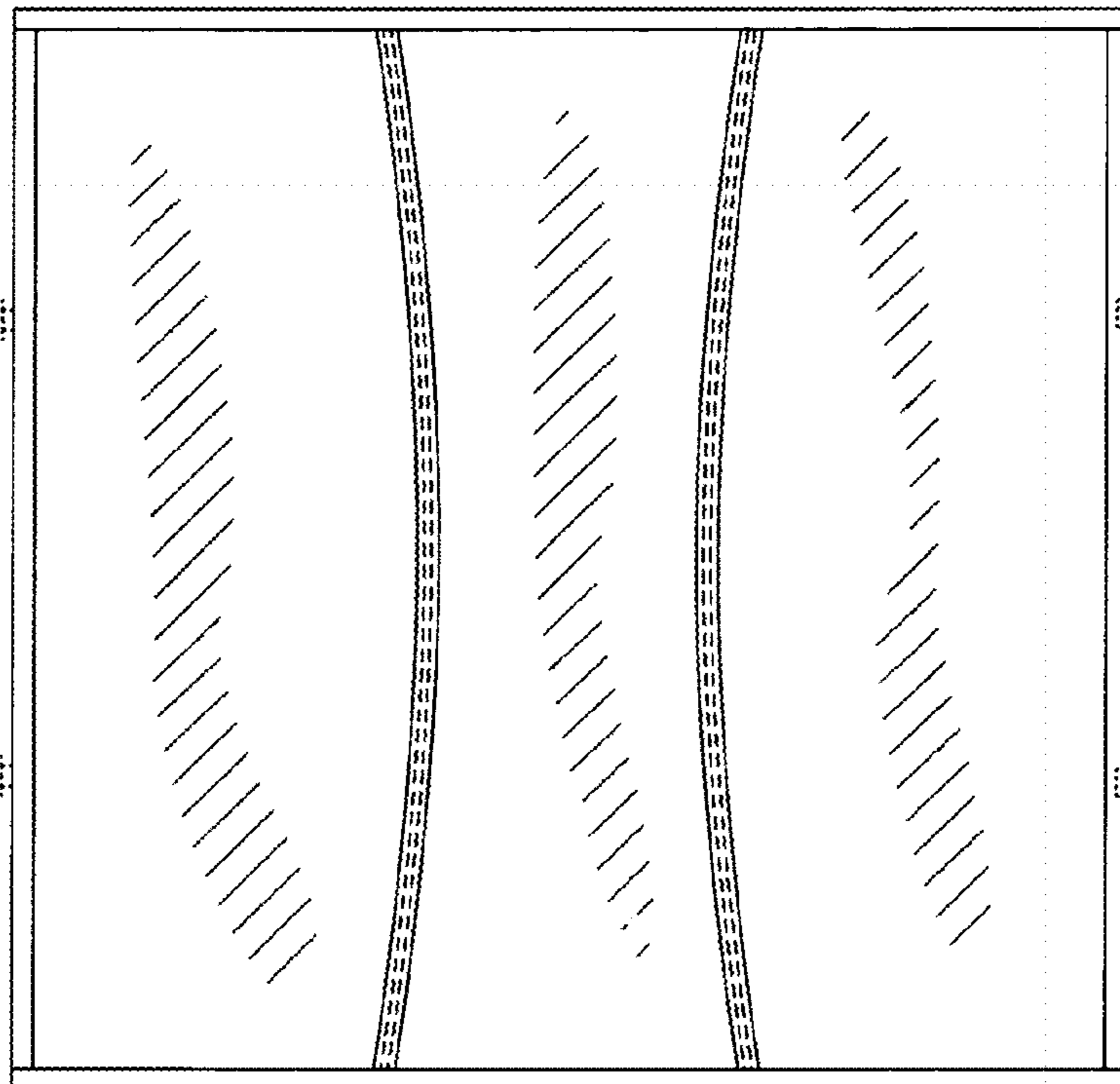

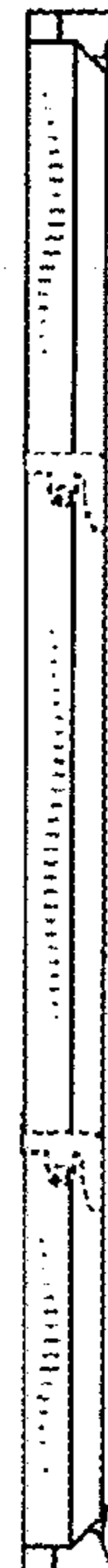

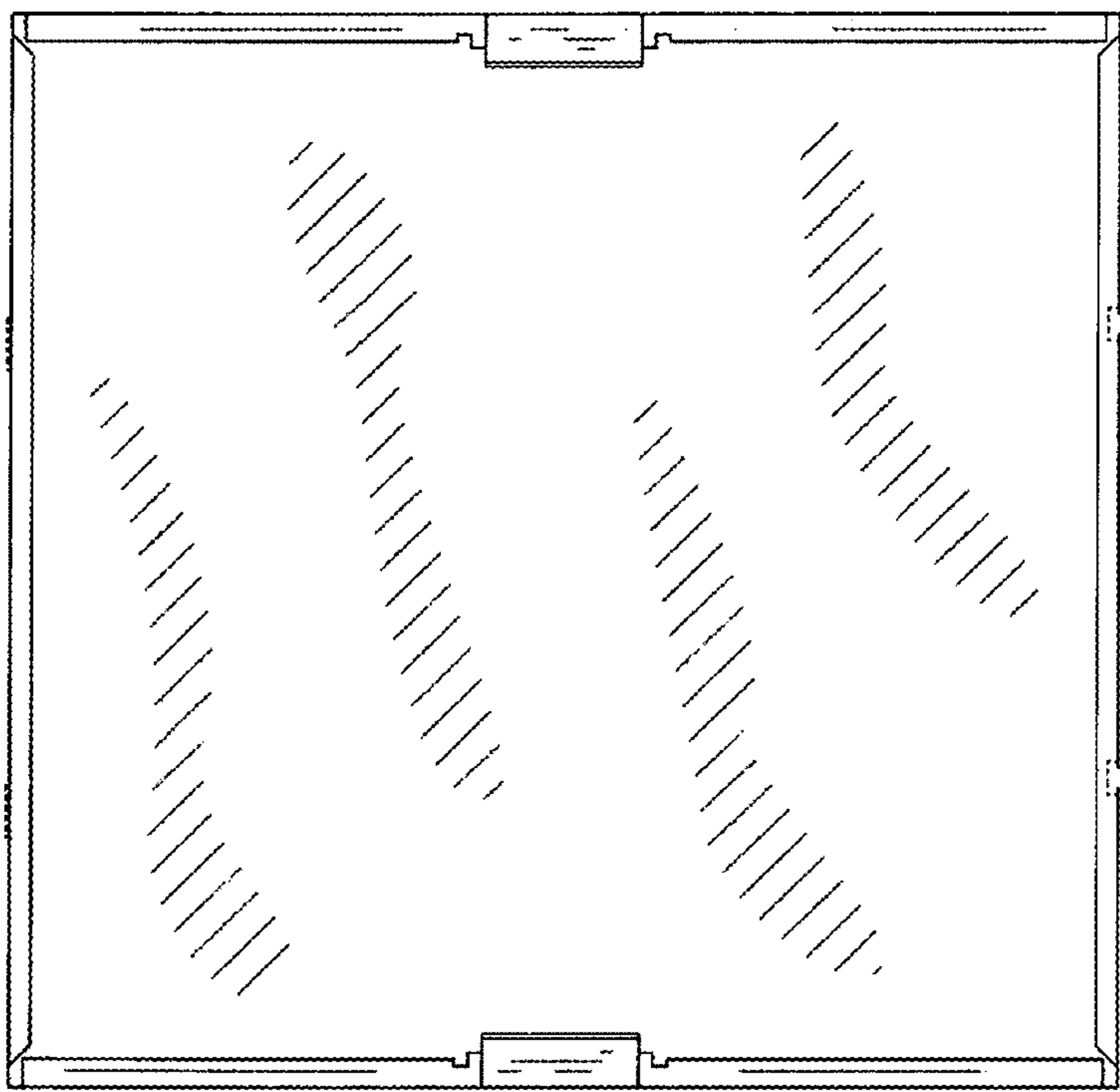

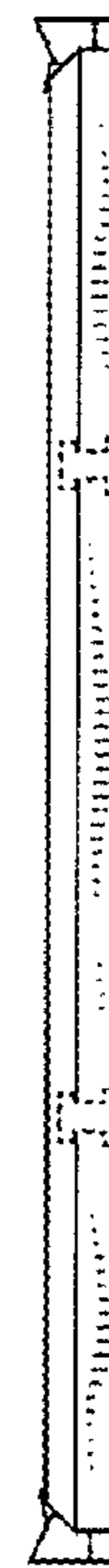

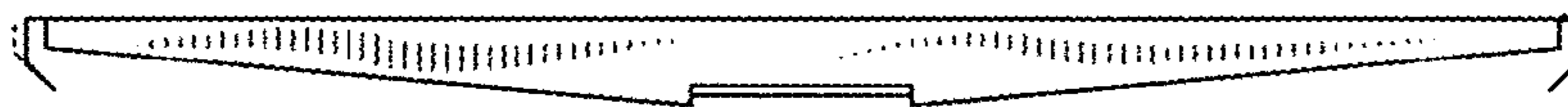

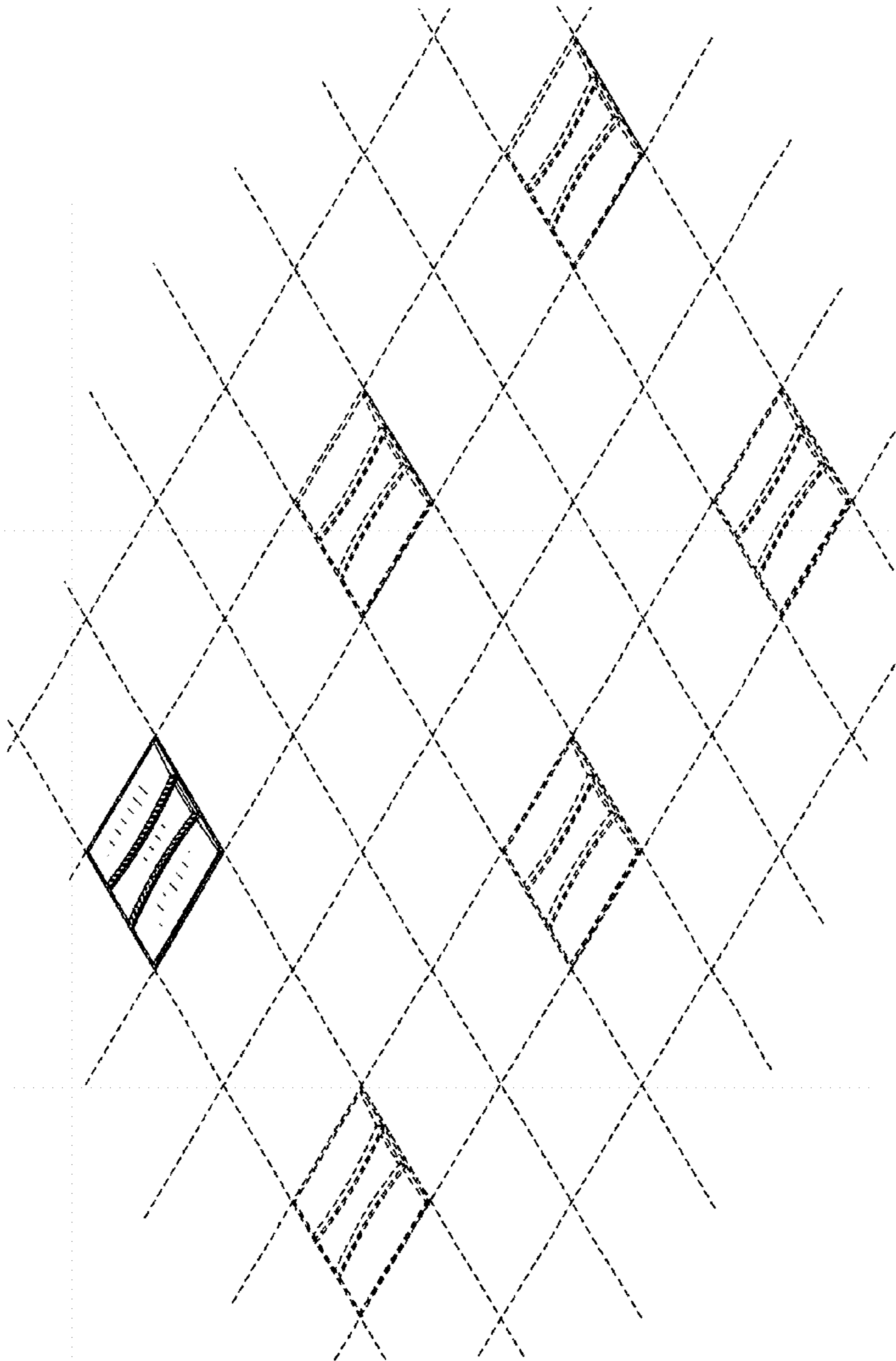
