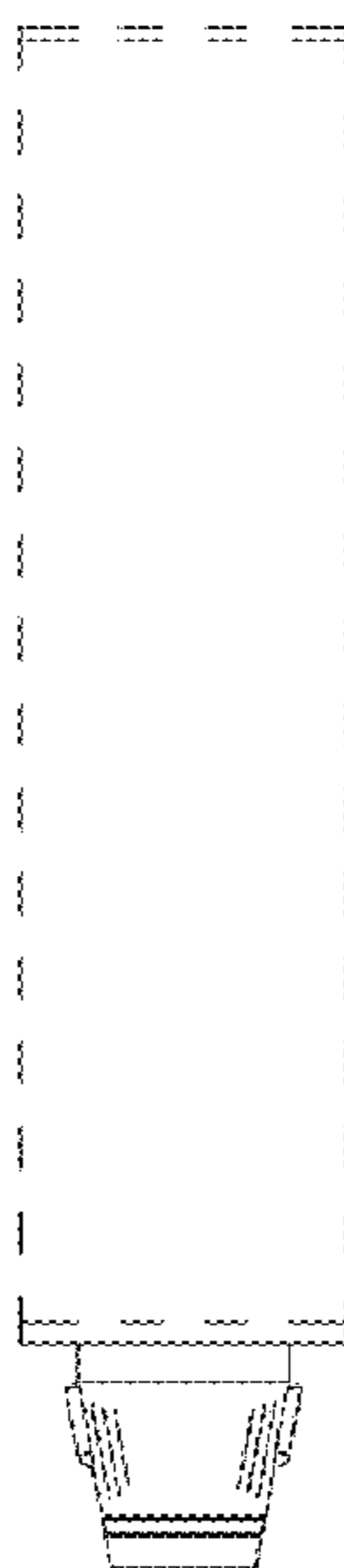
(57) **CLAIM**

The ornamental design for an electronic cigarette pole, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of the electronic cigarette pole;
FIG. 2 is a rear elevation view of the electronic cigarette pole;
FIG. 3 is a left side elevation view of the electronic cigarette pole;
FIG. 4 is a right side elevation view of the electronic cigarette pole;
FIG. 5 is a top plan the view of the electronic cigarette pole;
FIG. 6 is a bottom plan the view of the electronic cigarette pole; and,
FIG. 7 is a perspective view of the electronic cigarette pole. The broken lines show portions of the electronic cigarette pole that form no part of the claimed design.

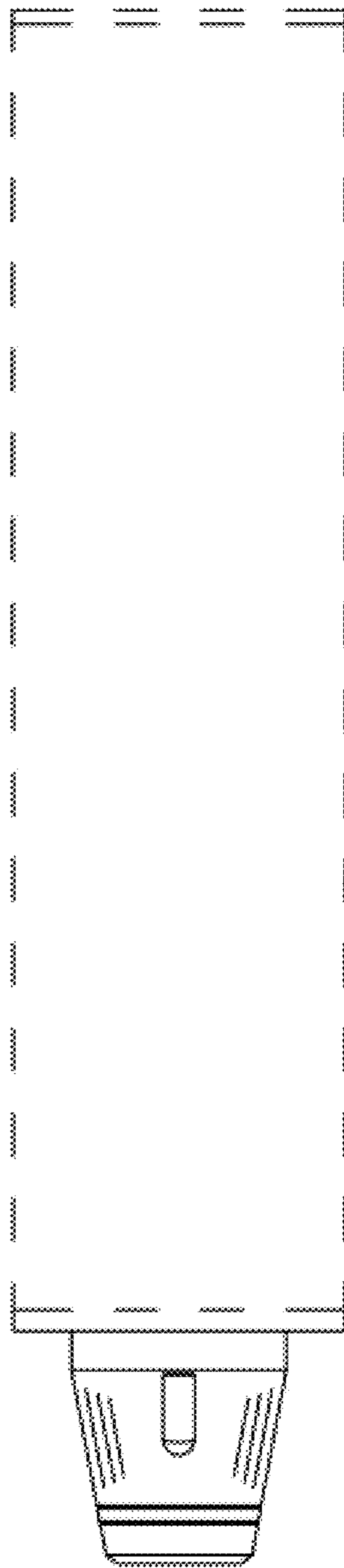

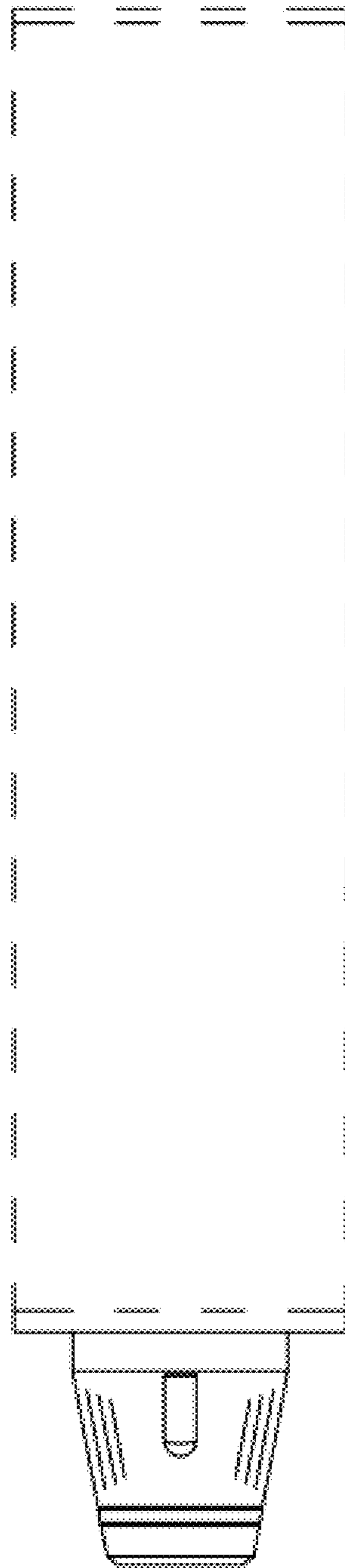

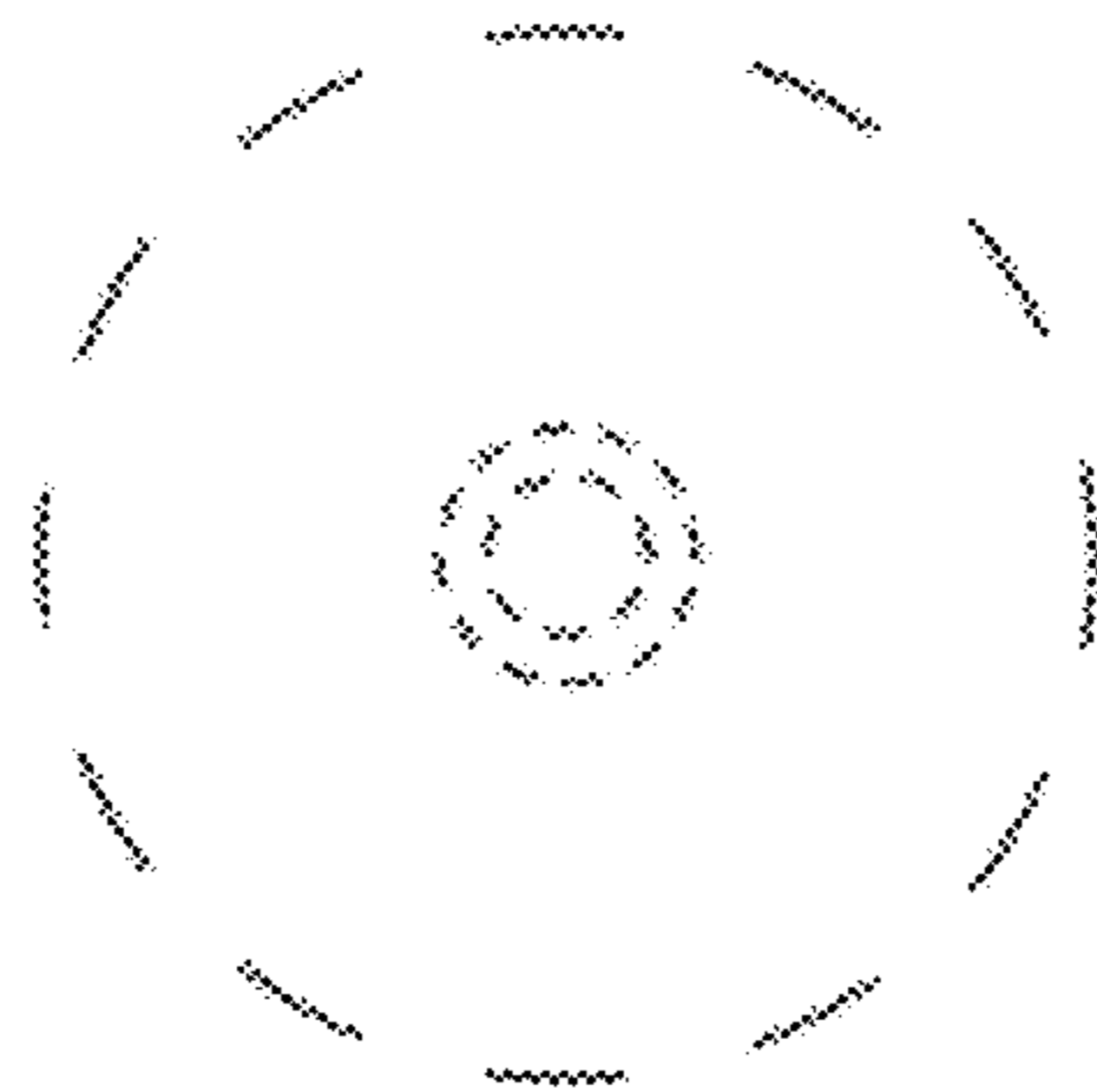

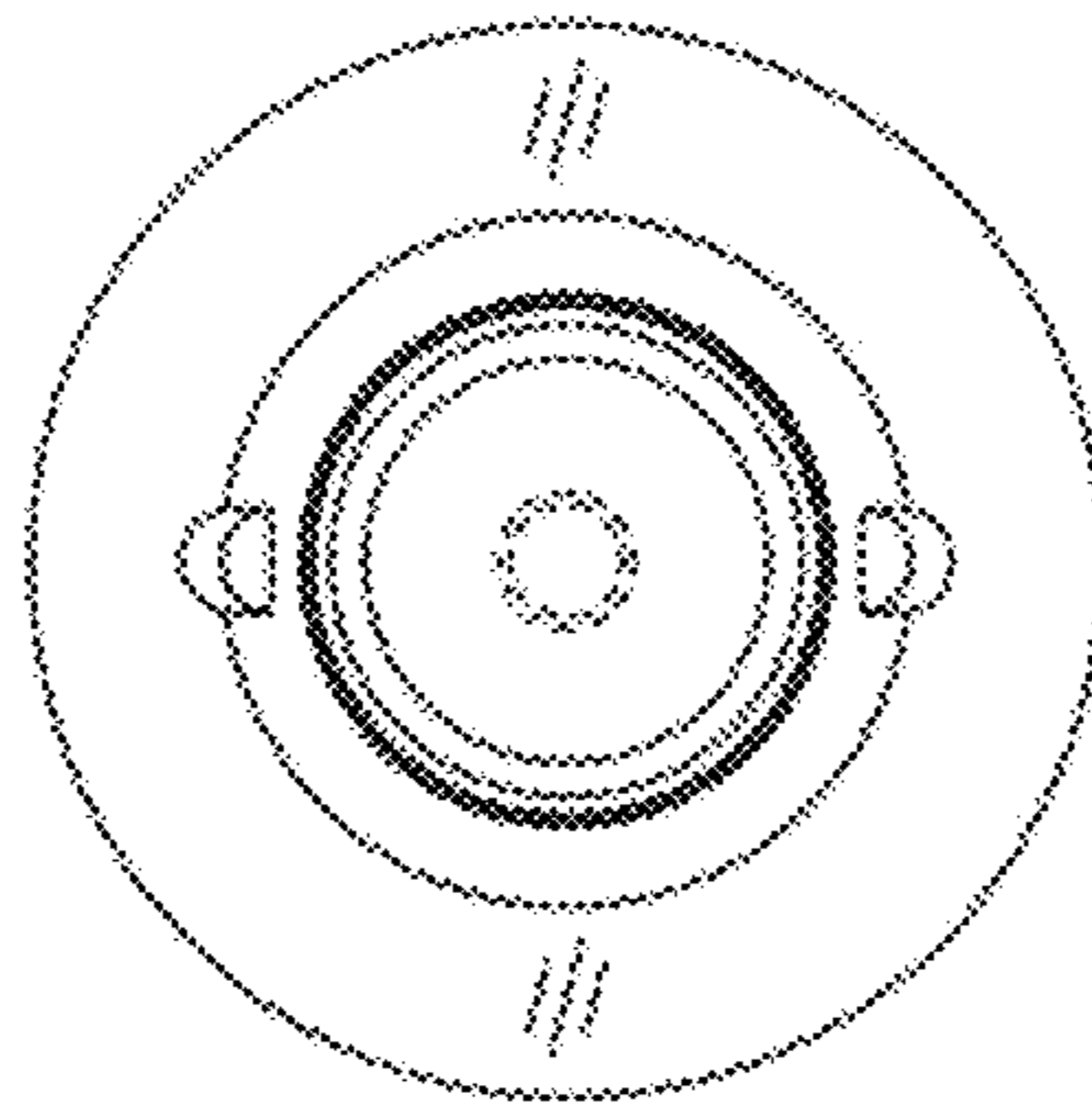

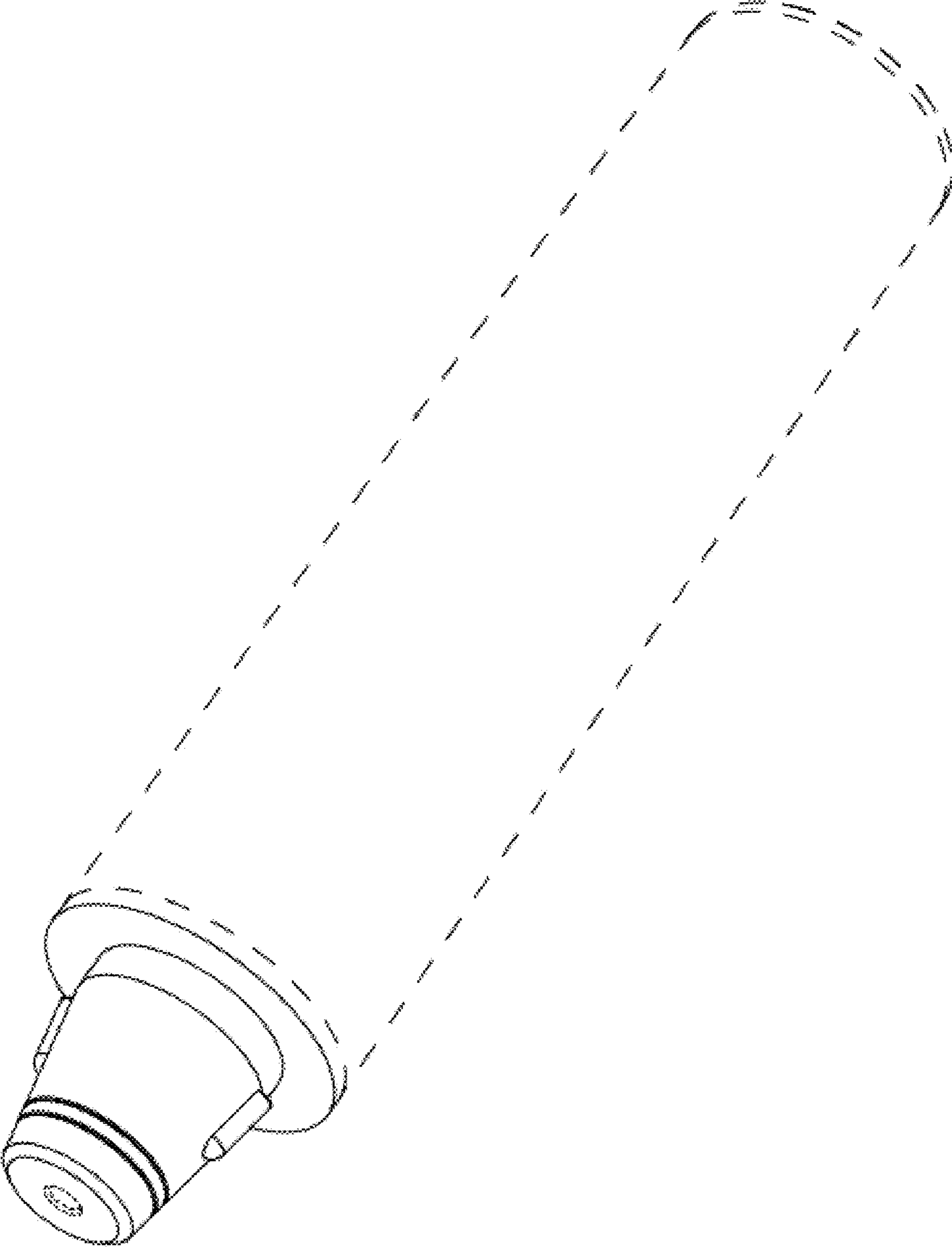
