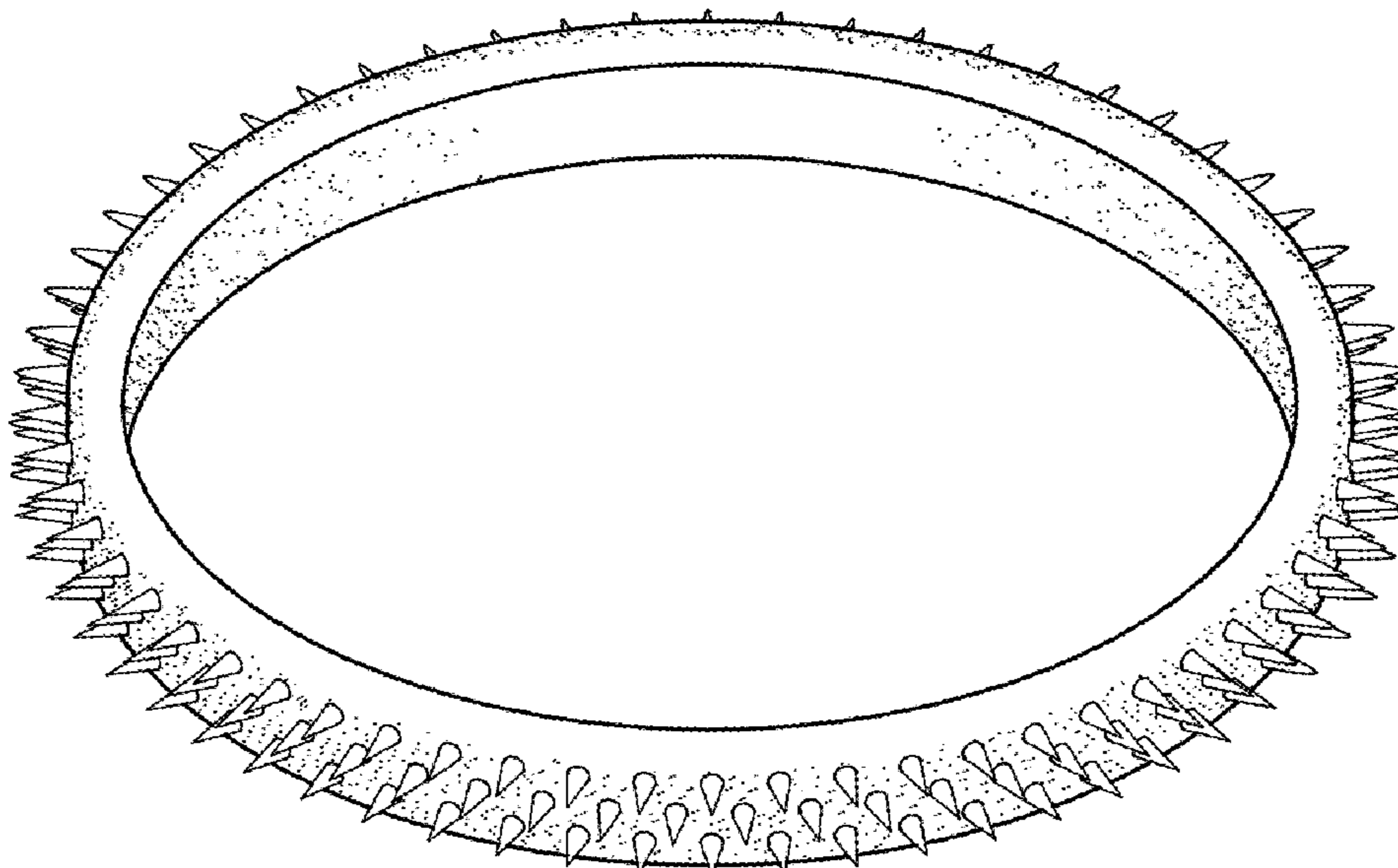
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a non-slip hair band showing  
our new design;

in which the non-slip hair band is used as a headwrap.

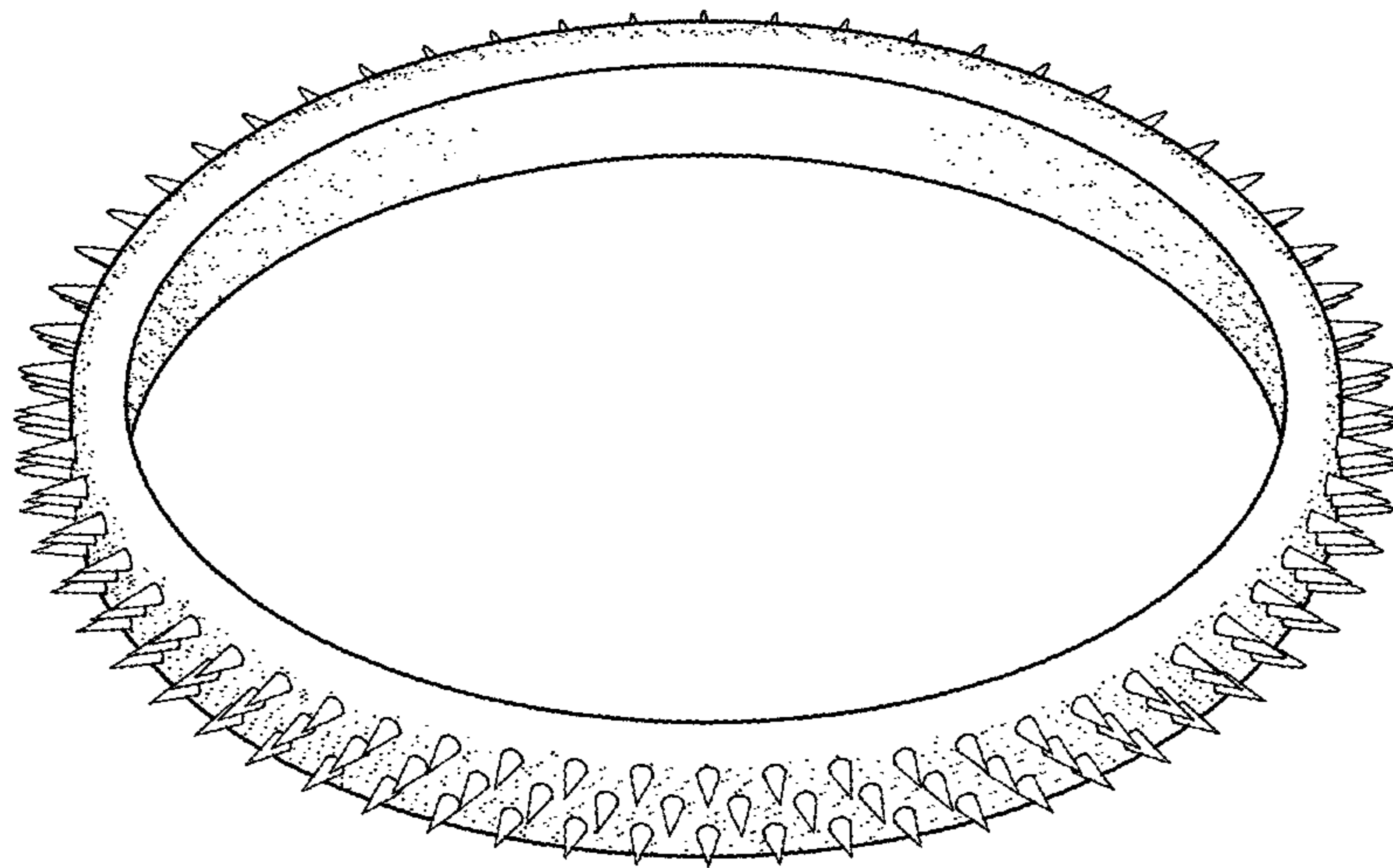

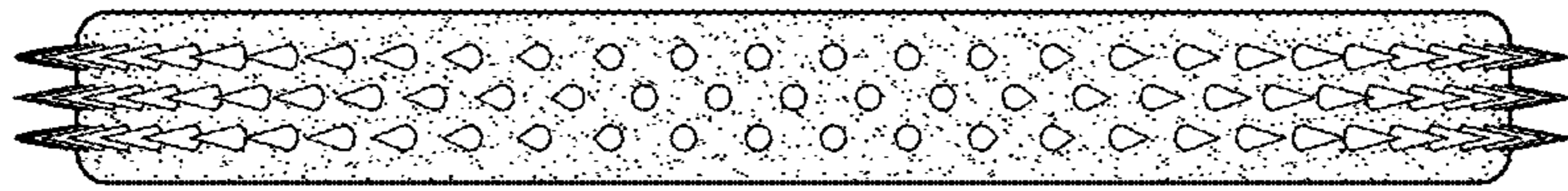

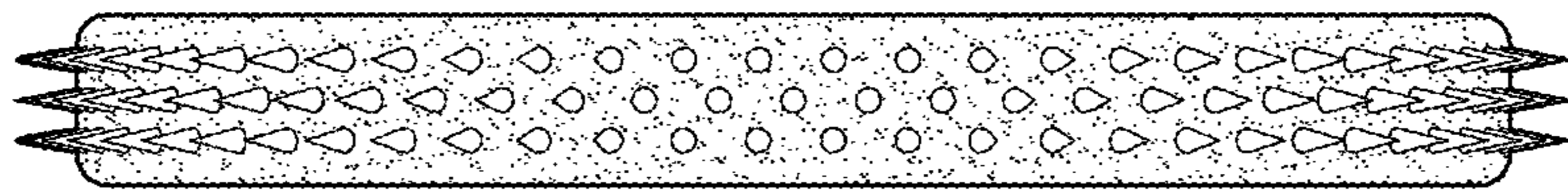

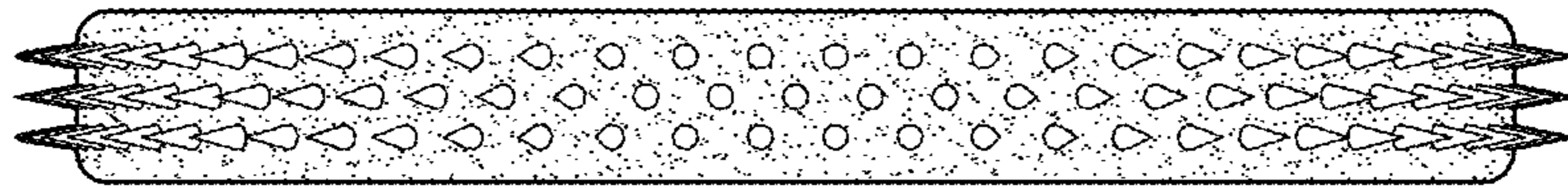

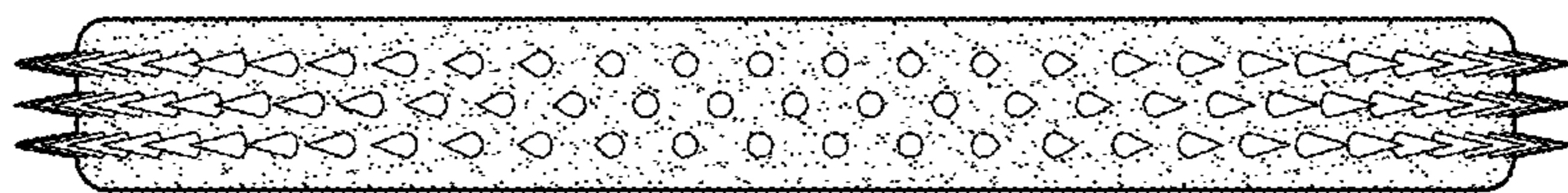

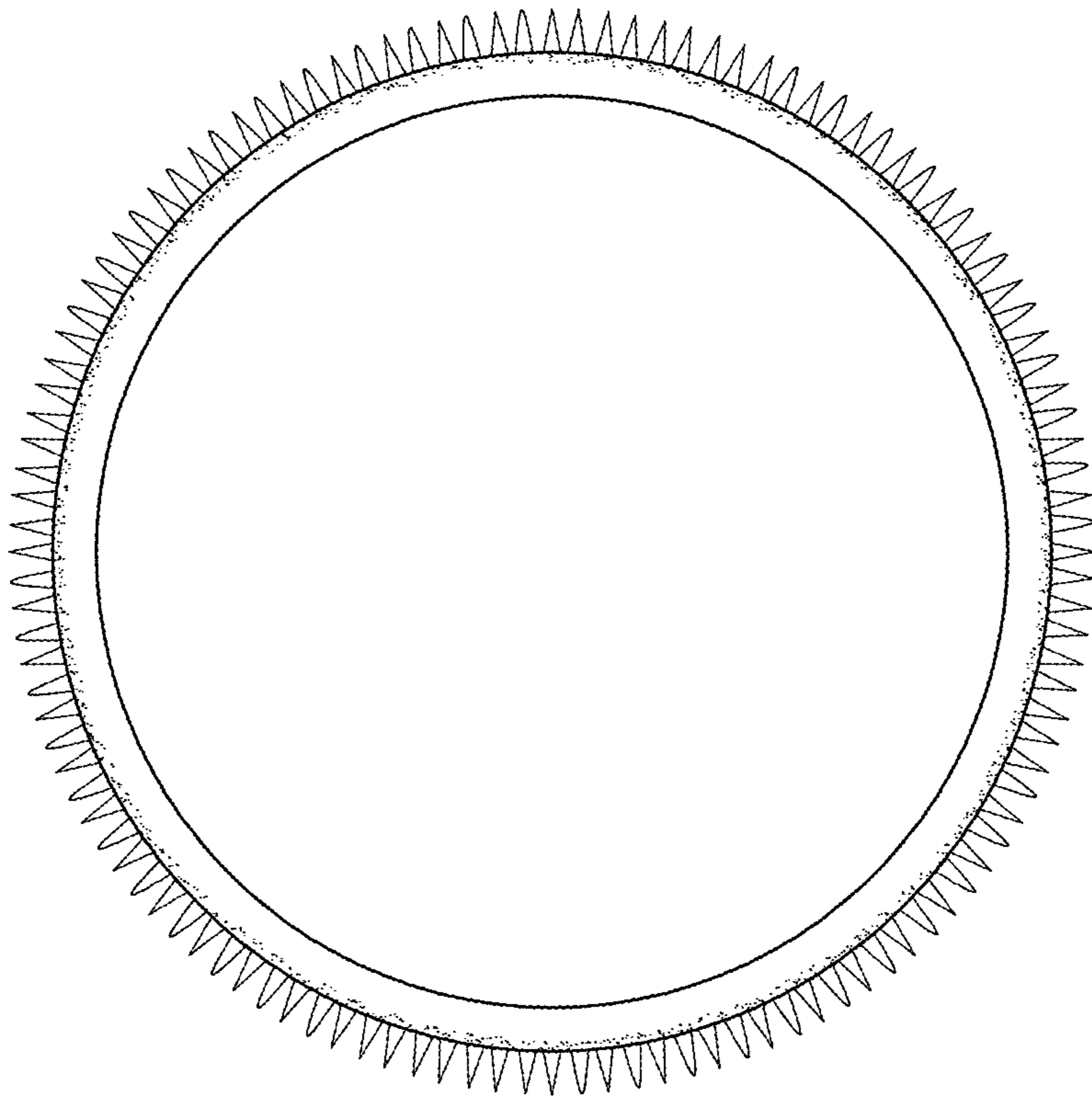

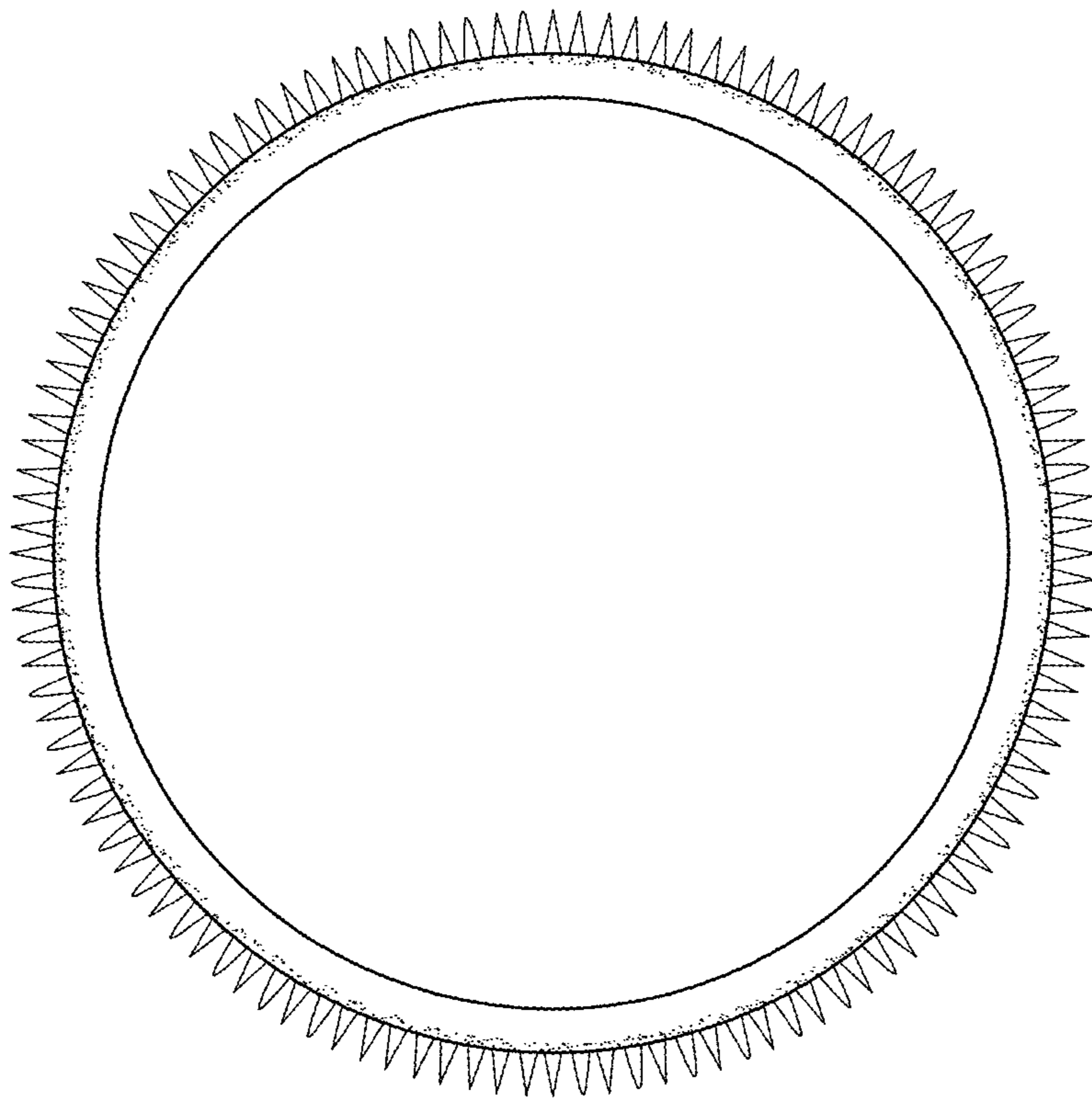

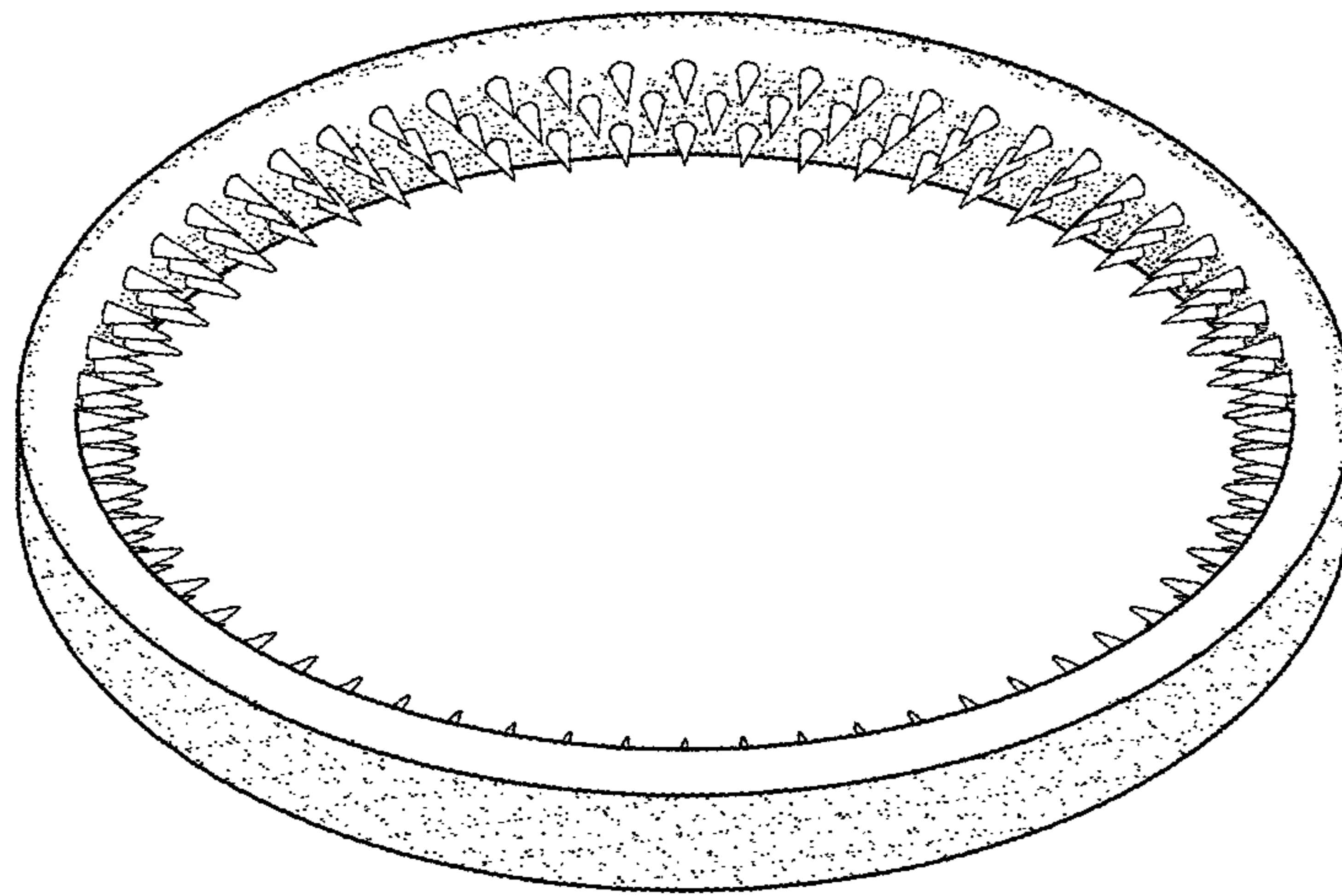

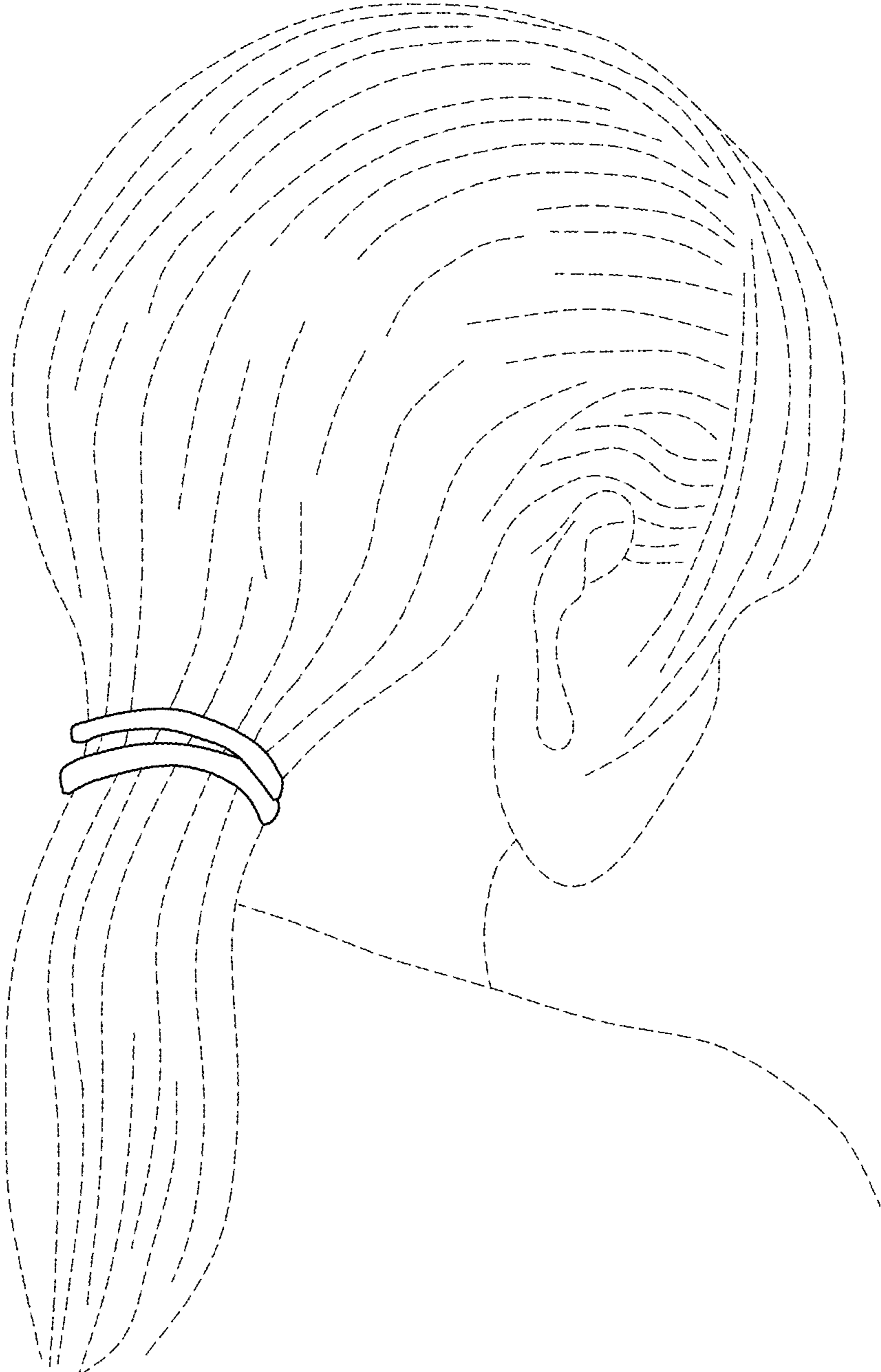

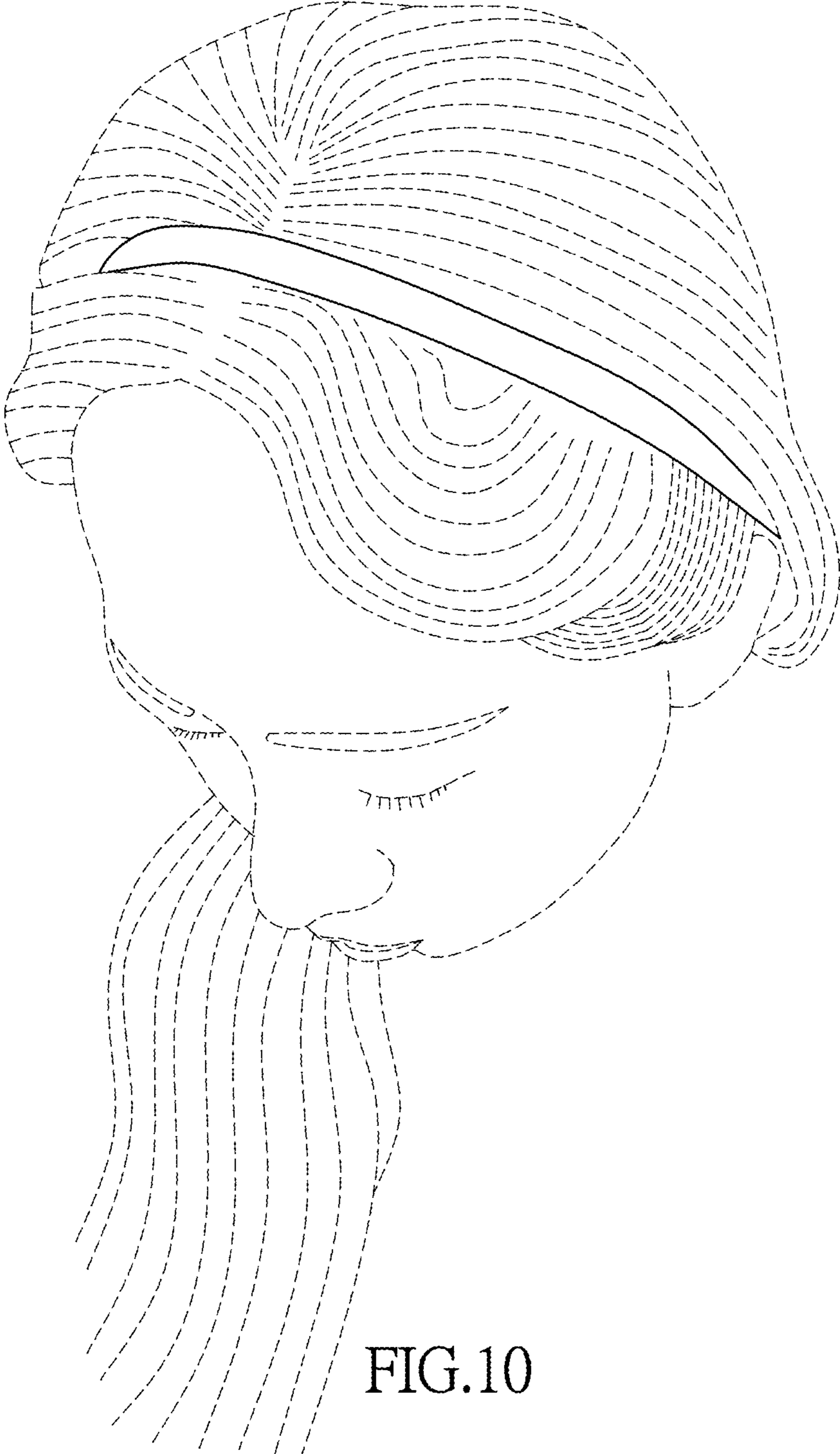
