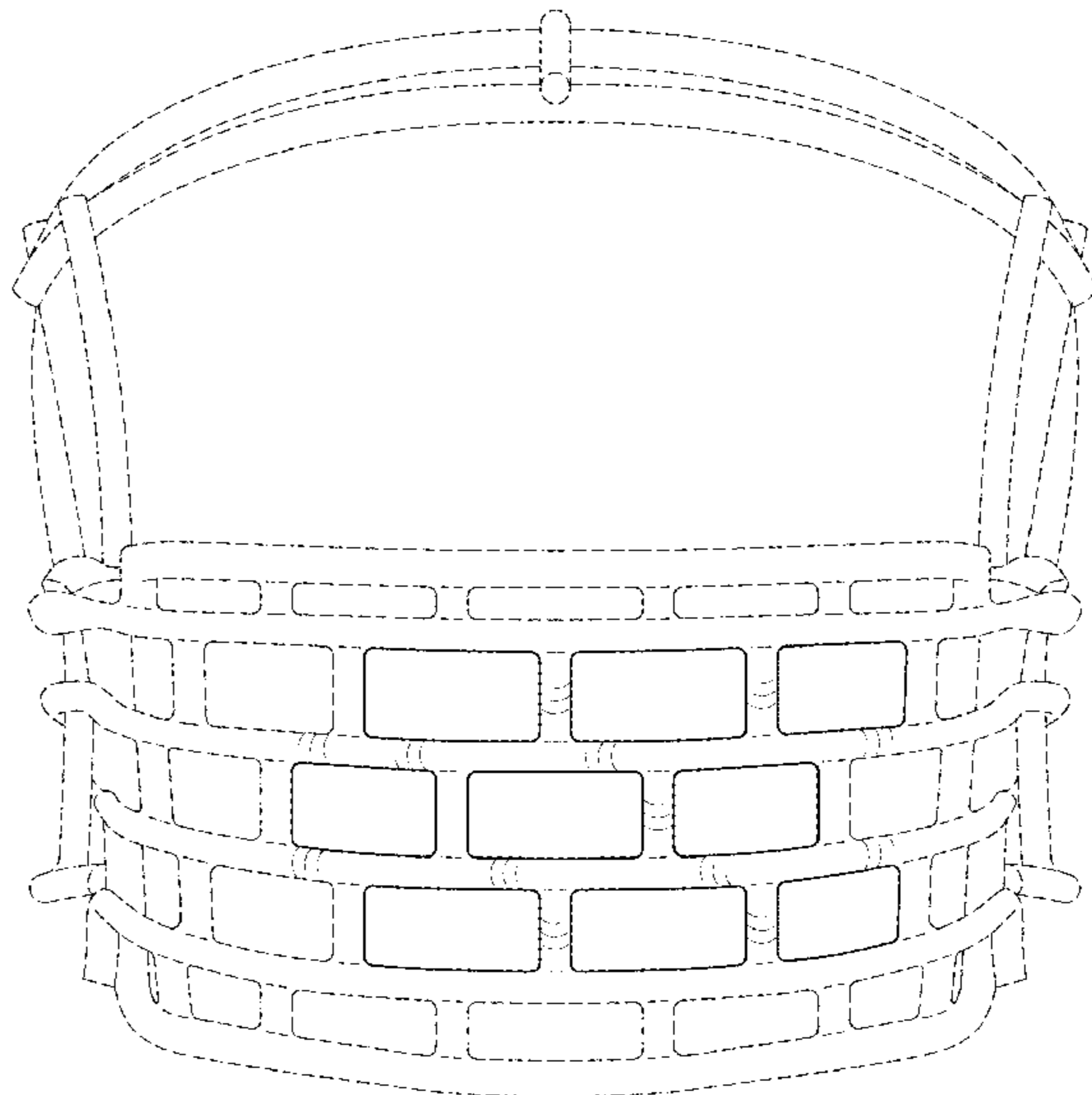
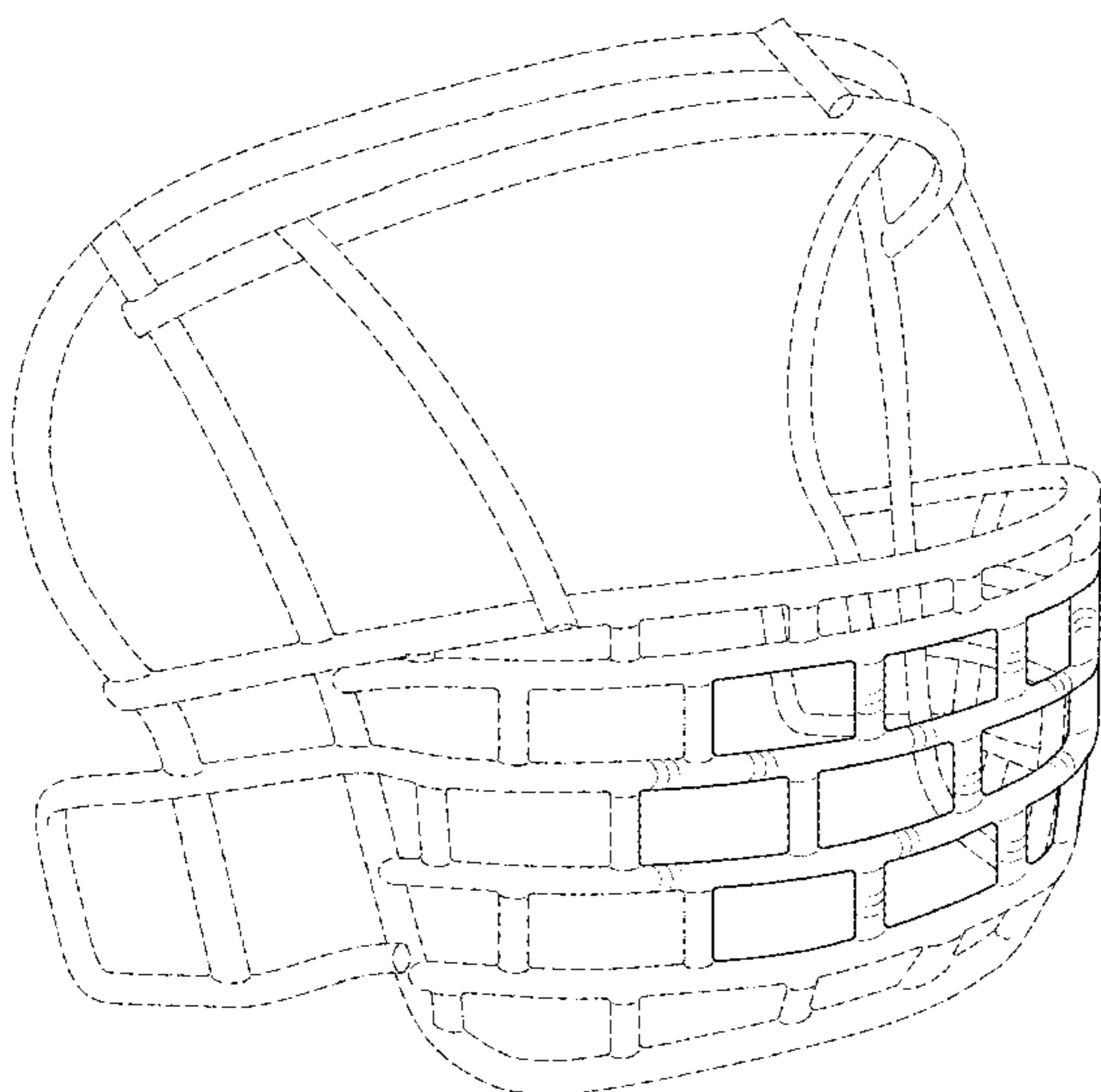
(57) **CLAIM**

The ornamental design for a sports helmet with brick-shaped facemask, as shown and described.

DESCRIPTION

FIG. 1 is front perspective view of a sports helmet with brick-shaped facemask showing my new design;
 FIG. 2 is a front view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is a left side view thereof; and,
 FIG. 5 is a top view thereof.
 The broken lines shown in the drawings represent portions of the sports helmet with brick-shaped facemask that form no part of the claimed design. All surfaces not shown form no part of the claimed design.

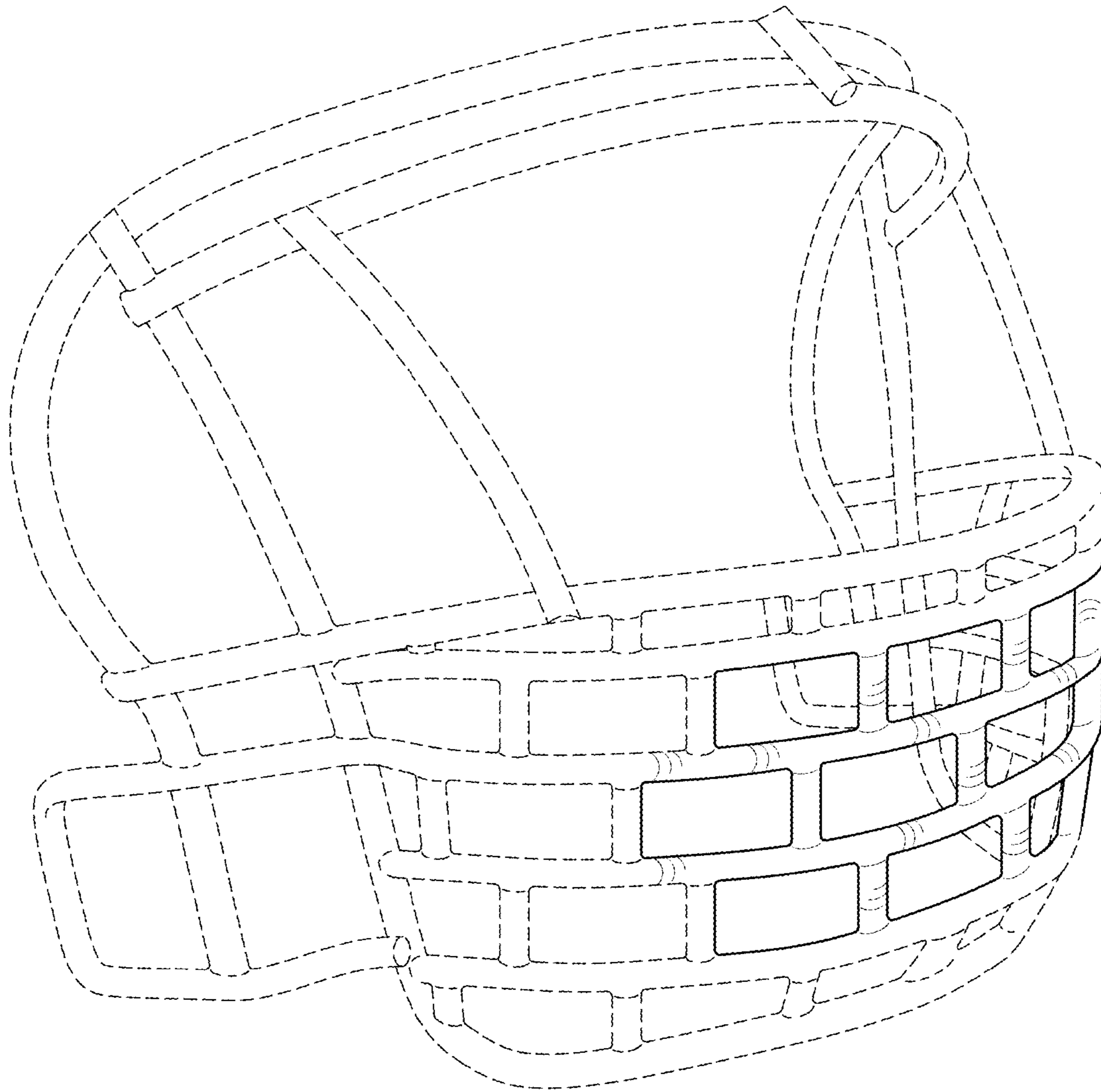

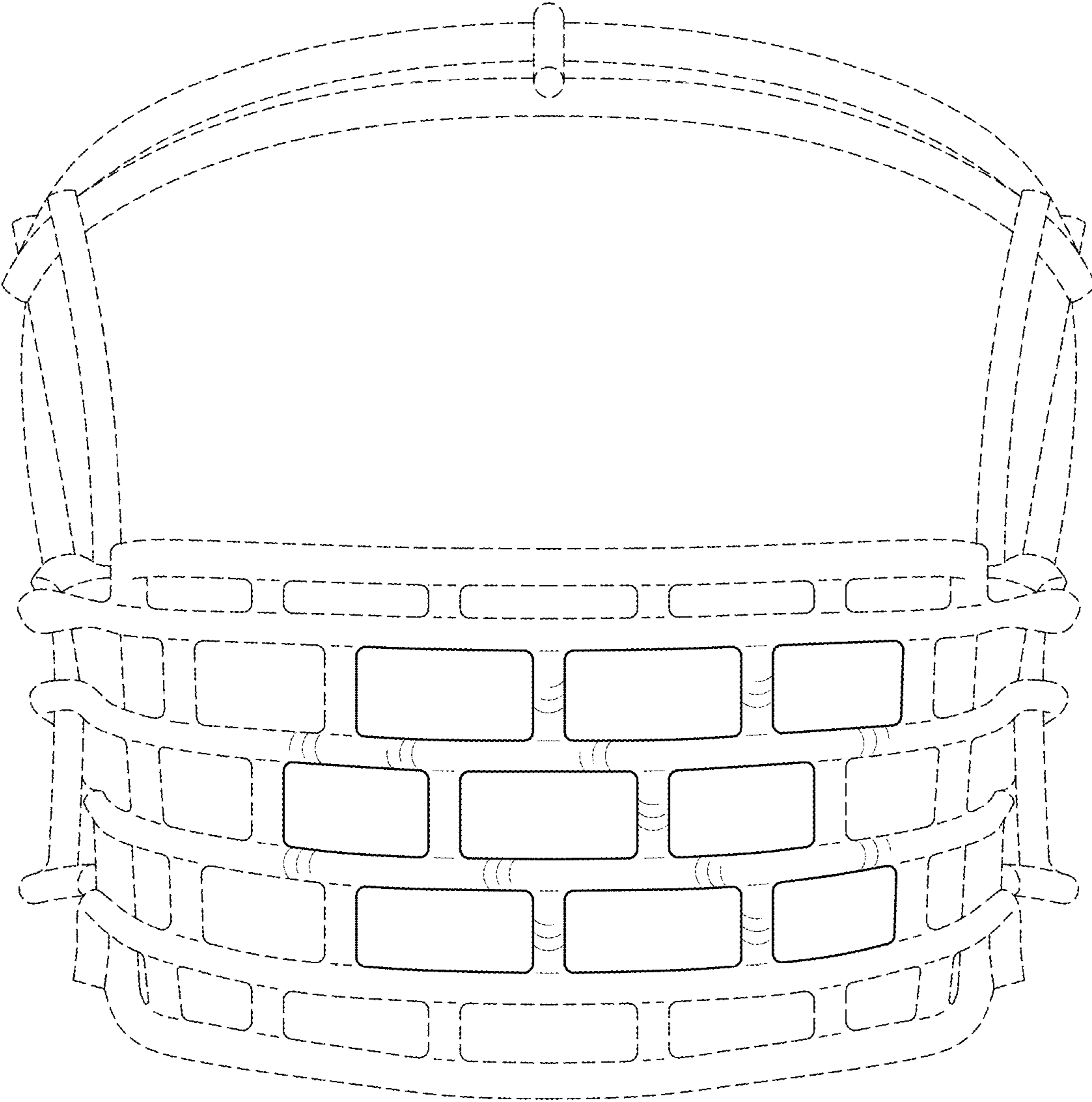

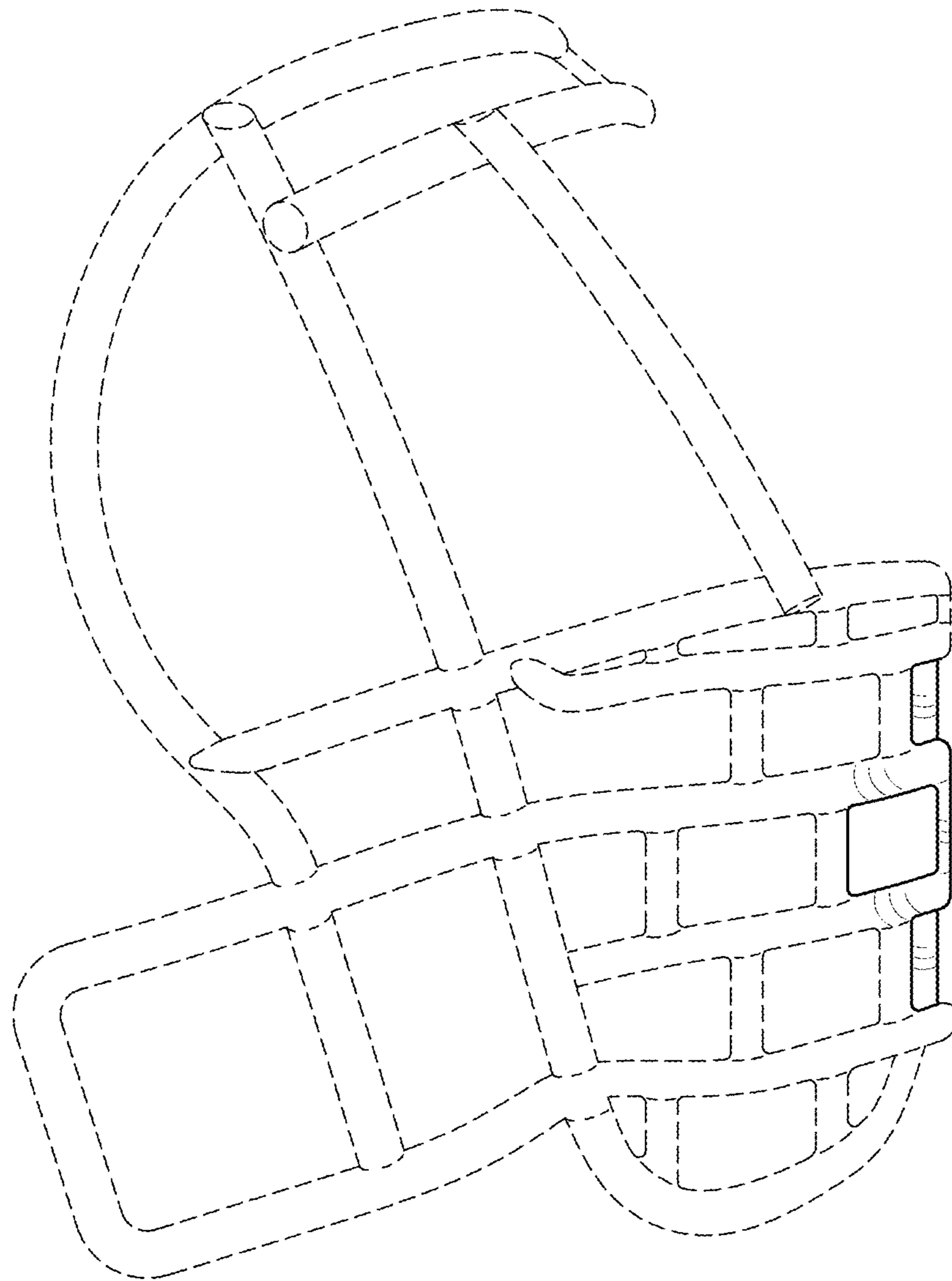

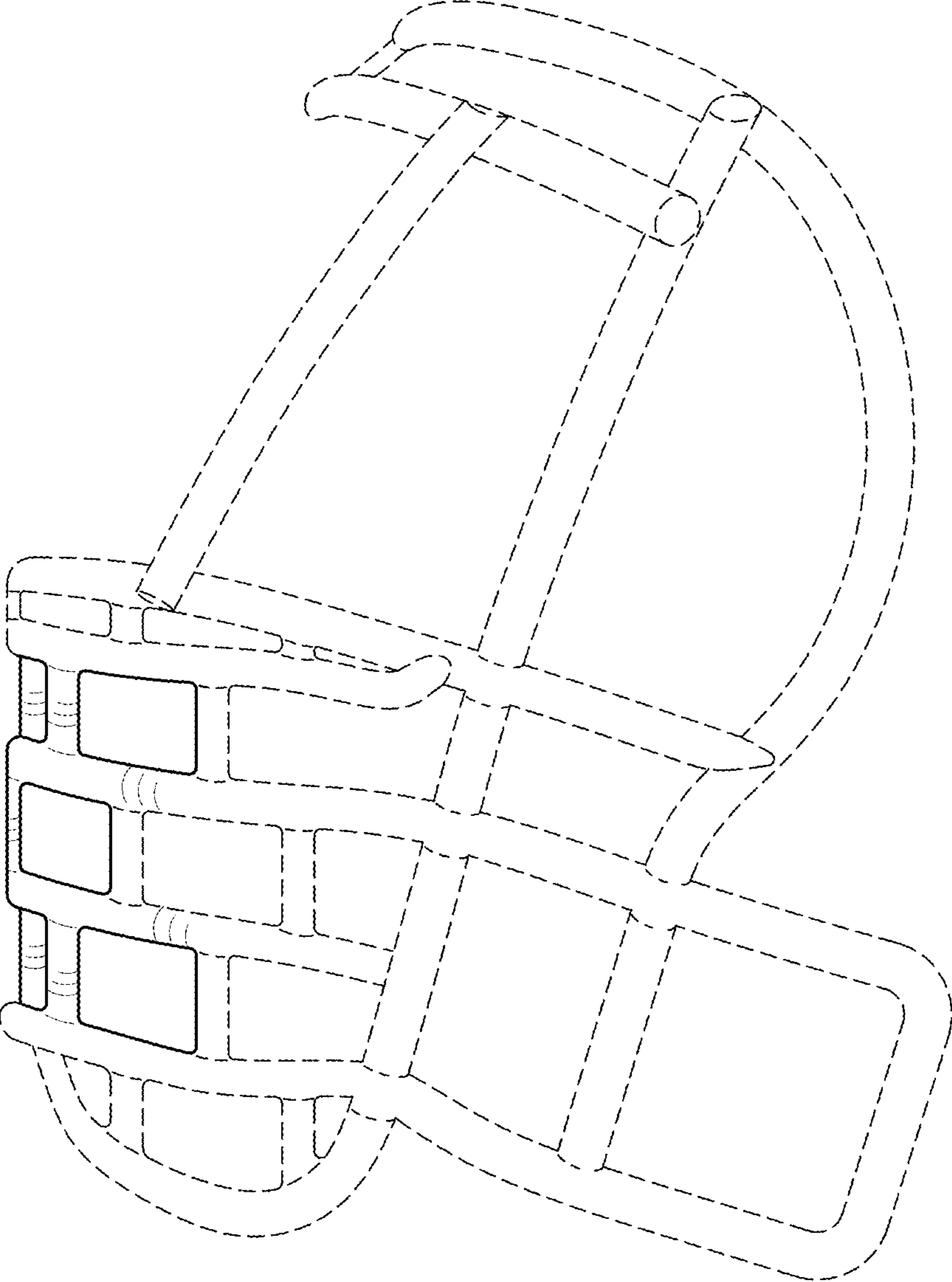

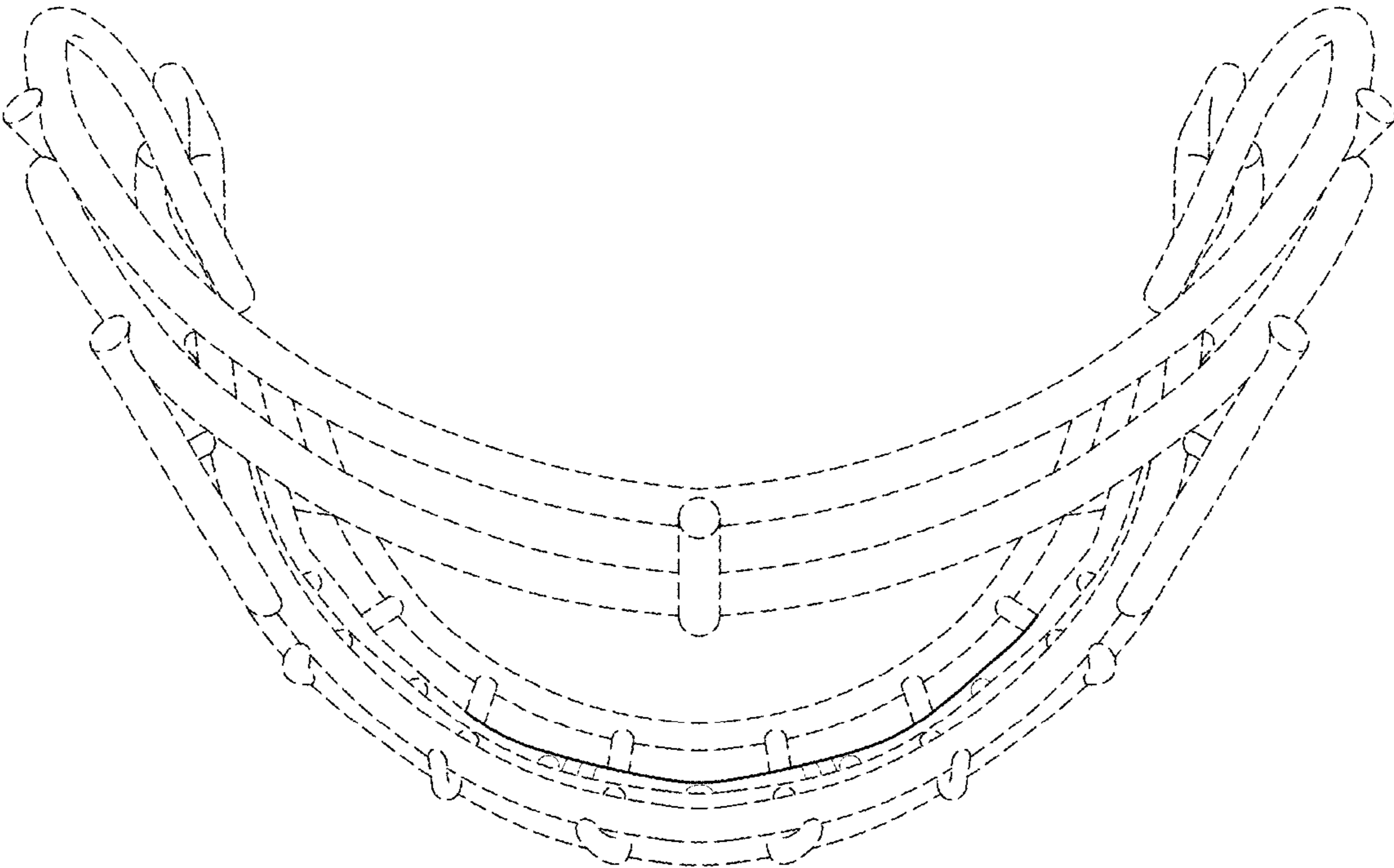
