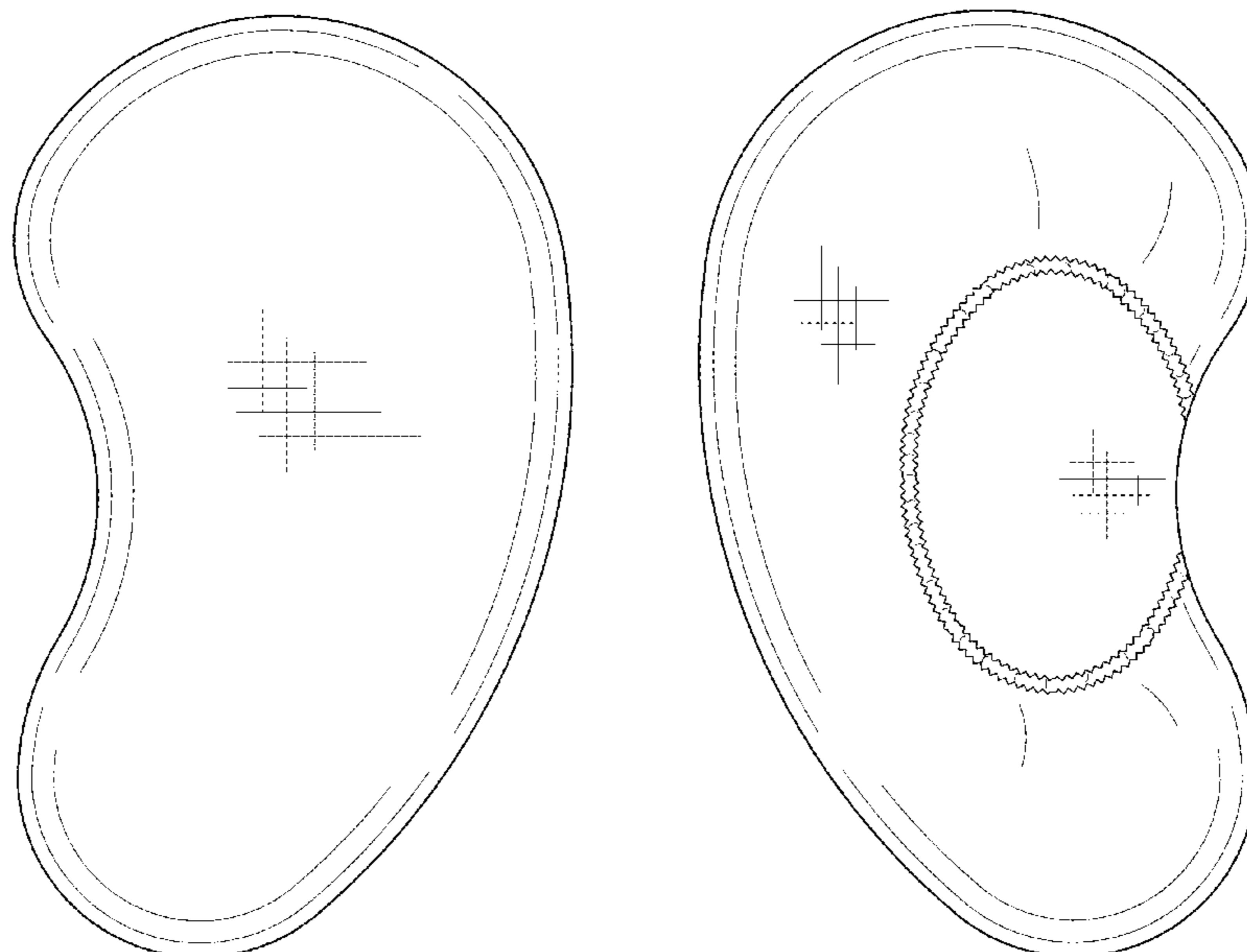
(57) **CLAIM**

The ornamental design for an ear protector, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevation view of an ear protector showing my new design;  
FIG. 2 is a rear elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a top plan view thereof; and,  
FIG. 7 is an isometric view thereof.

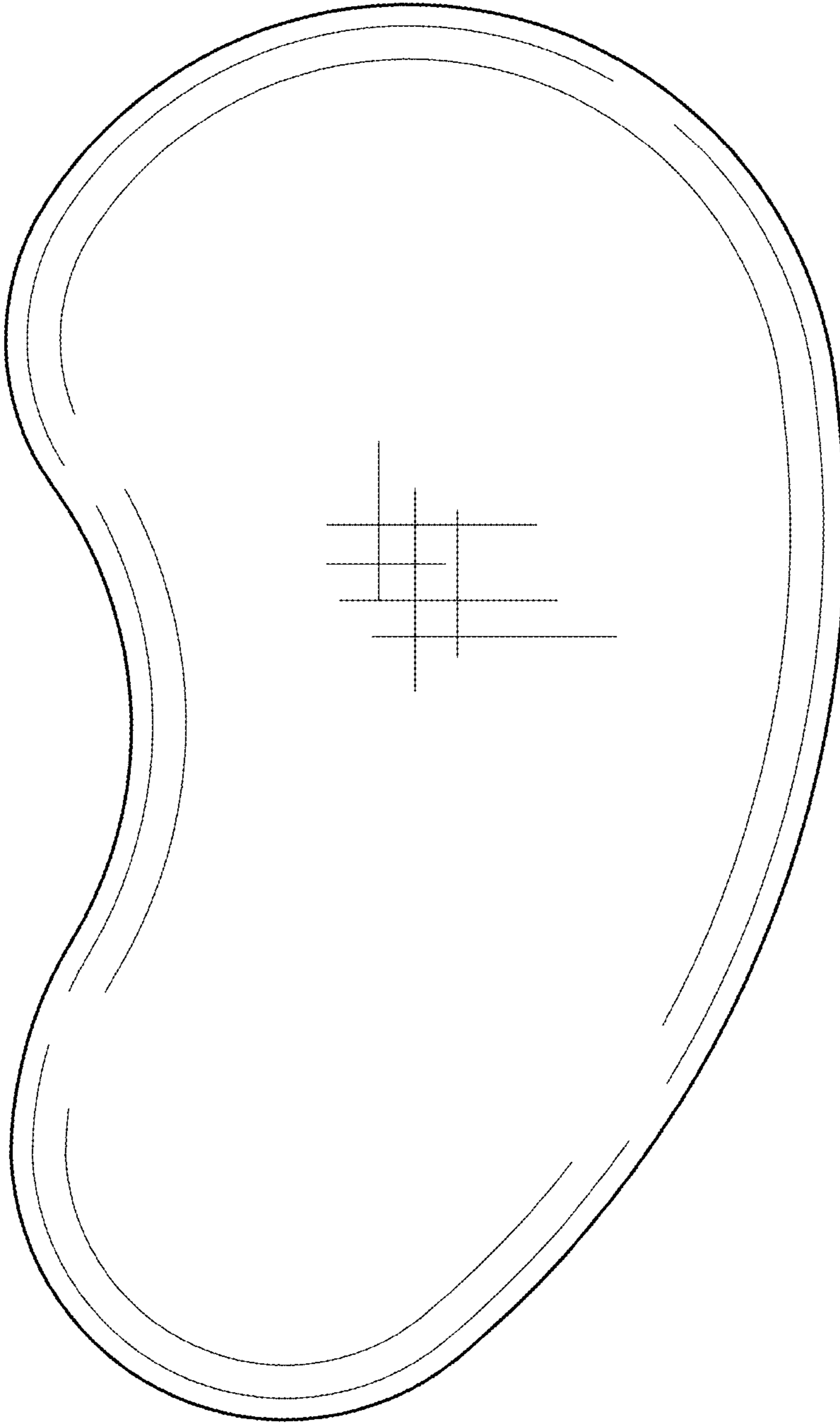

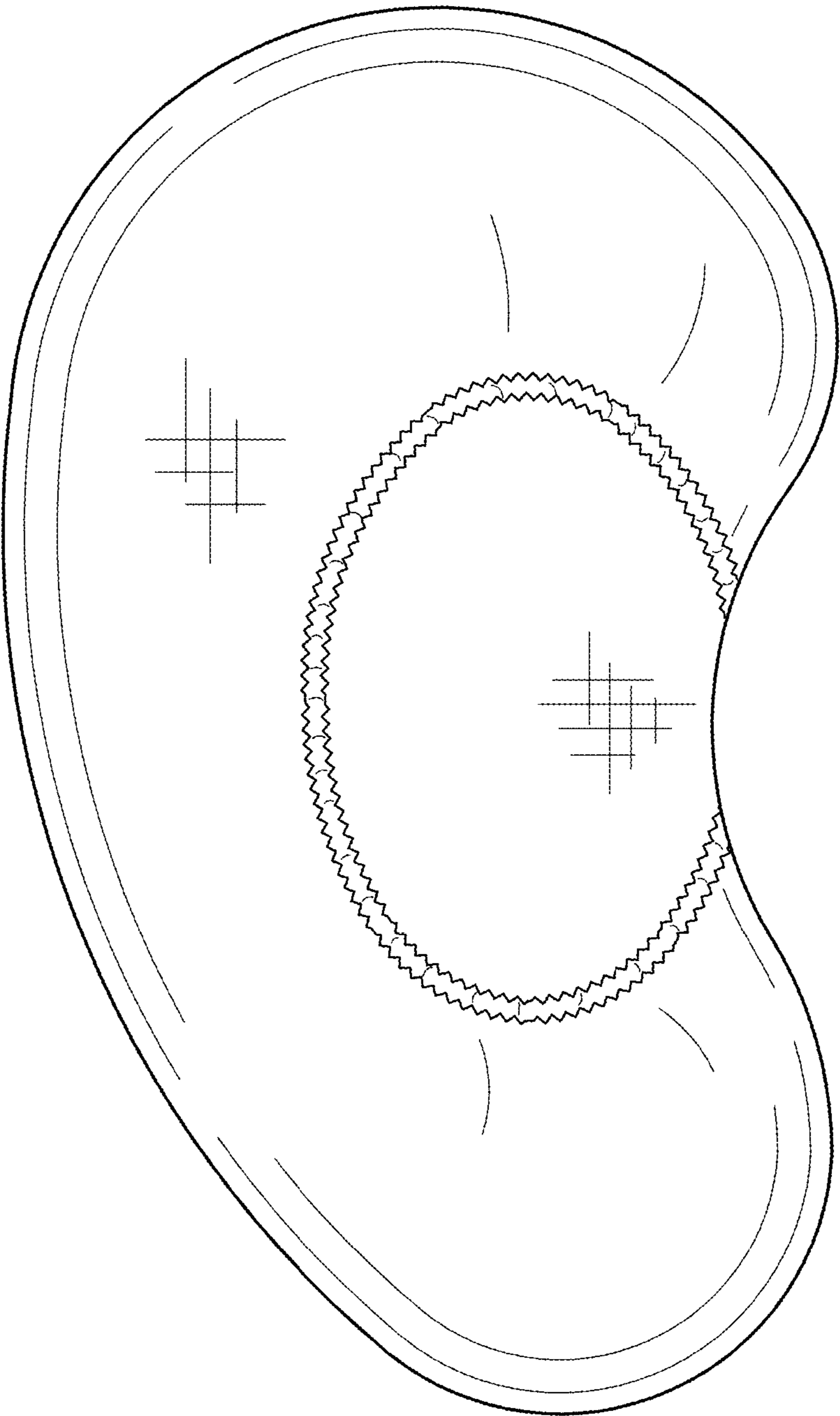

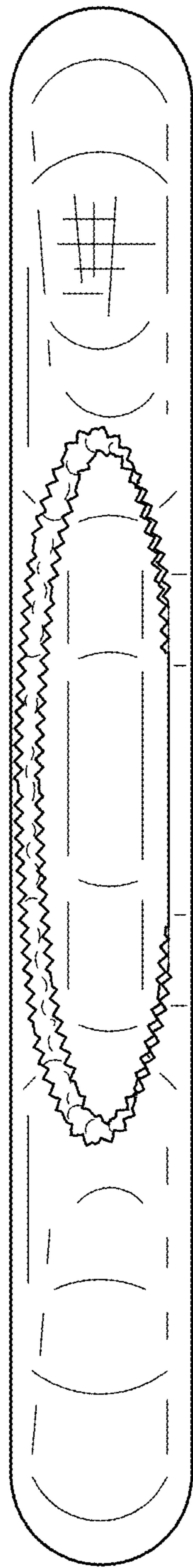

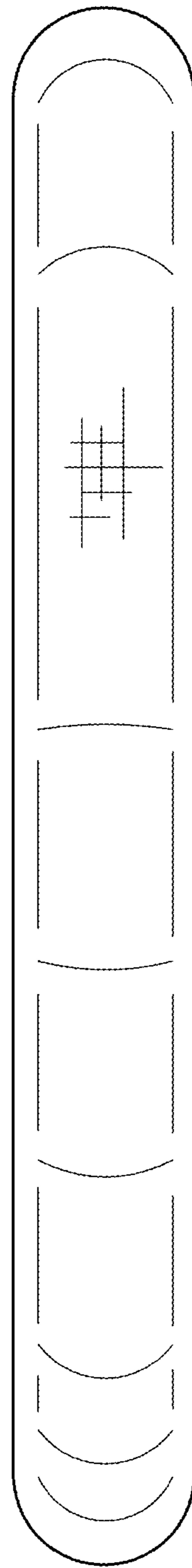

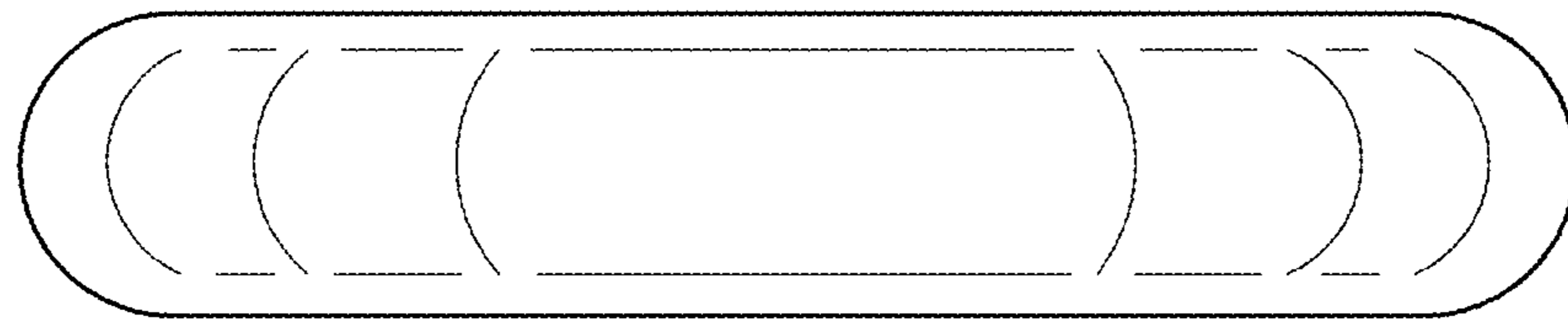

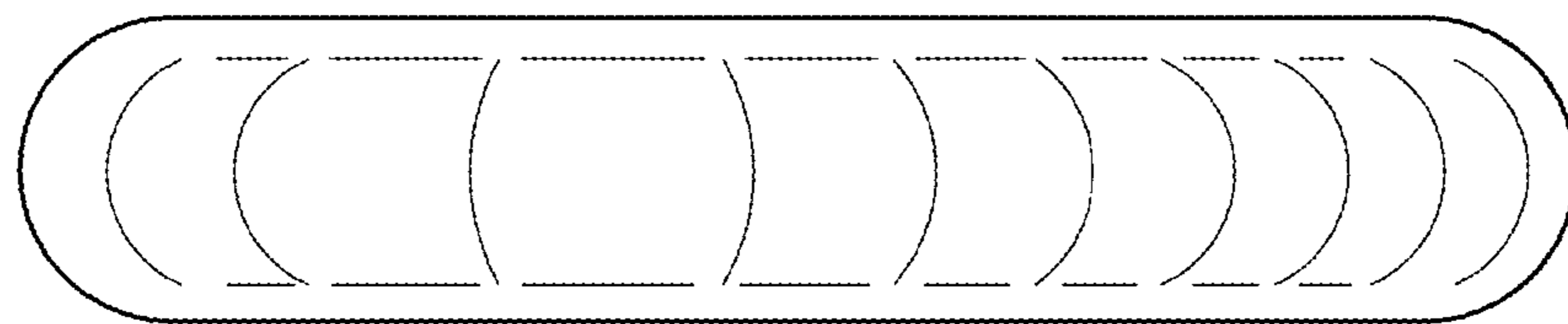

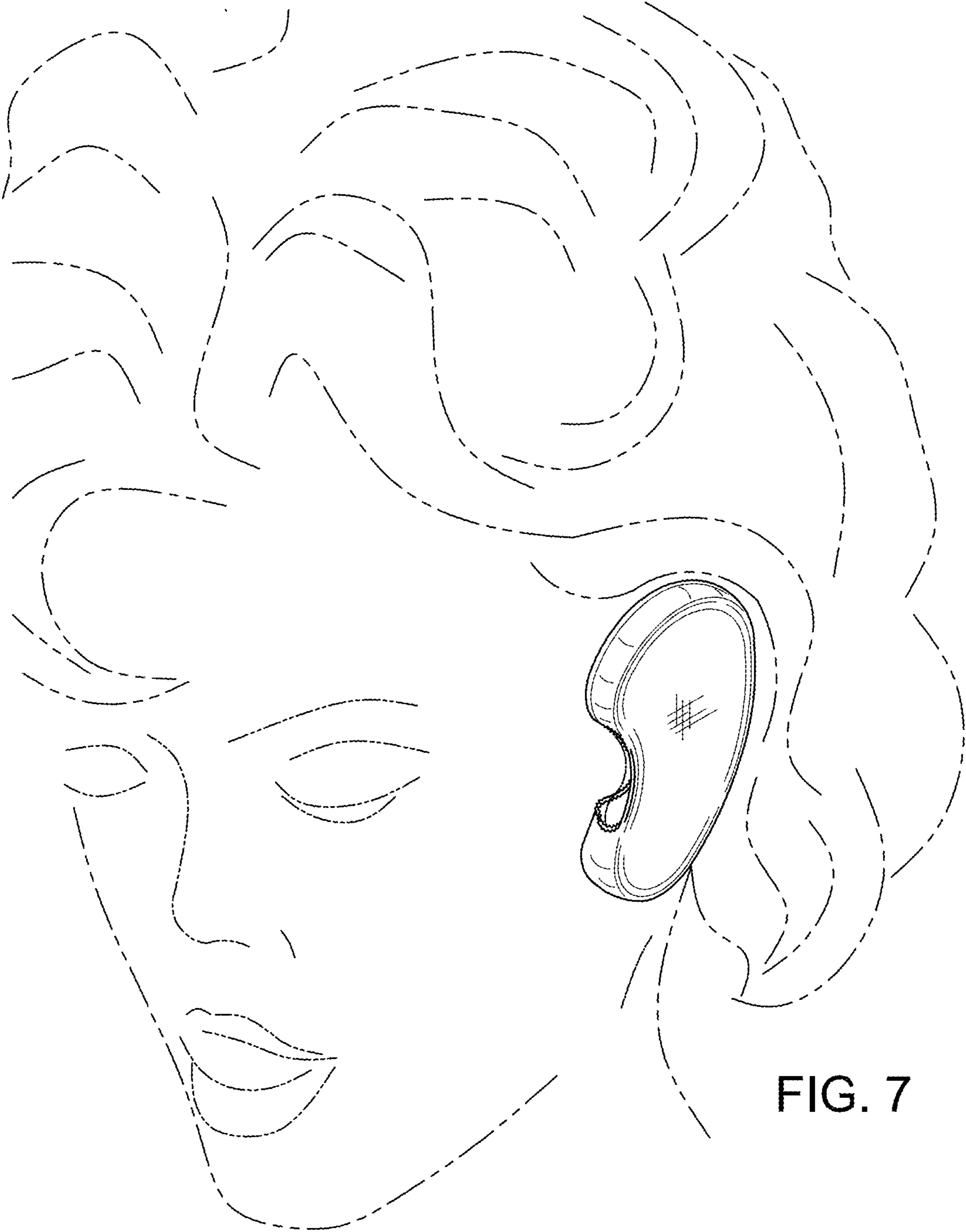
