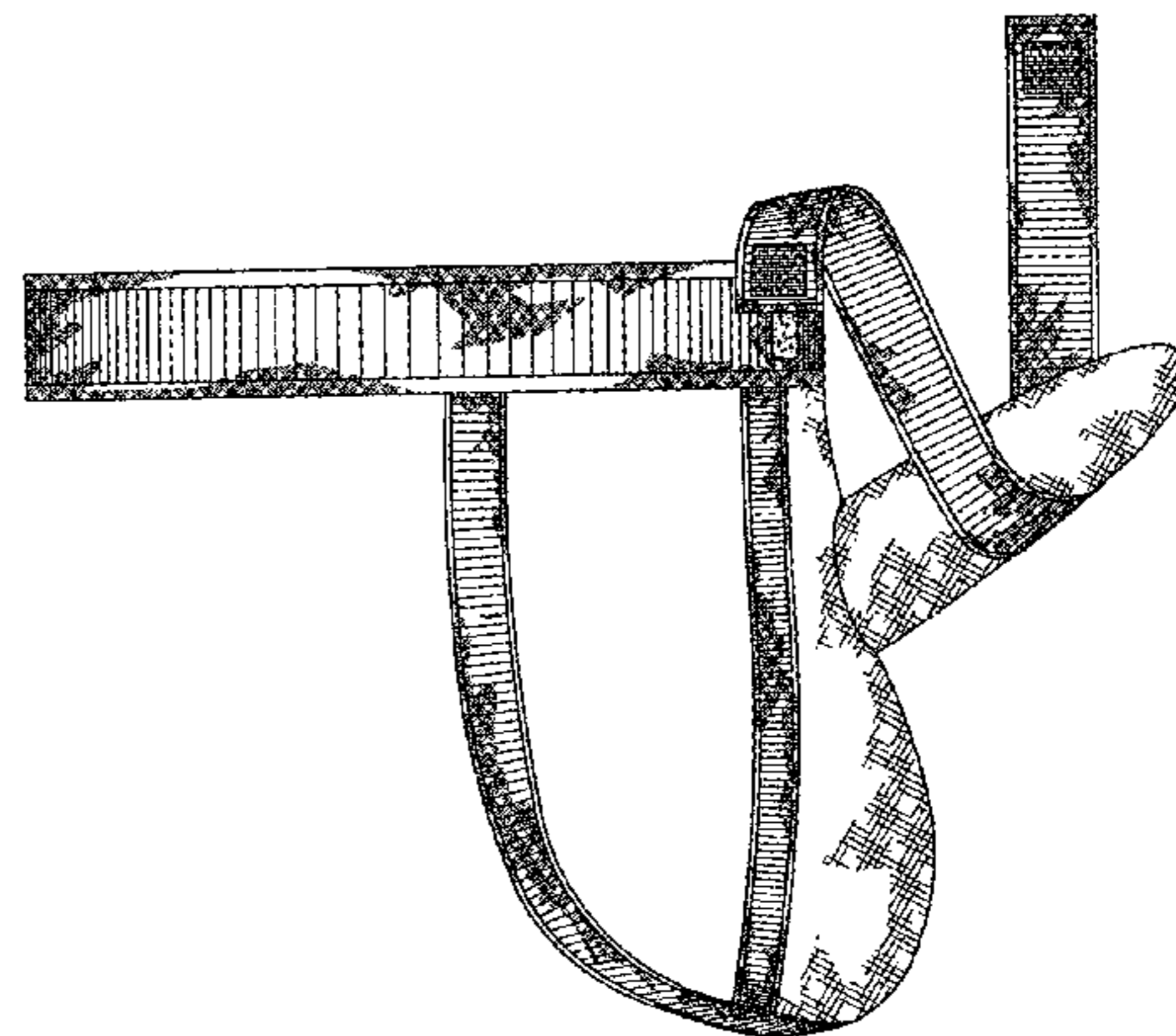
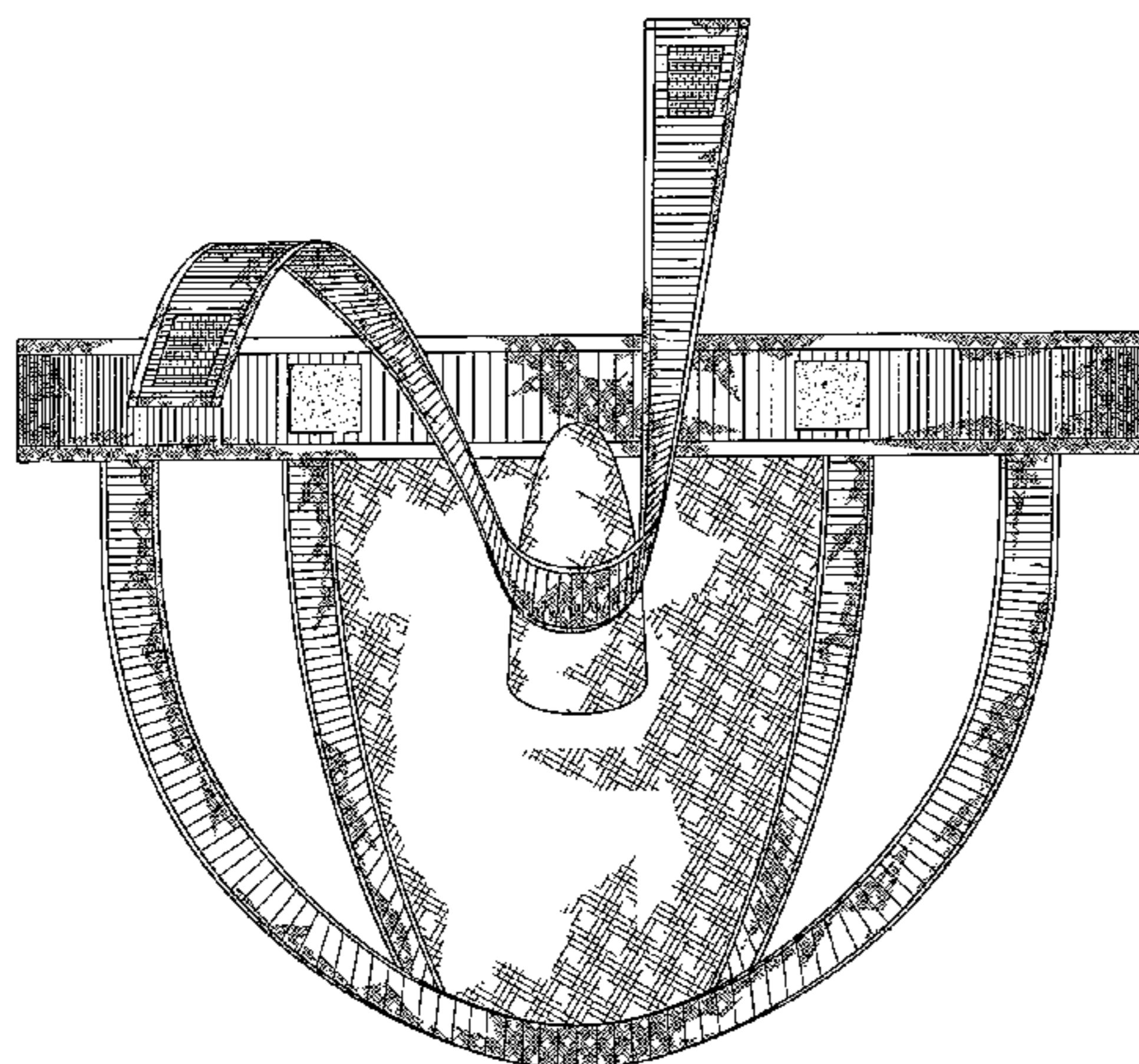
(57) **CLAIM**

The ornamental design for surgical support underwear garment, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of surgical support underwear garment showing our new design. FIG. 2 is a front elevational view thereof. FIG. 3 is a right side elevational view thereof, the left side elevational view being a mirror image thereof. FIG. 4 is a bottom perspective view thereof; and, FIG. 5 is a rear elevational view thereof.

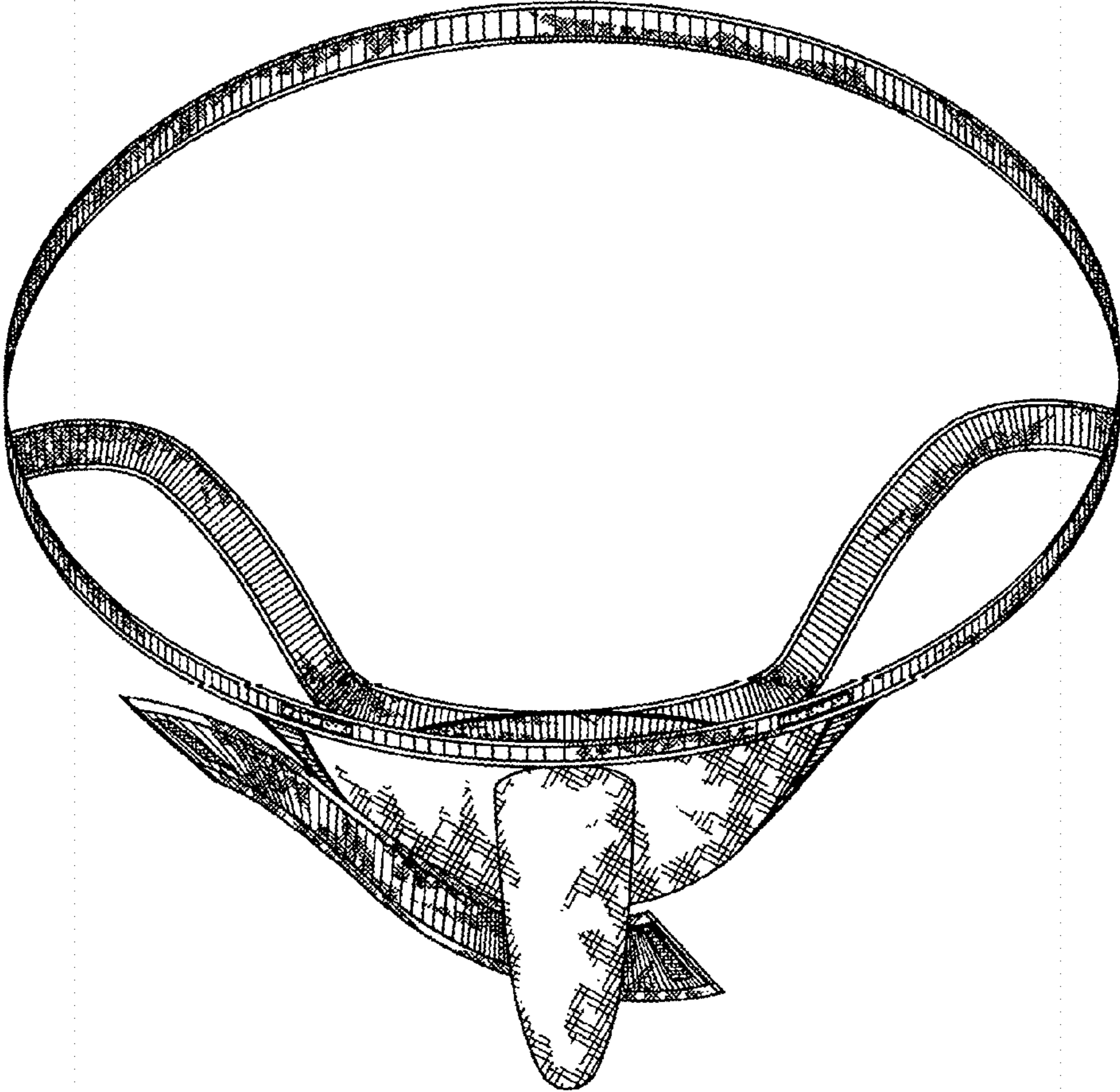

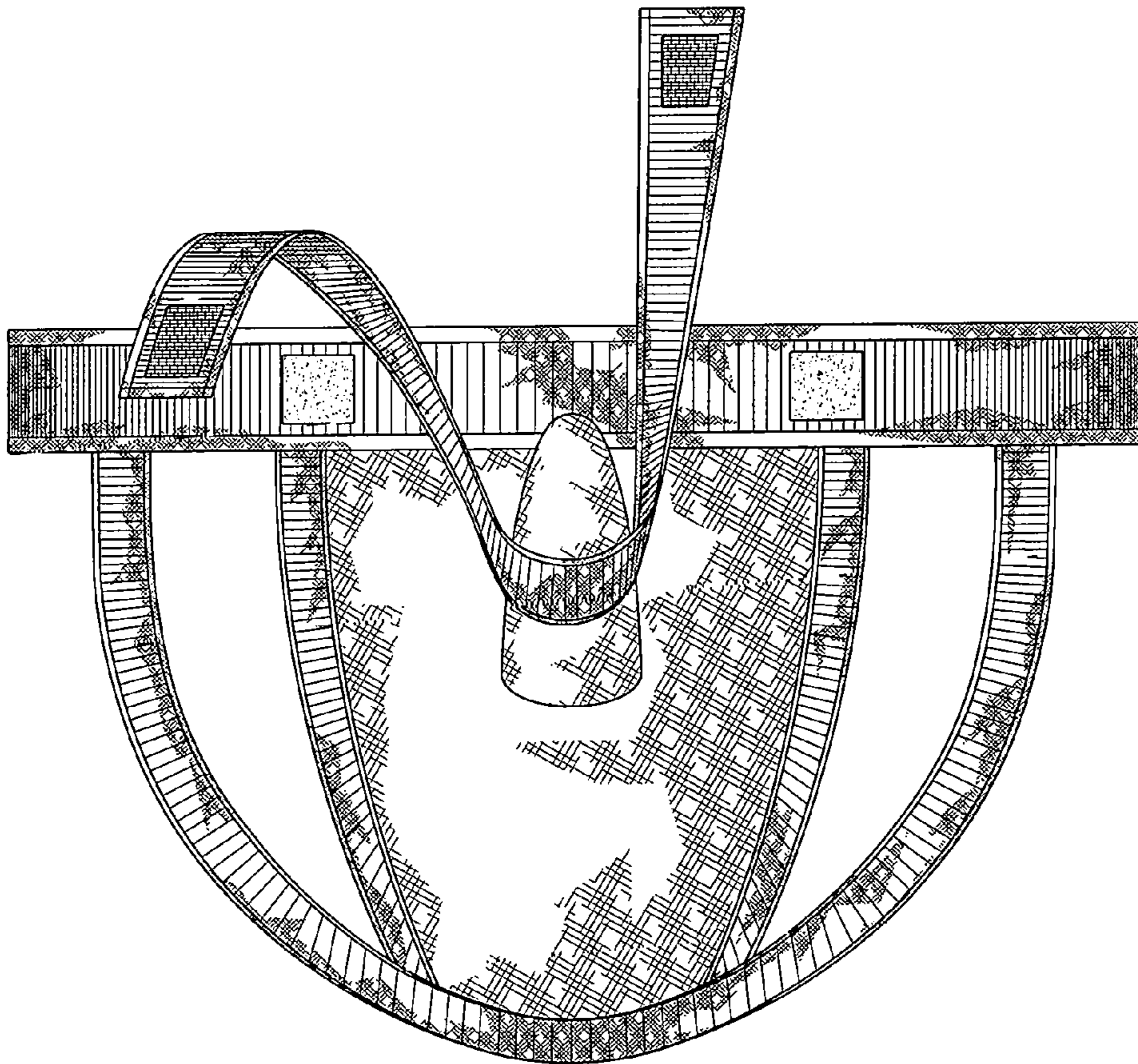

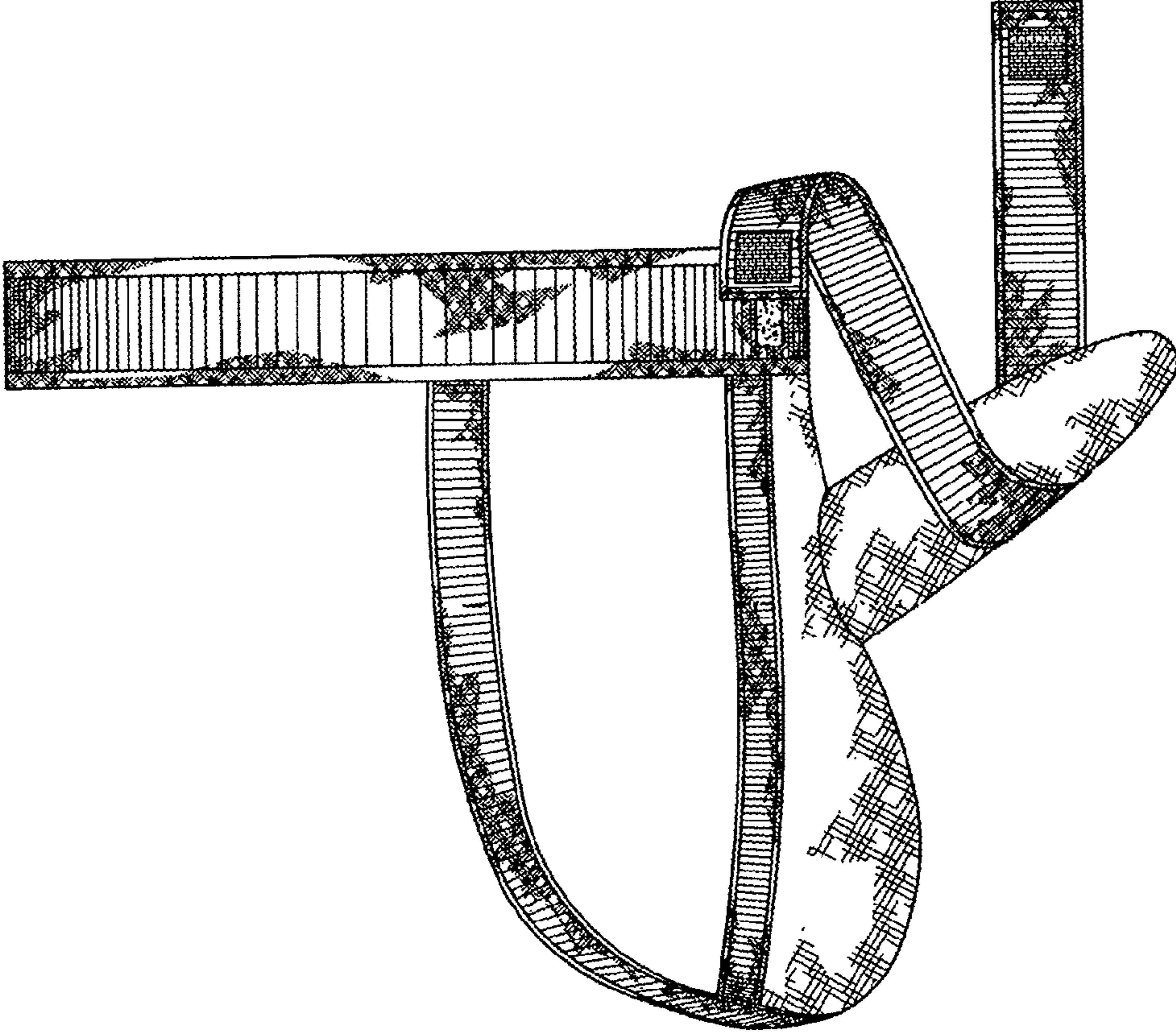

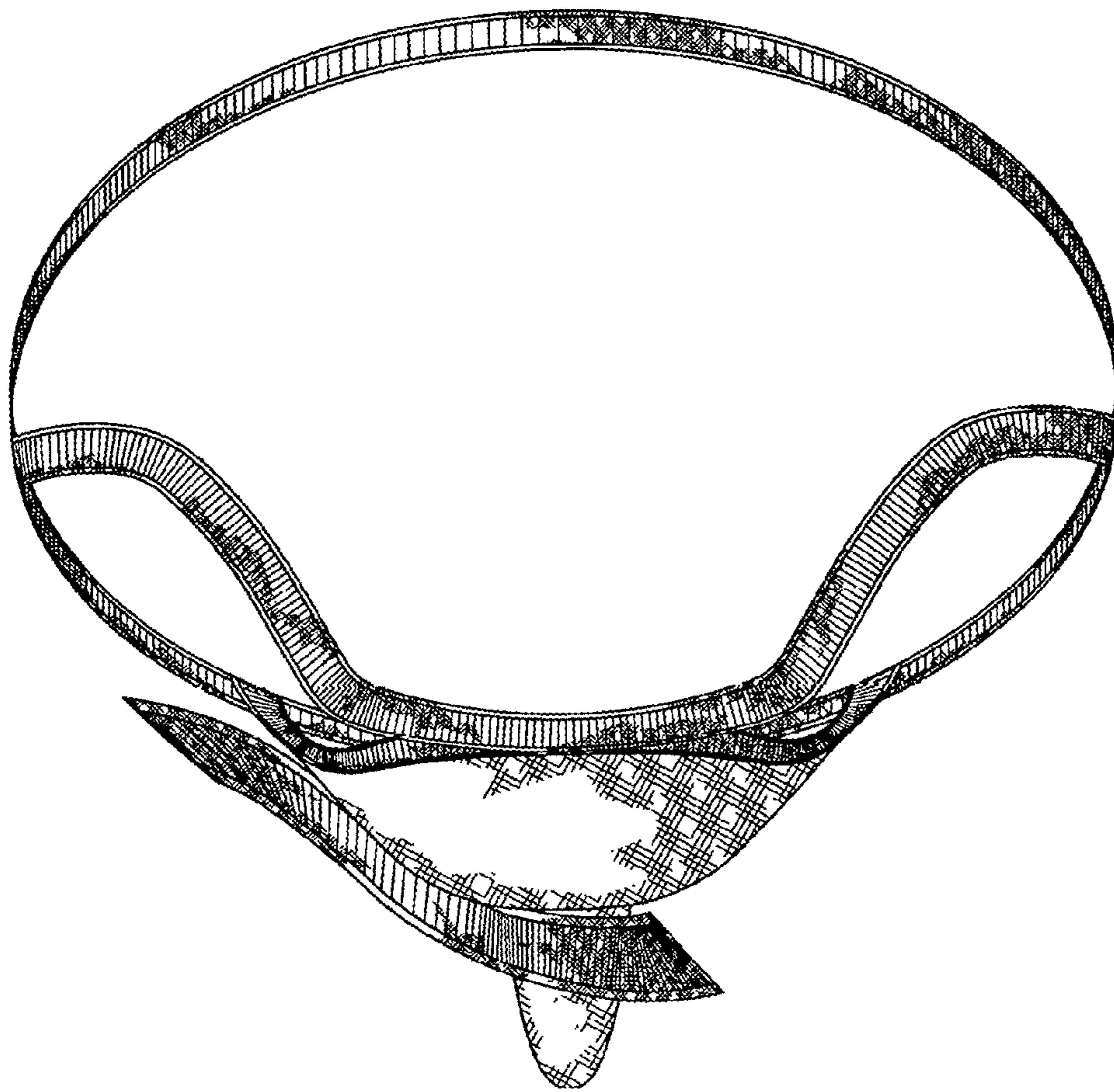

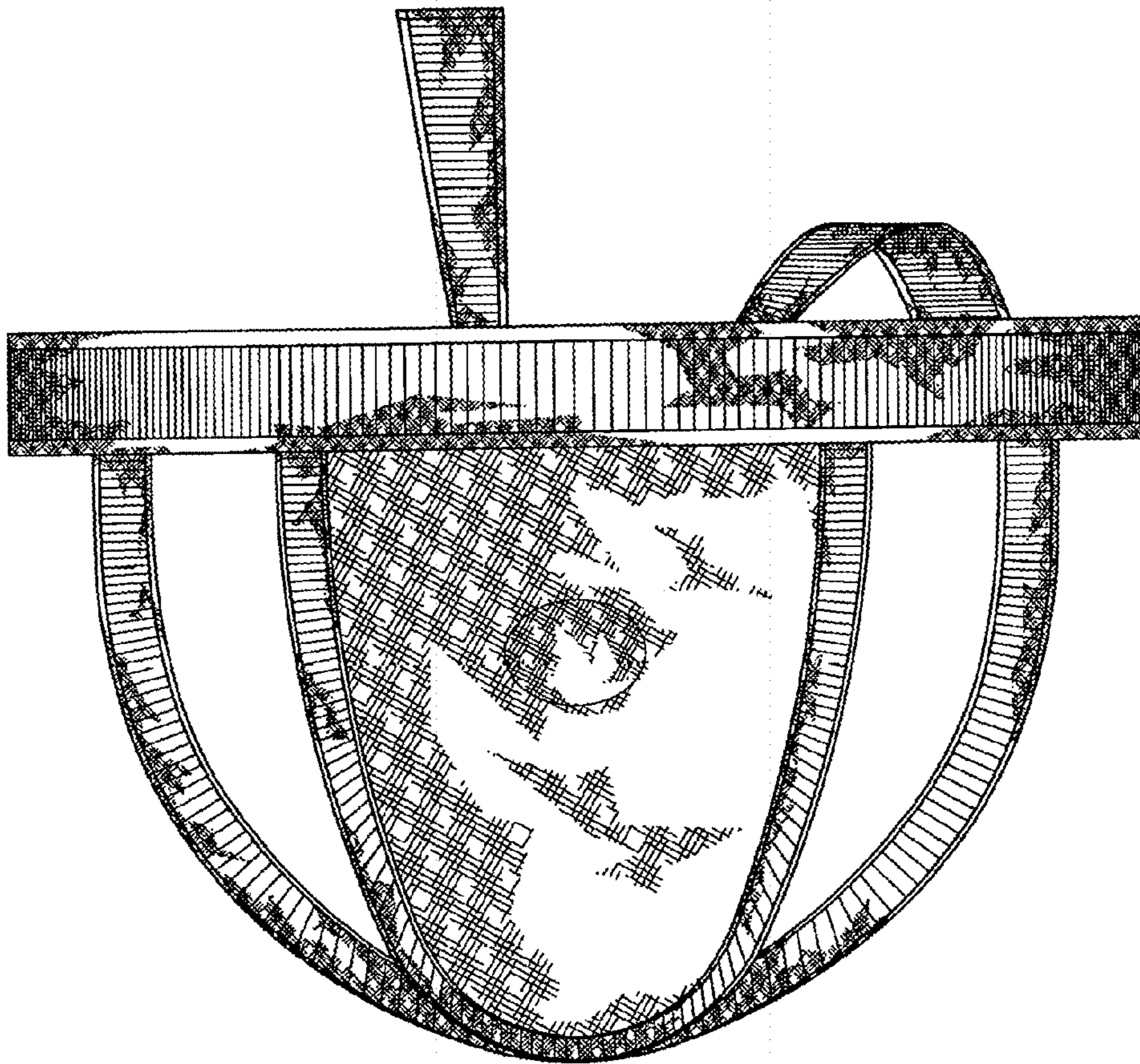
