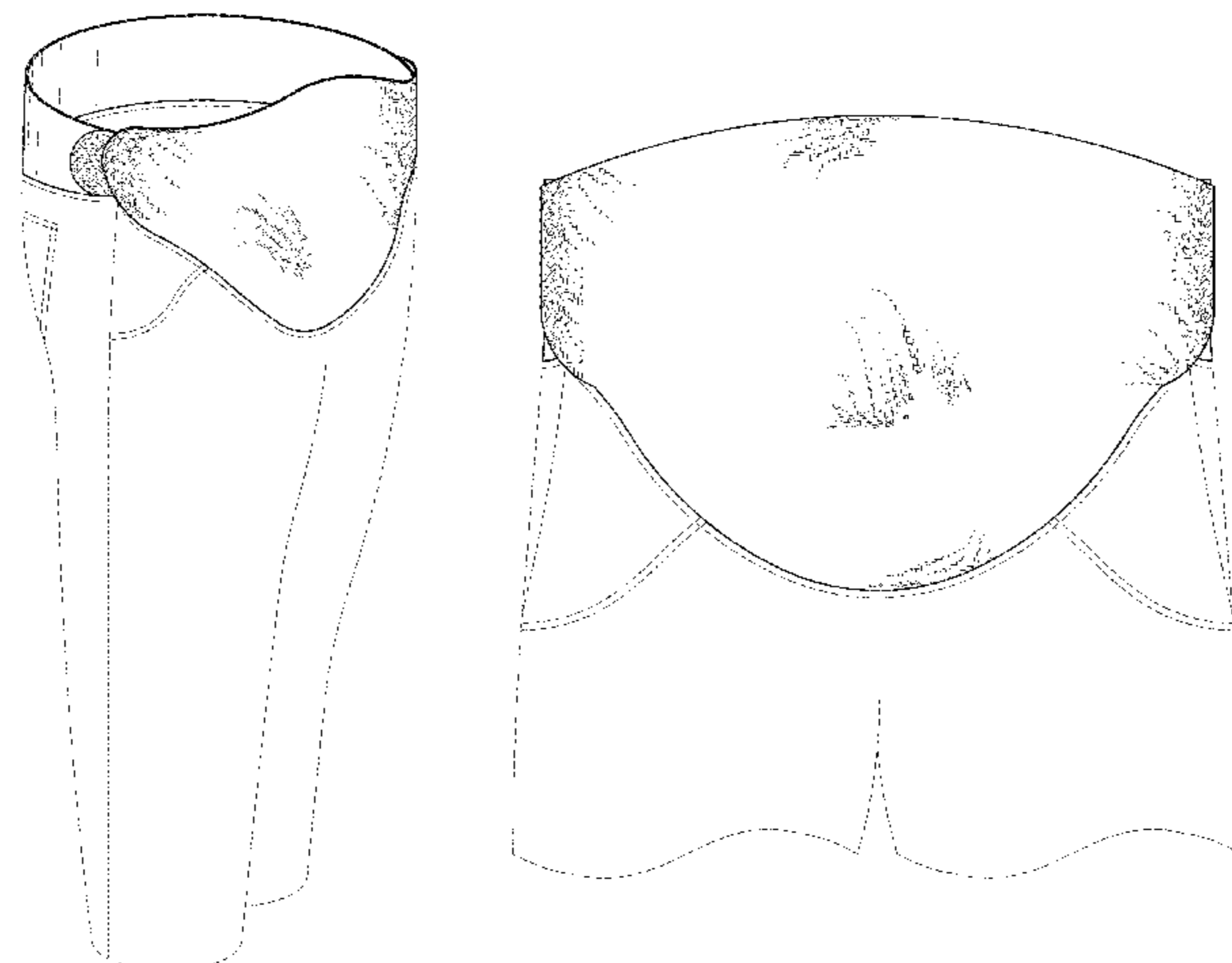
(57) **CLAIM**

The ornamental design for a maternity garment, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the maternity garment showing my new design; FIG. 2 is a front elevational view thereof; FIG. 3 is a right elevational view, the left side elevational view being a mirror image thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a perspective view thereof; with the strap disconnected; FIG. 7 is a perspective view of a second embodiment of the maternity garment; FIG. 8 is front elevational view thereof; FIG. 9 is a right side elevational view, the left side elevational view being a mirror image thereof; FIG. 10 is a rear elevational view thereof; and, FIG. 11 is a top plan view thereof. The shading shown in the drawings is for illustrative purposes only and forms no part of the claimed design.

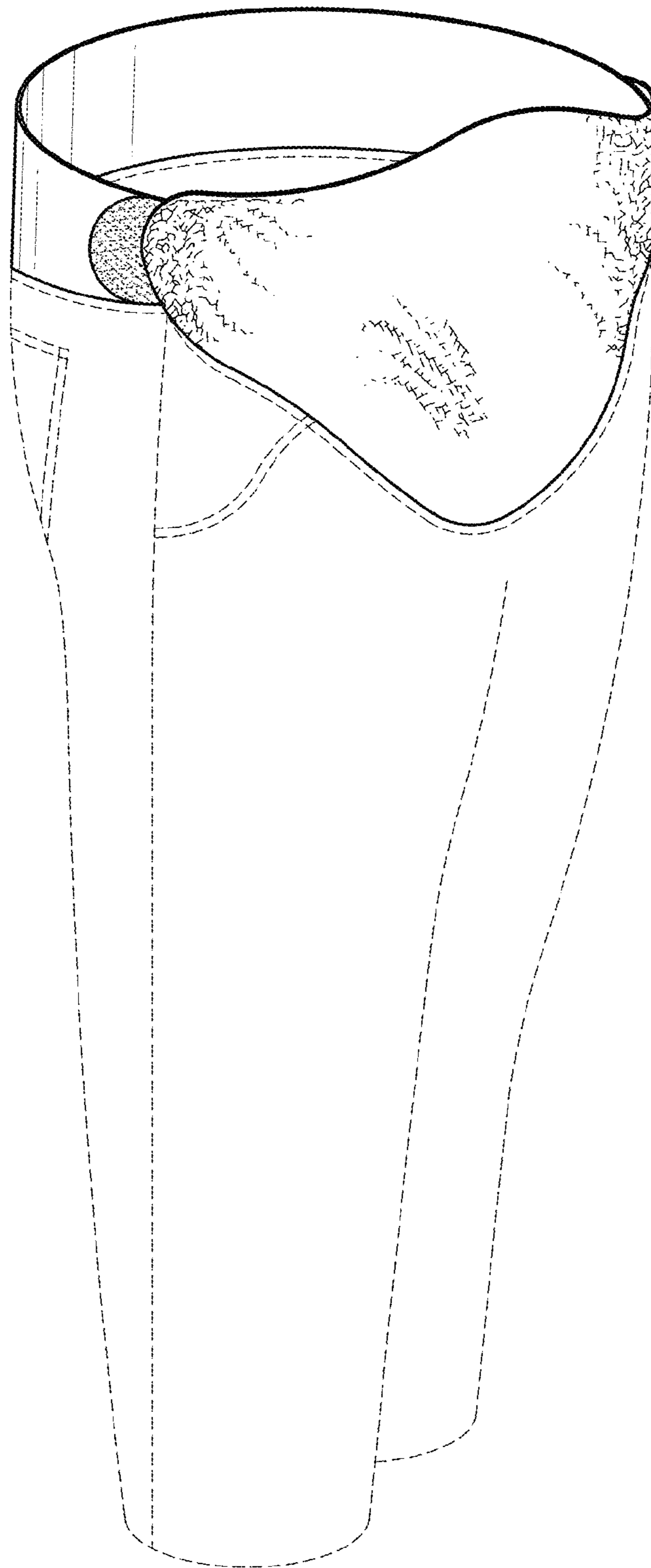

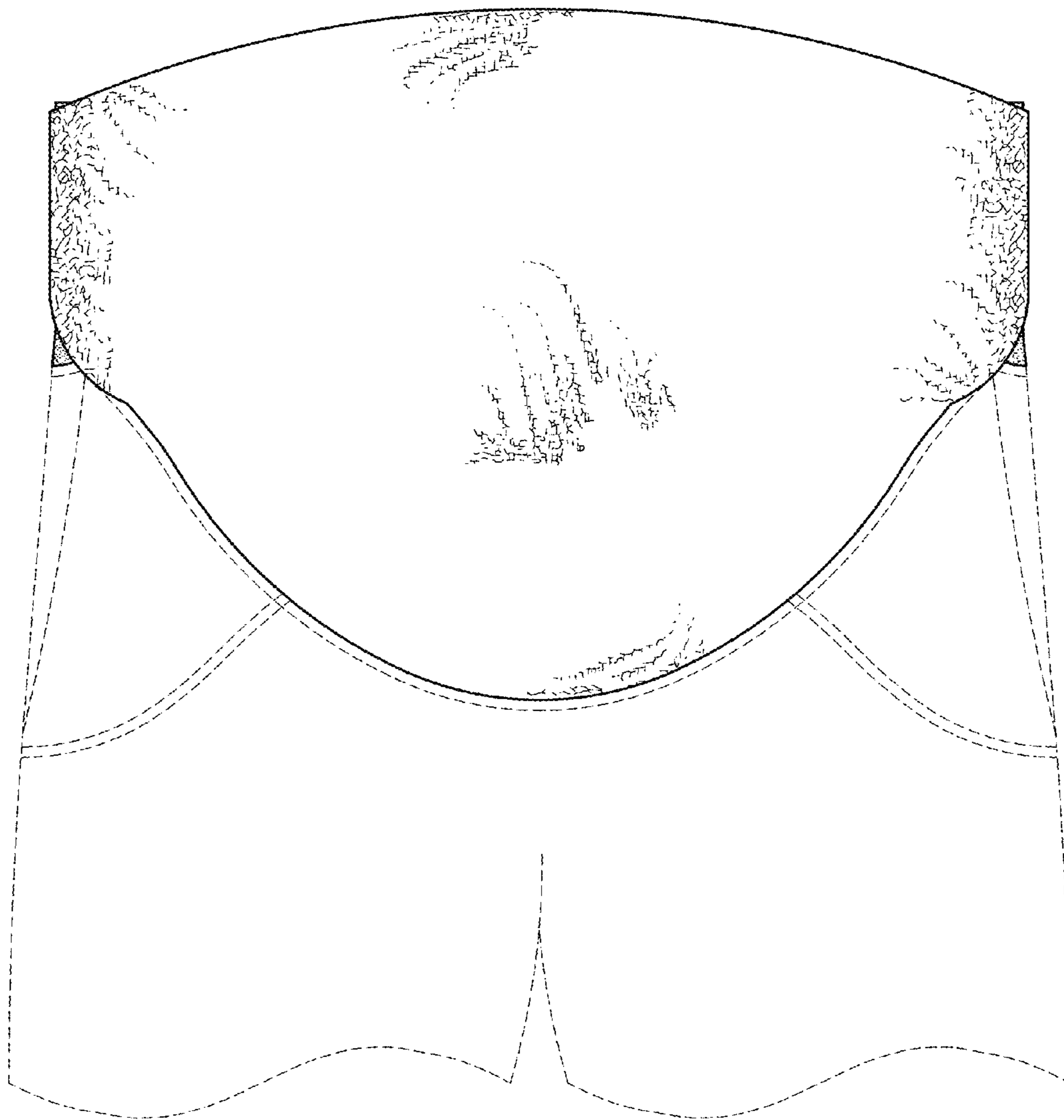

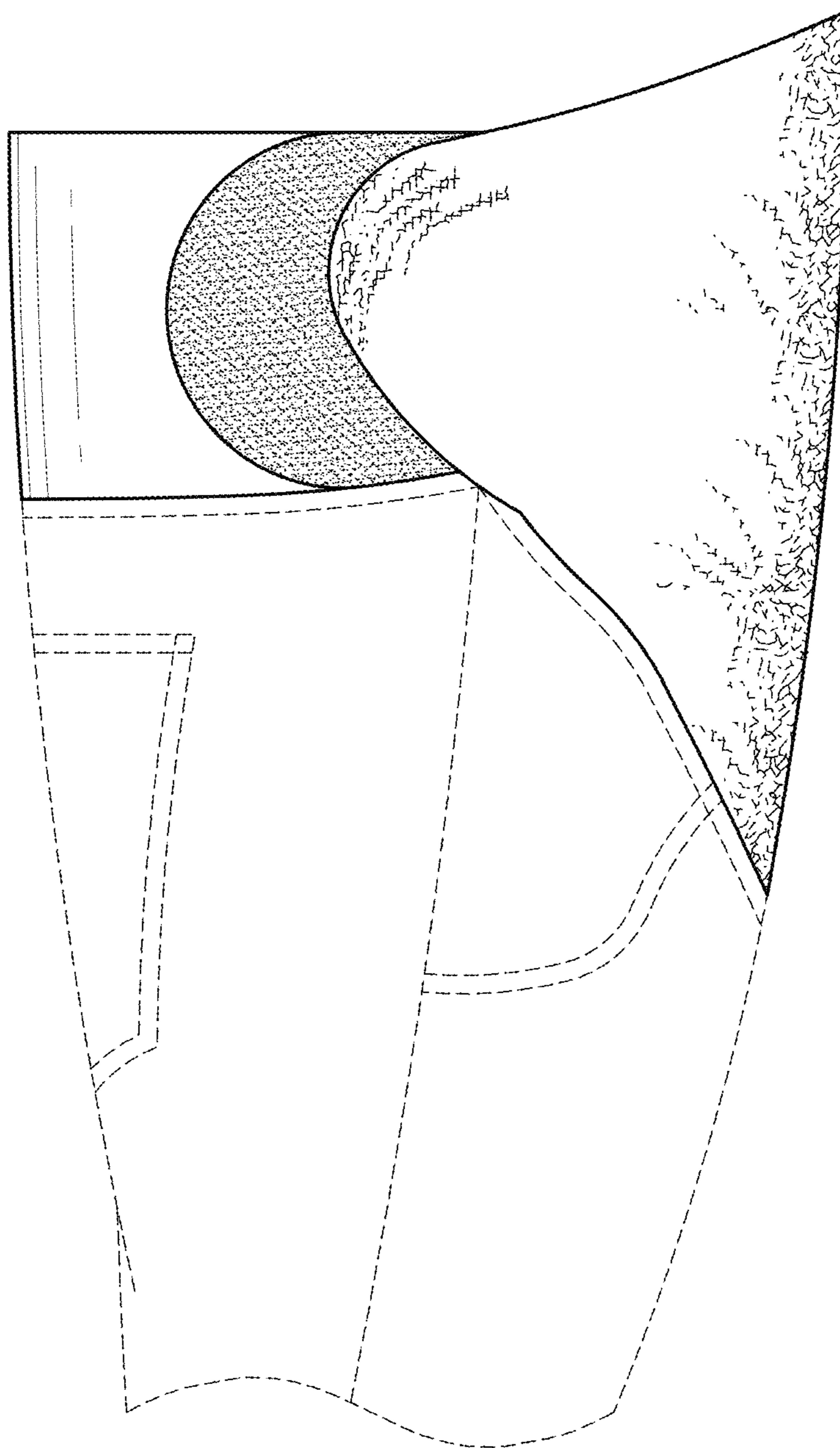

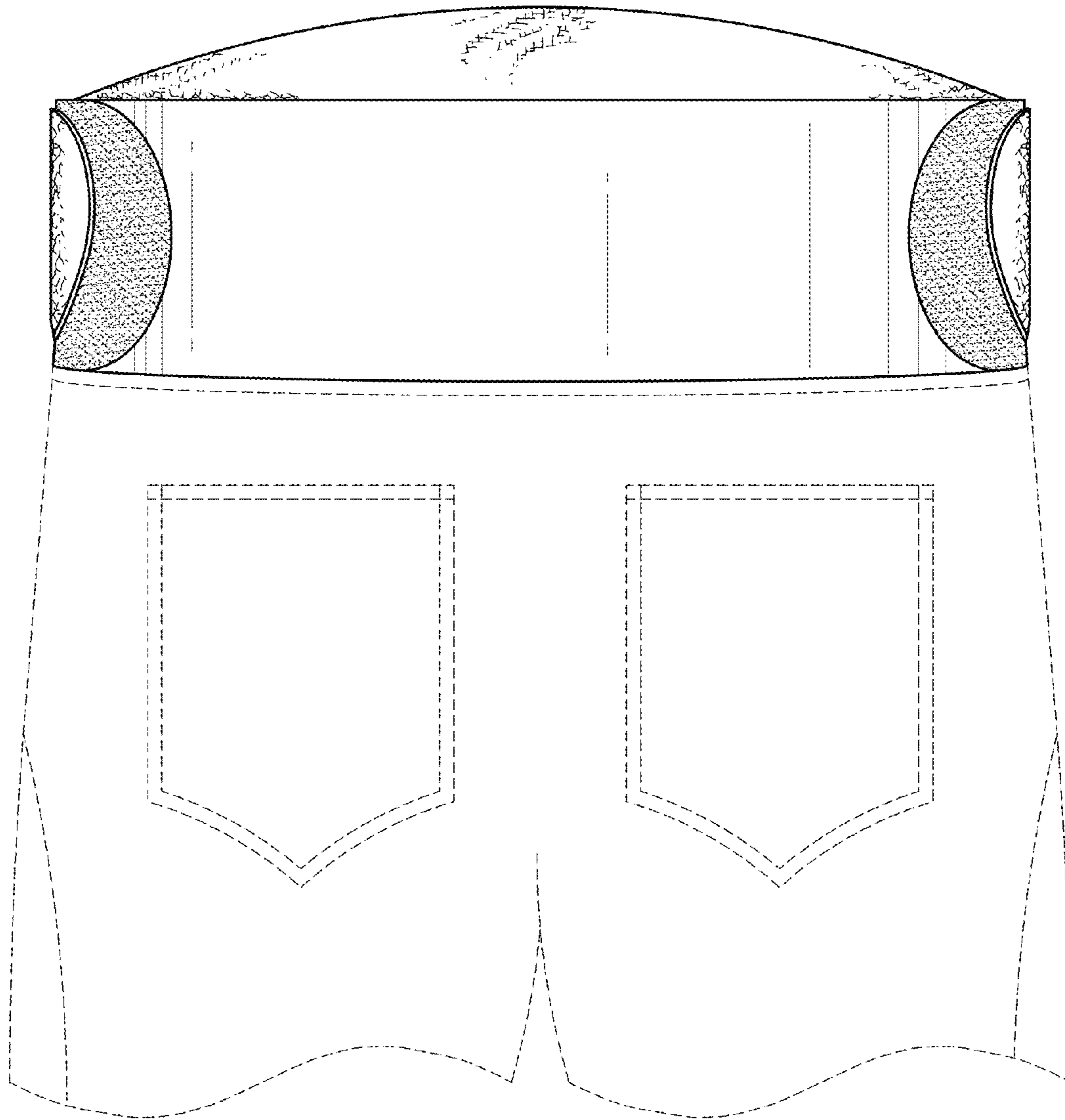

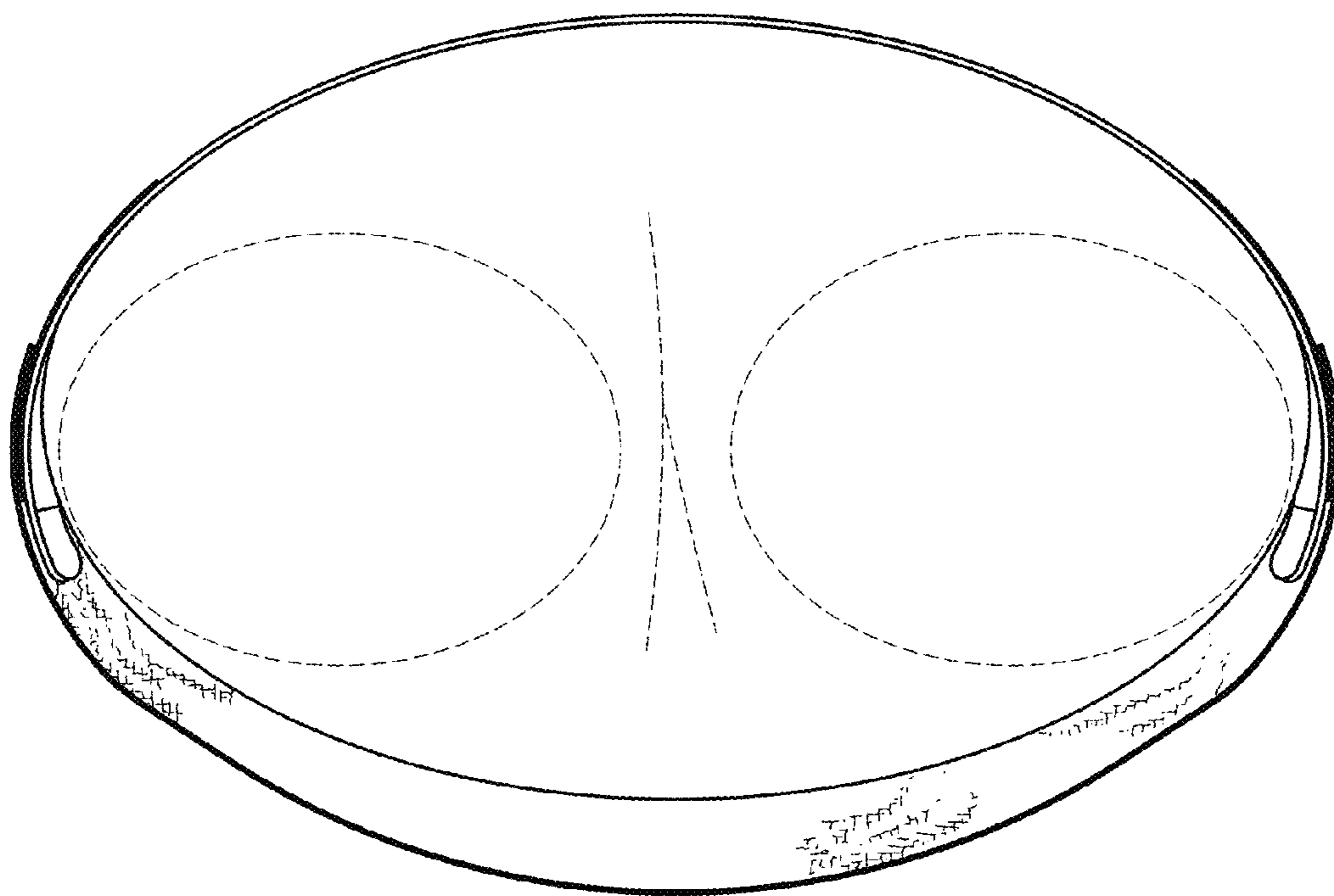

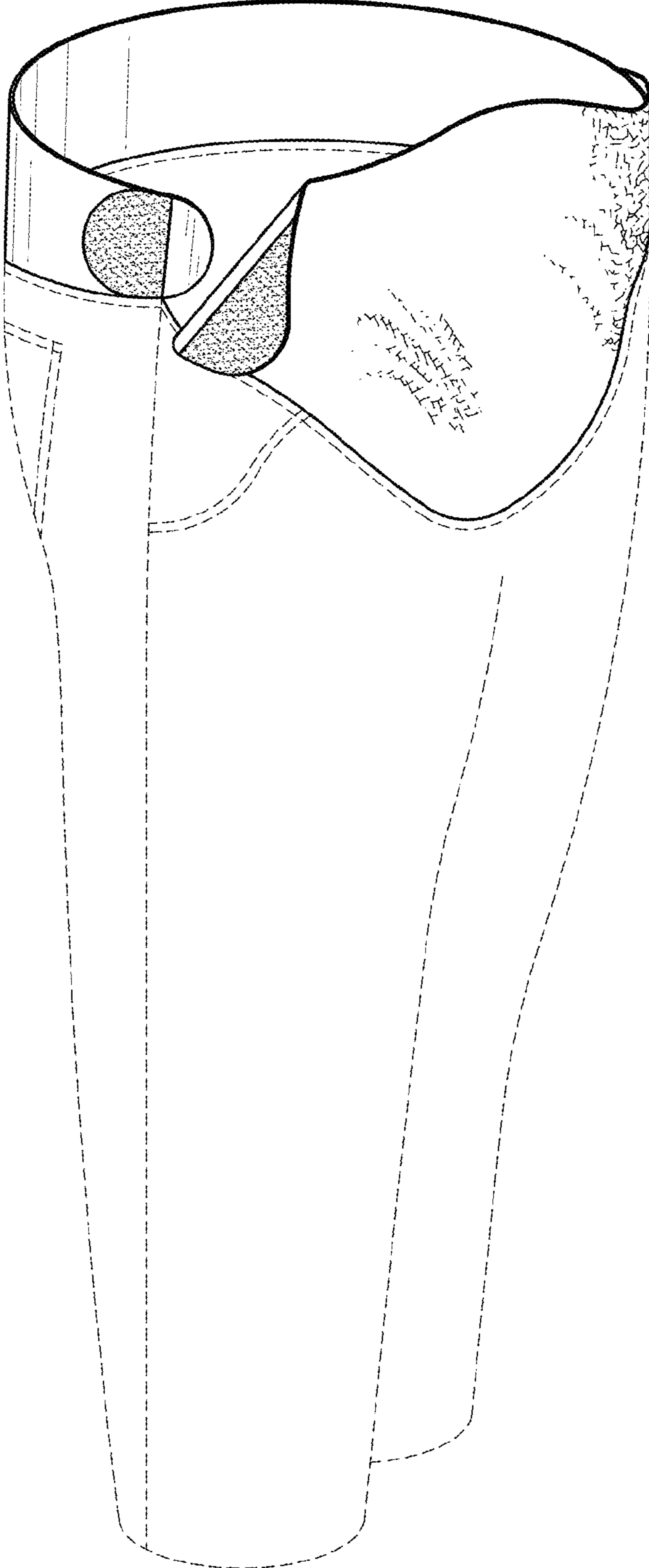

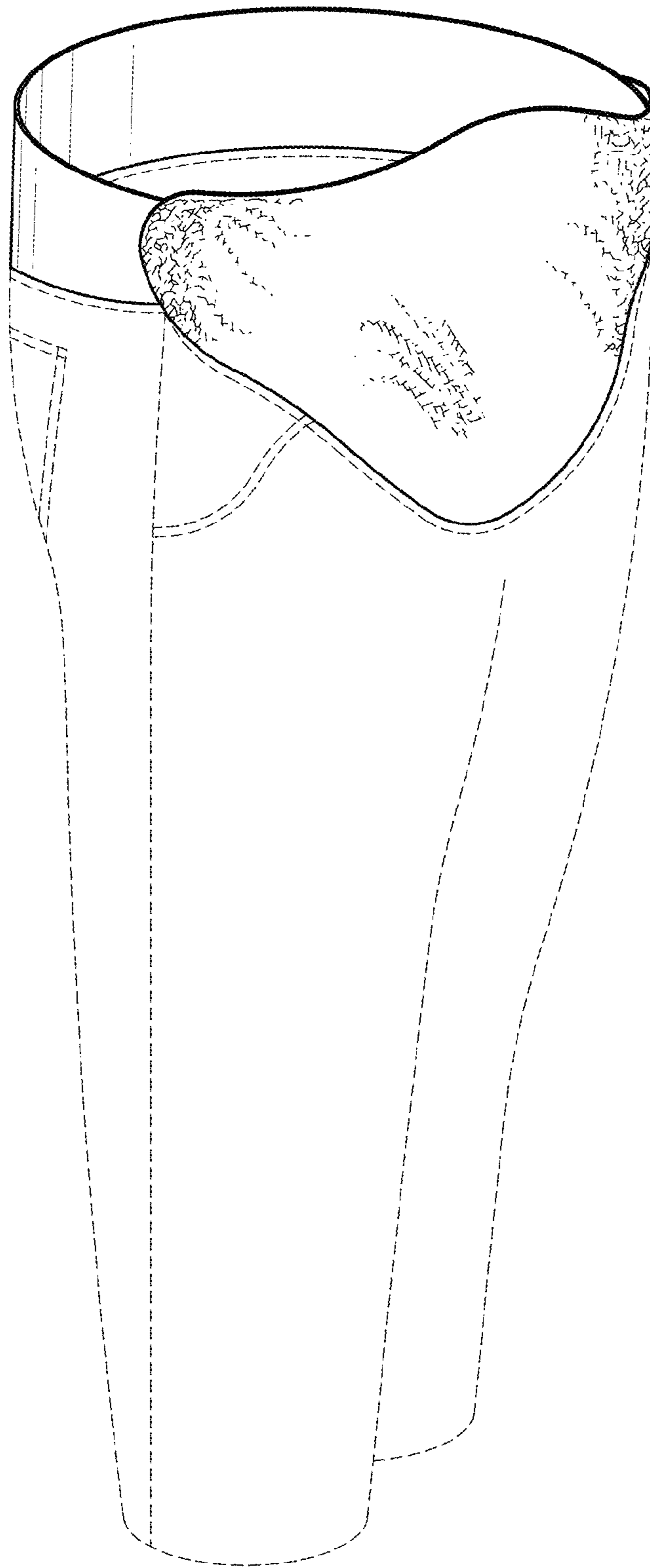

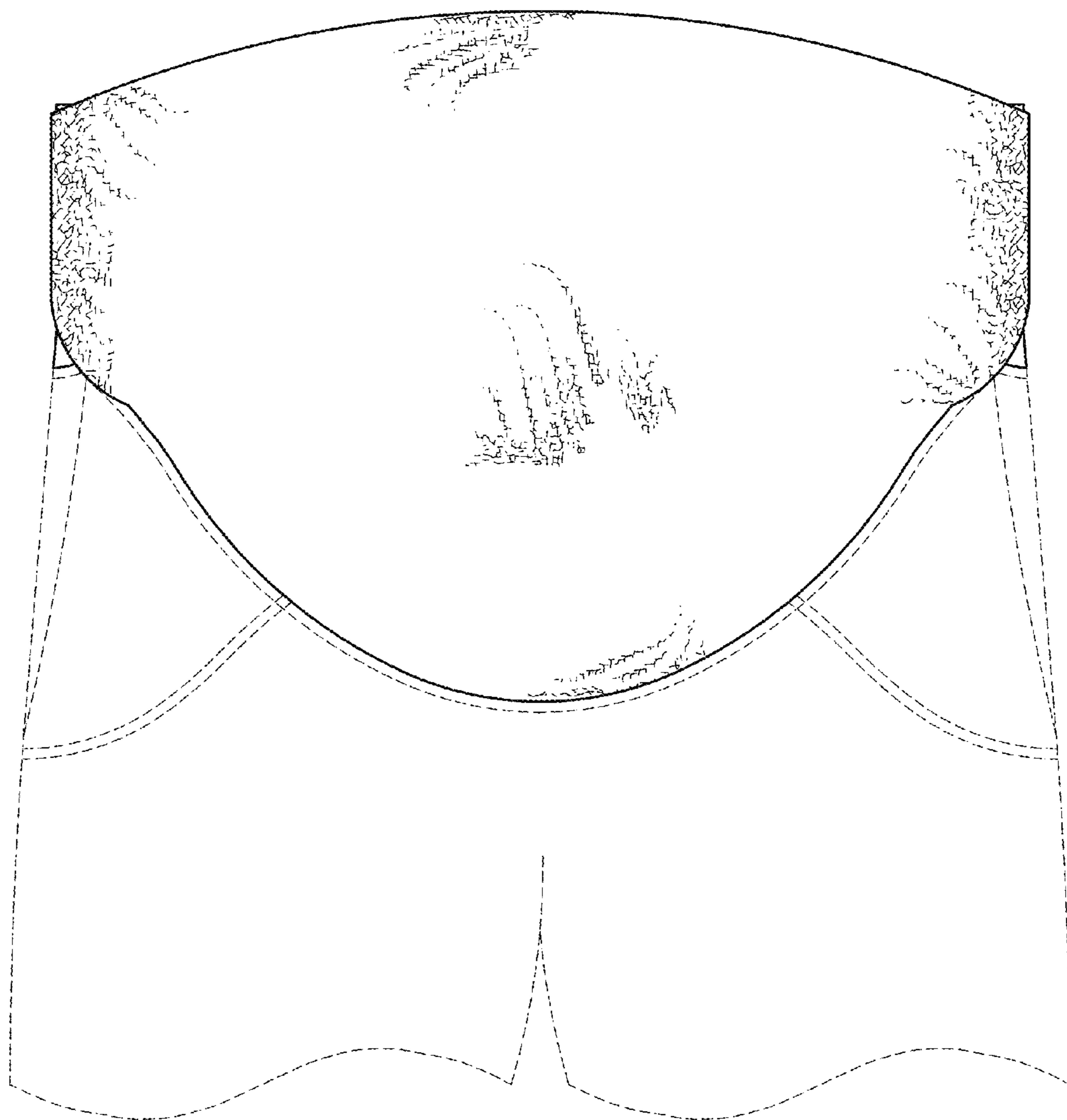

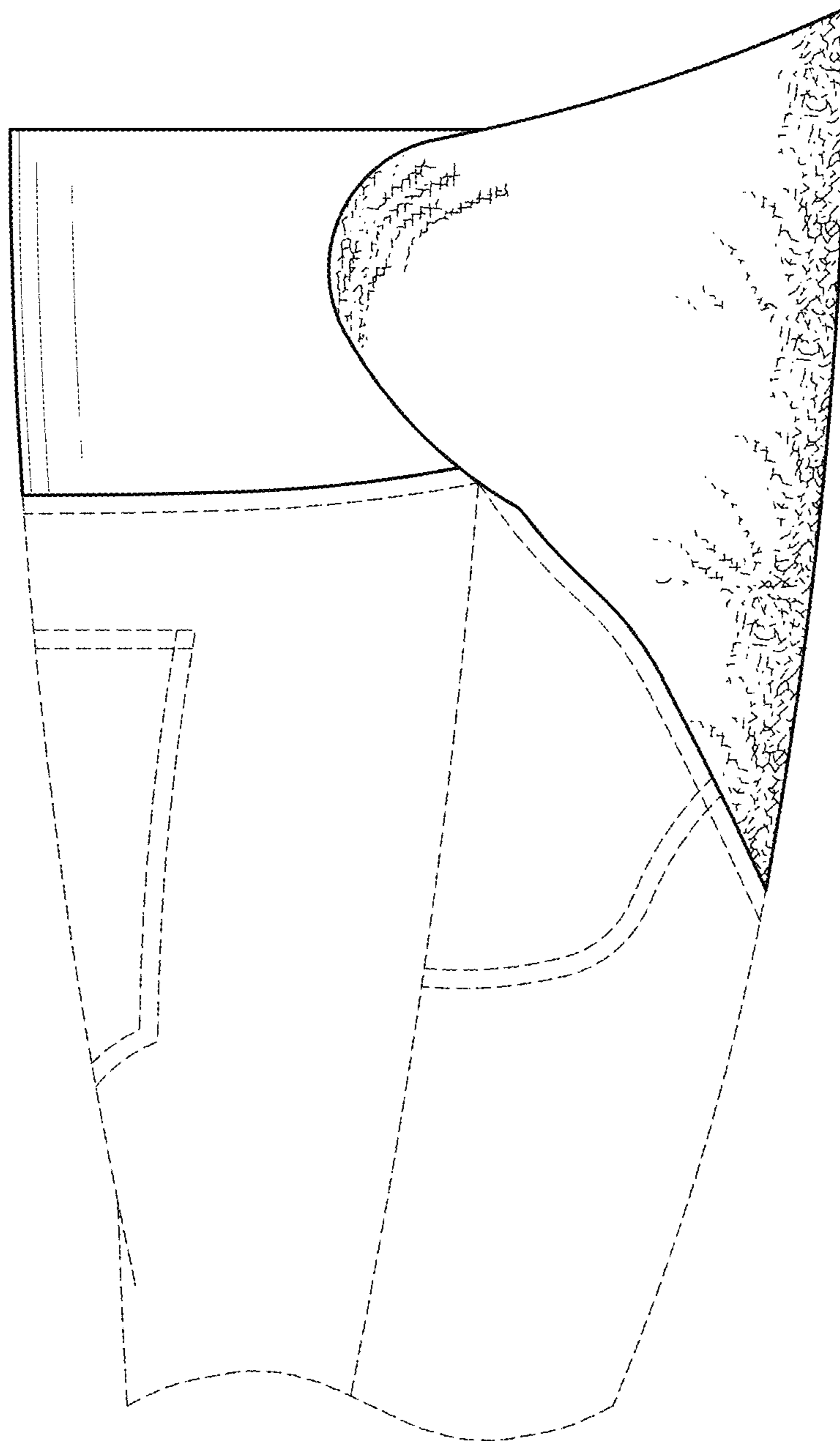

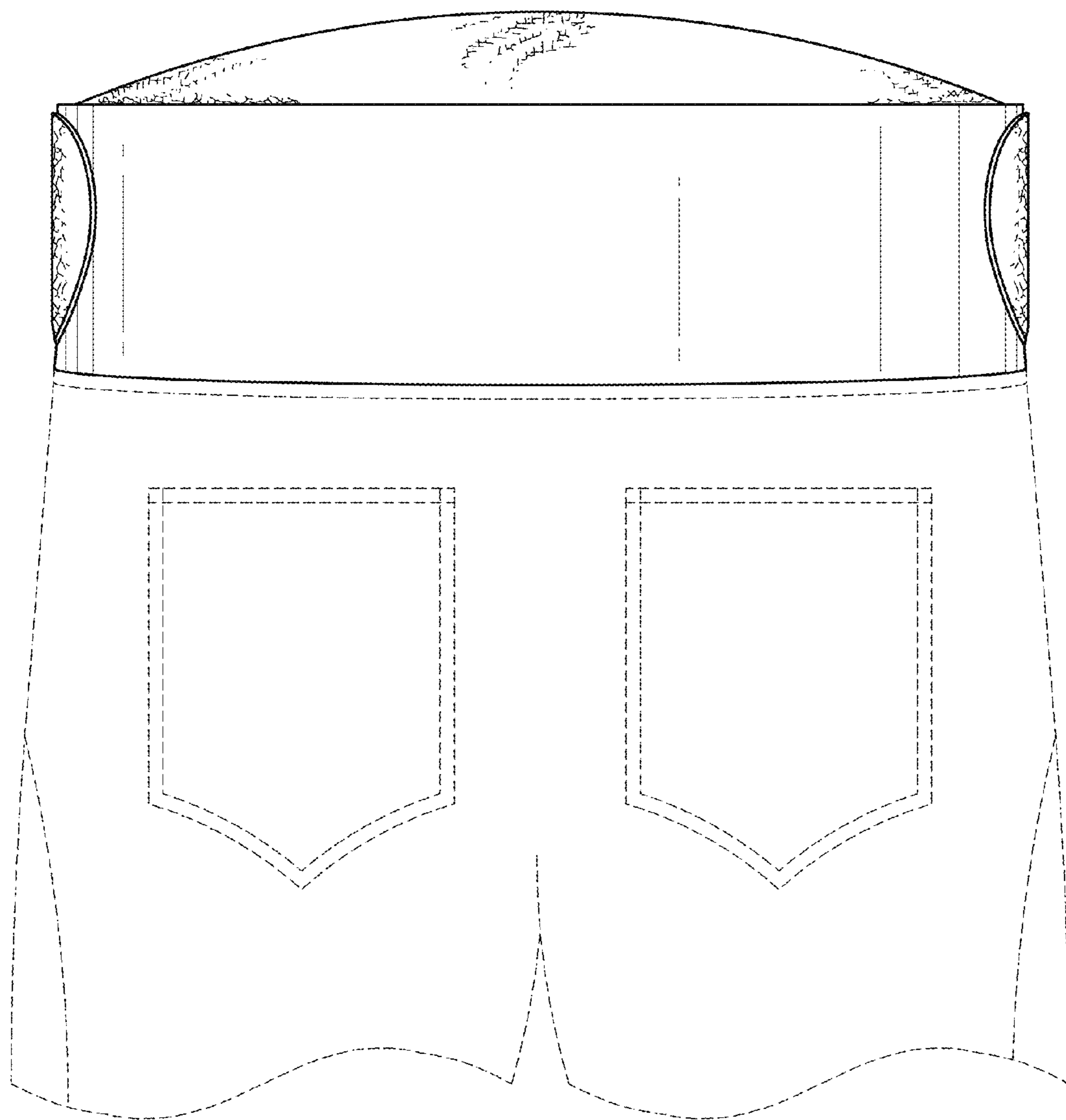

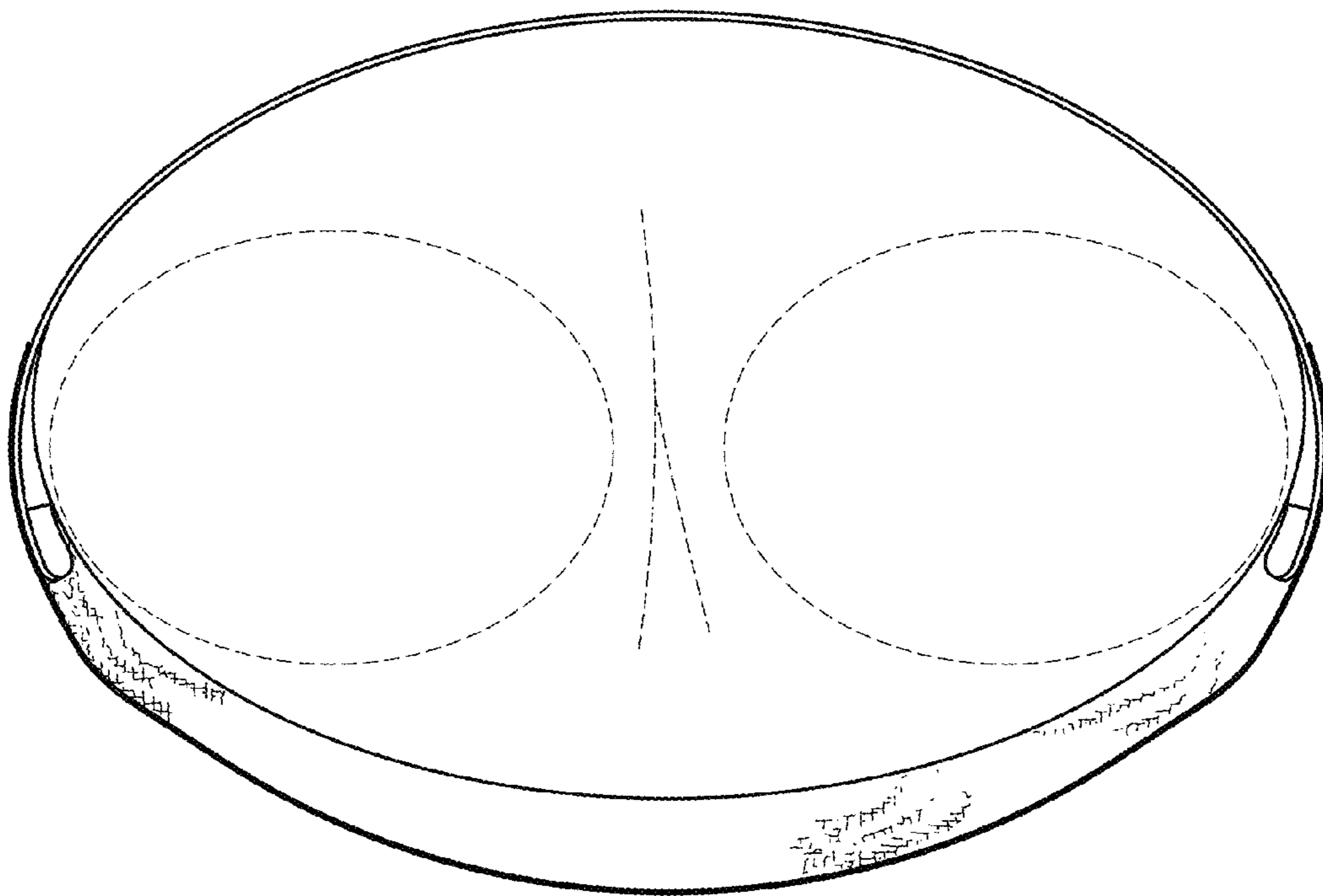
