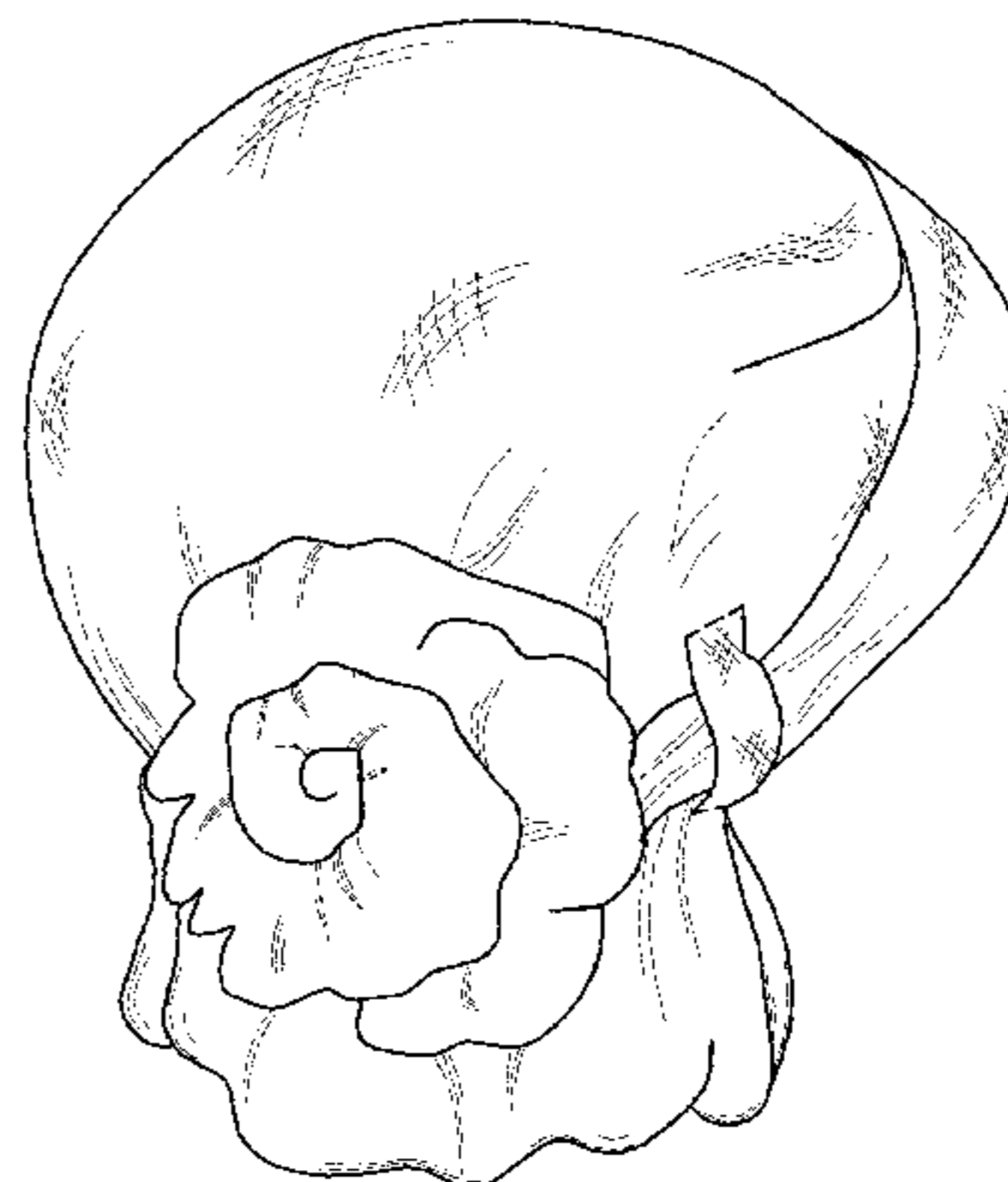
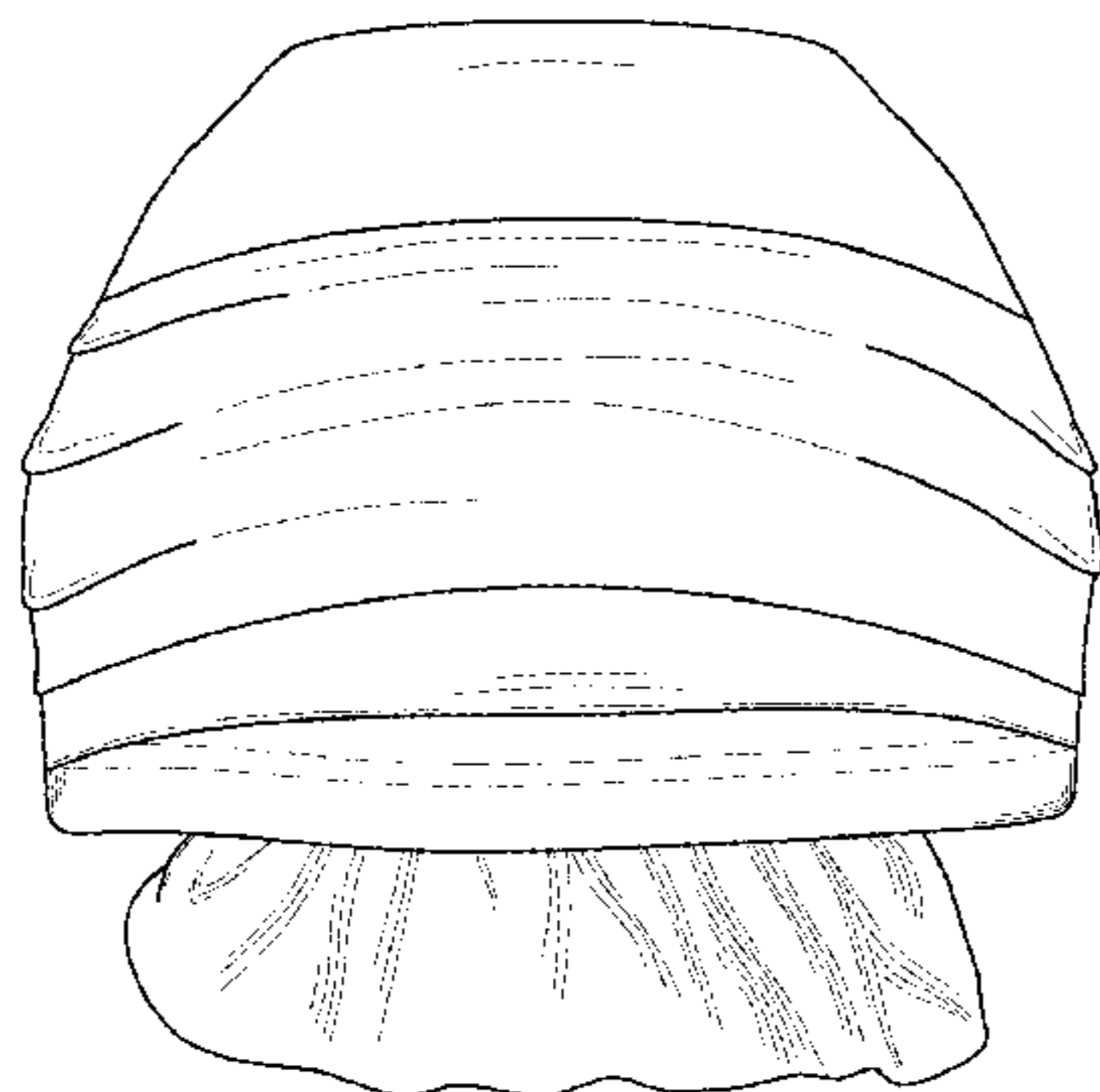

(57) **CLAIM**
The ornamental design for a decorative head cover, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a decorative head cover; FIG. 2 is a rear elevation view thereof; FIG. 3 is a left side elevation view thereof; and, FIG. 4 is a rear perspective view thereof. The broken lines in the drawings represent environmental structure that form no part of the claimed design.

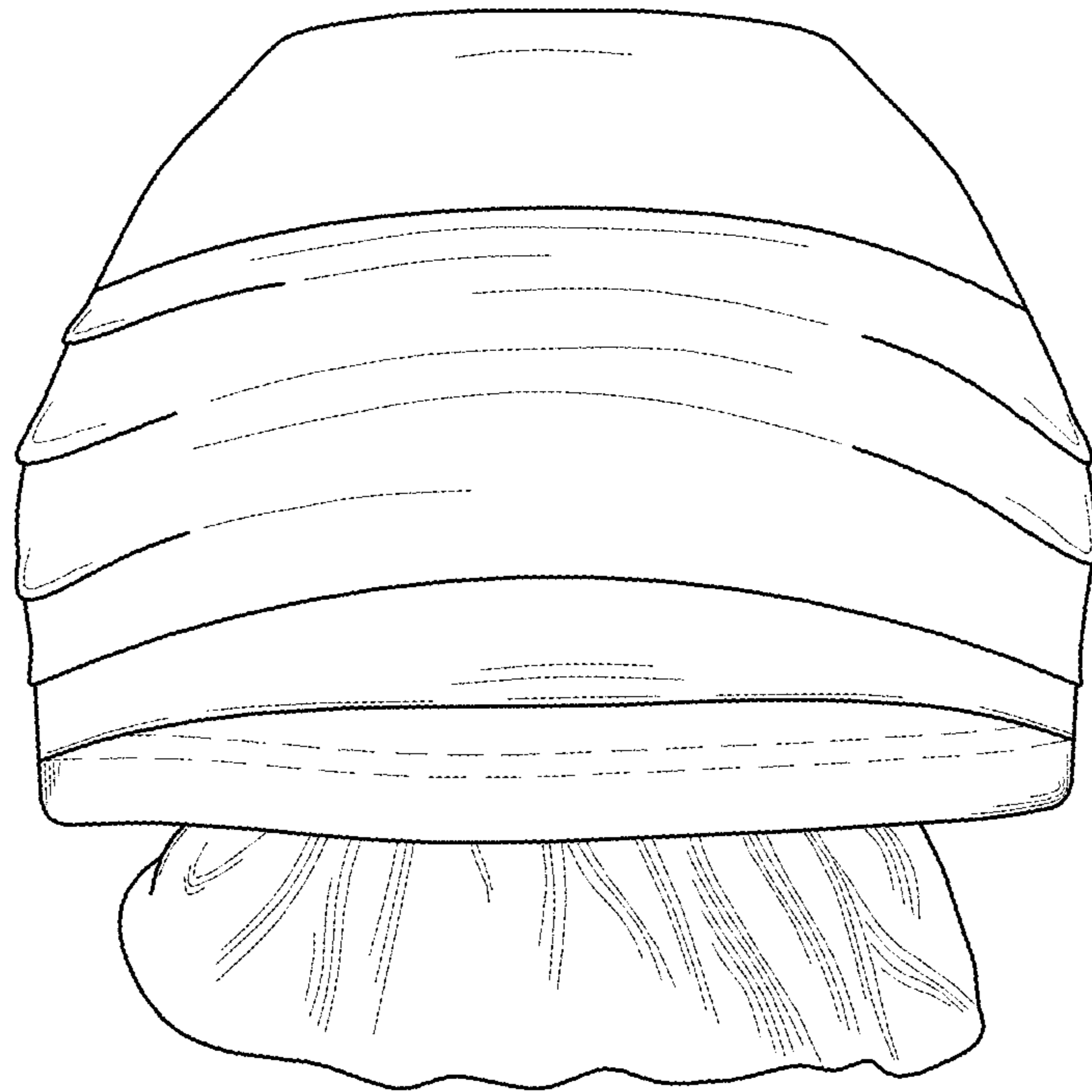

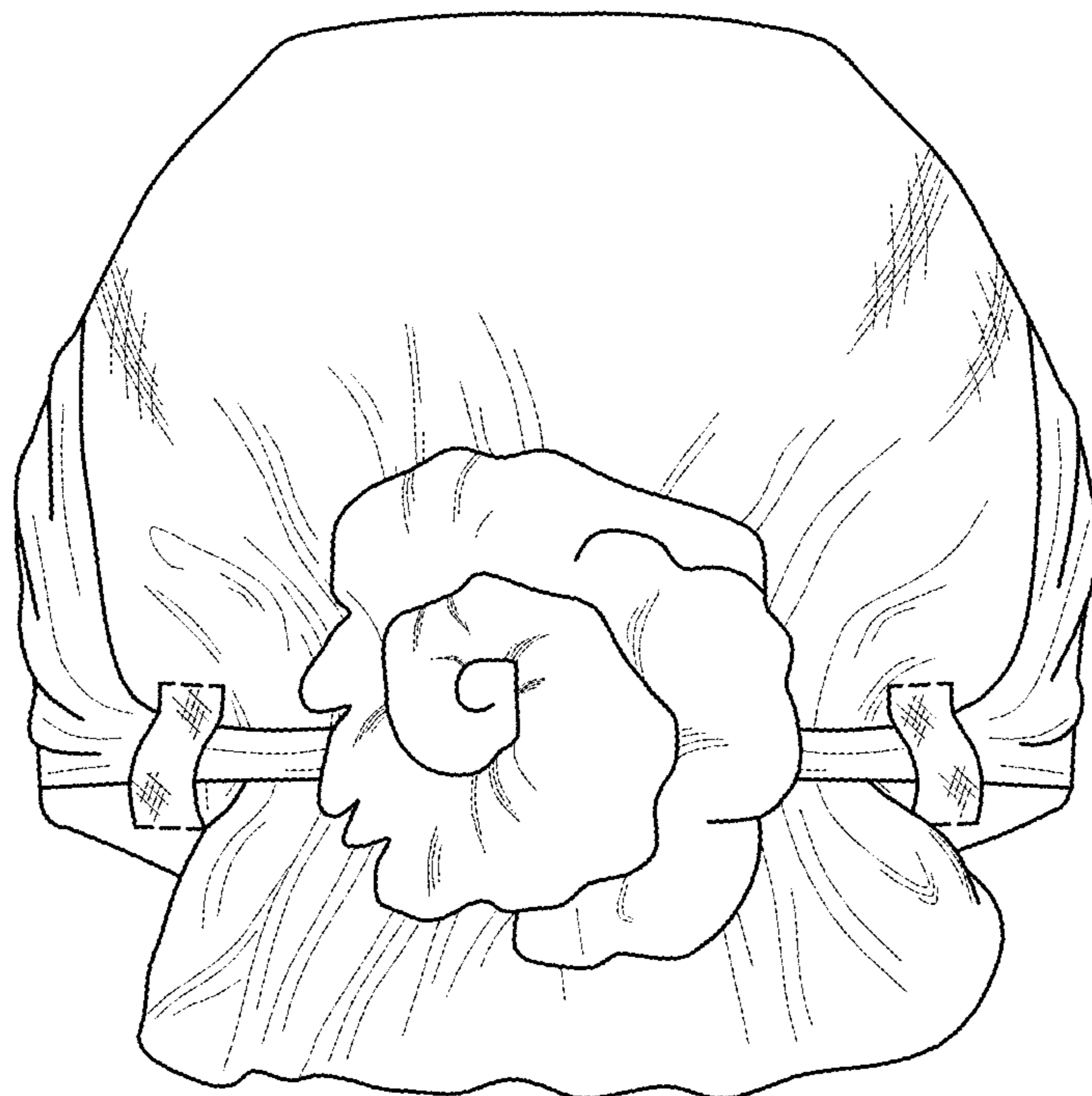

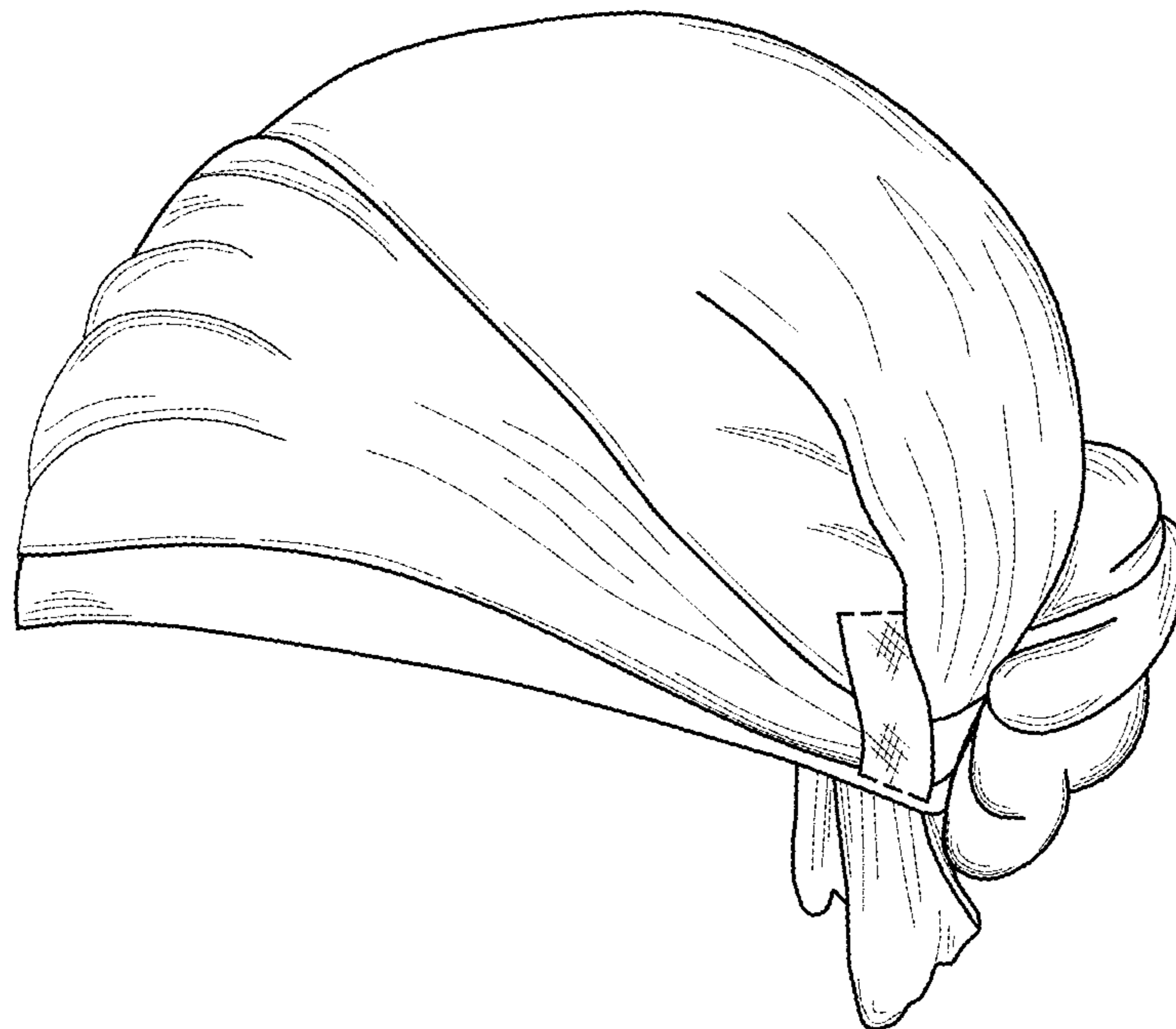
