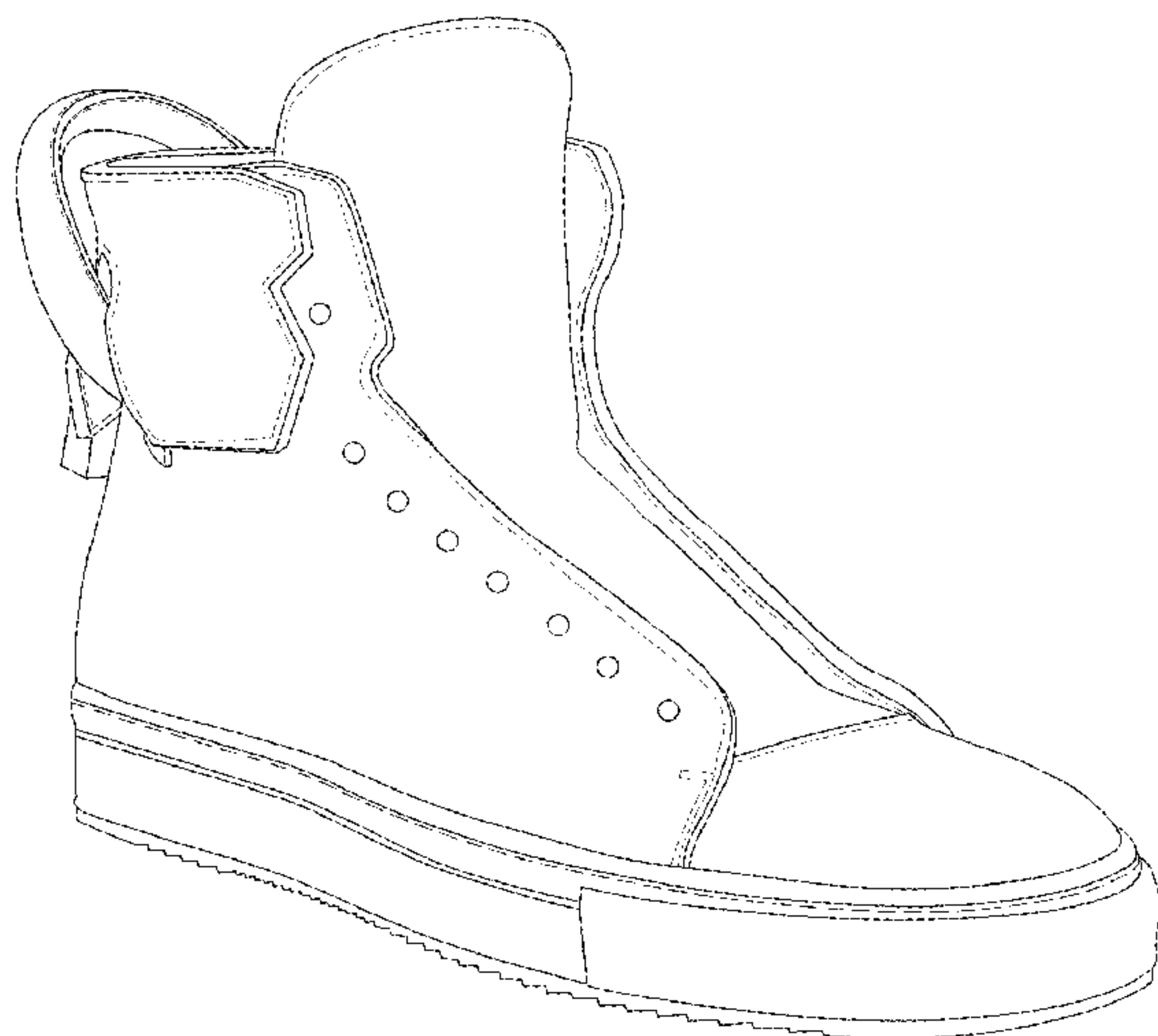
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a back view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a front view thereof; and,
FIG. 5 is a right side view thereof, the left side view being a mirror image of FIG. 5.
The broken lines shown on the shoe represent thread stitching. All surfaces and all sides not shown form no part of the claimed design.

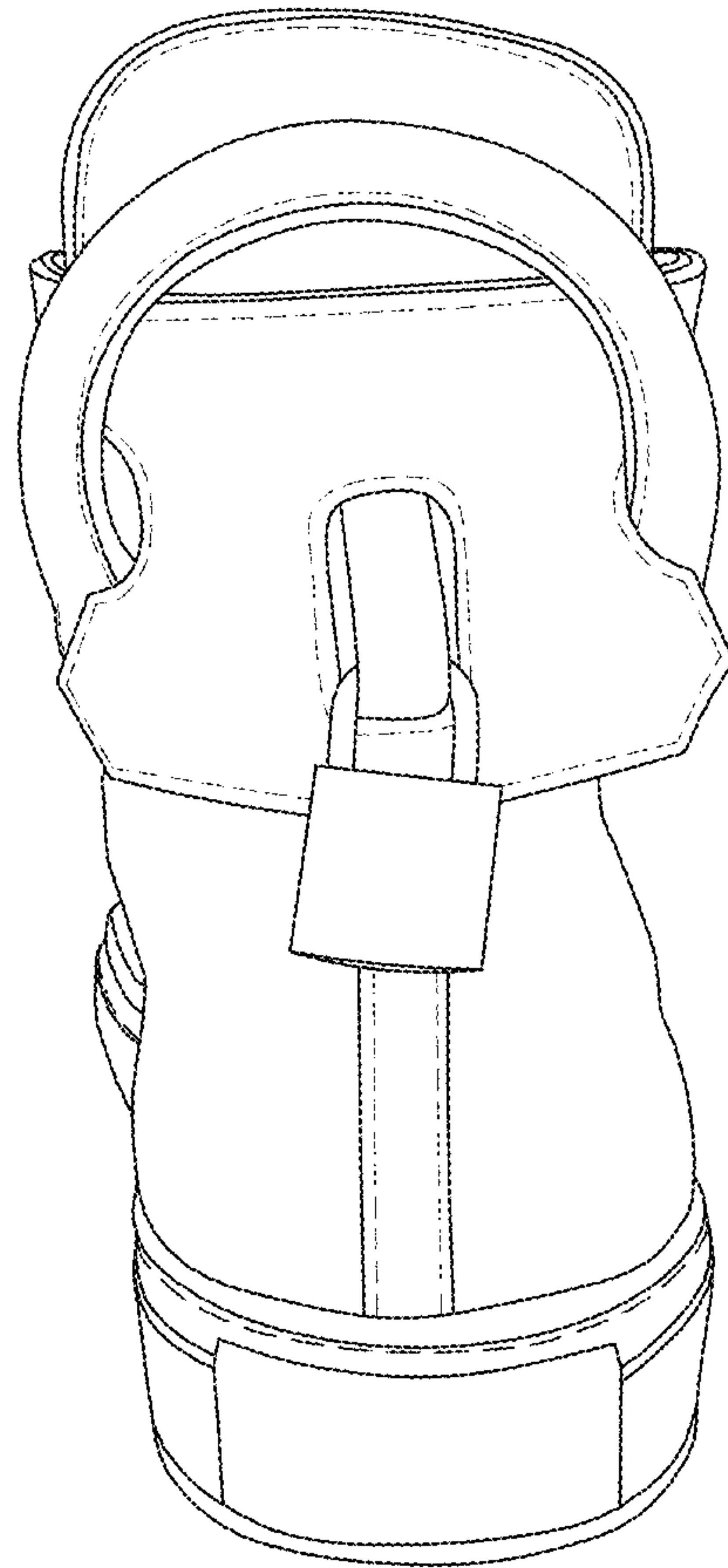

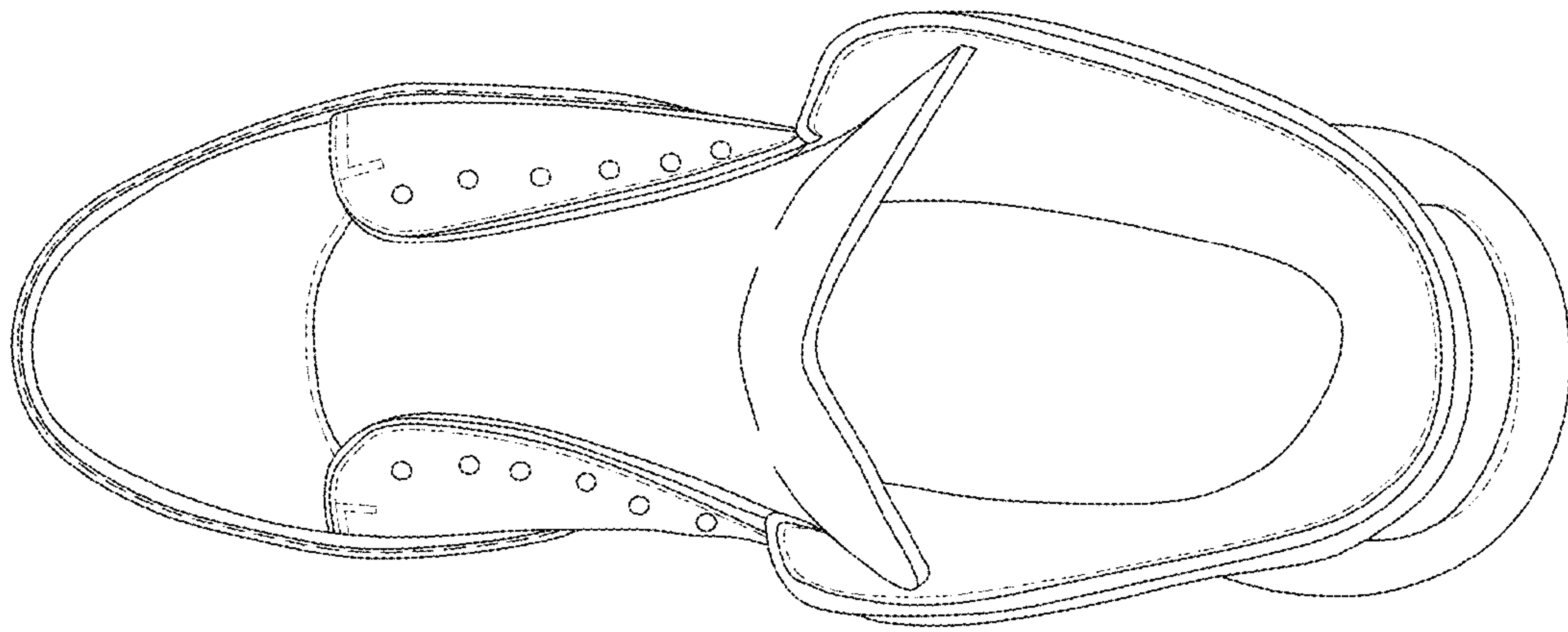

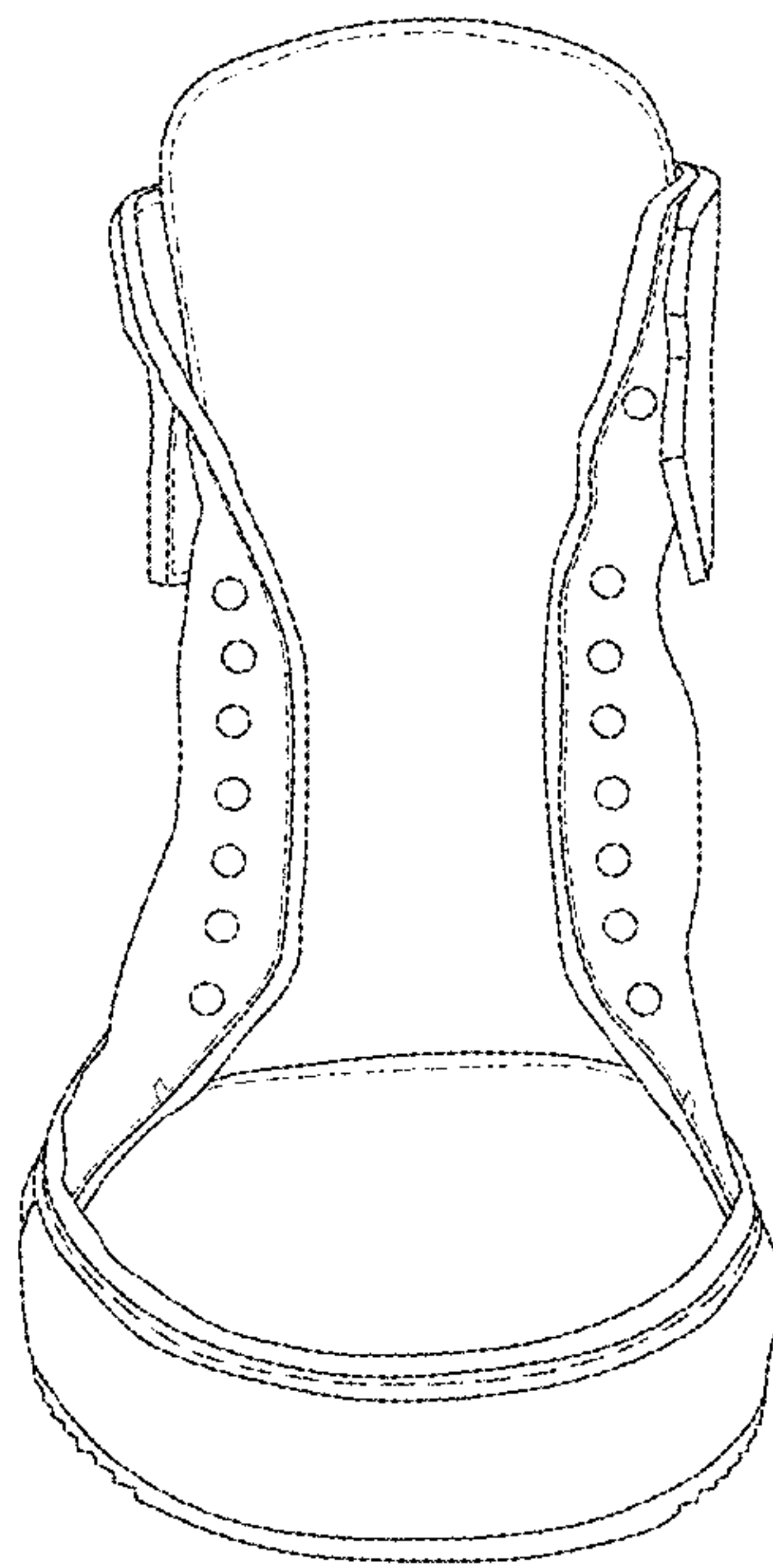
