(57) **CLAIM**

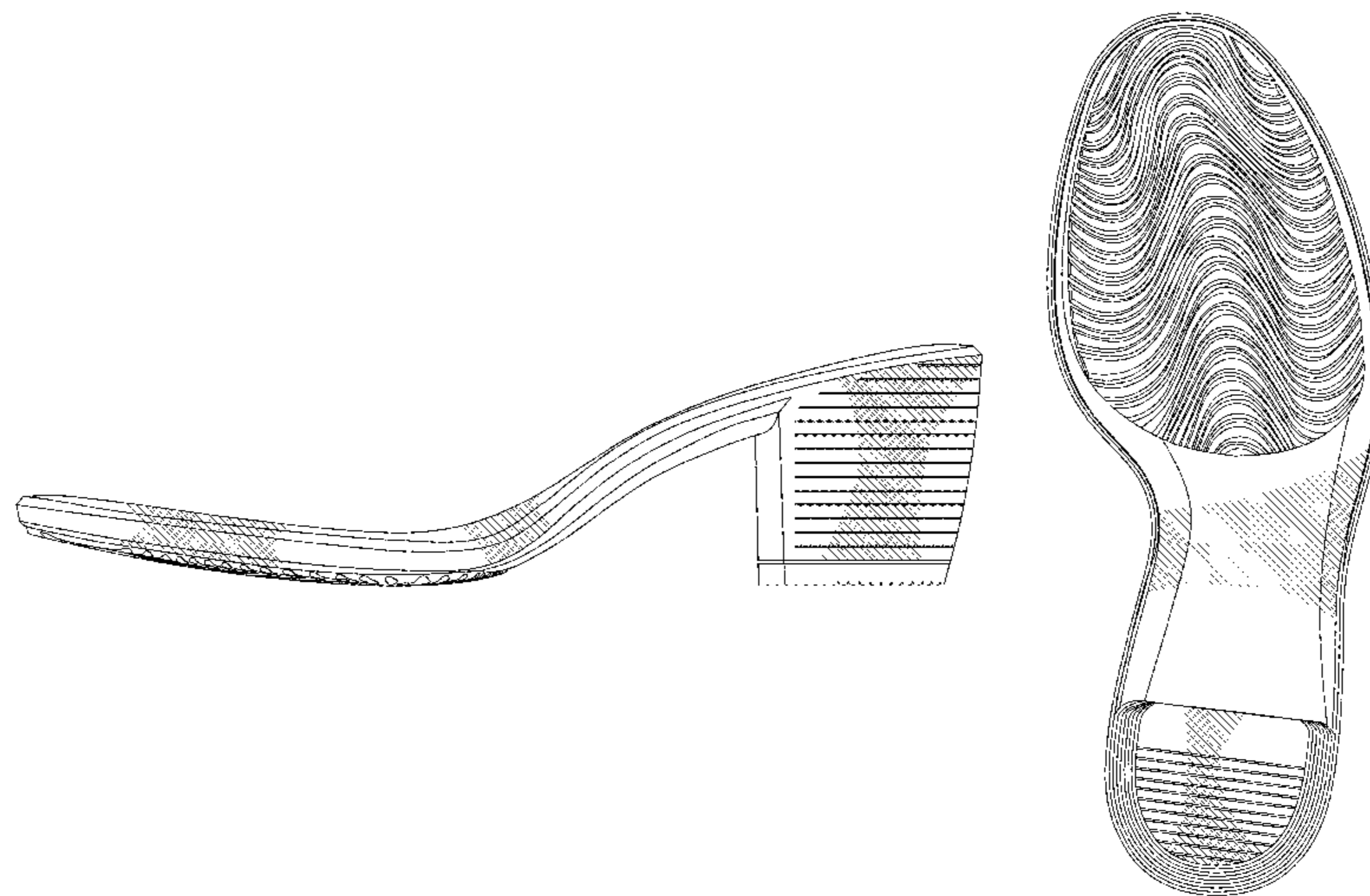
The ornamental design for a sole for footwear, as shown and described.

**DESCRIPTION**

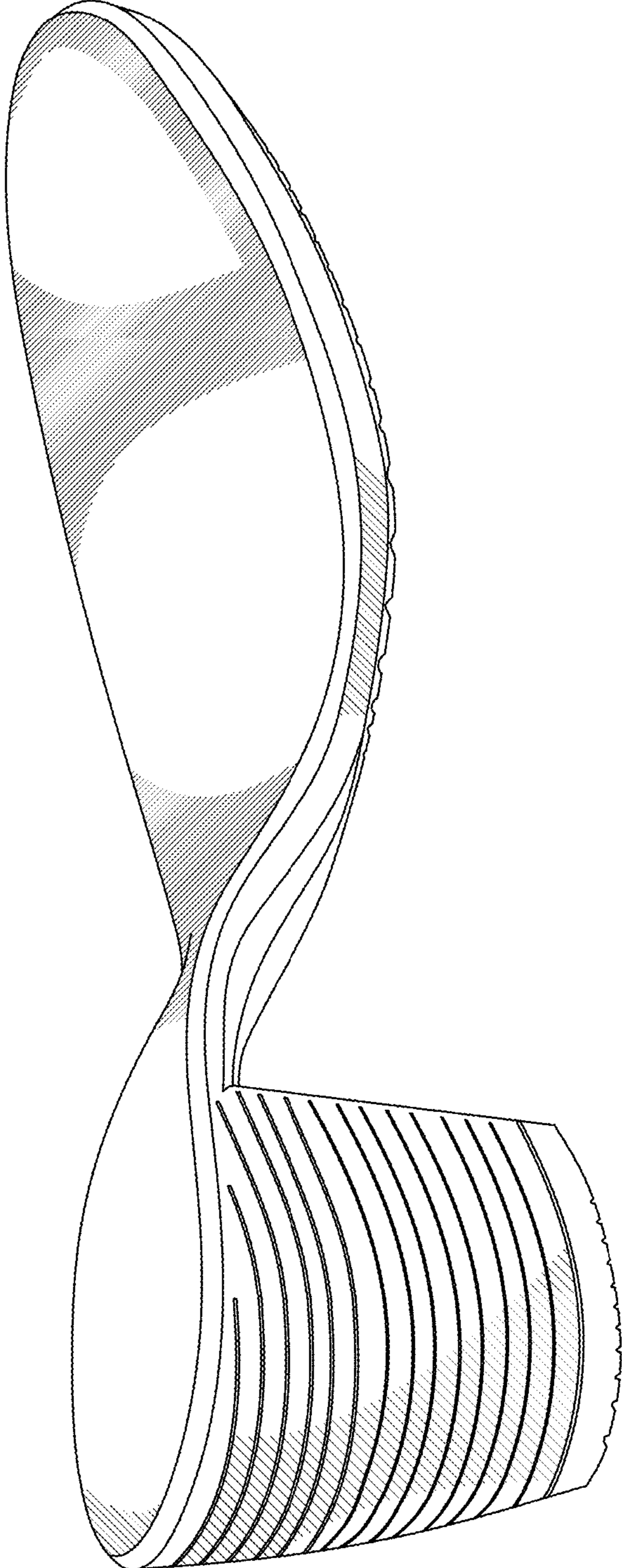

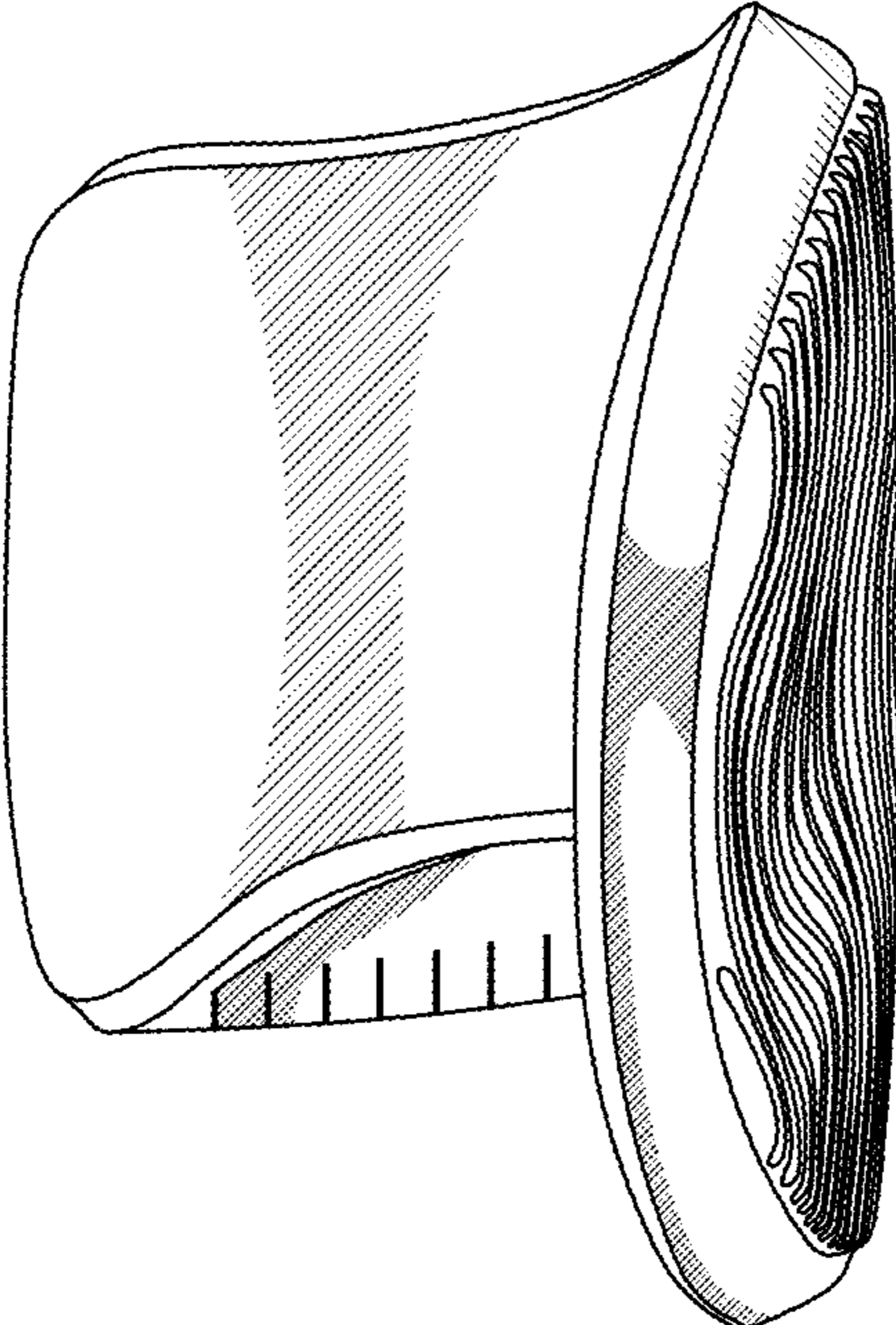

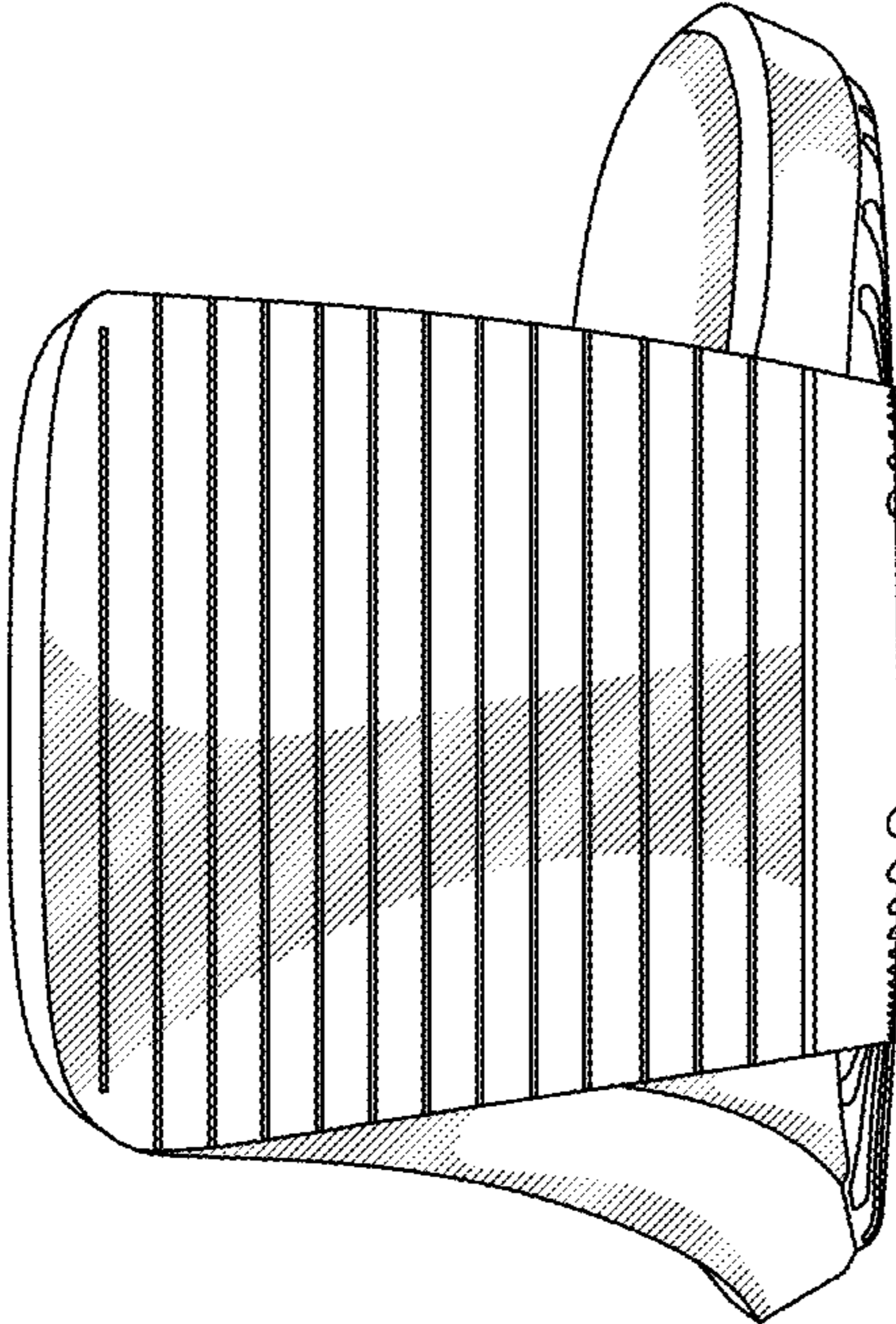

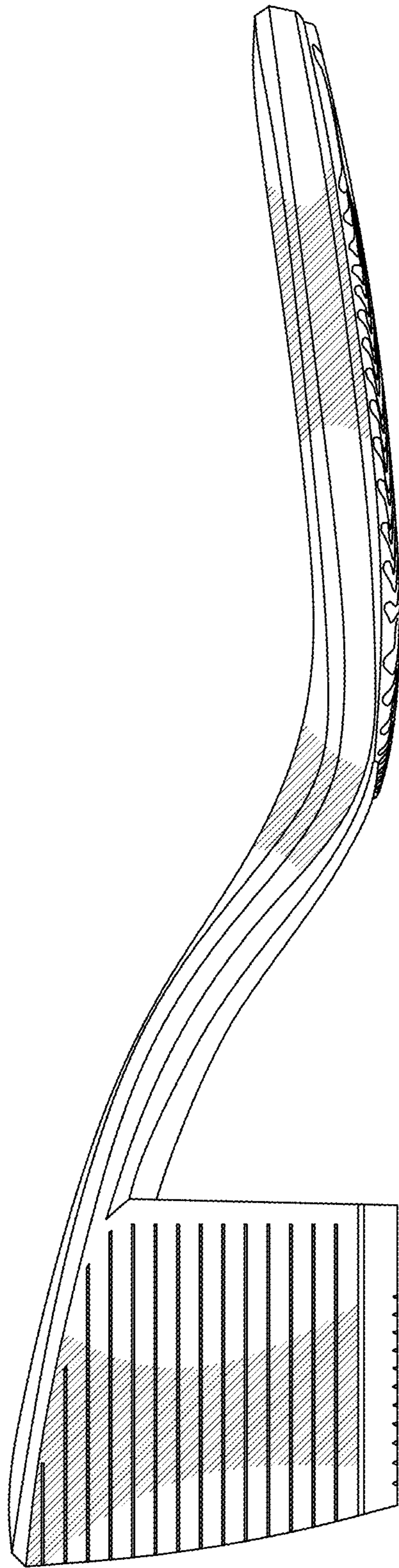

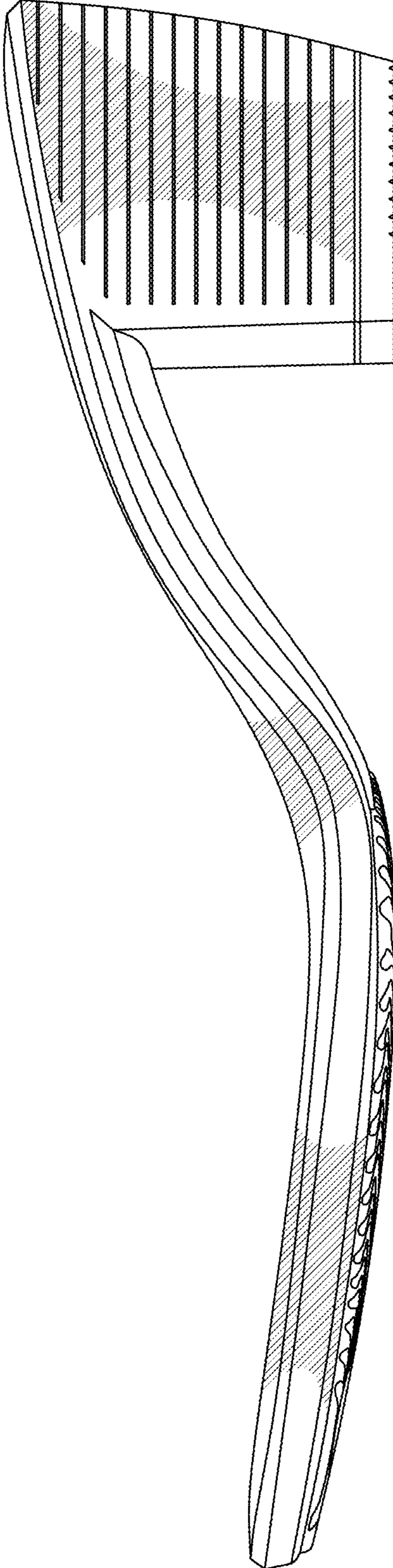

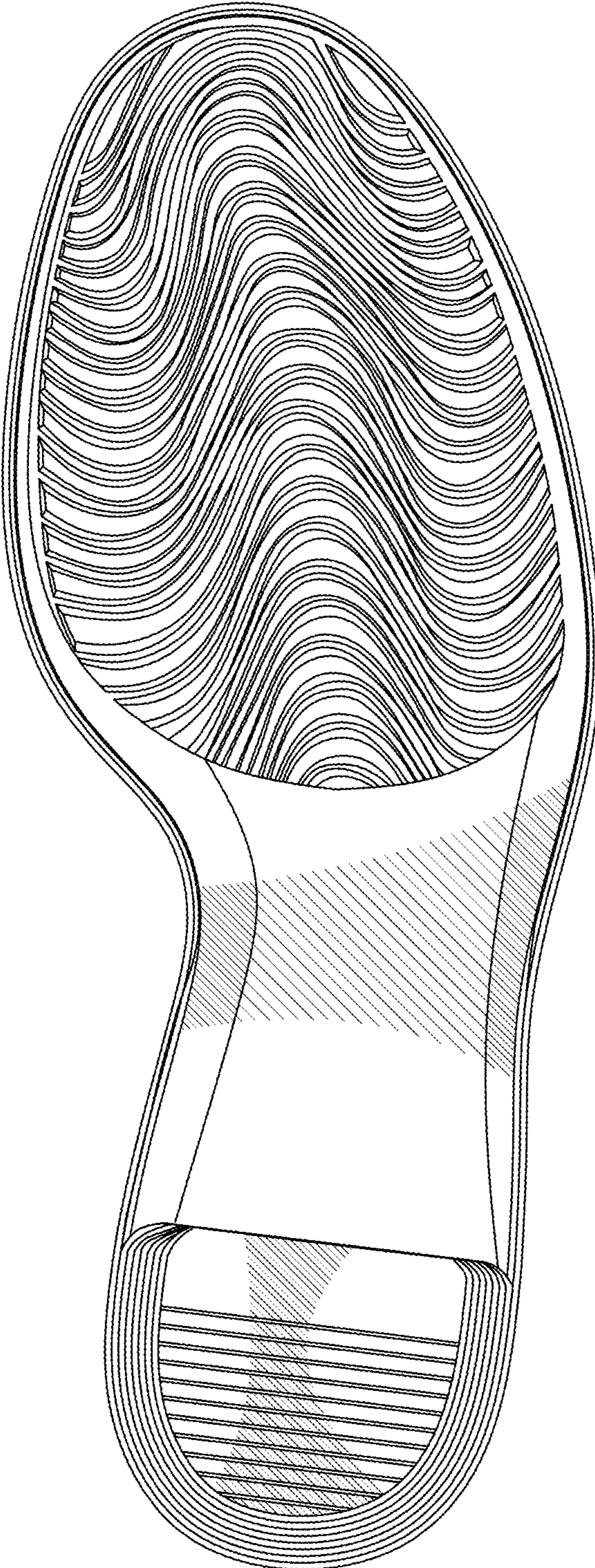
