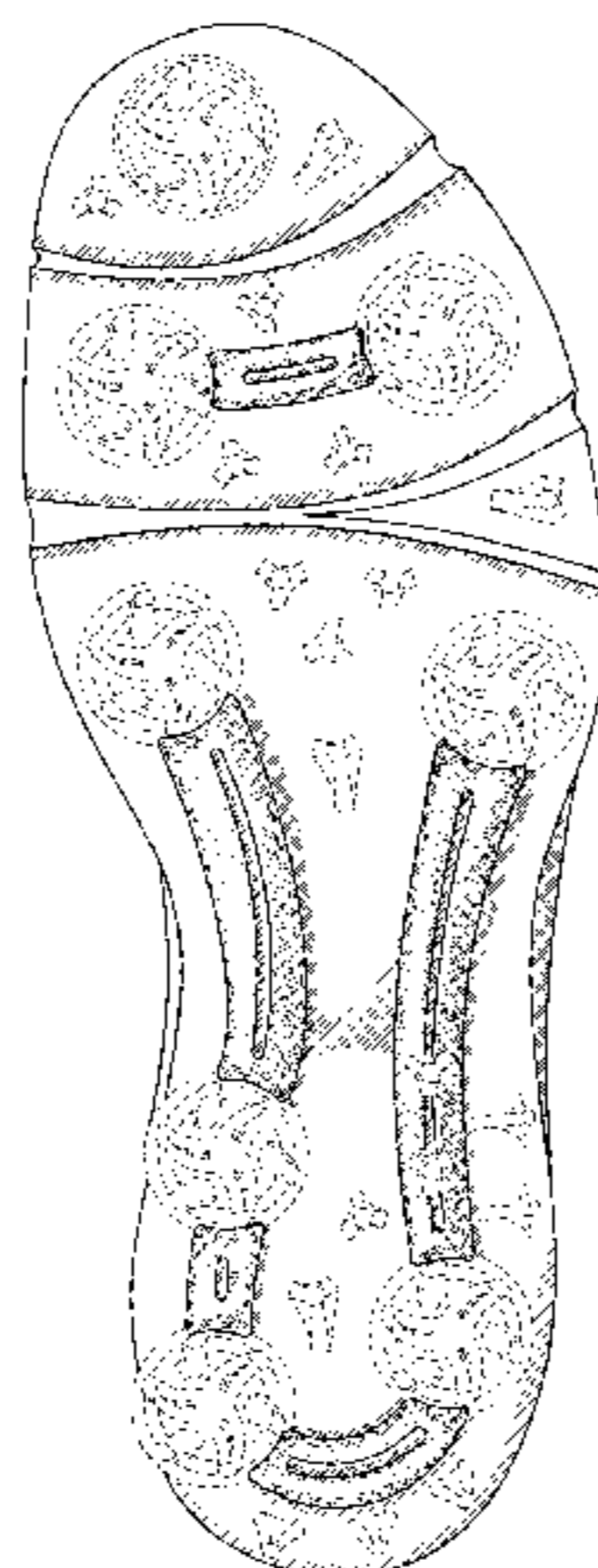
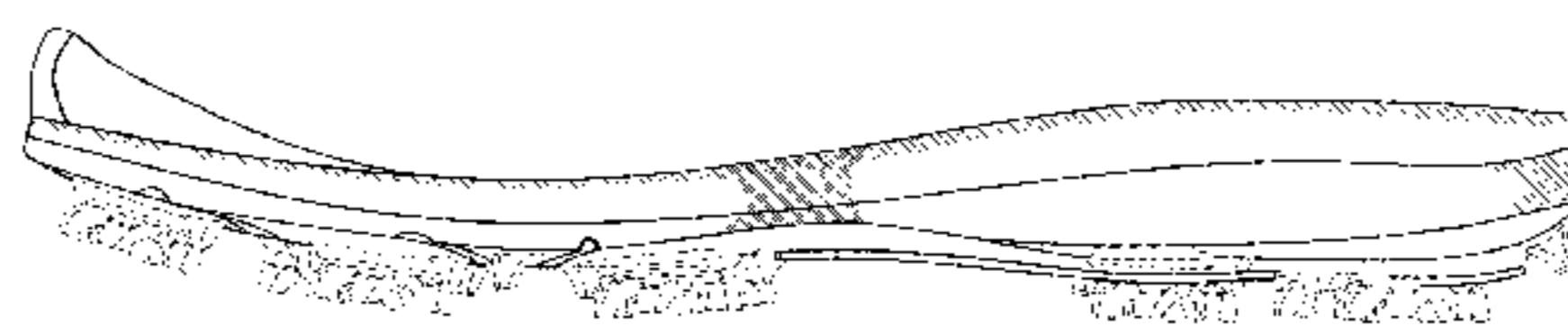

DESCRIPTION
FIG. 1 is a perspective view of a sole for footwear;
FIG. 2 is a front view thereof;

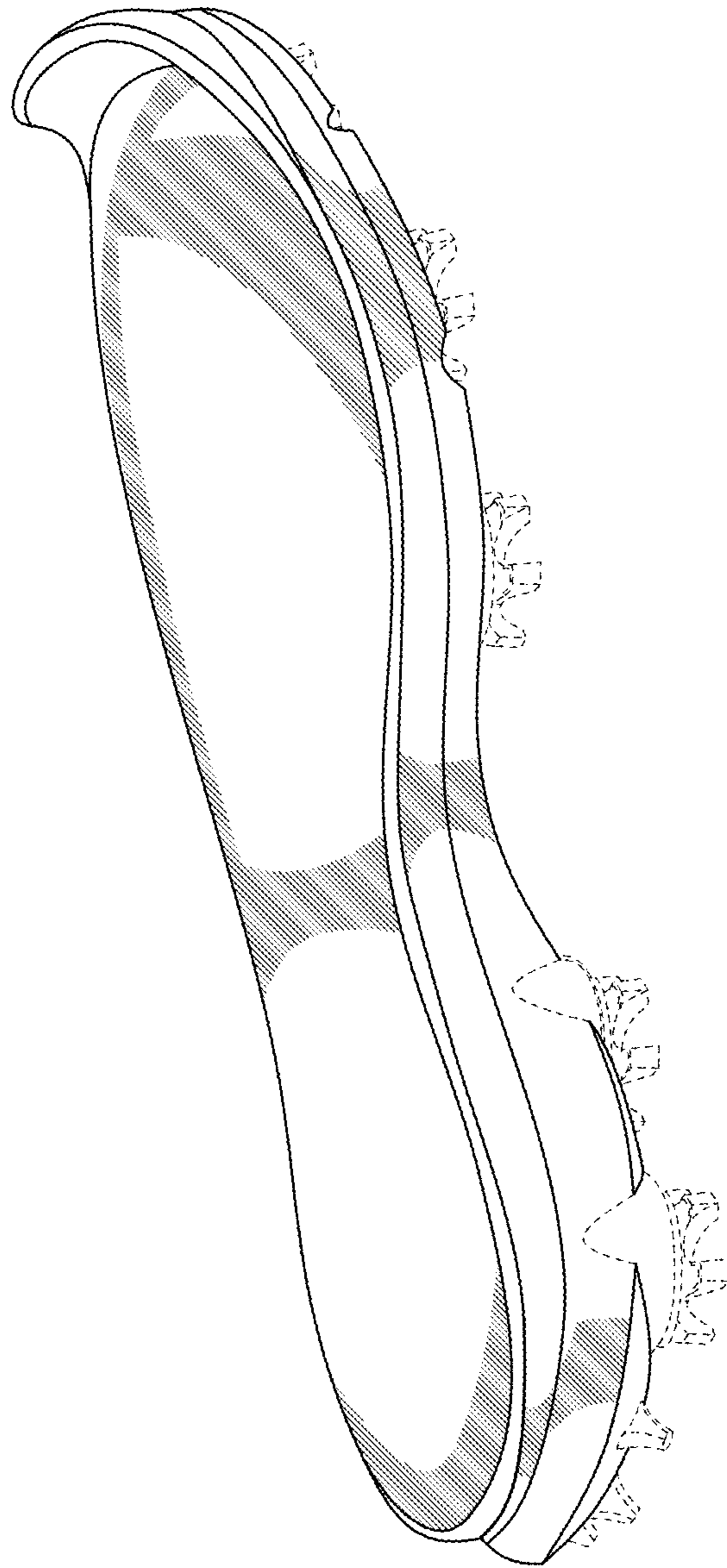

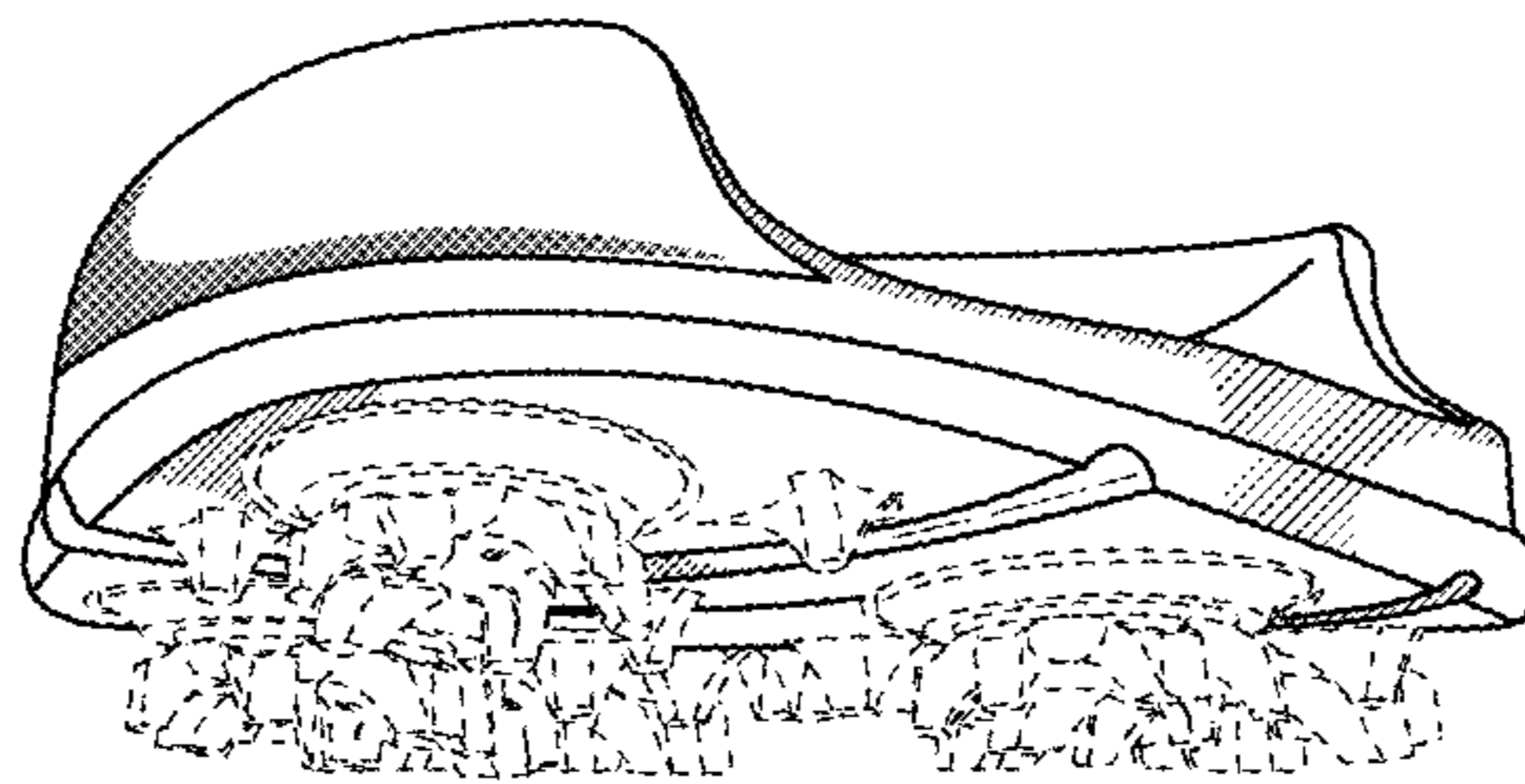

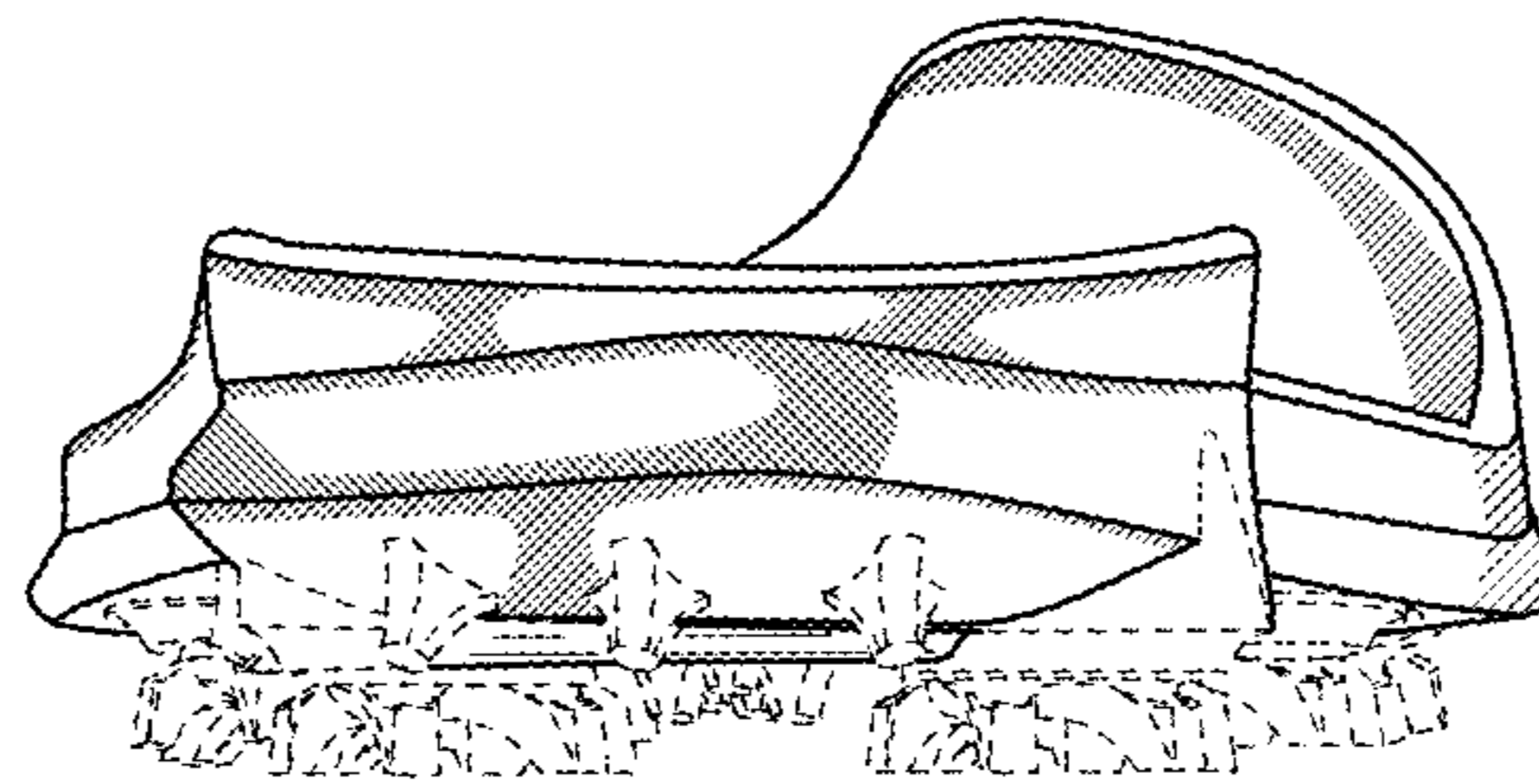

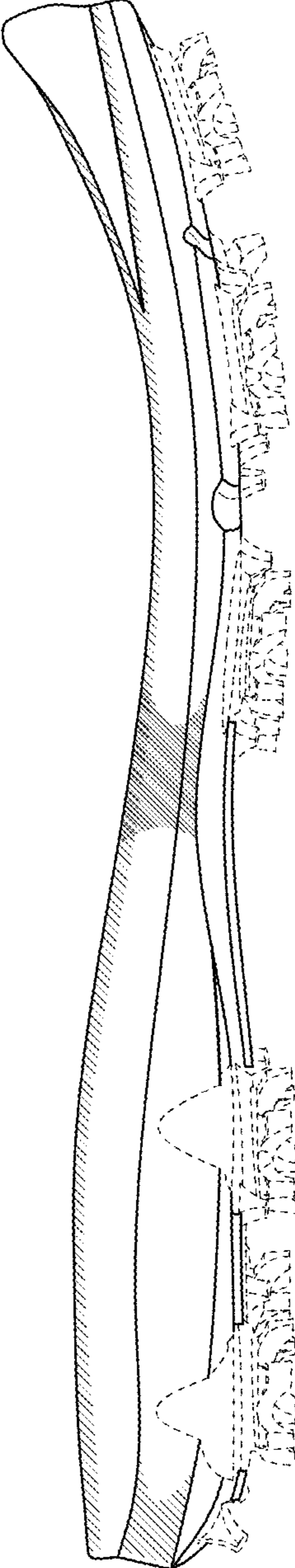

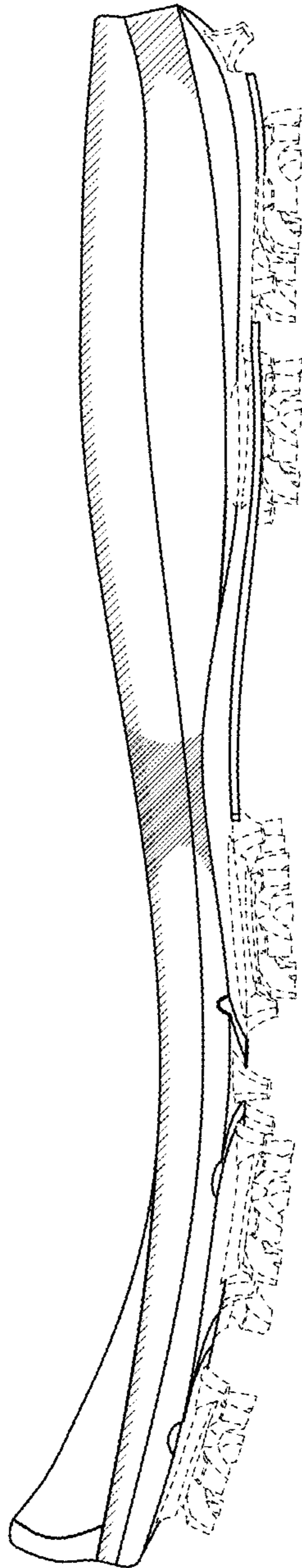

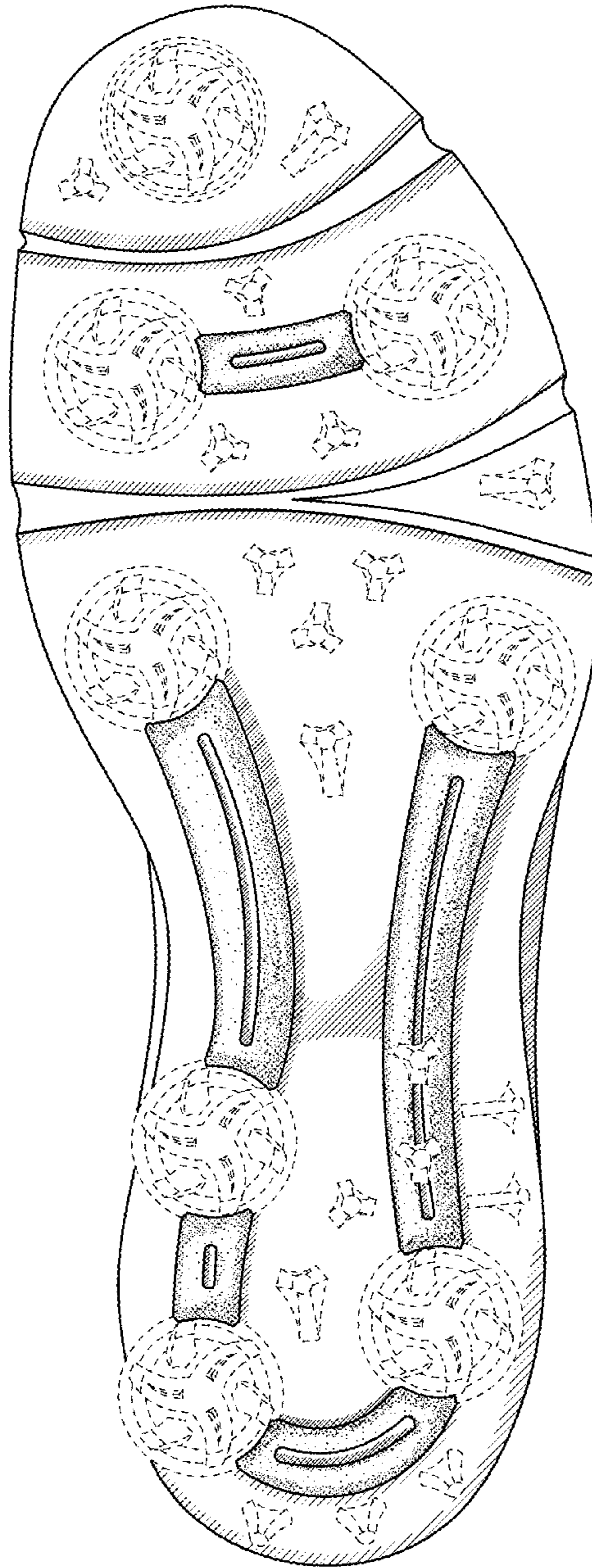
