DESCRIPTION

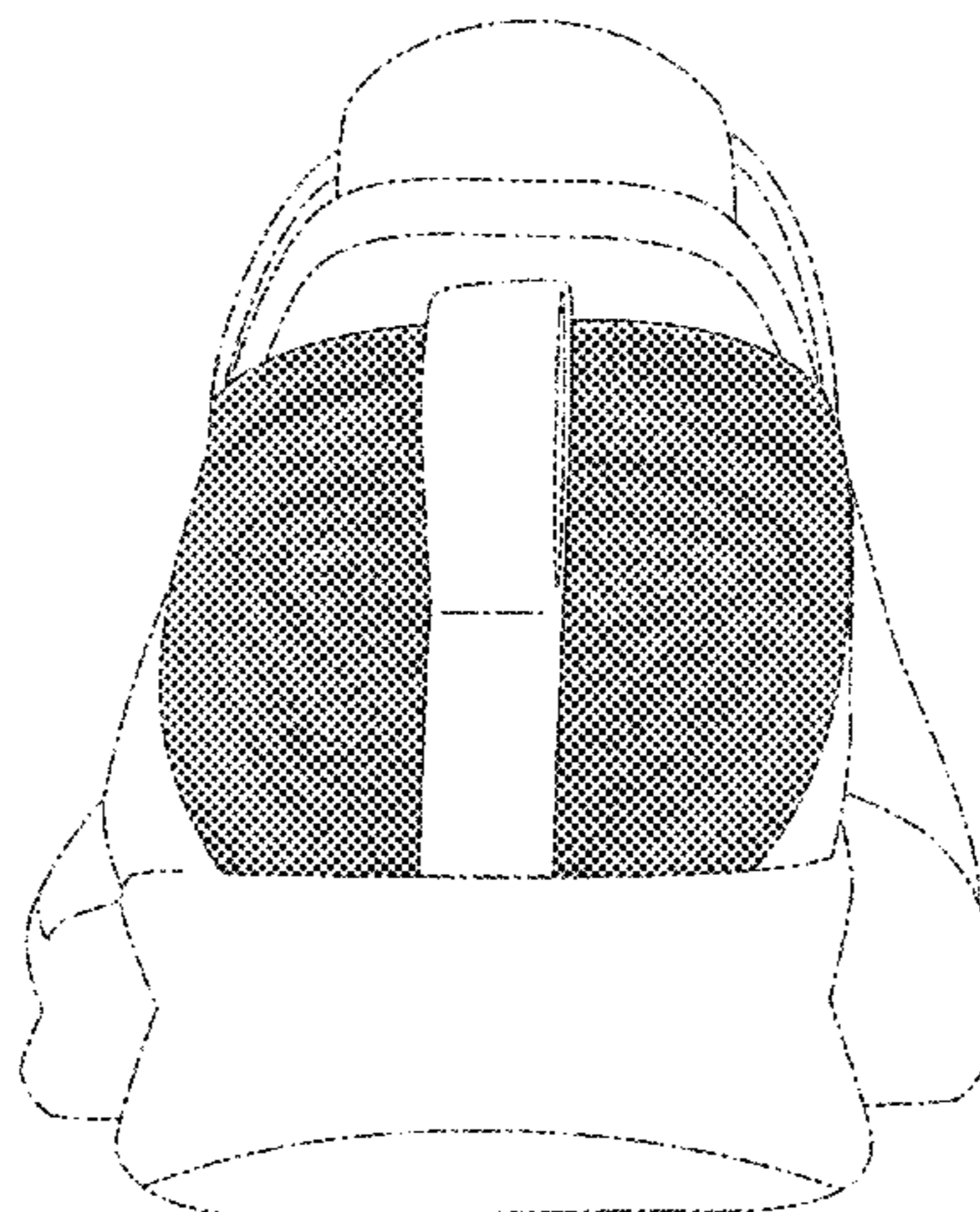
FIG. 1 is a rear perspective view of a shoe upper showing my new design;

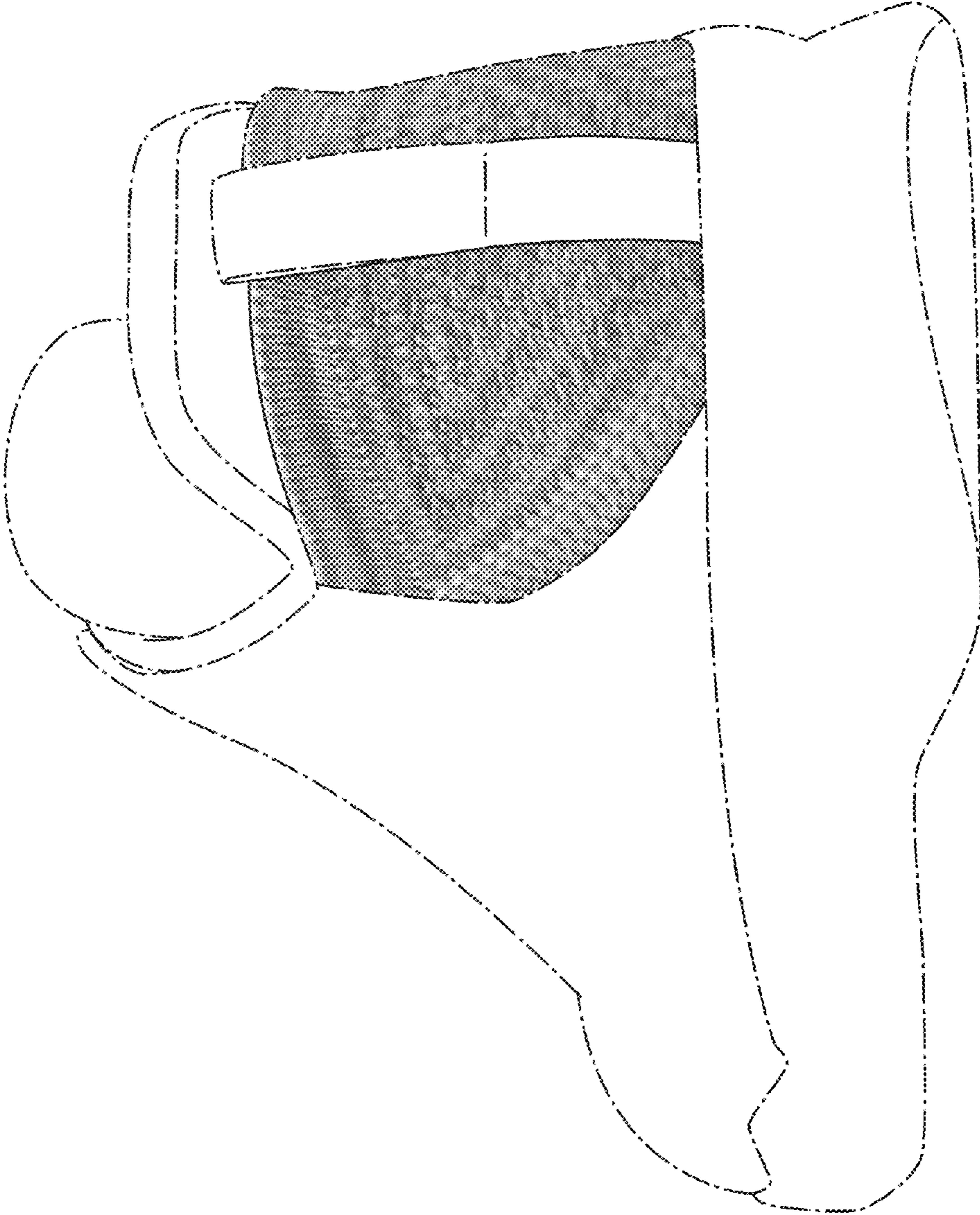

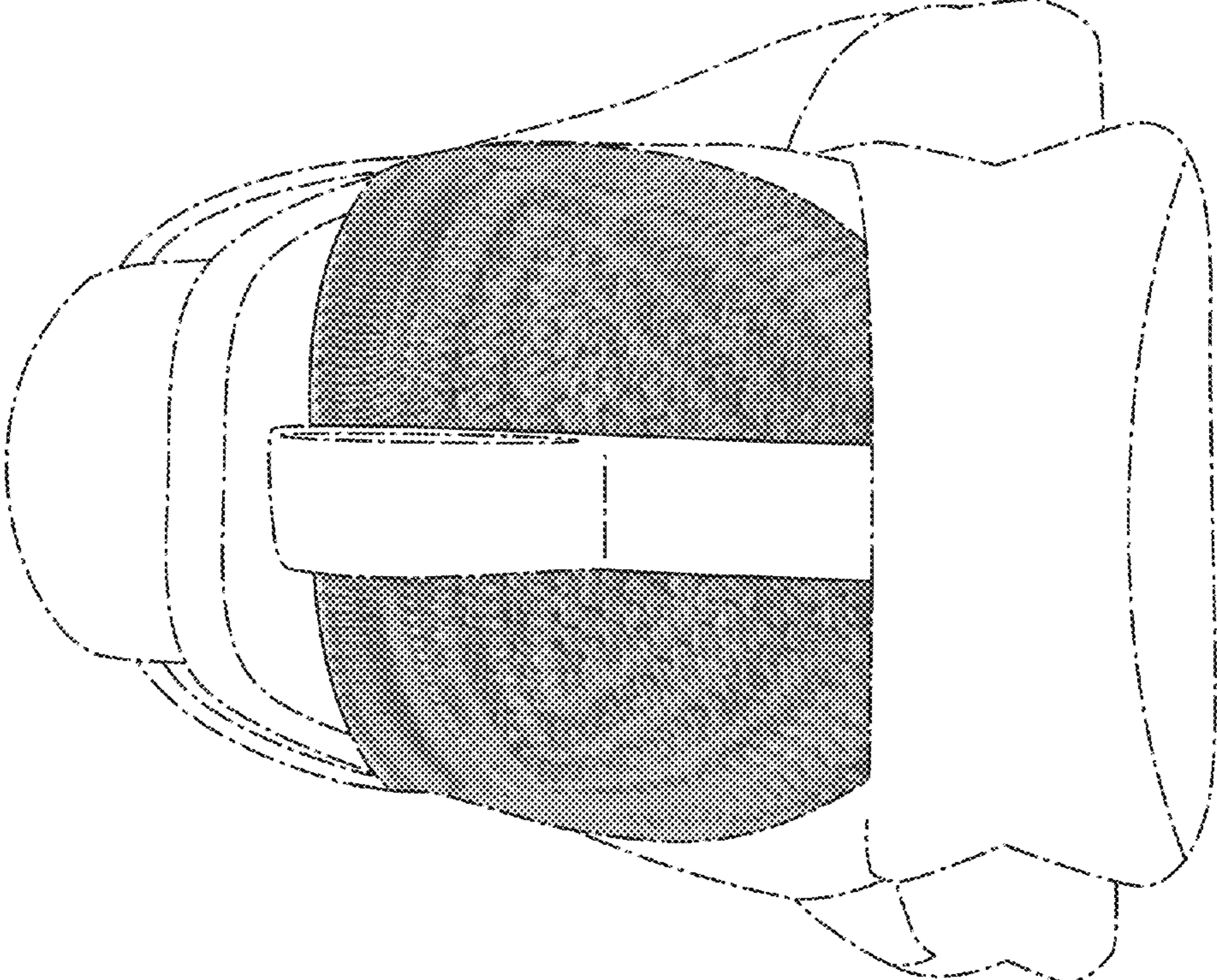

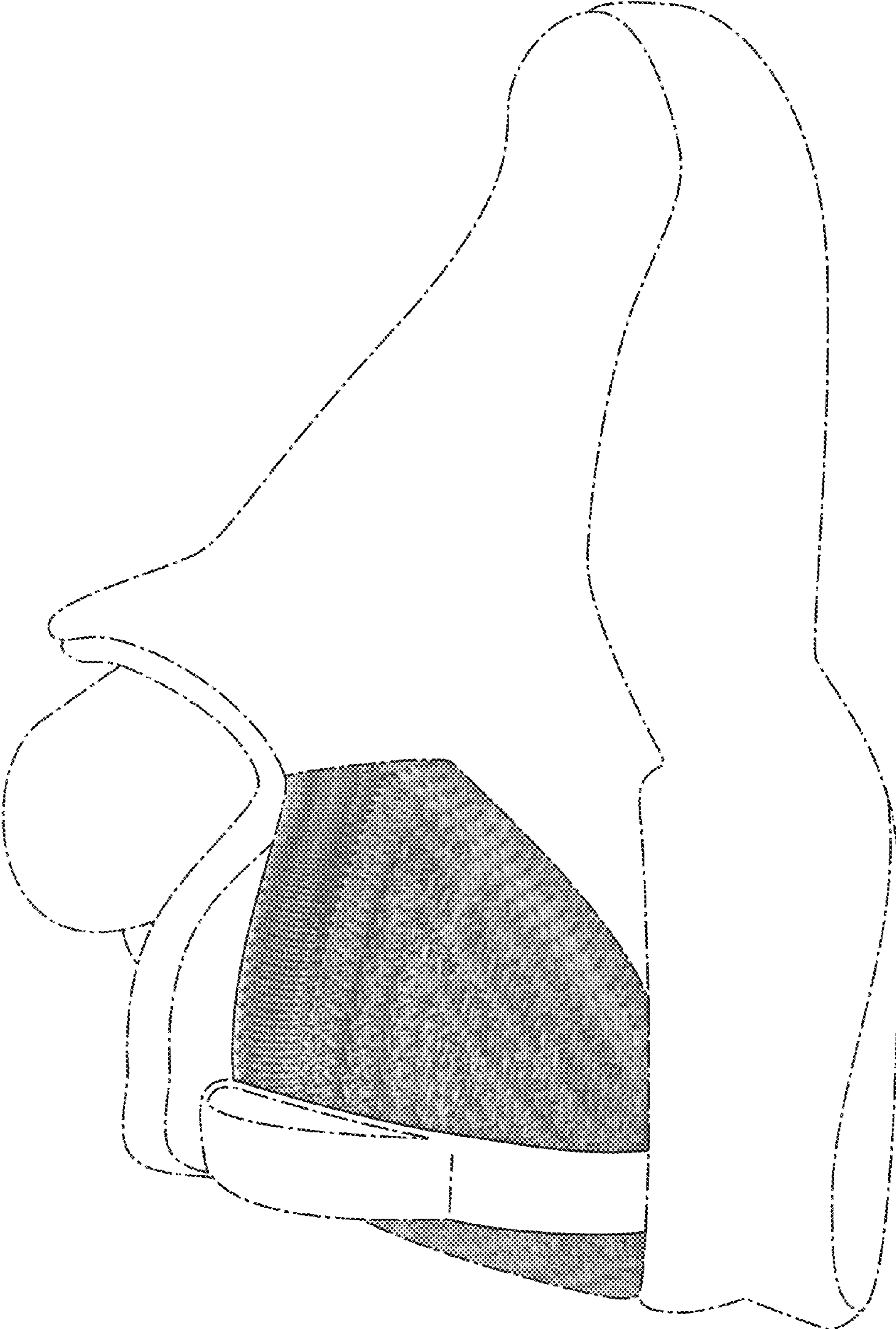
